(57) **CLAIM**

The ornamental design for a stuffed toy with a fingerprint pattern, as shown and described.

FIG. 4 is a side view of the stuffed toy with the fingerprint pattern.

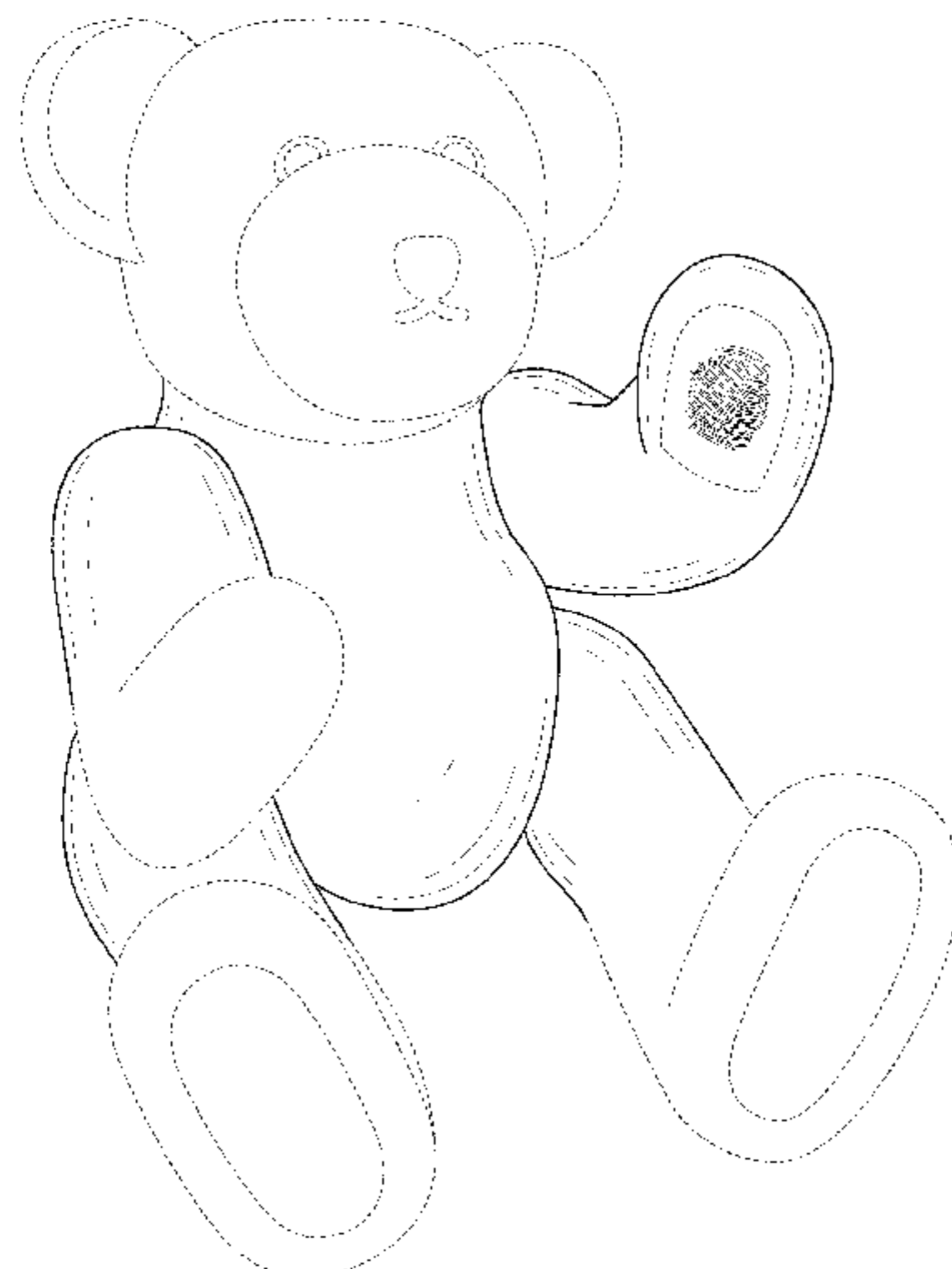
FIG. 5 is a side view of the stuffed toy with the fingerprint pattern.

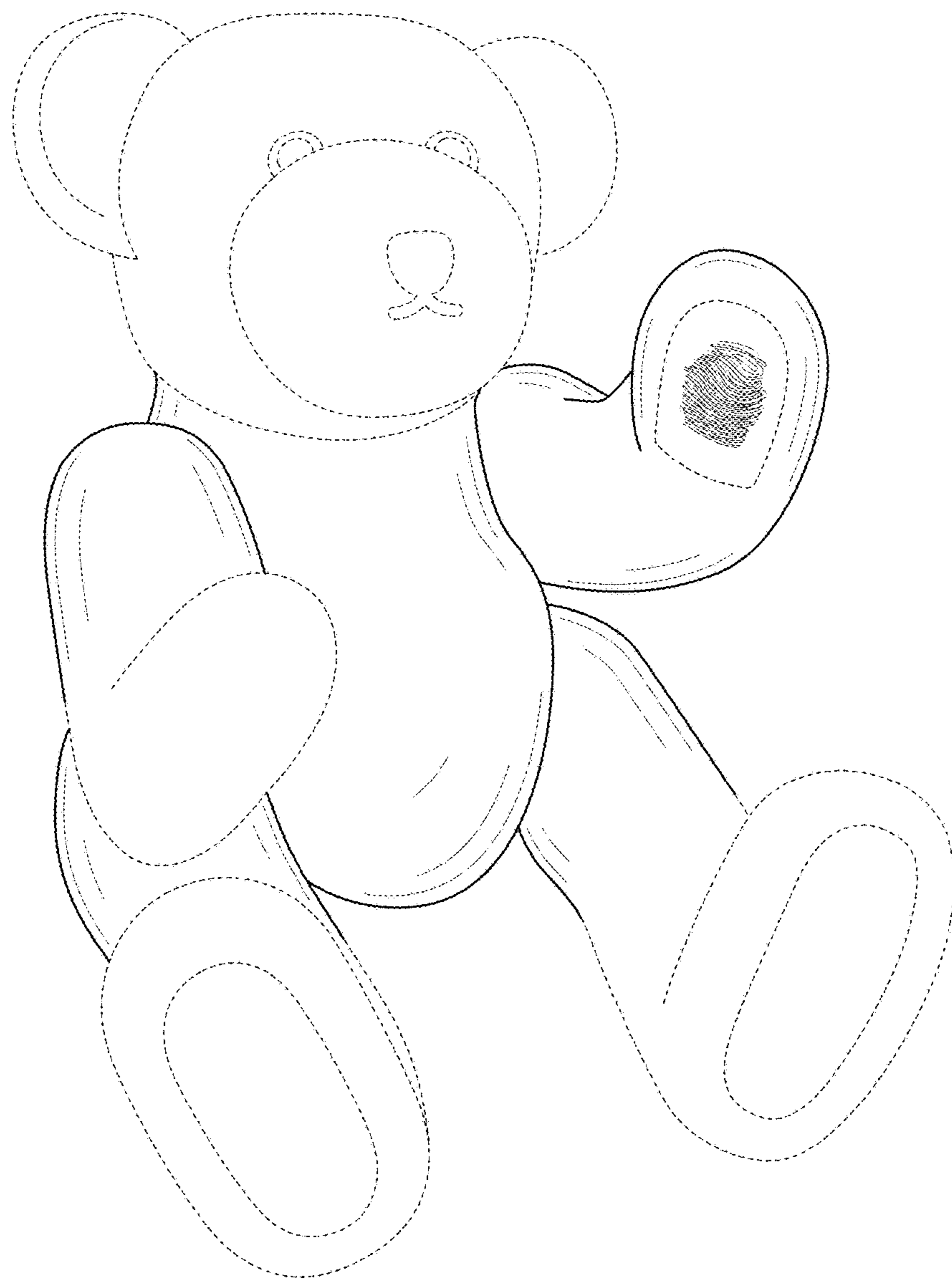

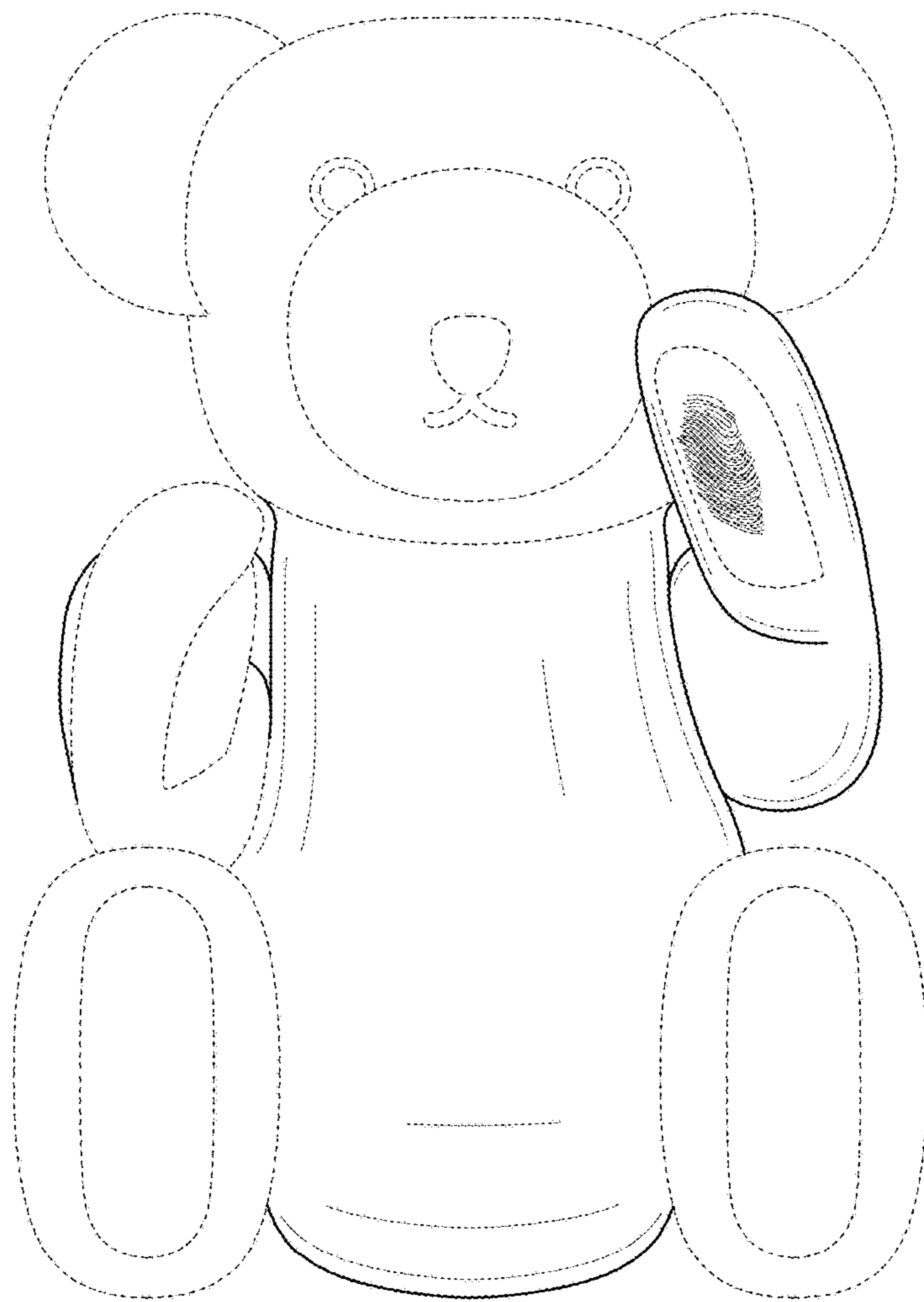

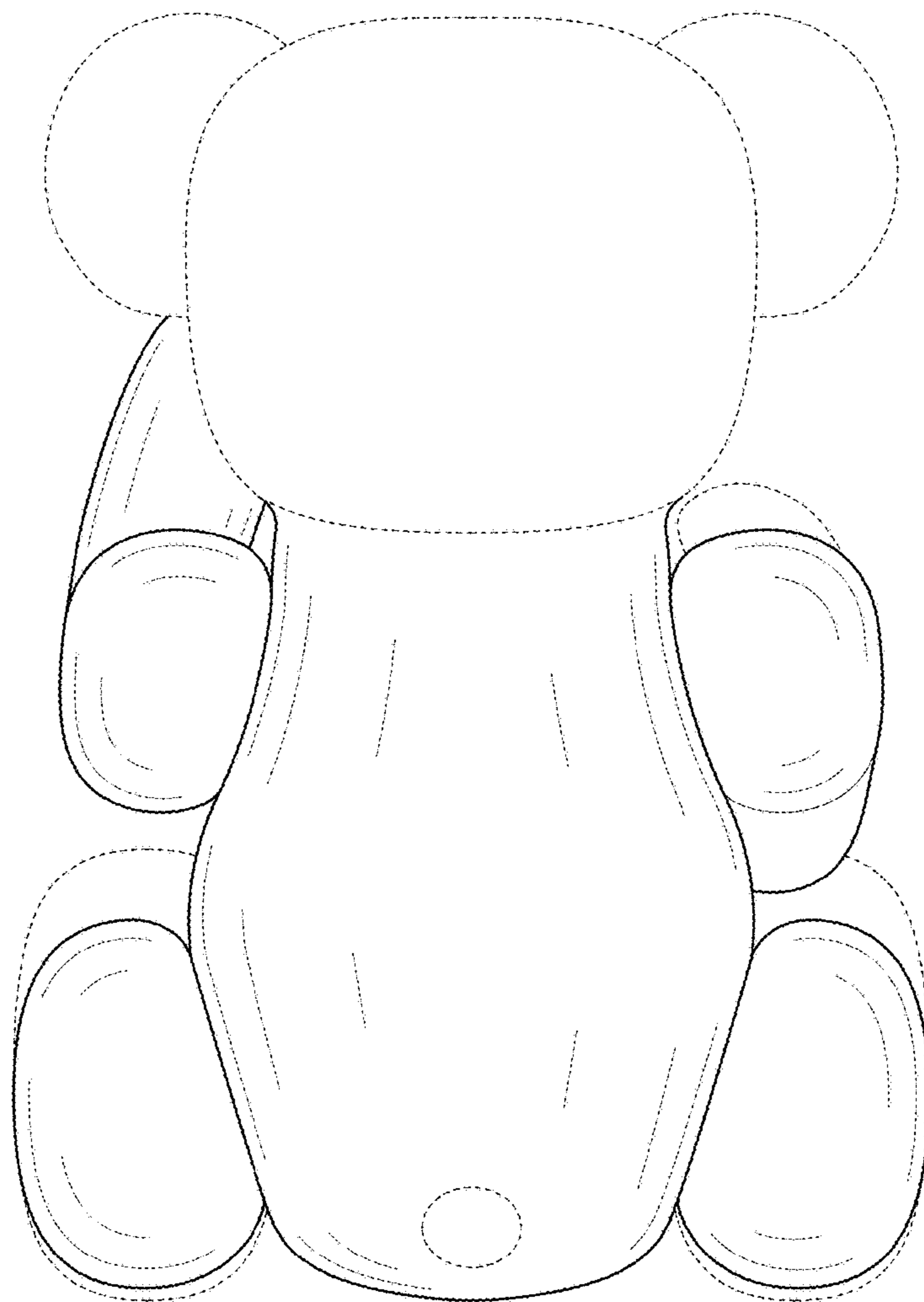

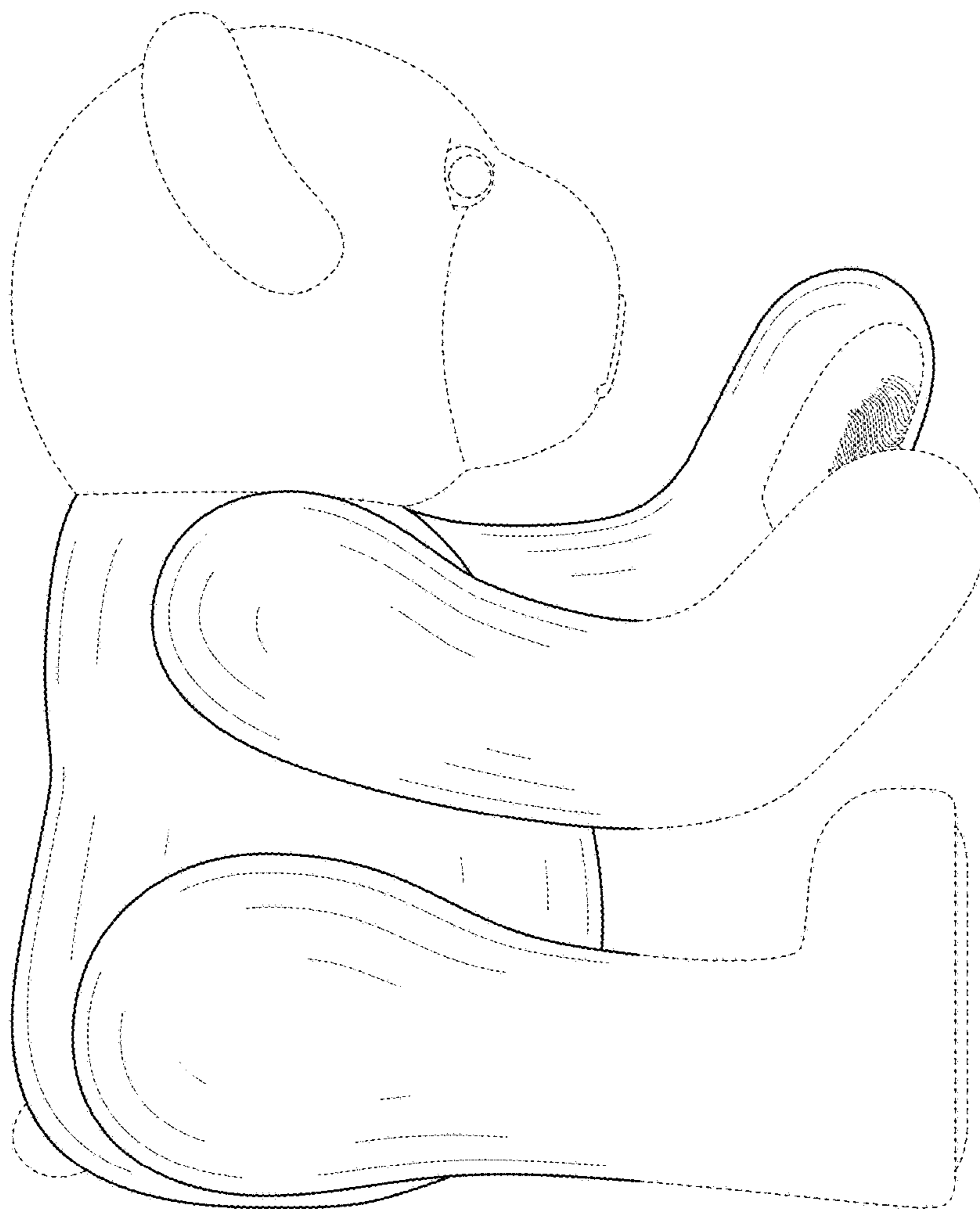

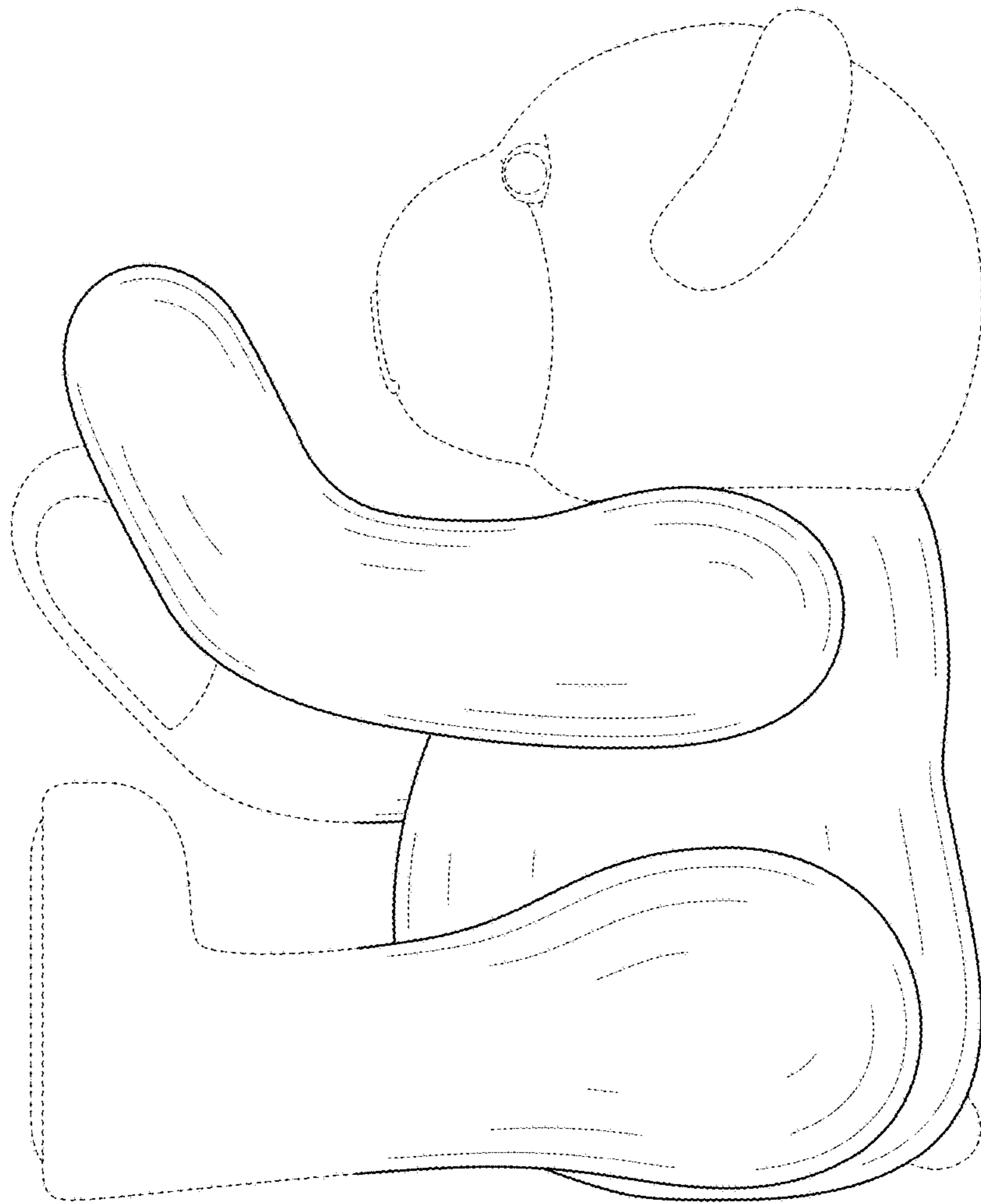

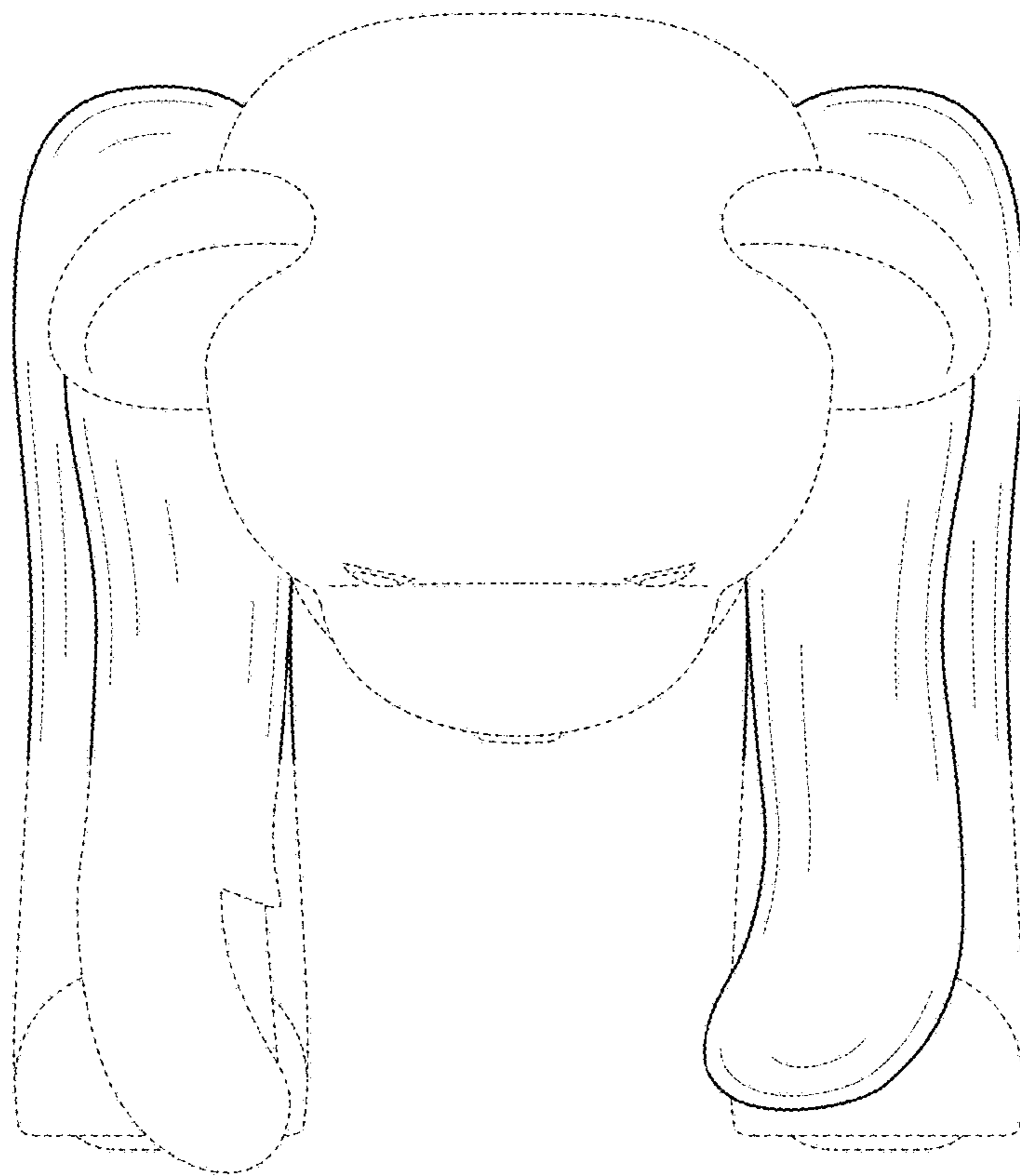

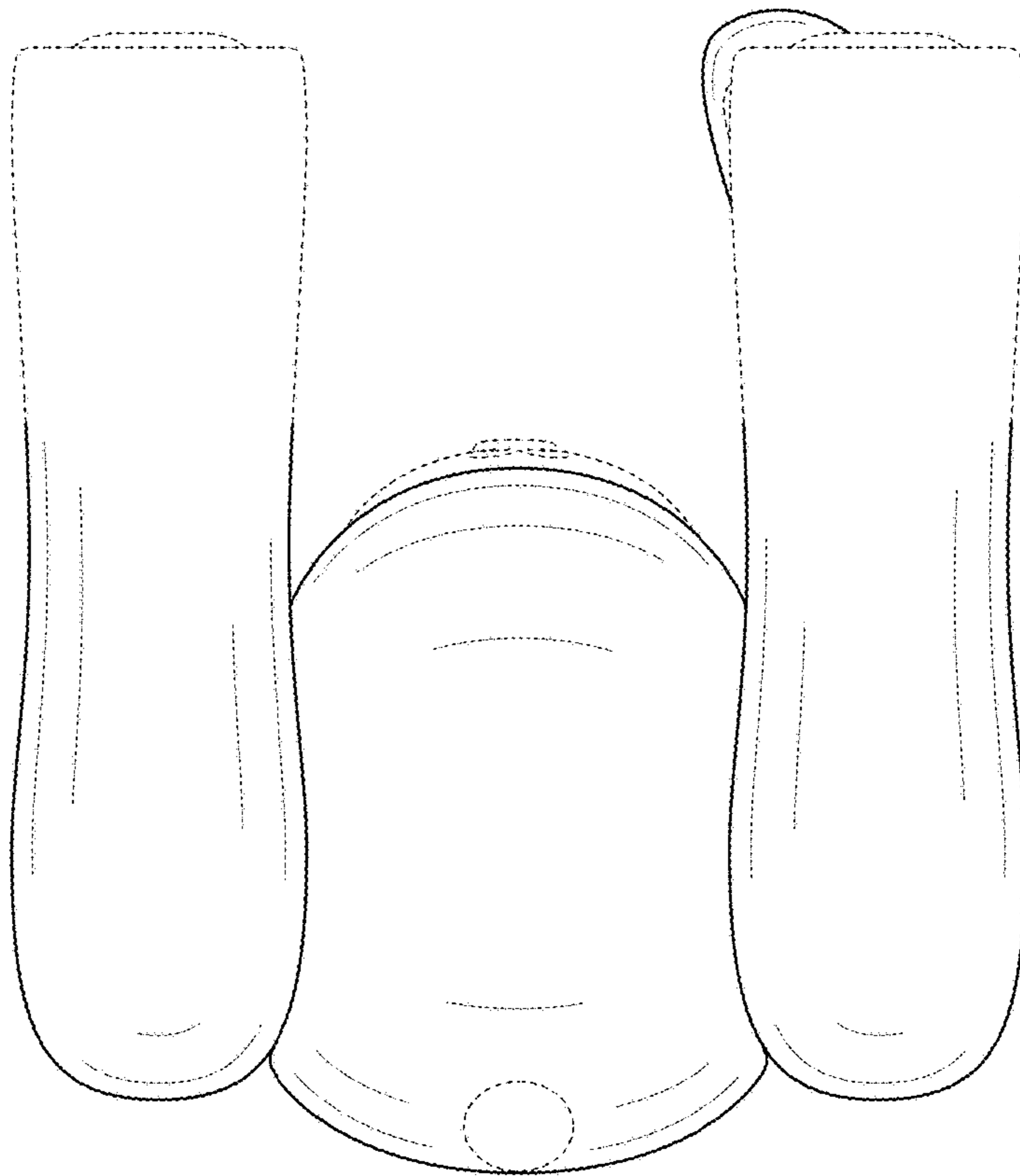
