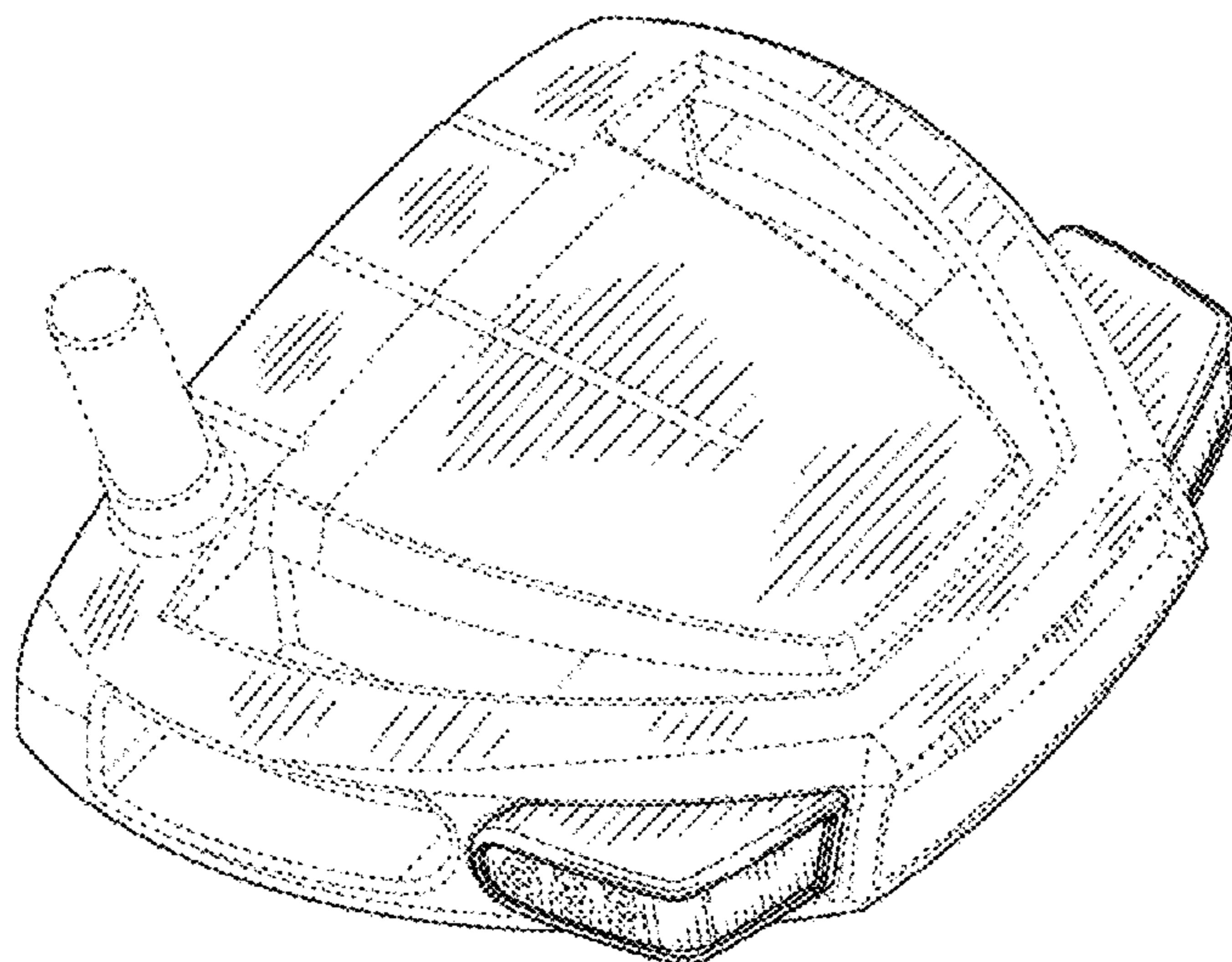
(57) **CLAIM**

We claim the ornamental design for a golf putter, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of the golf putter of FIG. 1, as viewed from the rear and one side.  
FIG. 2 is a front elevation view of a golf putter of FIG. 1.  
FIG. 3 is a rear elevation view of the golf putter of FIG. 1.  
FIG. 4 is a side elevation view of a toe side of the golf putter of FIG. 1.  
FIG. 5 is a side elevation view of a heel side of the golf putter of FIG. 1.  
FIG. 6 is a top plan view of the golf putter of FIG. 1; and, FIG. 7 is a bottom plan view of the golf putter of FIG. 1.  
The dashed lines in the drawings are for purposes of illustrating environmental structure as well as portions of the design that form no part of the present claimed design.

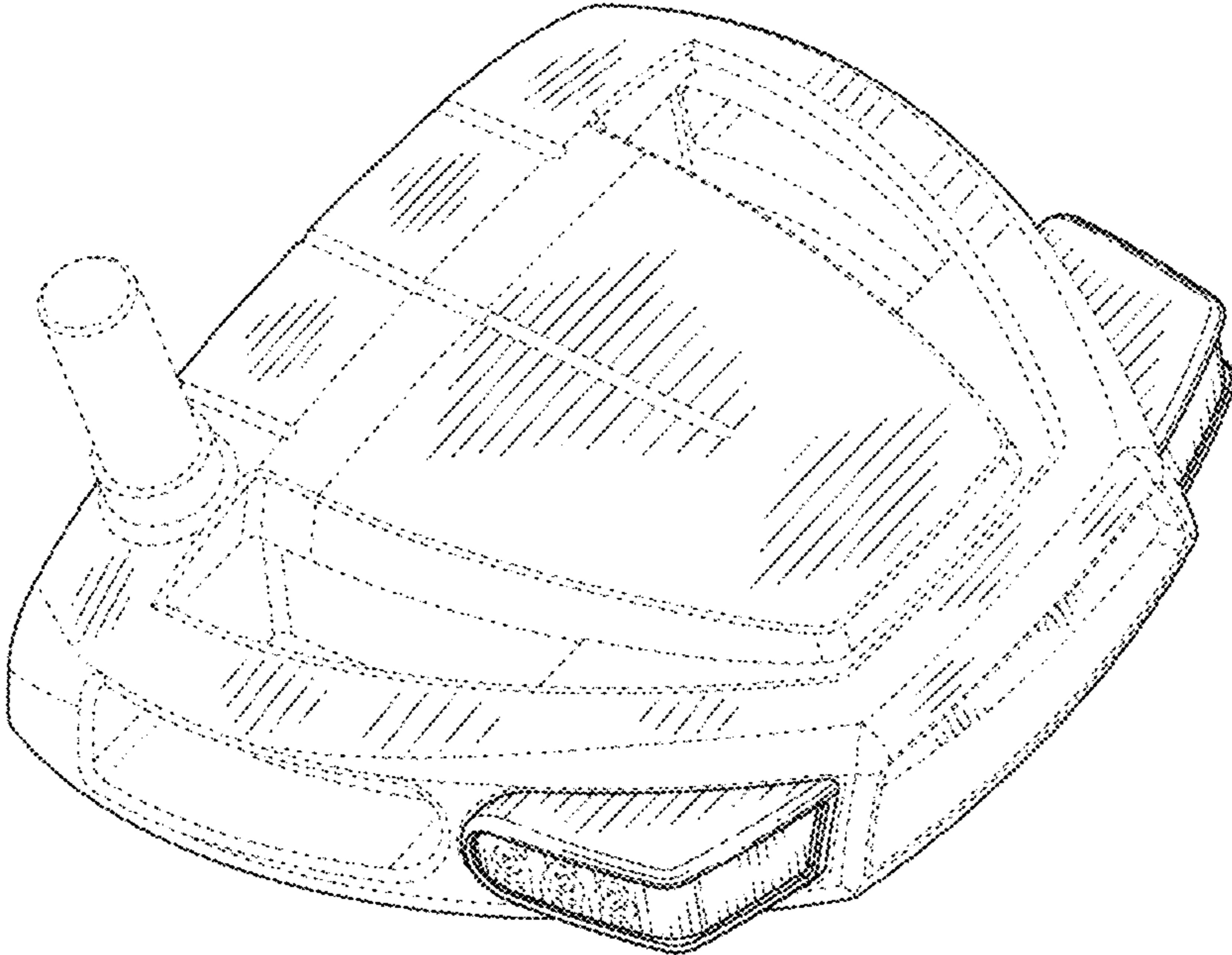

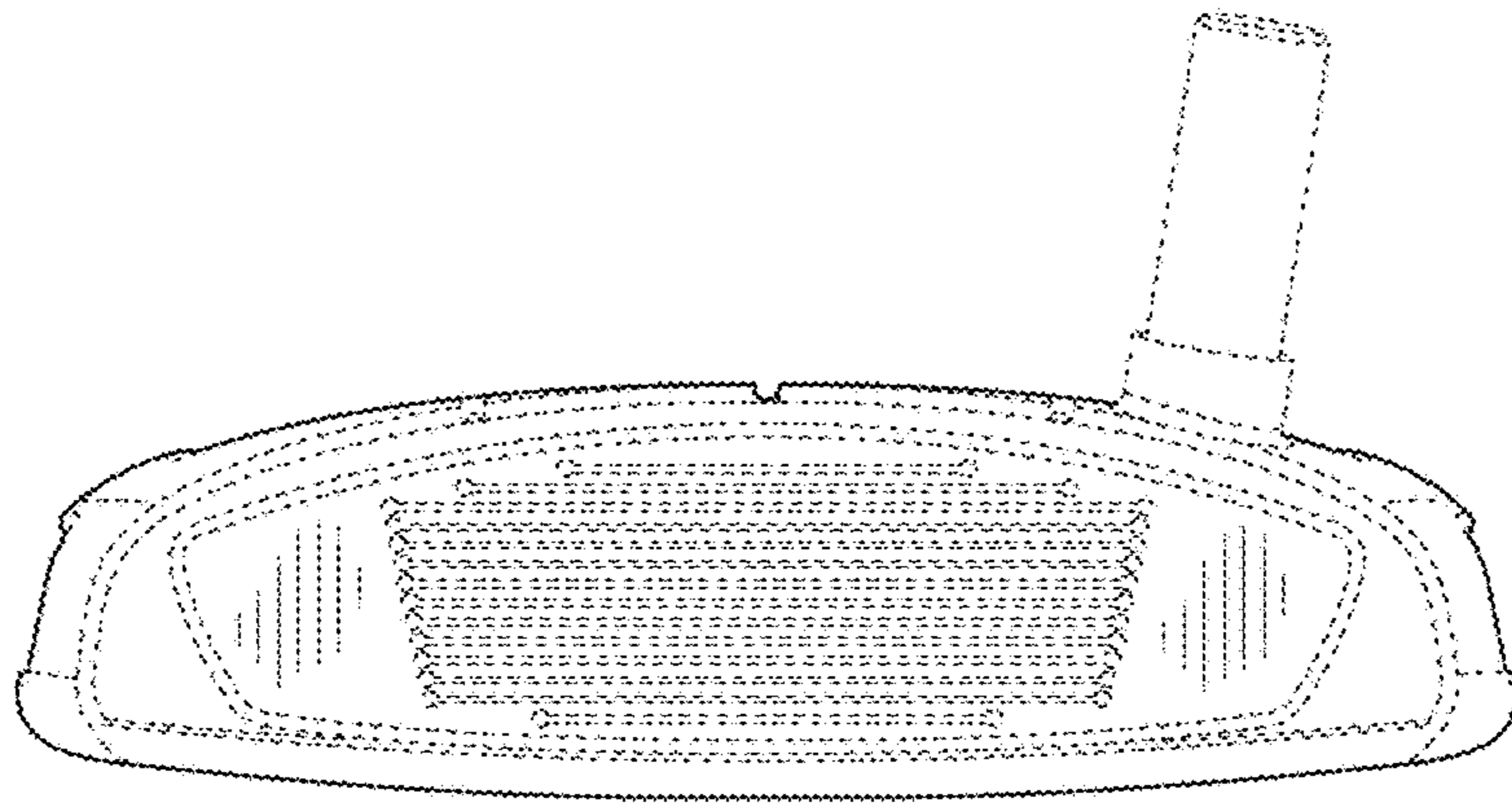

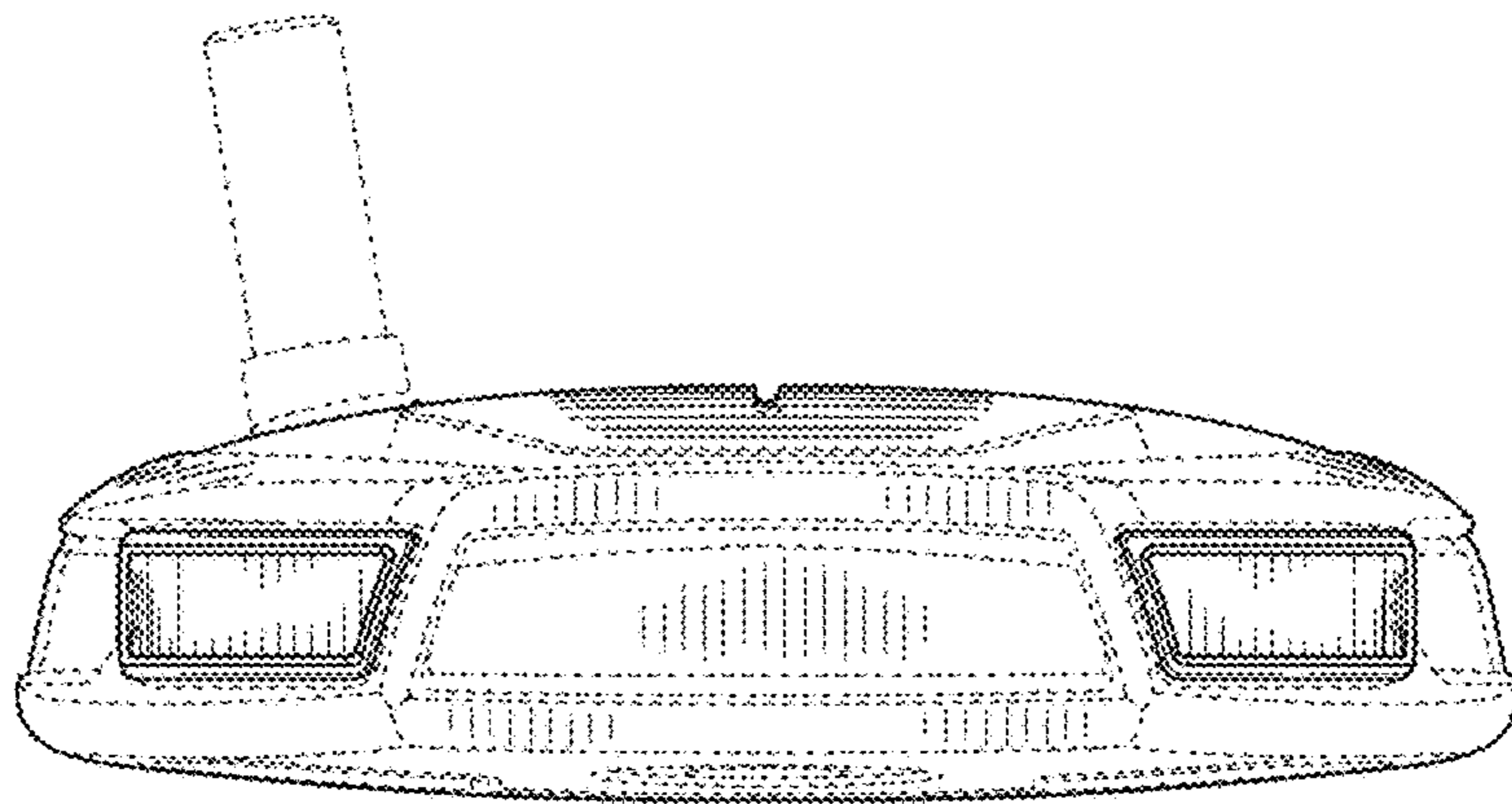

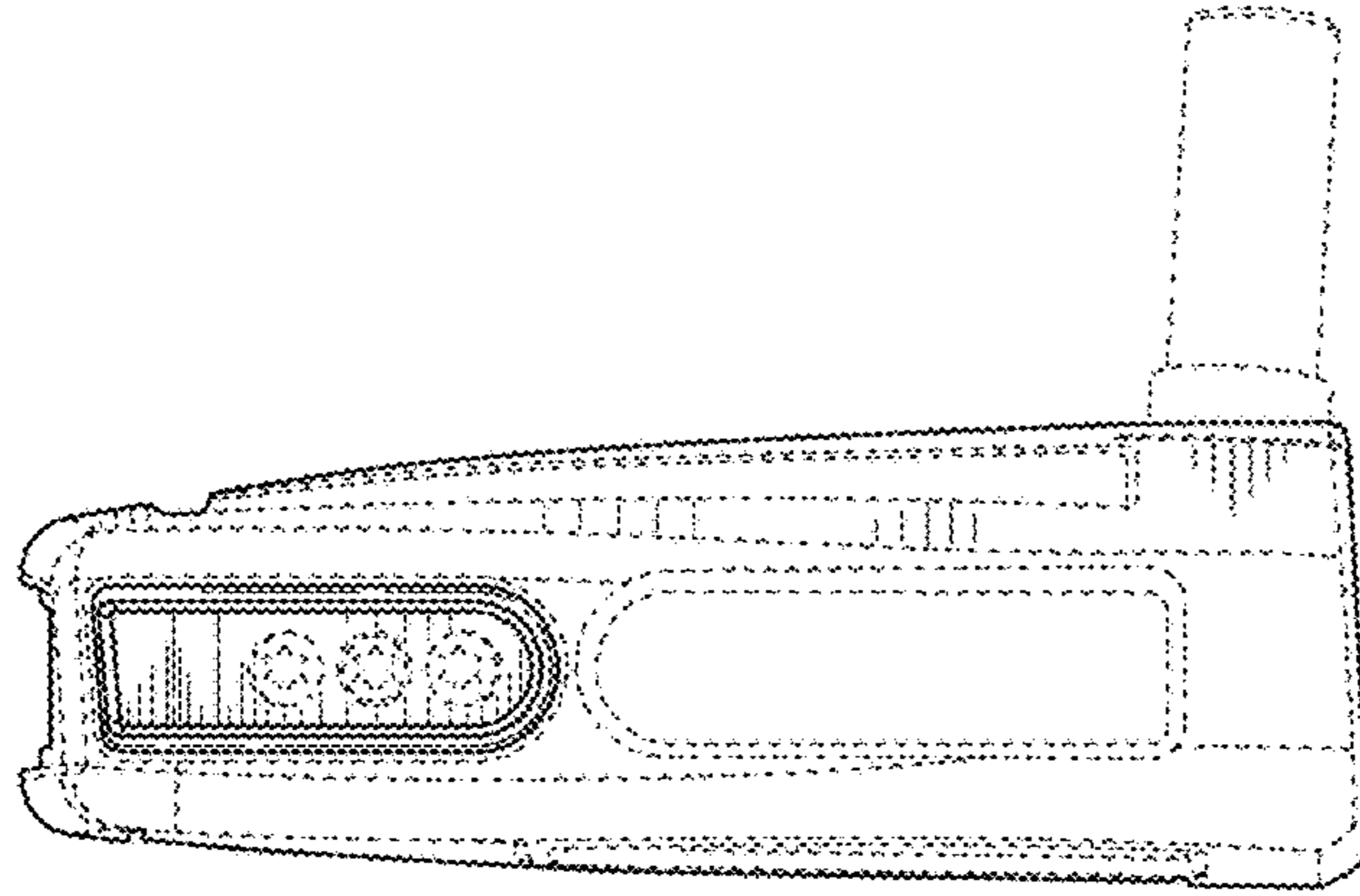

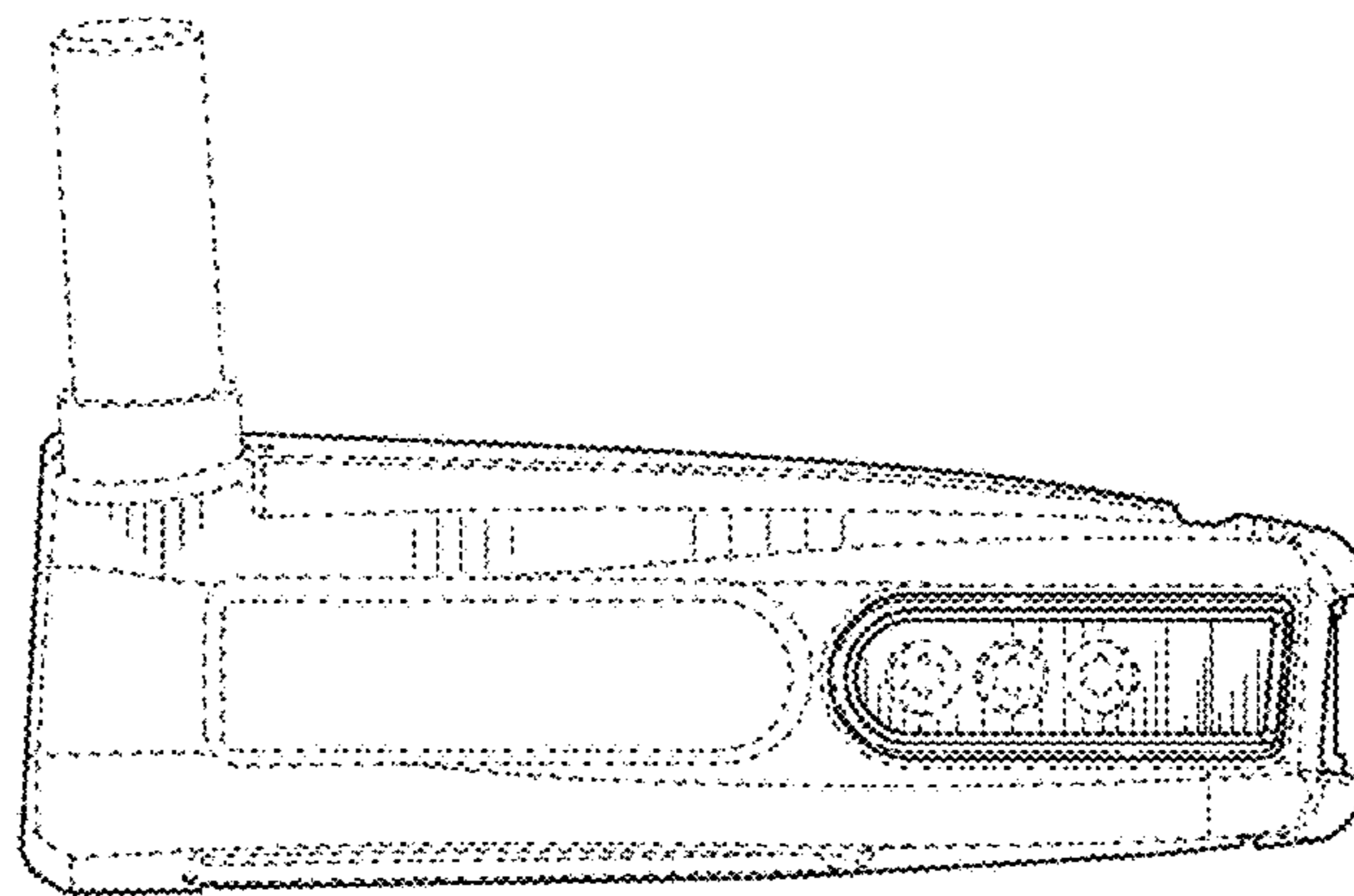

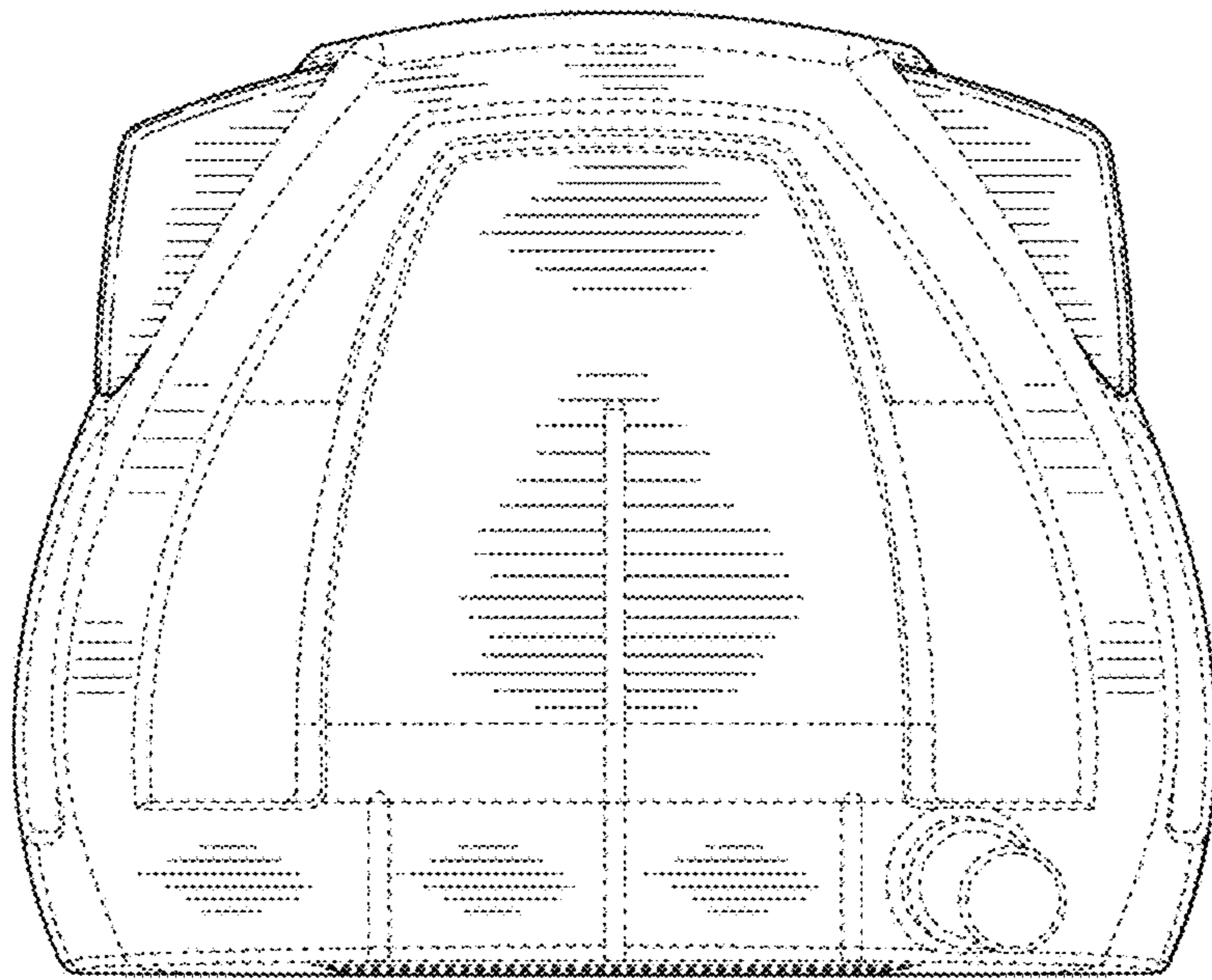

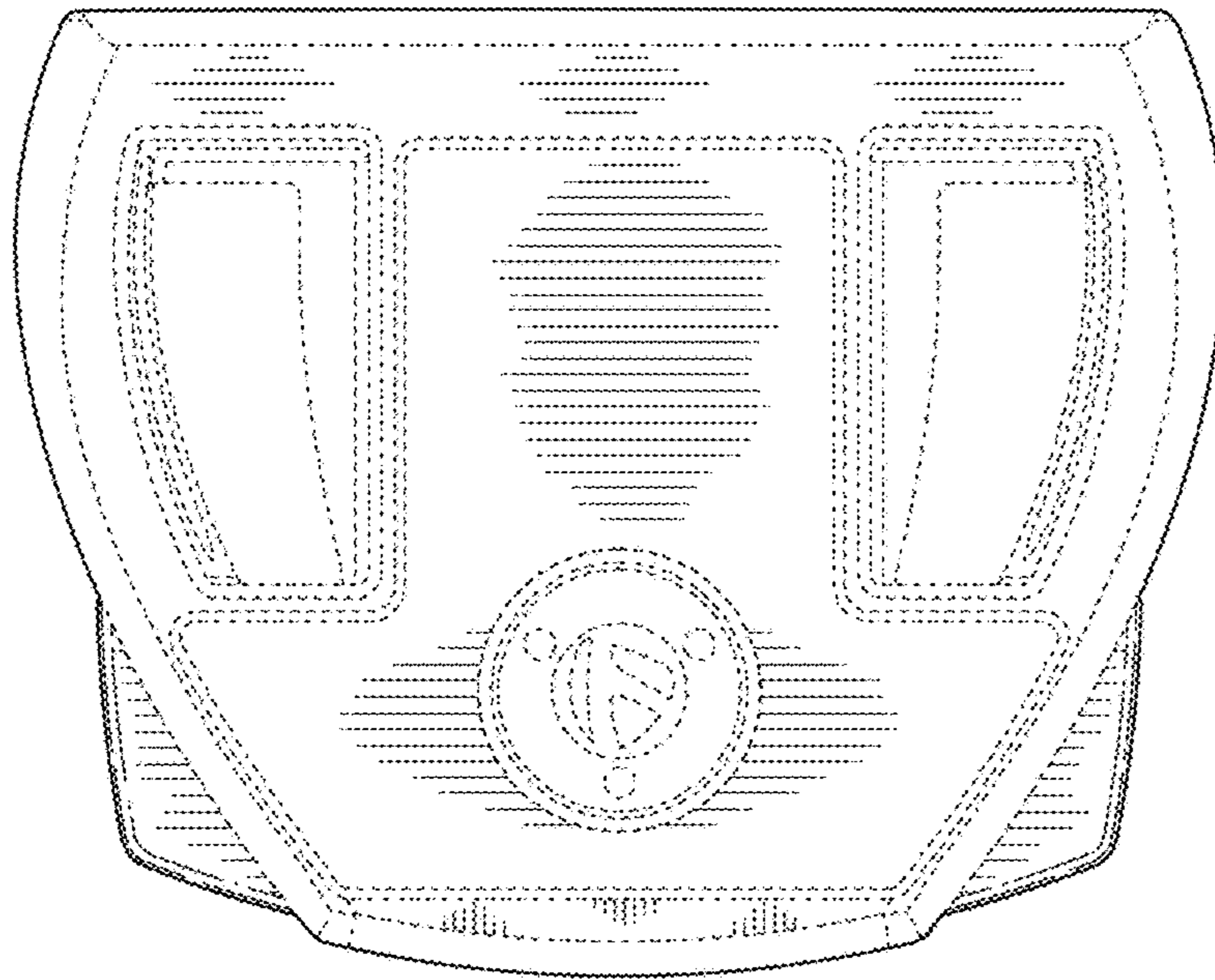
