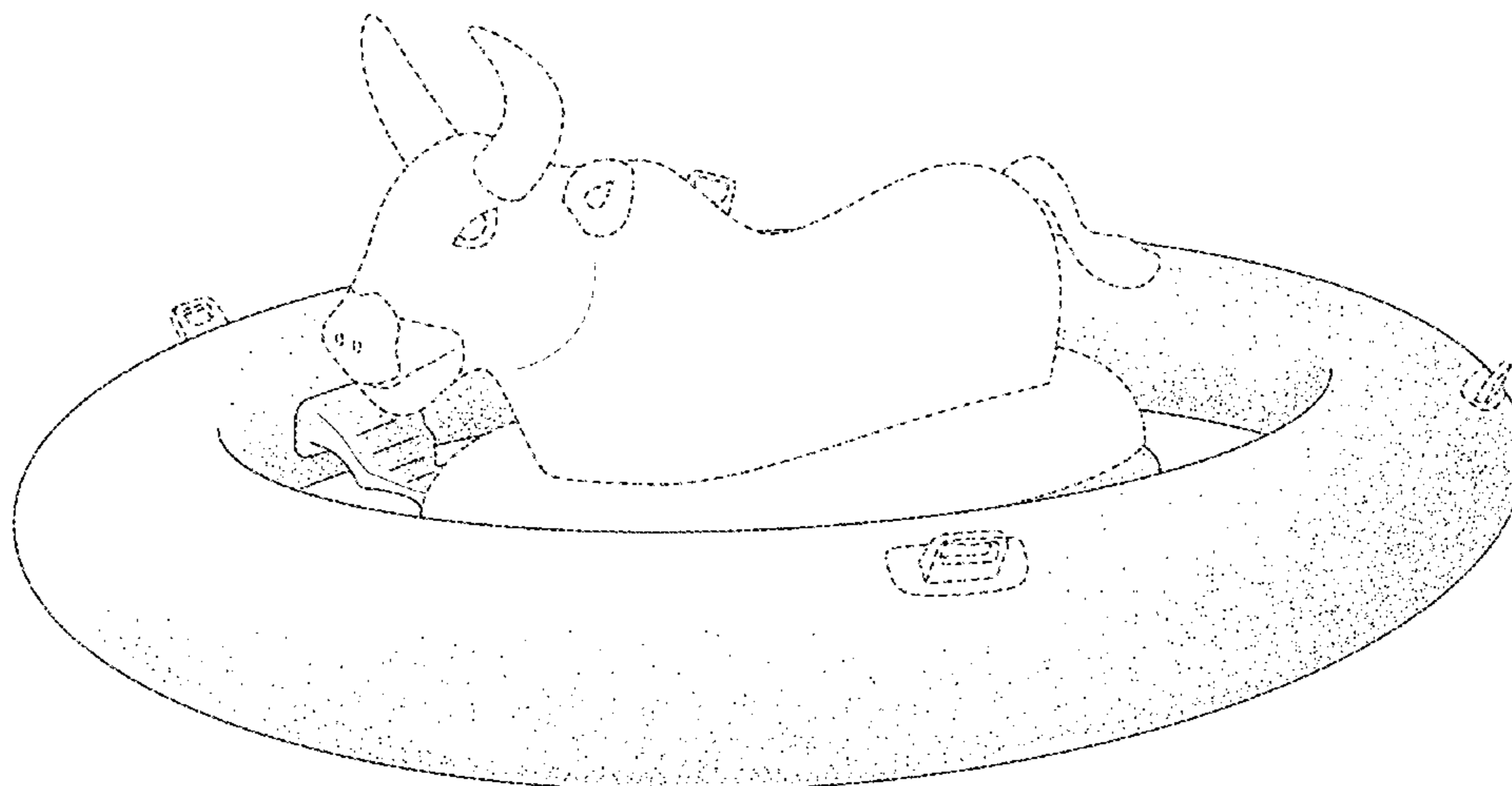
- (57) **CLAIM**

We claim the ornamental design for an inflatable riding toy, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of an inflatable bull;
 FIG. 2 is a front elevational view thereof;
 FIG. 3 is a rear elevational view thereof;
 FIG. 4 is a right side elevational view thereof;
 FIG. 5 is a left side elevational view thereof;
 FIG. 6 is a top plan view thereof; and,
 FIG. 7 is a bottom plan view thereof.
 The broken lines in FIGS. 1-7 represent portions of the inflatable bull that form no part of the claimed design.

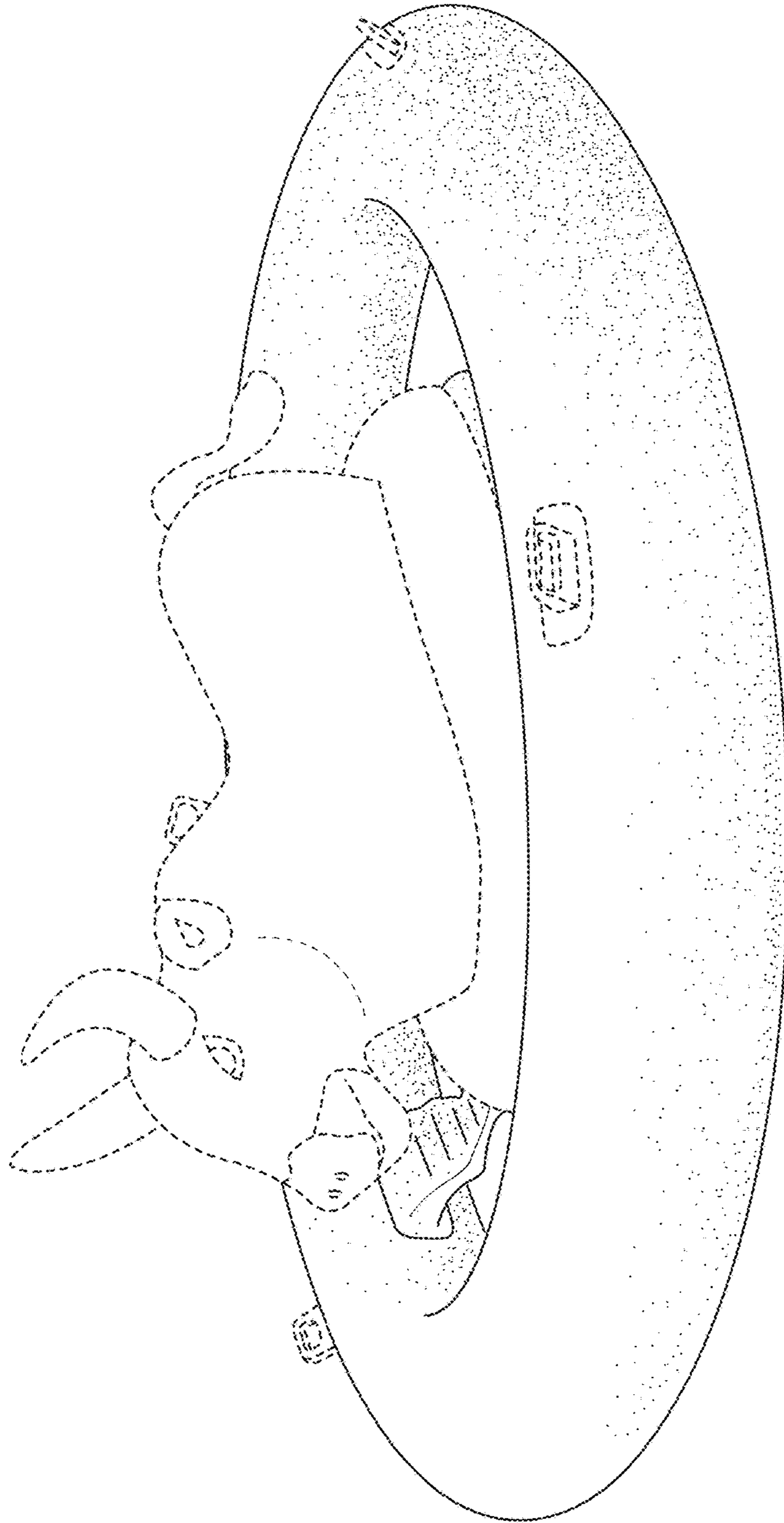

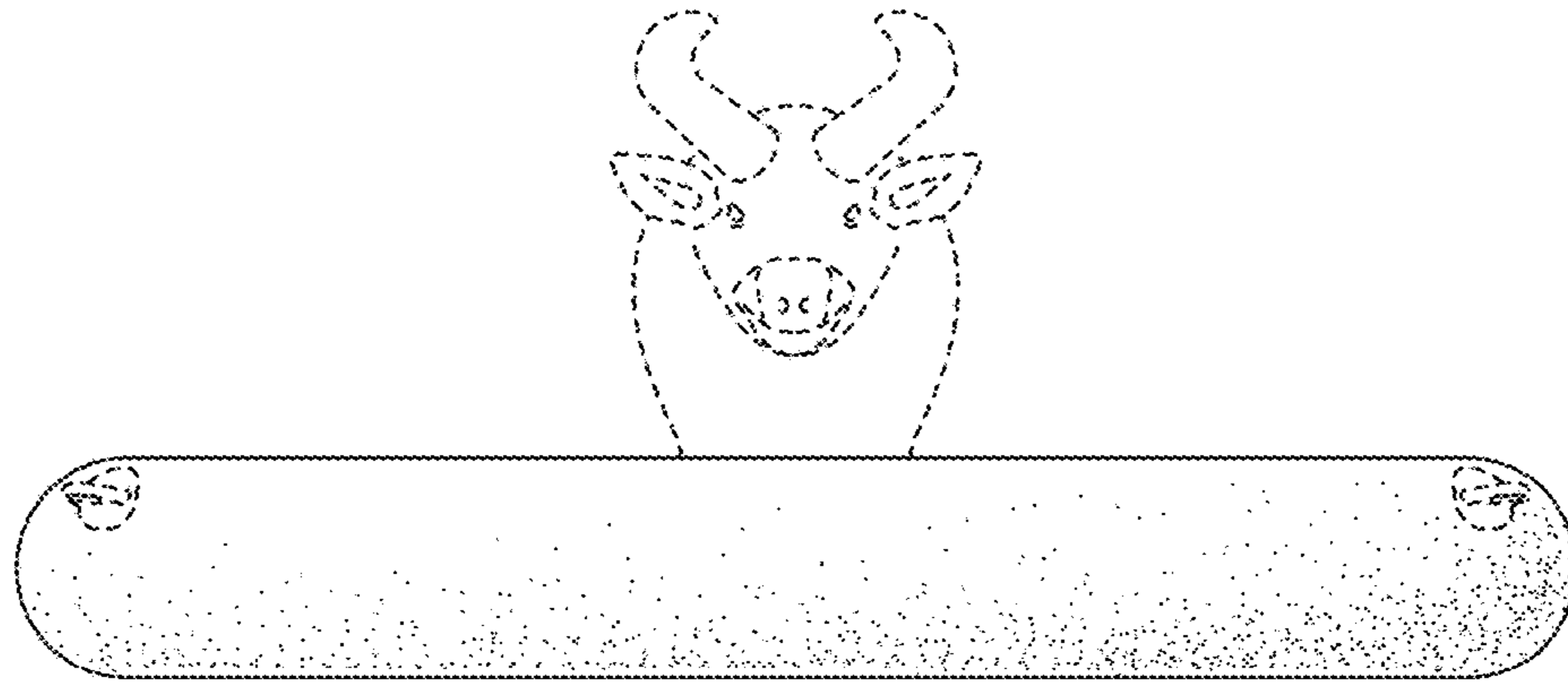

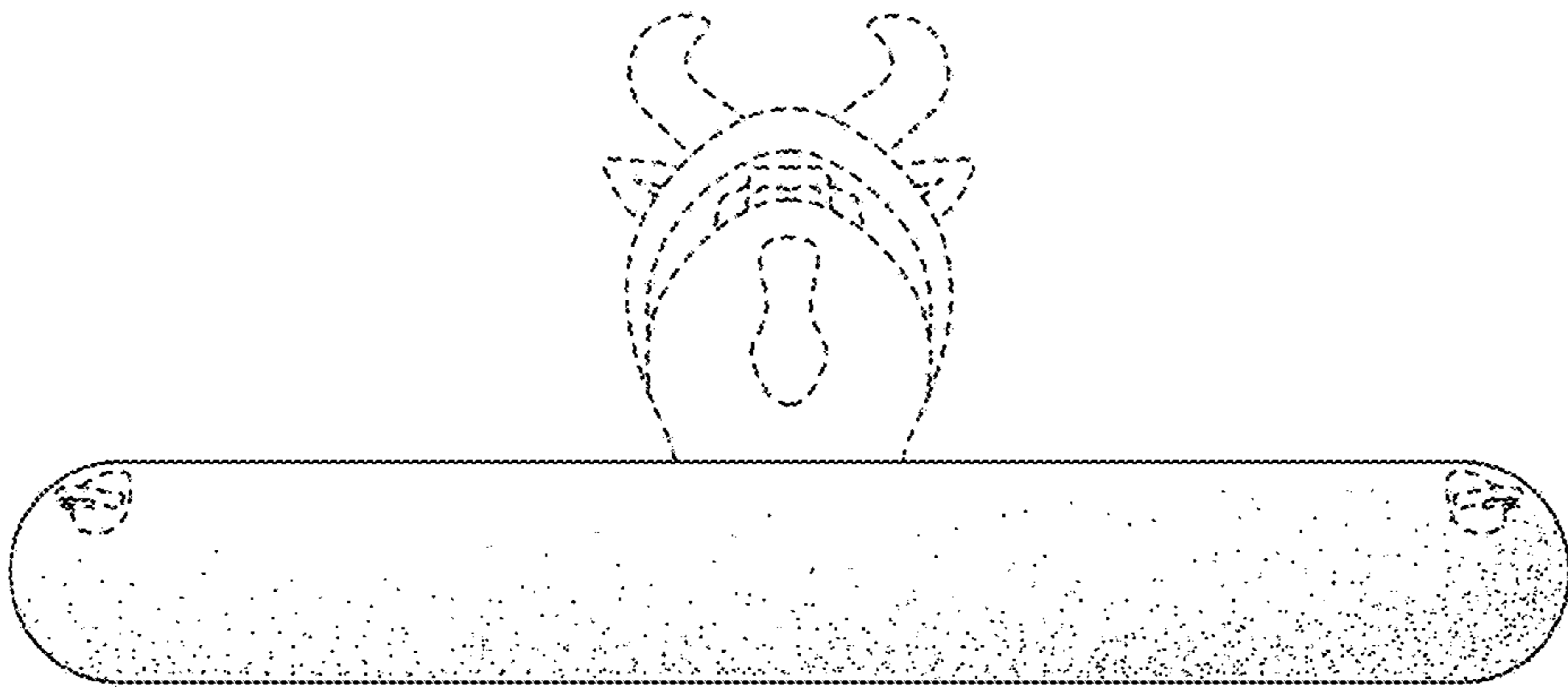

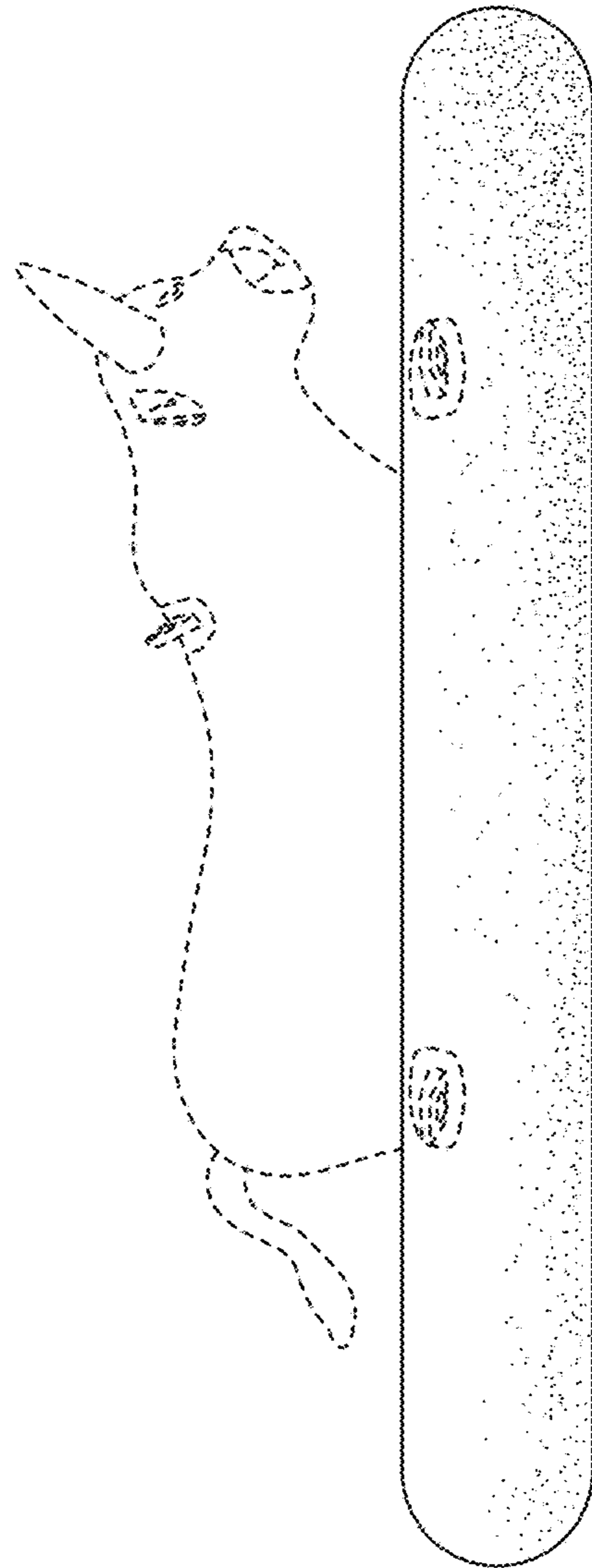

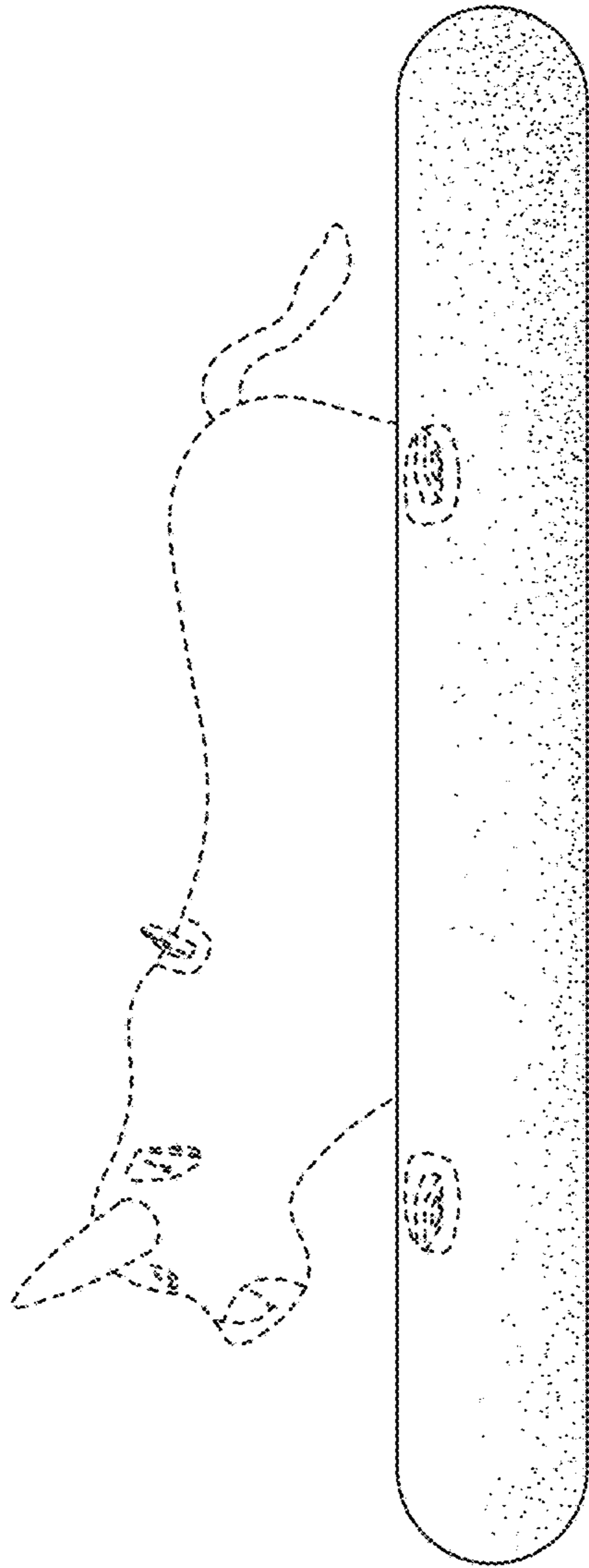

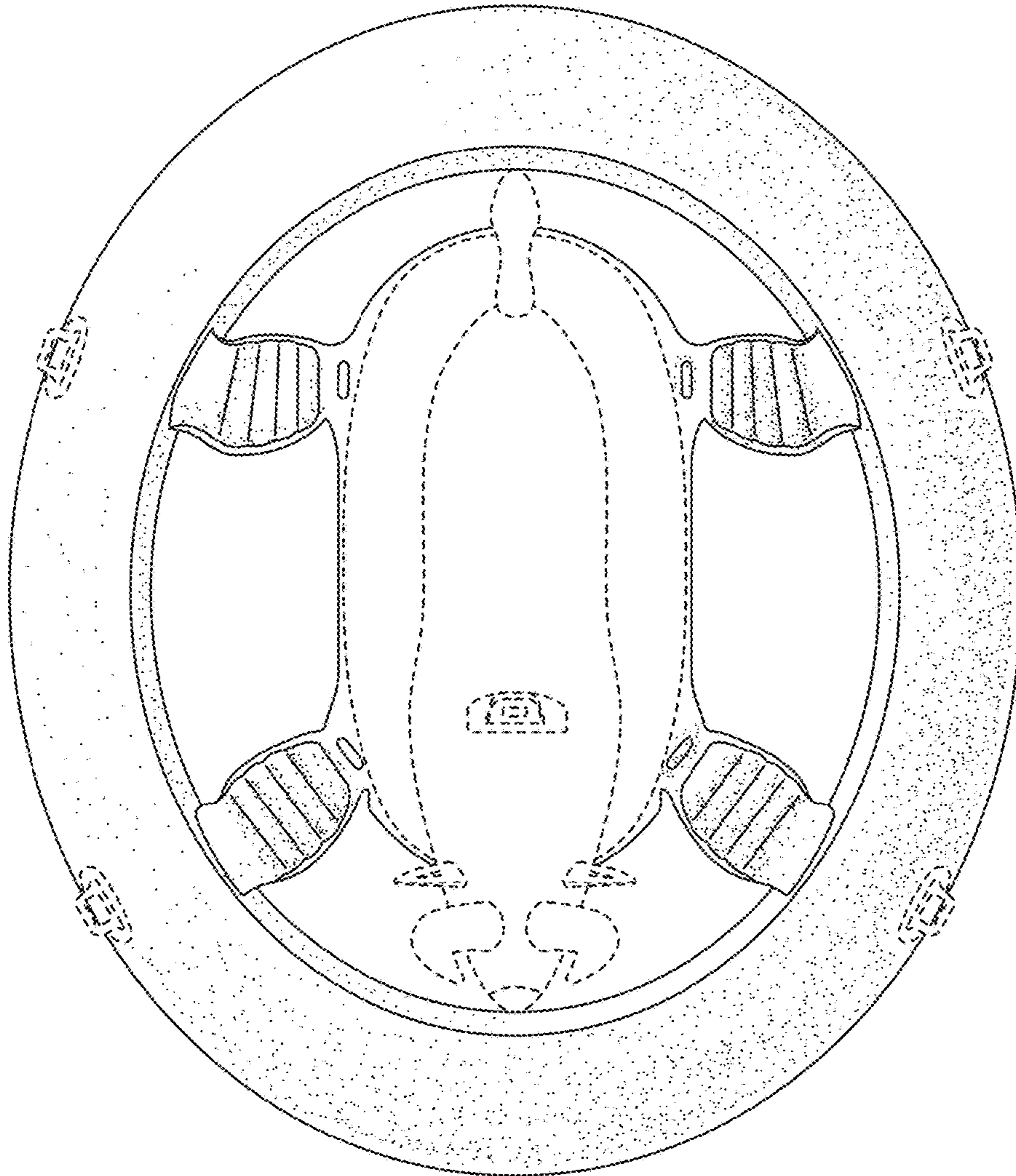

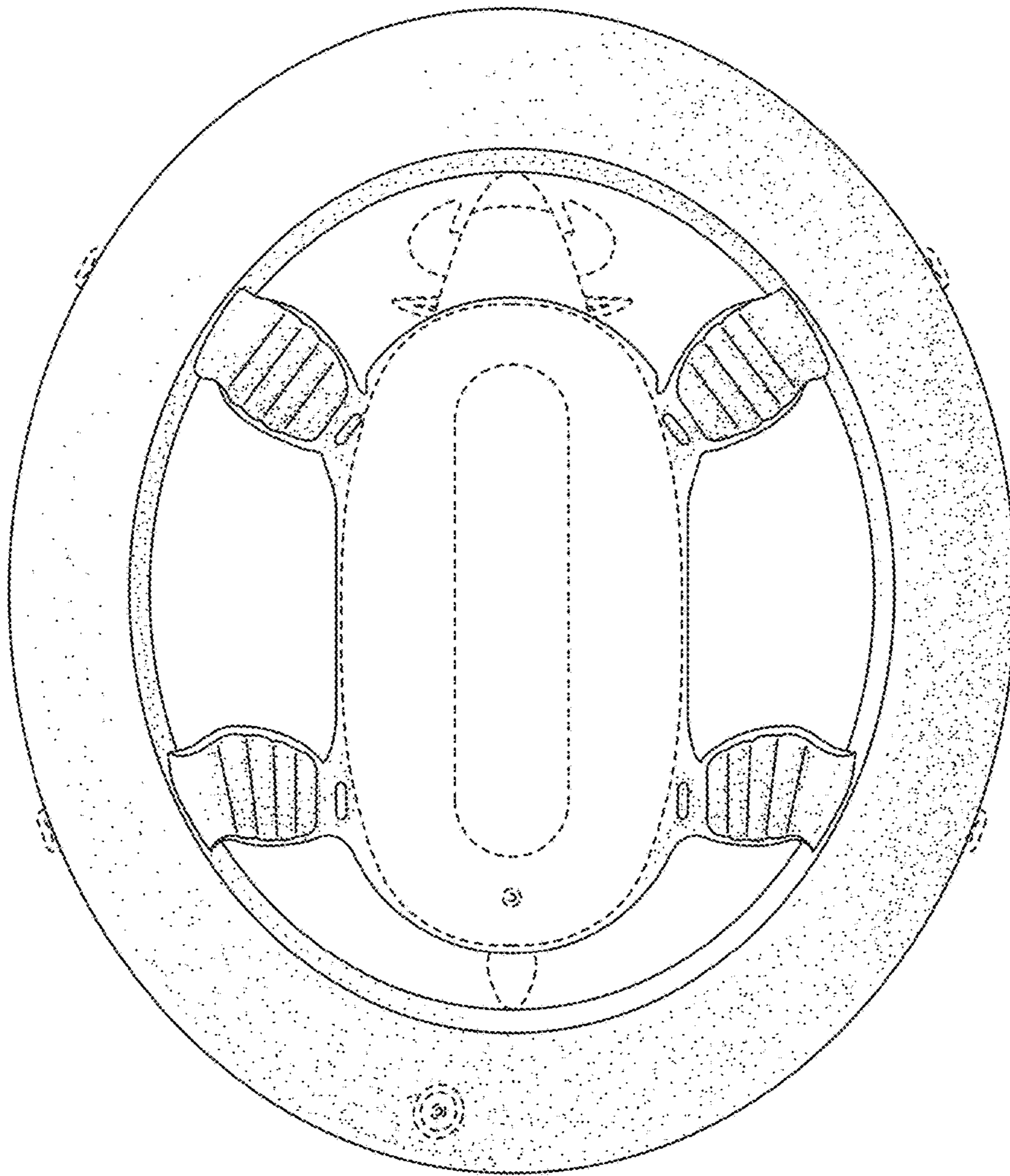
