The ornamental design for an air freshener dispenser, as shown and described.

DESCRIPTION

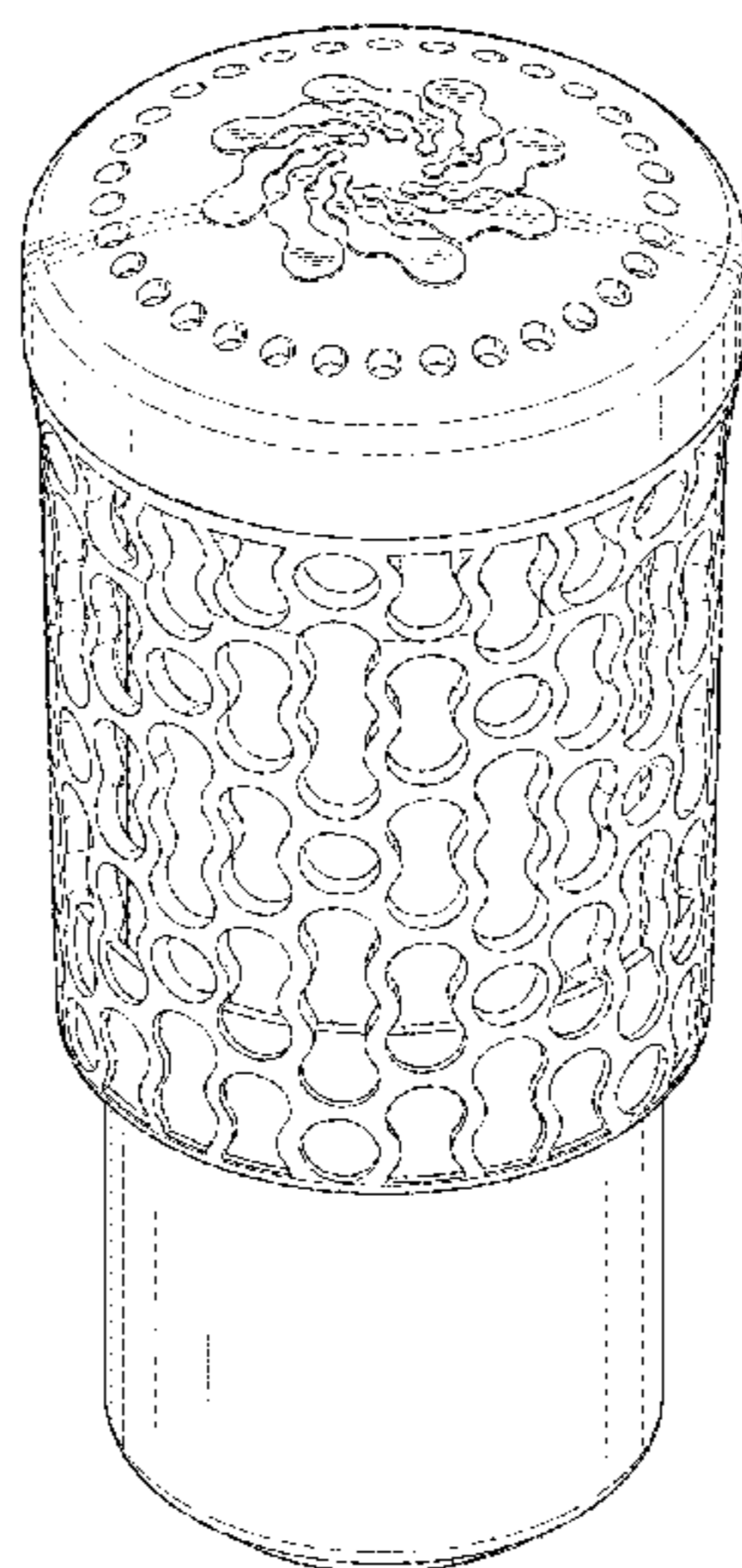
FIG. 1 is a perspective view of an air freshener dispenser in an inactive position showing my new design;
FIG. 2 is another perspective view of the air freshener dispenser of FIG. 1;
FIG. 3 is a perspective view of the air freshener dispenser in an activated position;

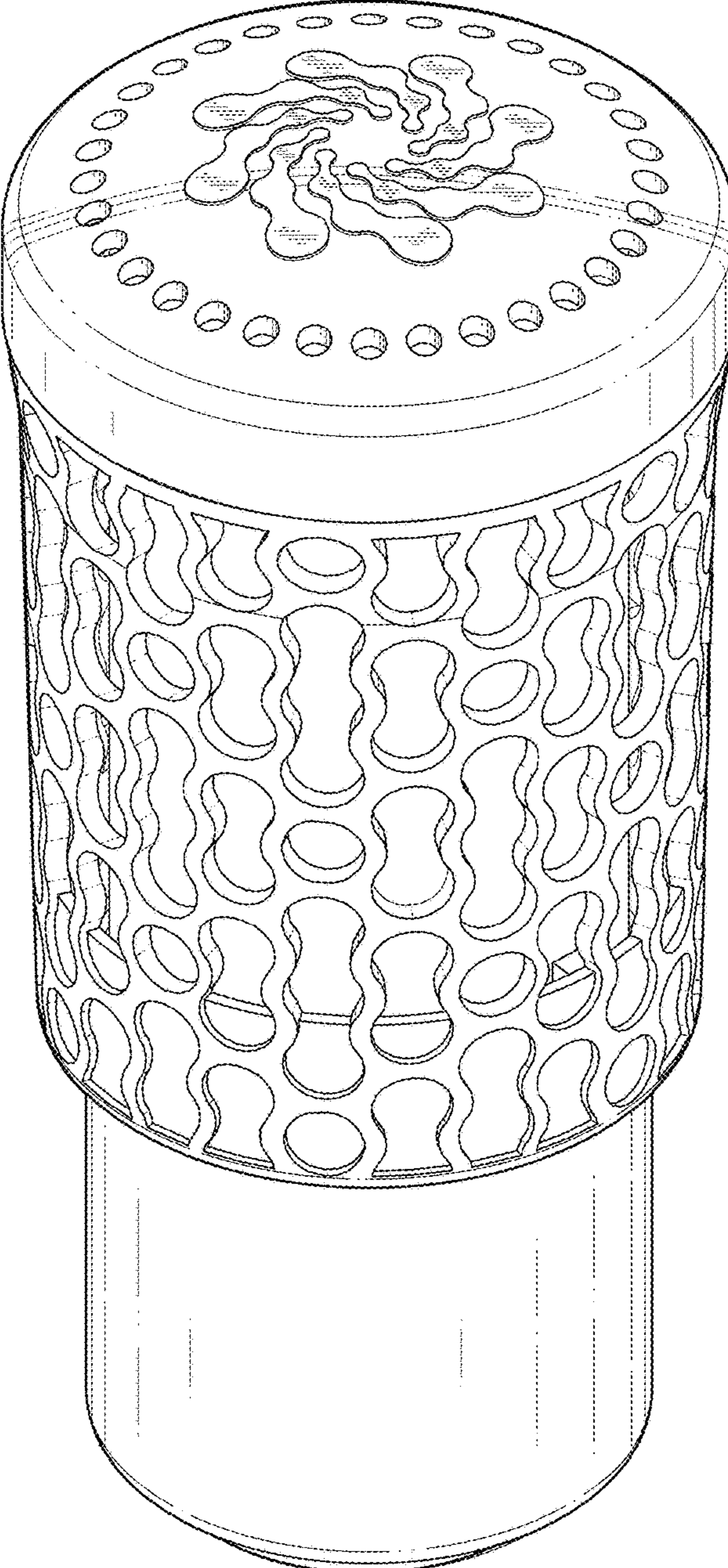

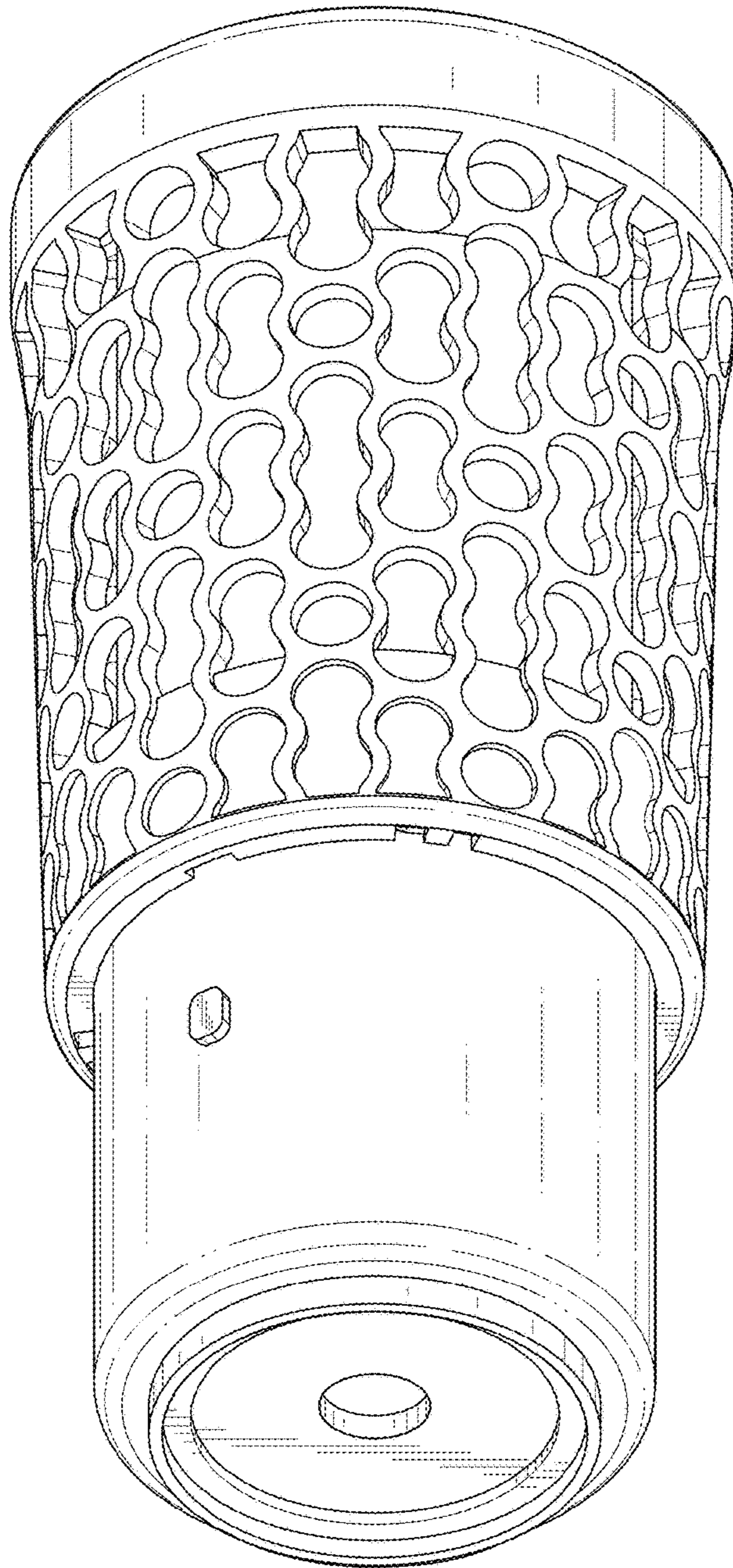

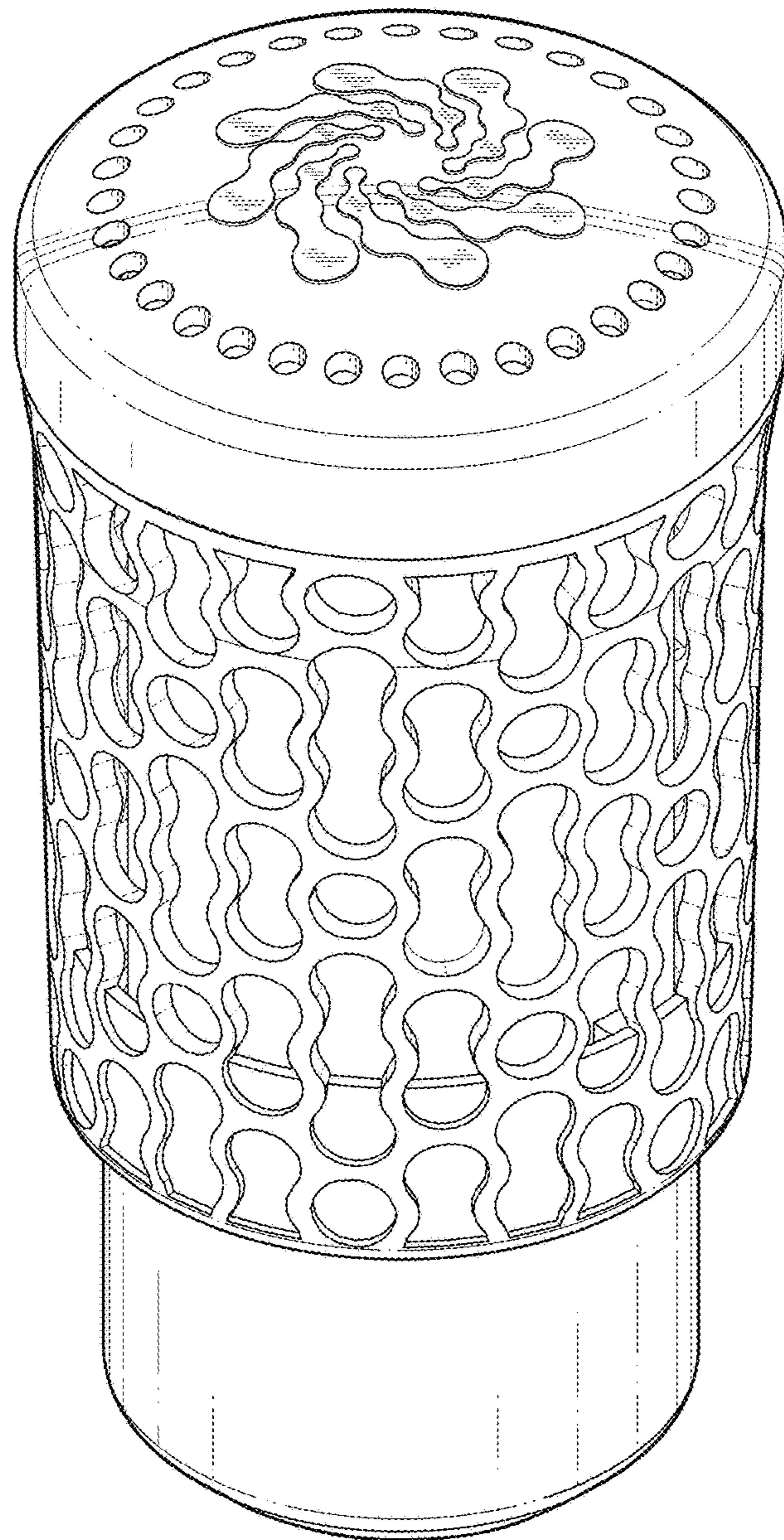

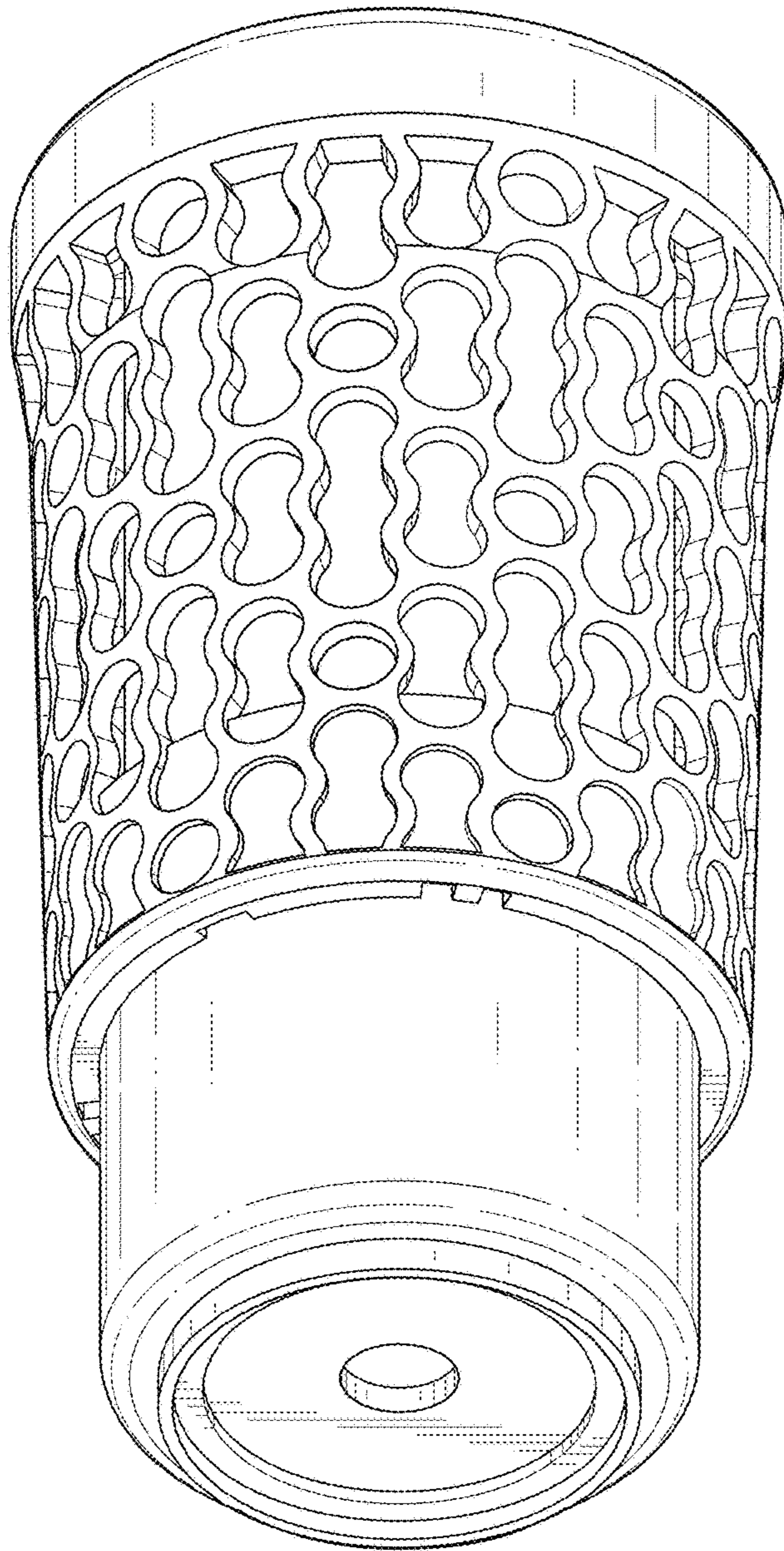

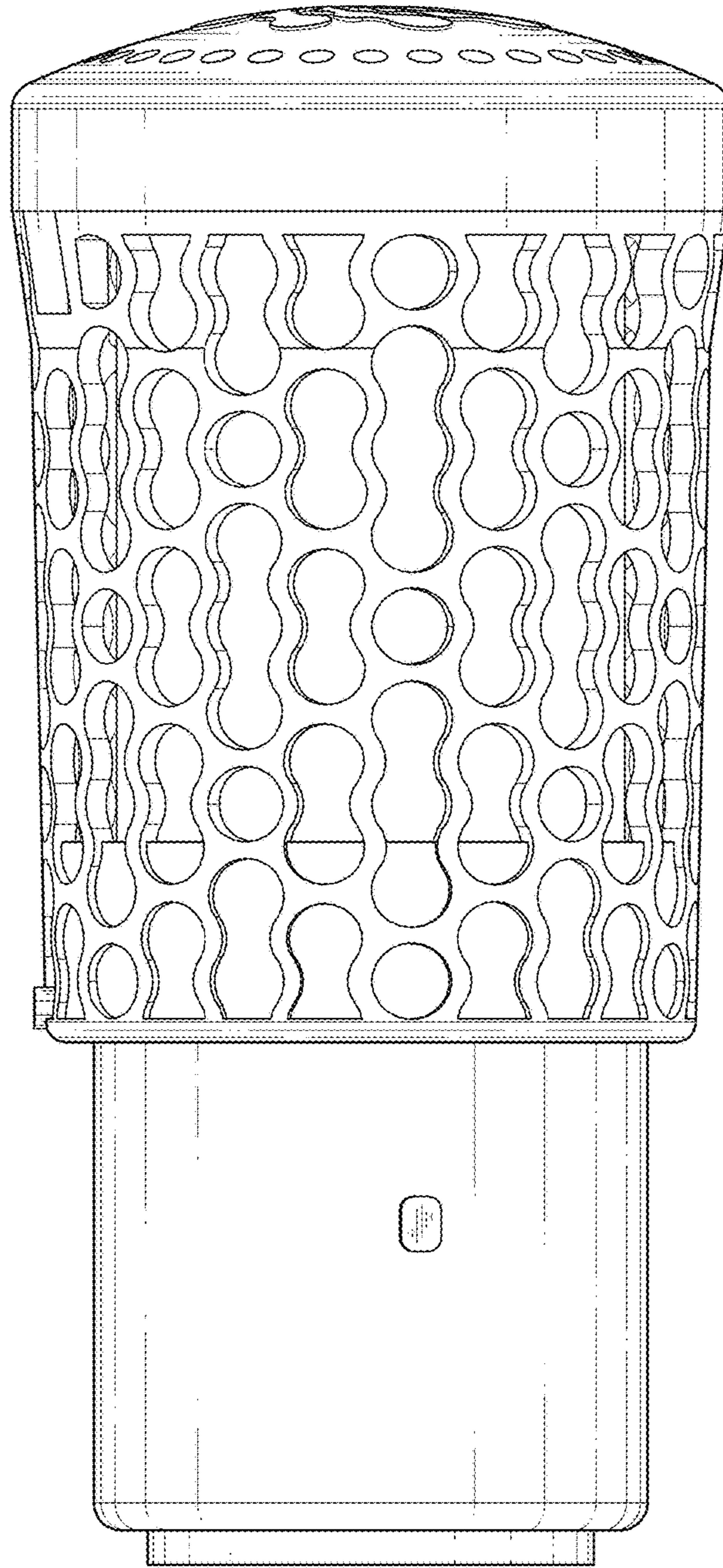

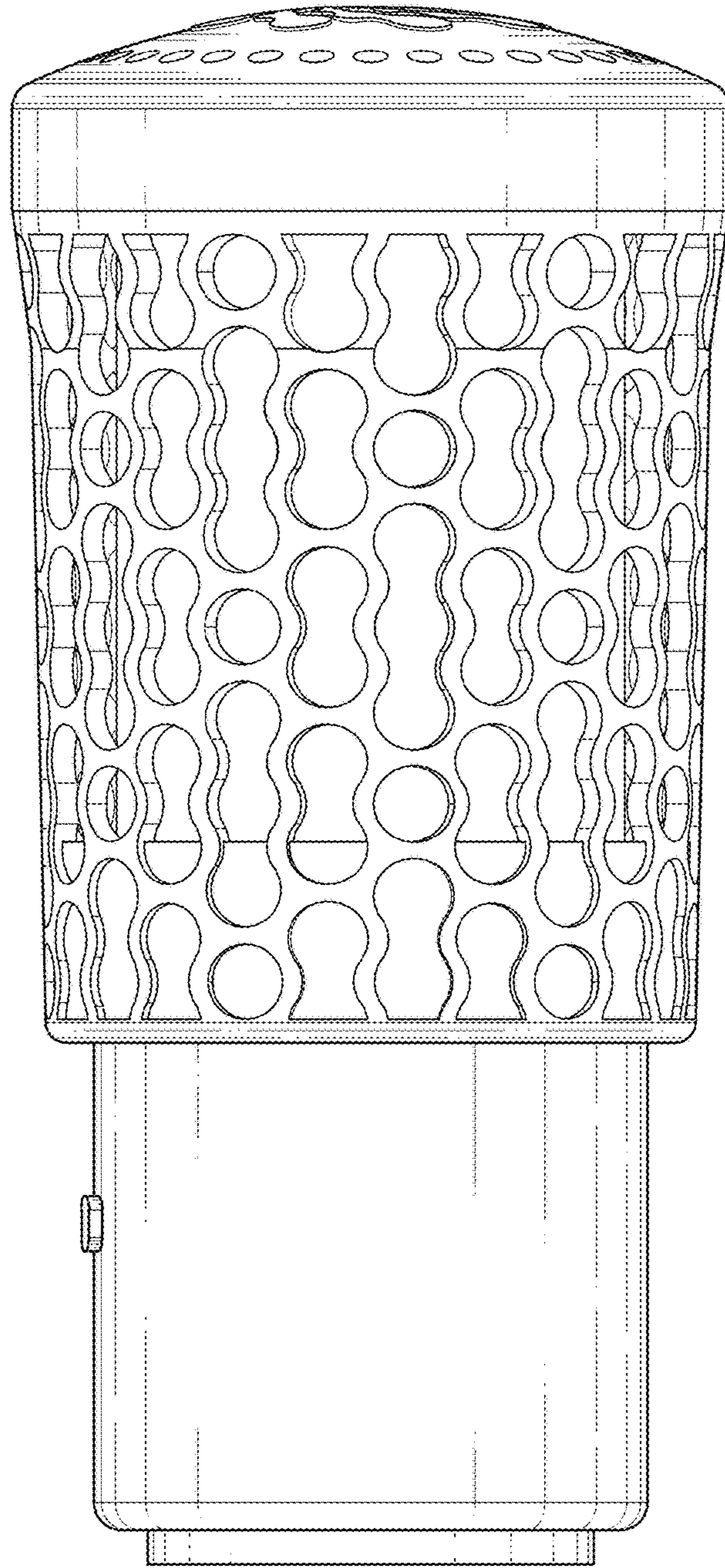

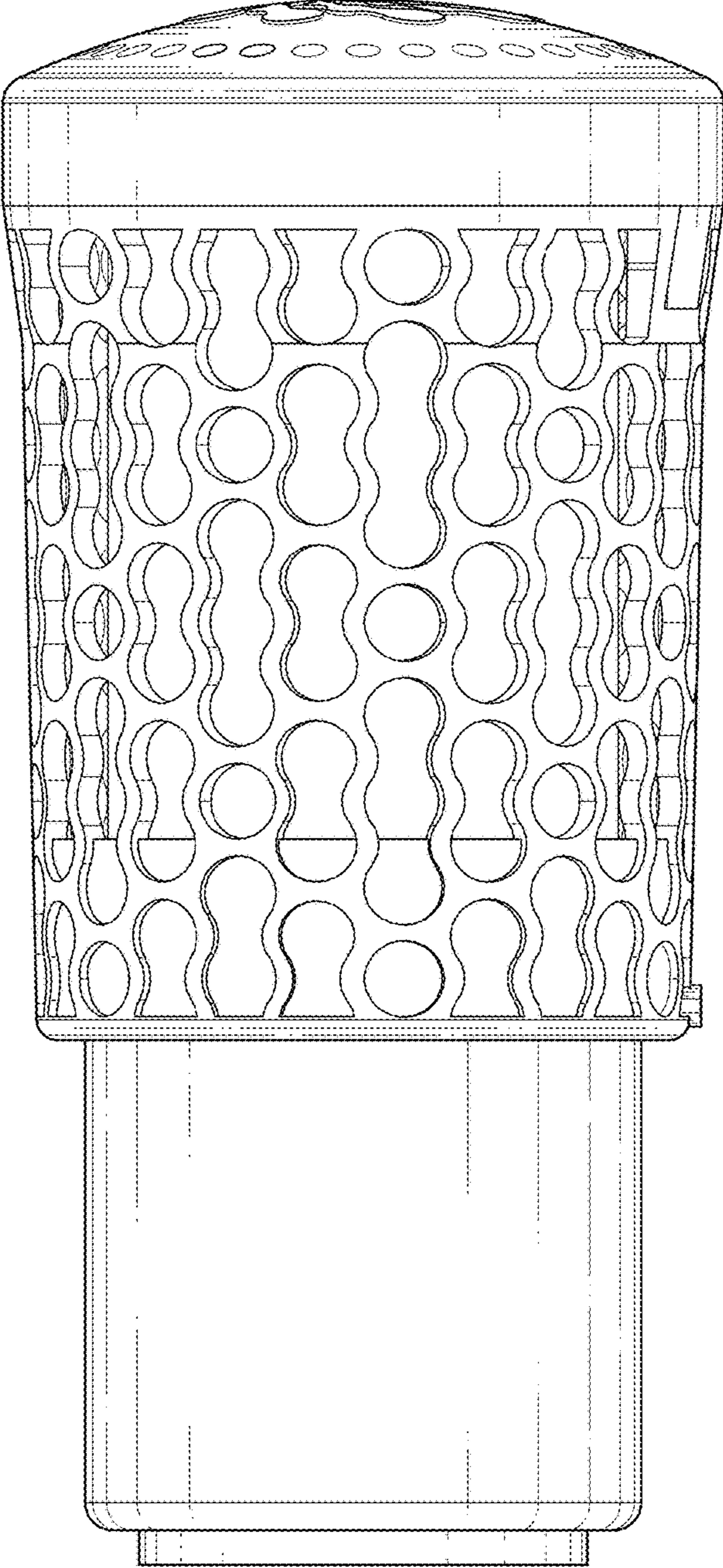

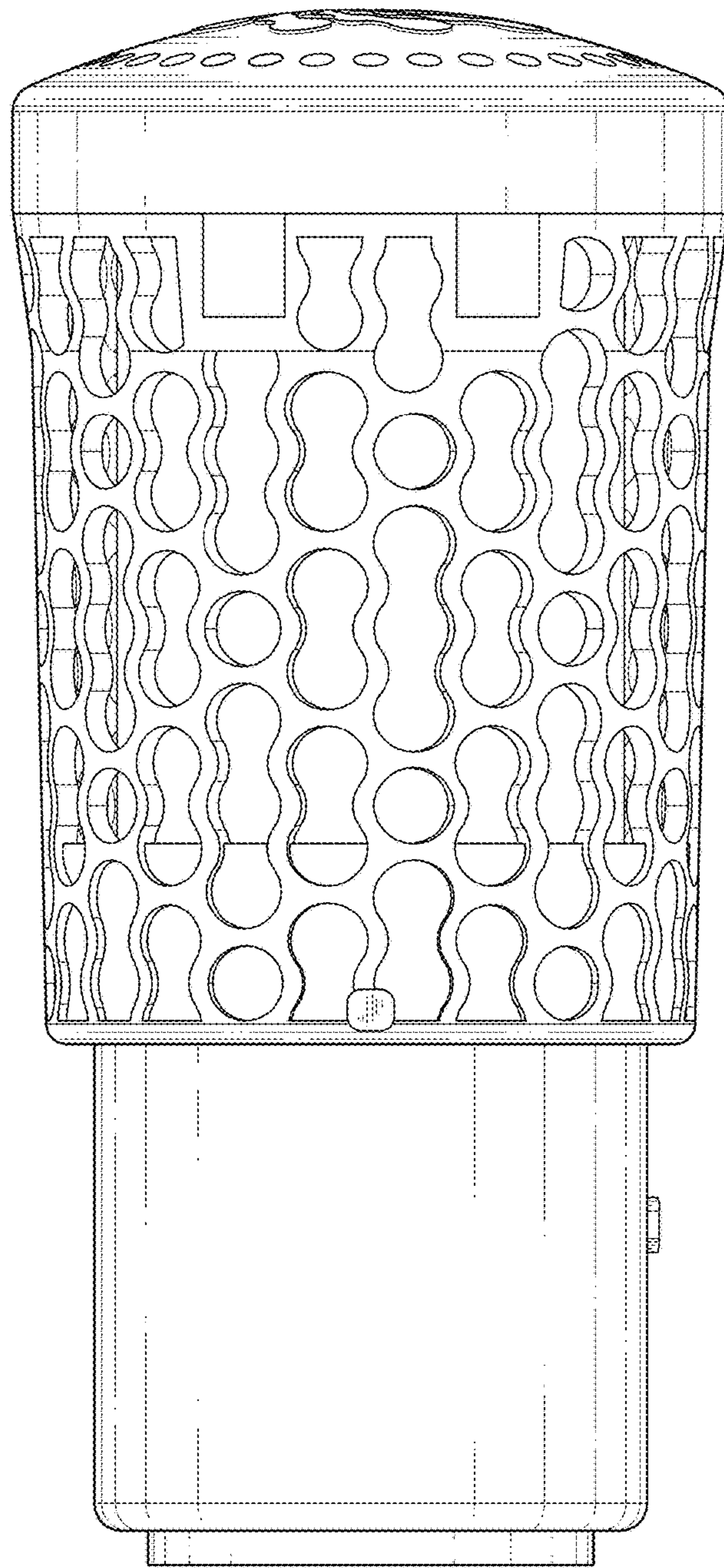

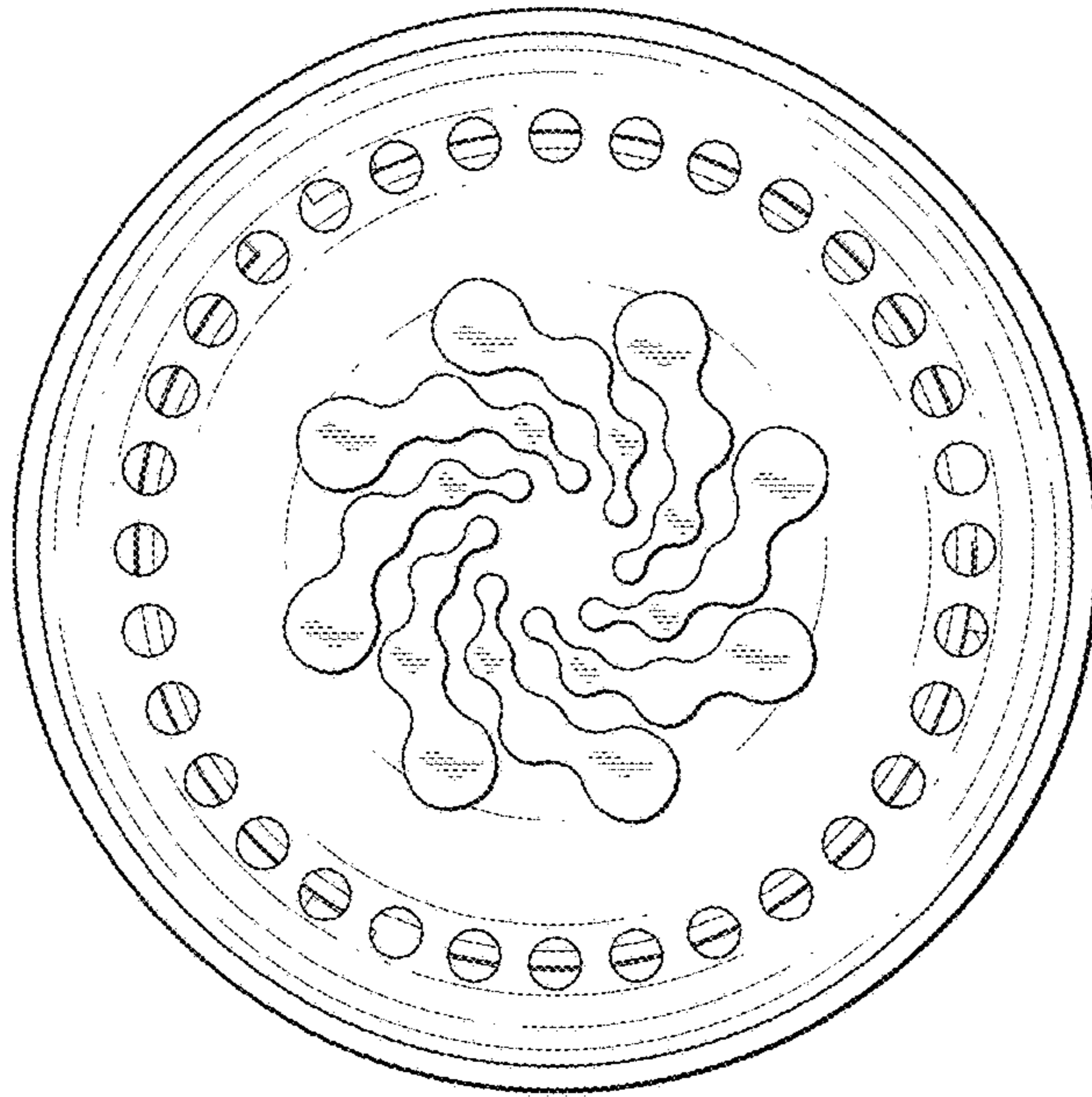

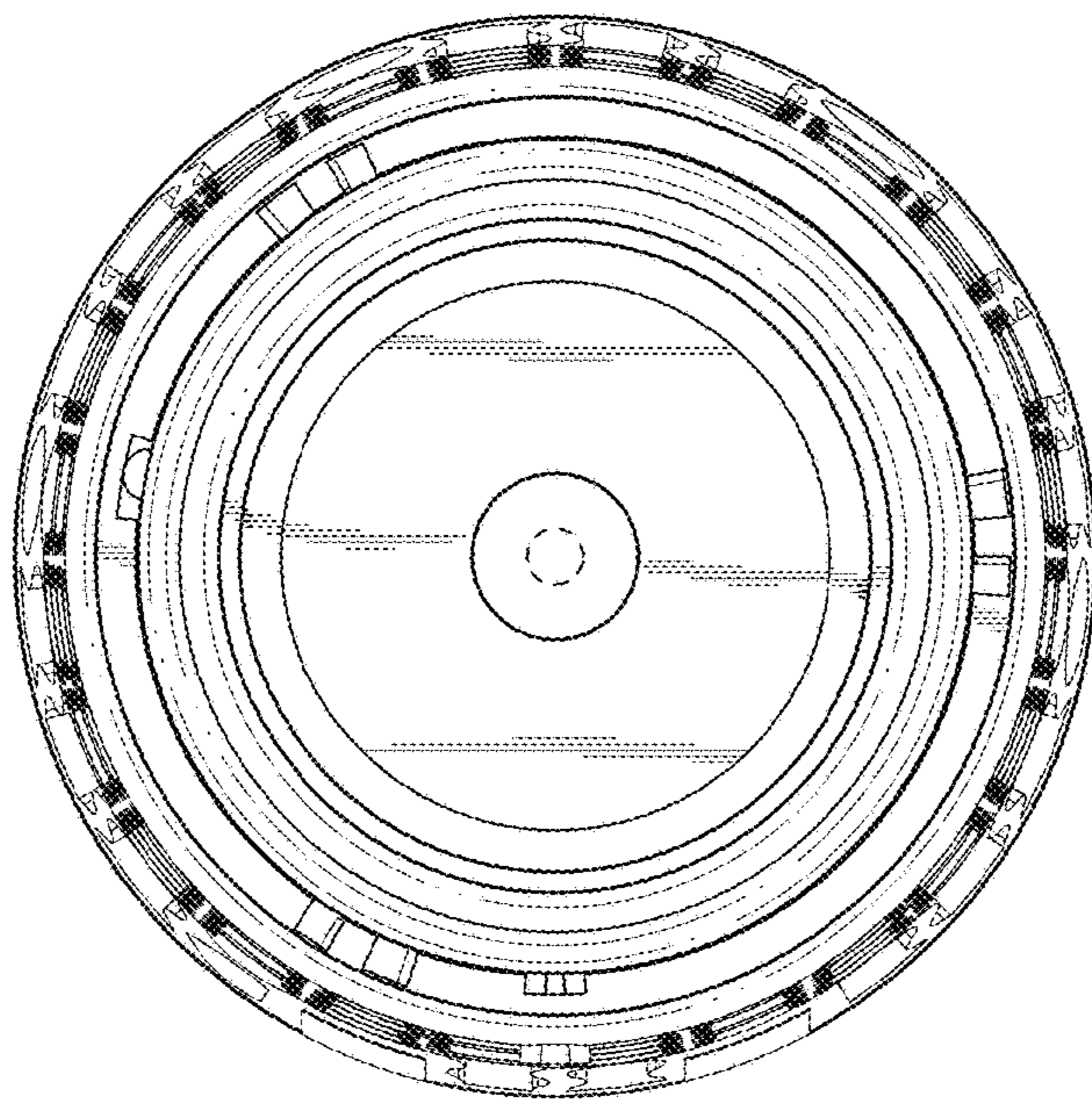
