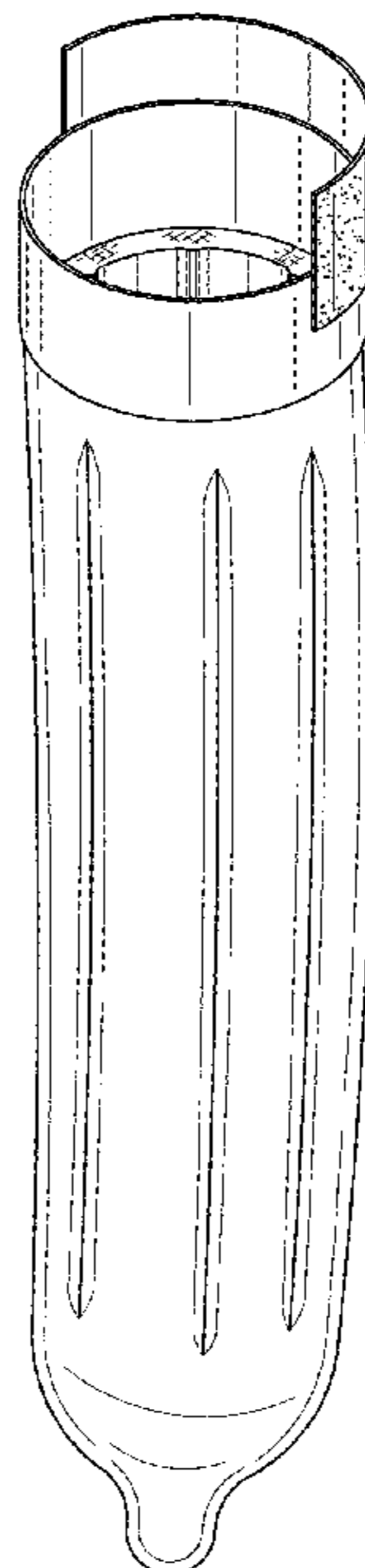

FIG. 1 is a front elevation view of an absorbent penis sheath showing my new design, the opposite side being a mirror image of the shown;
FIG. 2 is a left side elevation view thereof;

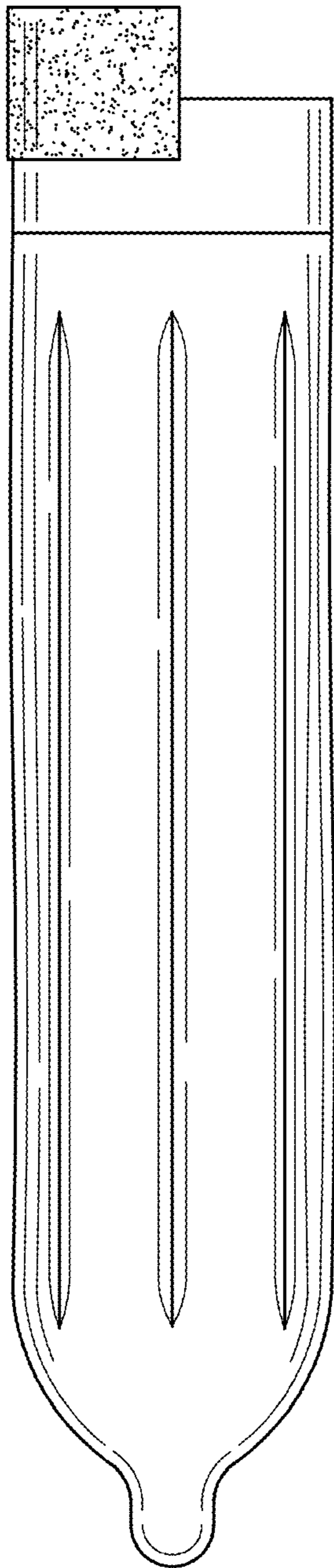

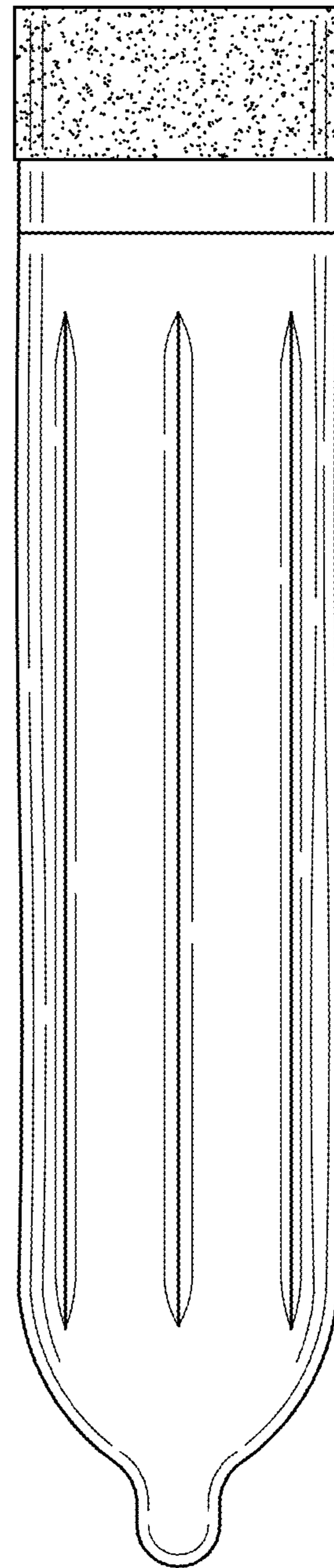

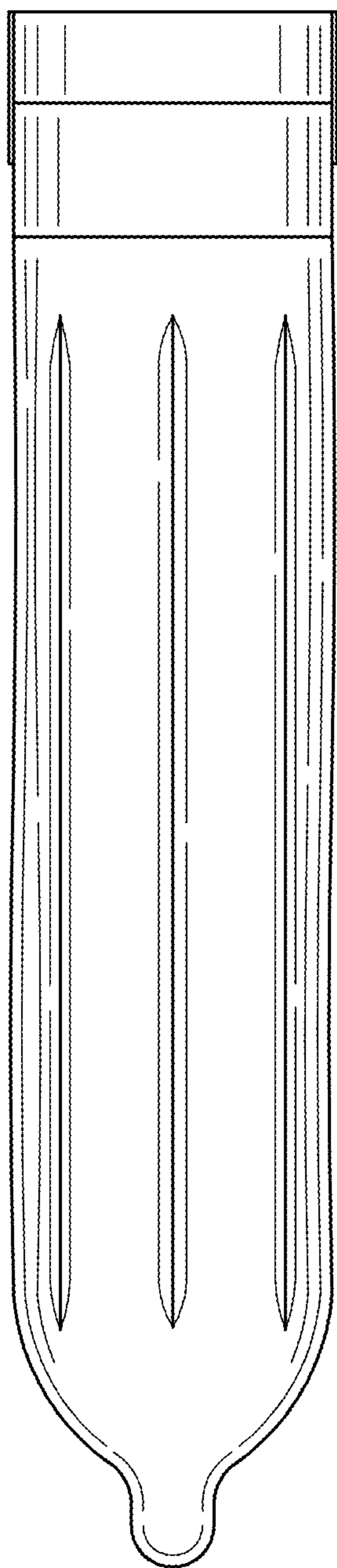

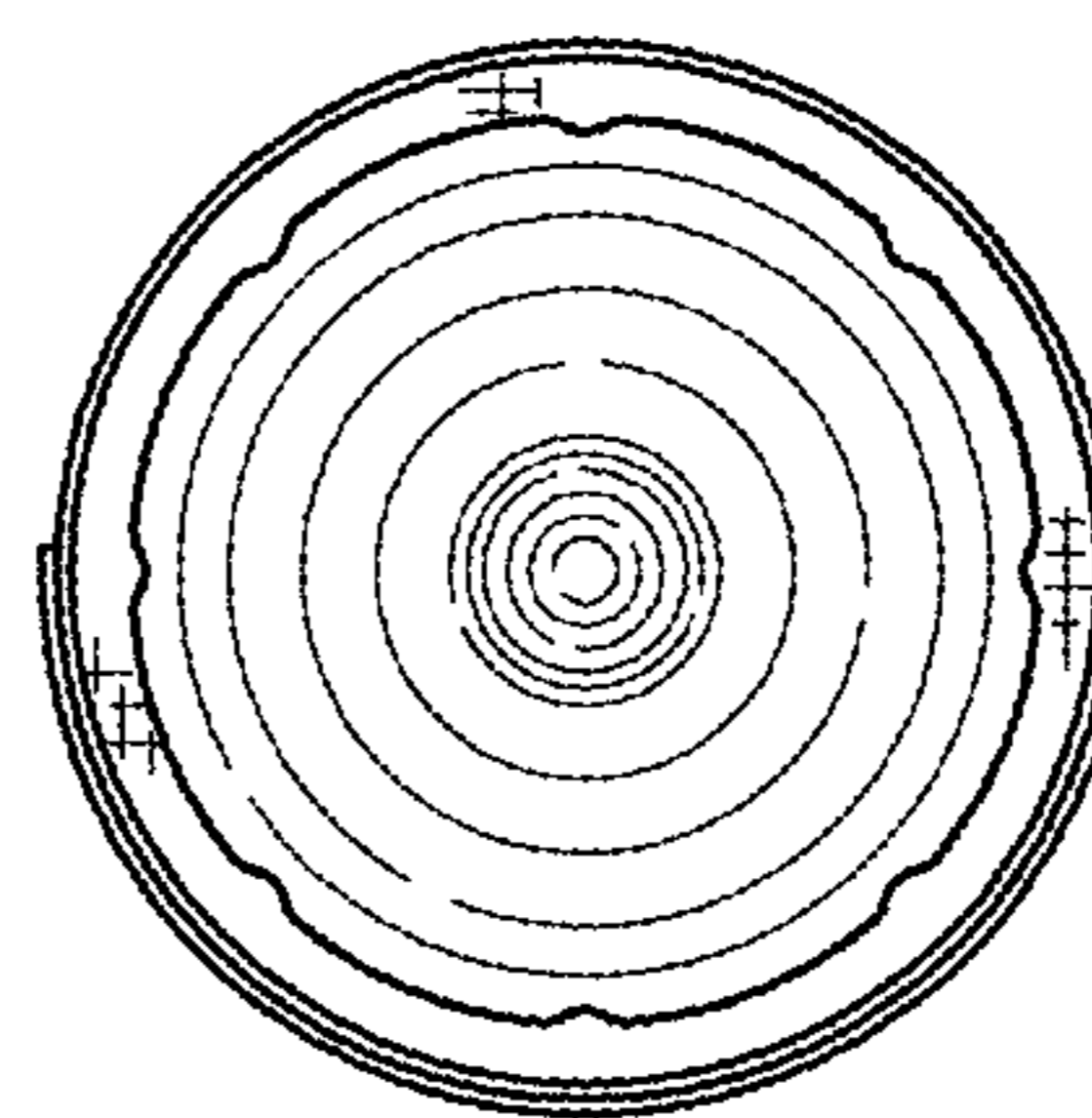

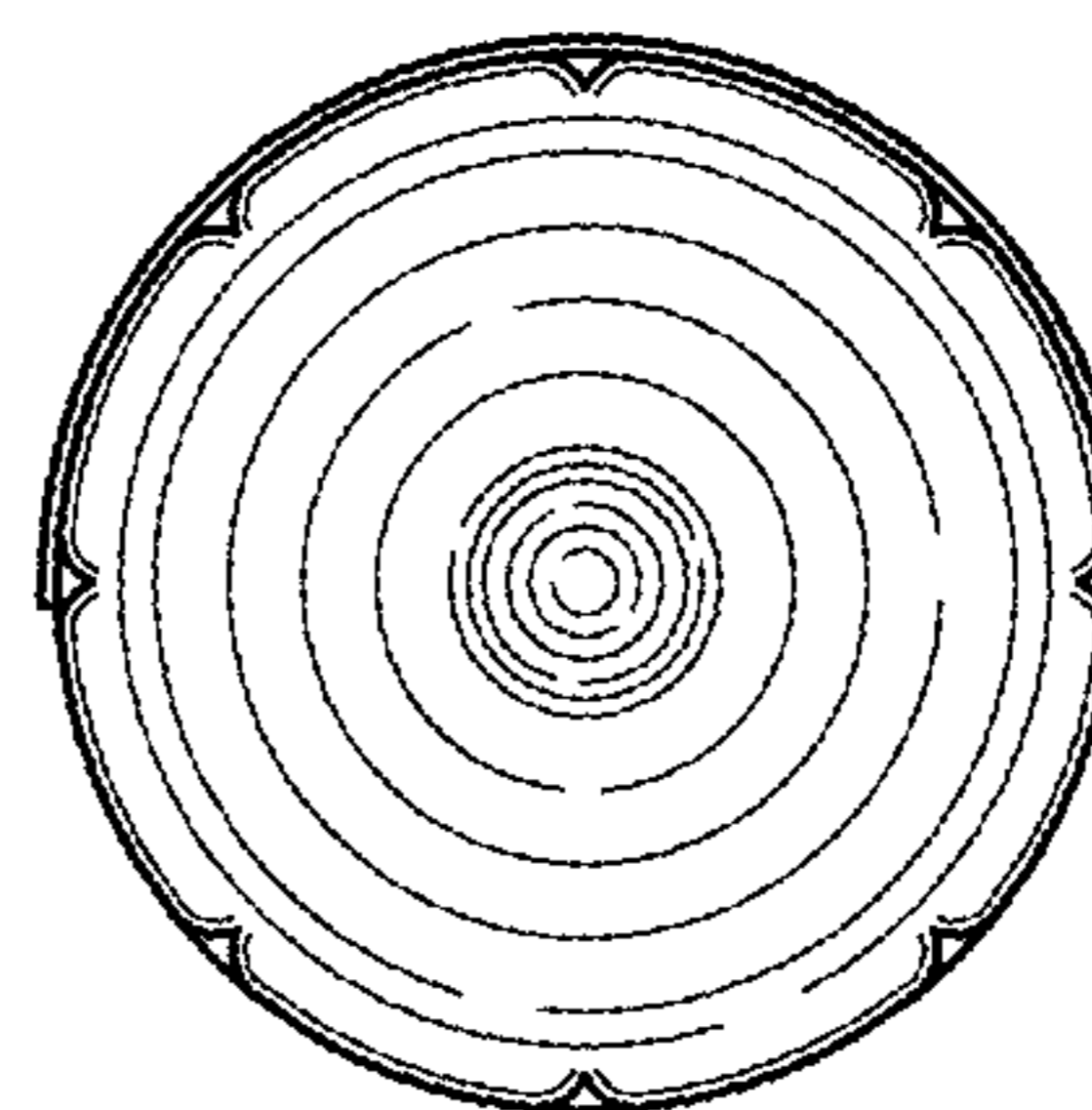

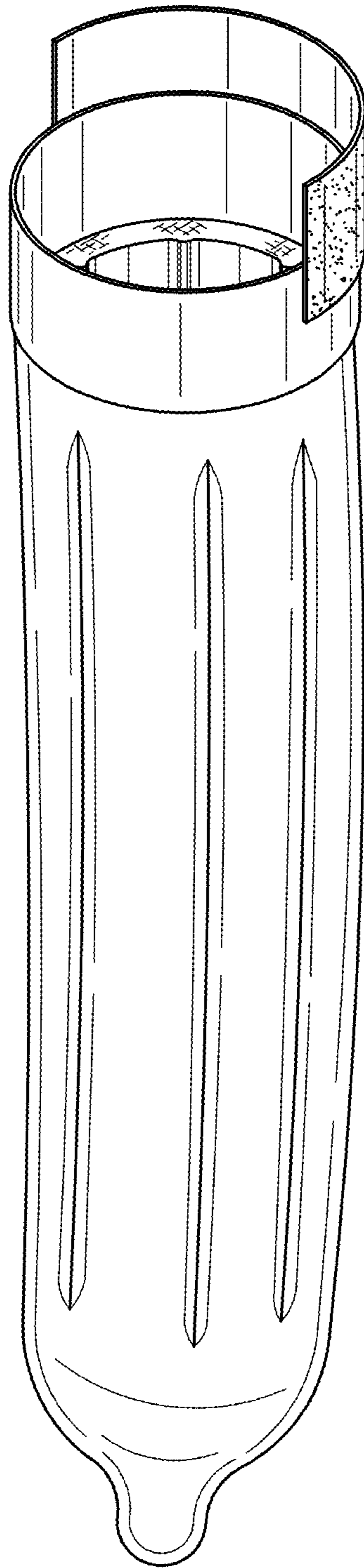
