(57) **CLAIM**

The ornamental design for a video laryngoscope with disposable blade for pediatrics, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a video laryngoscope with disposable blade for pediatrics according to the present invention.

FIG. 2 is a front view of the video laryngoscope with disposable blade for pediatrics of FIG. 1.

FIG. 3 is a rear view of the video laryngoscope with disposable blade for pediatrics of FIG. 1.

FIG. 4 is a left side view of the video laryngoscope with disposable blade for pediatrics of FIG. 1.

FIG. 5 is a right side view of the video laryngoscope with disposable blade for pediatrics of FIG. 1.

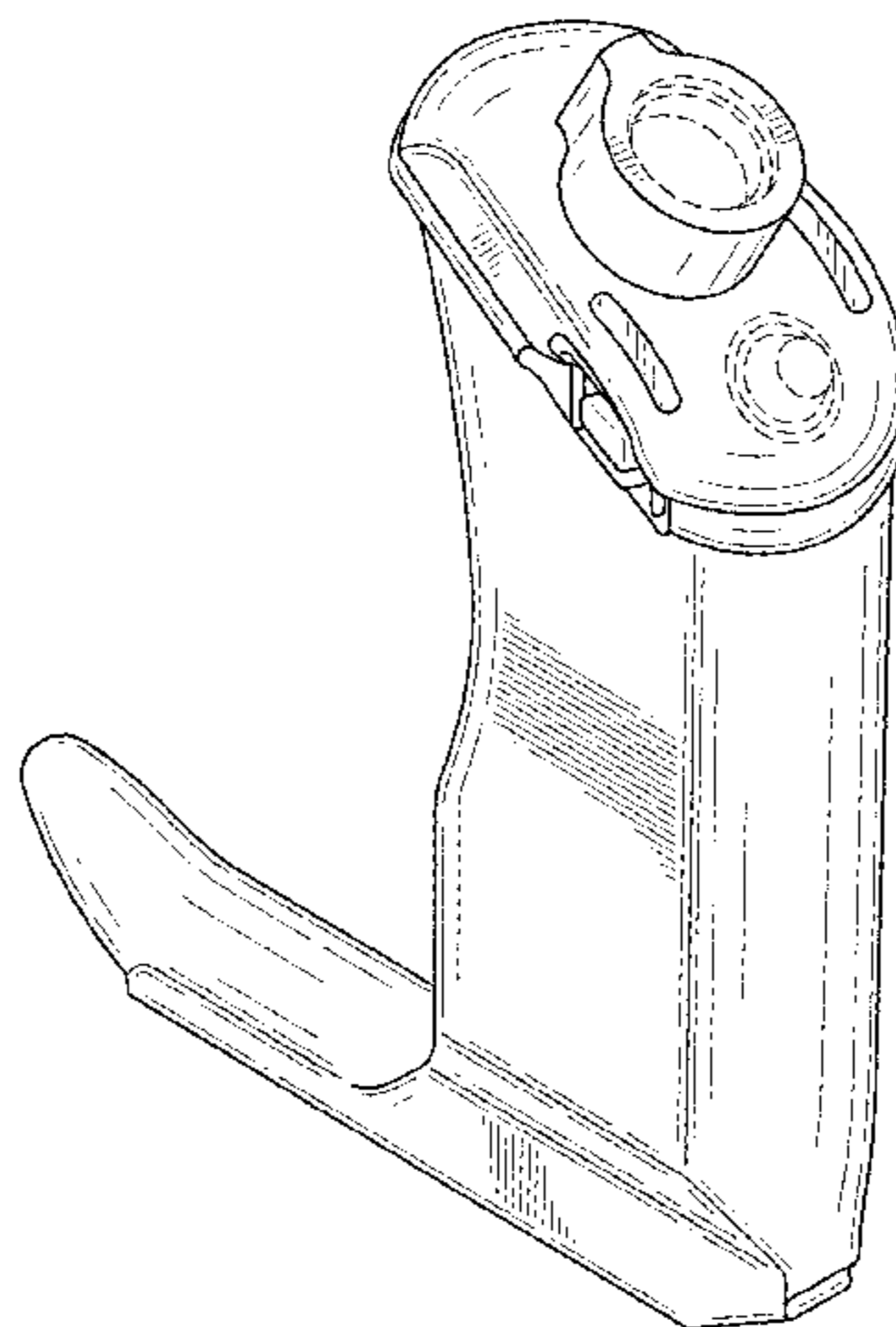
FIG. 6 is a top view of the video laryngoscope with disposable blade for pediatrics of FIG. 1.

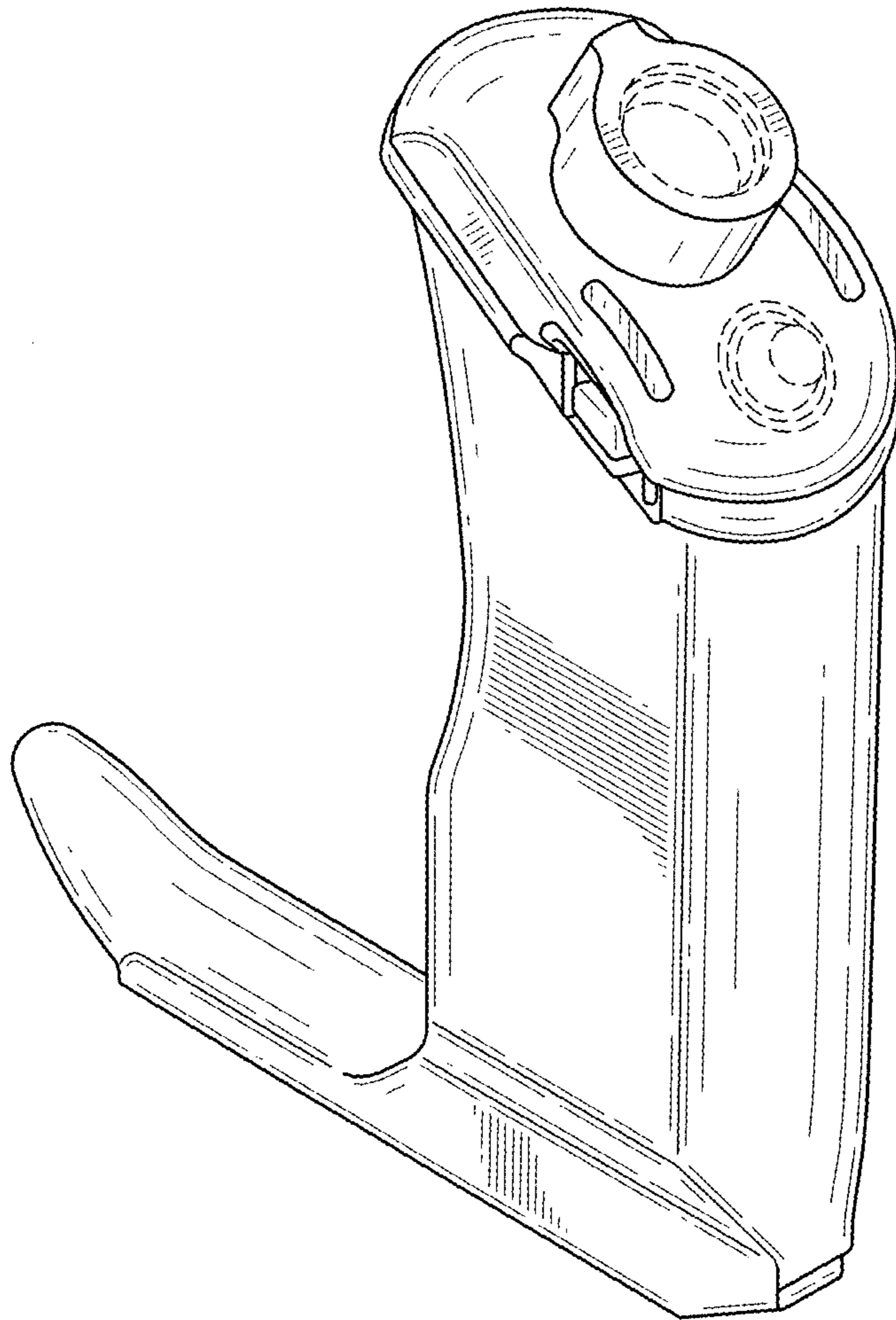

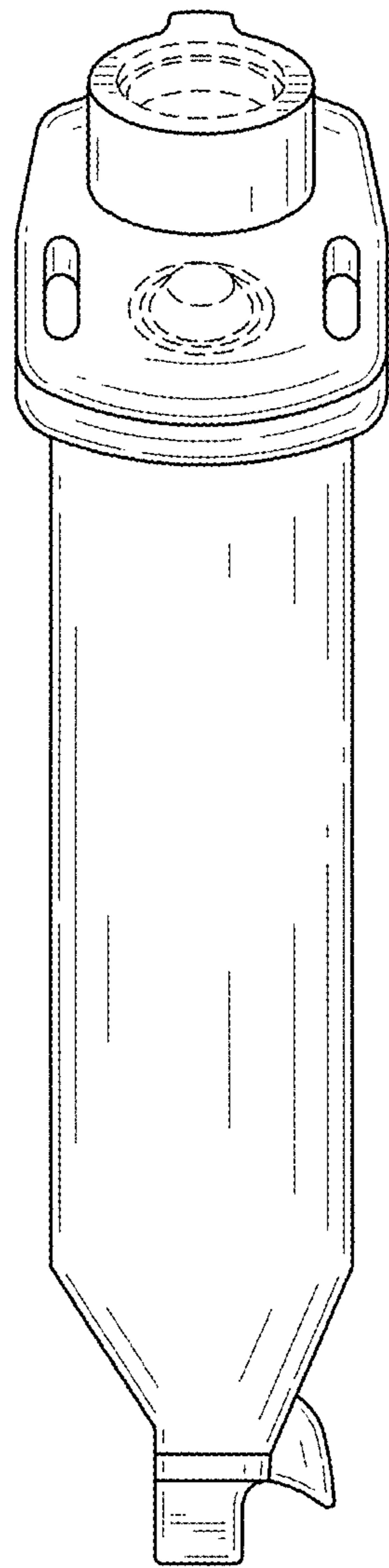

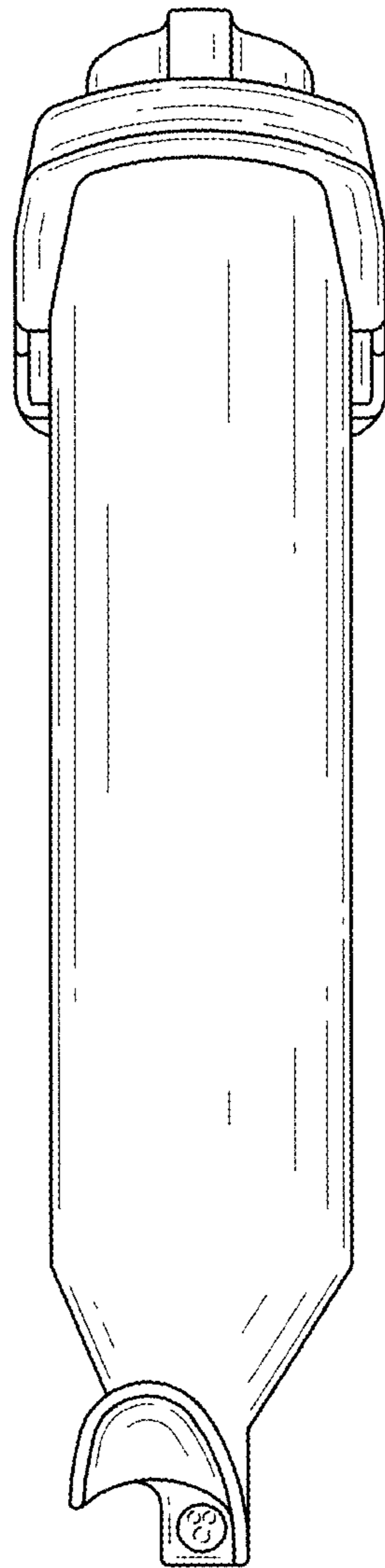

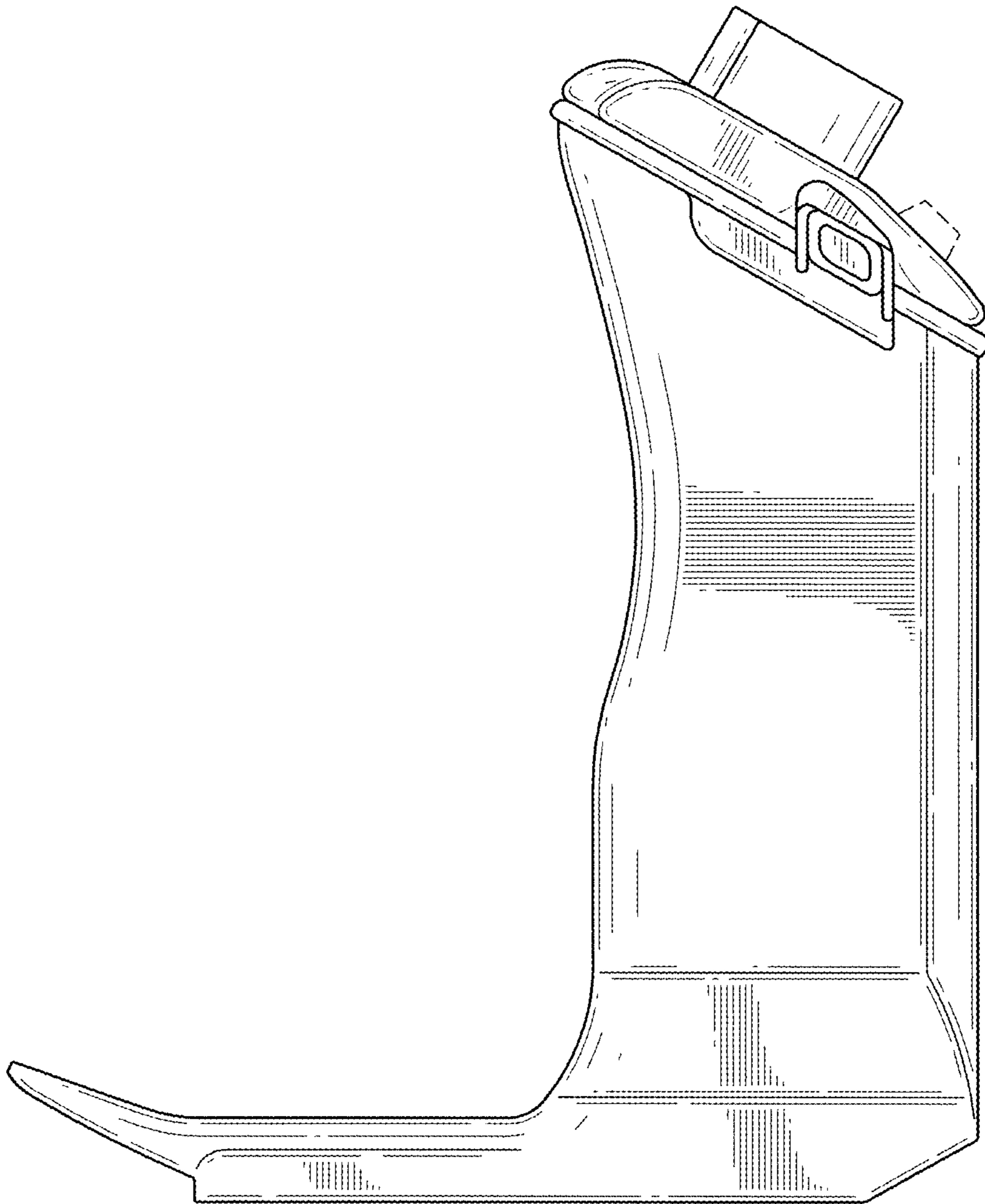

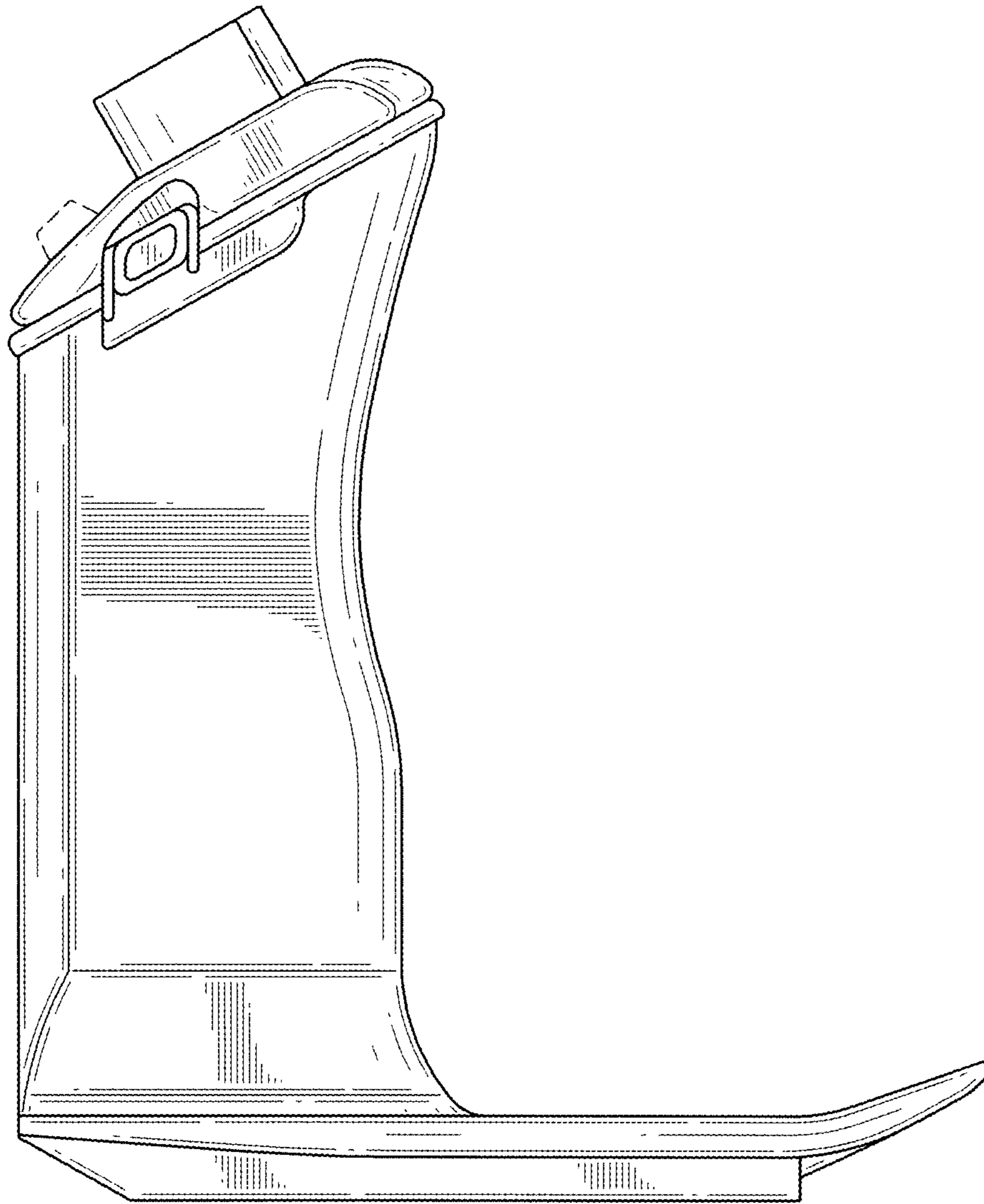

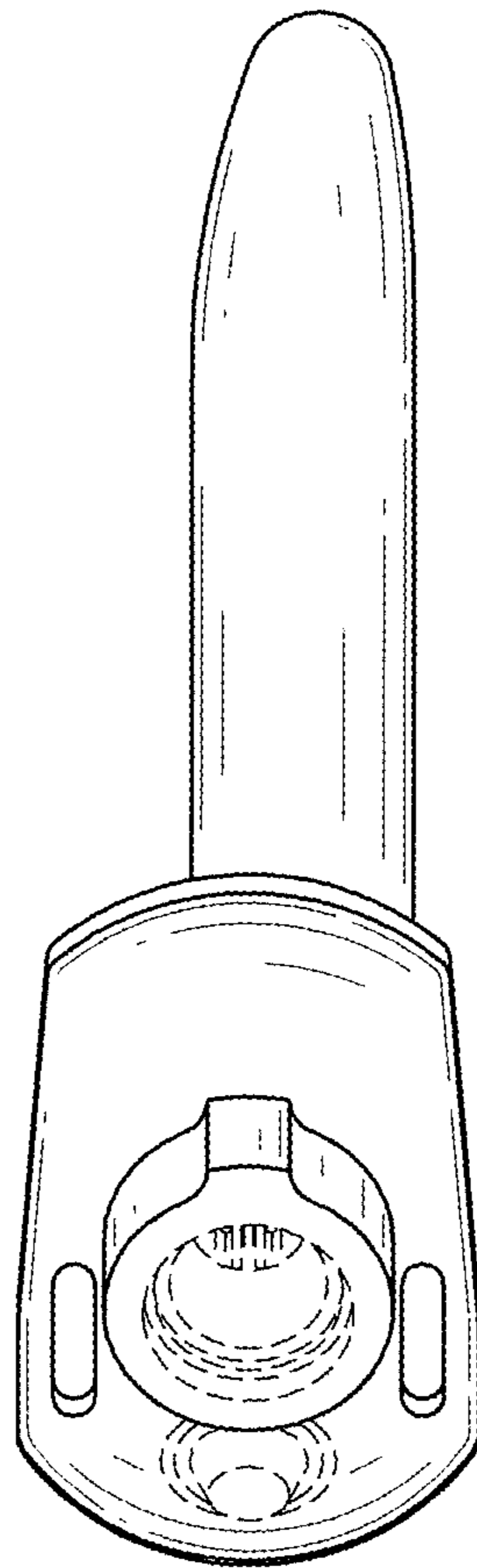

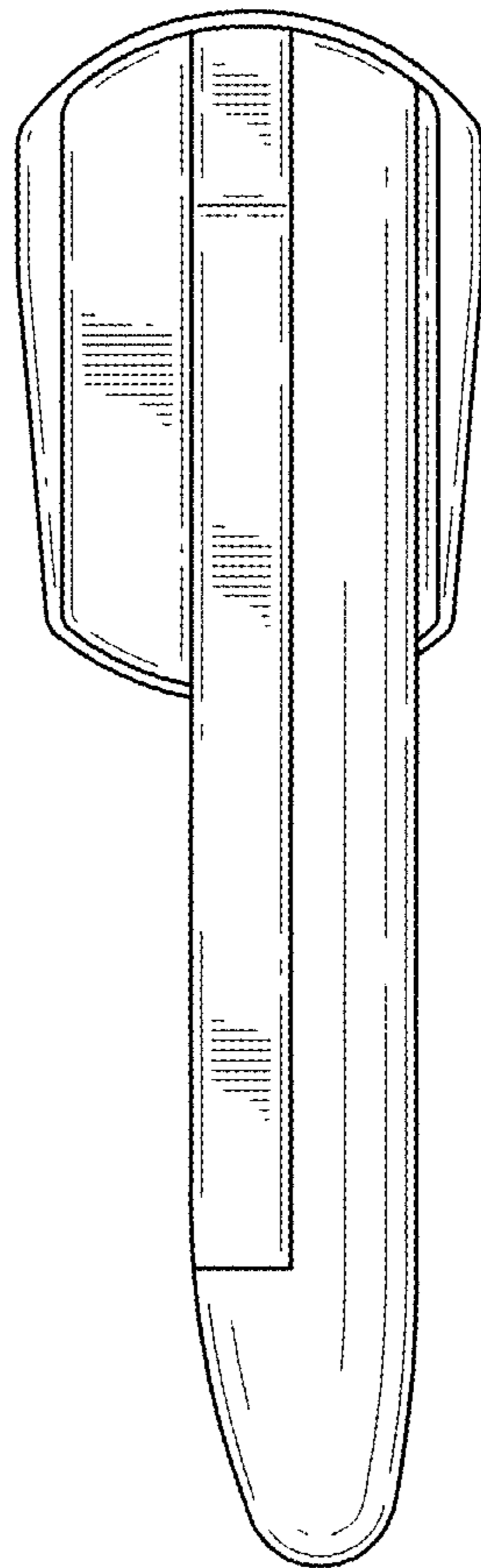

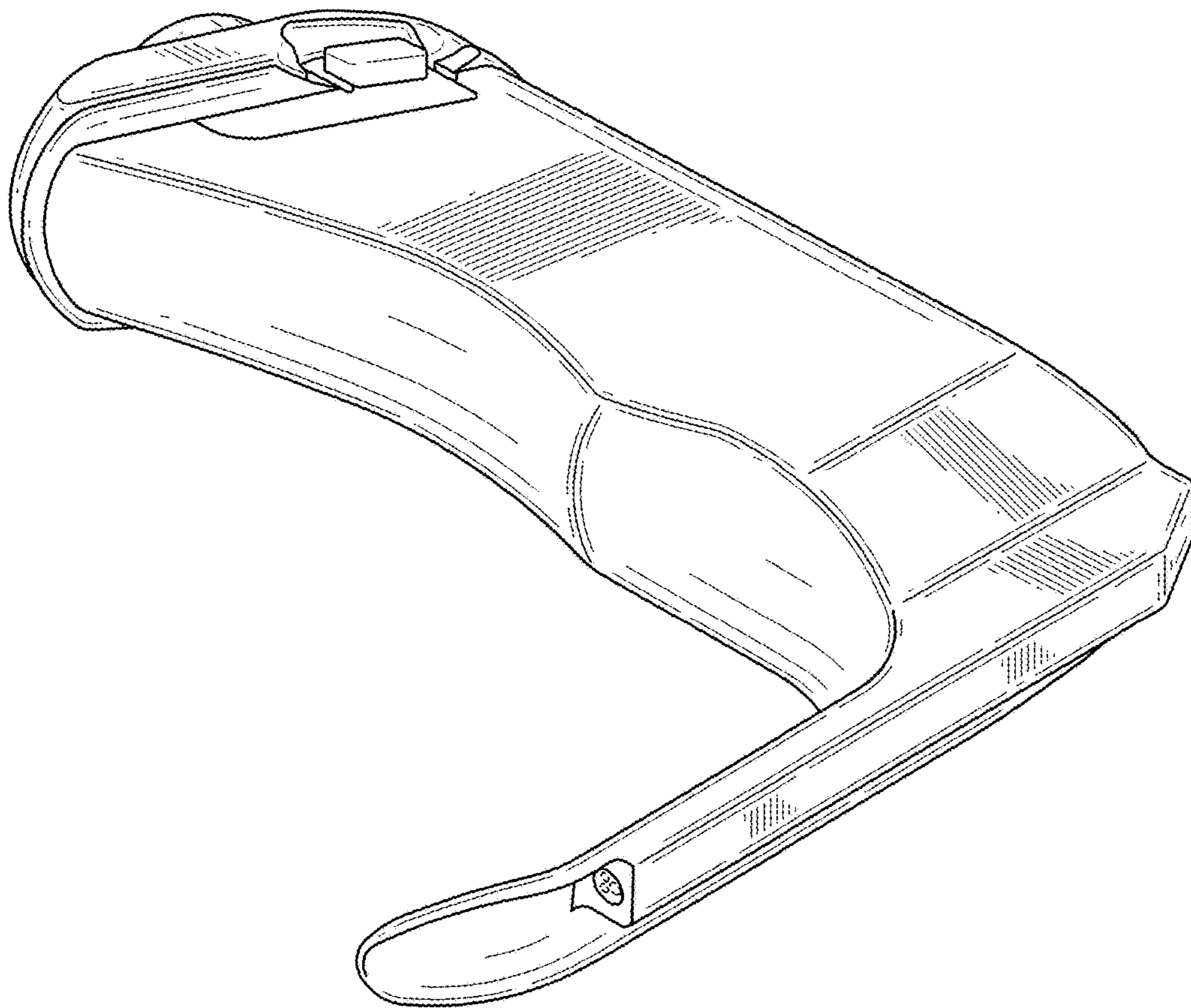
