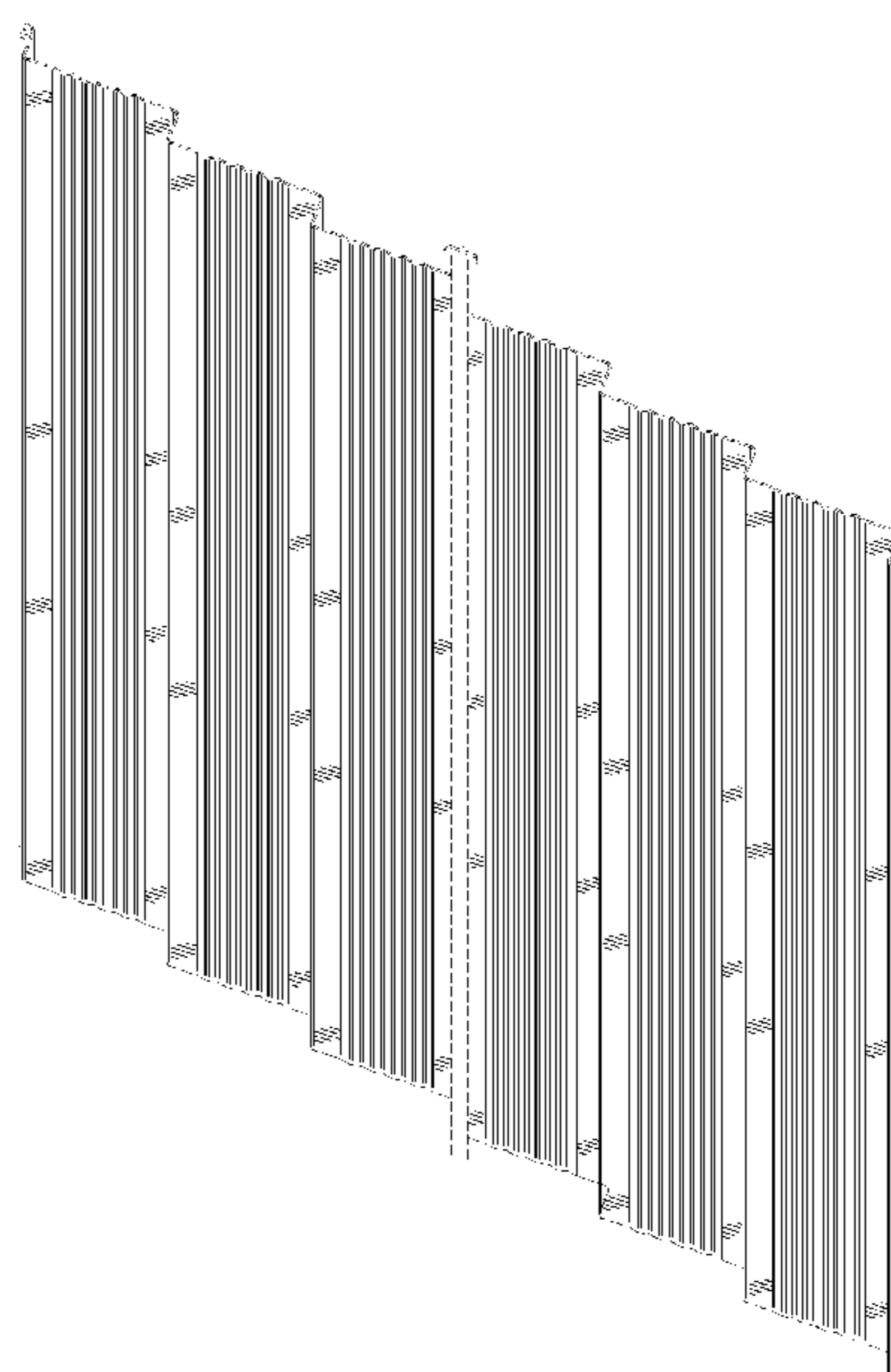
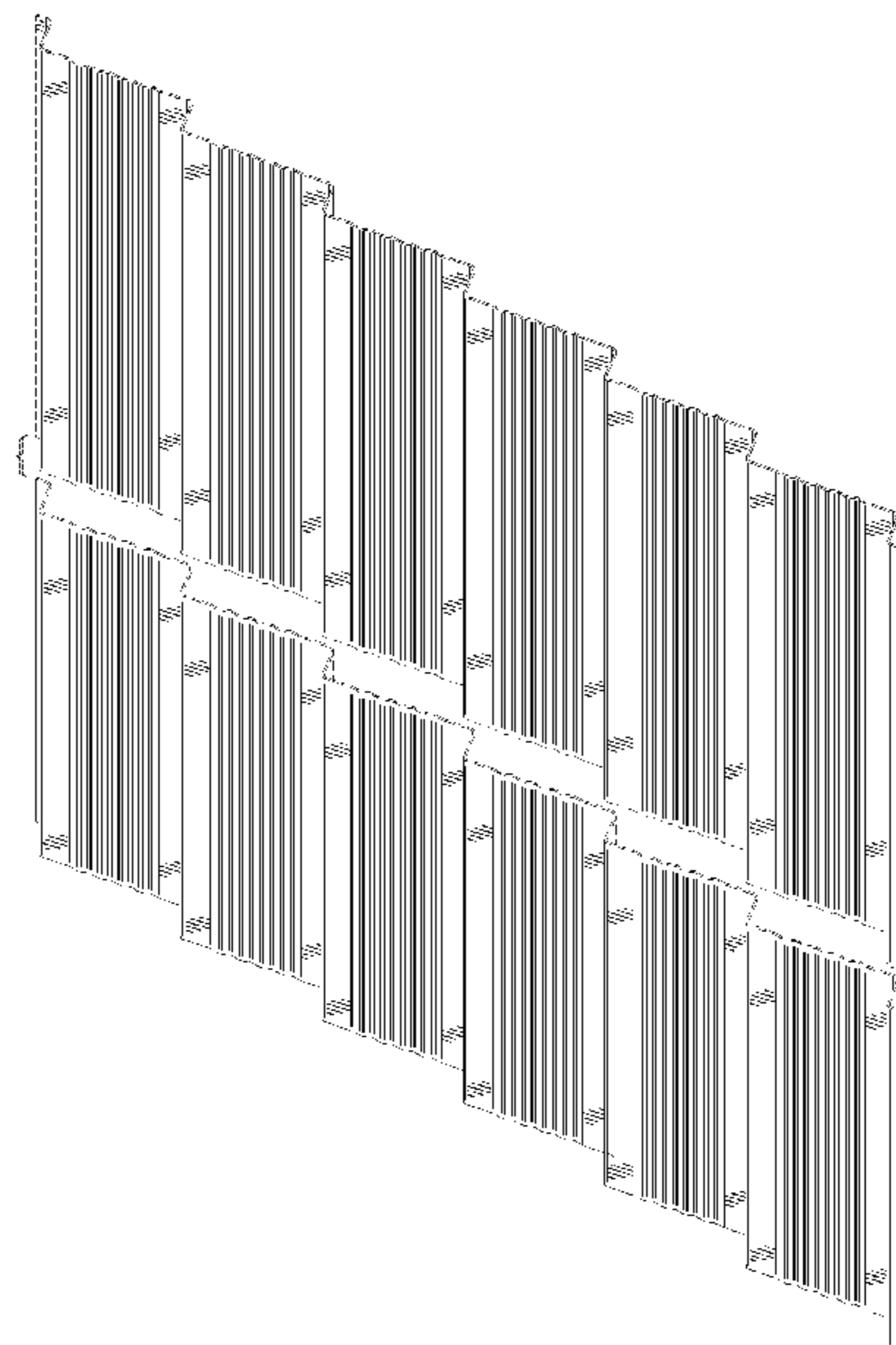
(57) **CLAIM**

DESCRIPTION

FIG. 1 is a front perspective view of a fencing panel sheet
showing my new design according to a first embodiment;

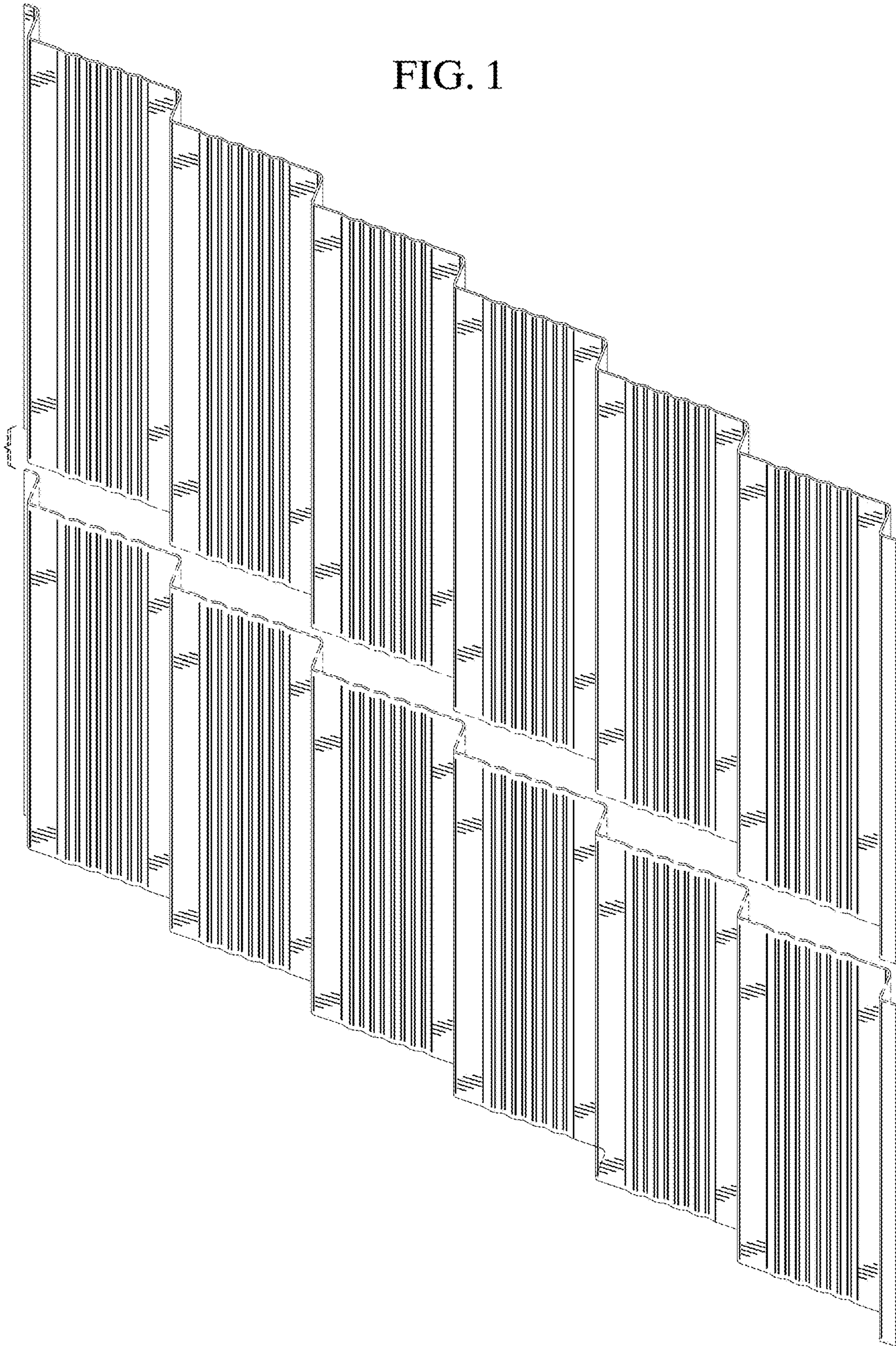

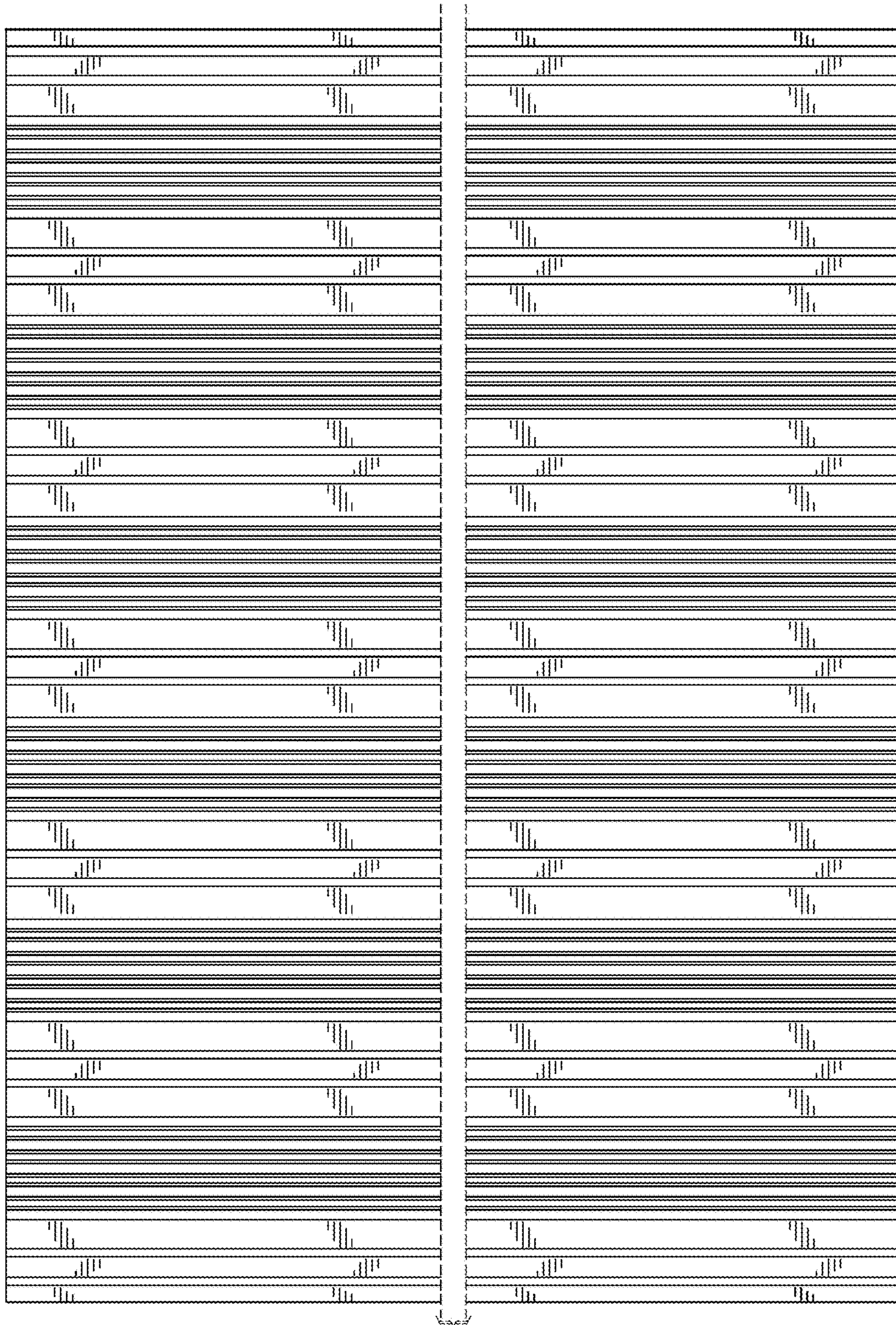

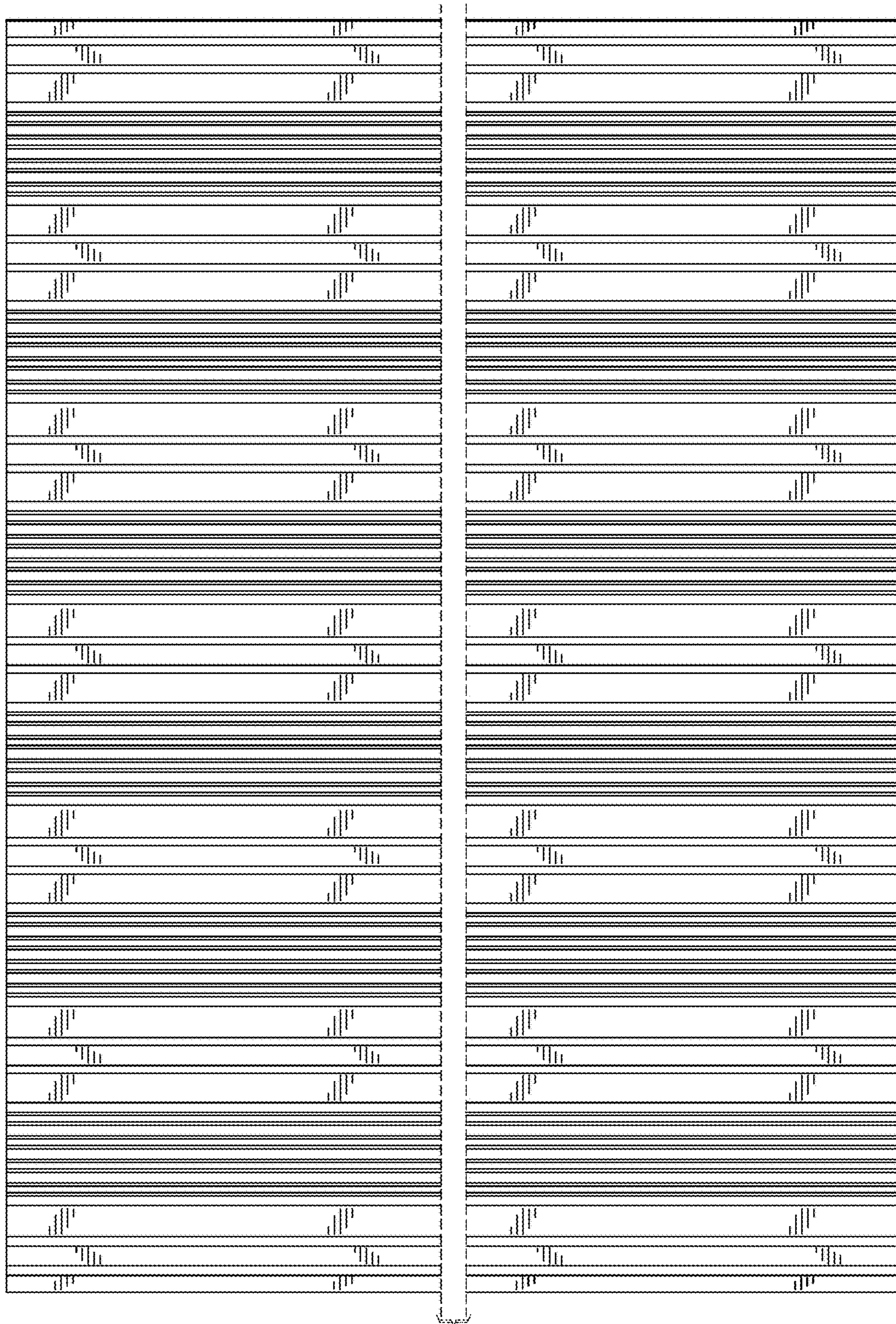

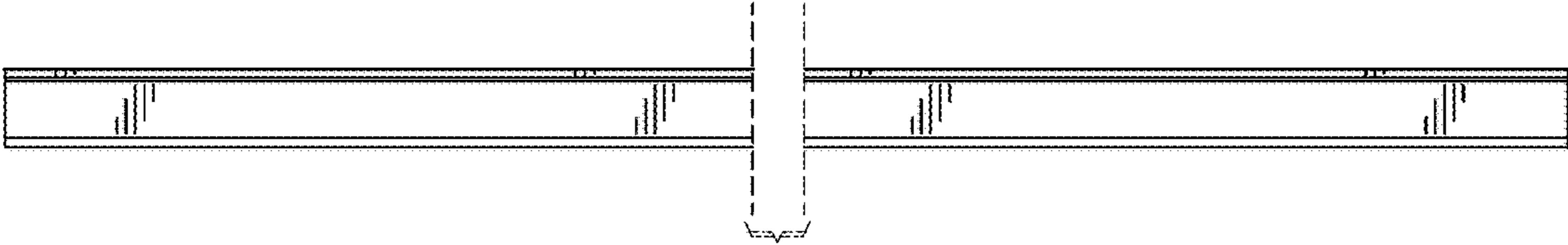

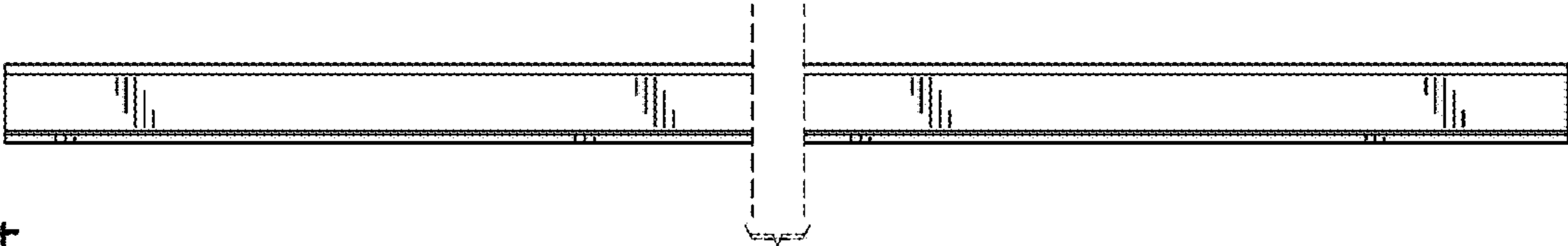

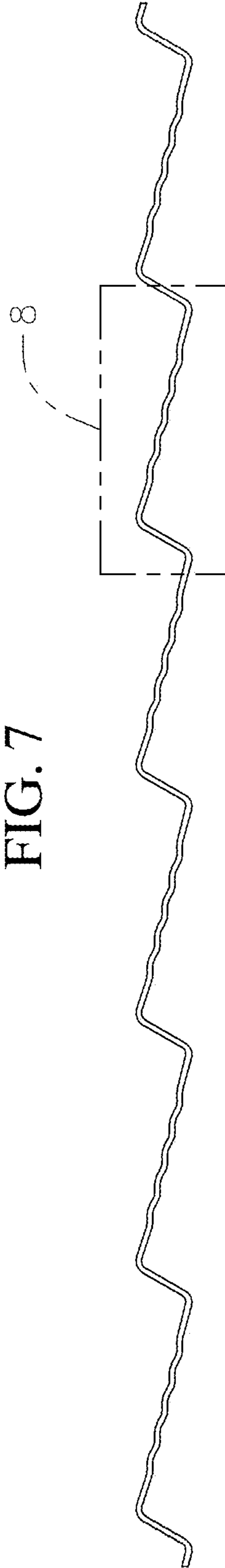

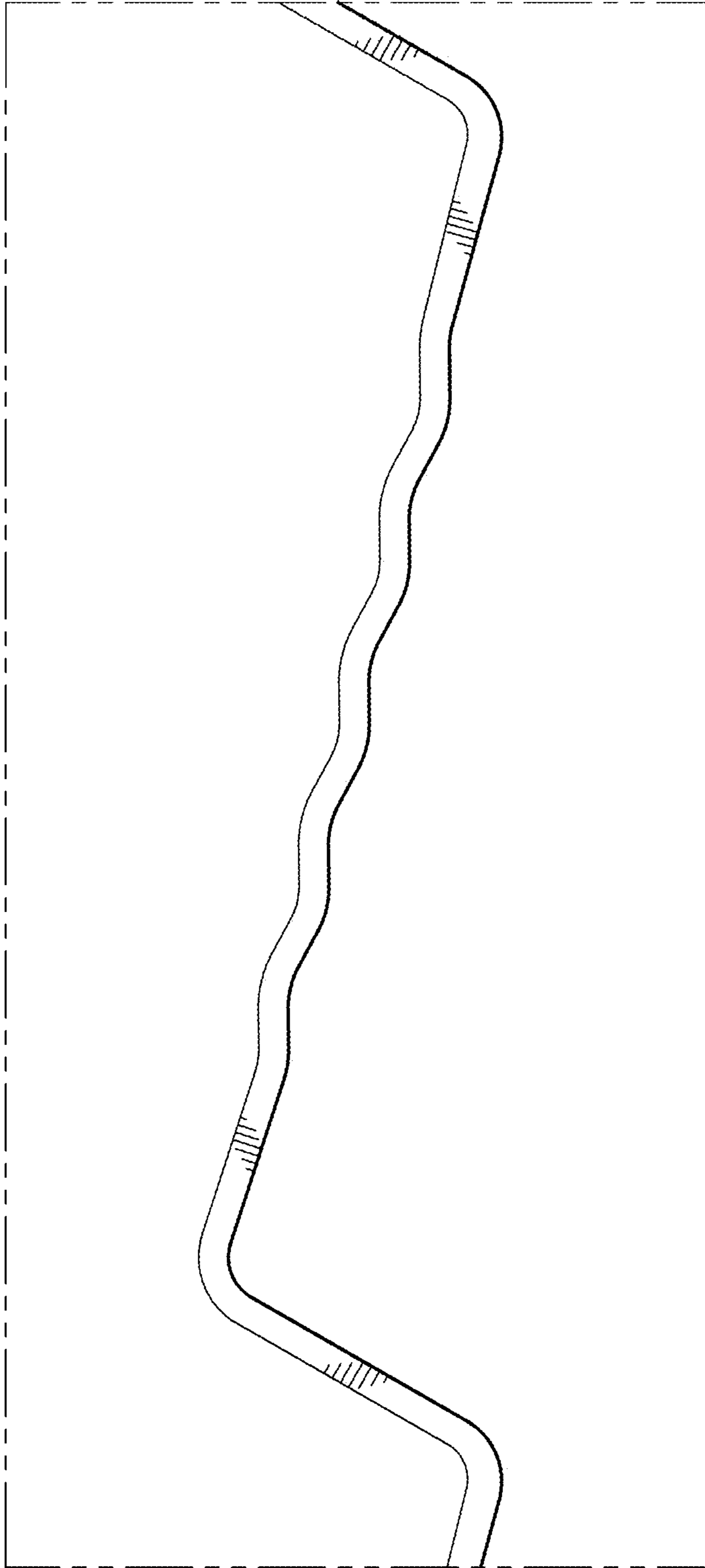

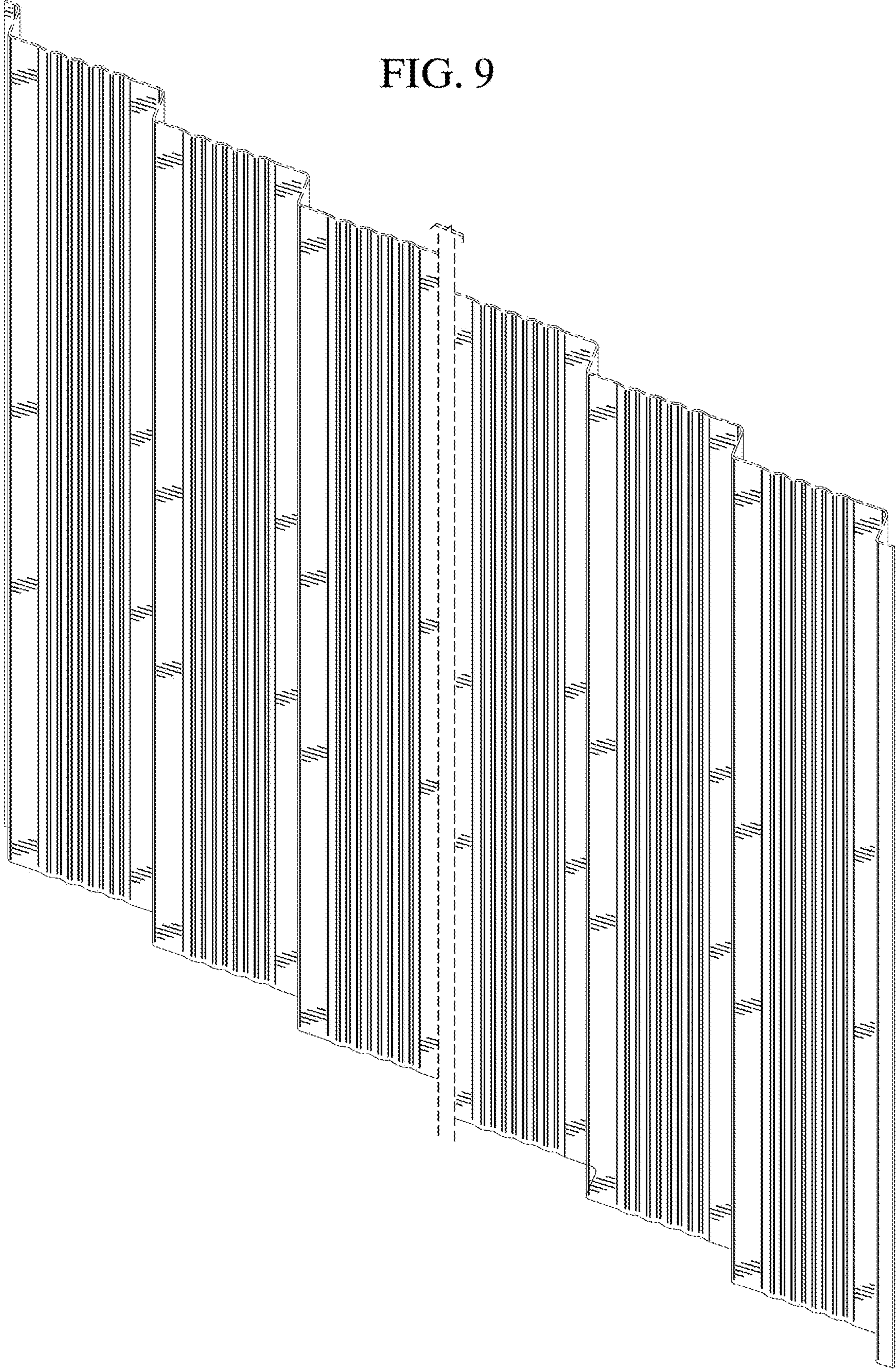

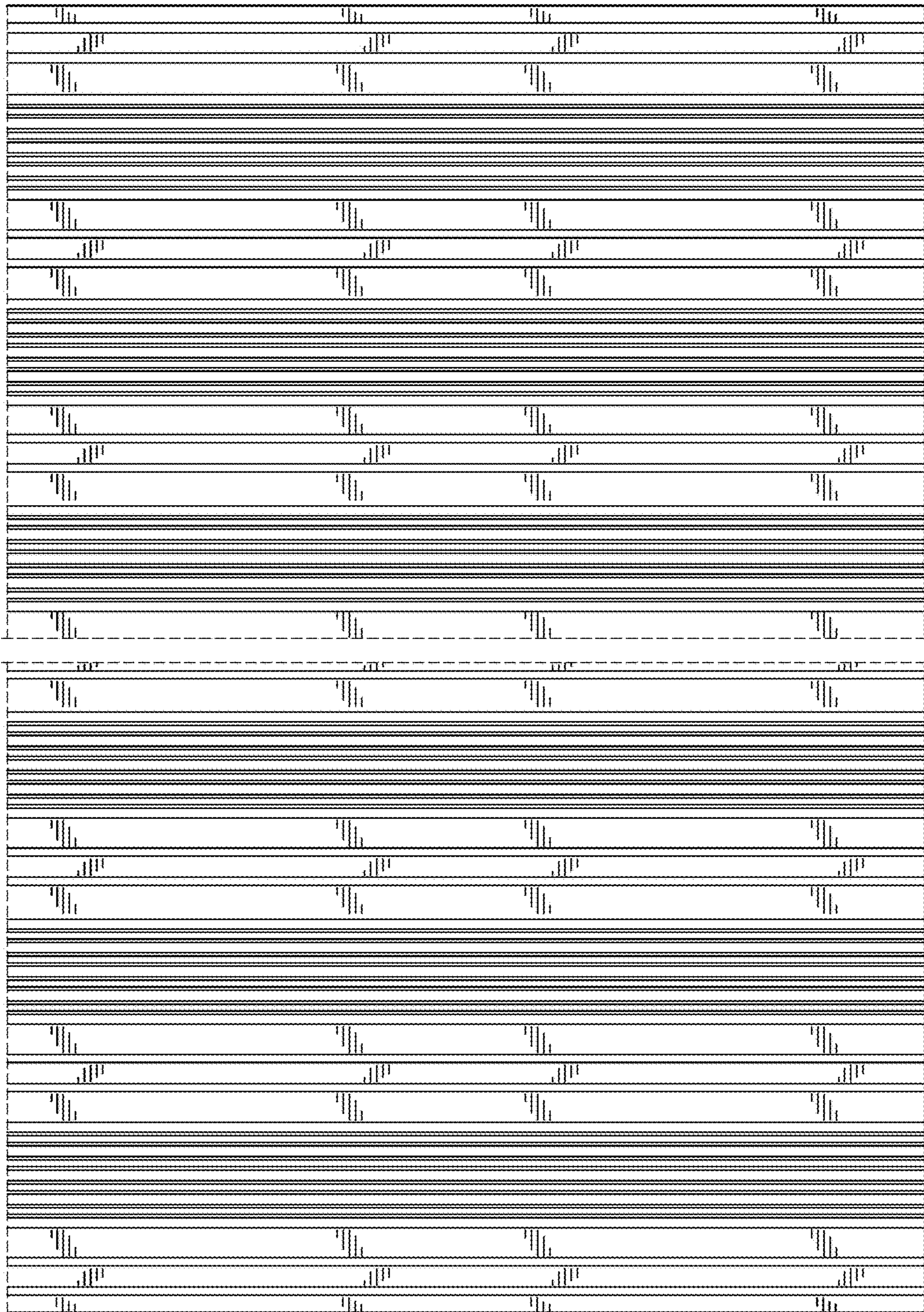

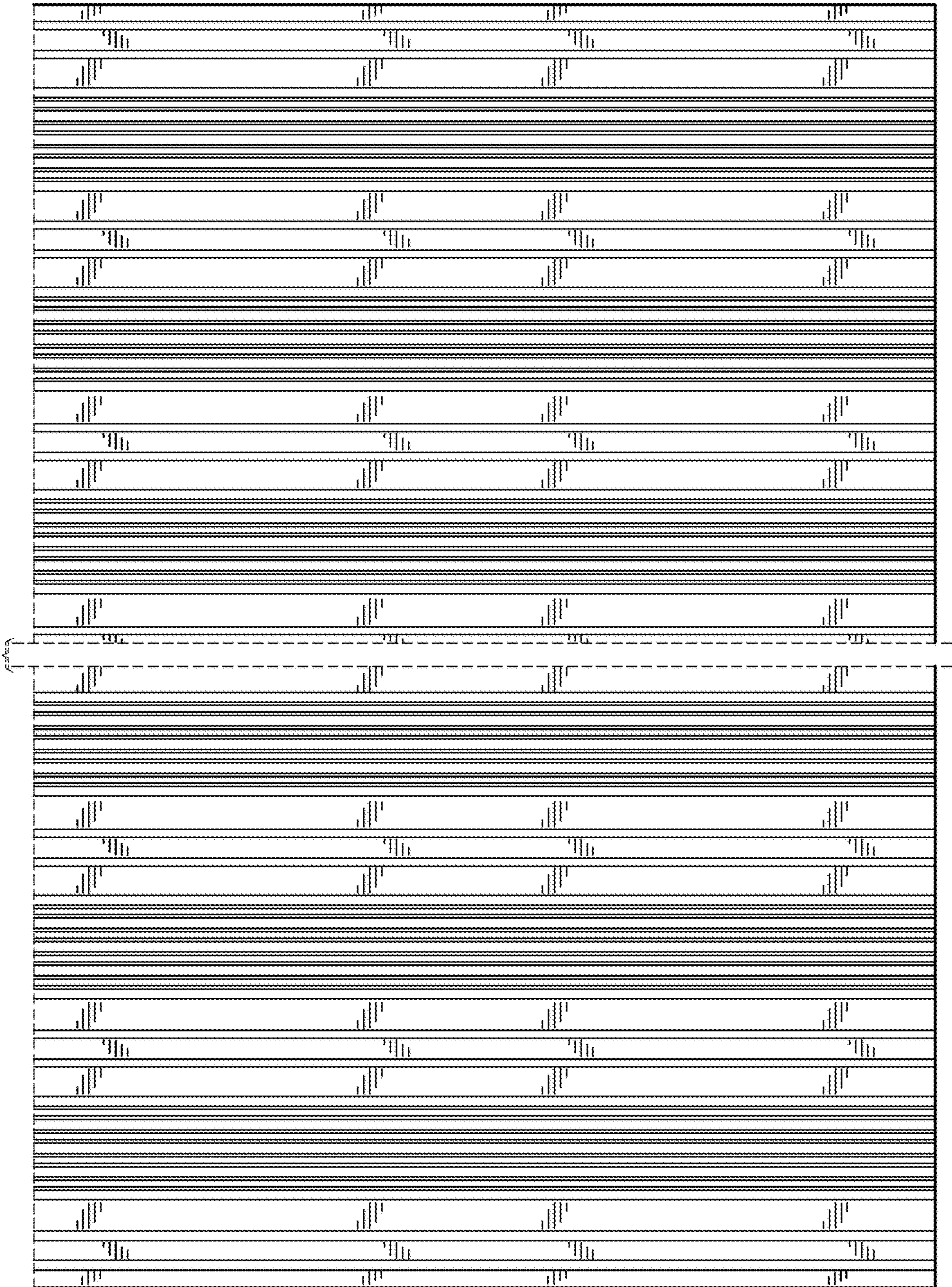

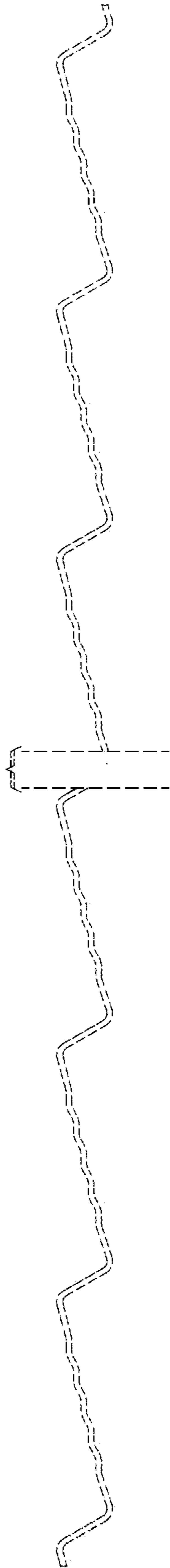

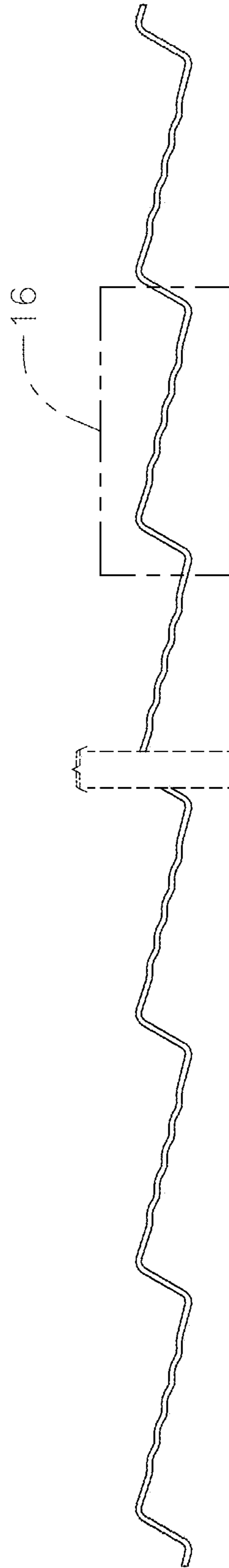
