FIG. 1 is a perspective view of an automobile headlight lens;

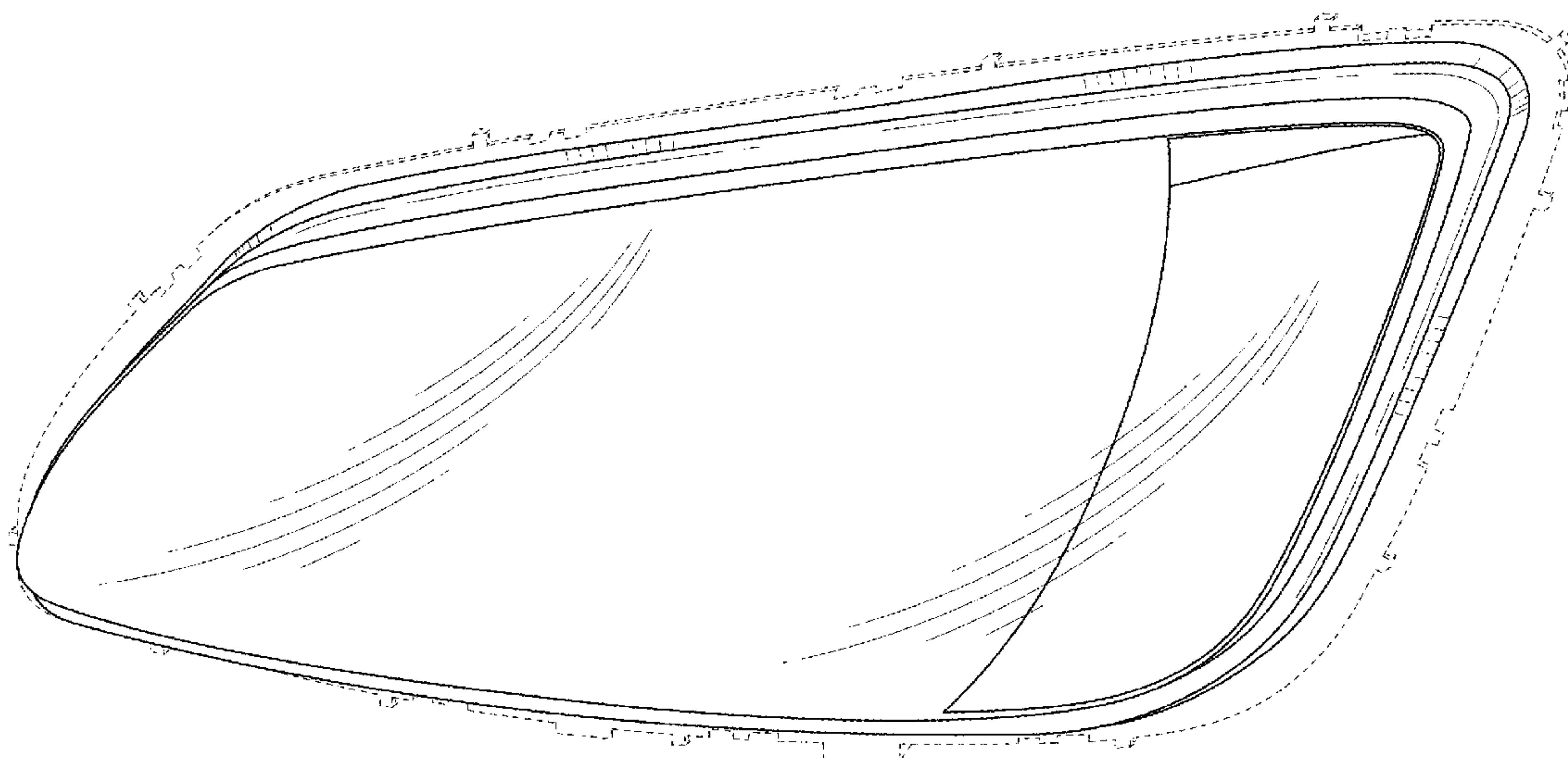
FIG. 2 is a front view thereof;

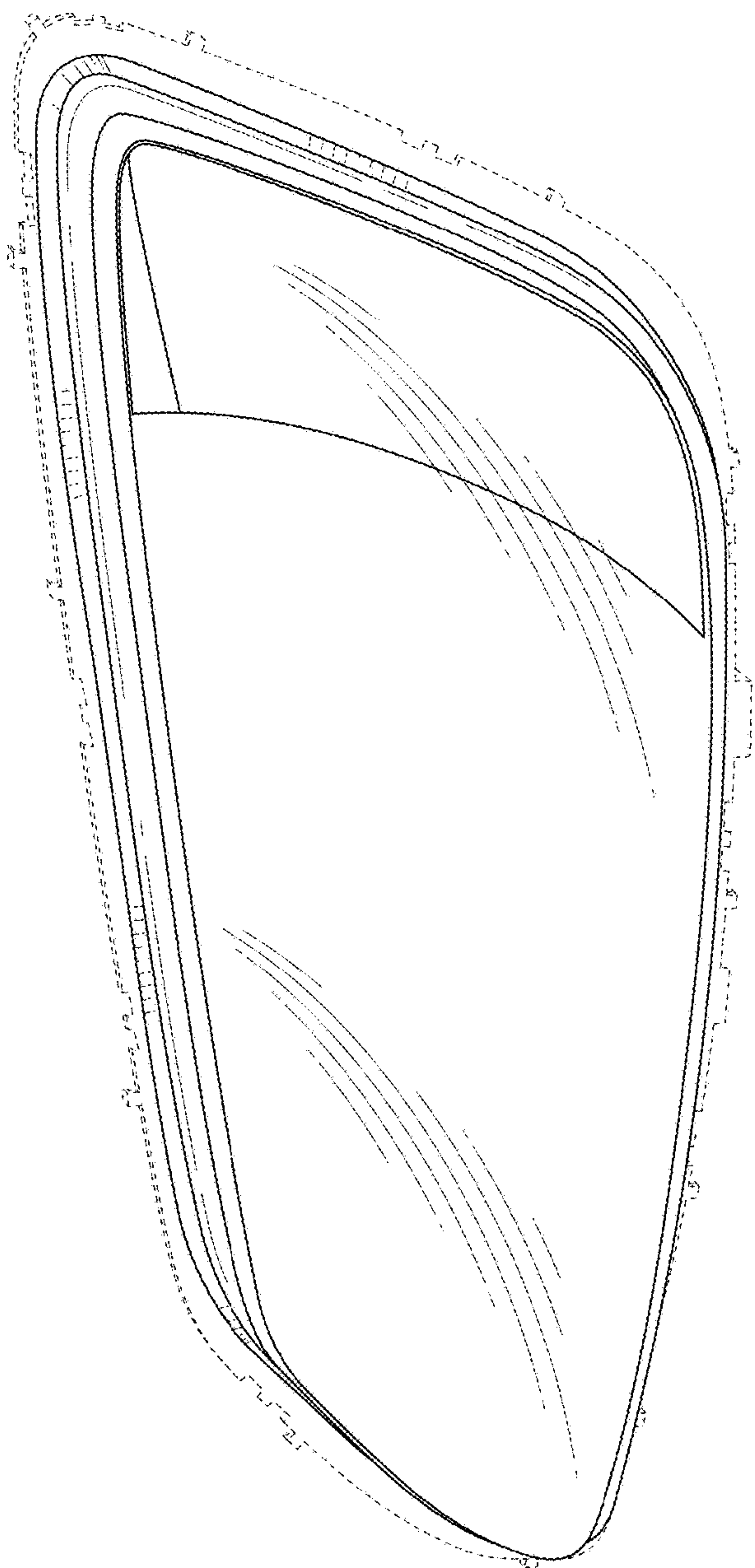

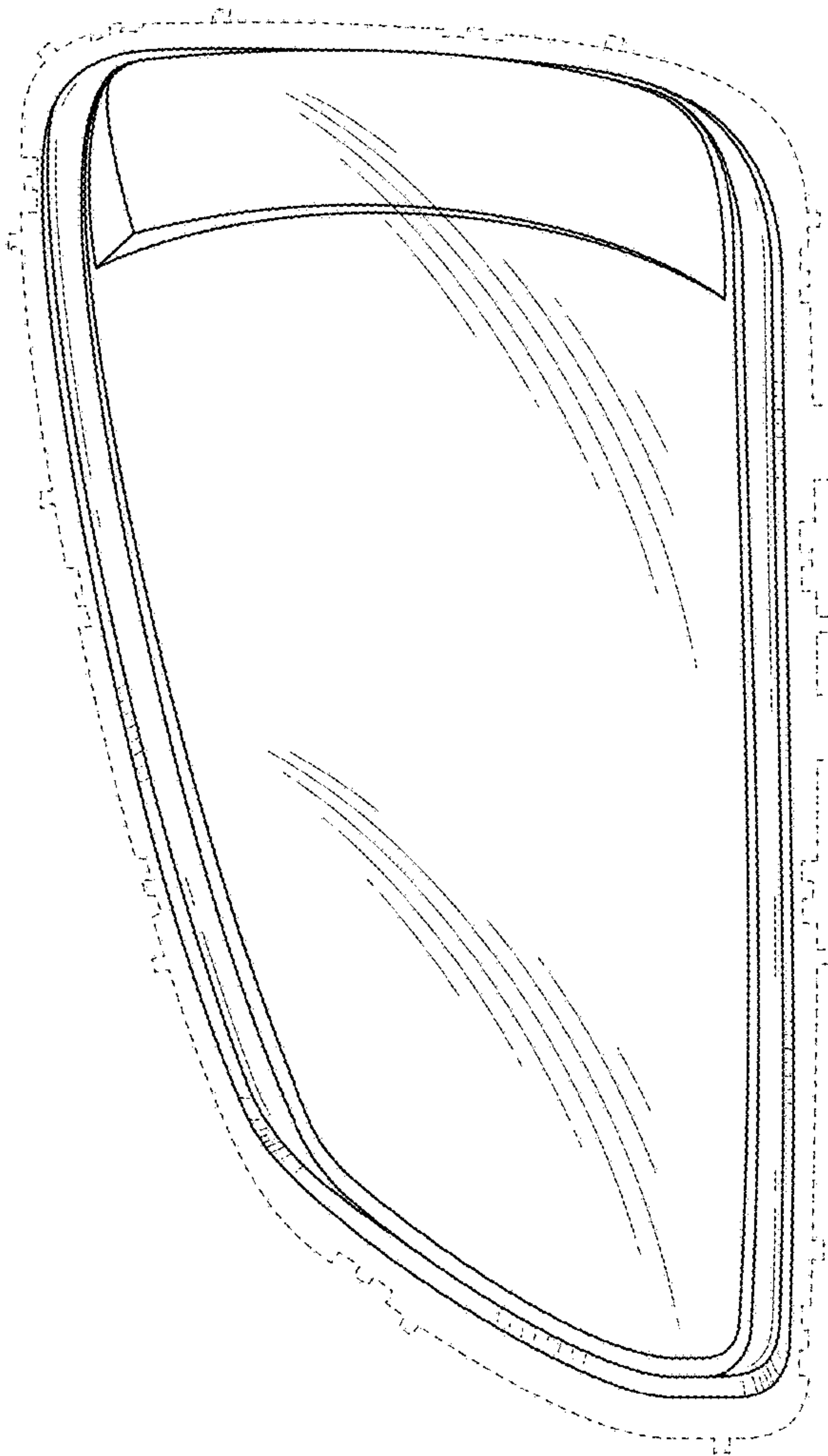

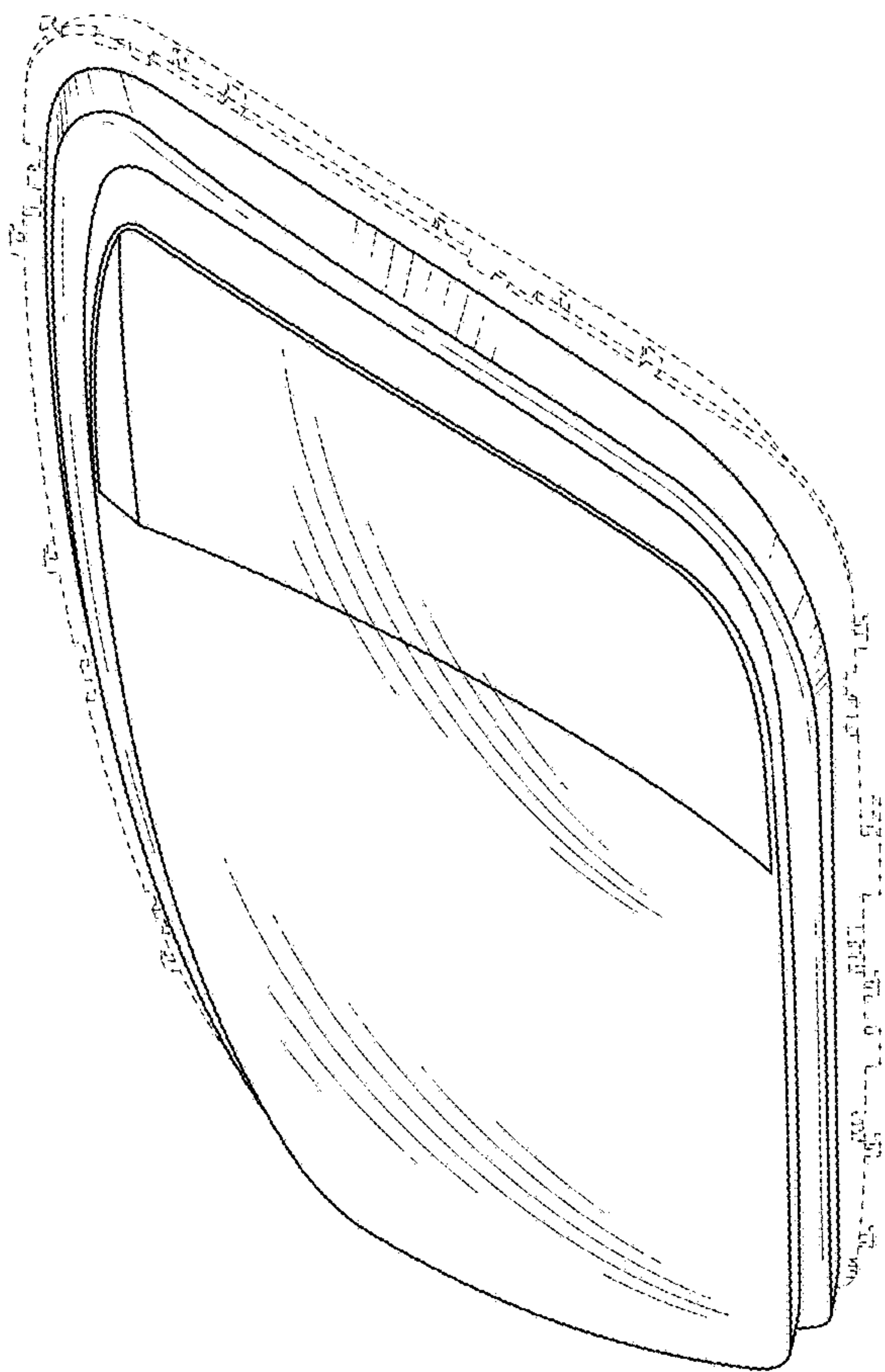

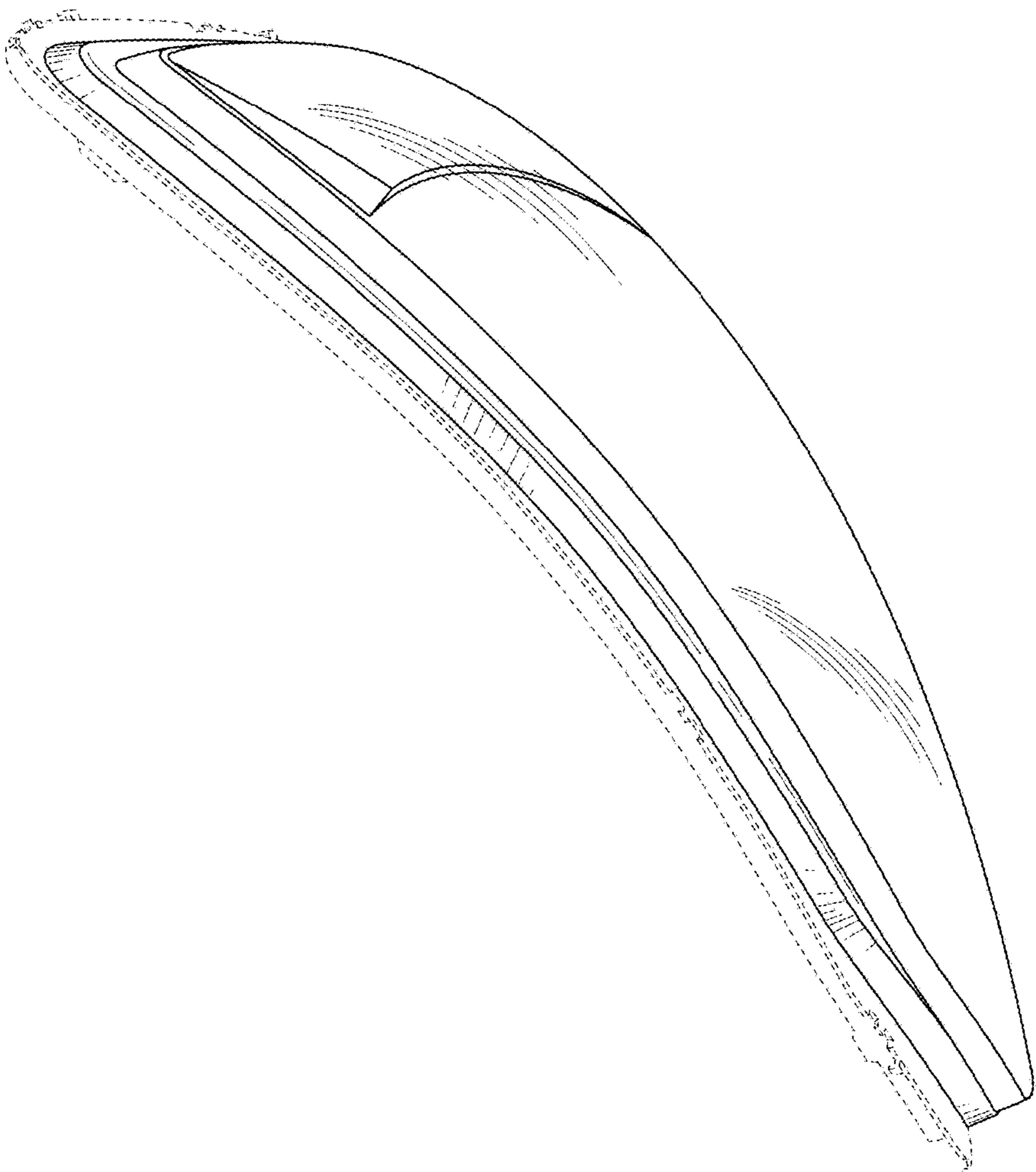
