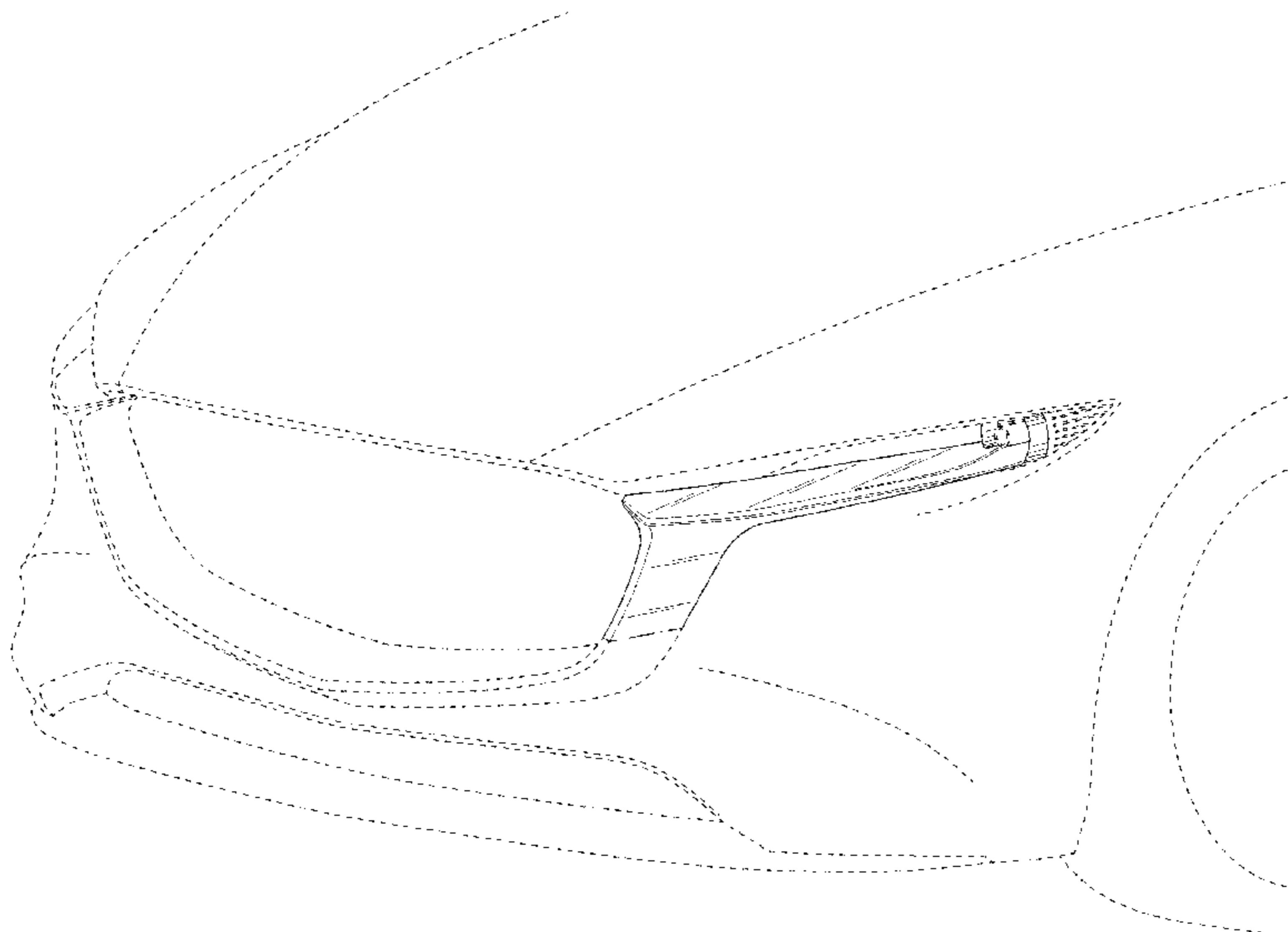
(57) **CLAIM**

The ornamental design for a vehicle headlight, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of a vehicle headlight;

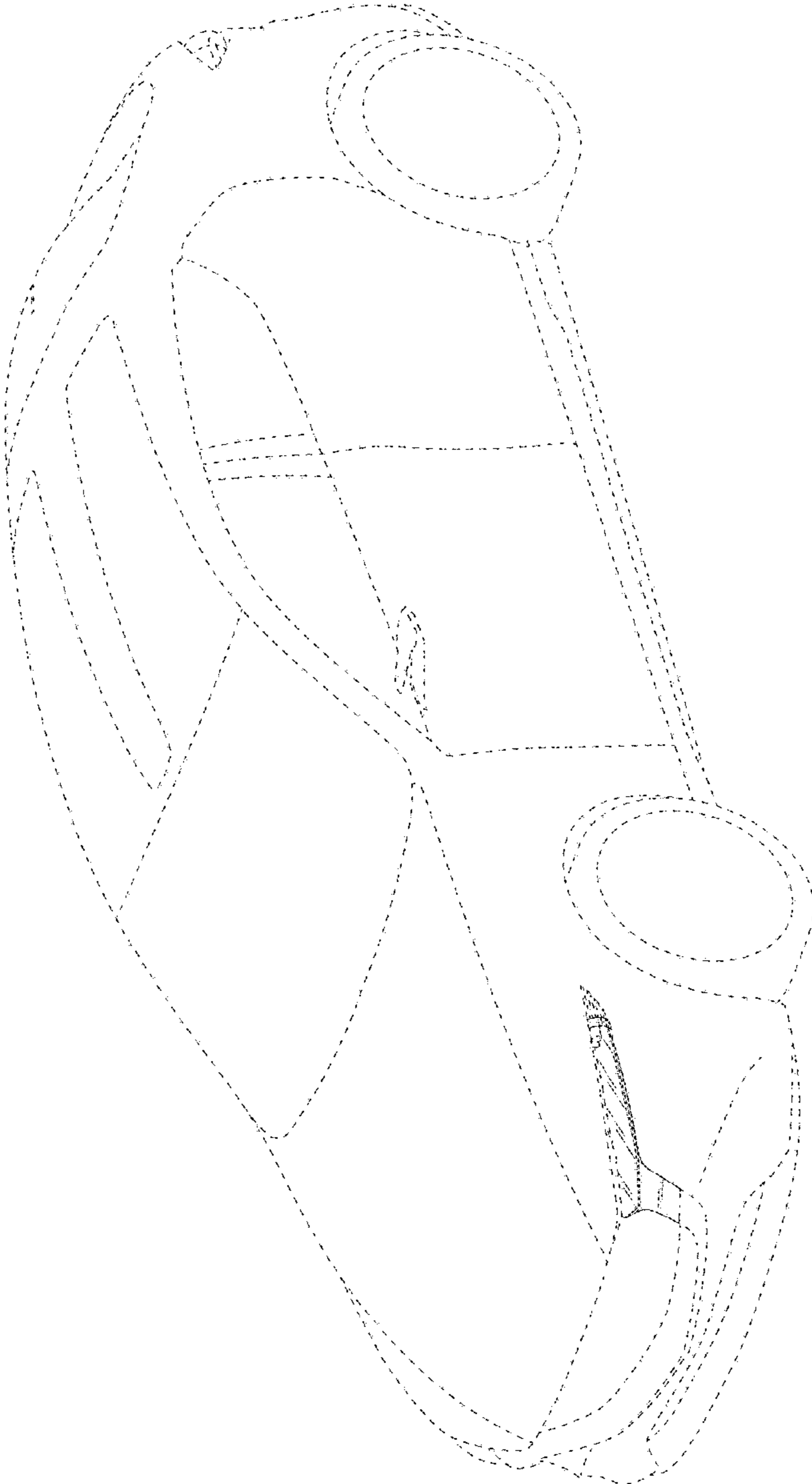

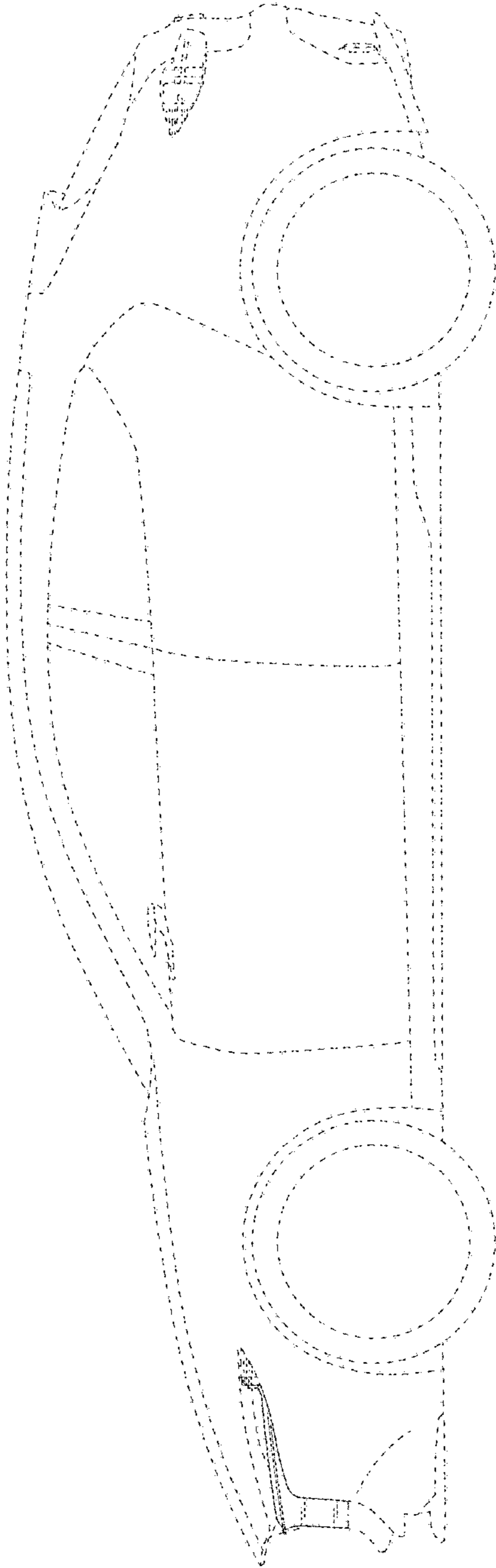

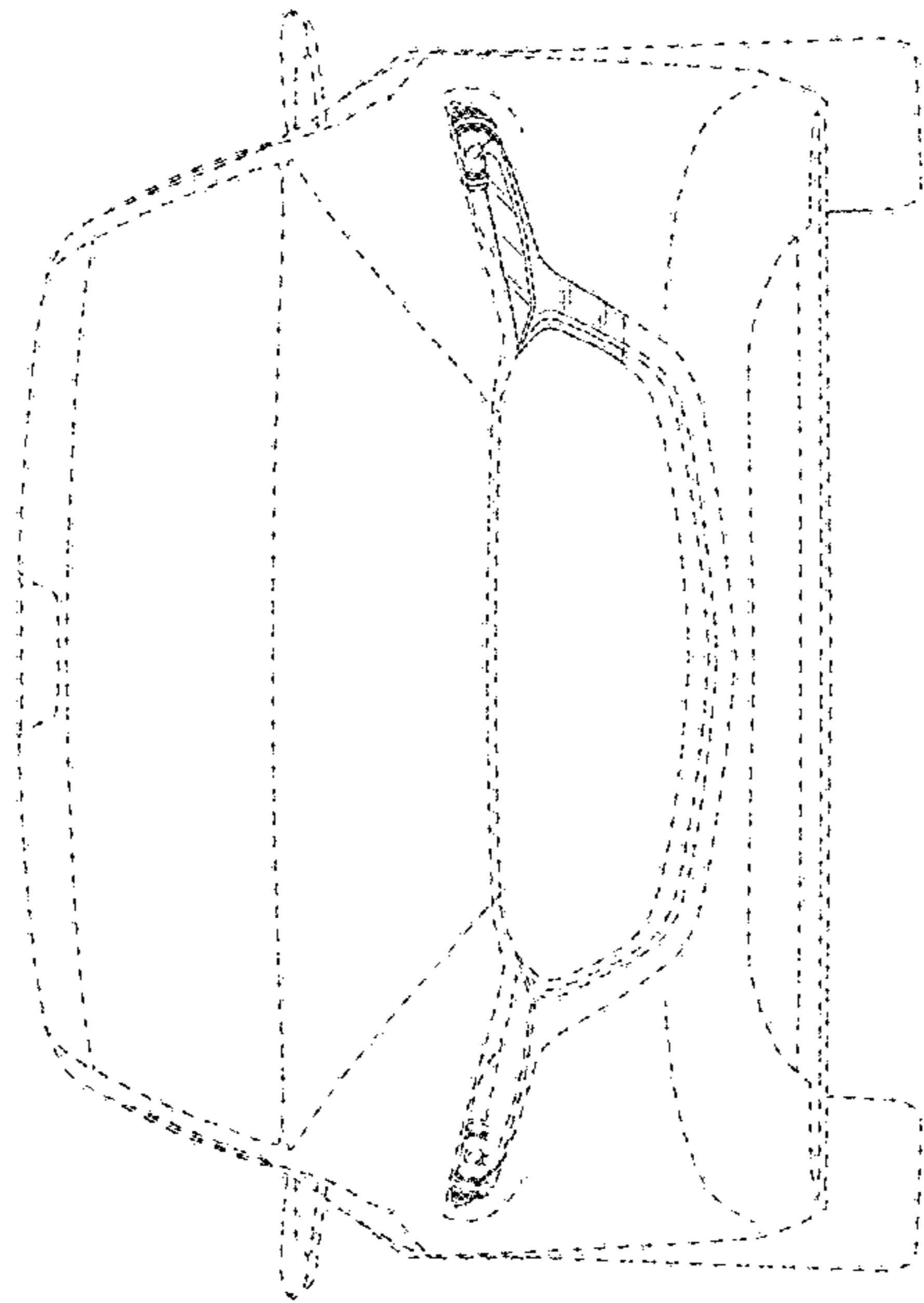

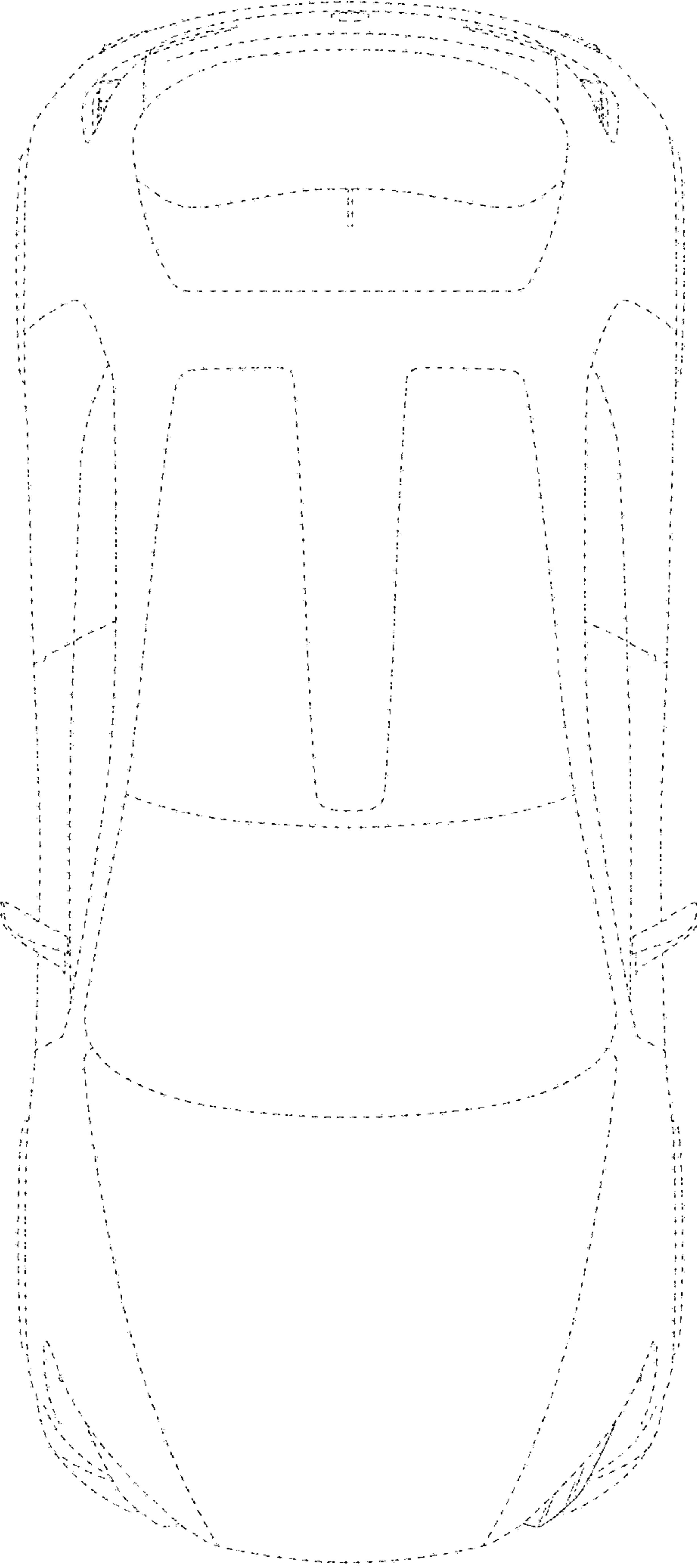

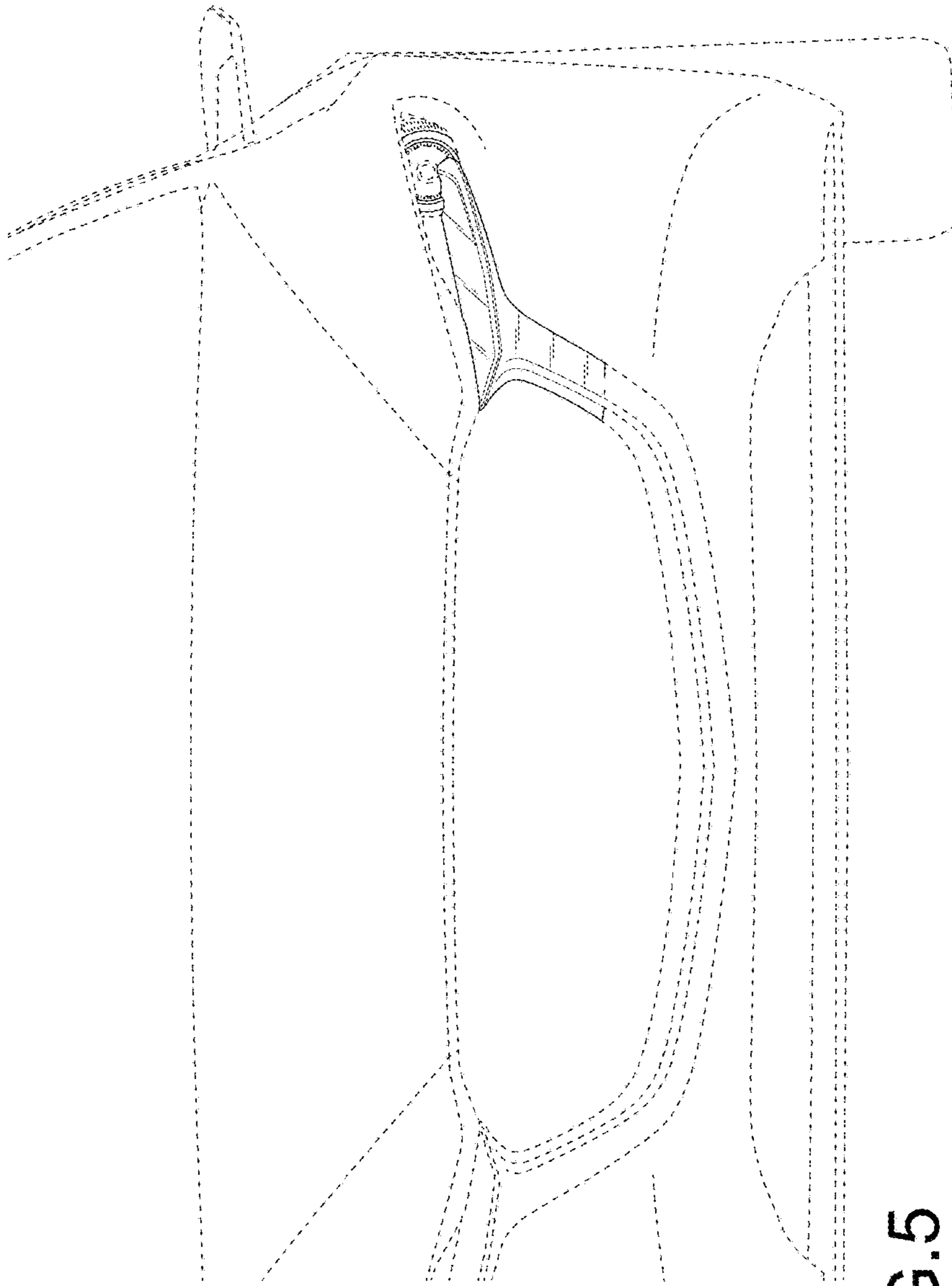

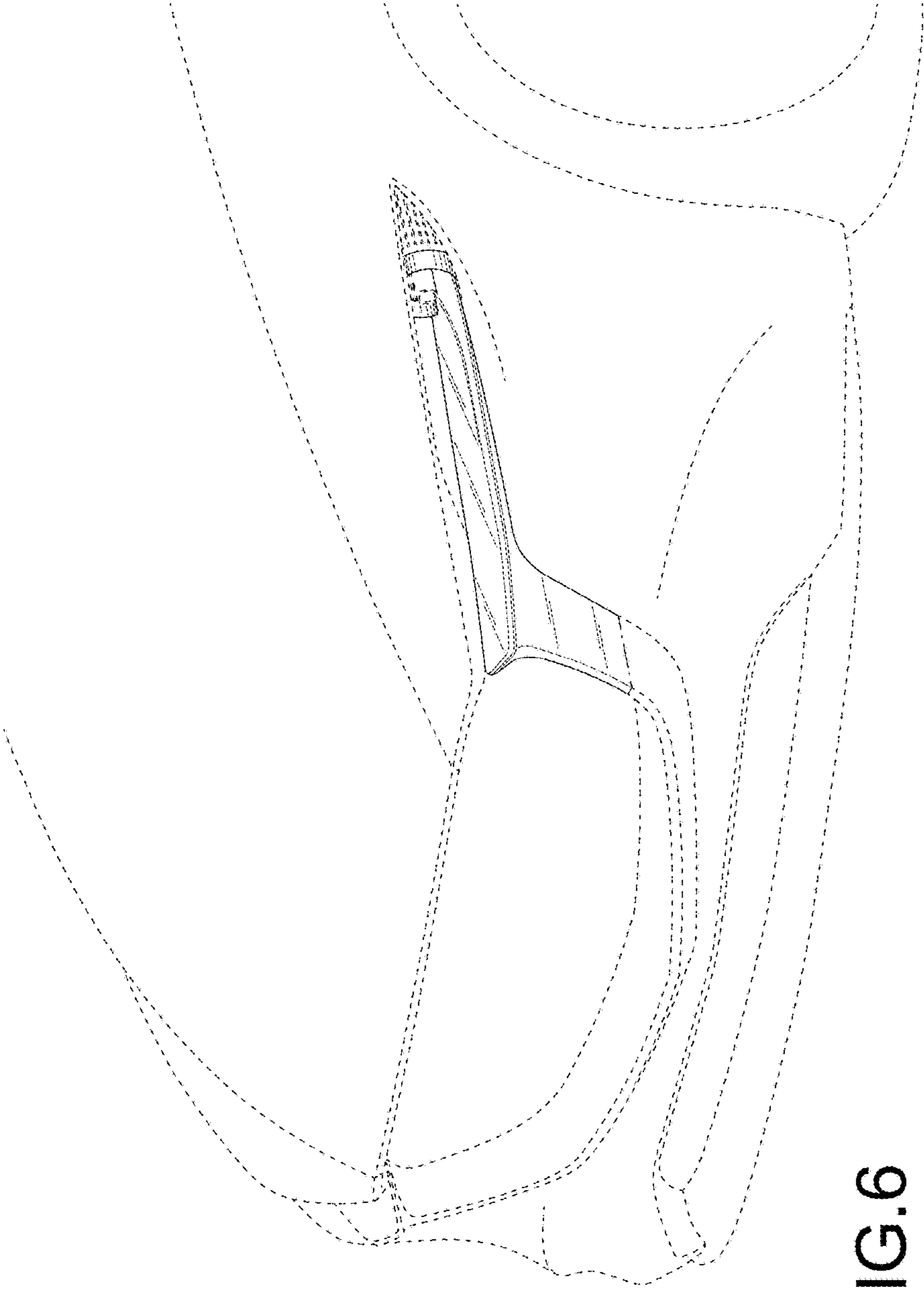

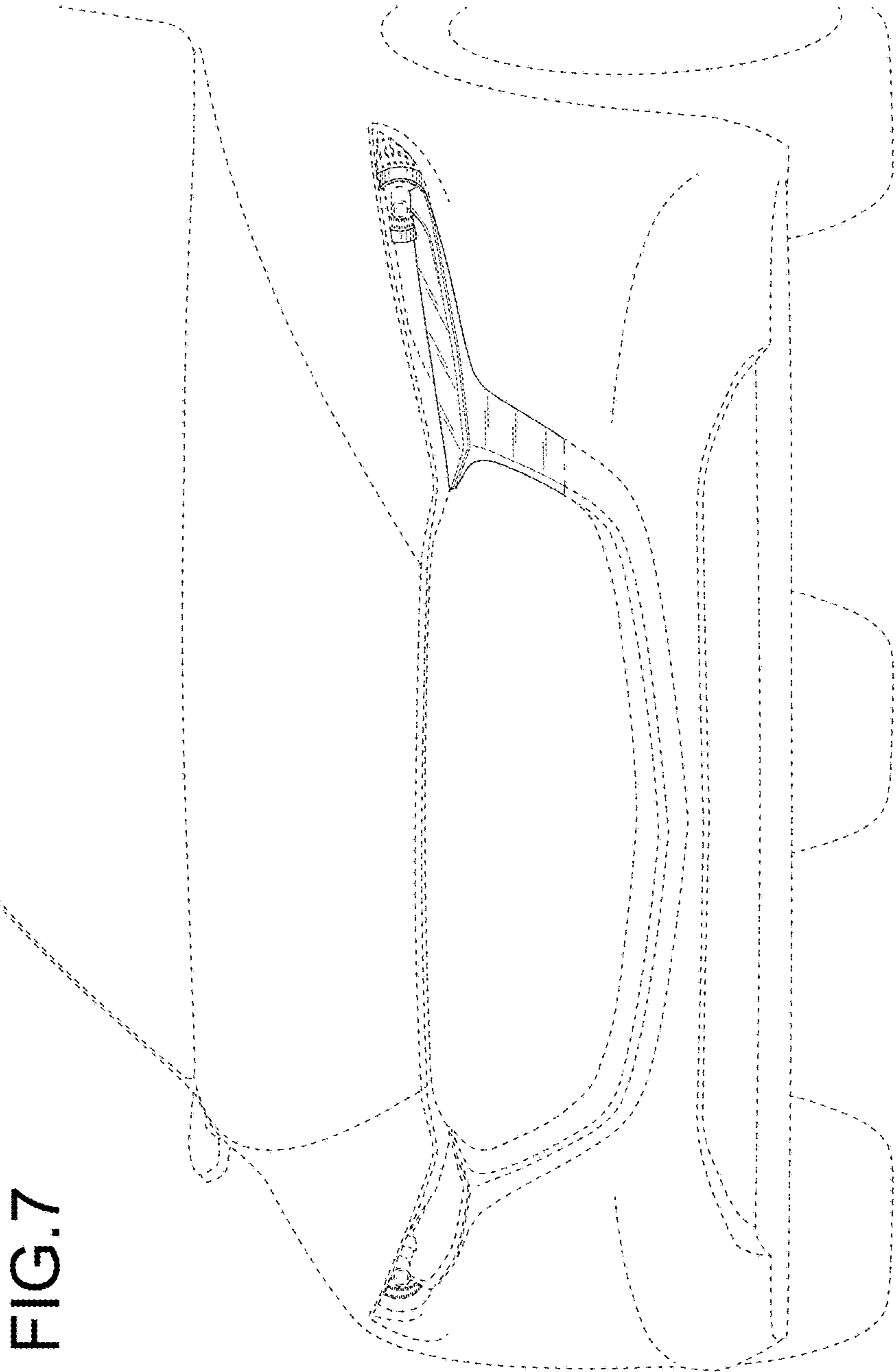
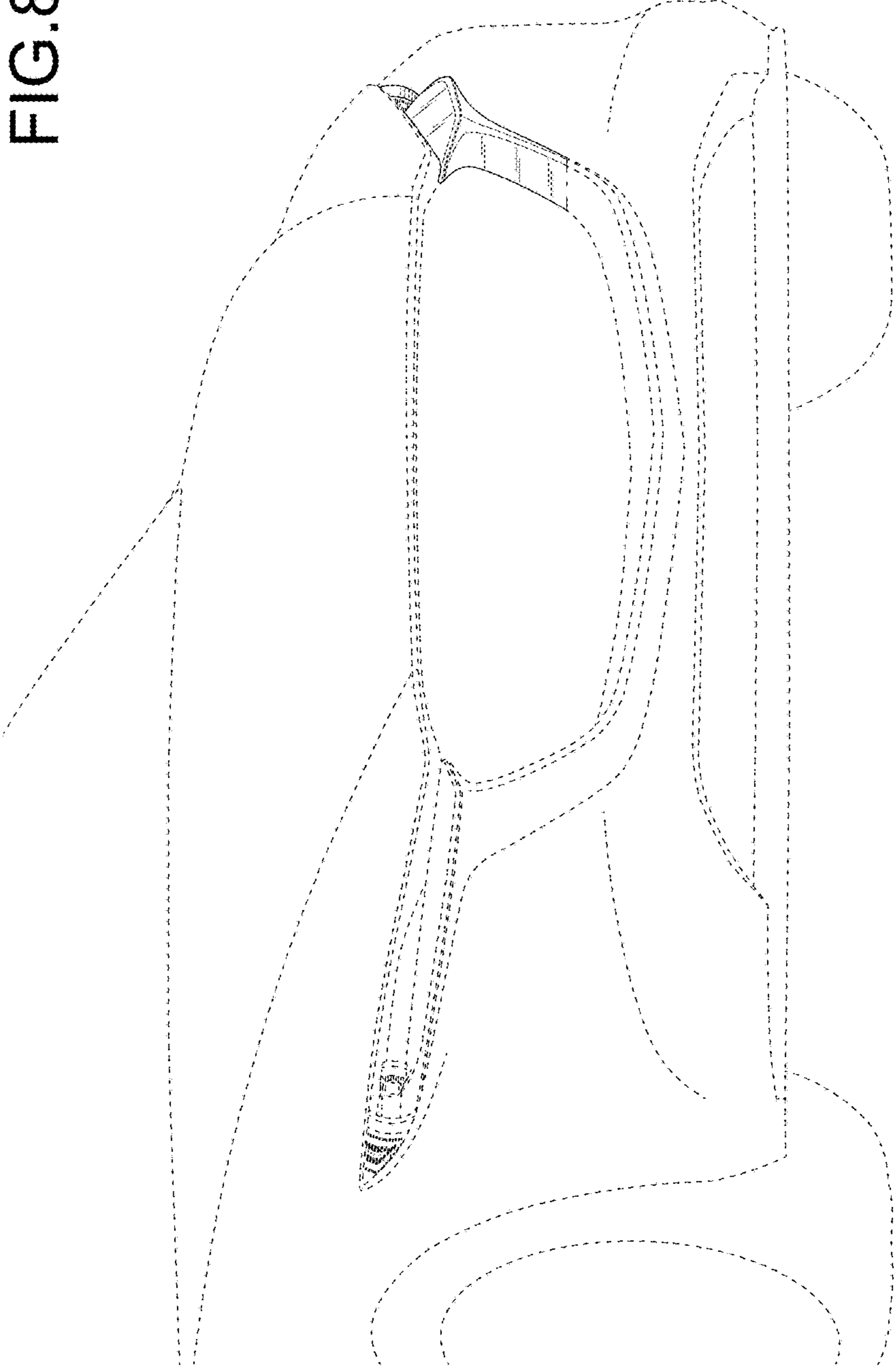

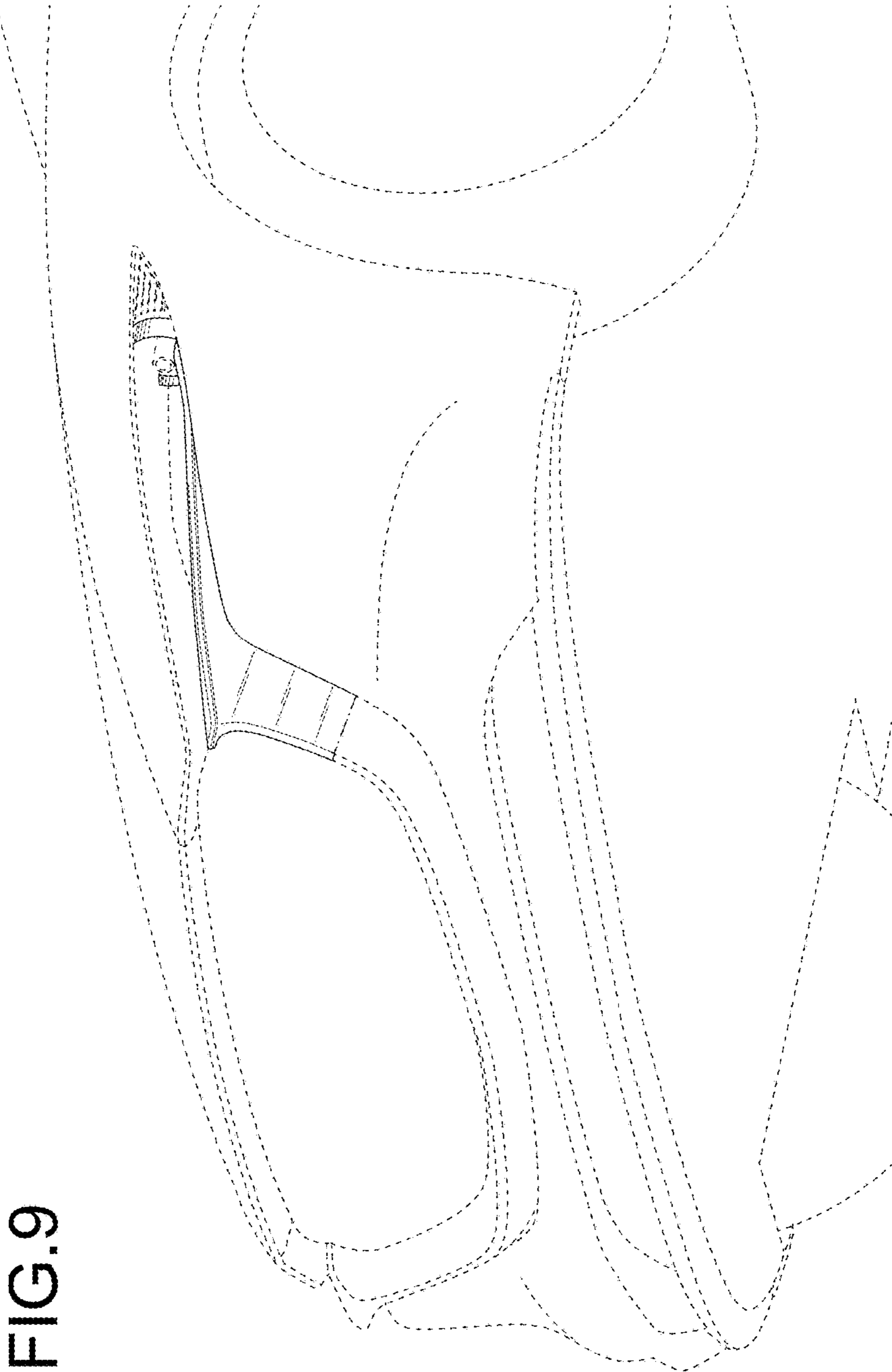
