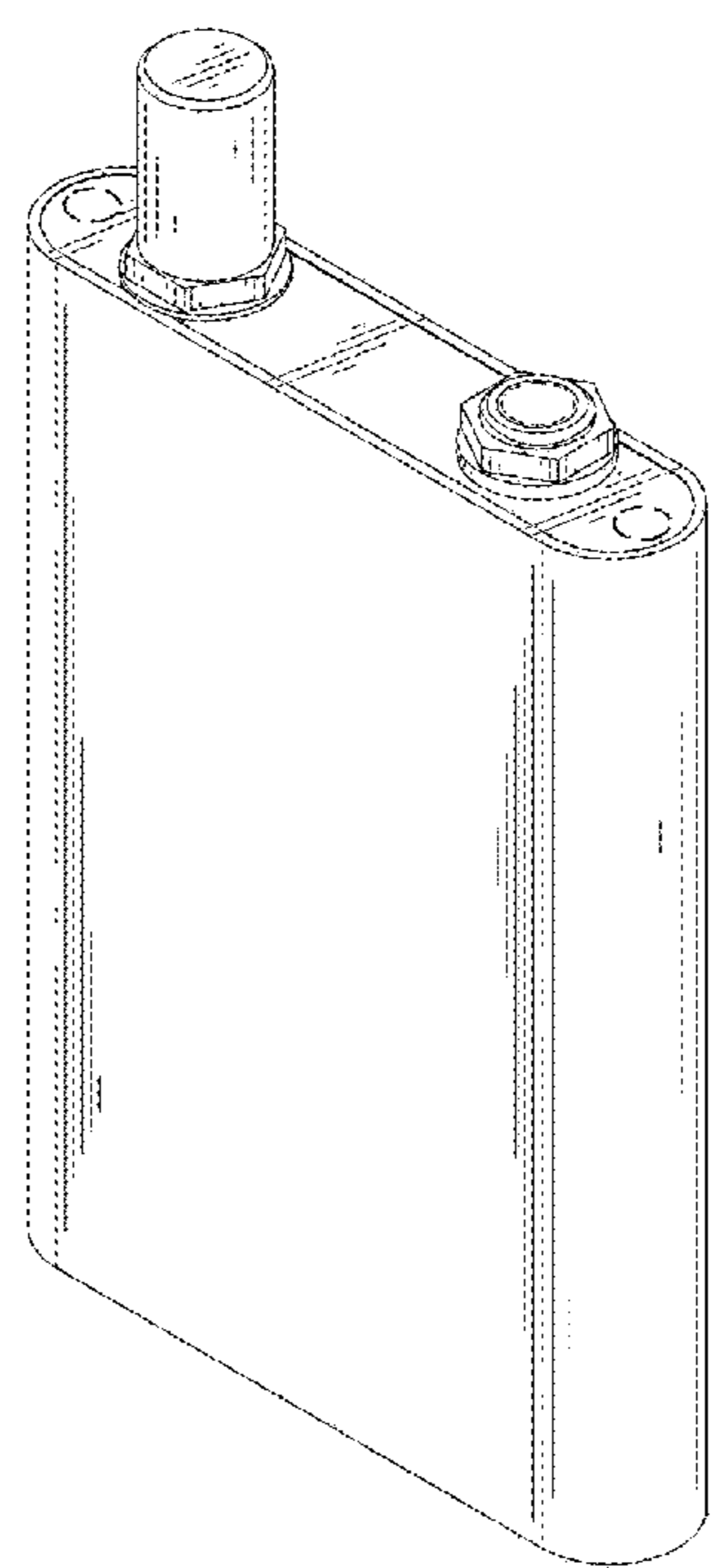

DESCRIPTION
FIG. 1 is a perspective view of a dental LED headlight
showing my new design;
FIG. 2 is a front elevational view thereof;
FIG. 3 is a rear elevational view thereof;

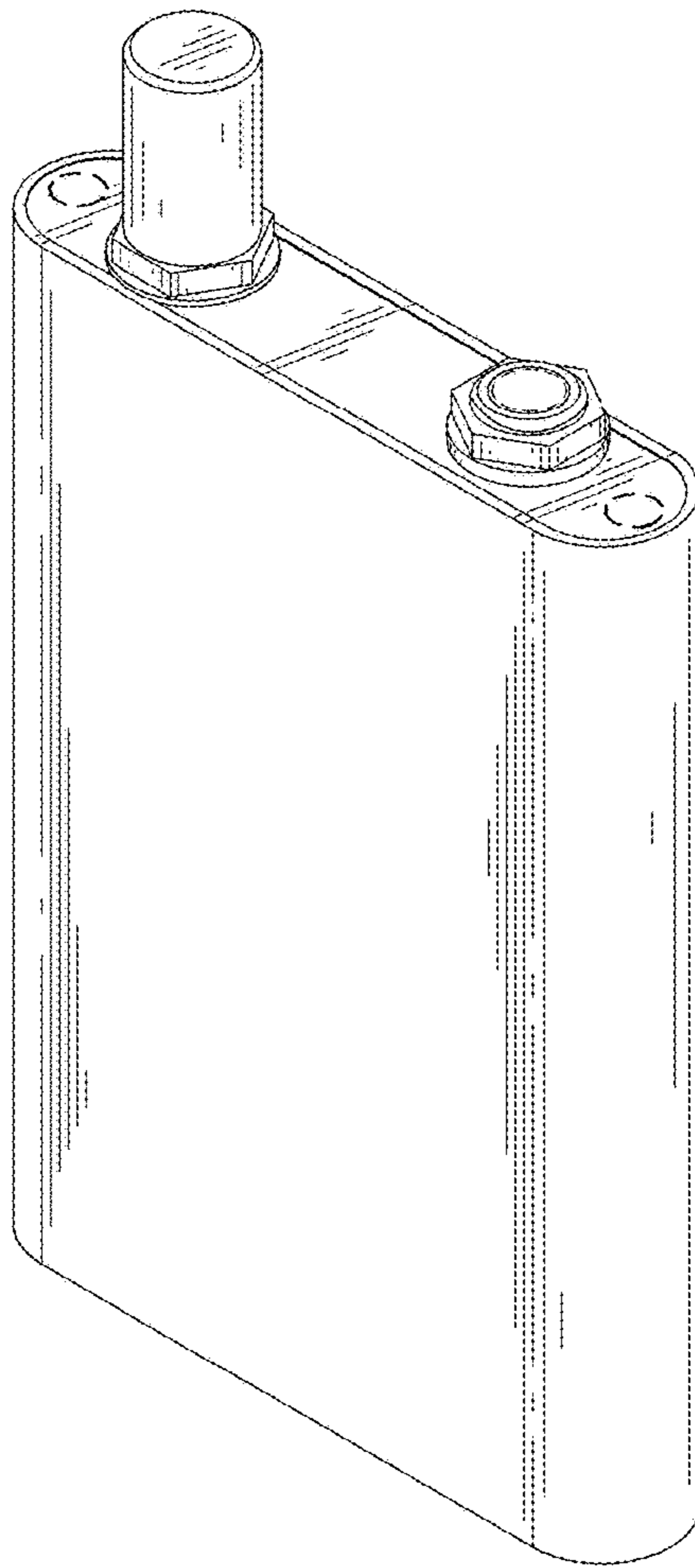

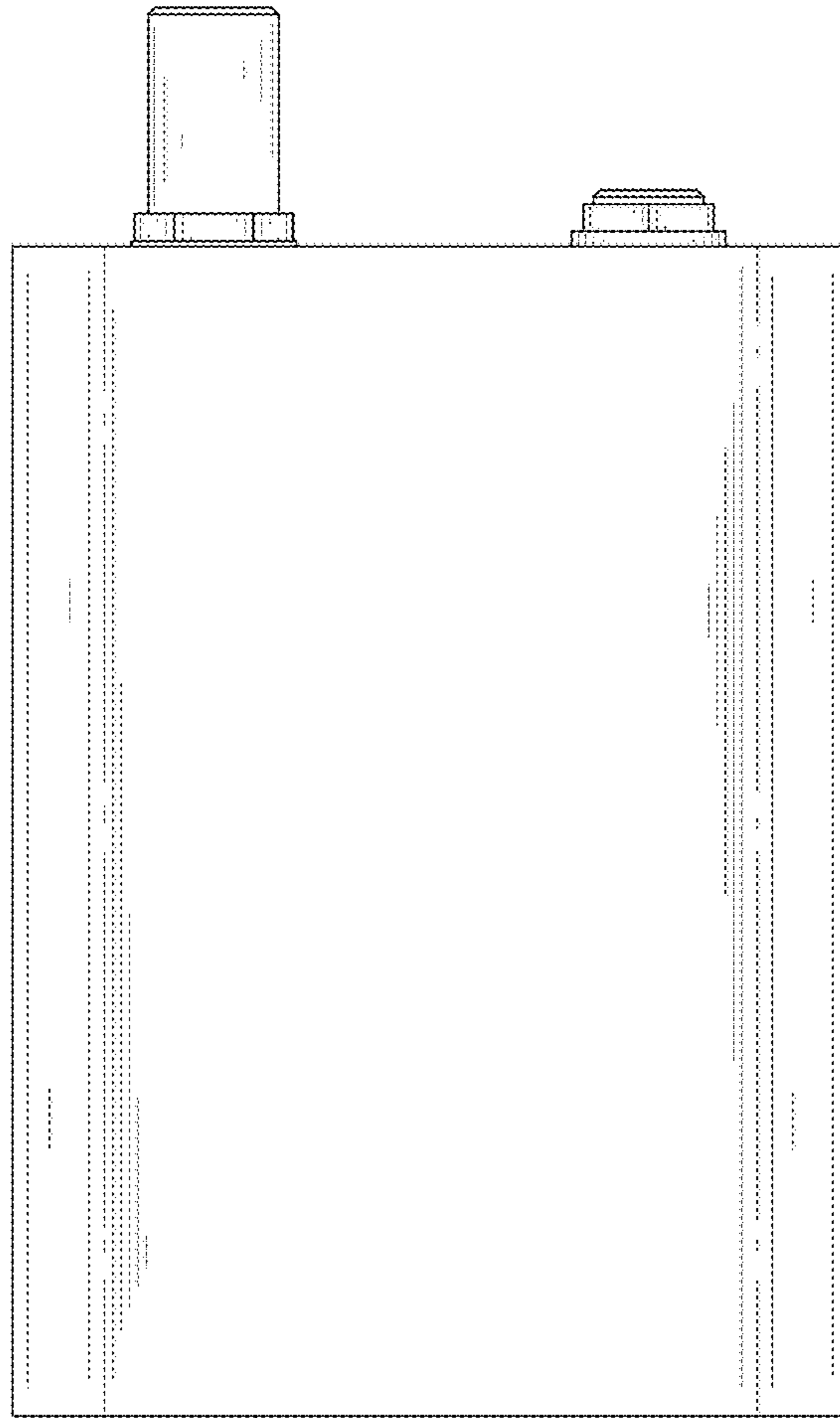

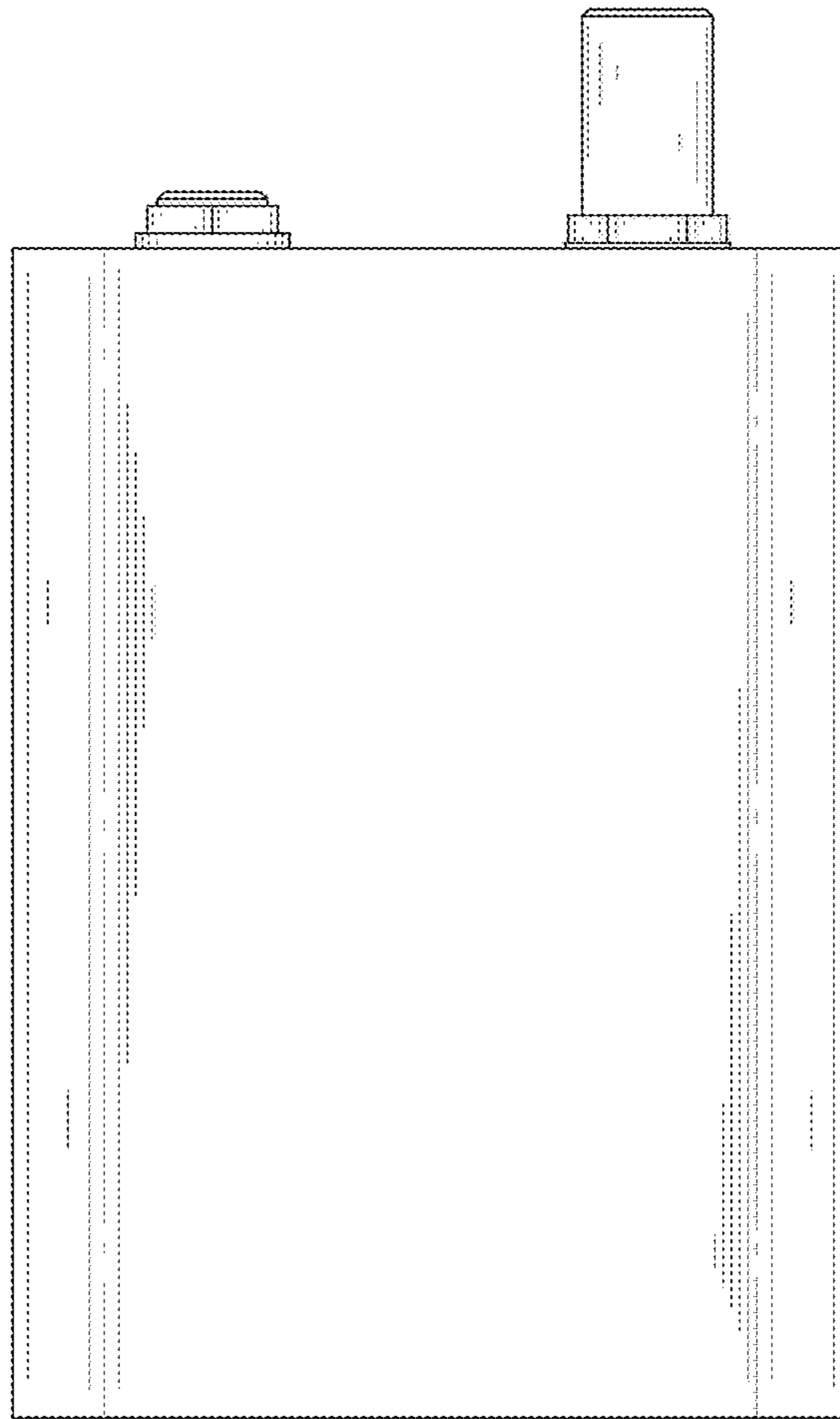

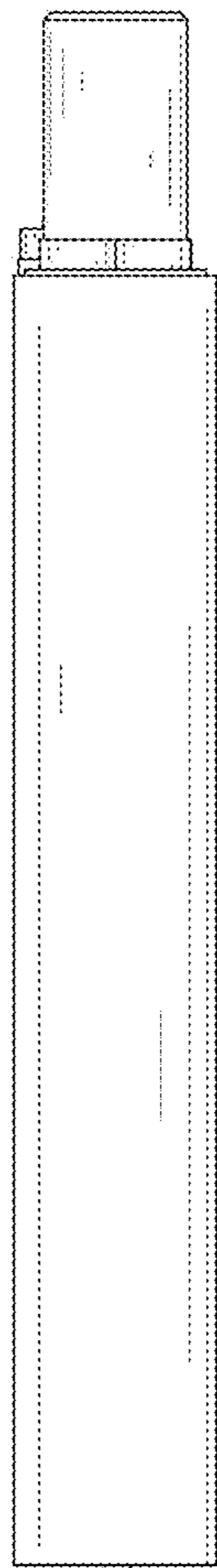

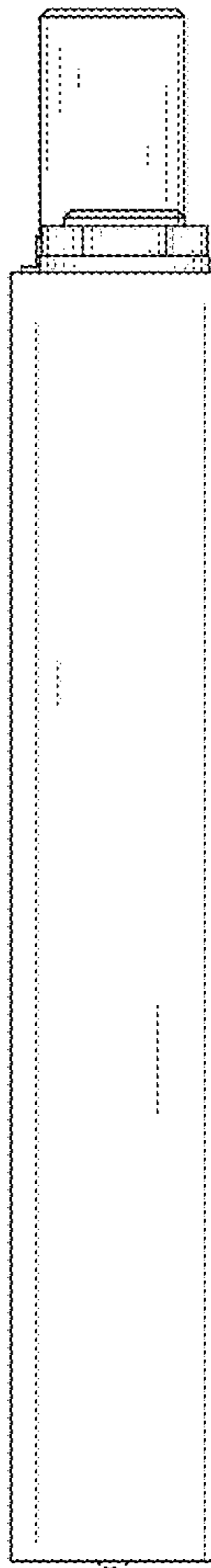

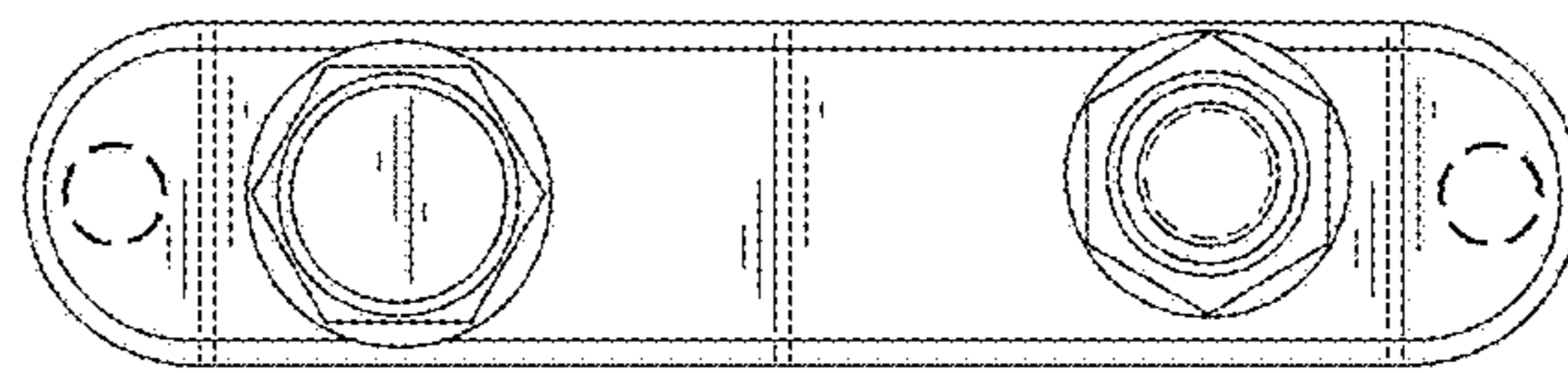
