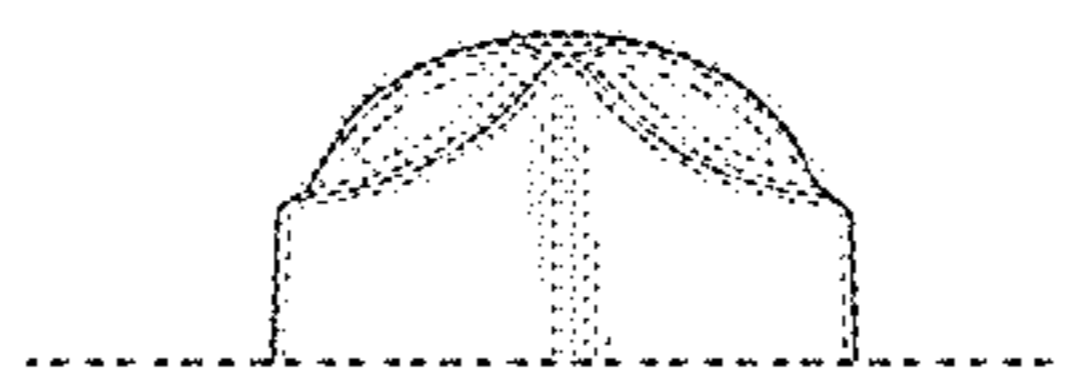
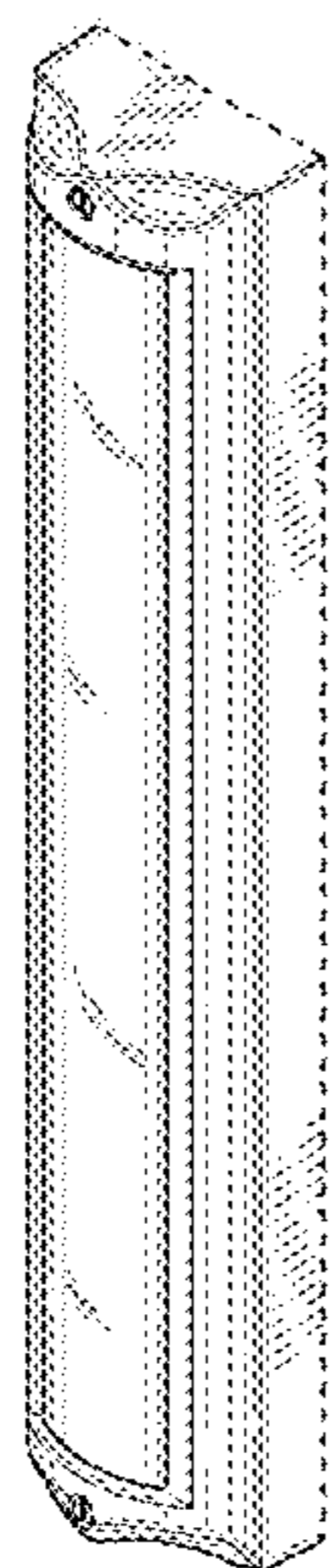
(57) **CLAIM**

The ornamental design for a lighting fixture, as shown and described.

**DESCRIPTION**

FIG. 1 is a front perspective view of a new lighting fixture; FIG. 2 is a back perspective view thereof; FIG. 3 is a front elevational view thereof; FIG. 4 is a left elevational view thereof; FIG. 5 is a right elevational view thereof; FIG. 6 is a top plan view thereof; FIG. 7 is a bottom plan view thereof; and, FIG. 8 is a back elevational view thereof. The broken line disclosures in FIGS. 1, 2 and 8 represent the rear surface of the lighting fixture, which forms no part of the claimed design. The broken line disclosures in FIGS. 4, 5, 6 and 7 represent environmental structure which forms no part of the claimed design.

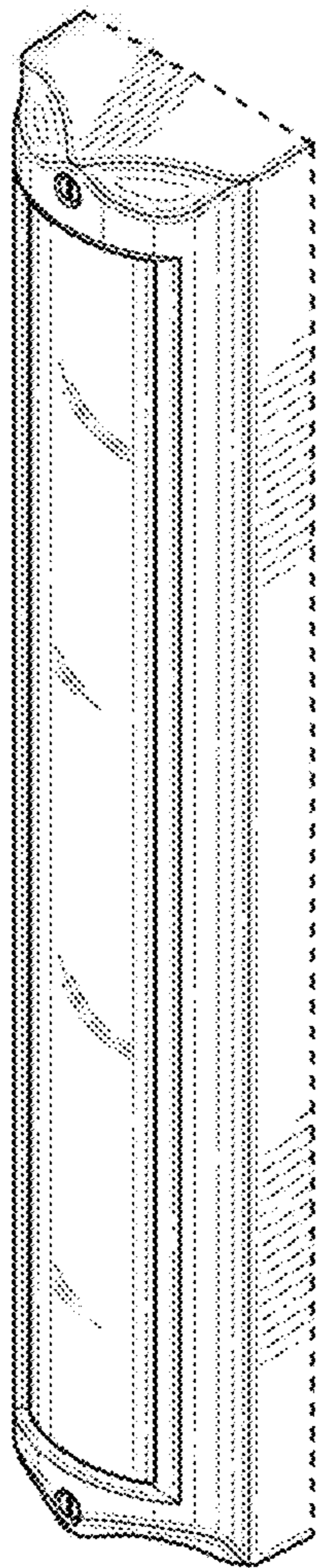

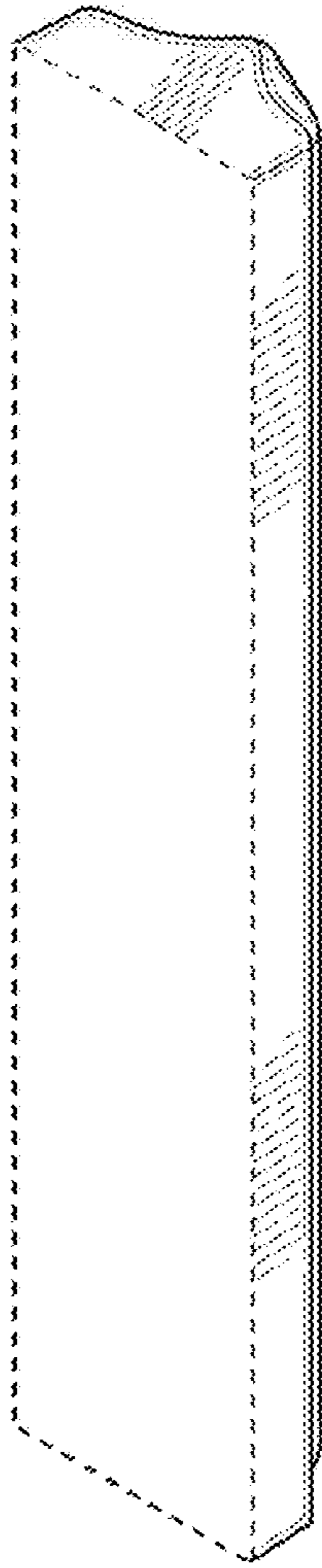

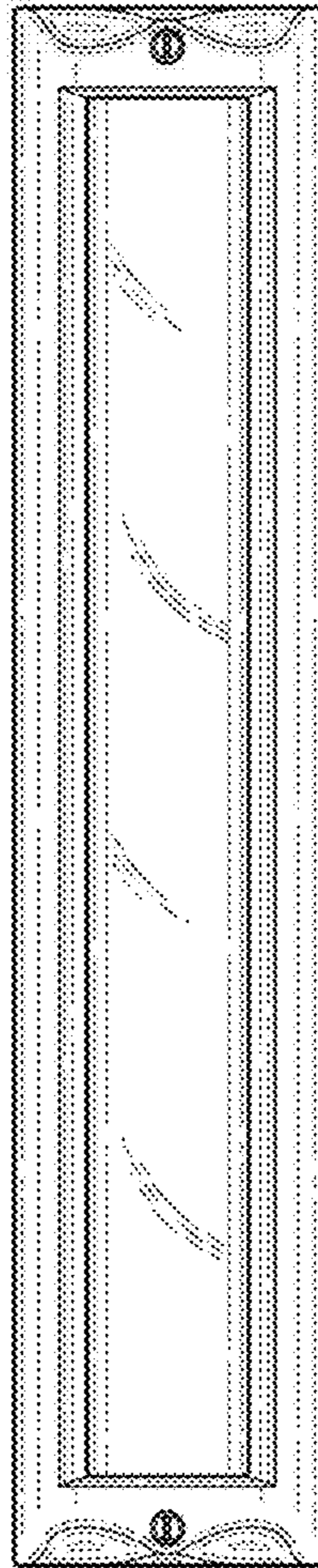

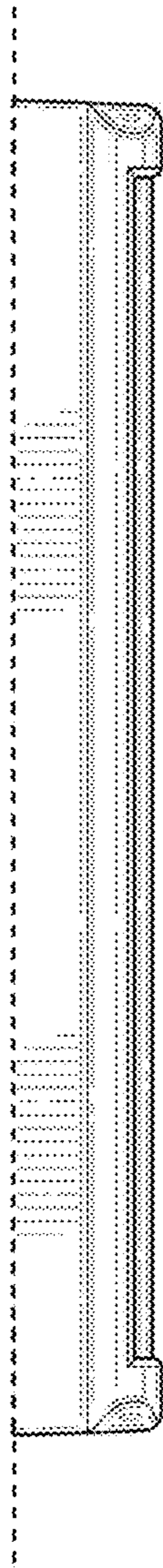

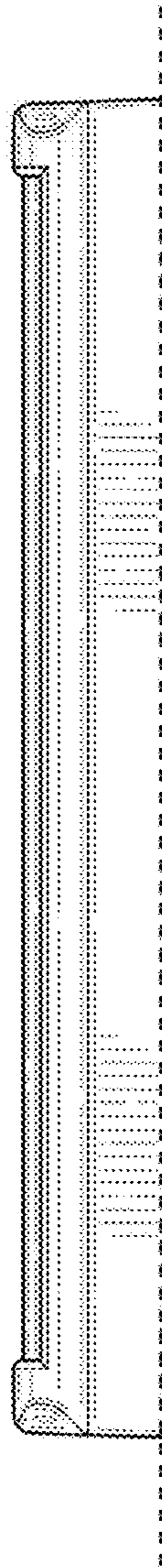

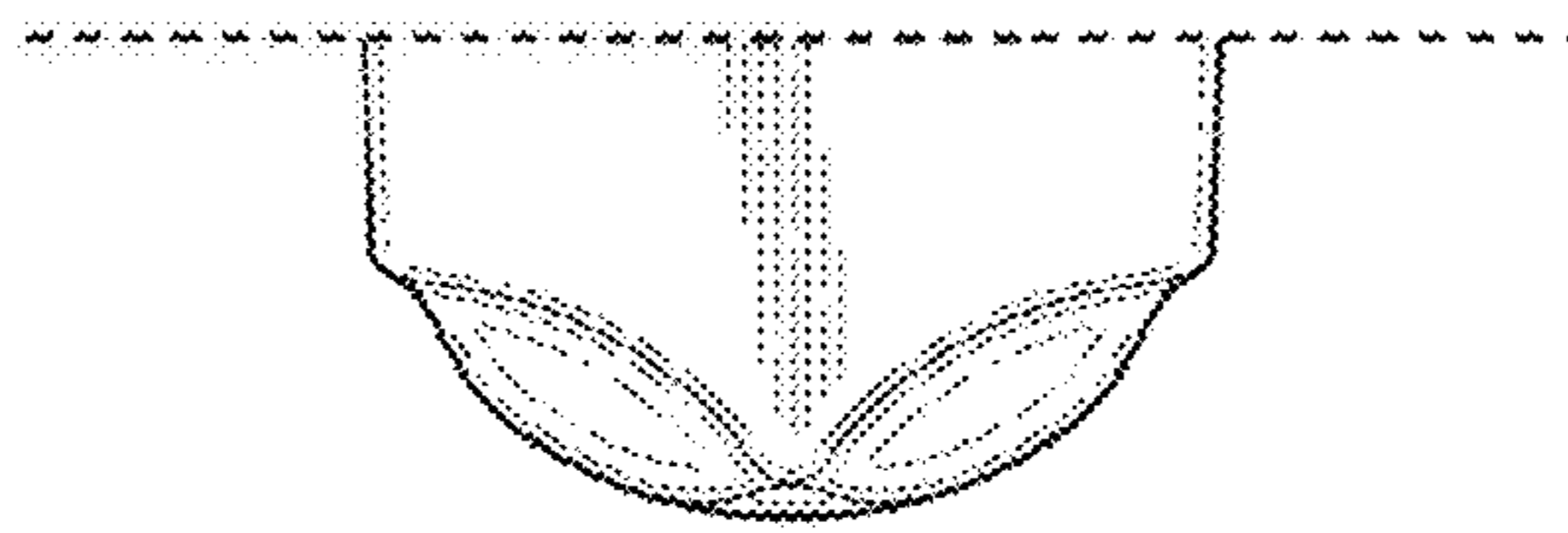

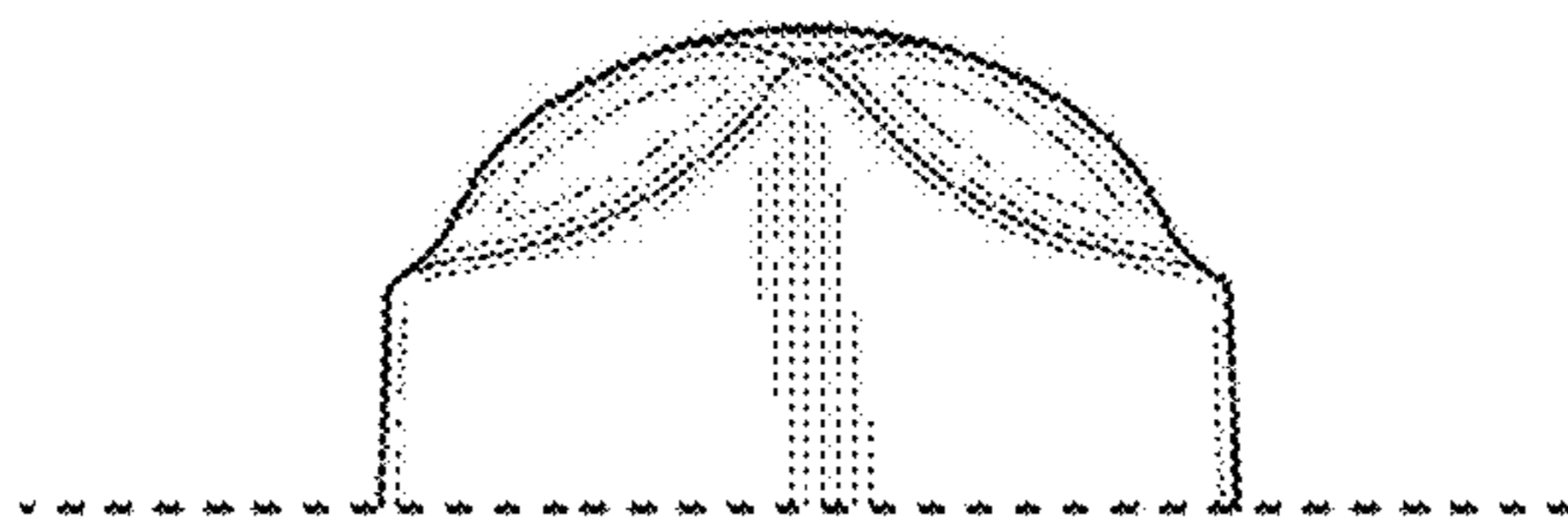

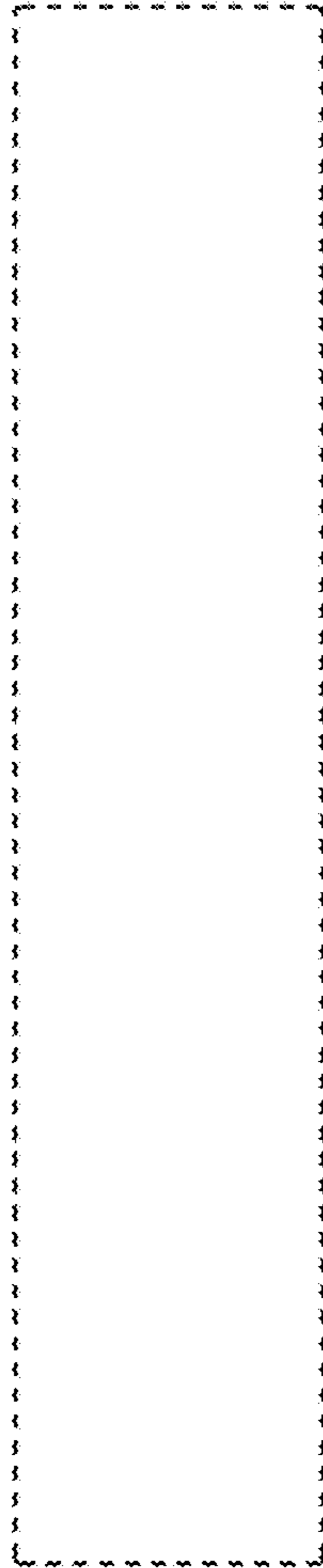
