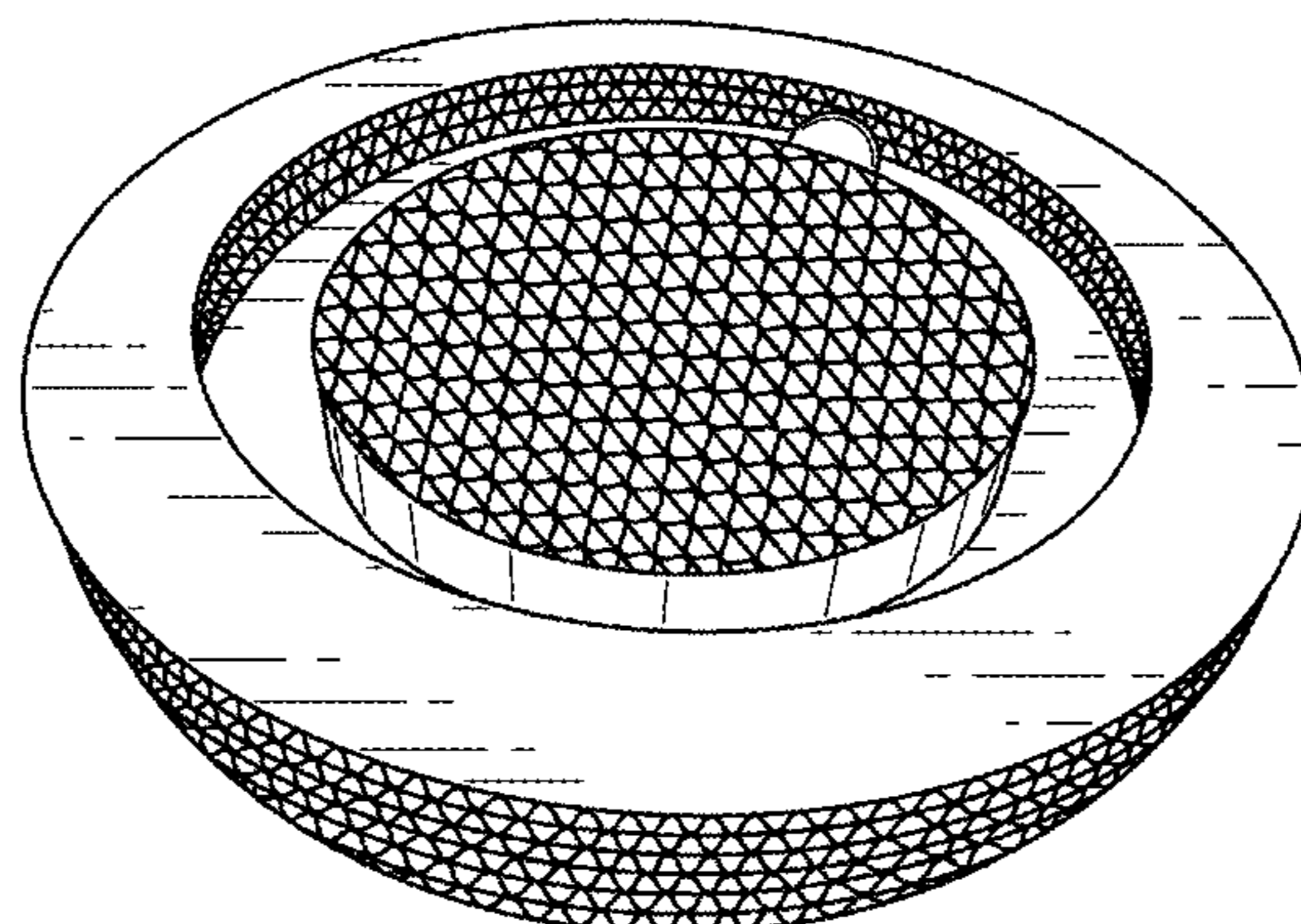
(57) **CLAIM**

I claim the ornamental design for a cardboard cat ball track wobble toy, as shown and described.

DESCRIPTION

FIG. 1 is a top right perspective view of a cardboard cat ball track wobble toy;
 FIG. 2 is a front view of the cardboard cat ball track wobble toy of FIG. 1;
 FIG. 3 is a back view of the cardboard cat ball track wobble toy of FIG. 1;

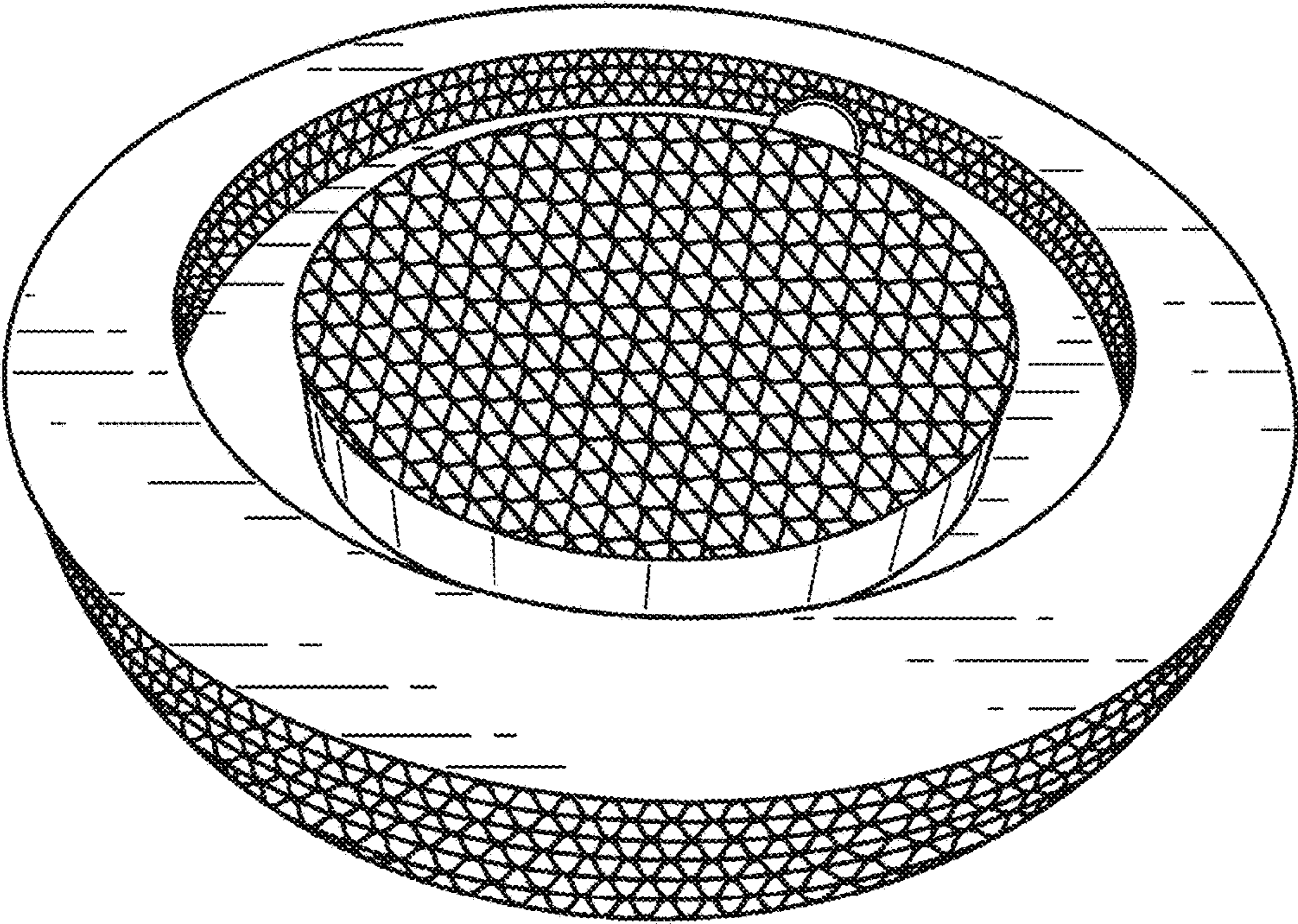

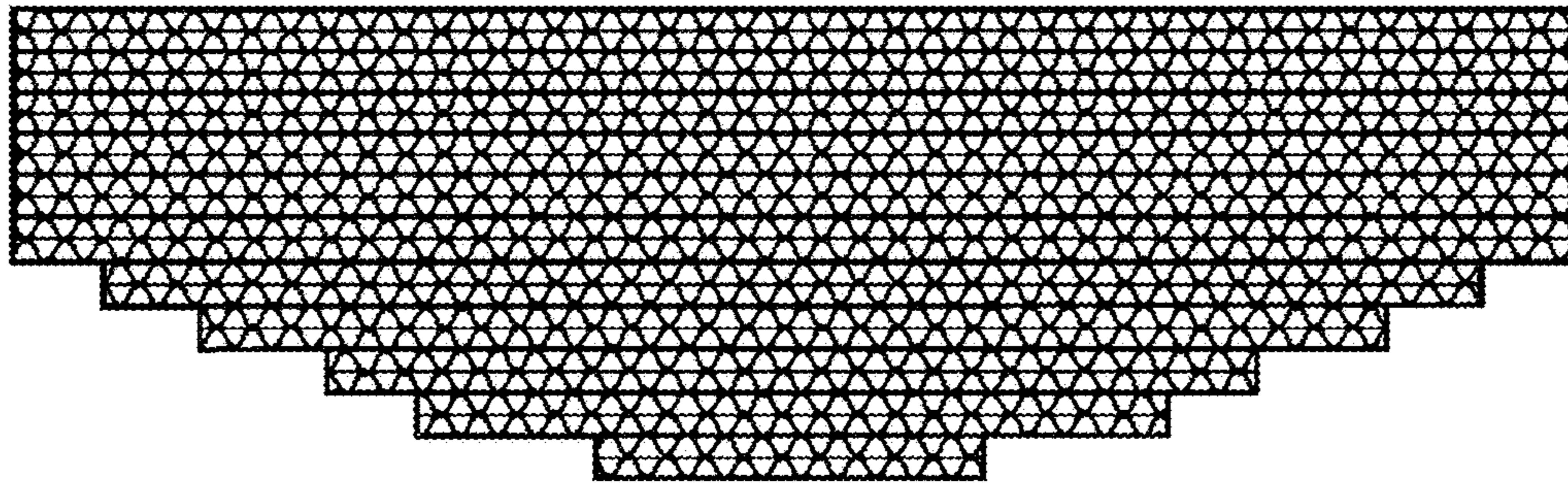

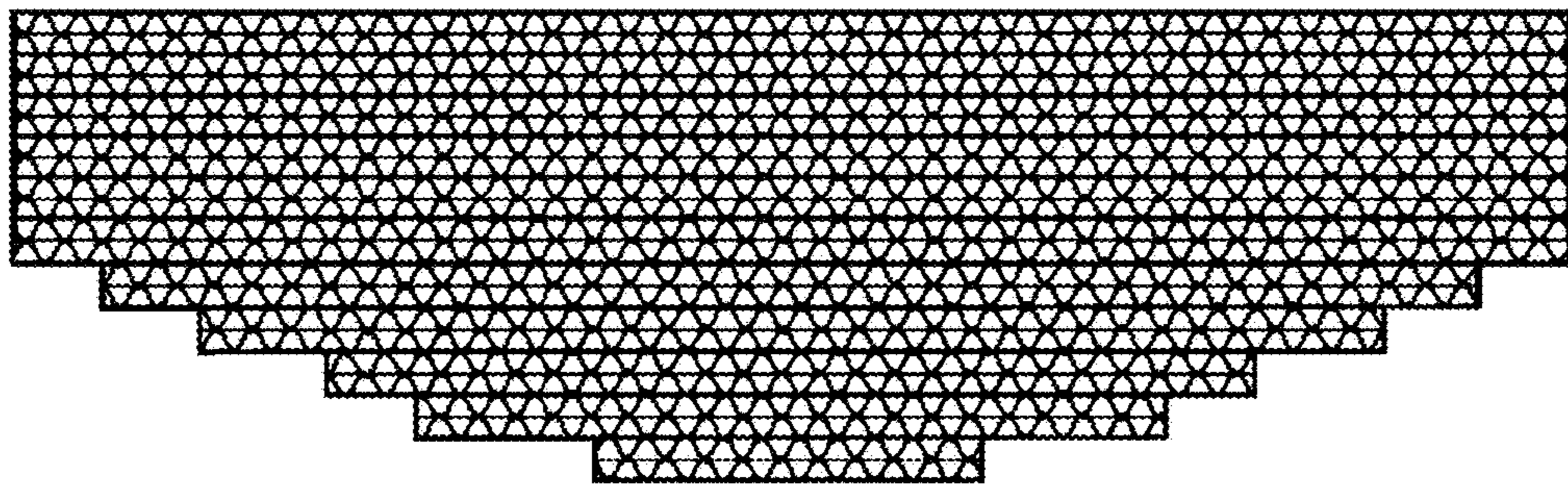

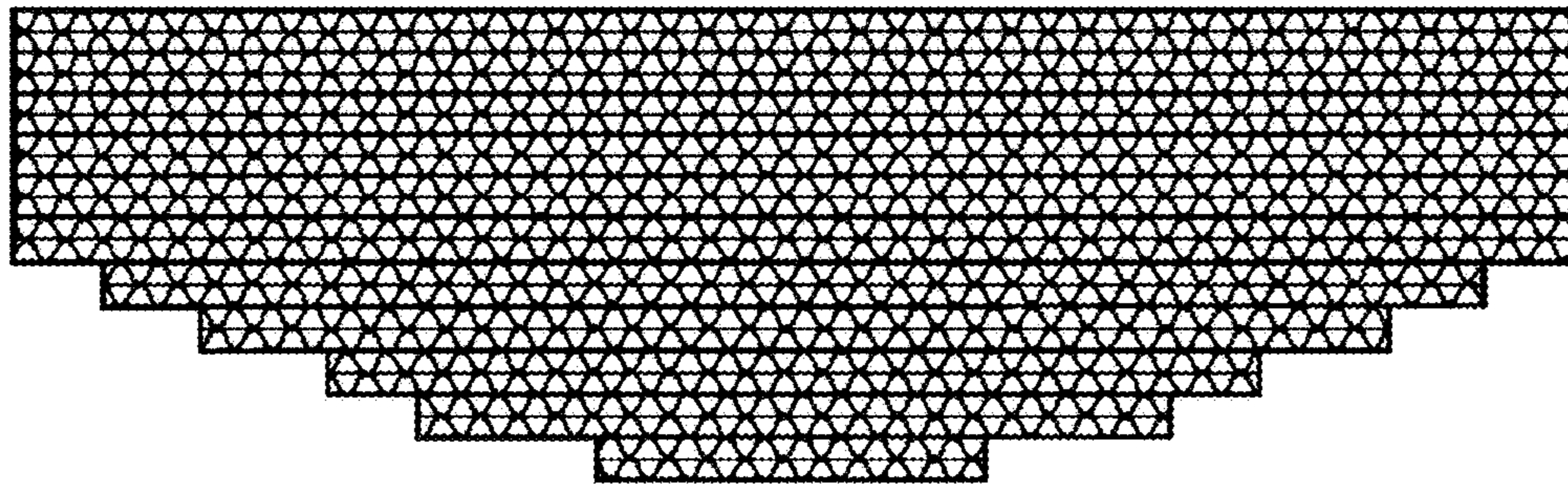

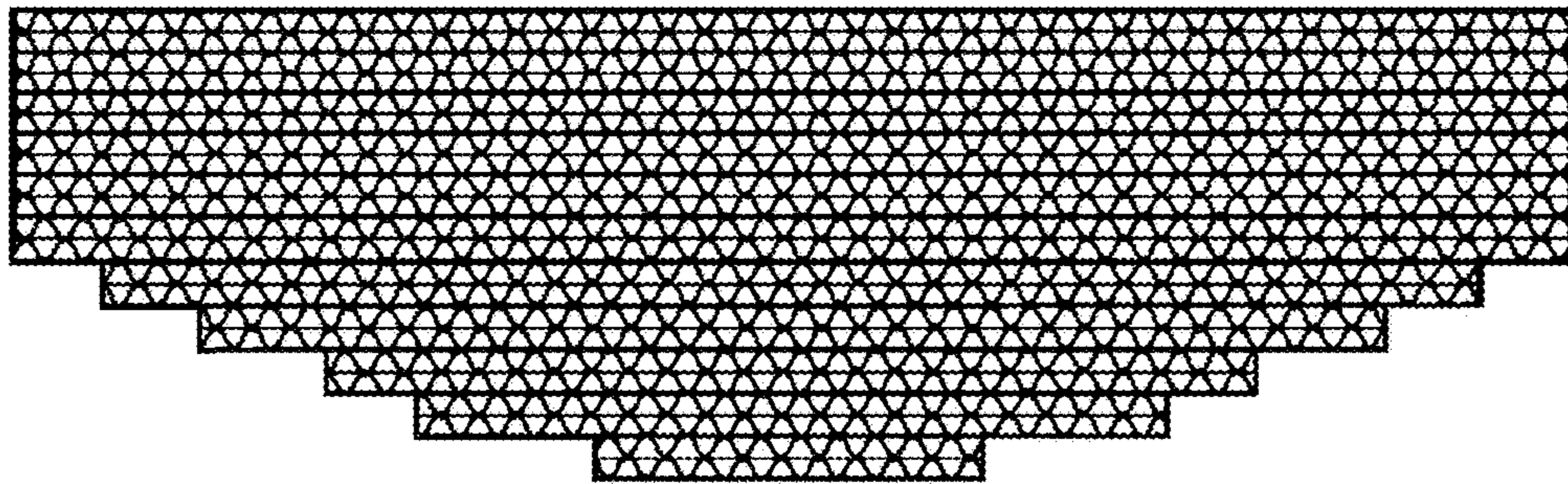

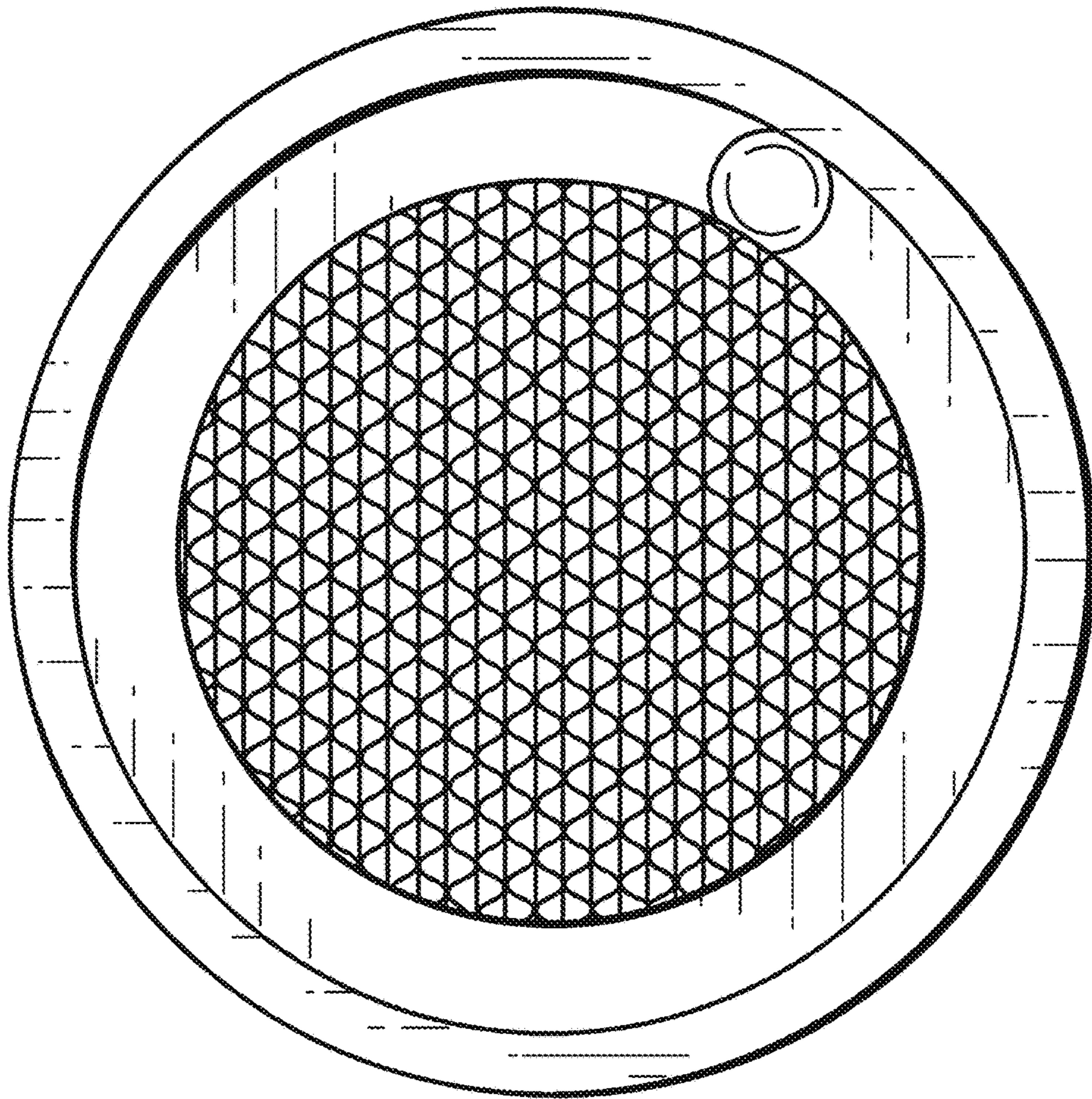

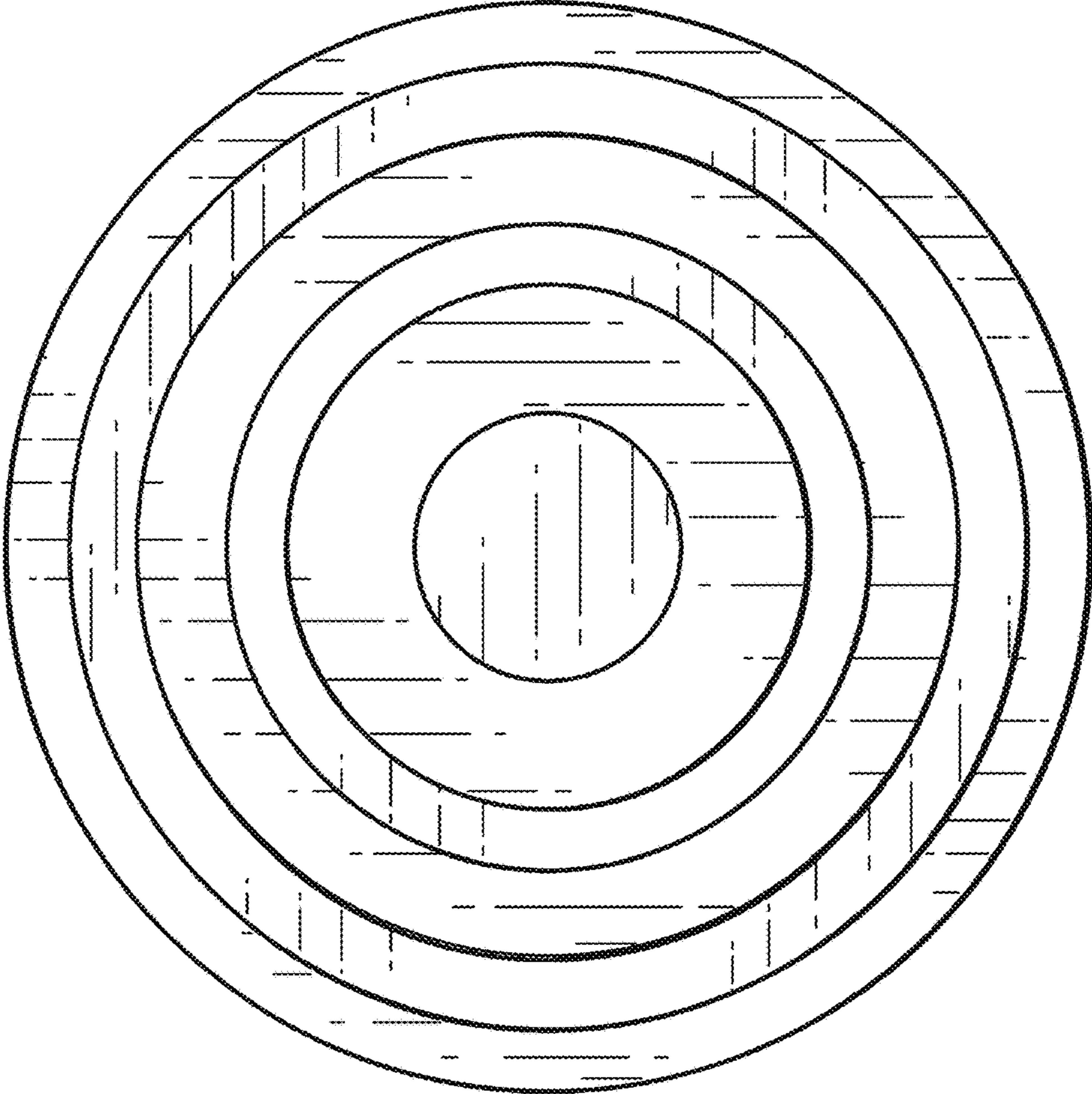

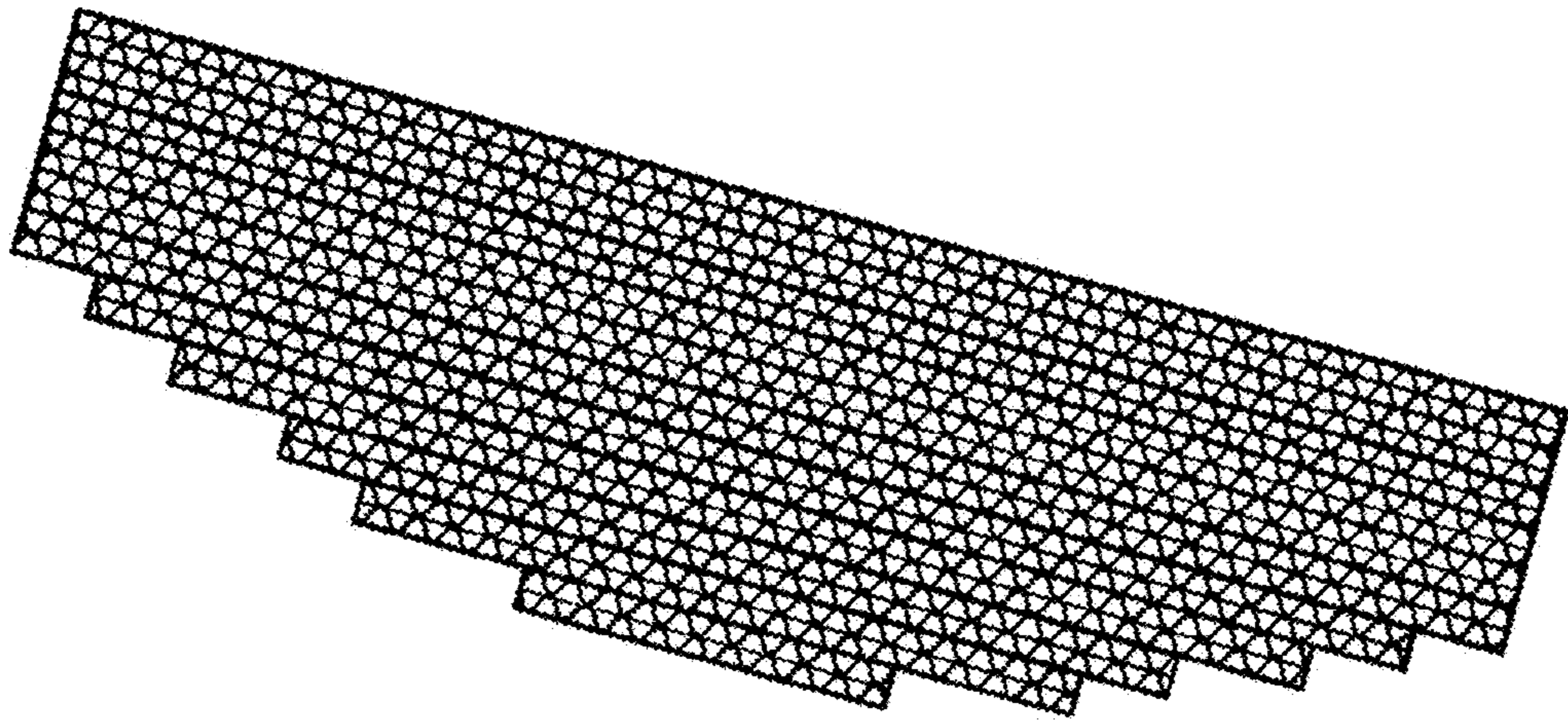

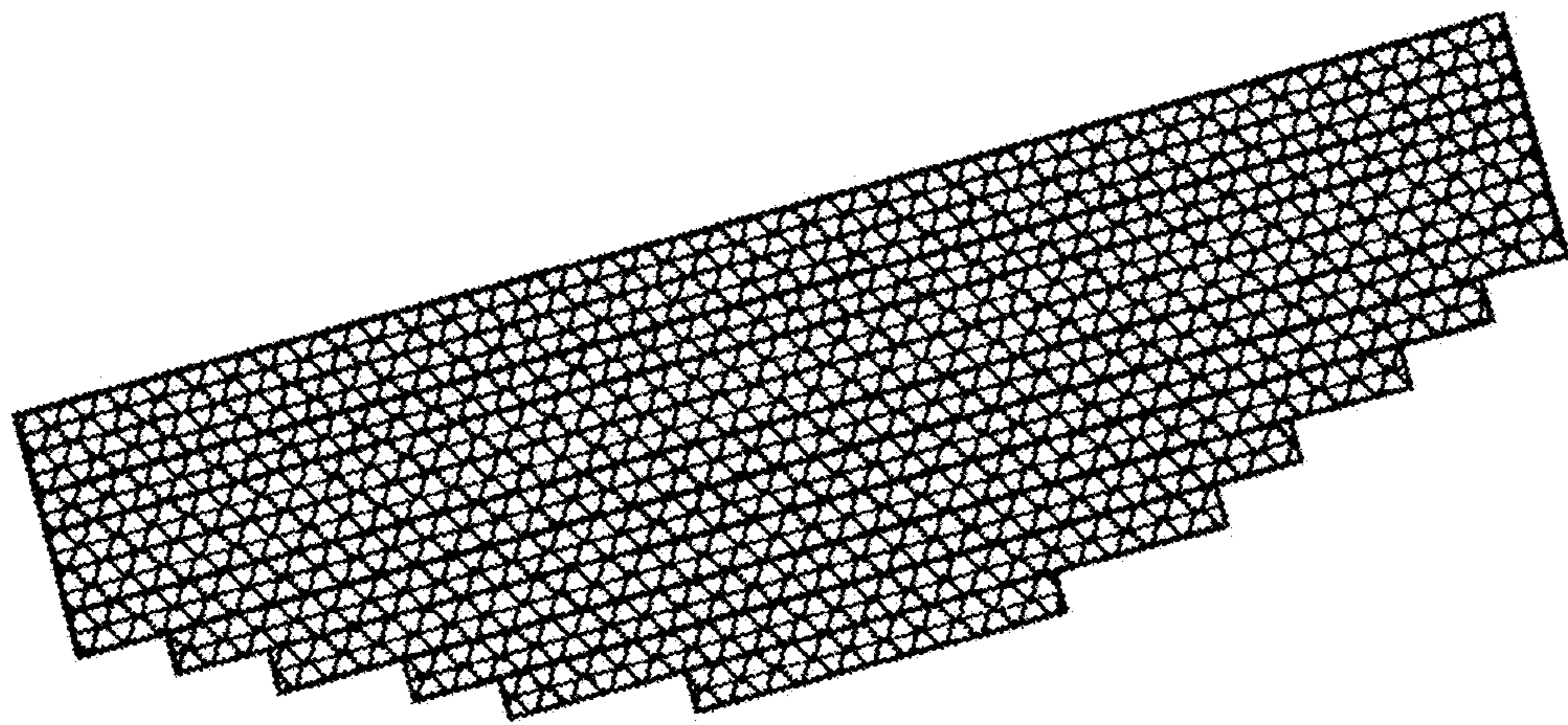
