The ornamental design for sport wear, as shown and described.

DESCRIPTION

FIG. 1 is a back elevational view of the sport wear in one of intended use positions and showing the outer surface of the sport wear.

FIG. 2 is a front elevational view of the sport wear of FIG. 1;

FIG. 3 is a right plan view thereof;

FIG. 5 is a top plan view thereof;

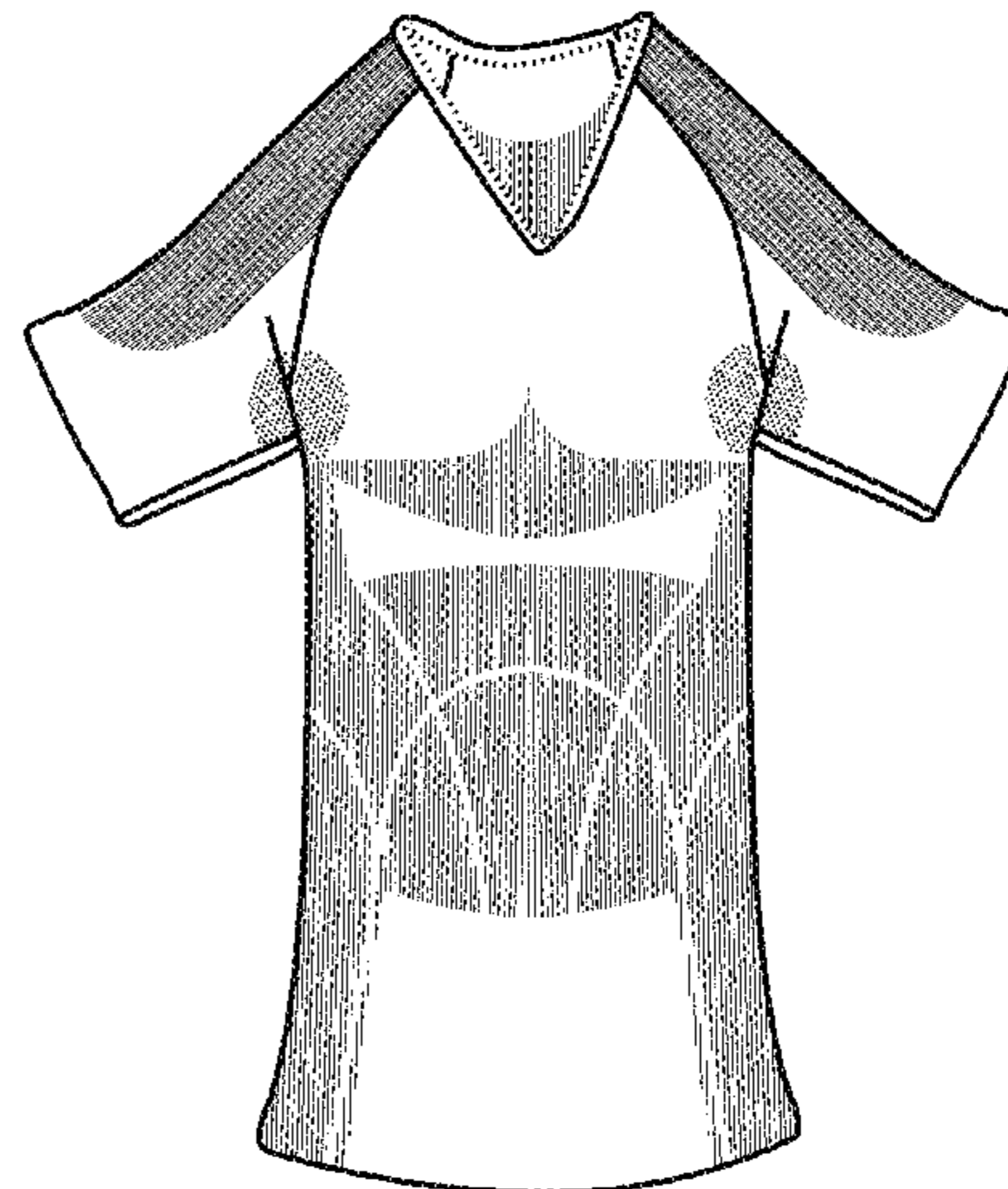
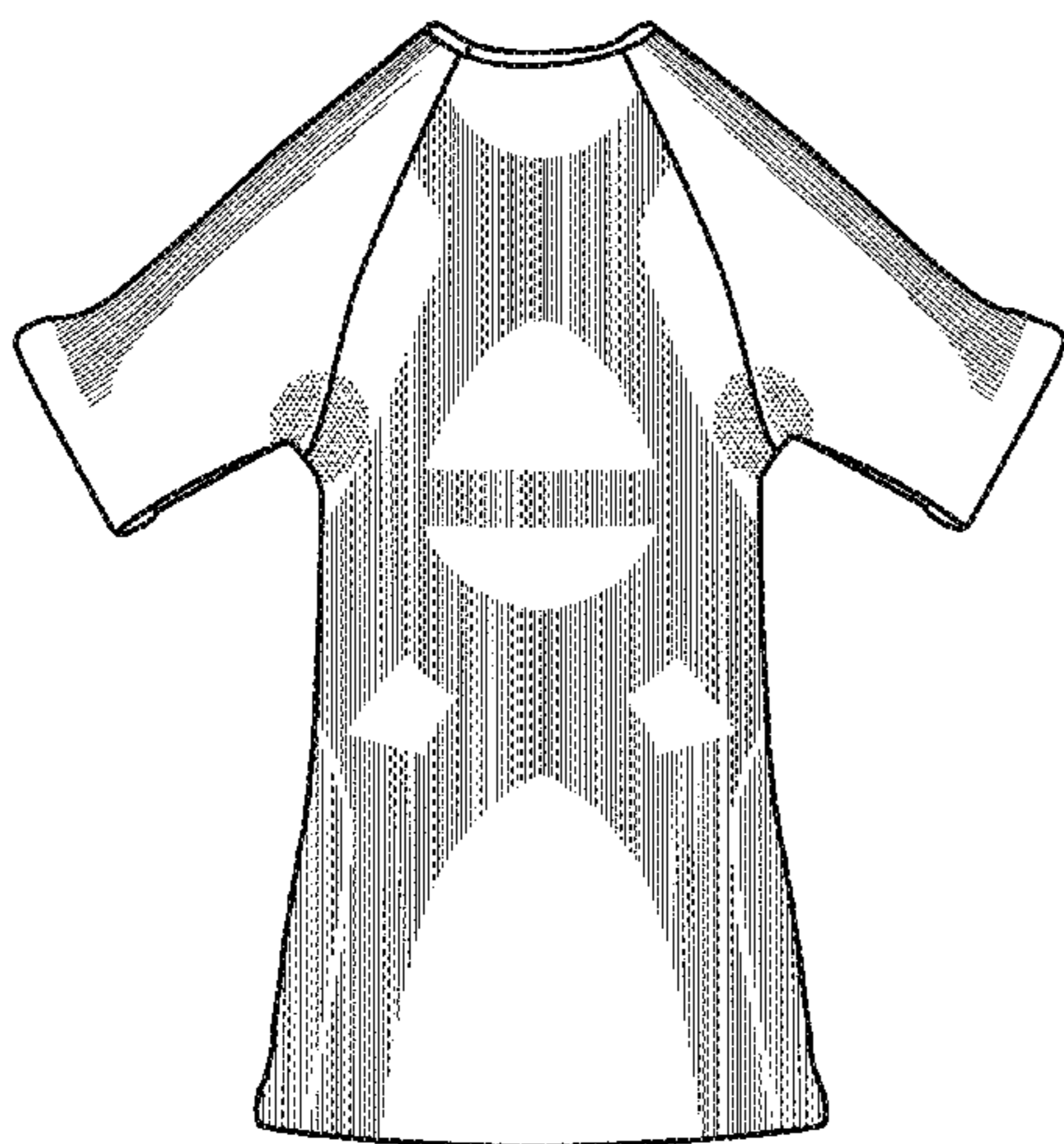
FIG. 6 is a bottom plan view thereof;

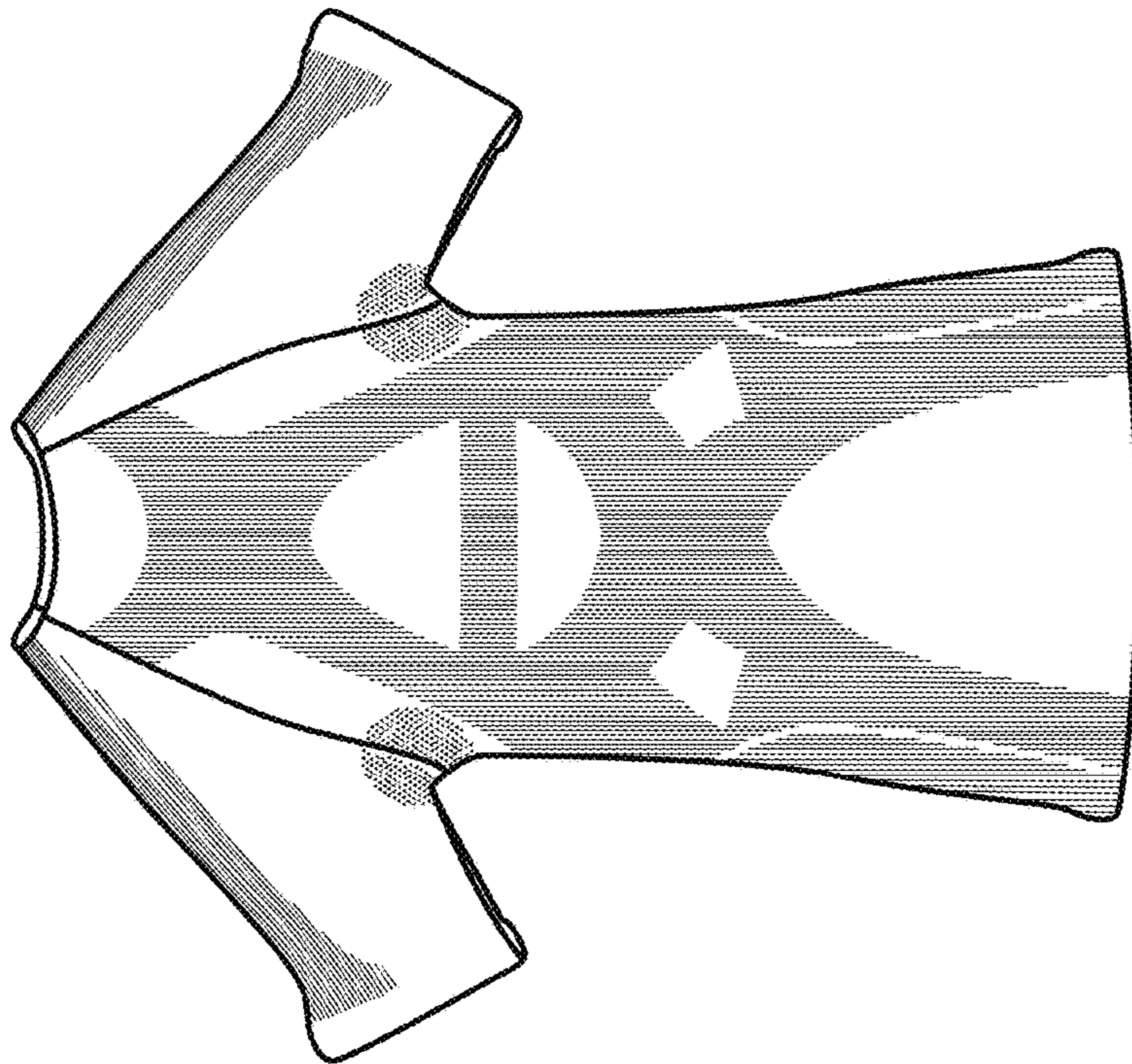

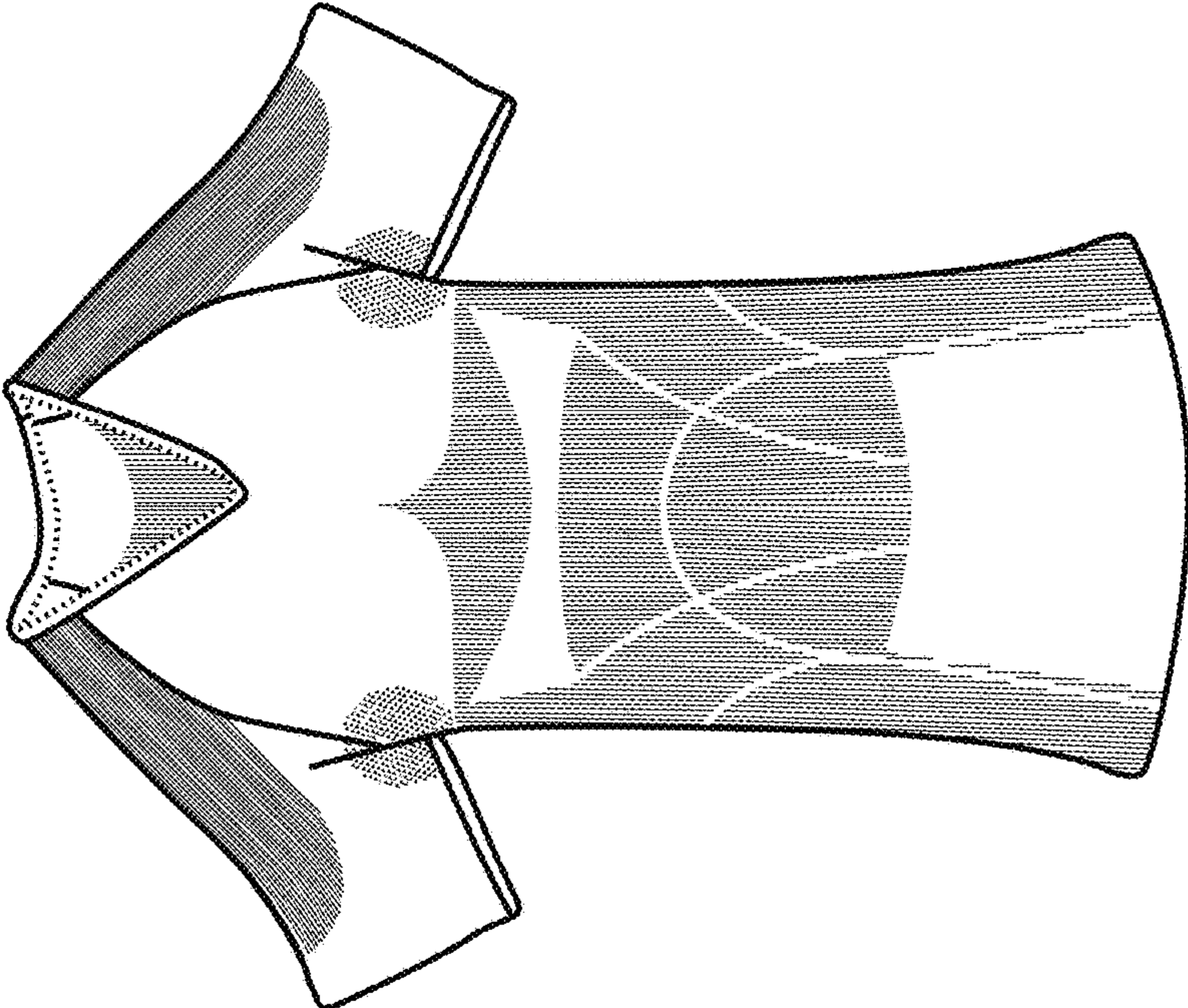

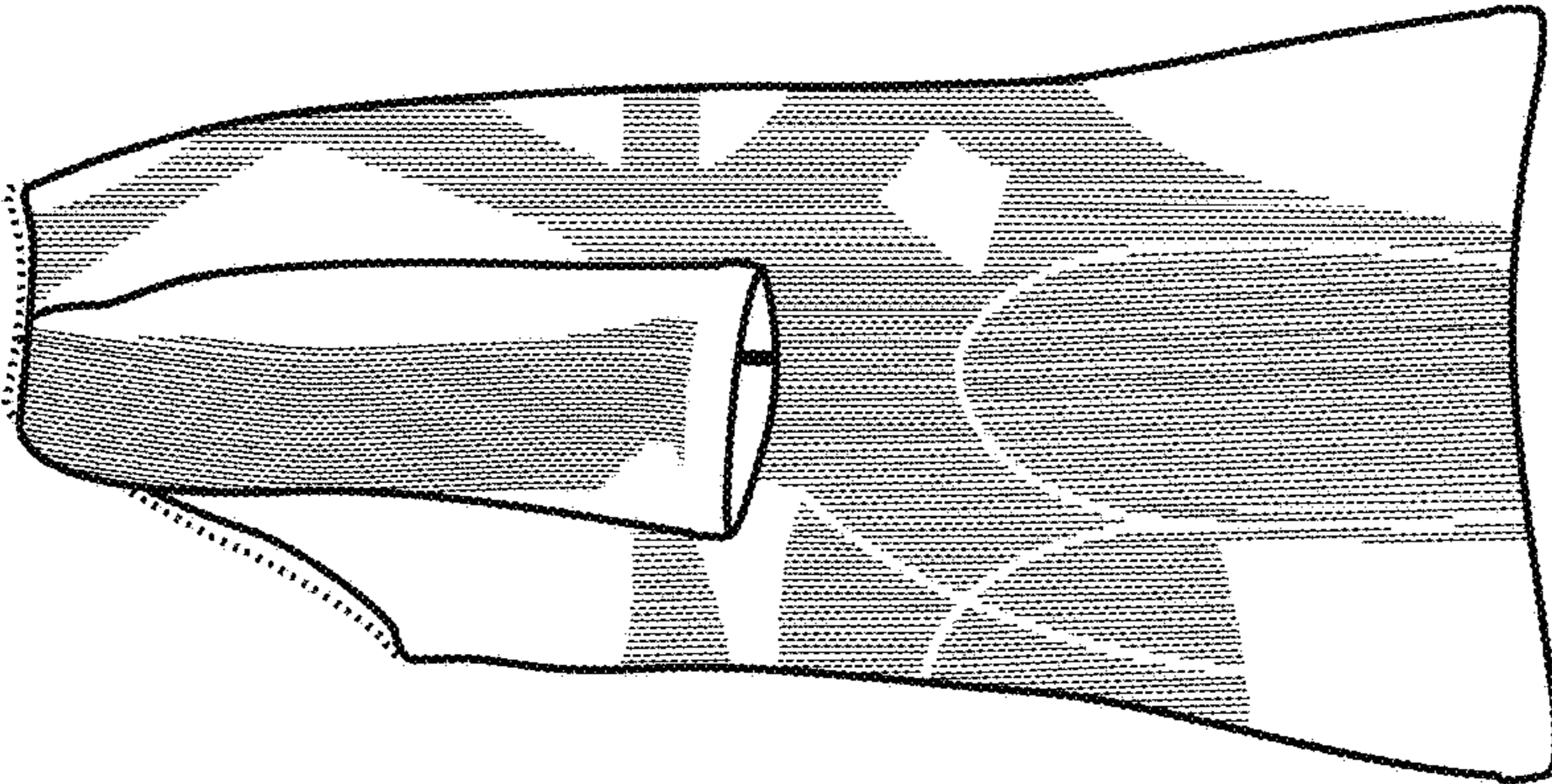

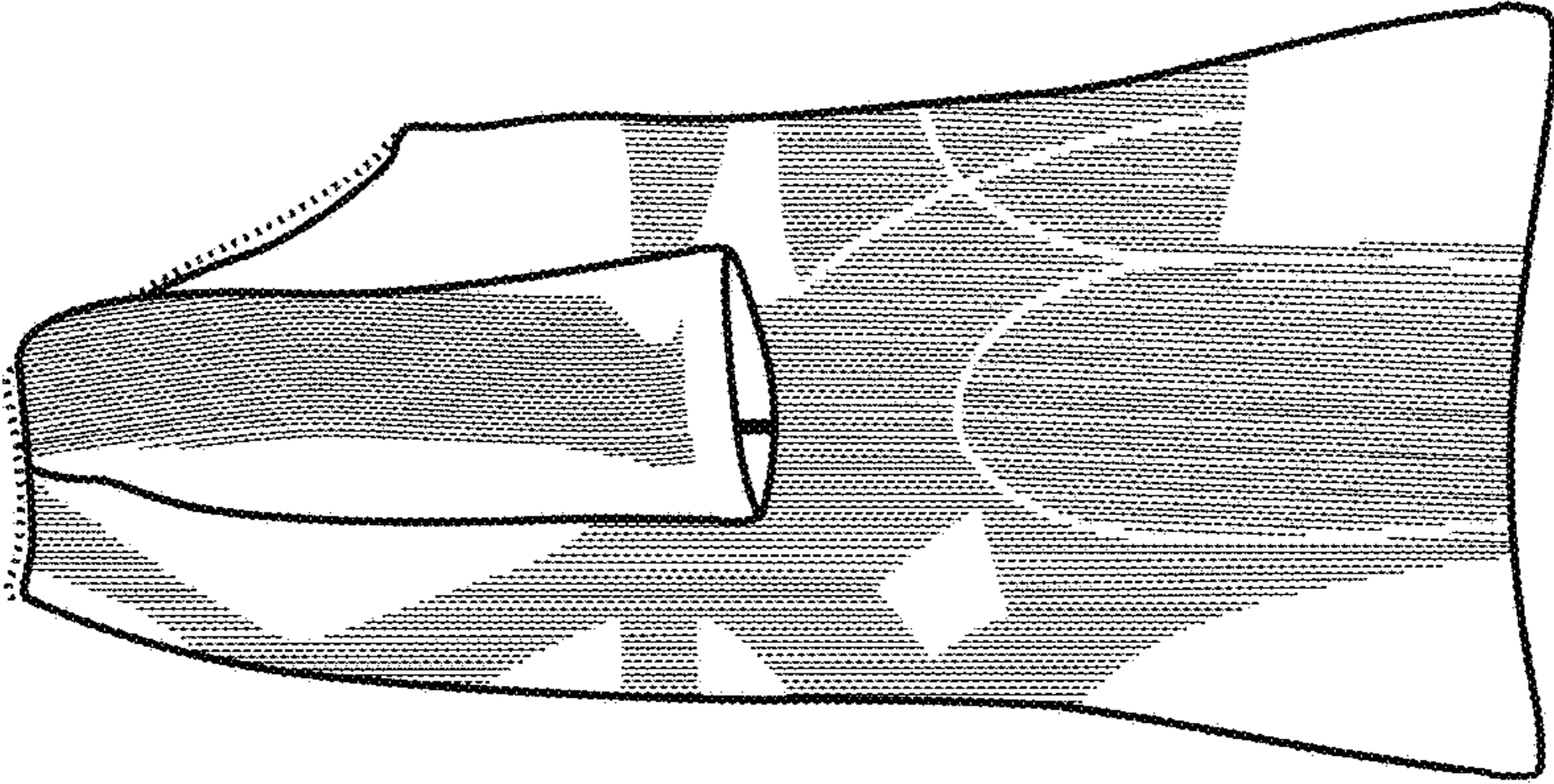

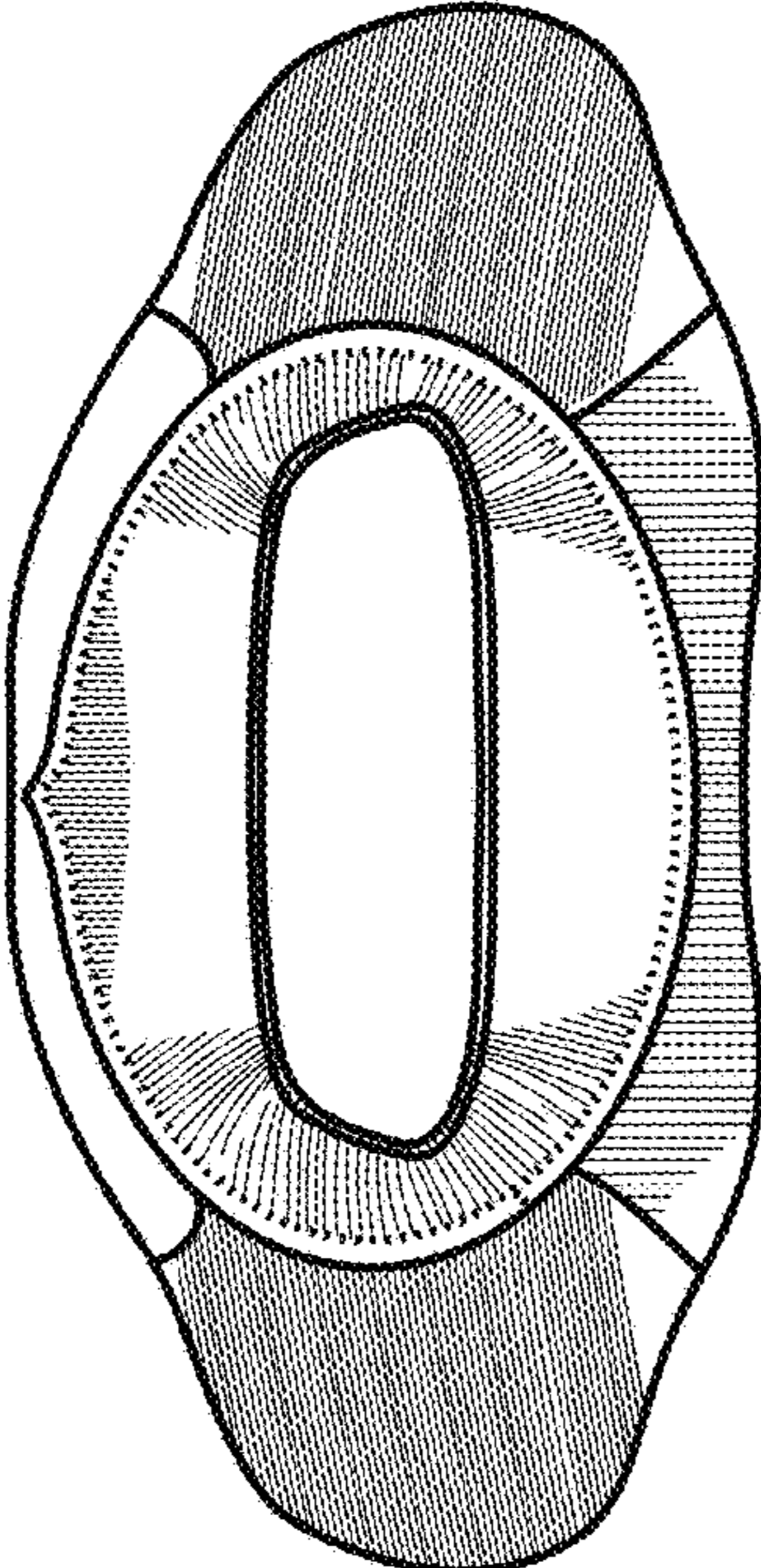

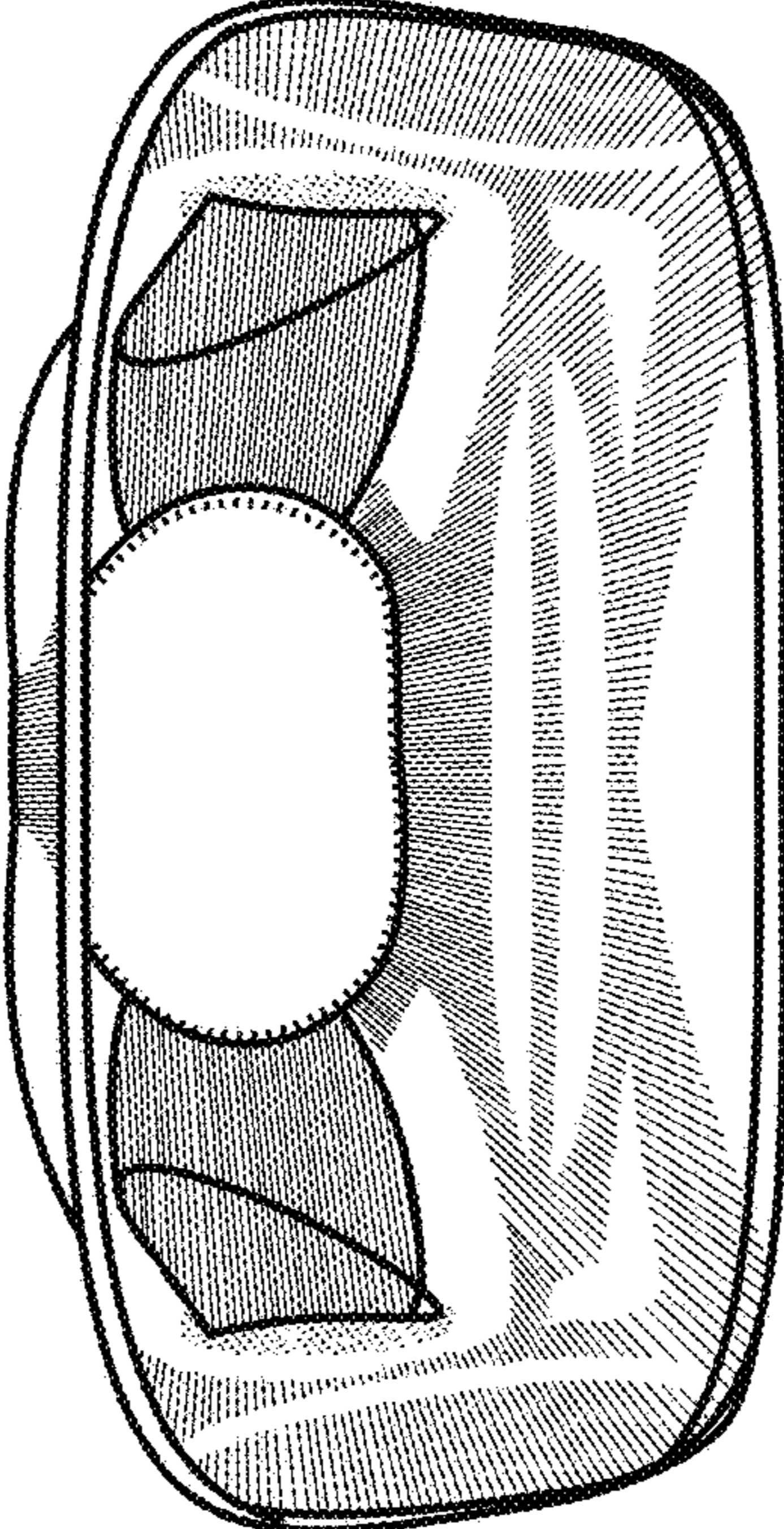

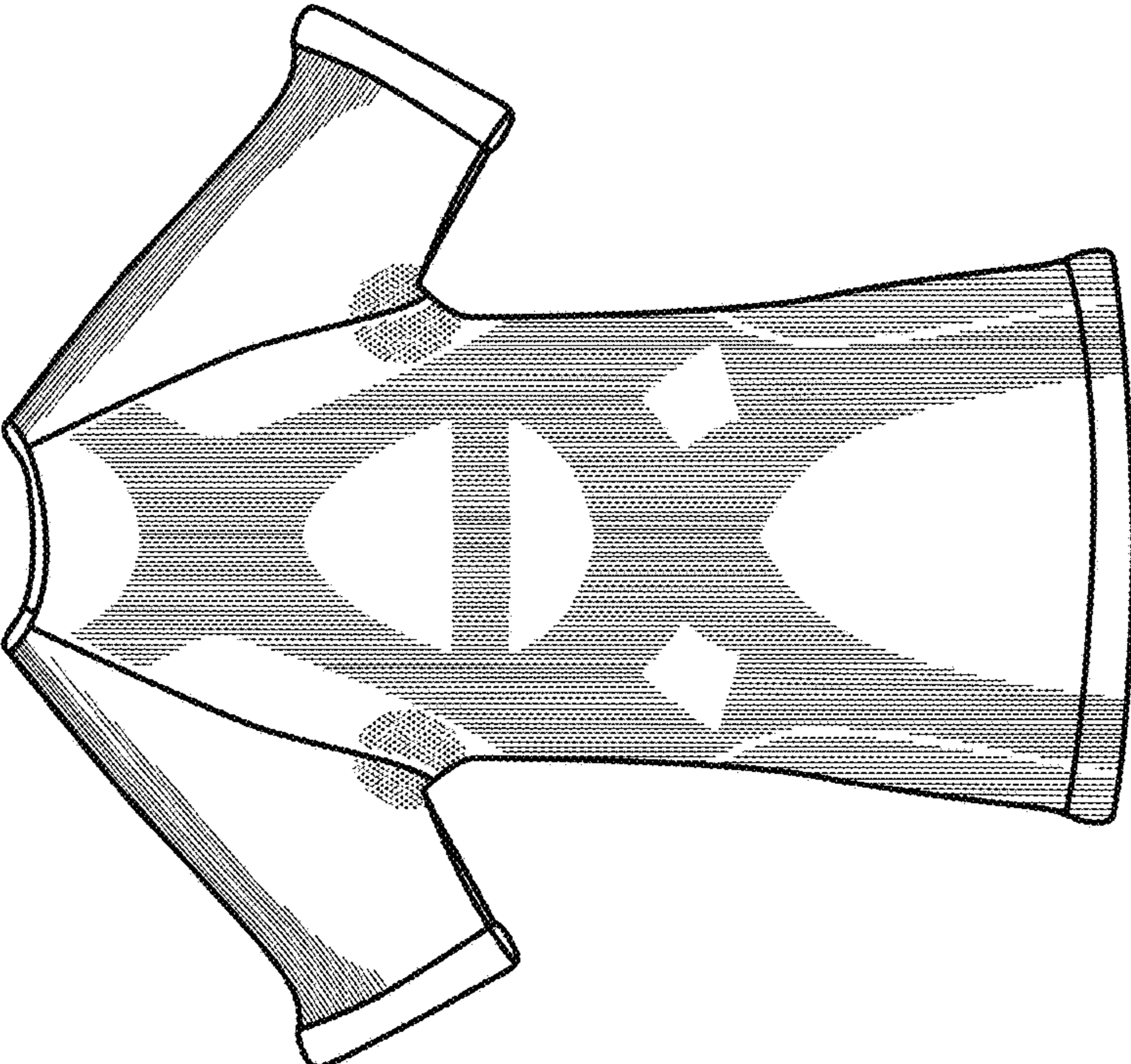

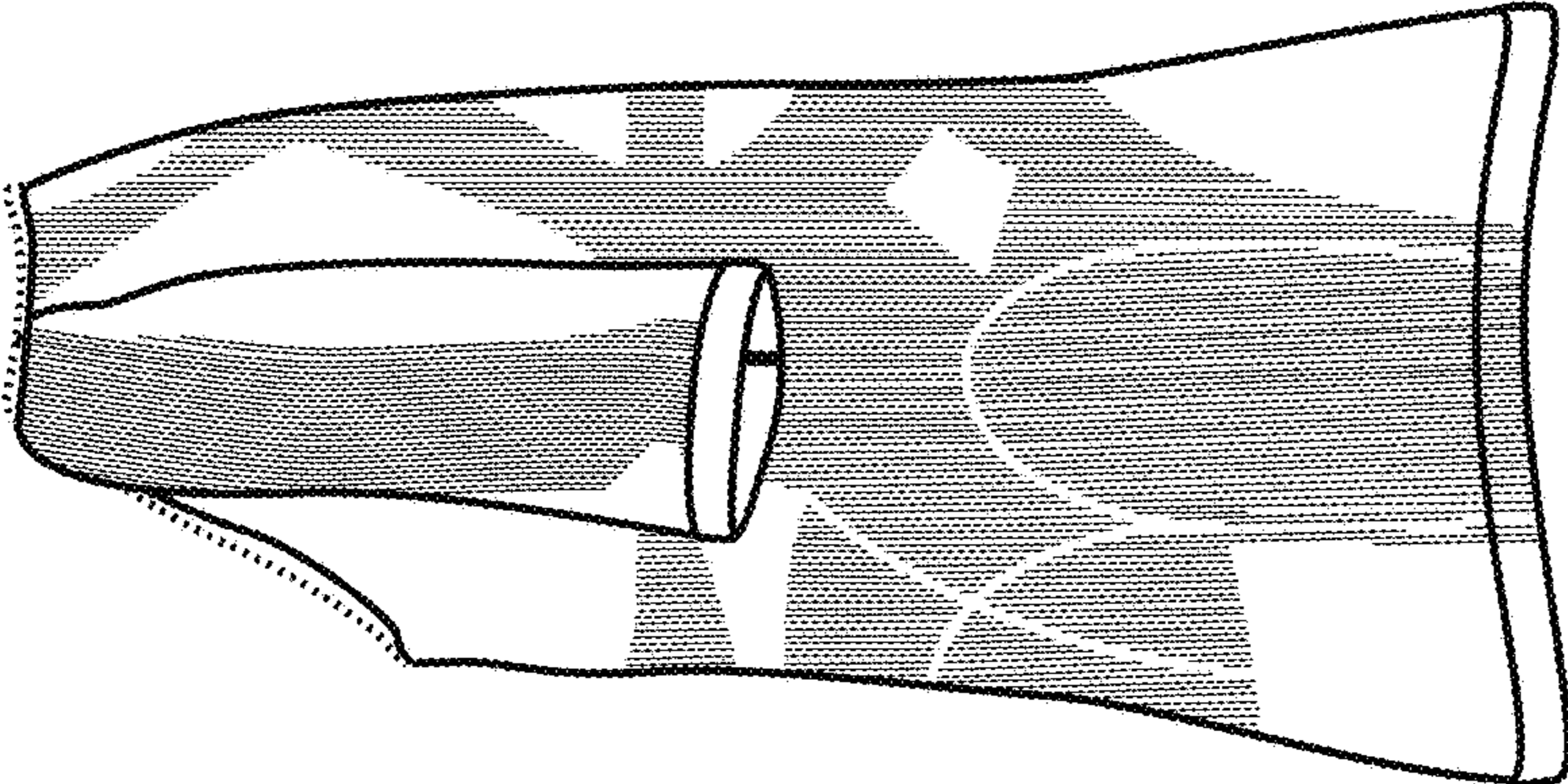
