We claim the ornamental design for a neonate medical wrap, as shown and described.

**DESCRIPTION**

The broken lines depict environment that forms no part of the claimed design.

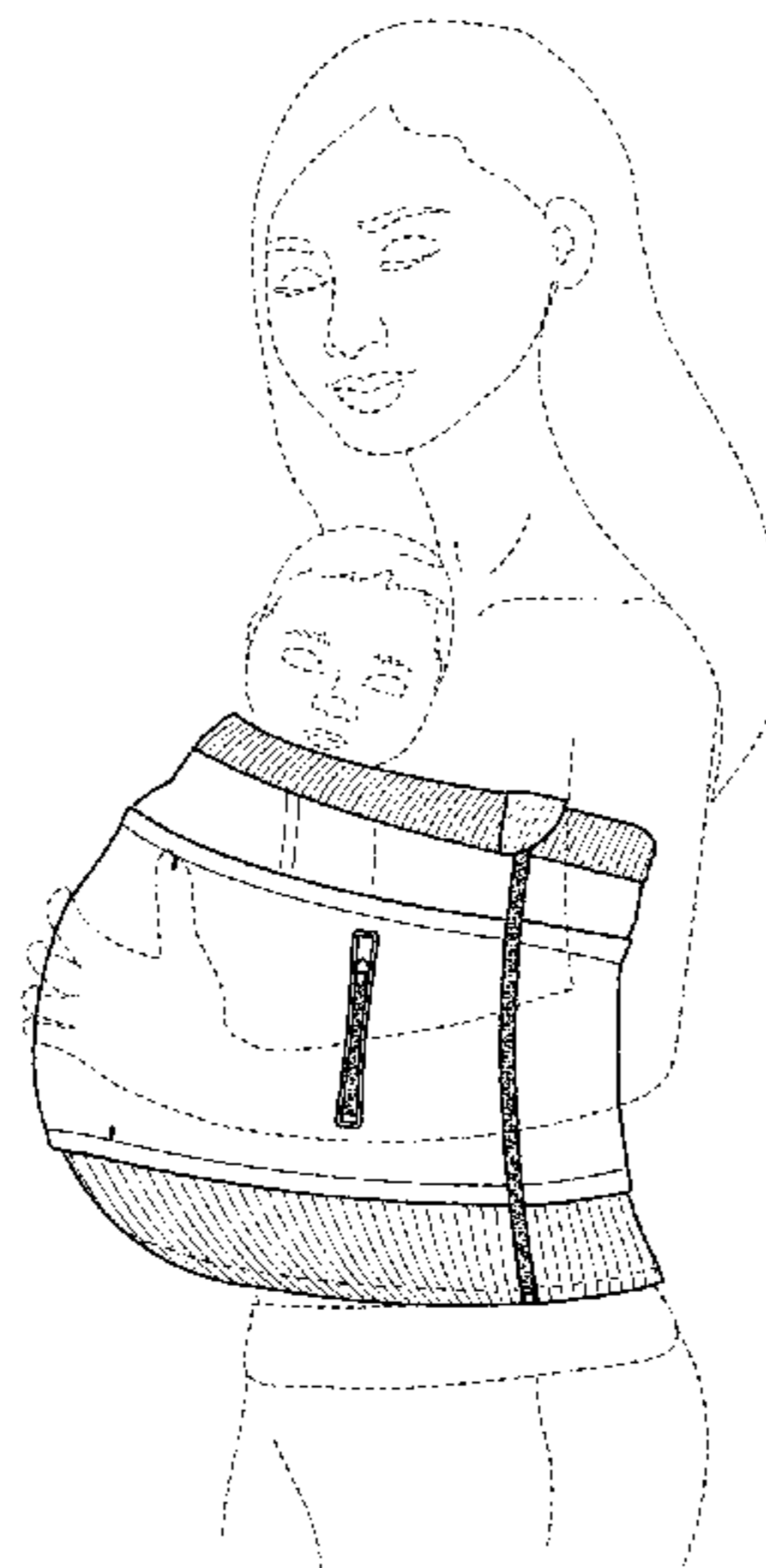
The depicted neonate medical wrap features a novel and unique appearance over the prior art.

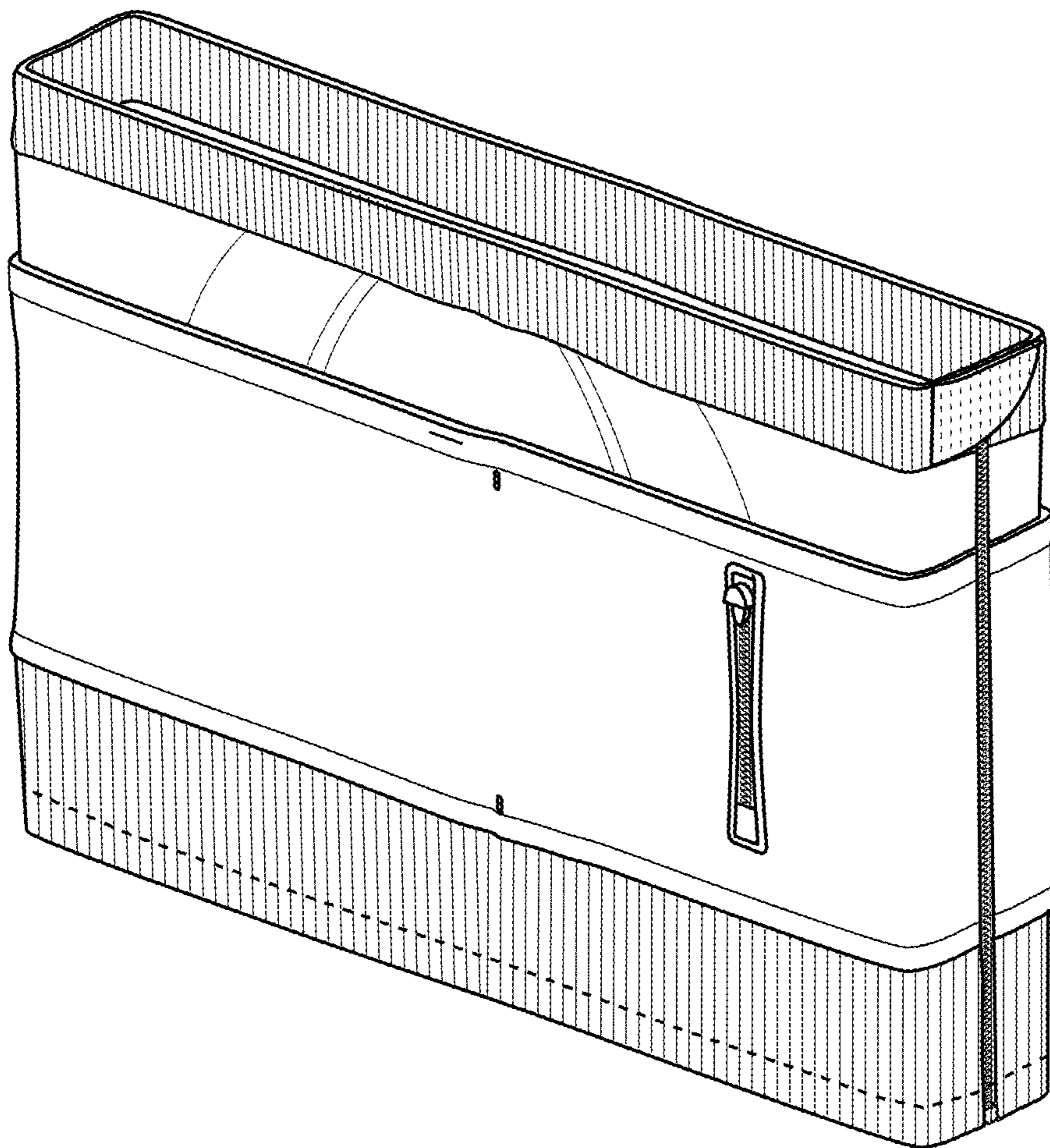

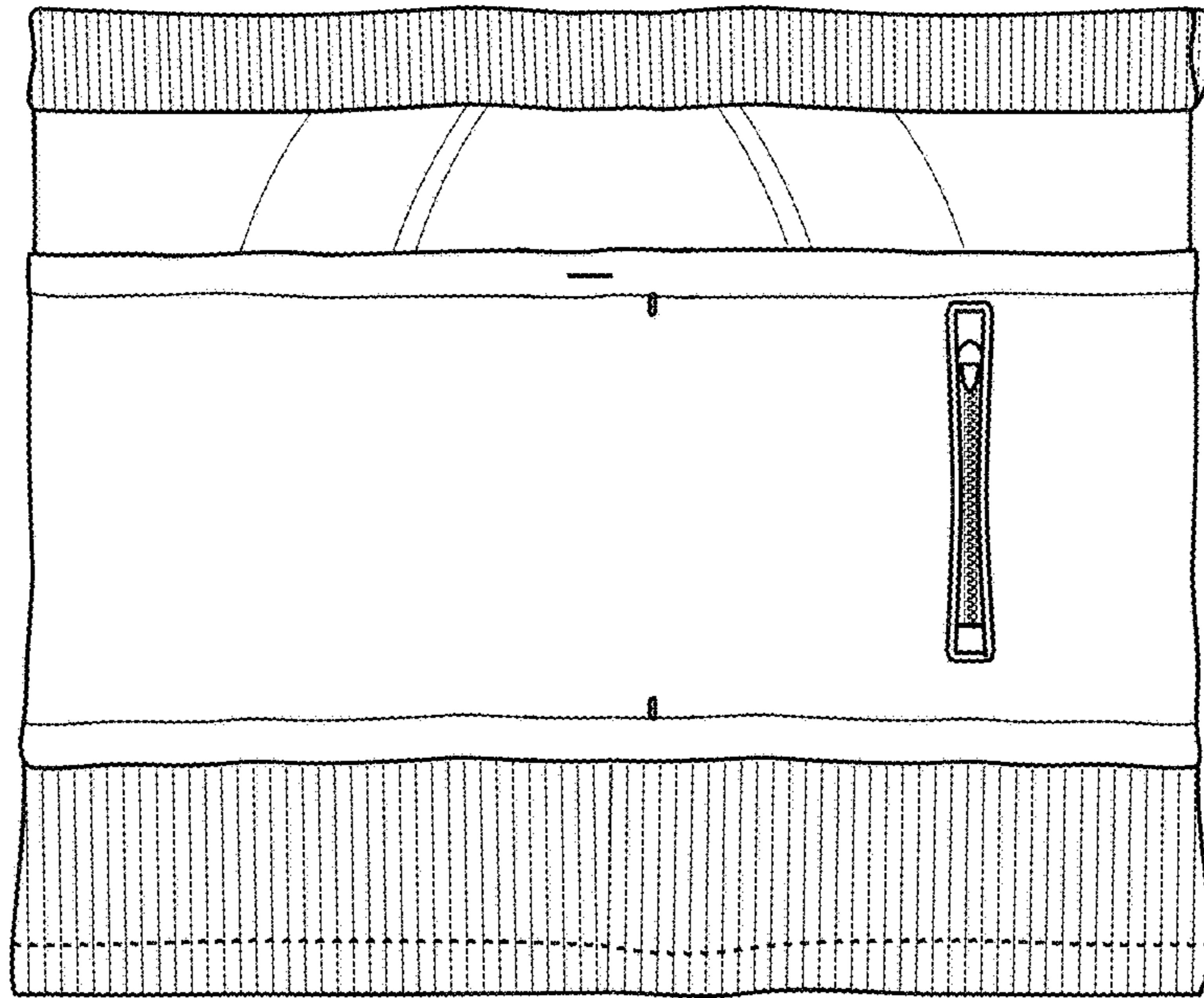

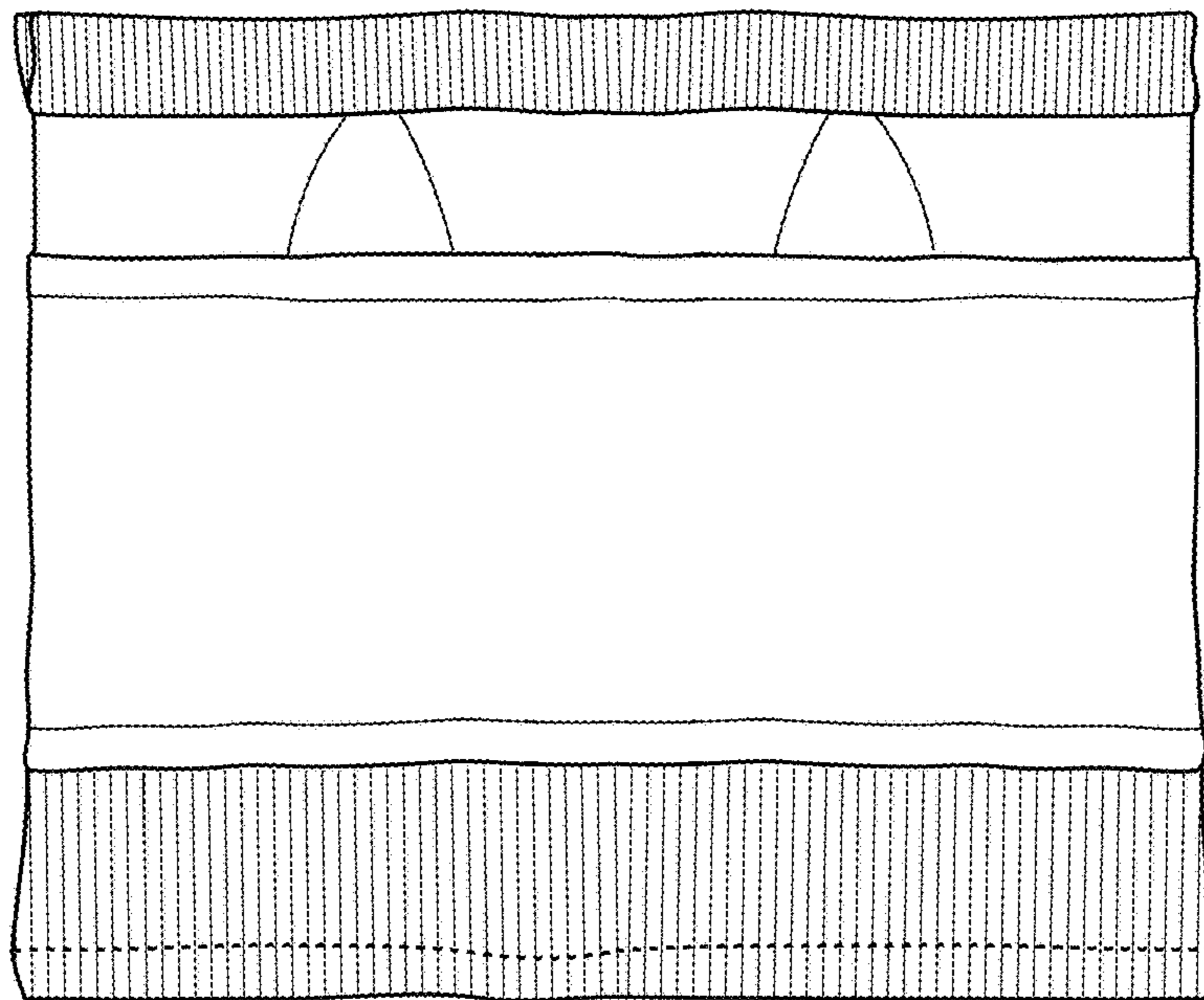

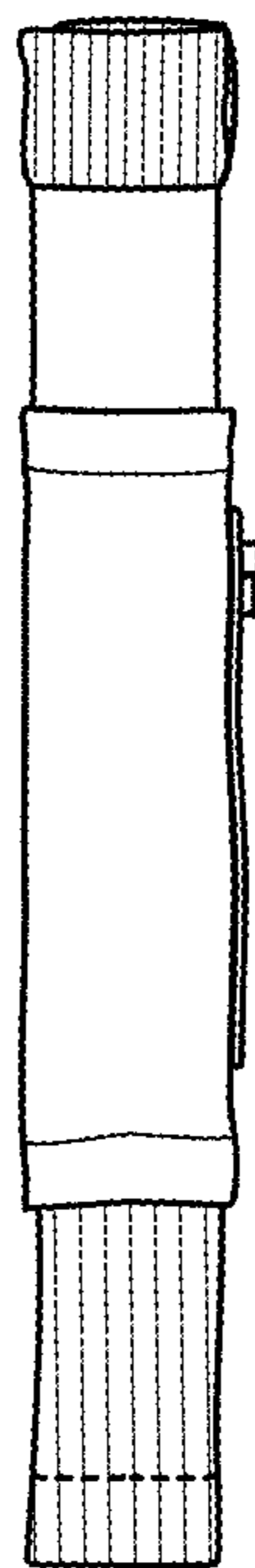

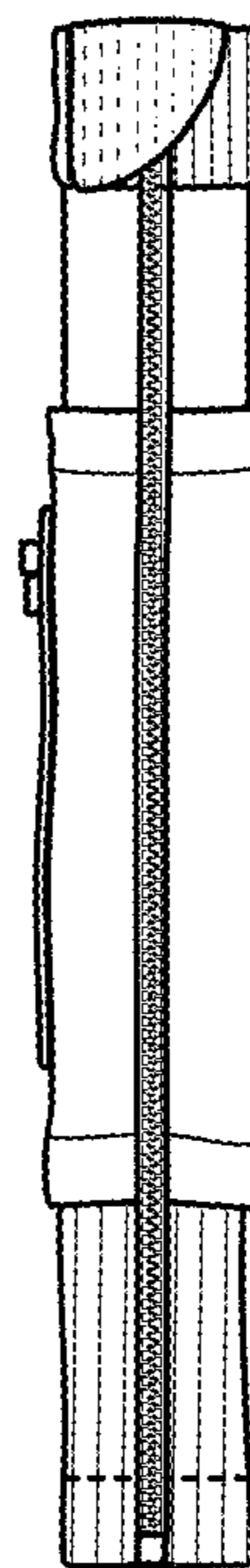

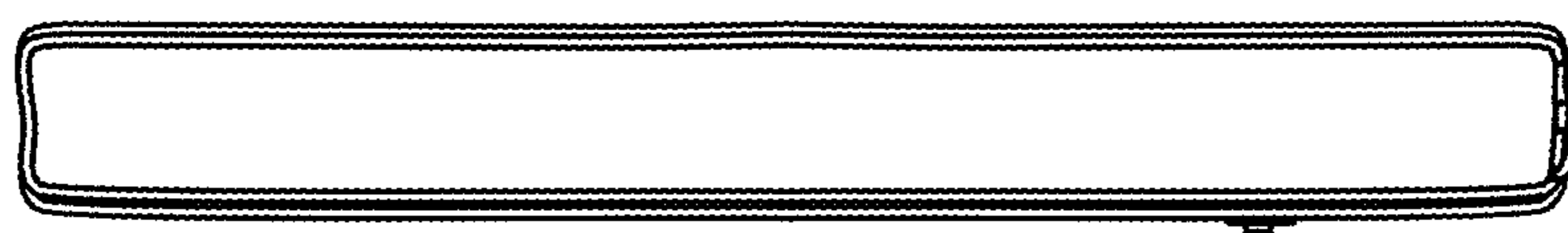

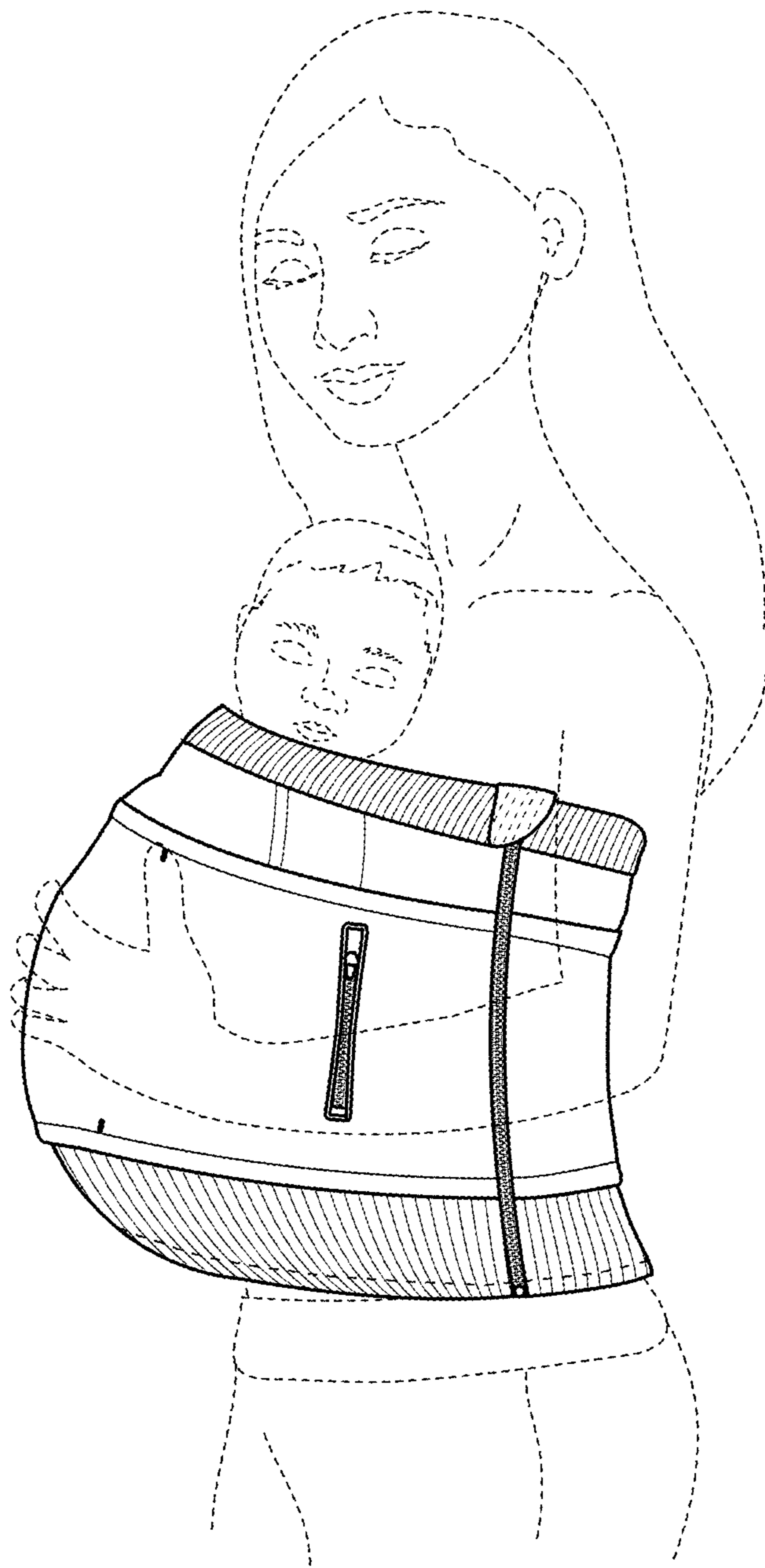
