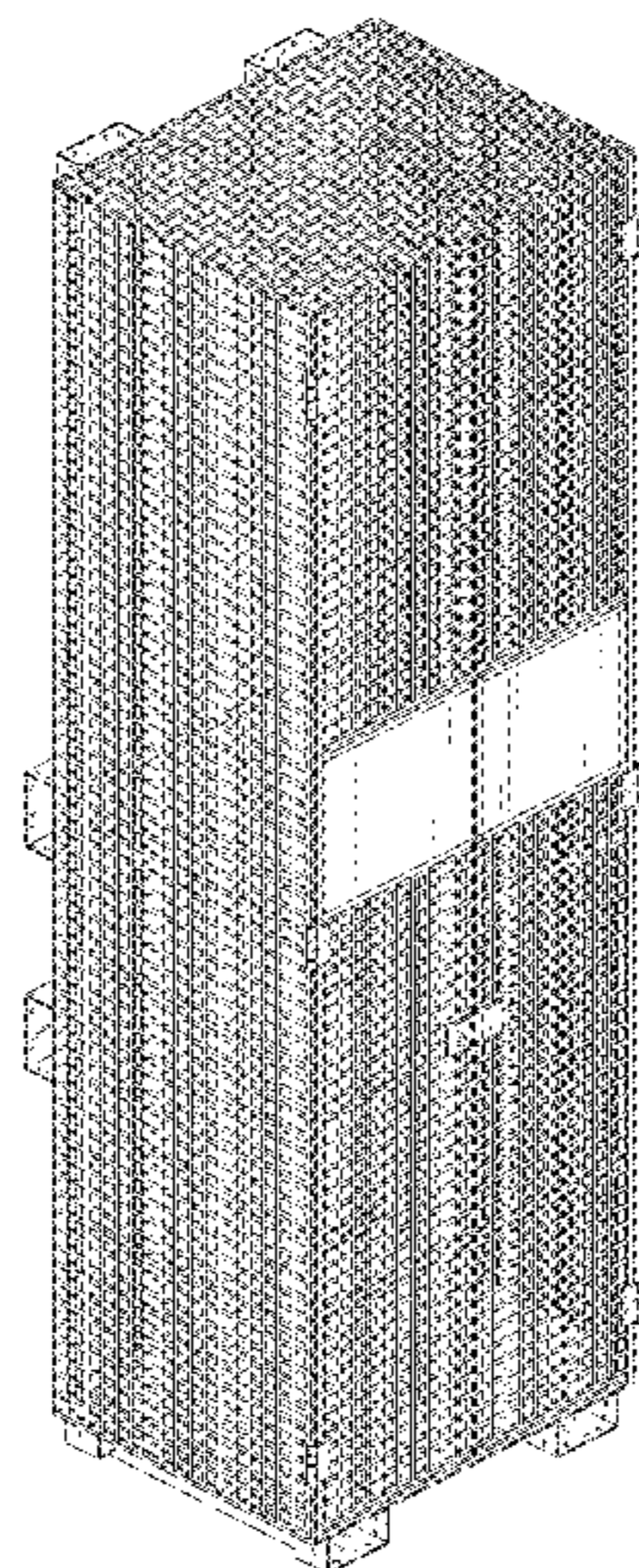

**DESCRIPTION**

FIG. 1 is a perspective view of the storage container showing a variant of the design;

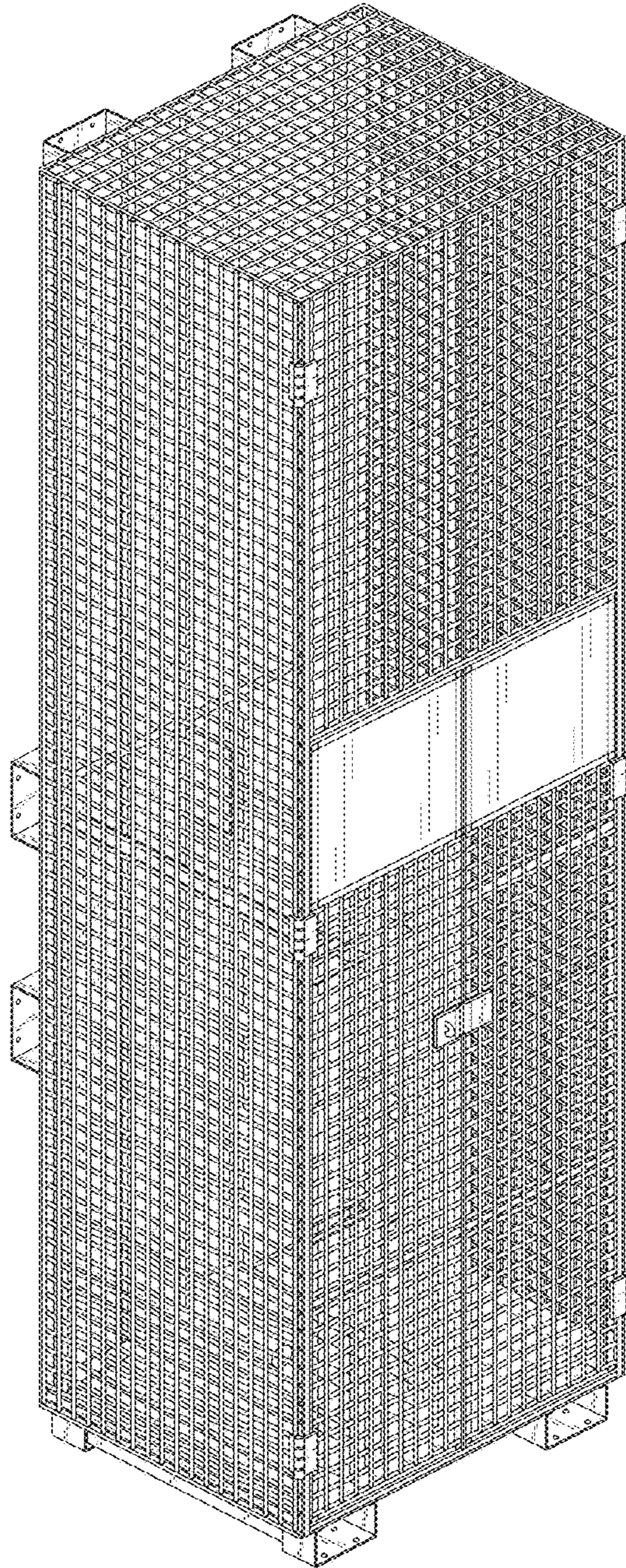

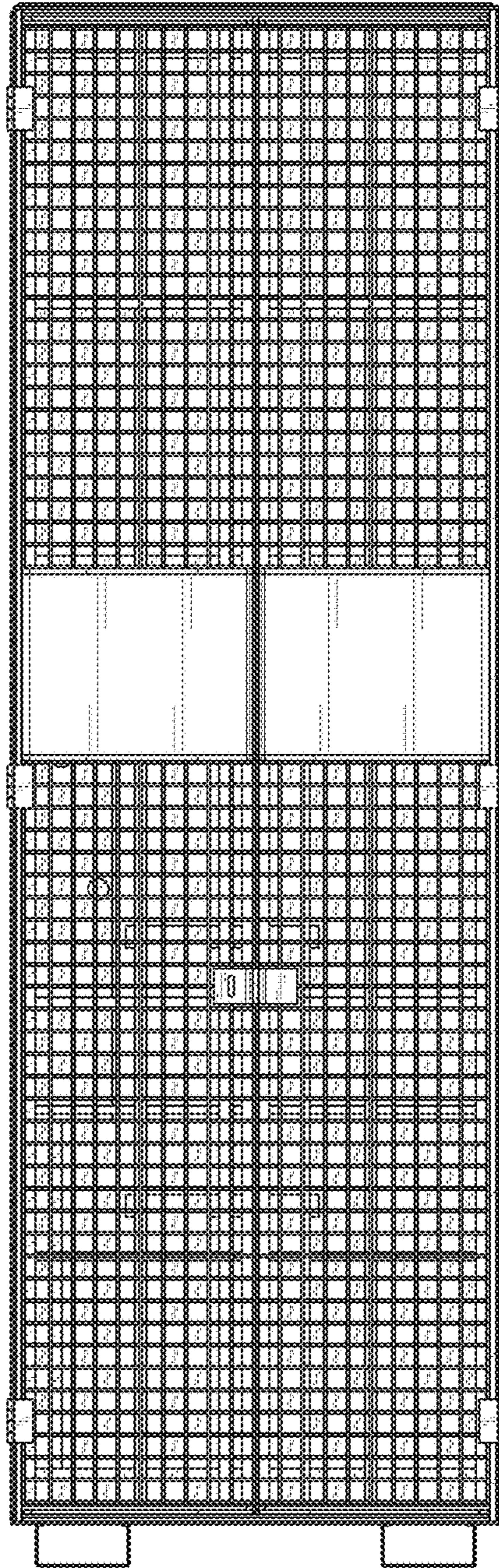

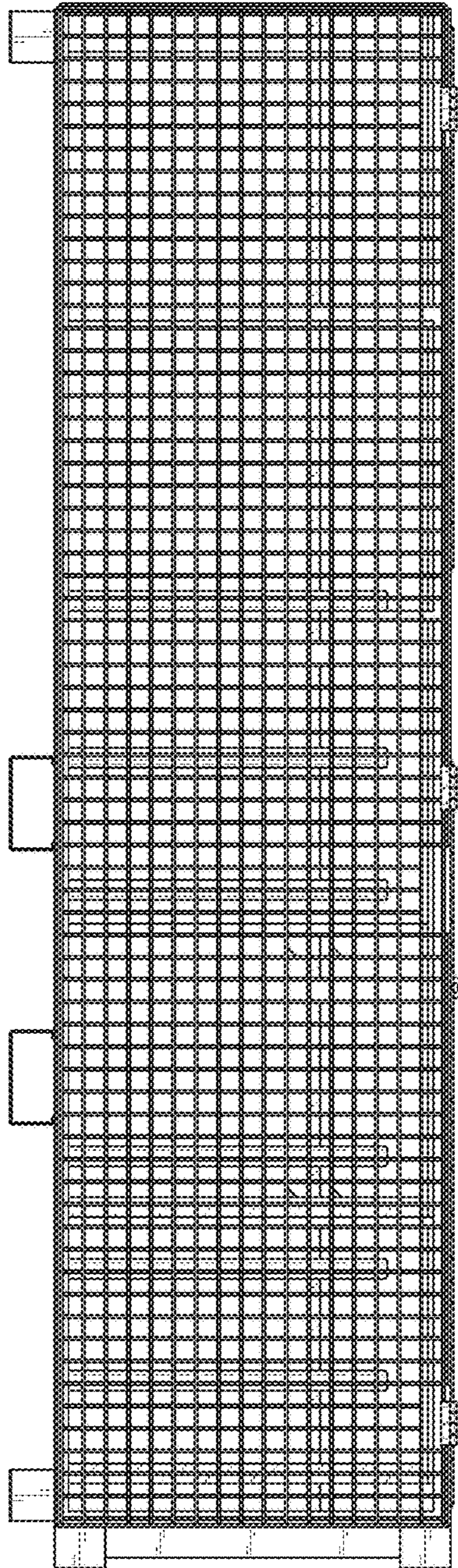

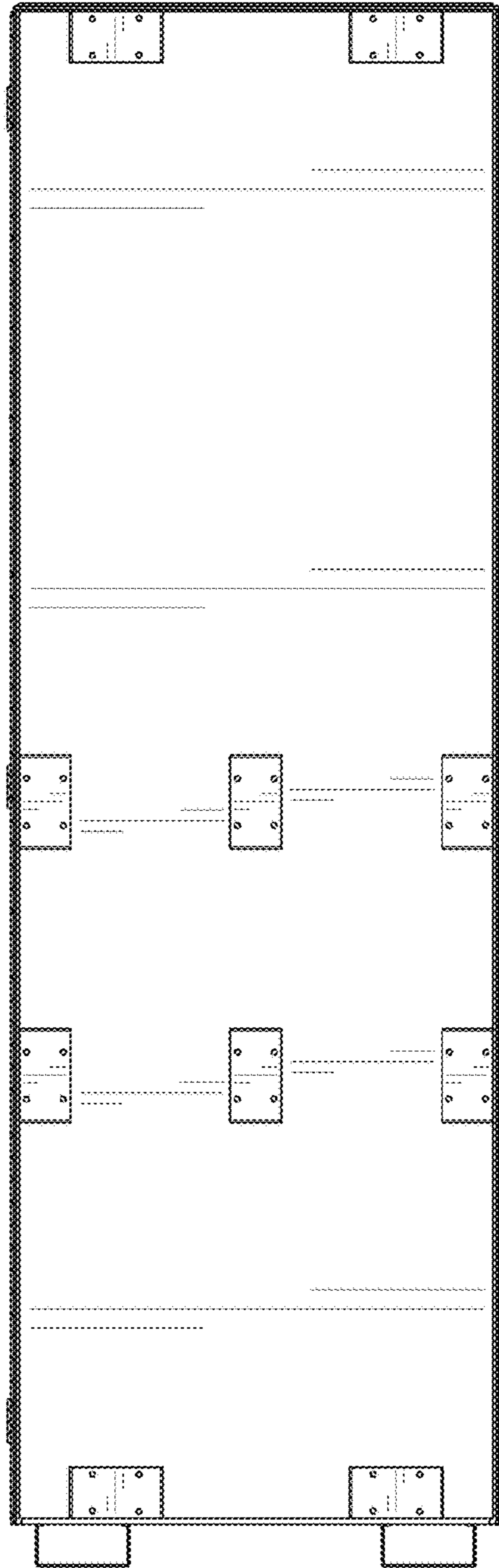

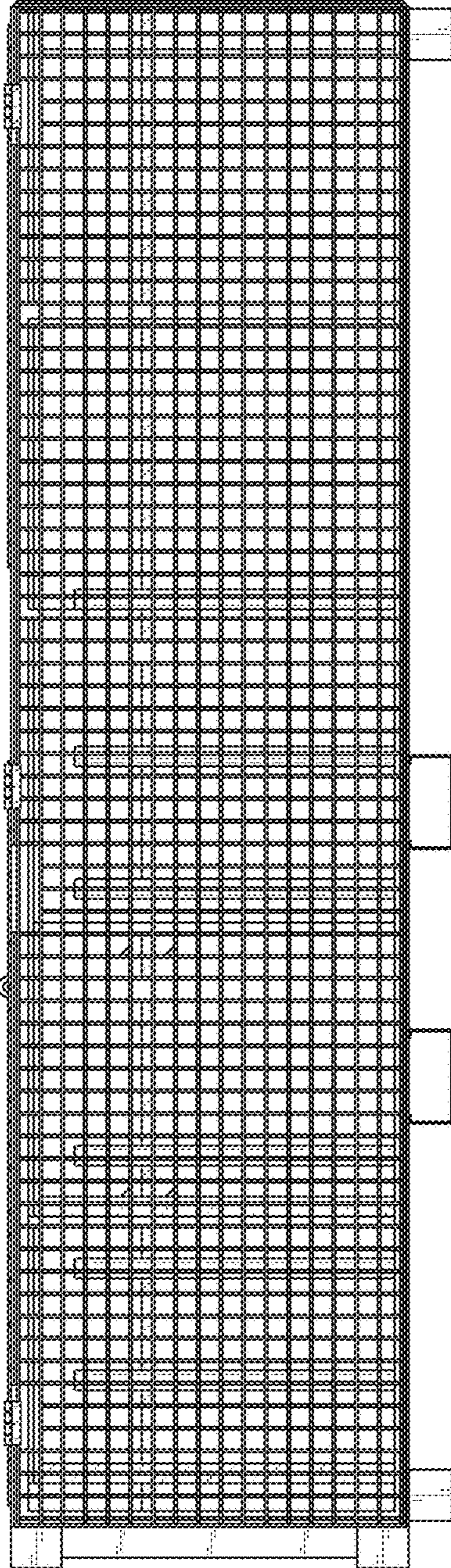

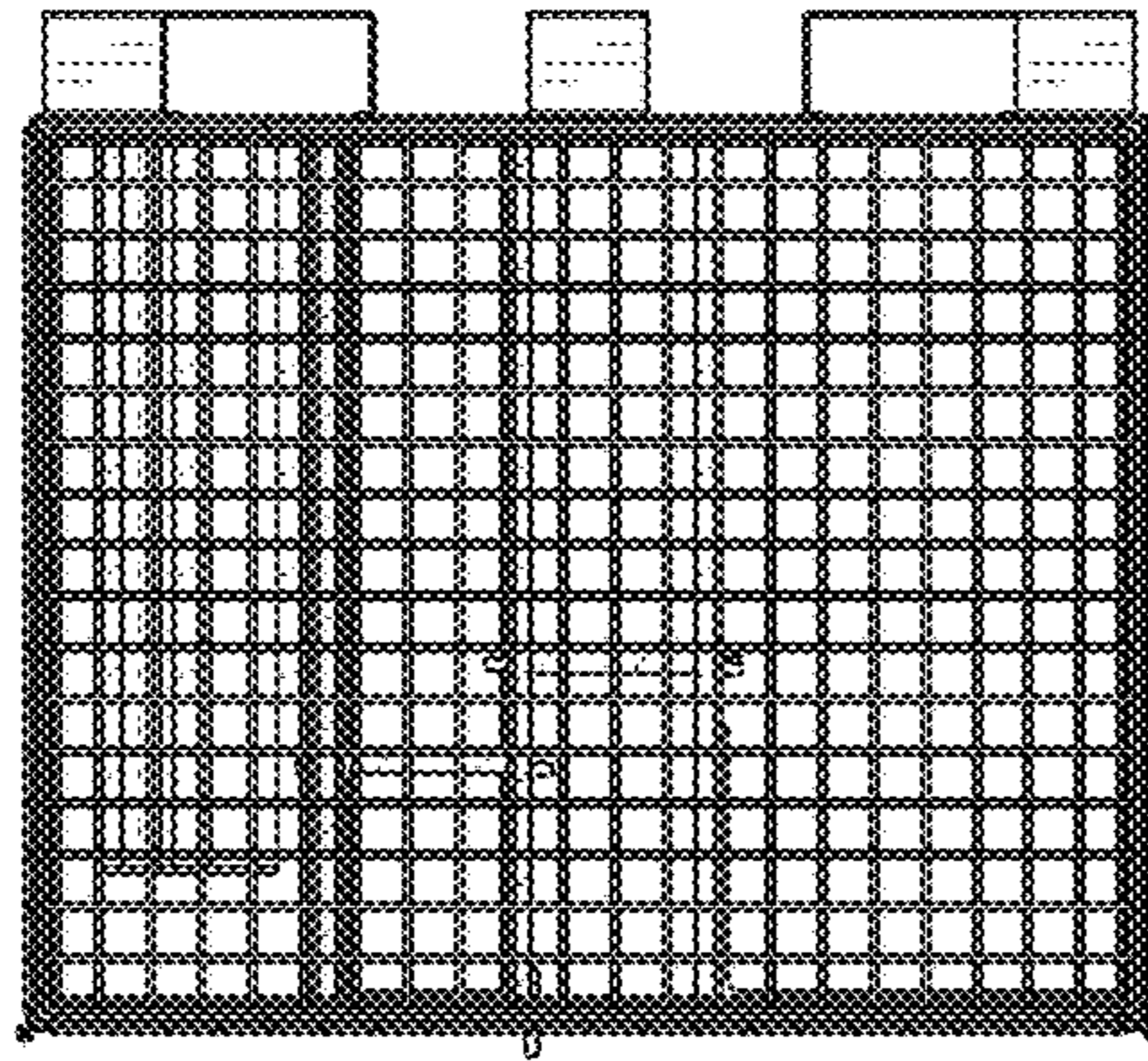

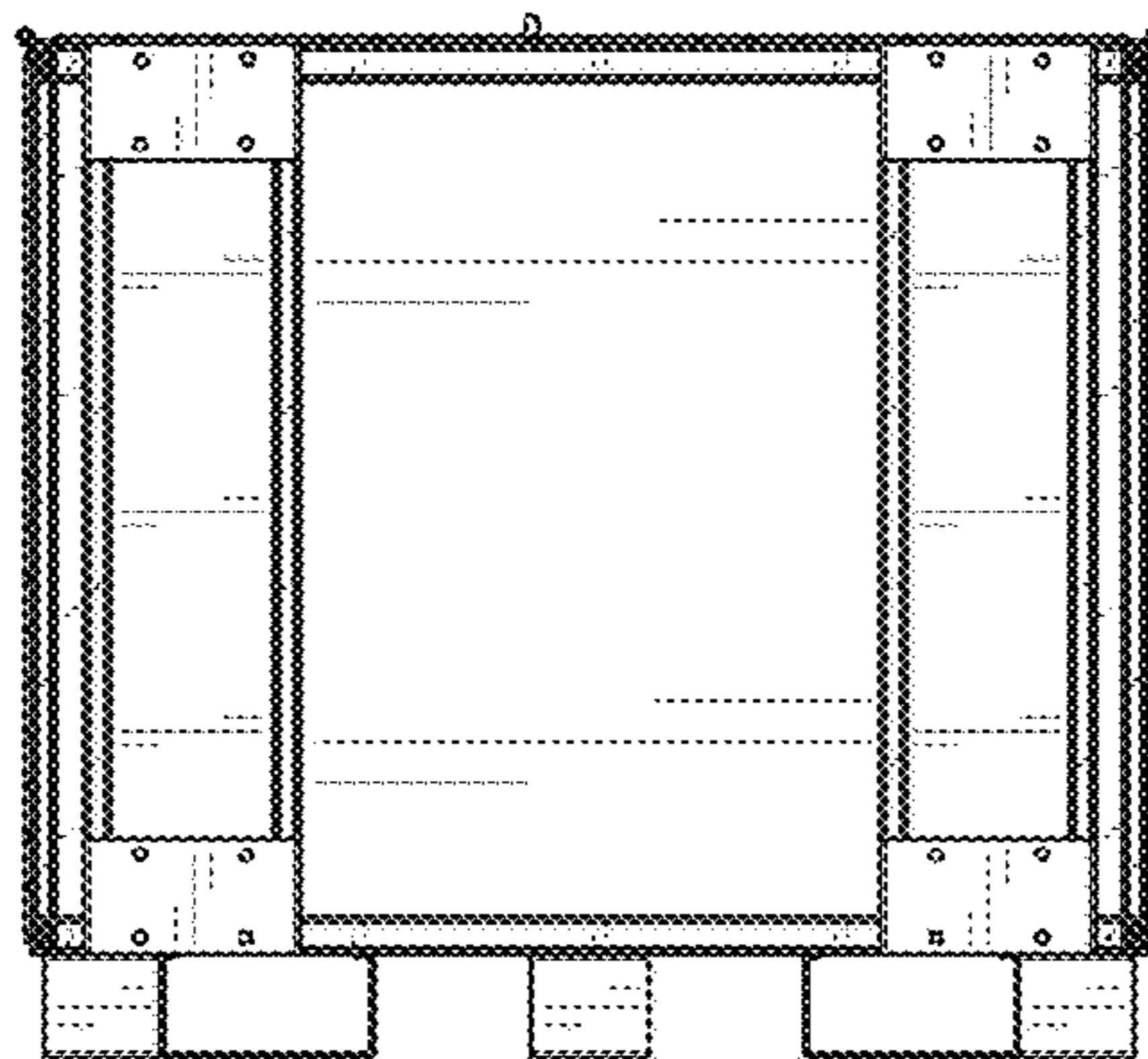
