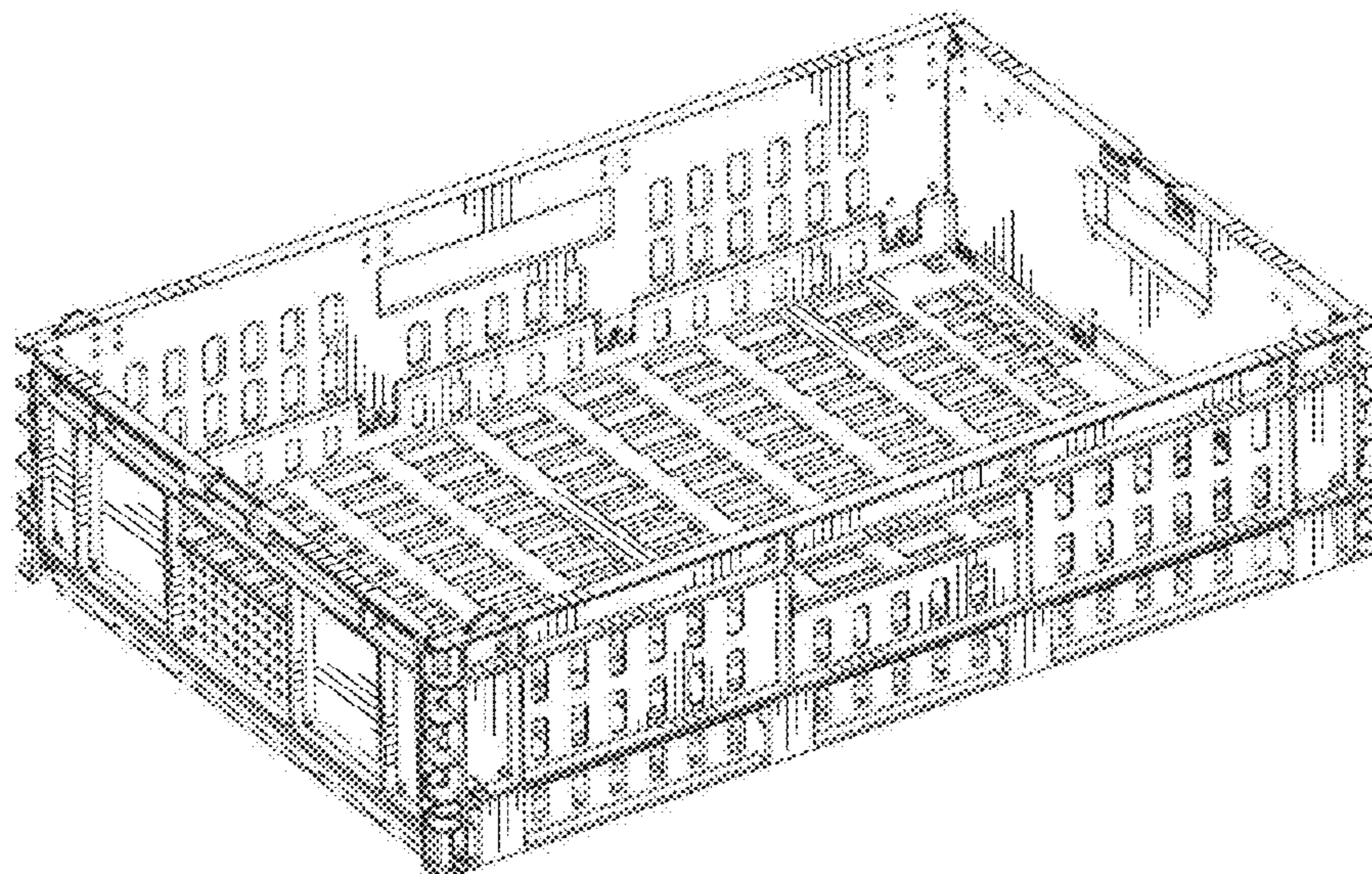

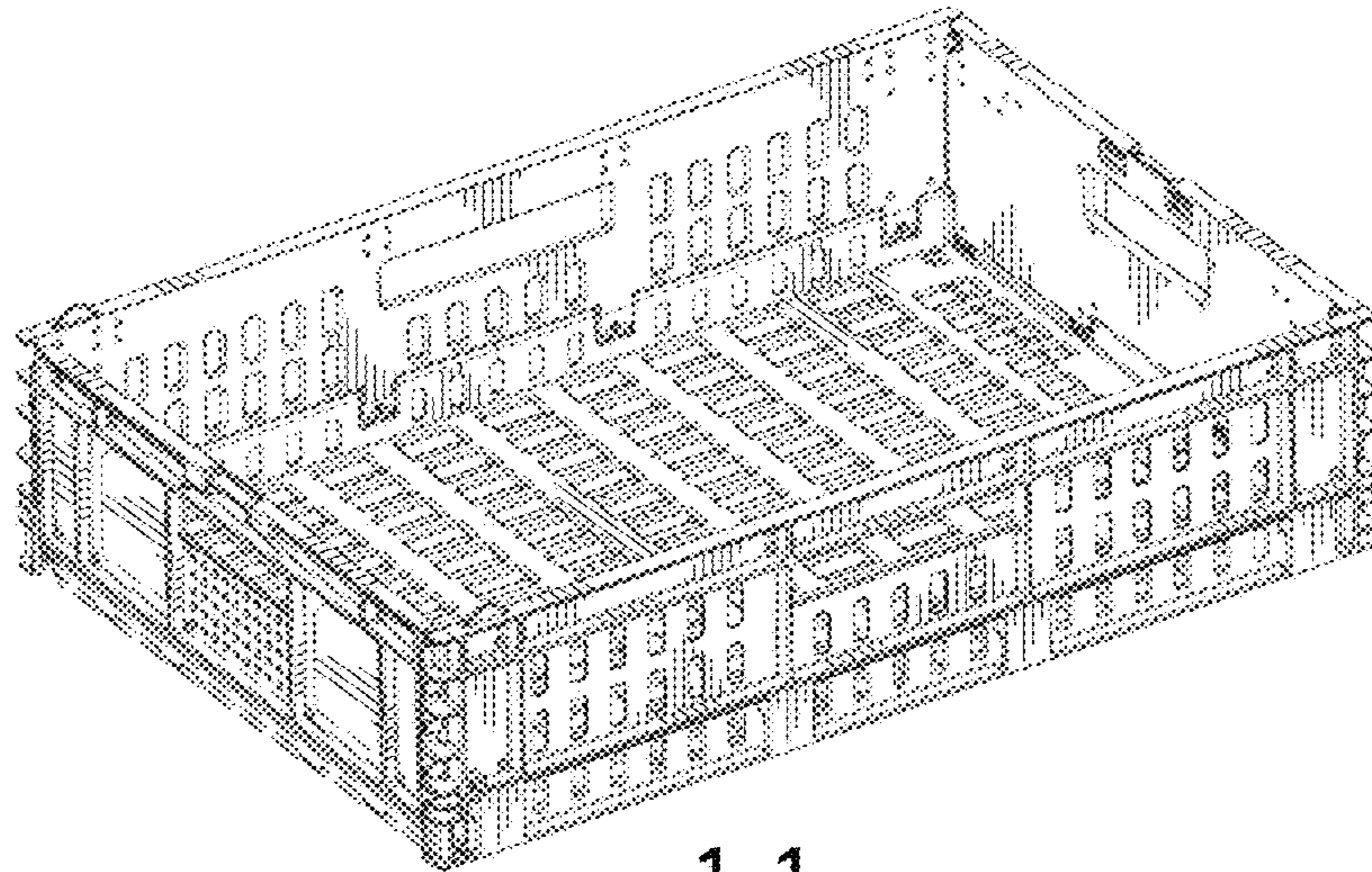
The ornamental design for a stacking crate, as shown and described.

DESCRIPTION

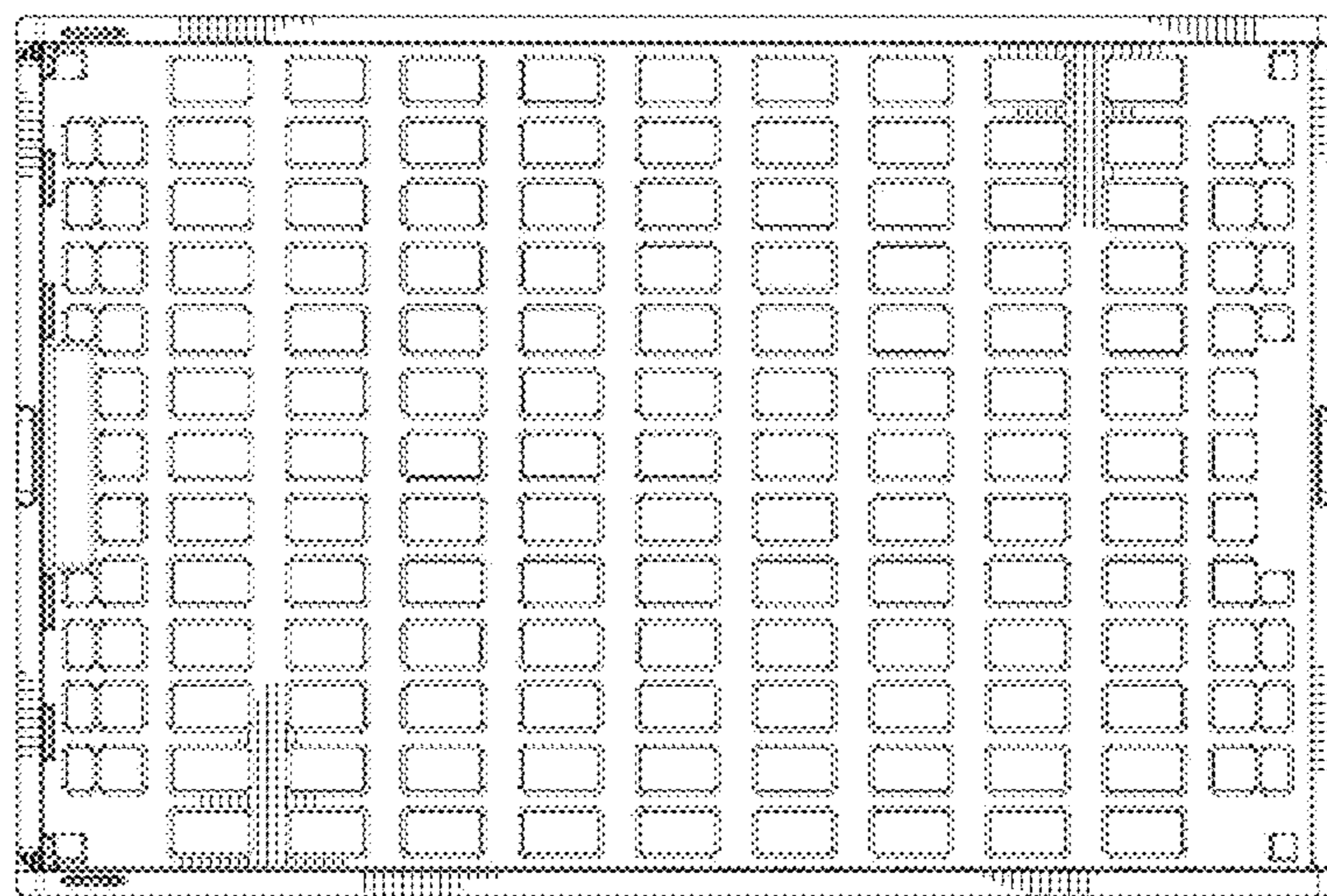
1.1 is a perspective view of a stacking crate showing my new design;

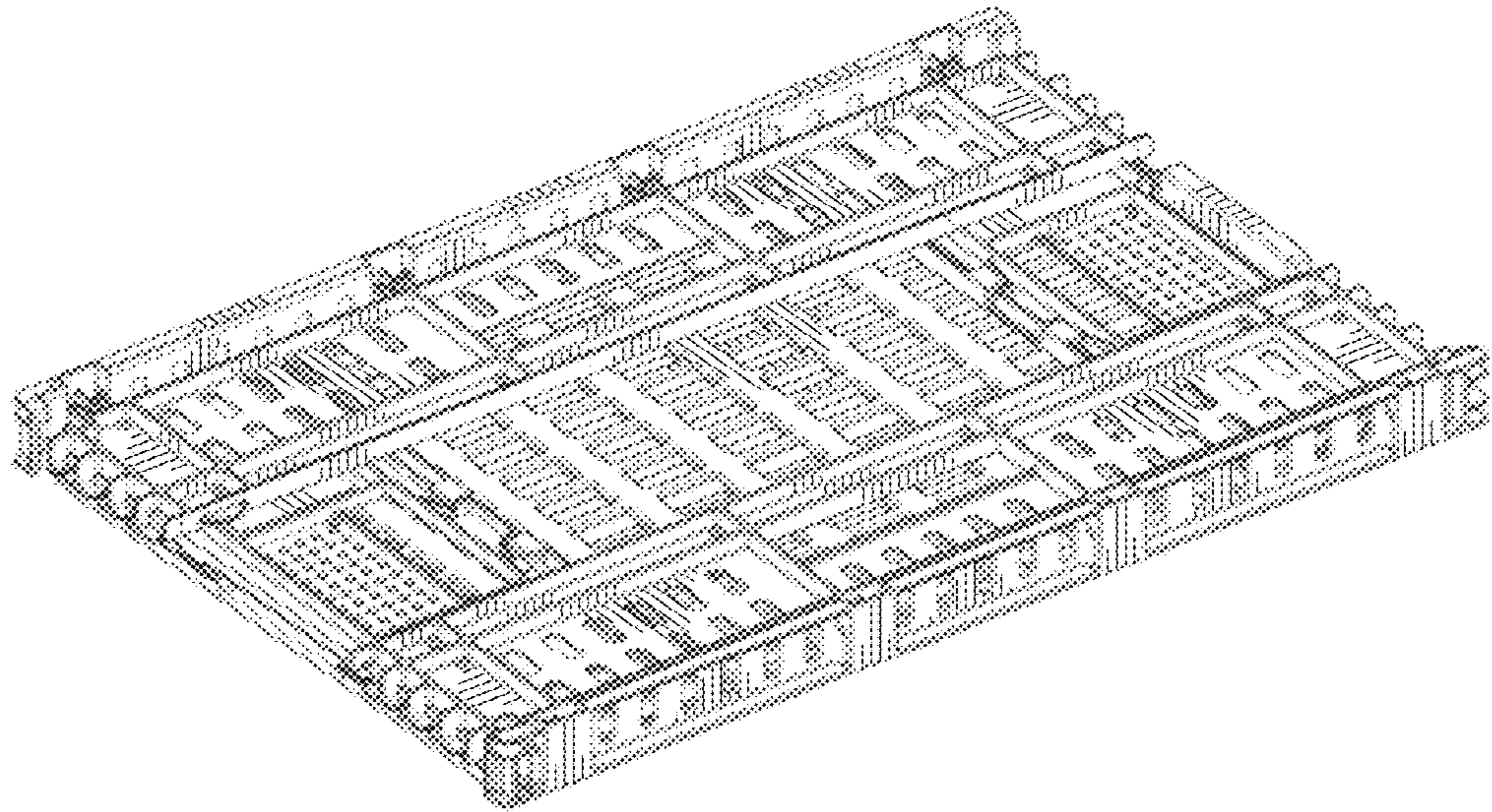




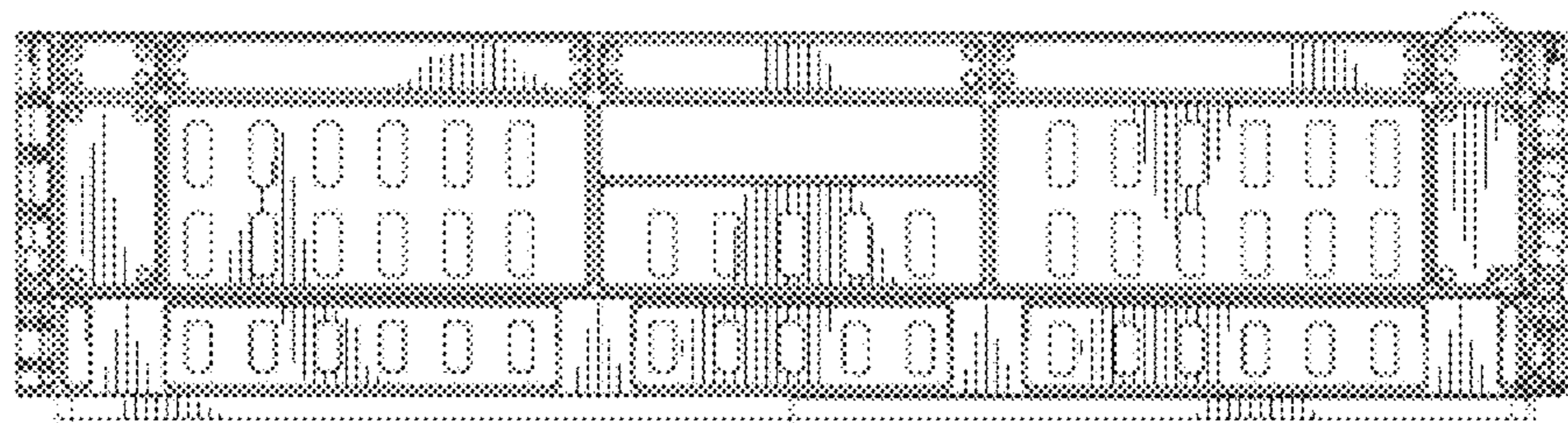

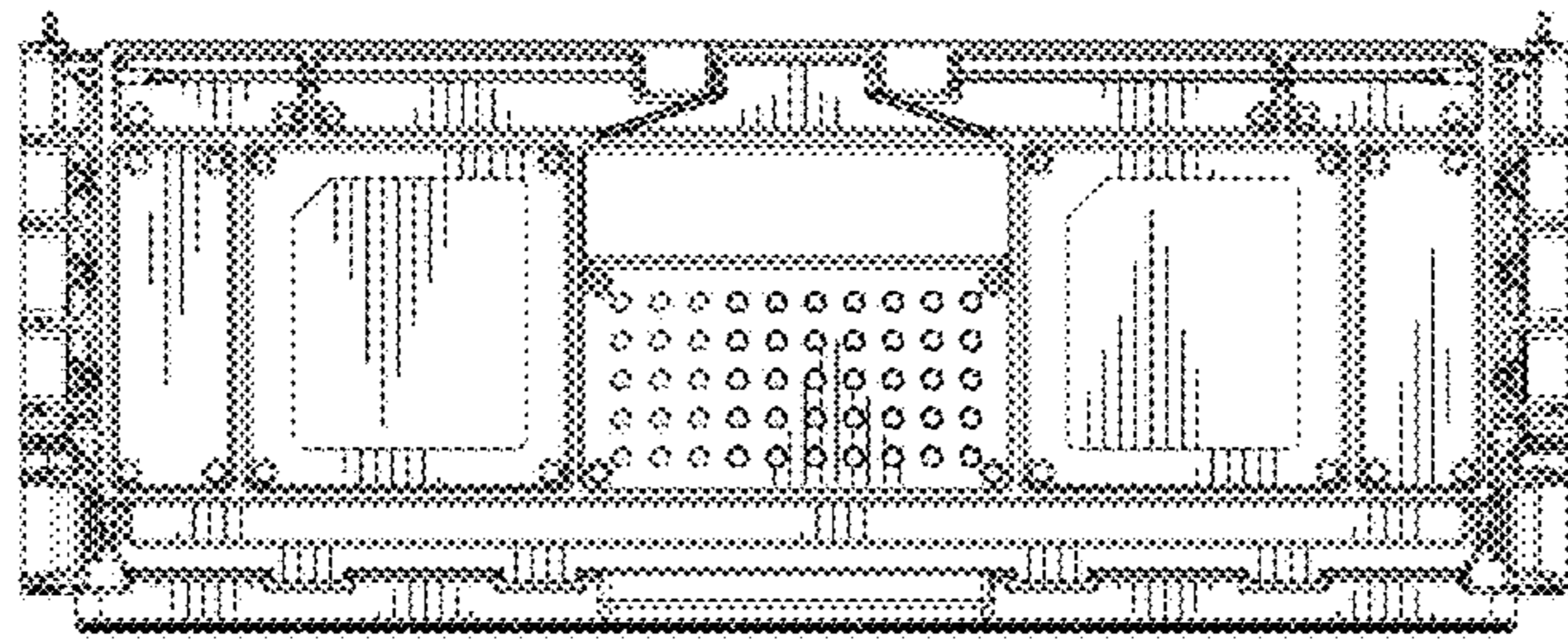

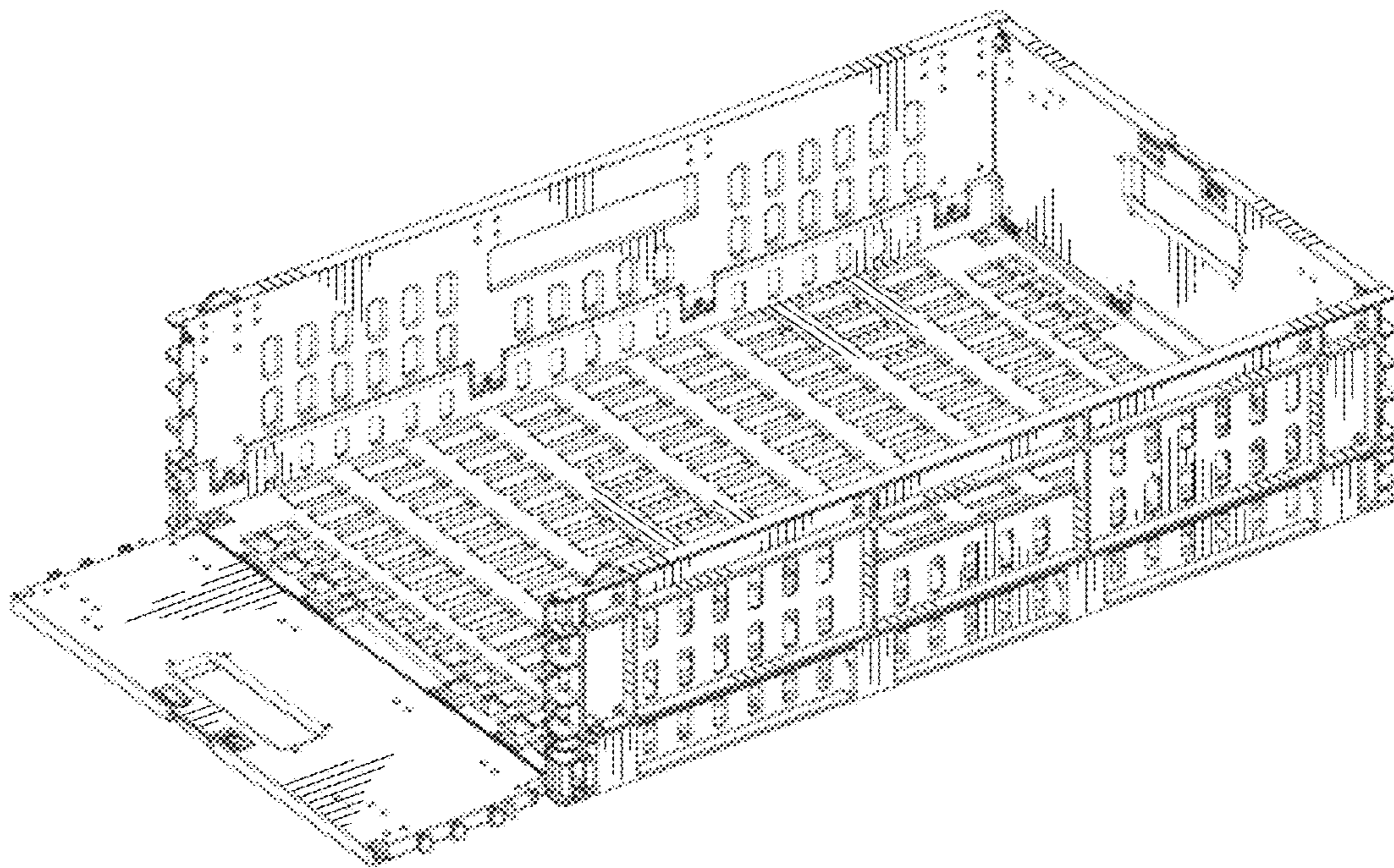
