DESCRIPTION

FIG. 8 is a bottom plan view thereof;

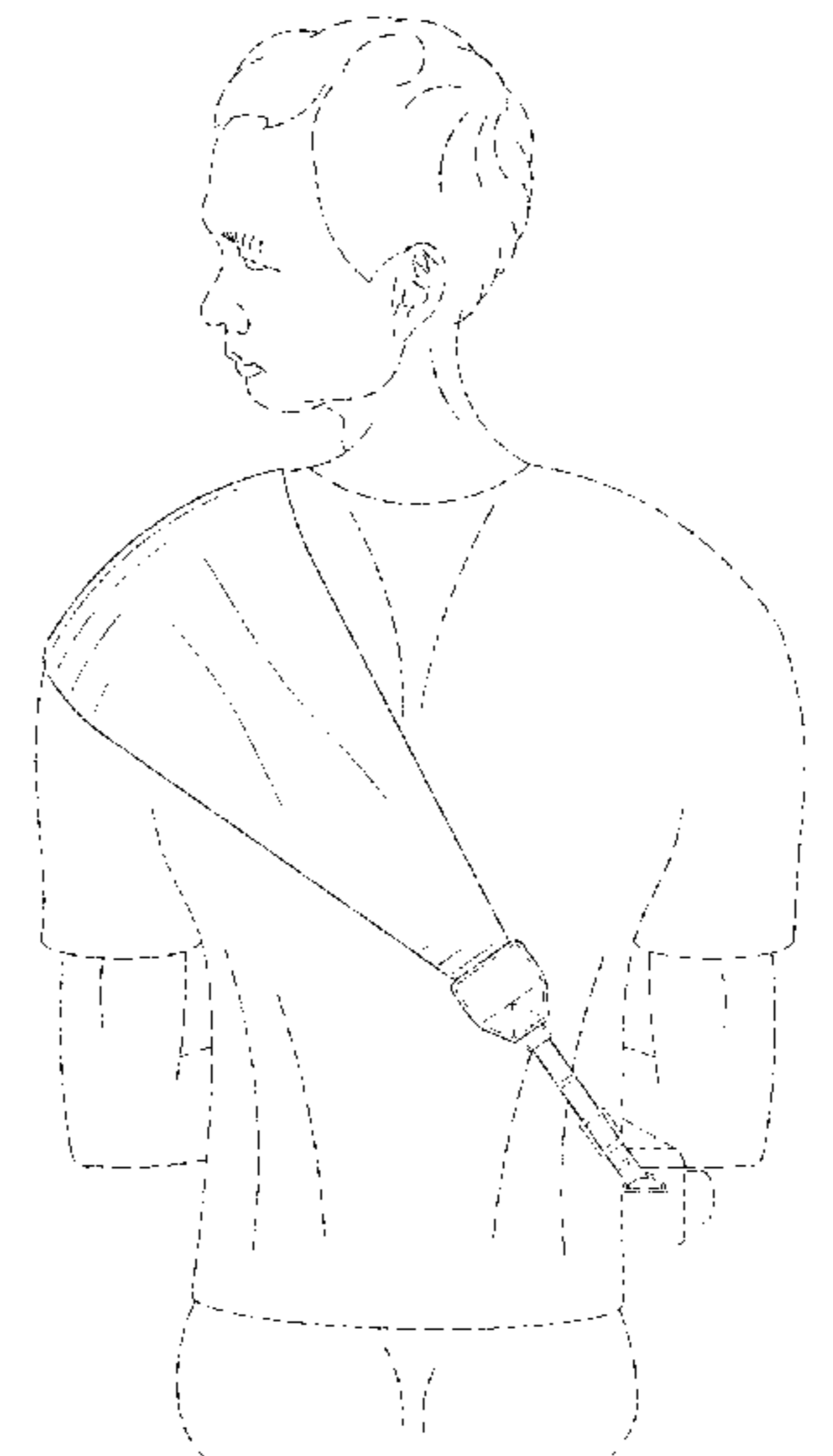
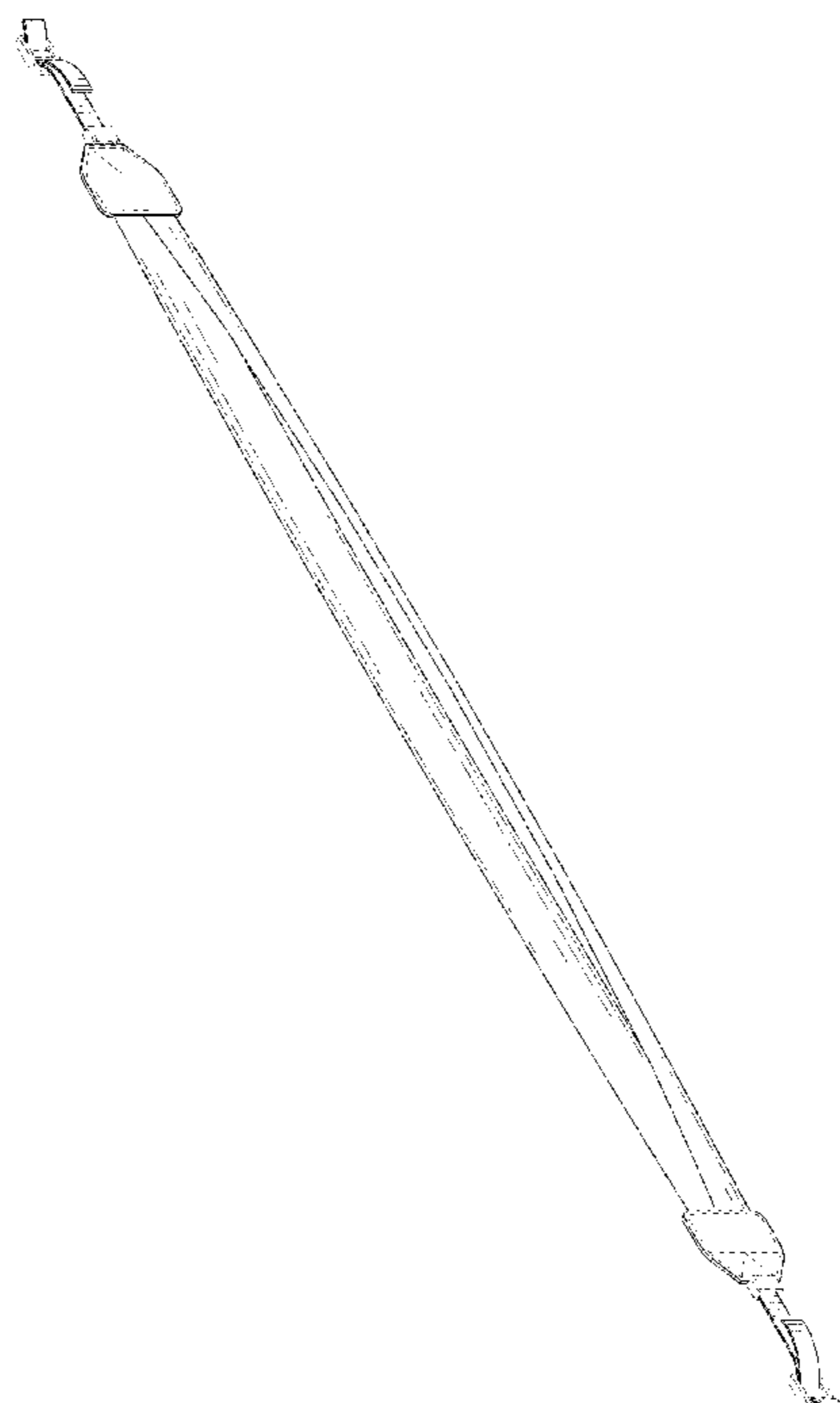
FIG. 9 is an enlarged view of portion 9 of FIG. 7; and,

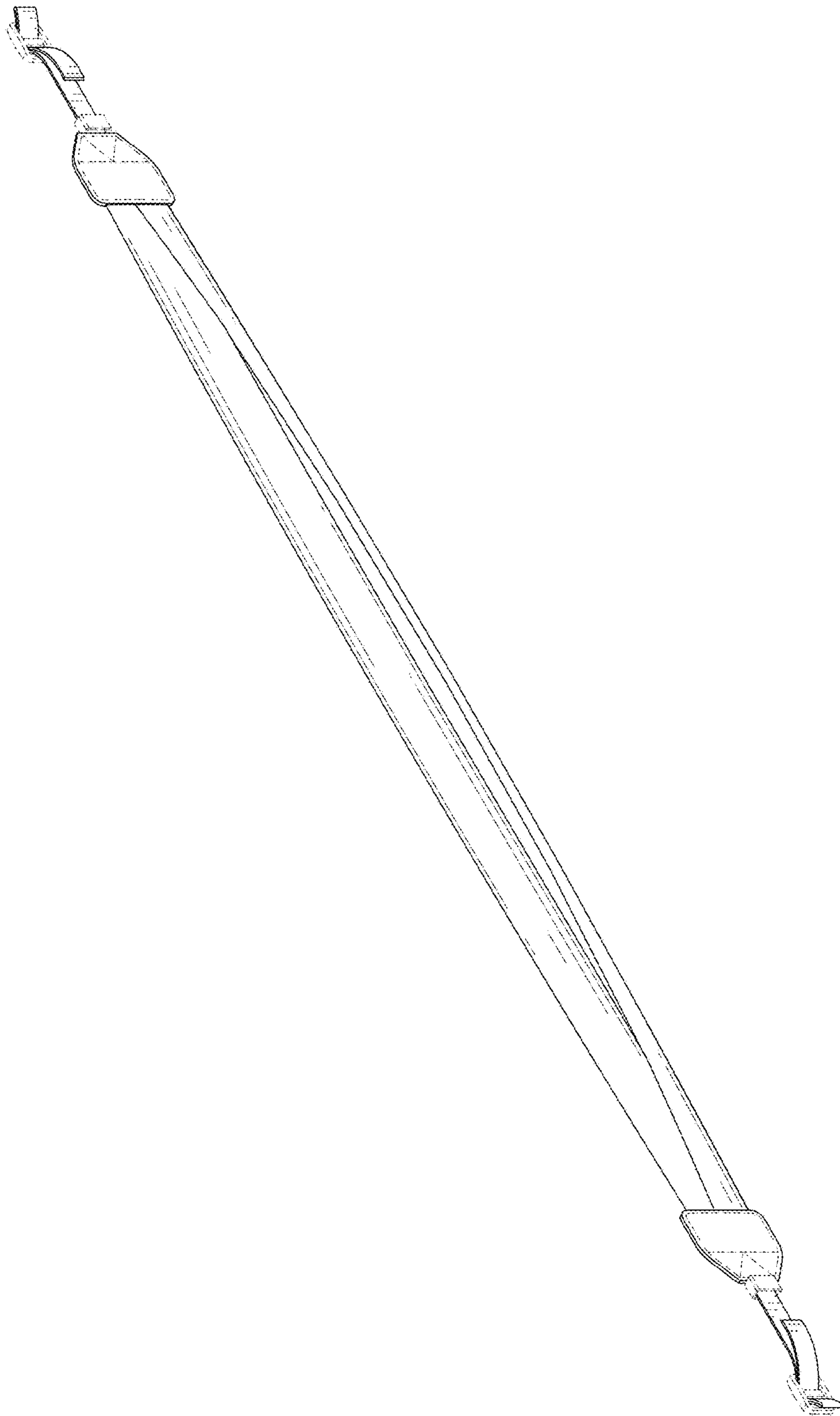

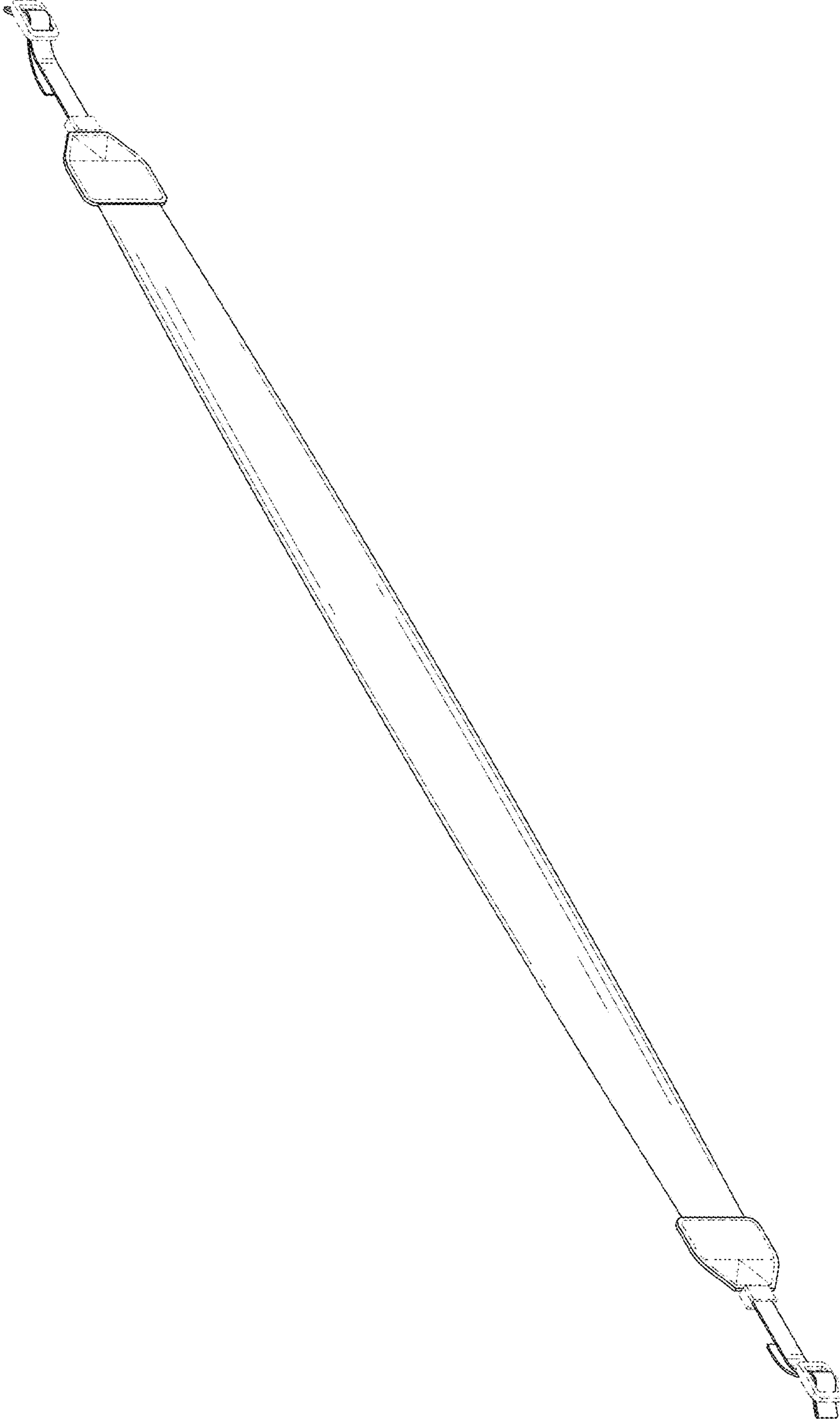

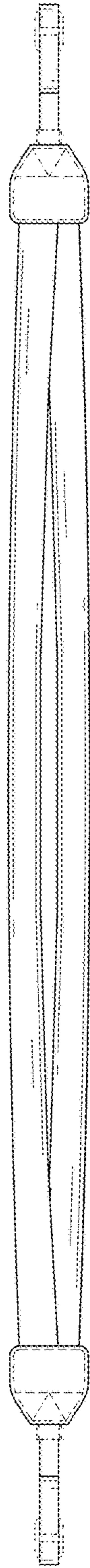

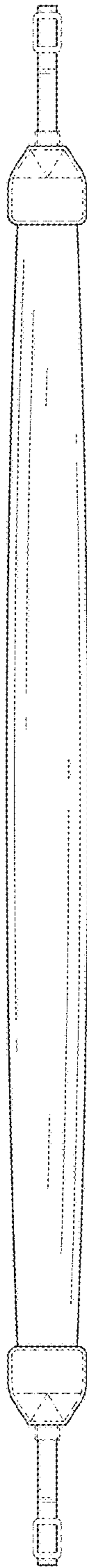

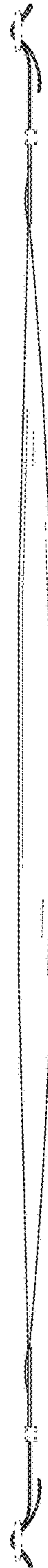

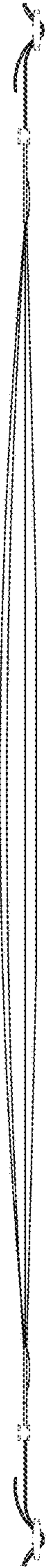

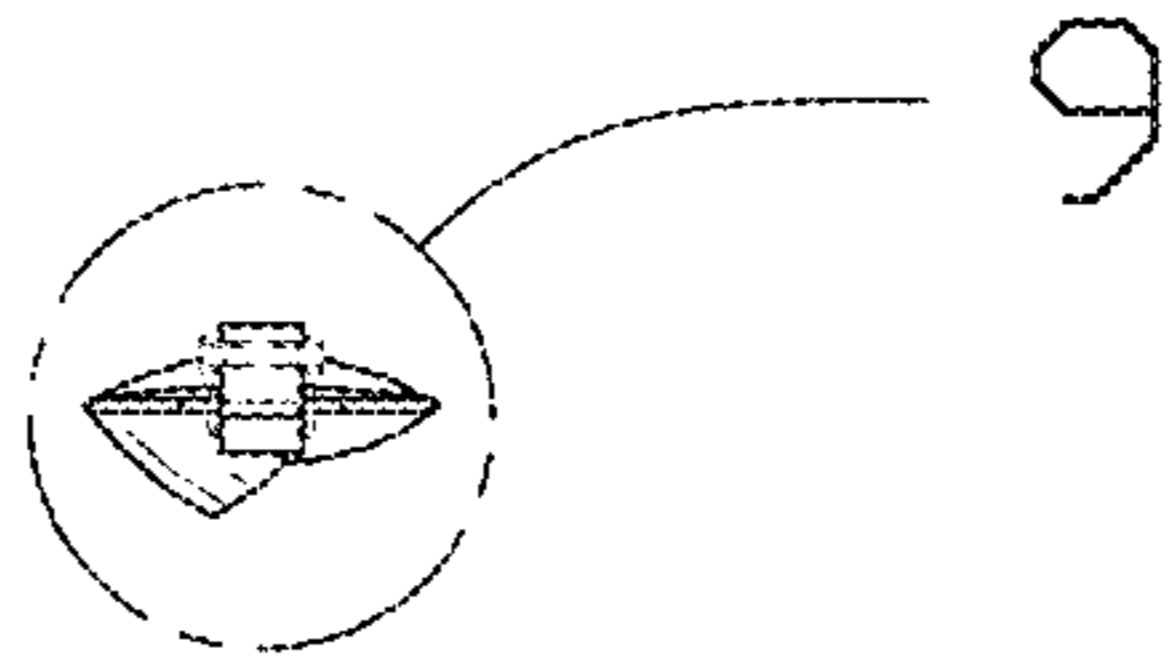

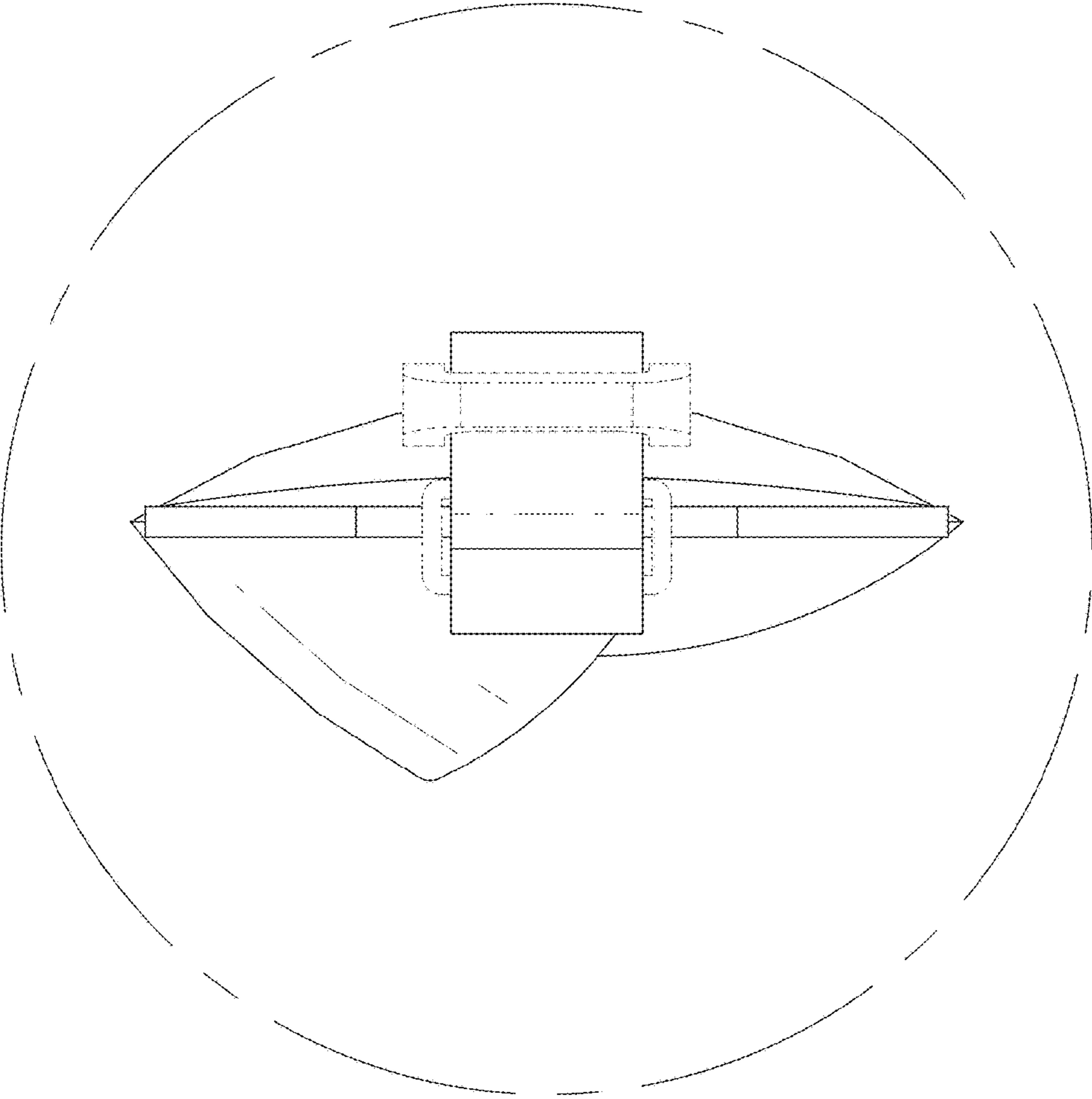

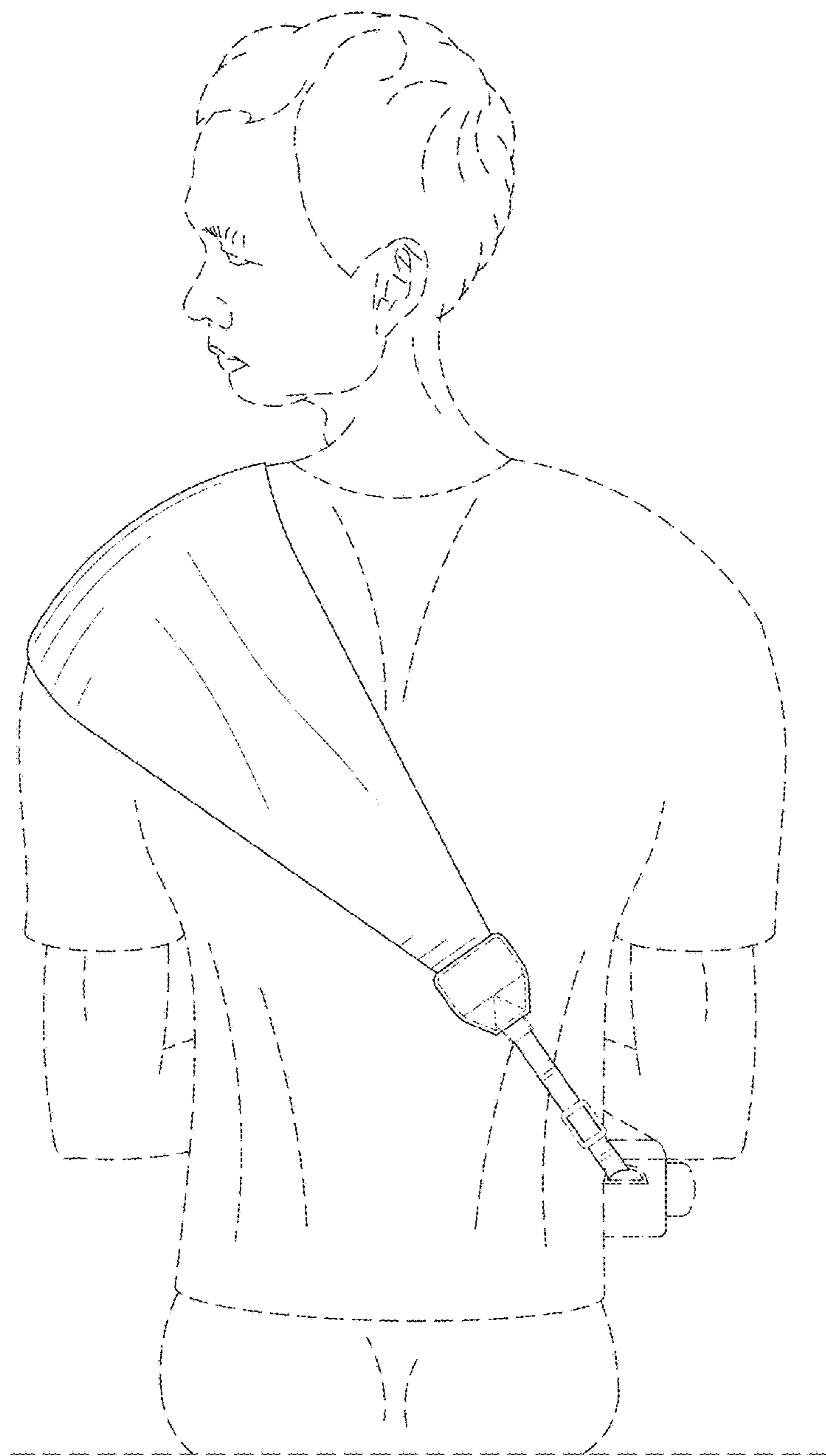
