DESCRIPTION

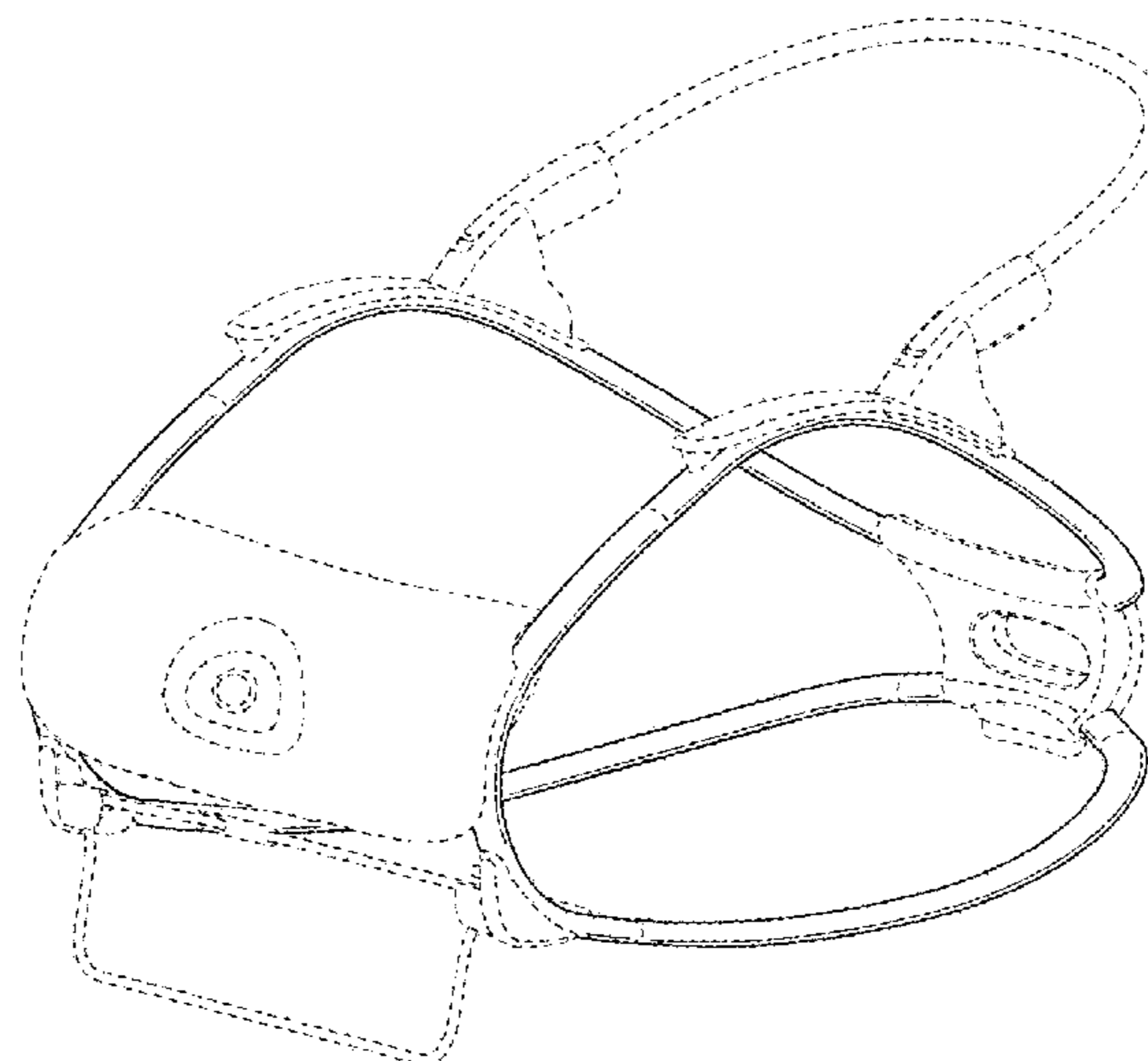
FIG. 1 is a top perspective view of a rocker, showing our new design;

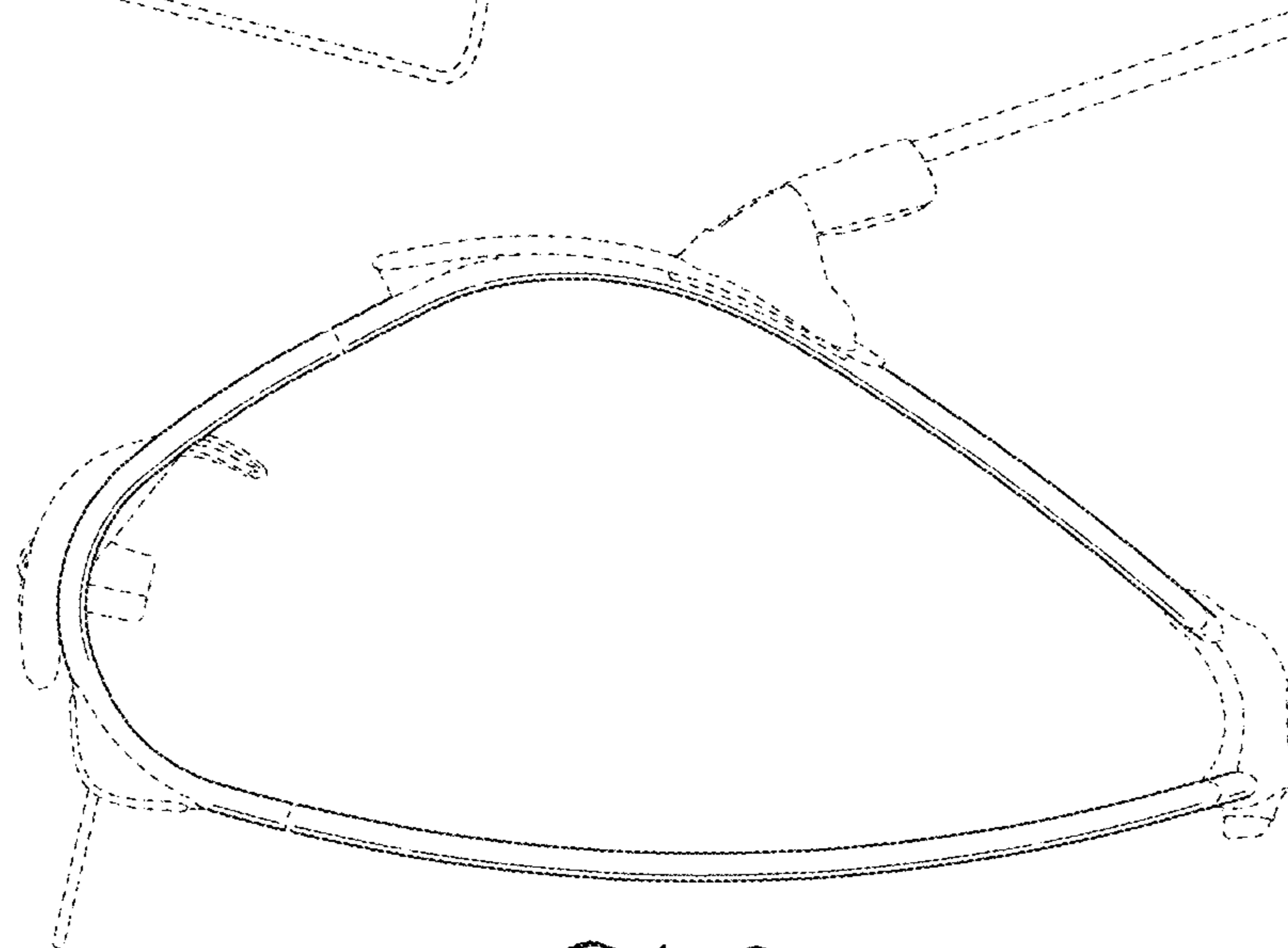
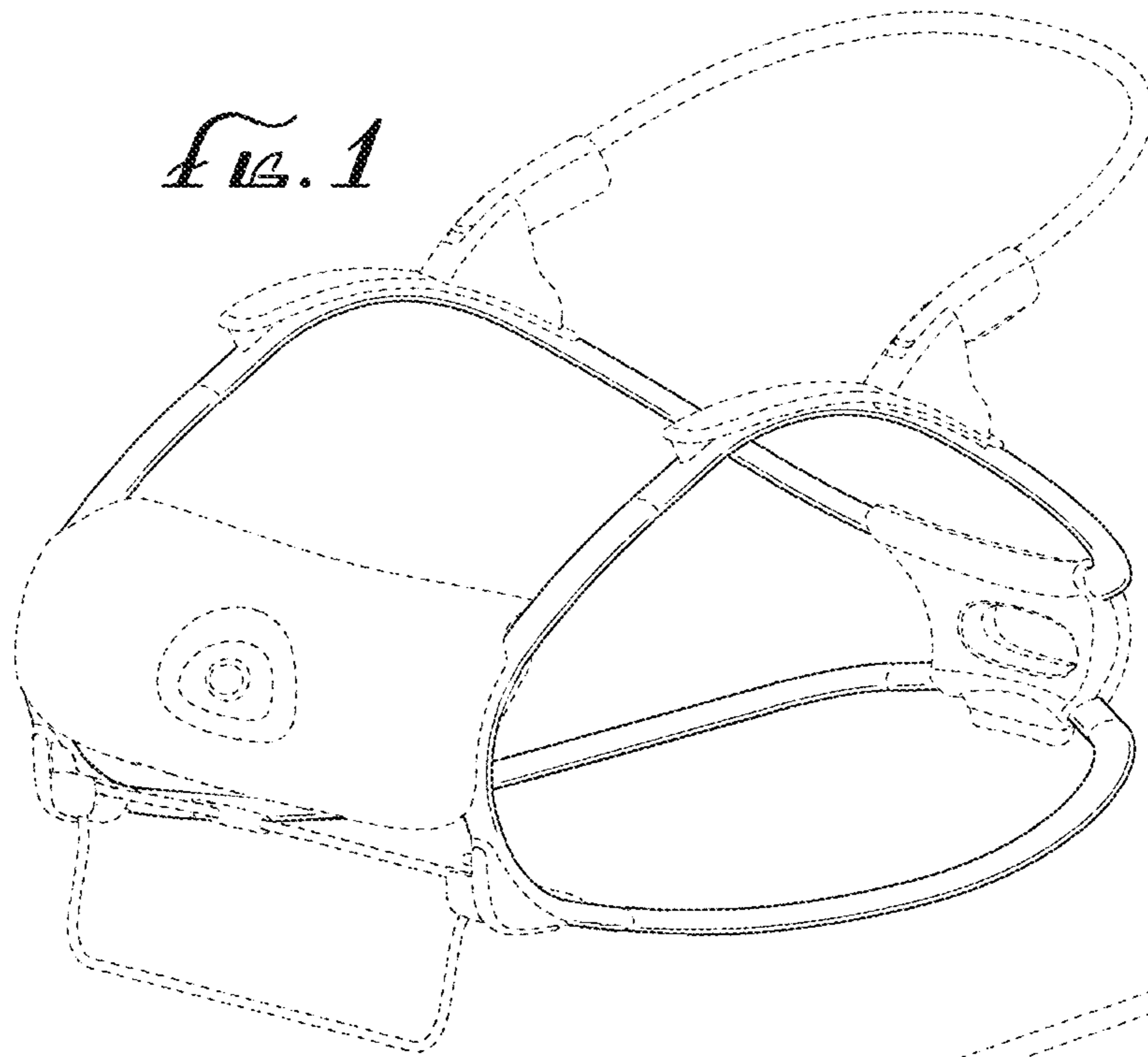

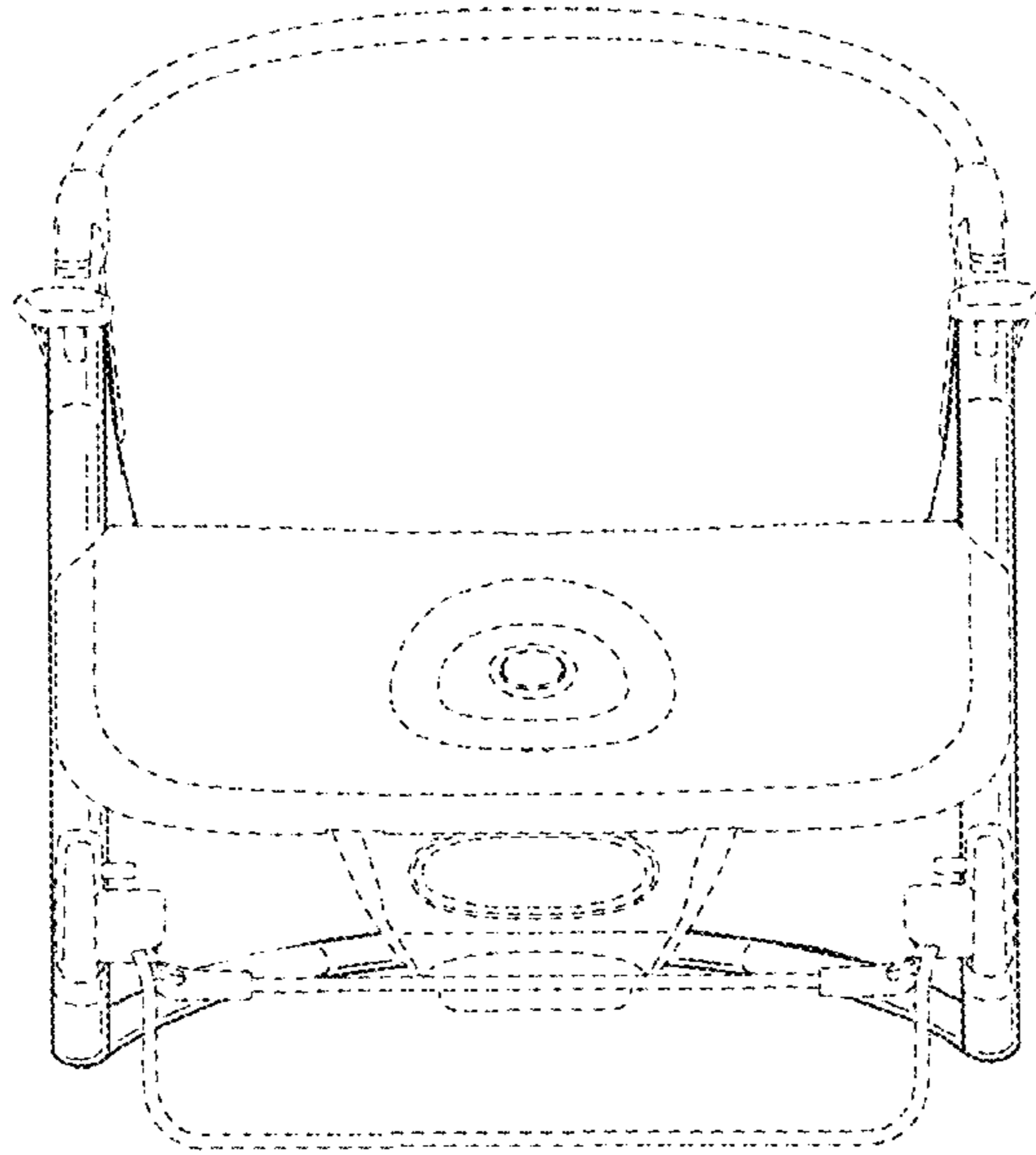

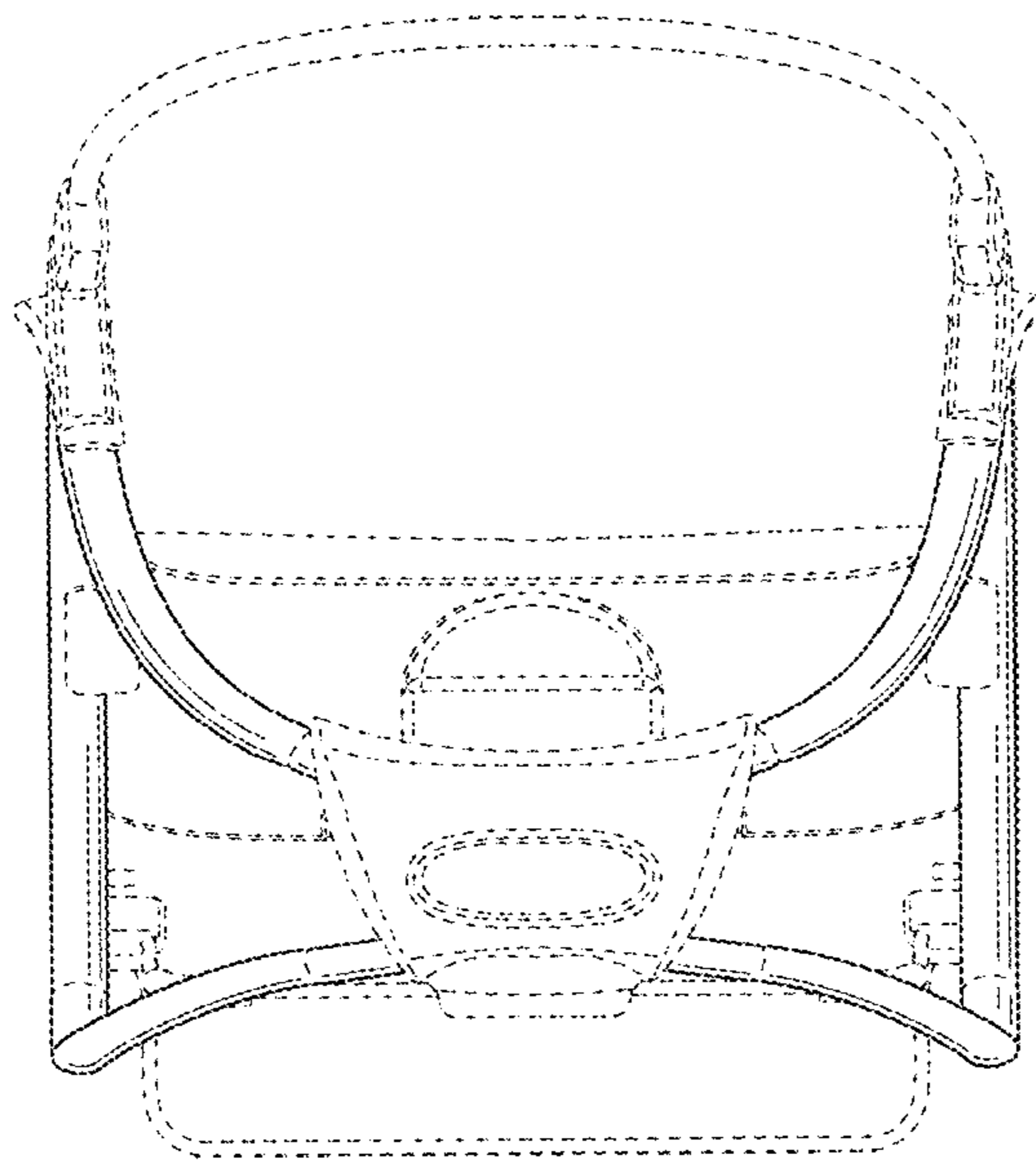

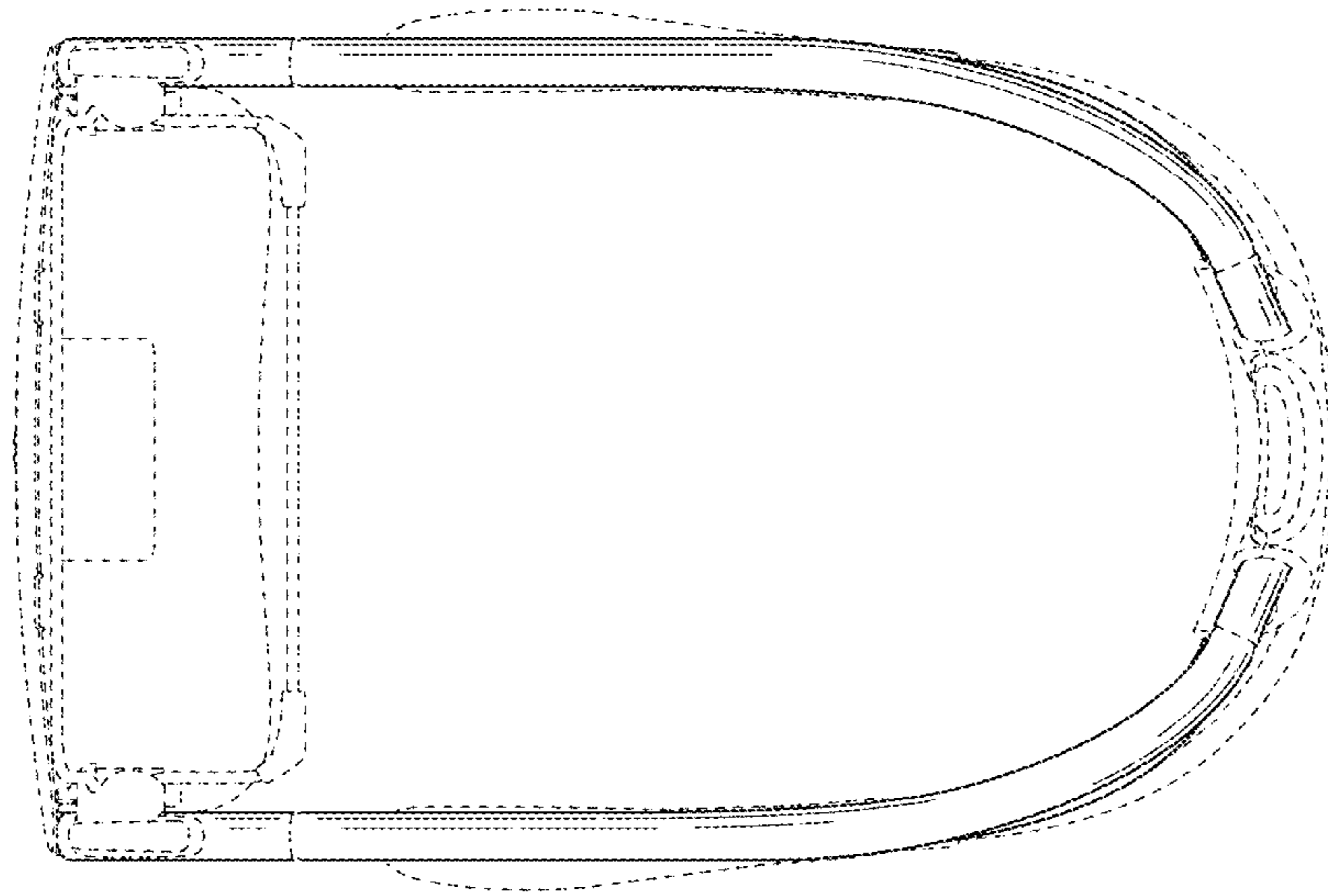

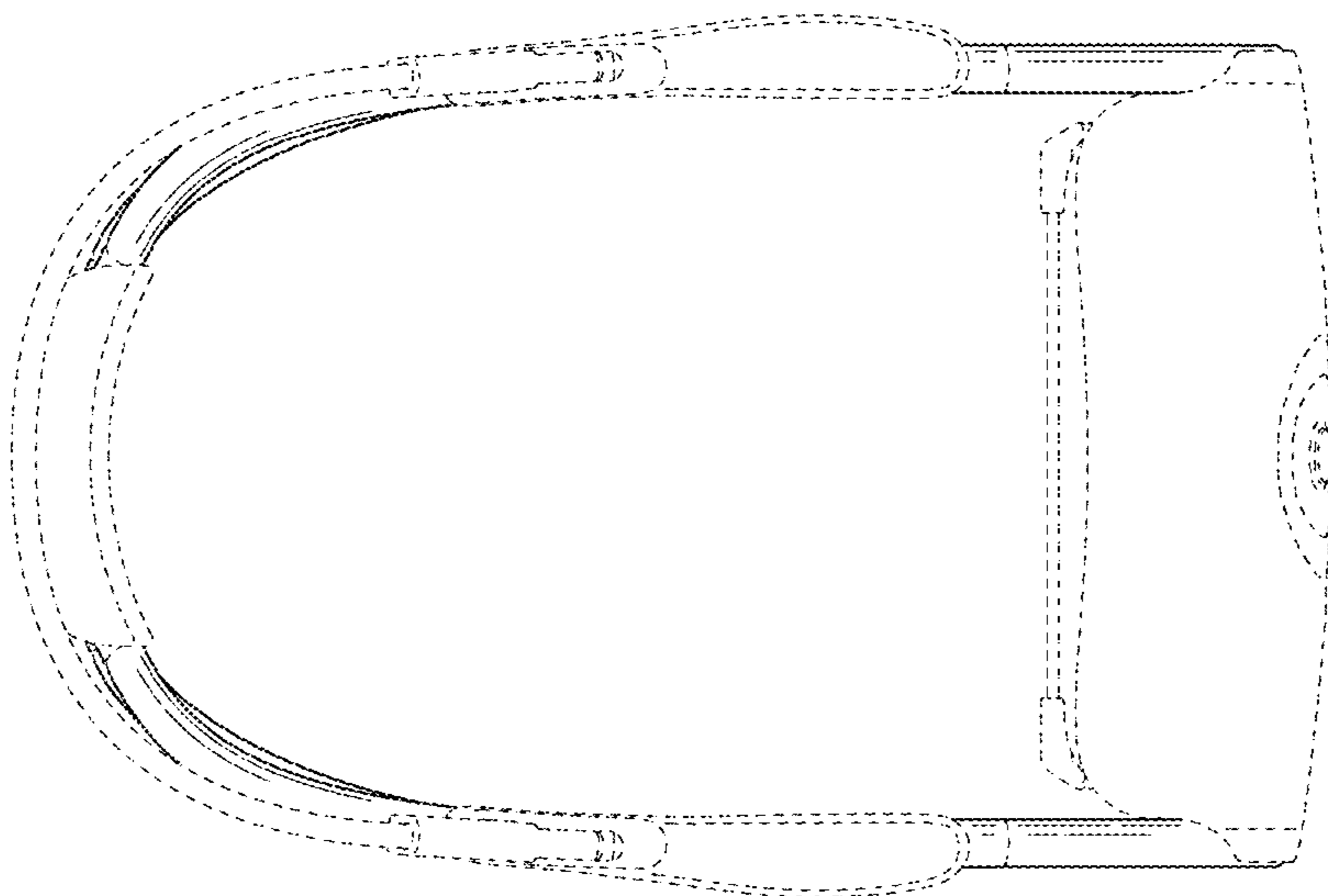
