DESCRIPTION

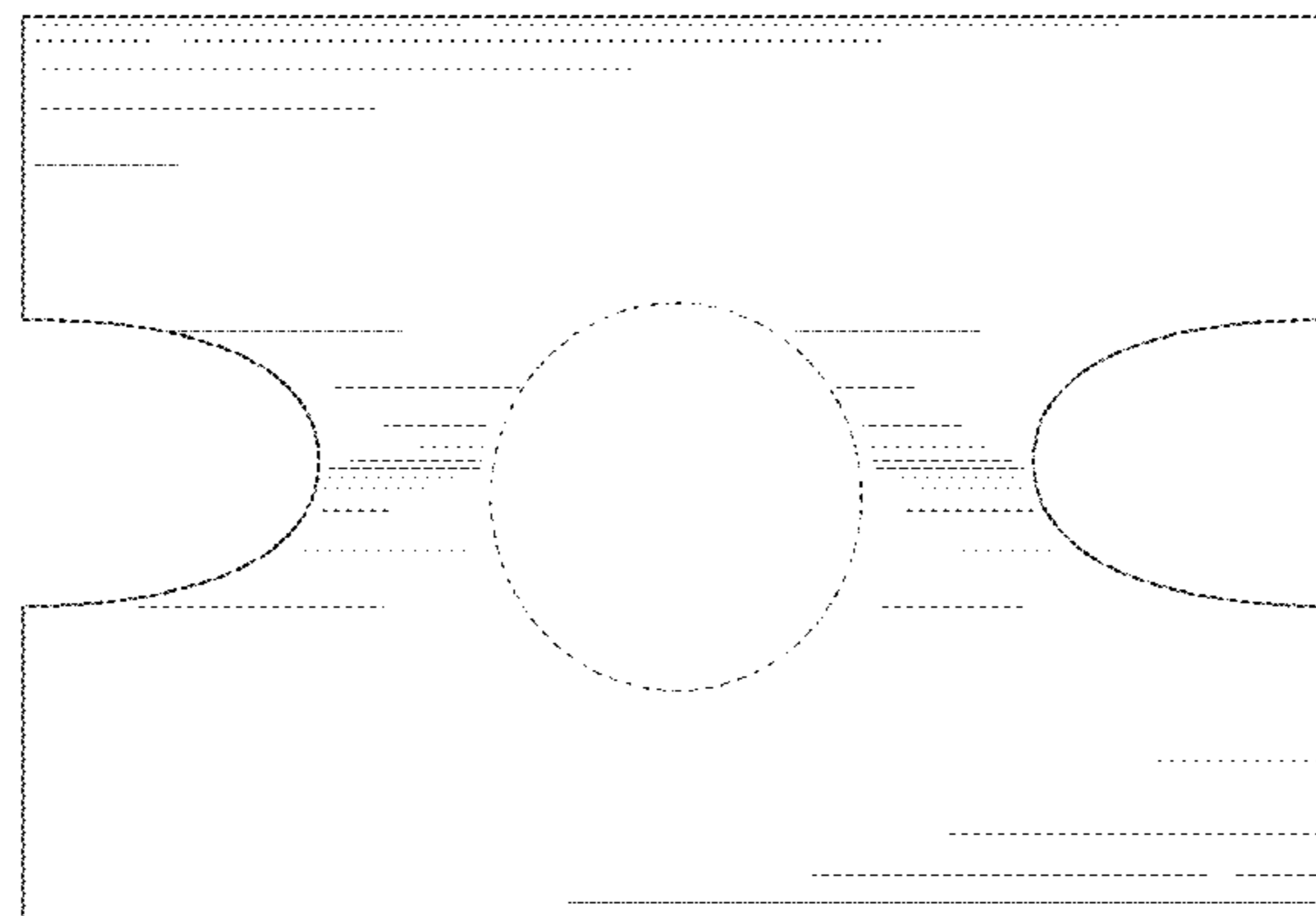
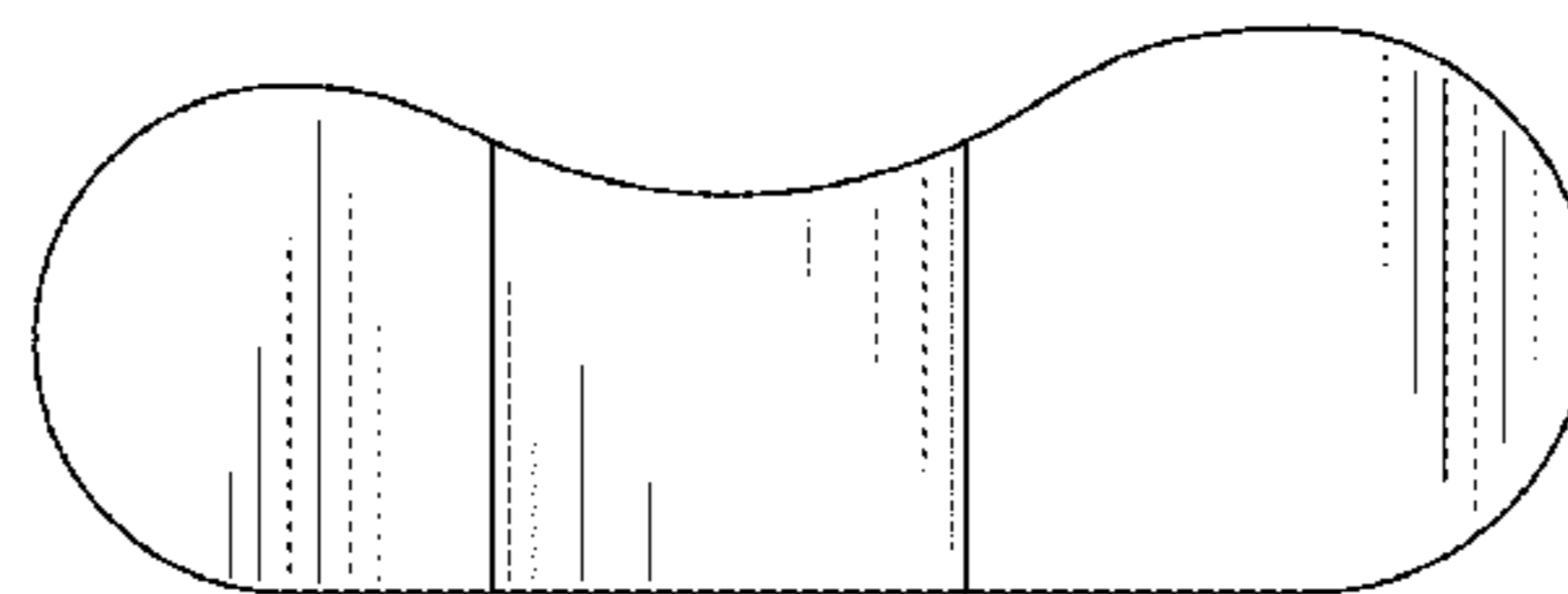
FIG. 1 is a front view of a therapeutic face pillow showing my new design;

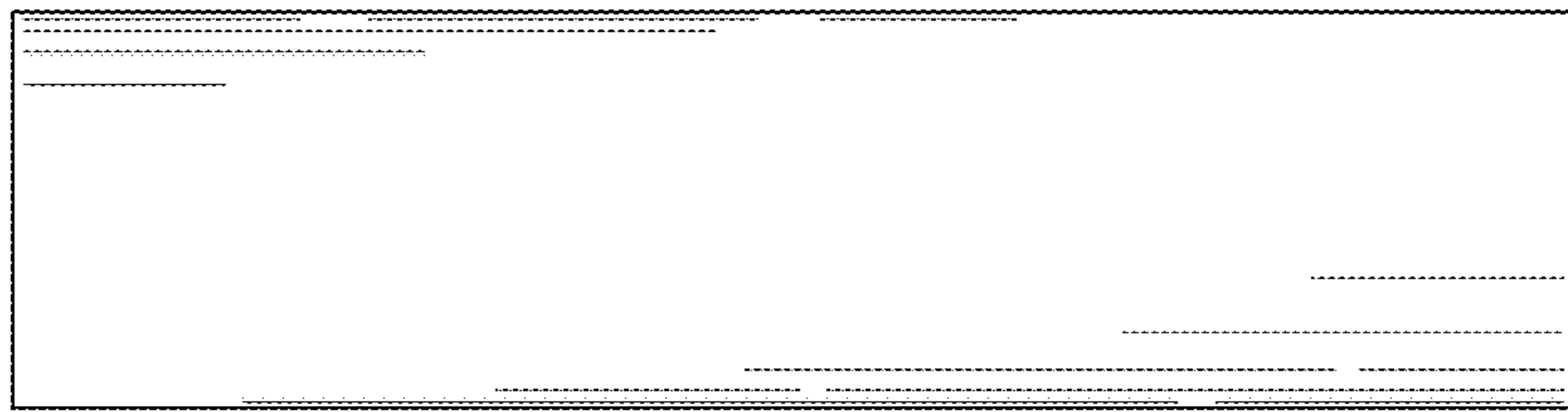

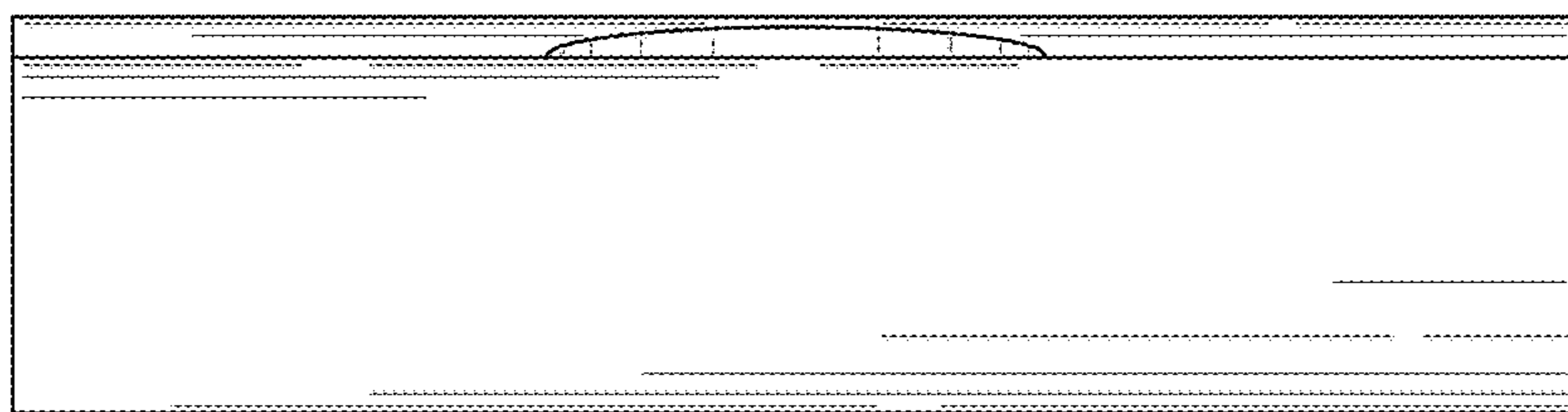

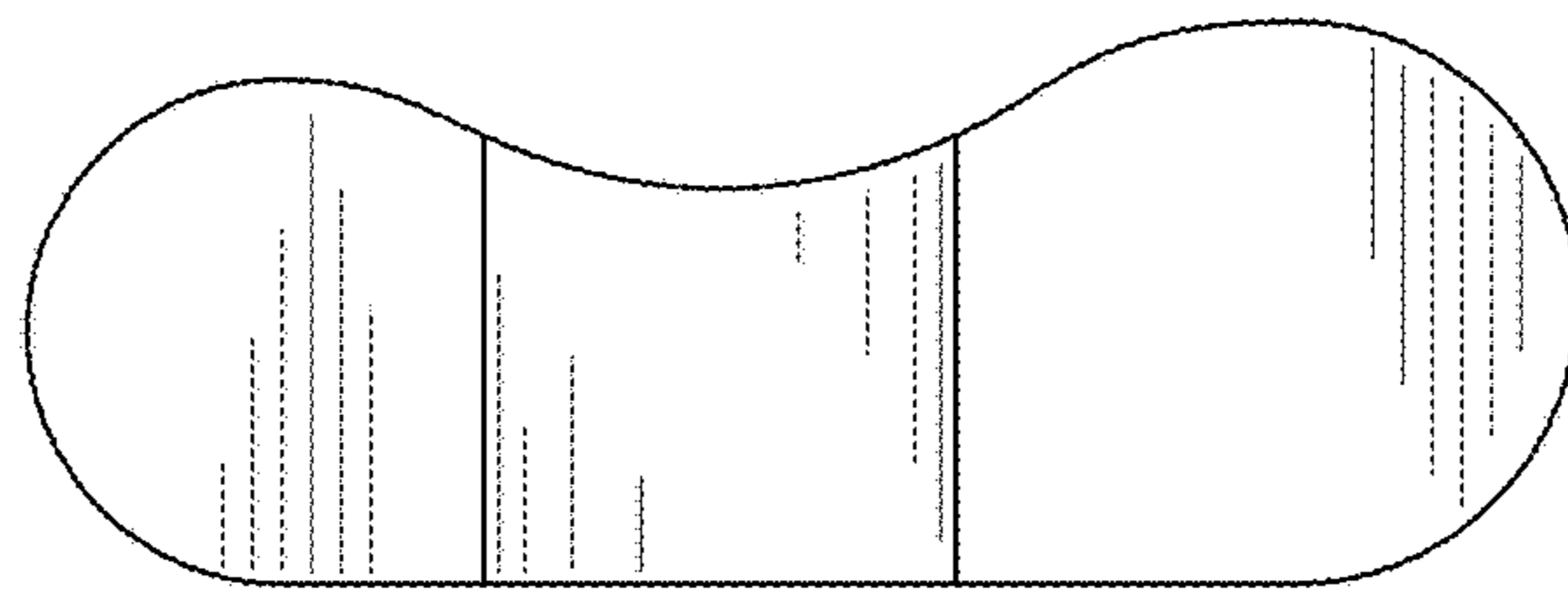

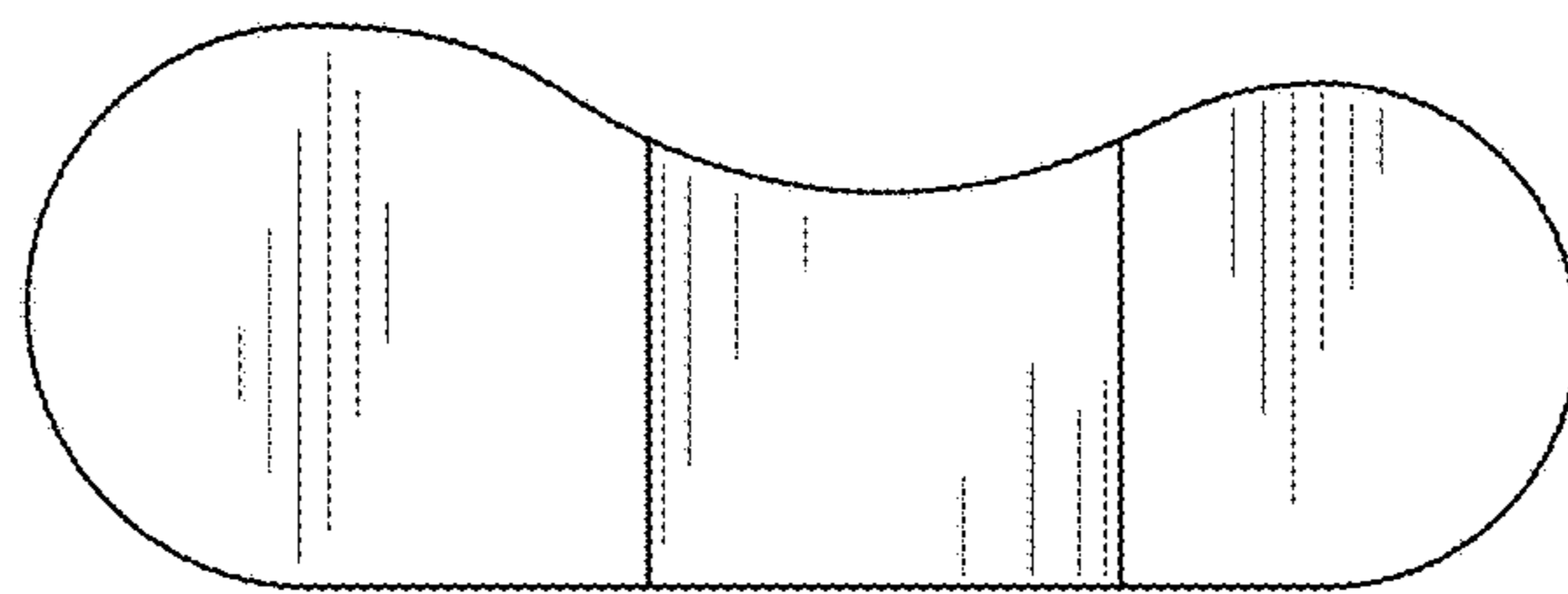

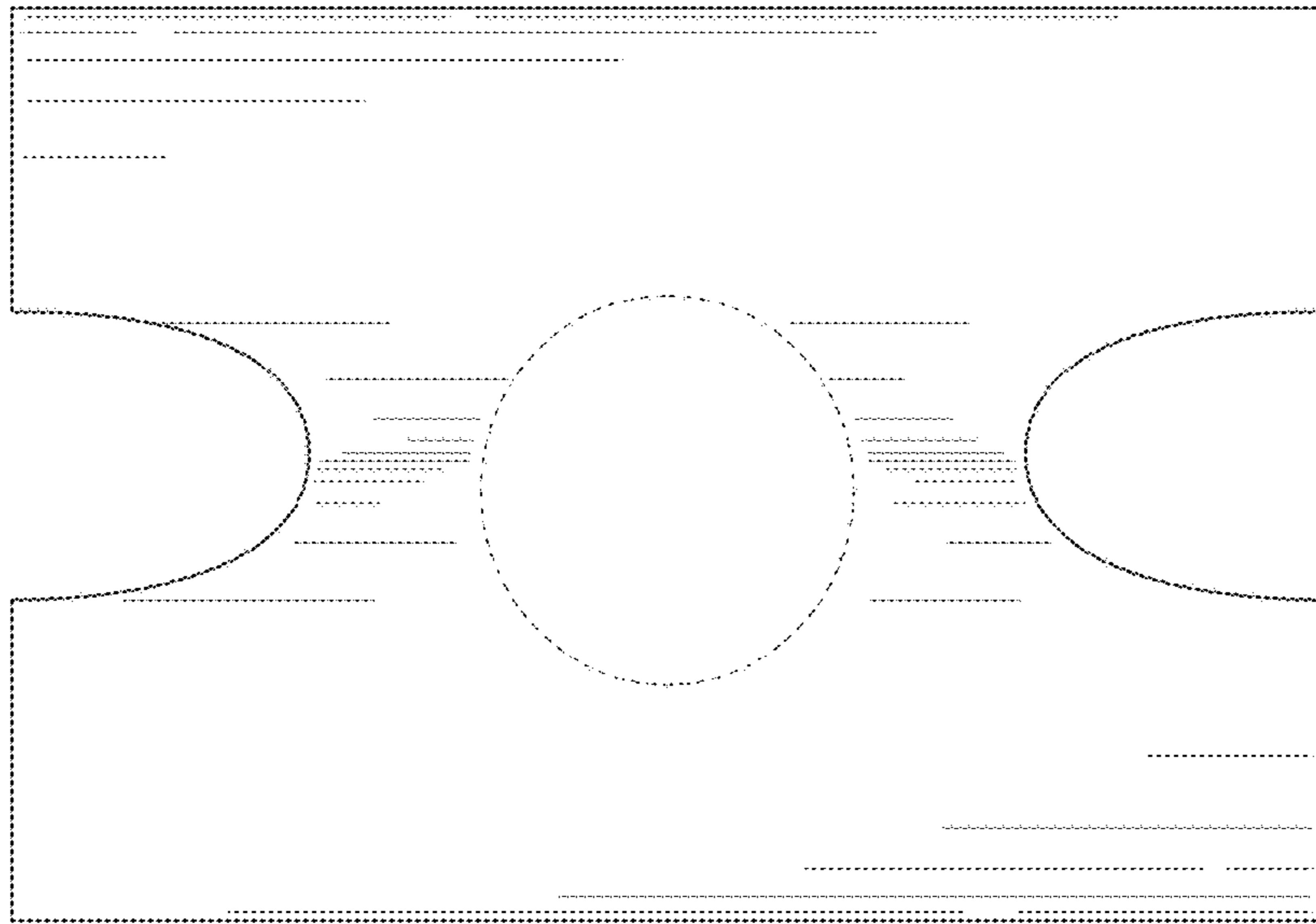

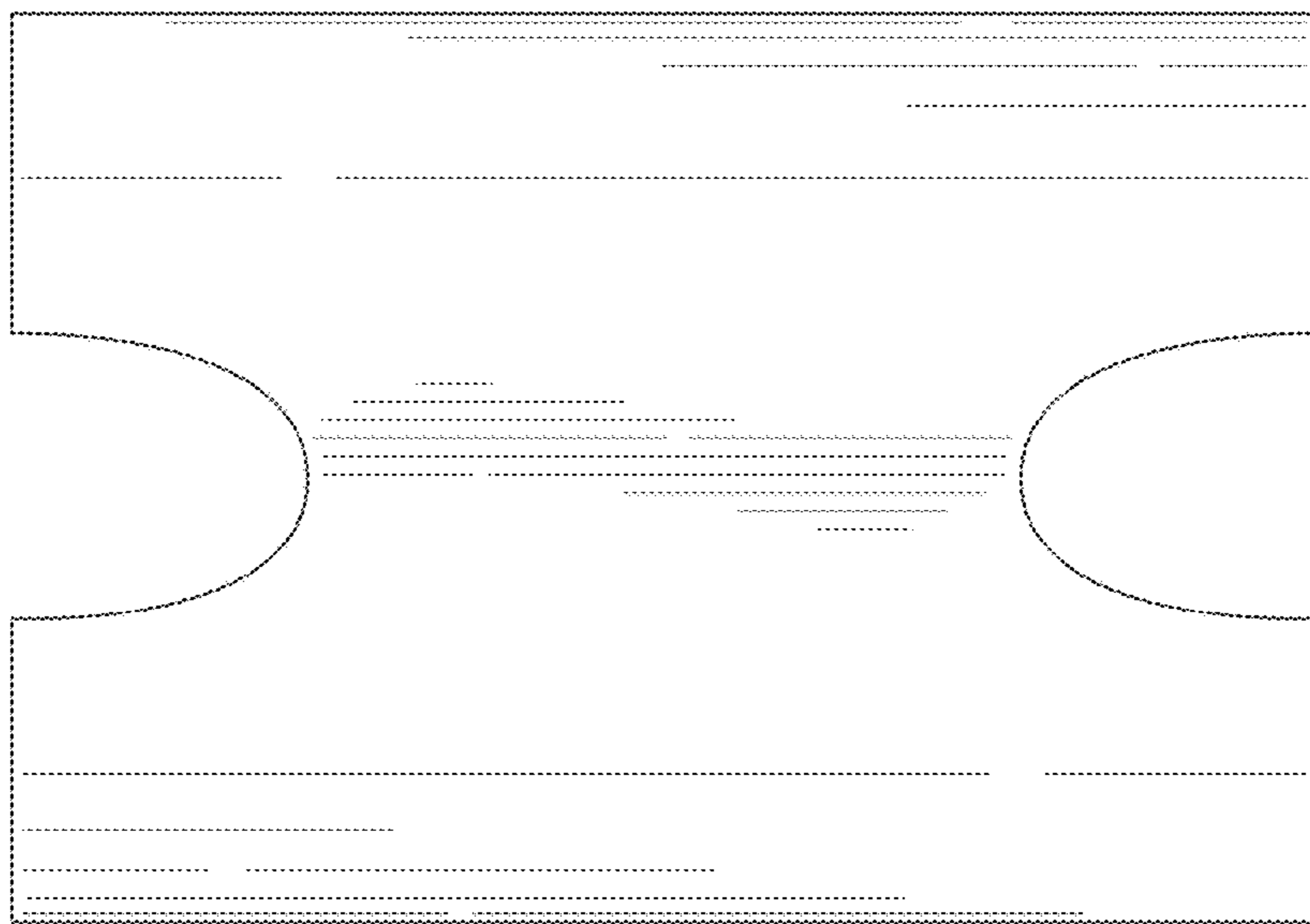
