FIG. 4 is a right side elevation view thereof.

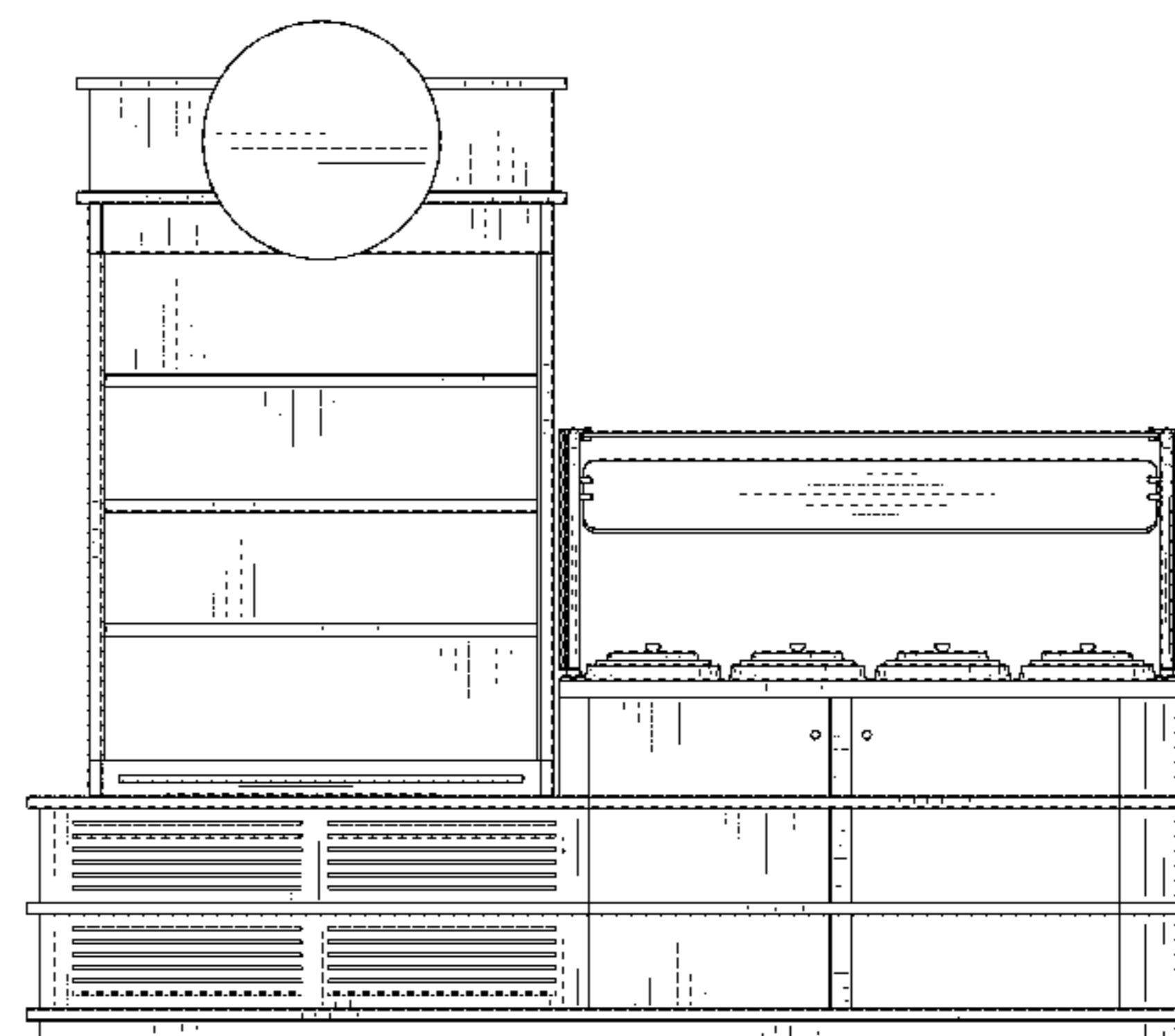
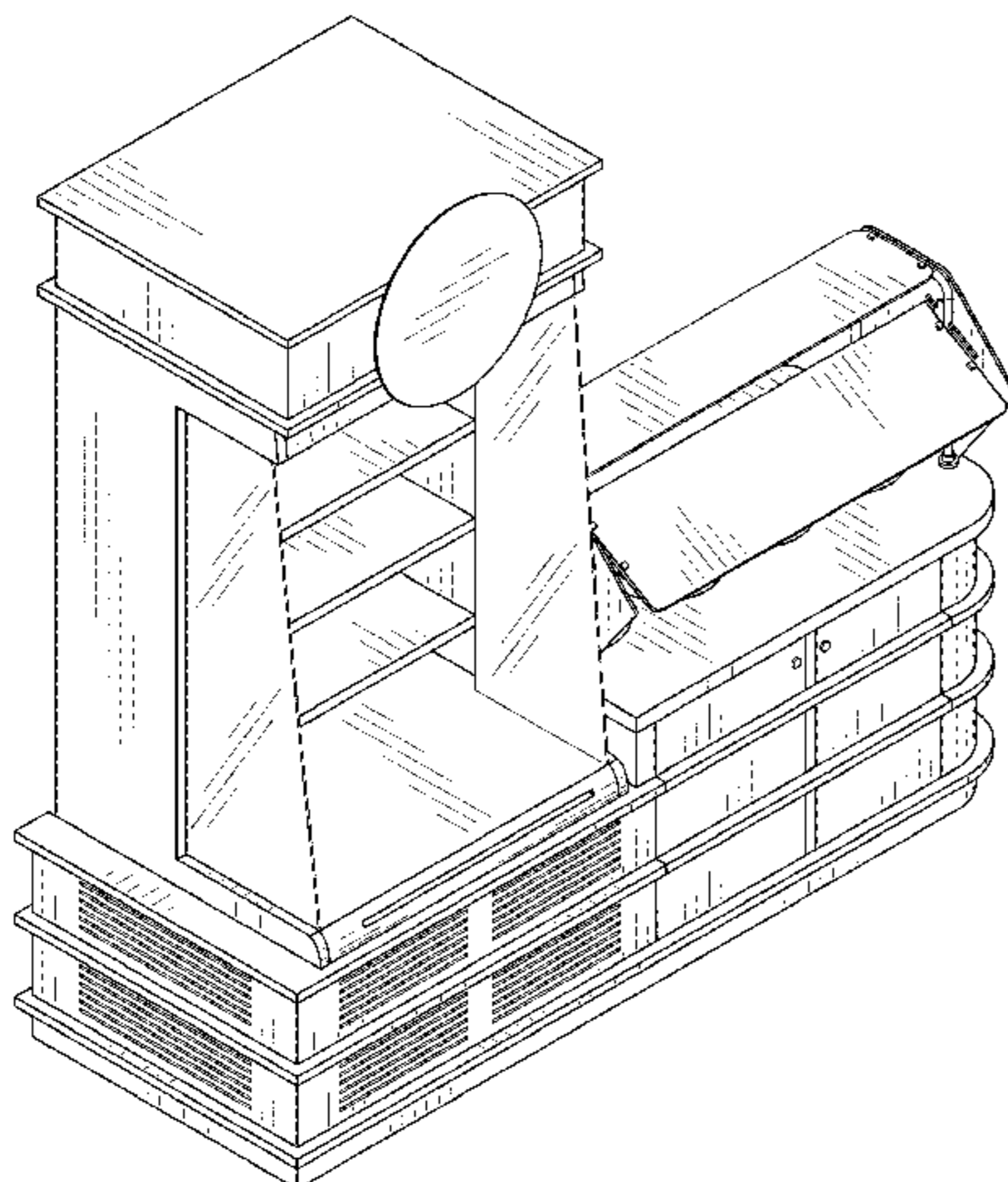
FIG. 5 is a left side elevation view thereof.

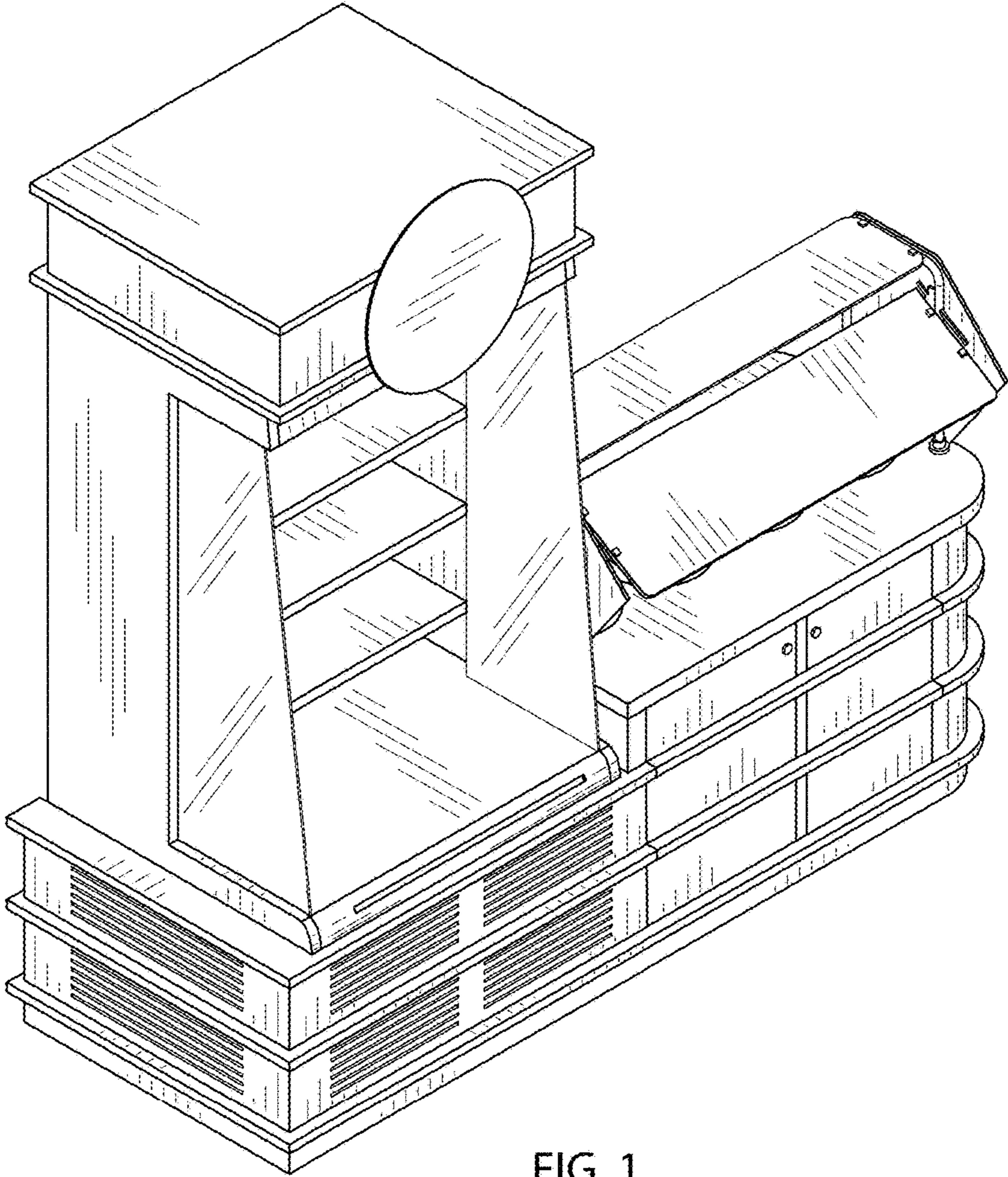

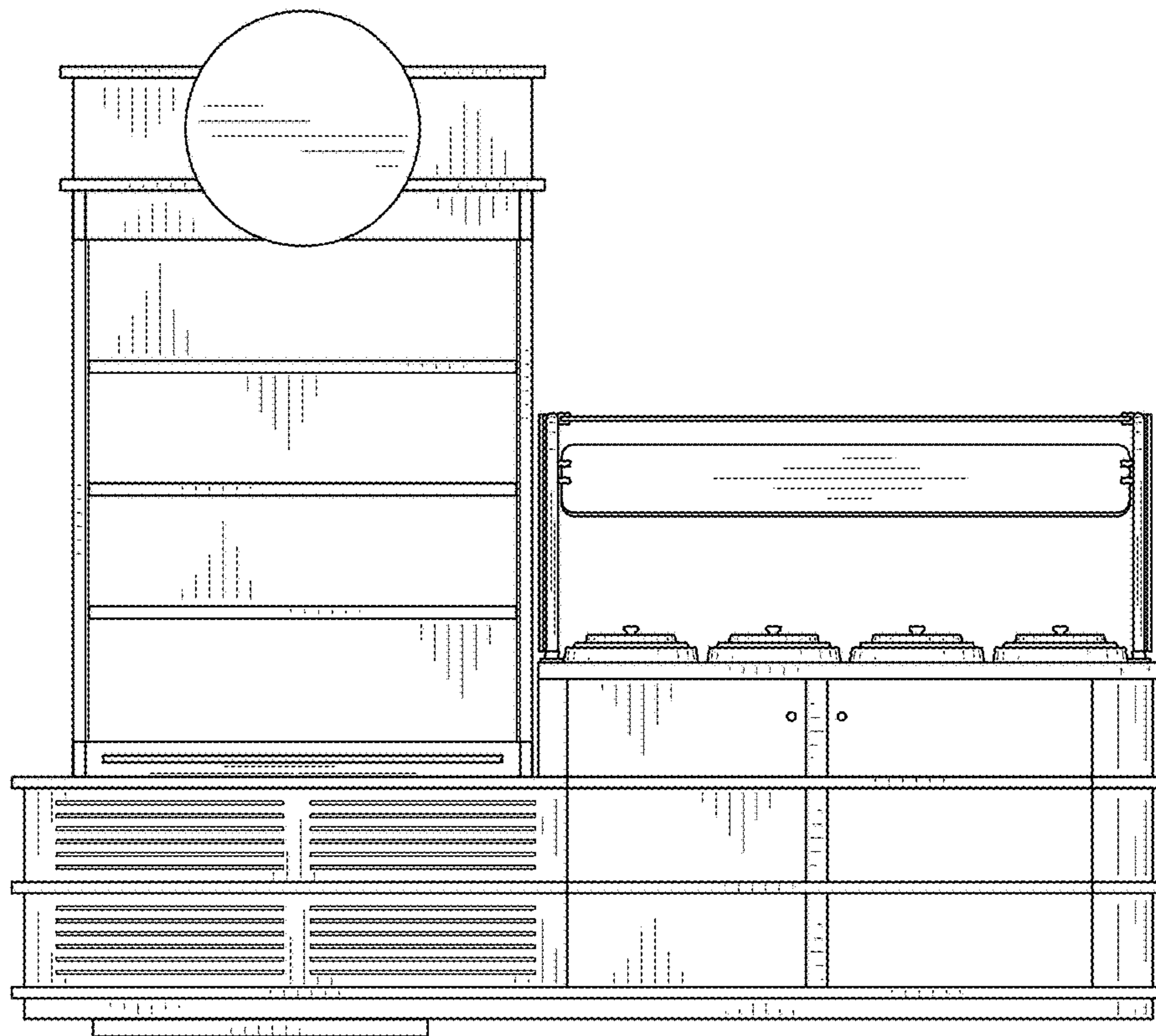

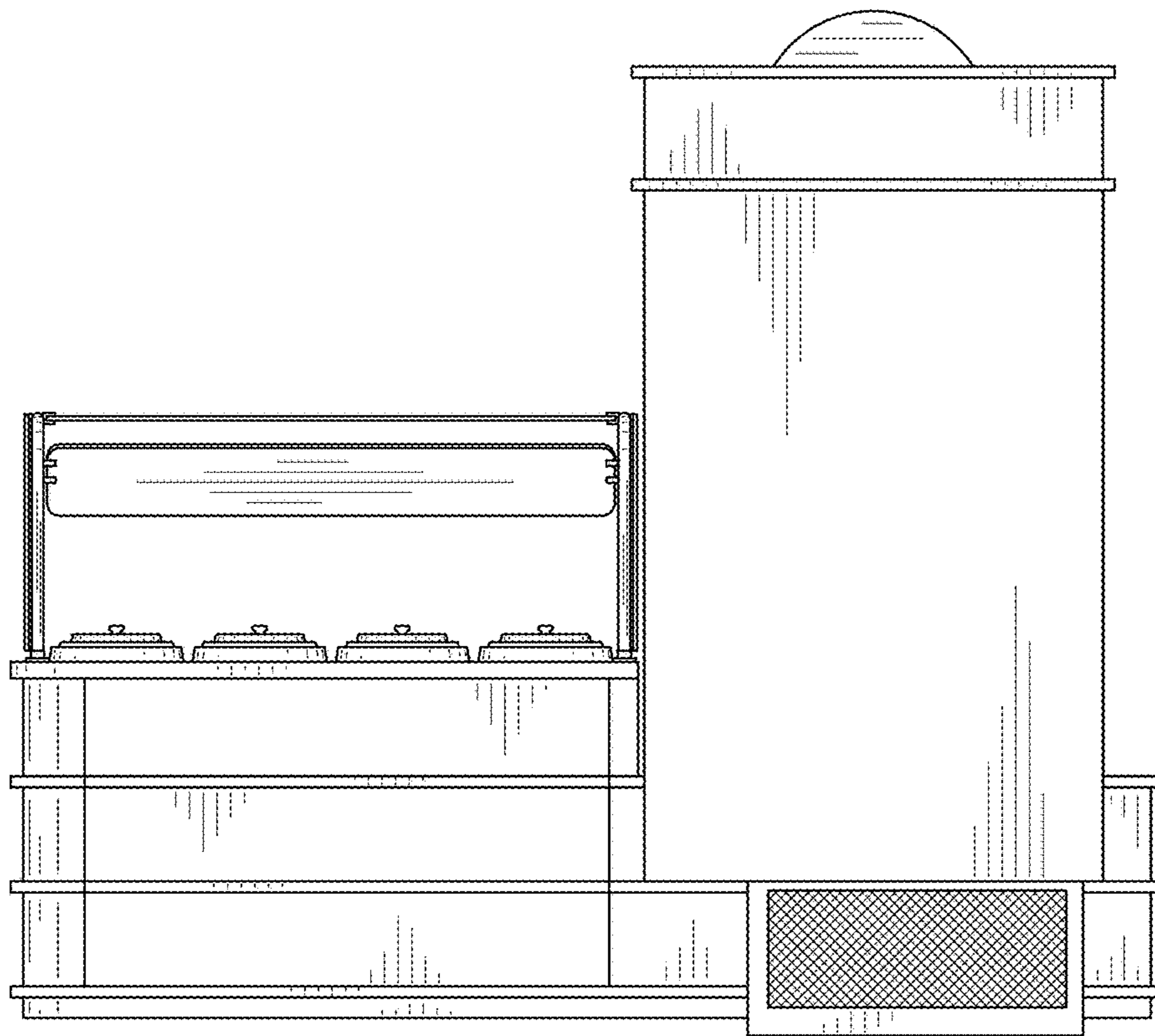

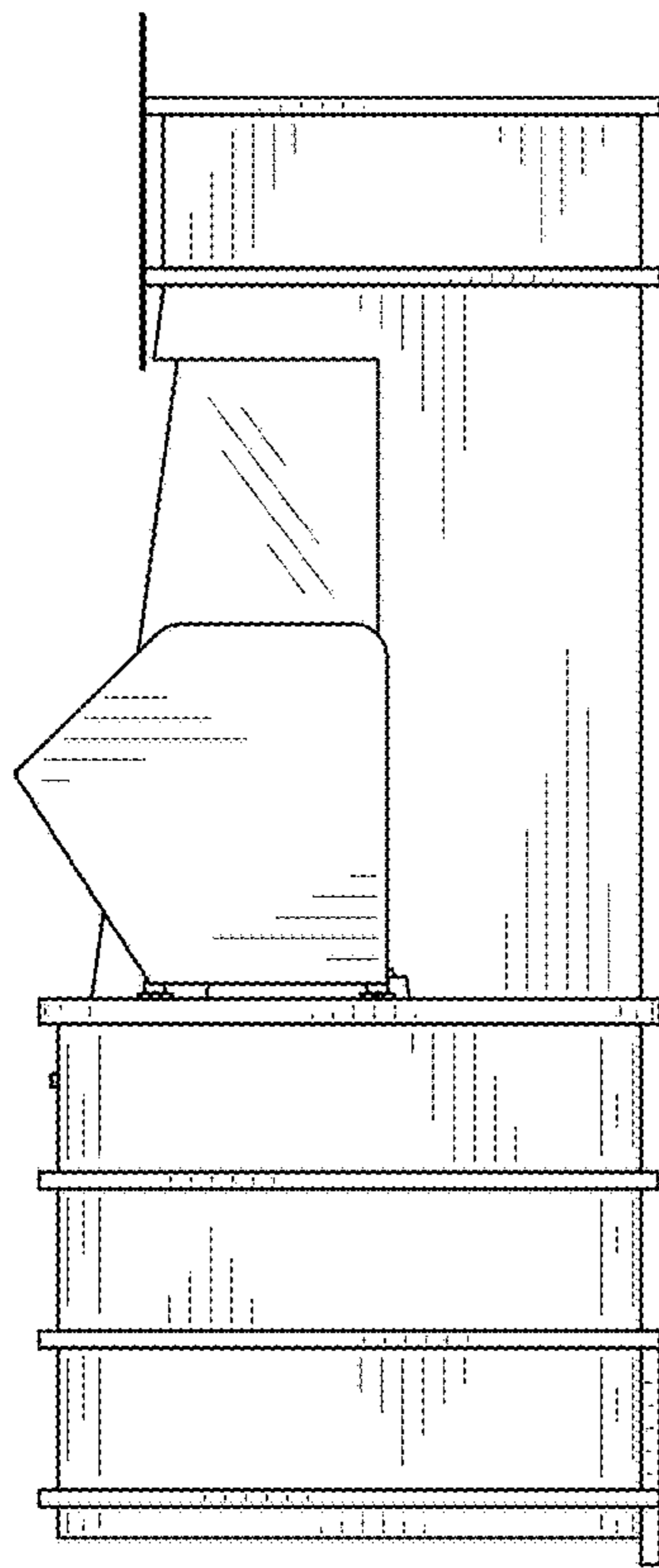

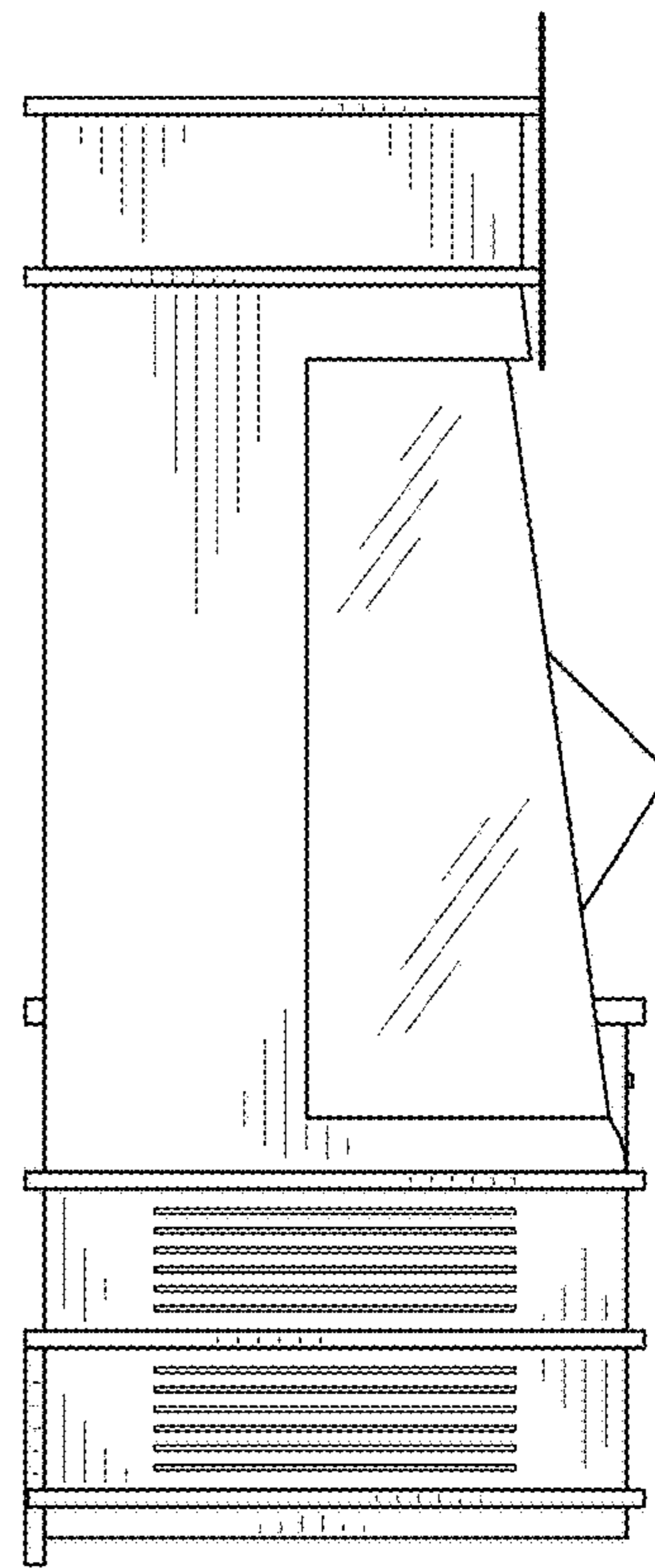

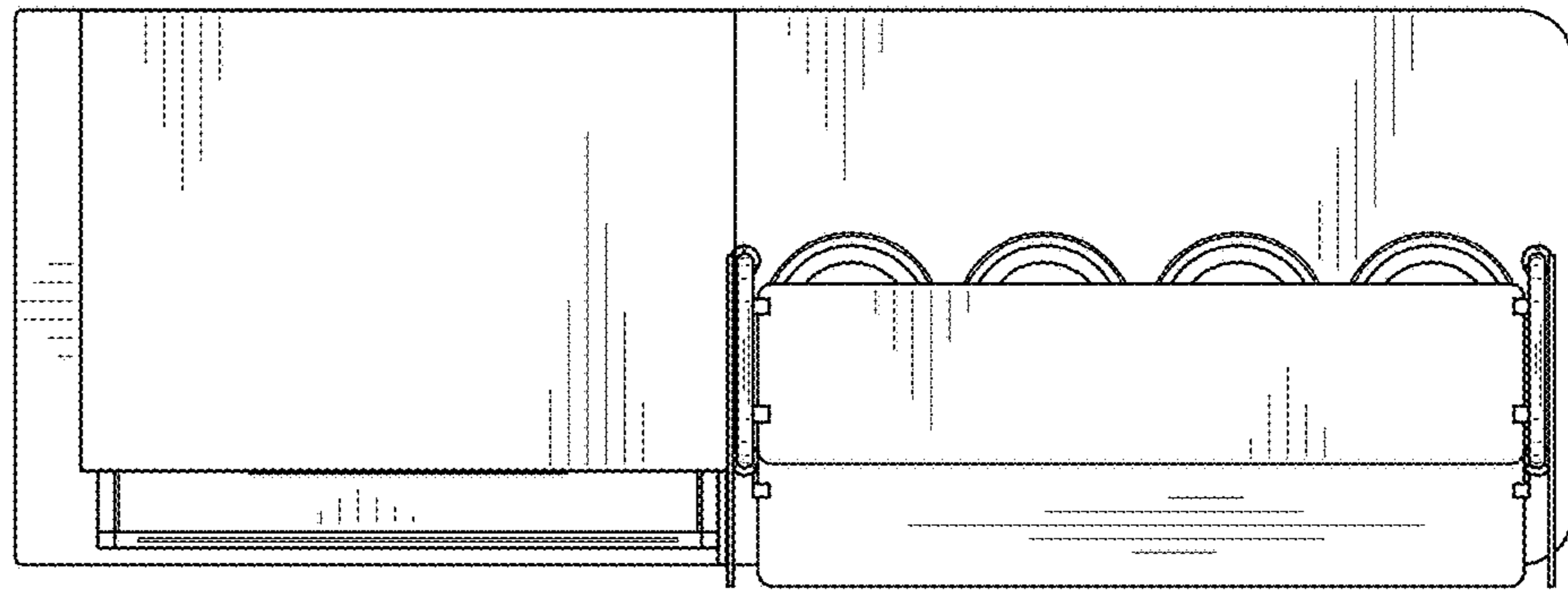

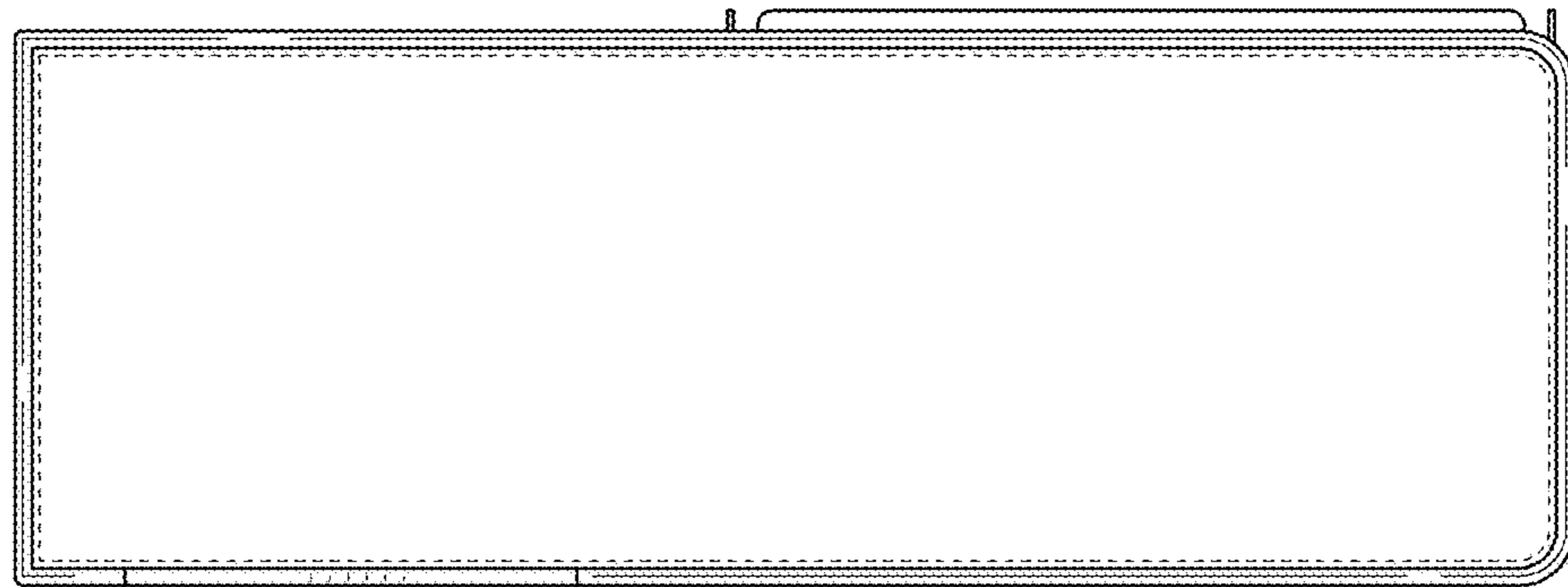
