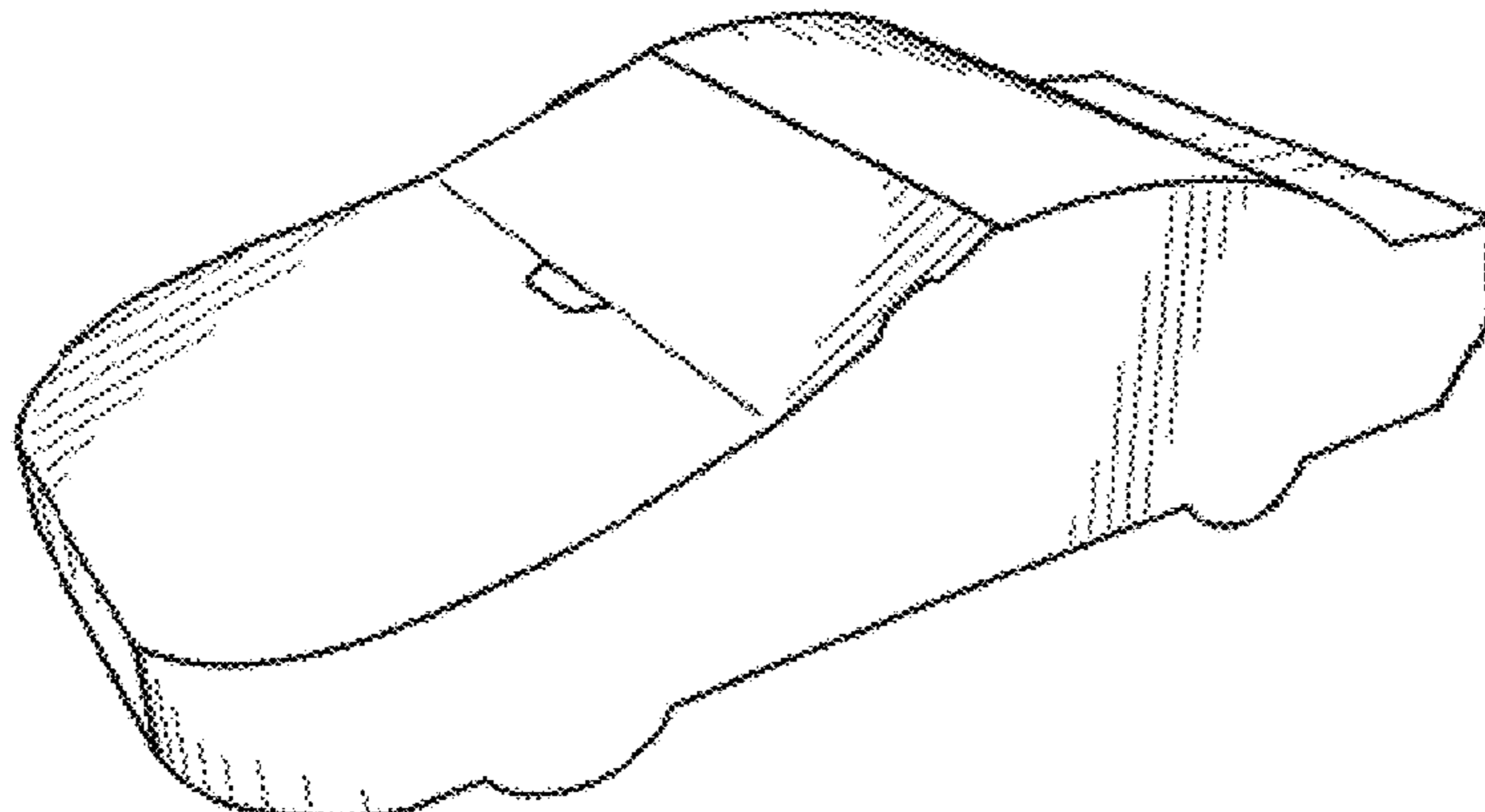

The ornamental design for a vehicle carton, as shown and described.

**DESCRIPTION**  
FIG. 1 is a flat unfolded view of a vehicle carton;  
FIG. 2 is a top view of the vehicle carton of FIG. 1 in the folded form;  
FIG. 3 is a bottom assembled view thereof;  
FIG. 4 is a right side assembled view thereof;  
FIG. 5 is a front end assembled view thereof;  
FIG. 6 is a back end assembled view thereof; and,  
FIG. 7 is a perspective assembled view thereof.  
The broken lines in FIG. 1 depict fold lines illustrated in the other figures as solid lines when folded.

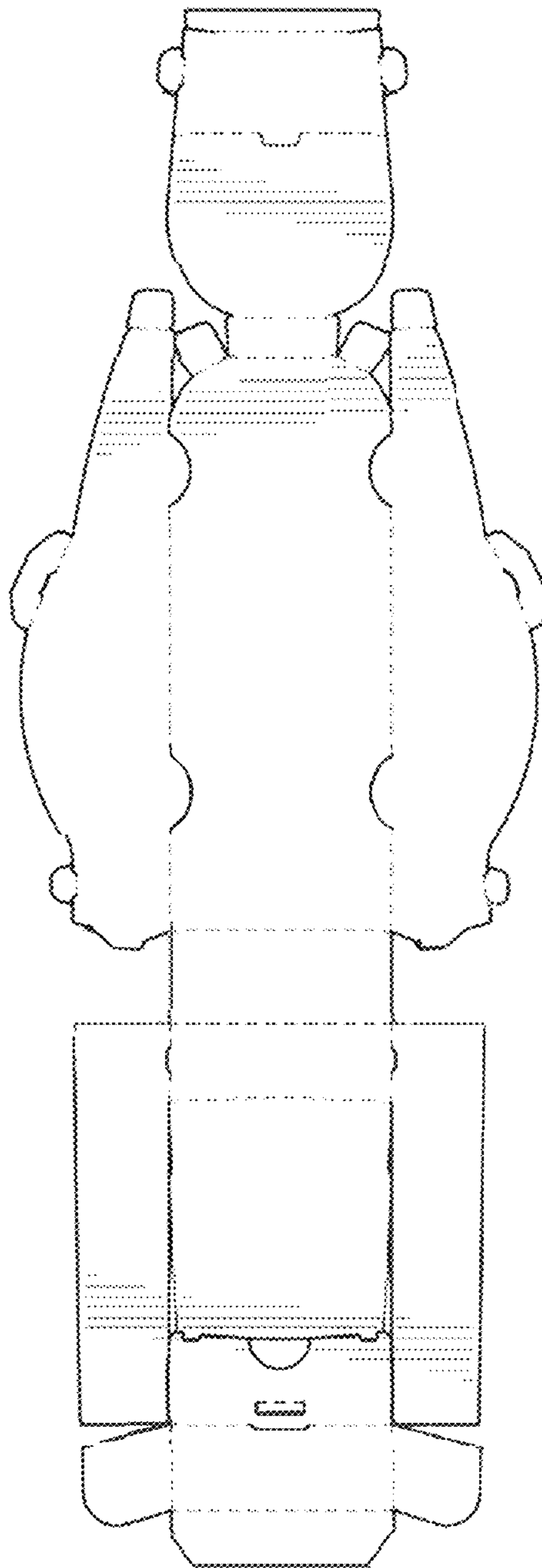

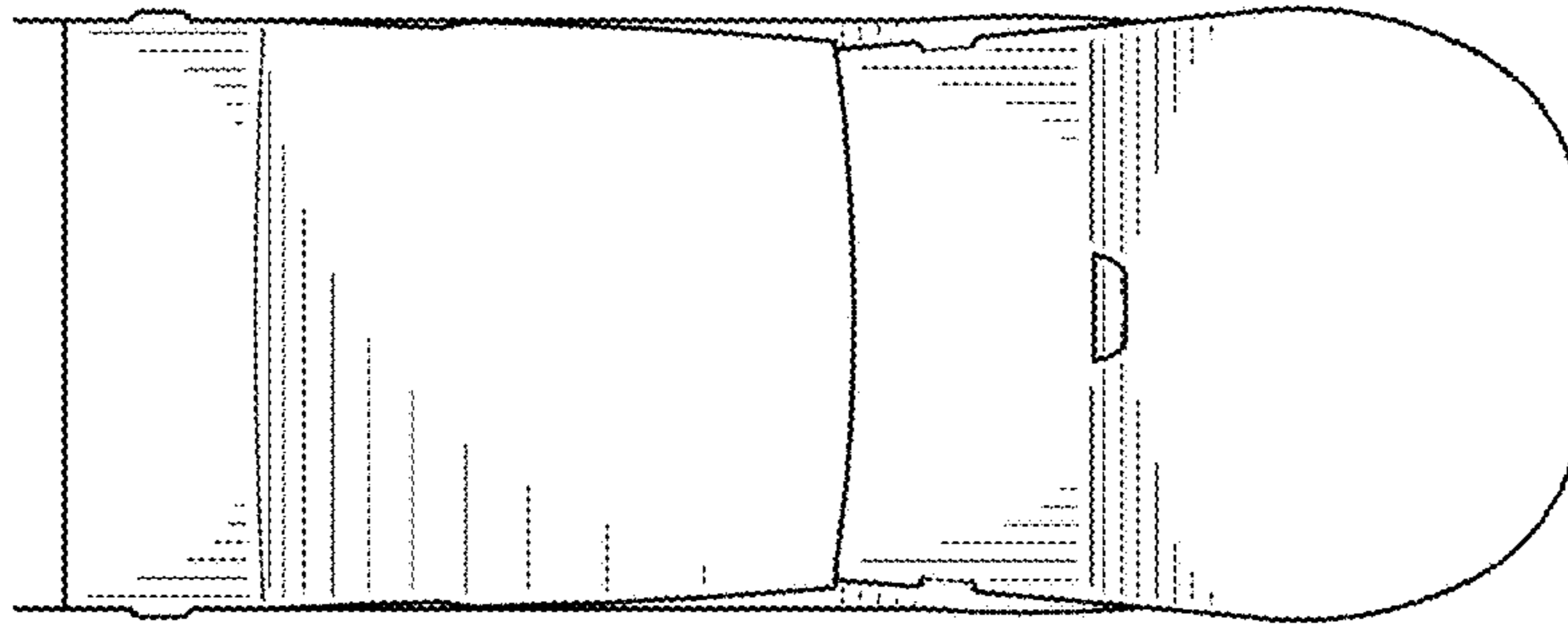

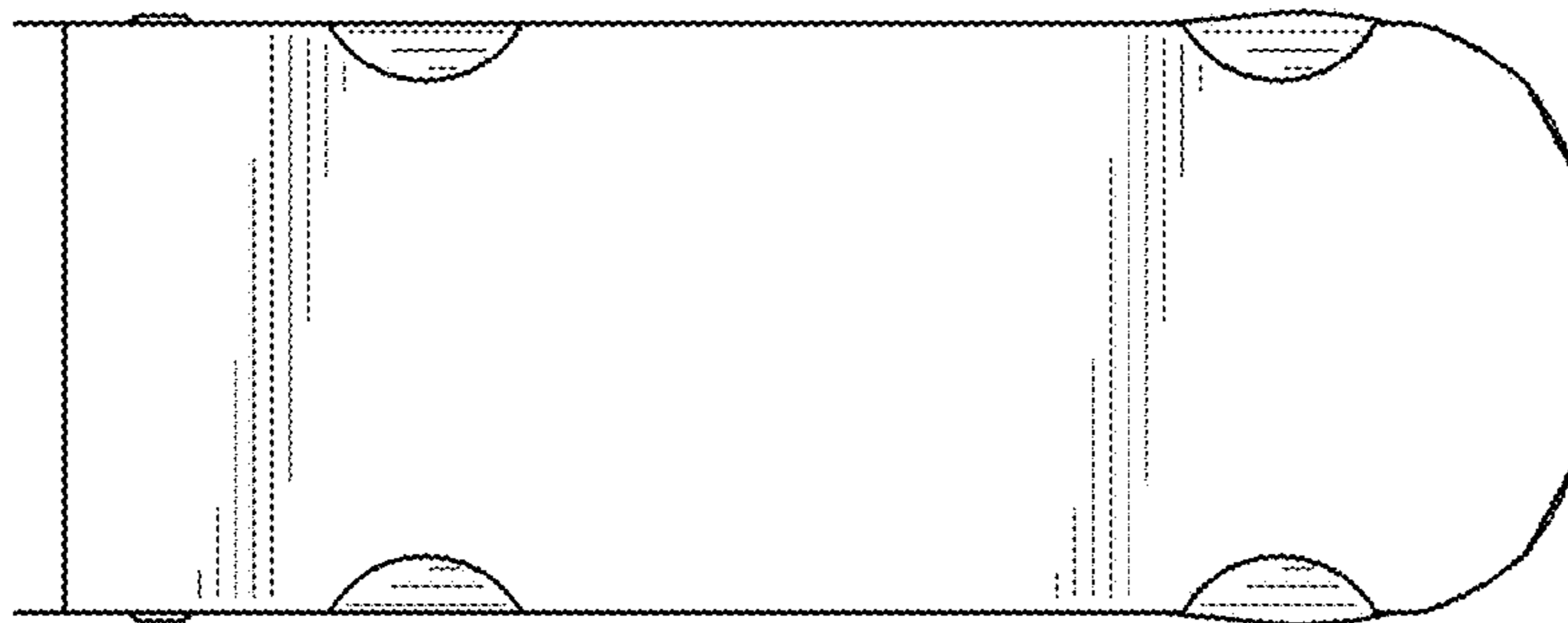

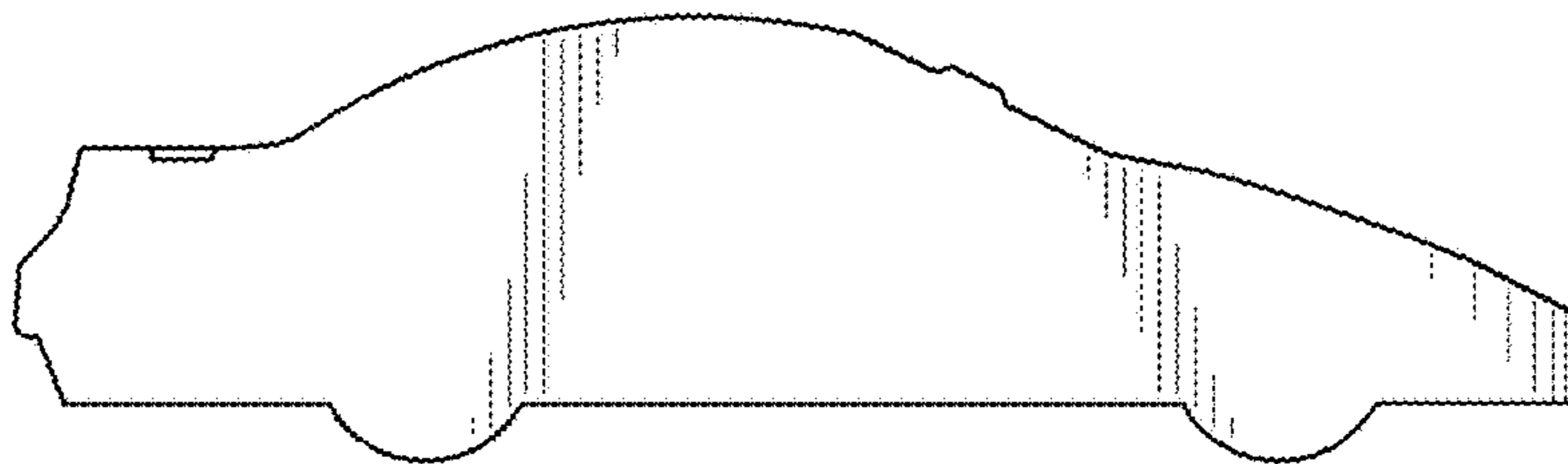

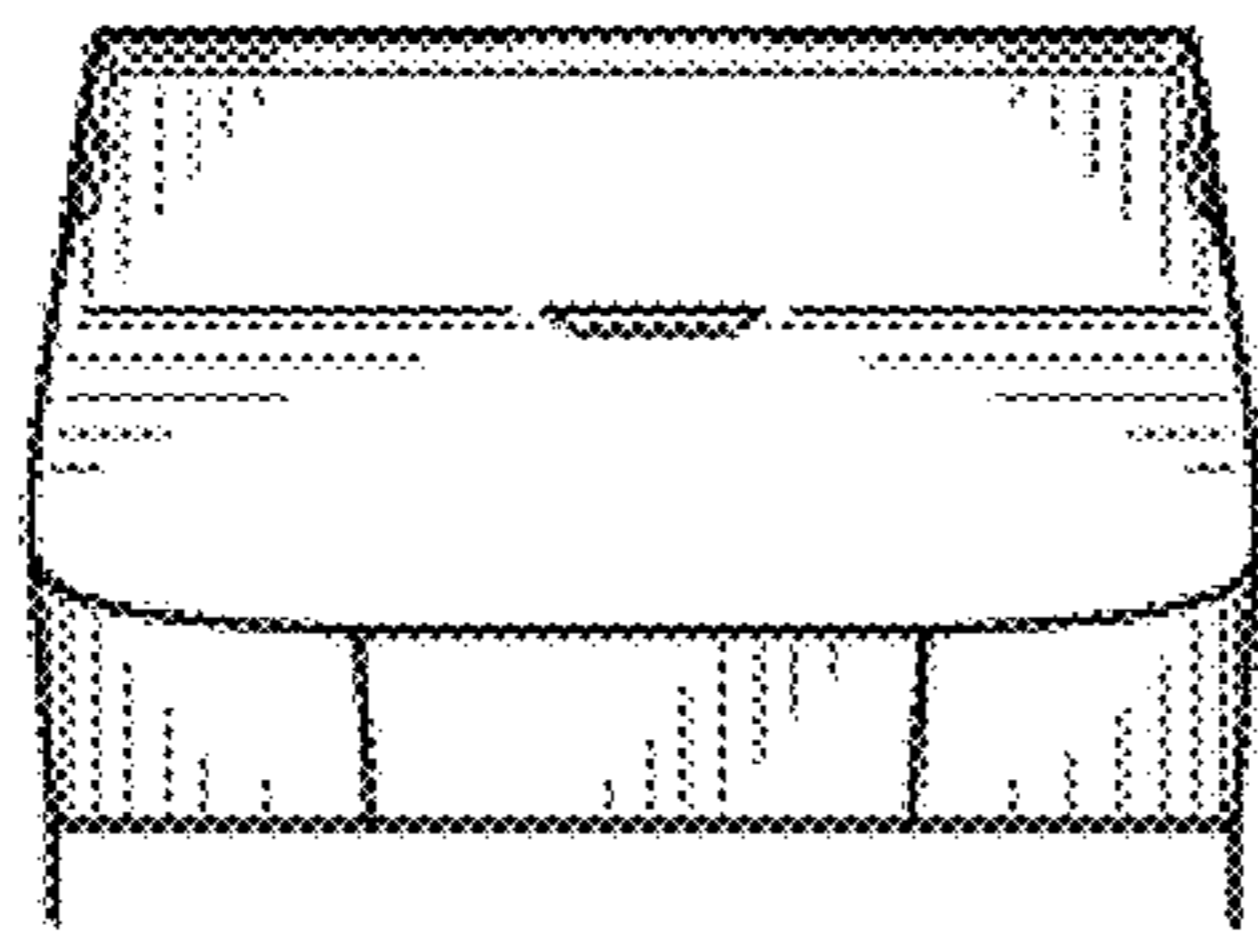

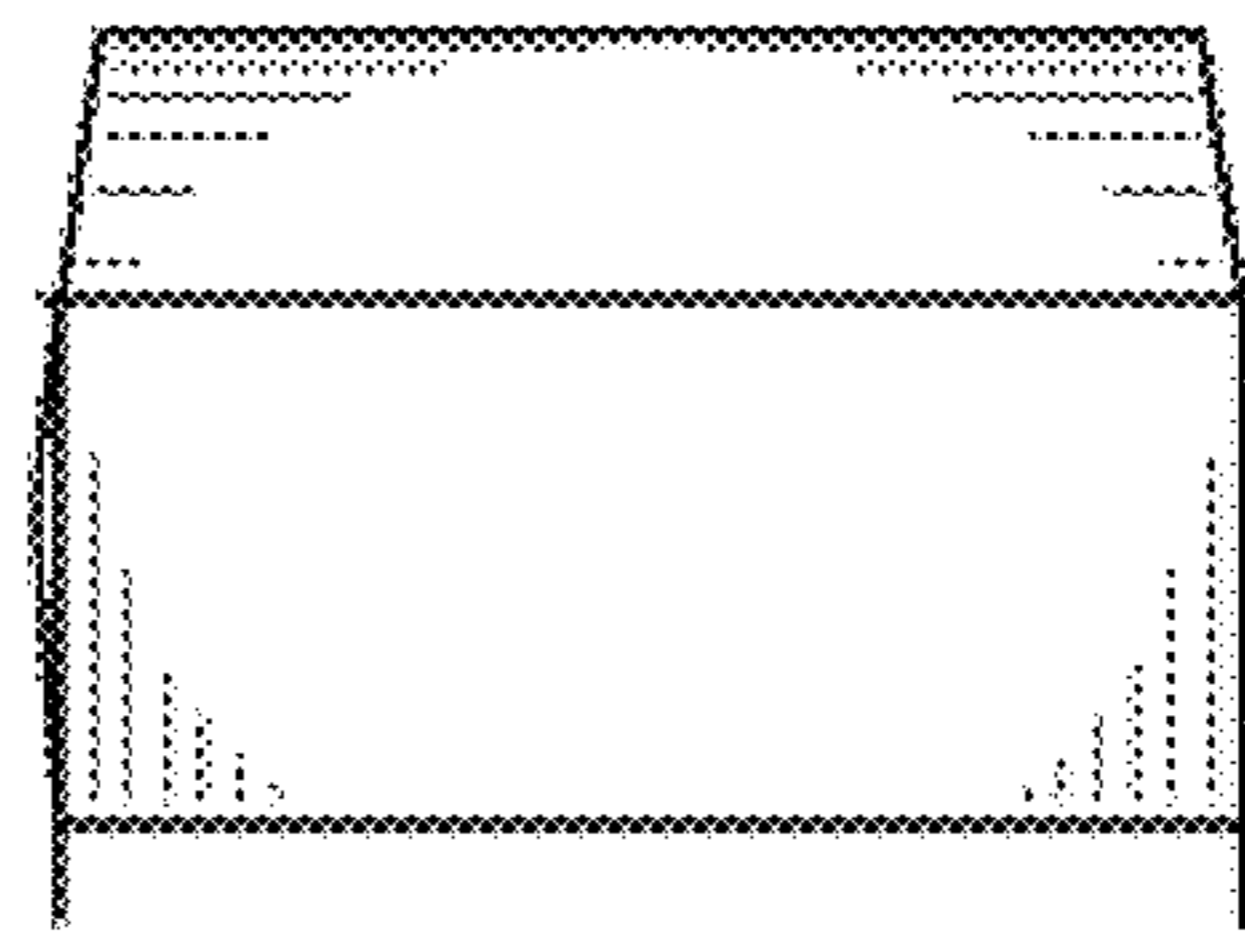

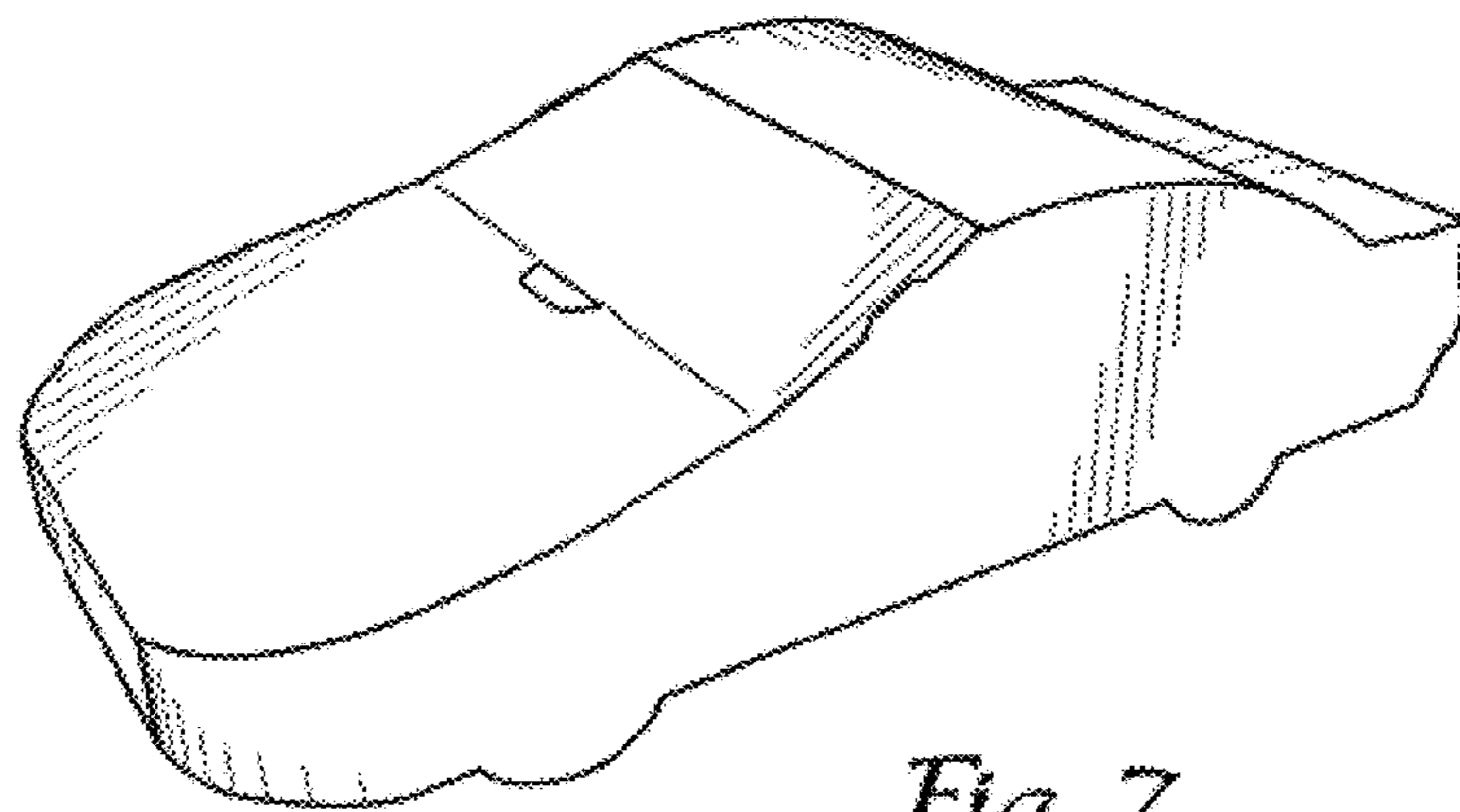
