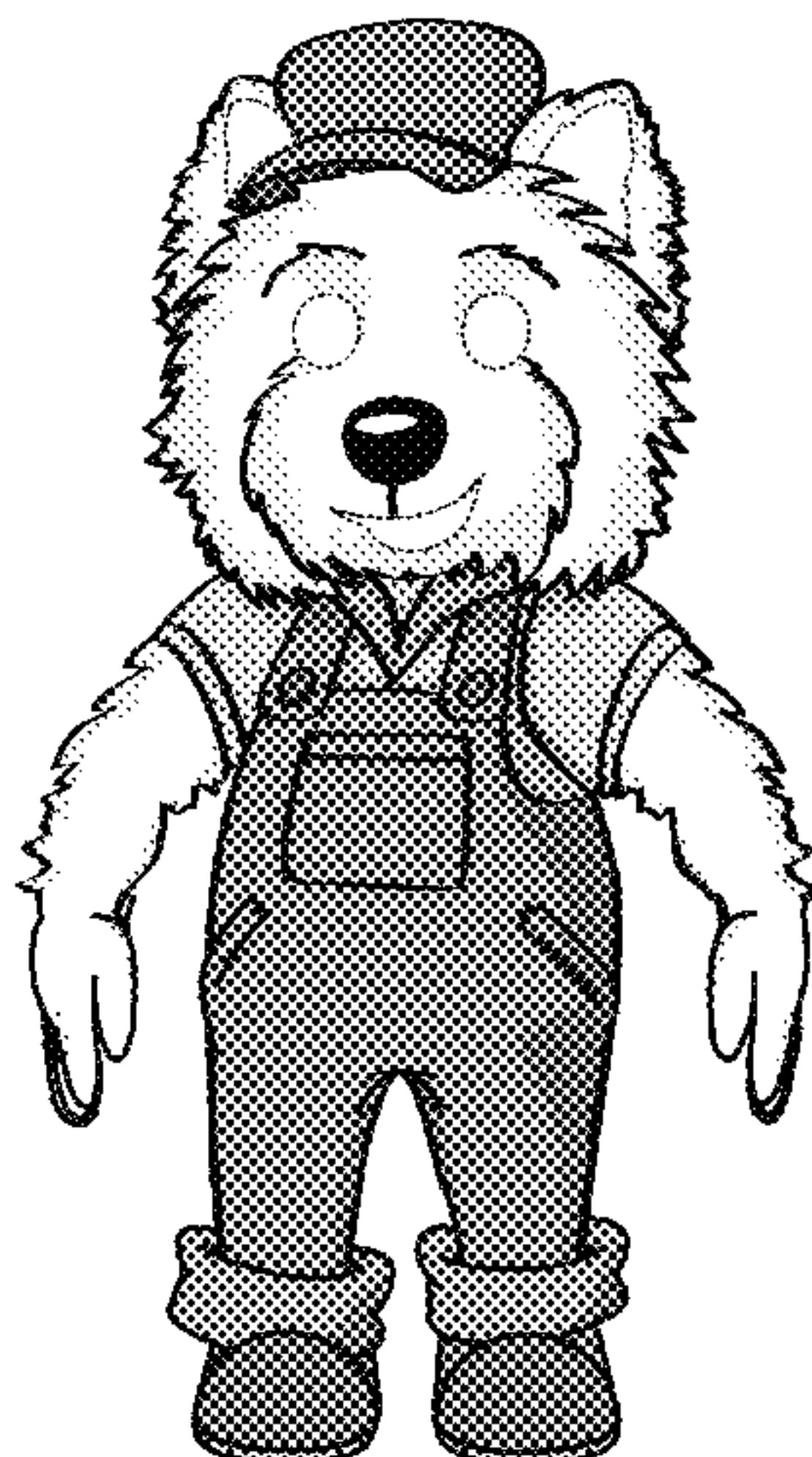
(57) **CLAIM**

The portions shown in broken lines form no part of the claimed design.

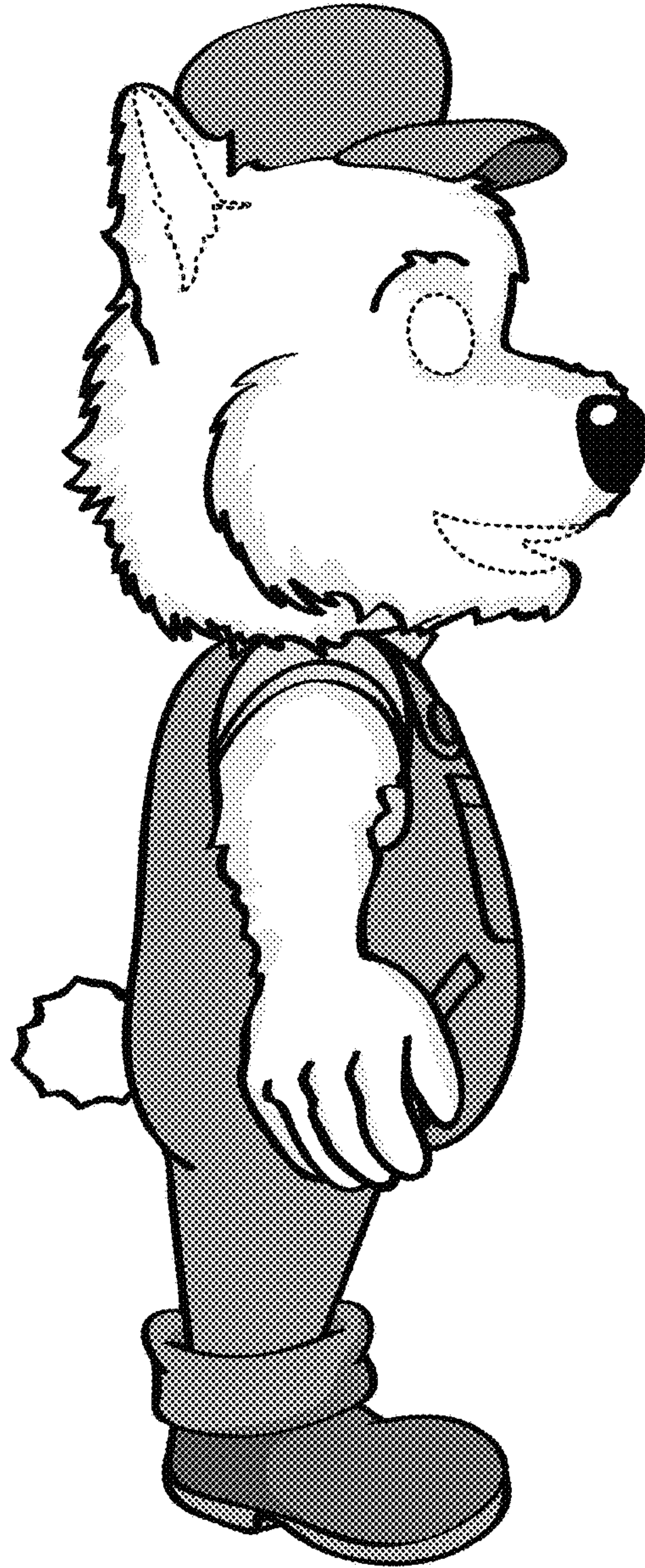

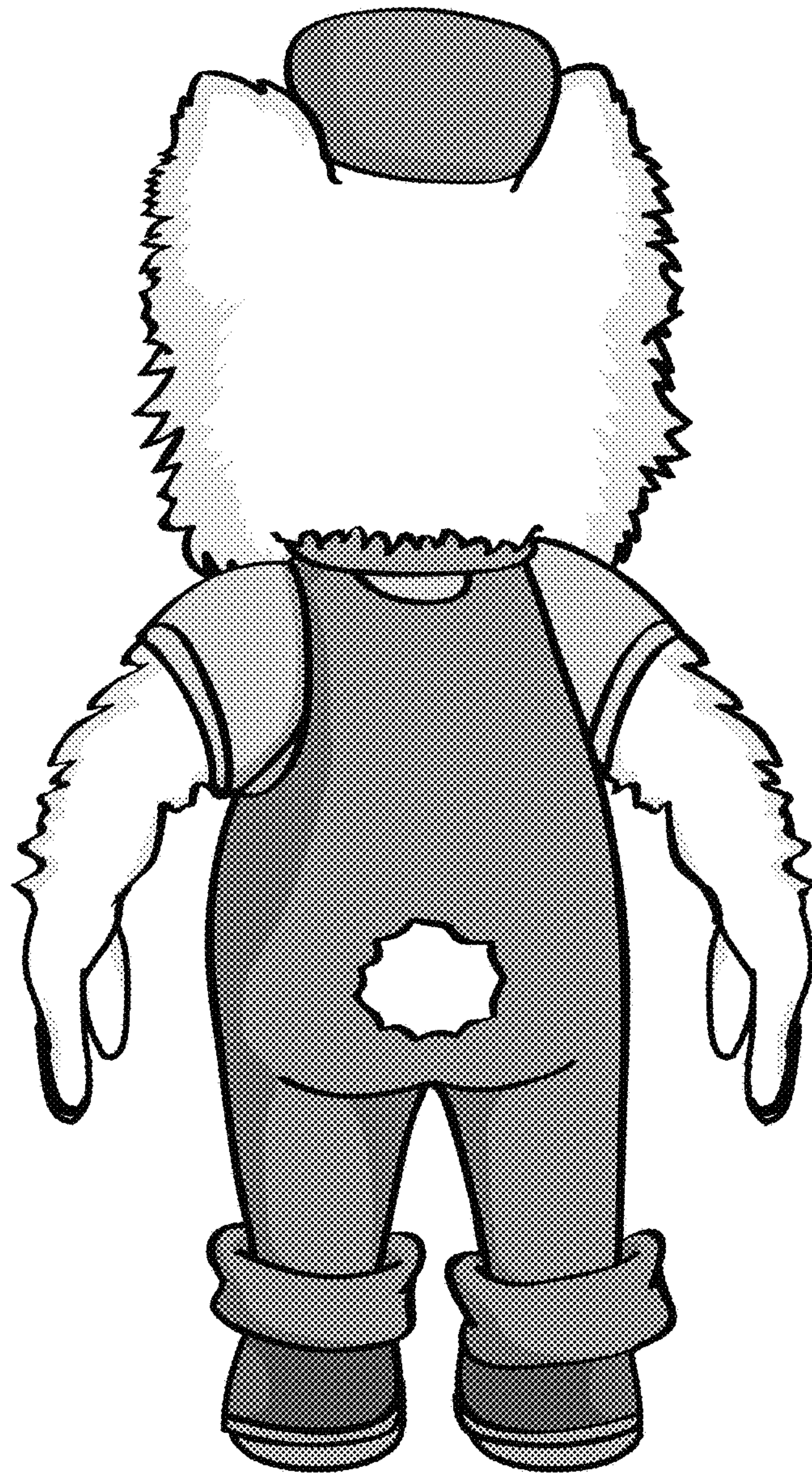
