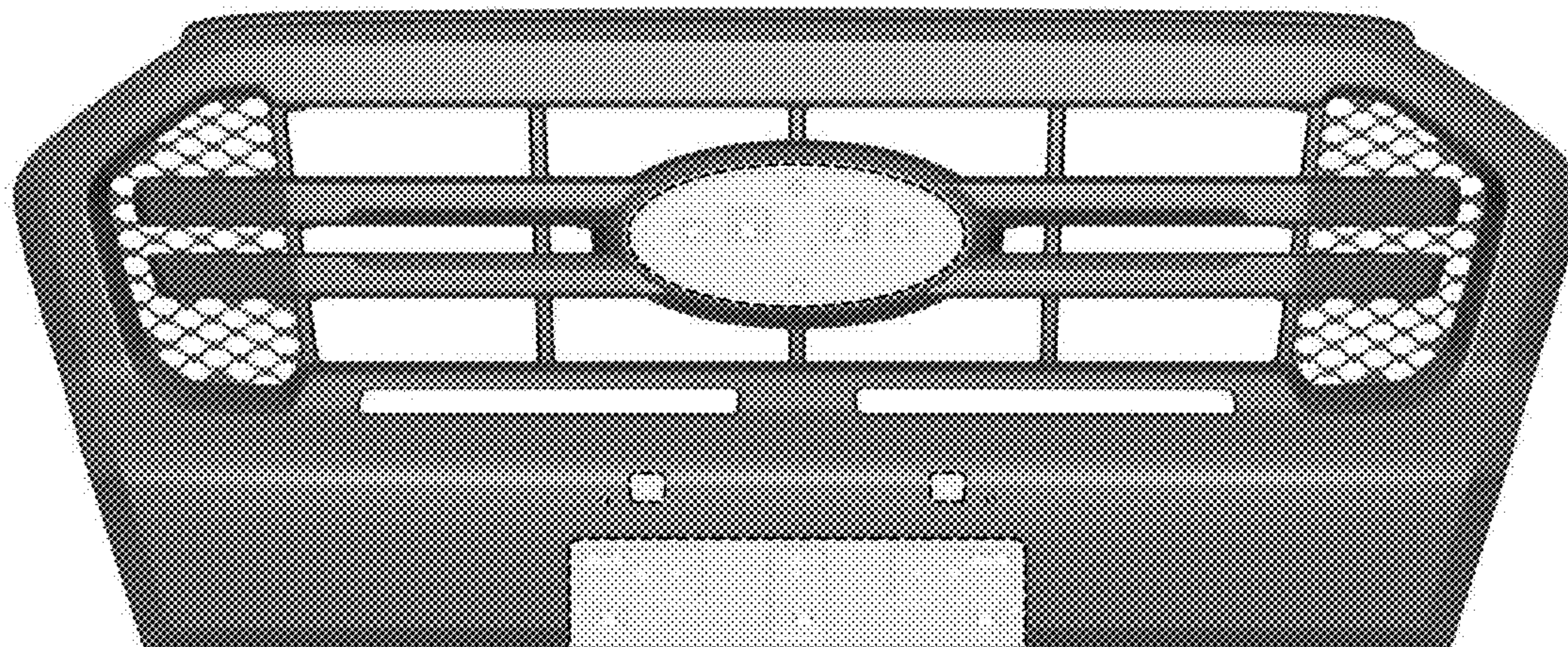

The ornamental design for a vehicle front upper grille, as shown and described.

**DESCRIPTION**  
FIG. 1 is a front elevational view of a vehicle front upper grille, showing our new design;  
FIG. 2 is a left side elevational view thereof;  
FIG. 3 is a right side elevational view thereof;  
FIG. 4 is a top plan view thereof;  
FIG. 5 is a bottom plan view thereof;  
FIG. 6 is a top, front, and left side perspective view thereof;  
and,  
FIG. 7 is a bottom, front, and left side perspective view thereof.  
Evenly-spaced broken lines represent the boundaries of the claimed design. Neither the broken line itself nor any areas shown in half-tone shading outside the broken line boundaries form any part of the claimed design.

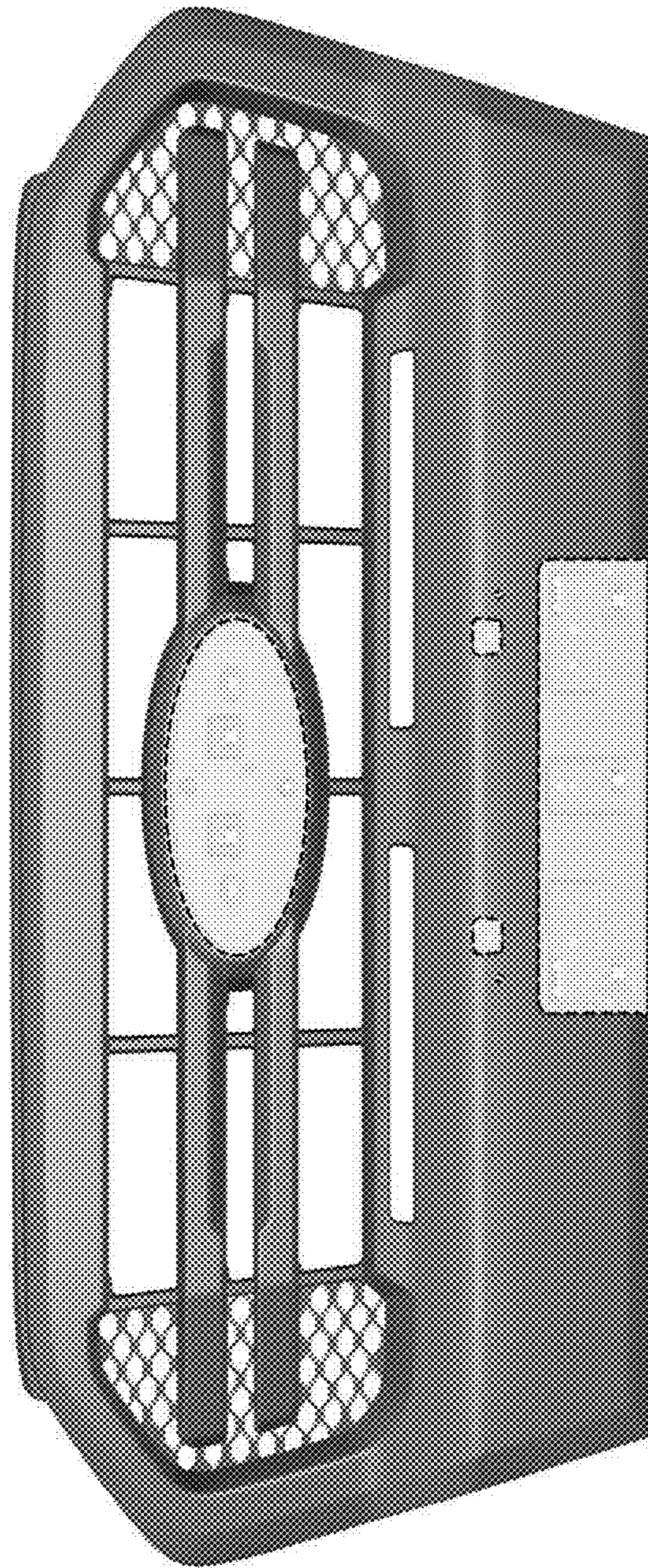

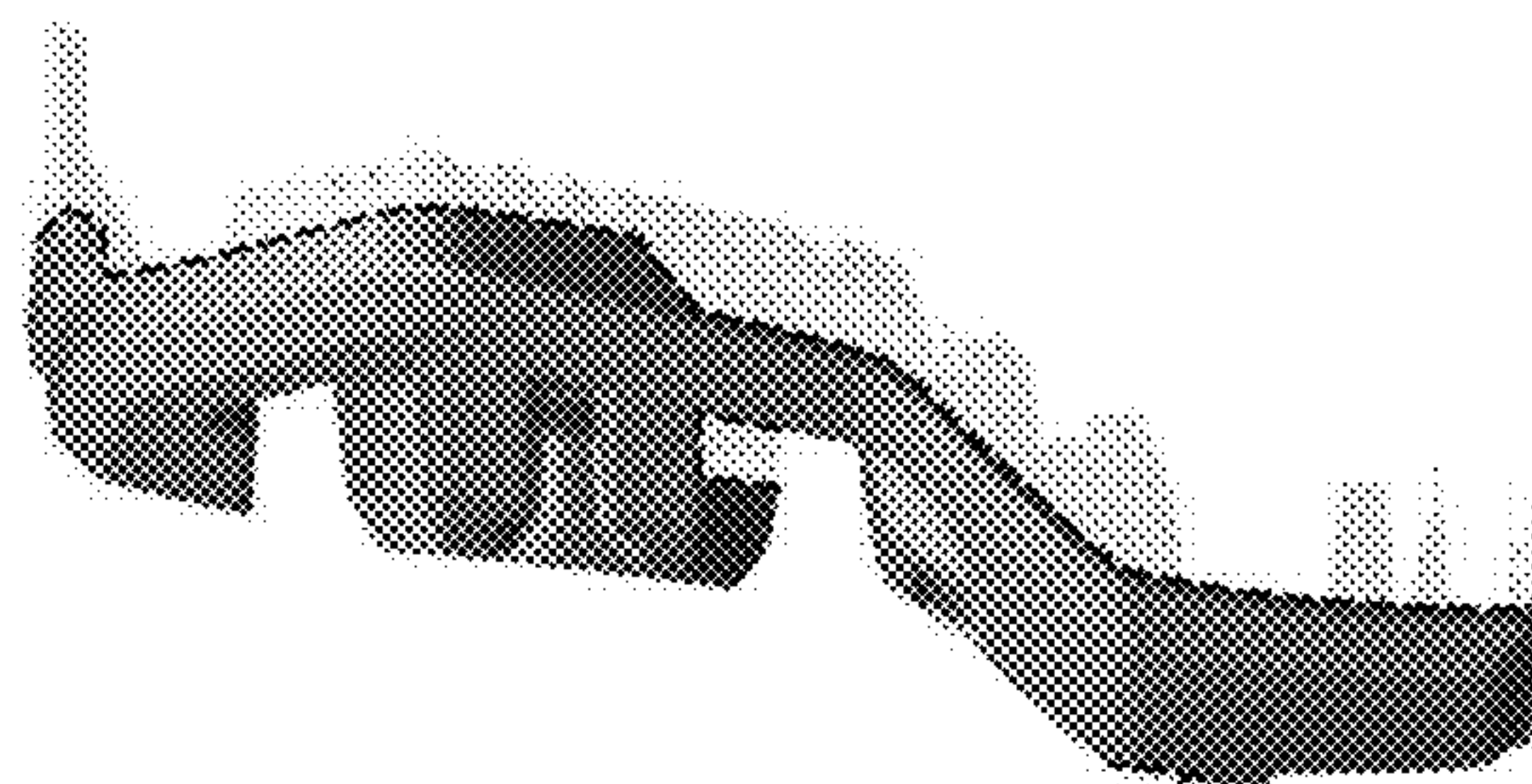

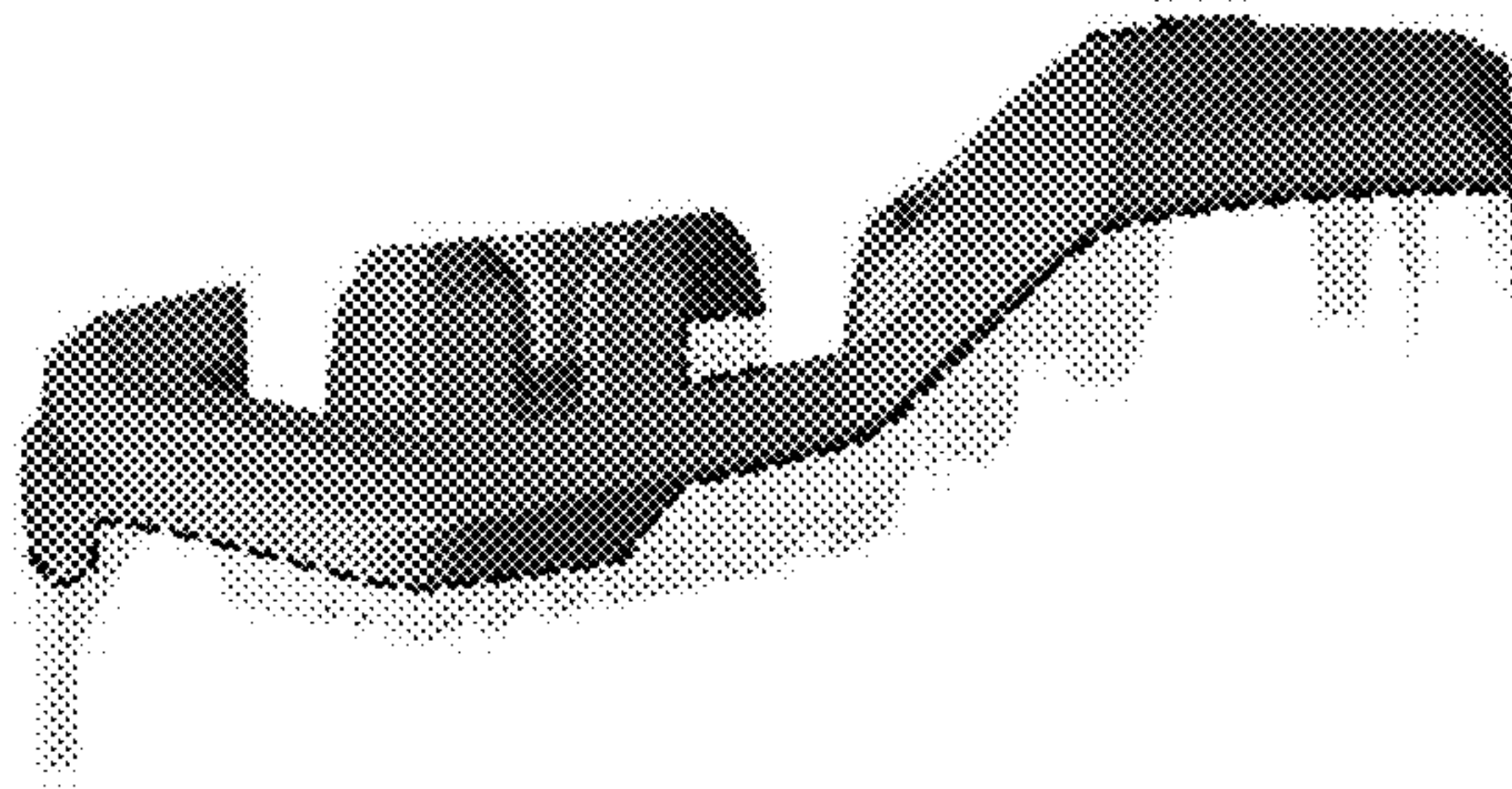

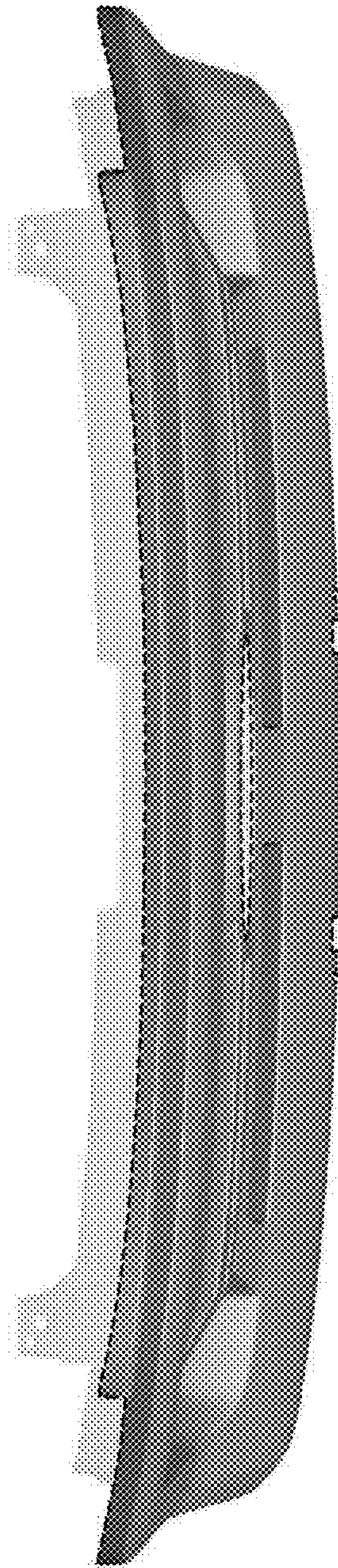

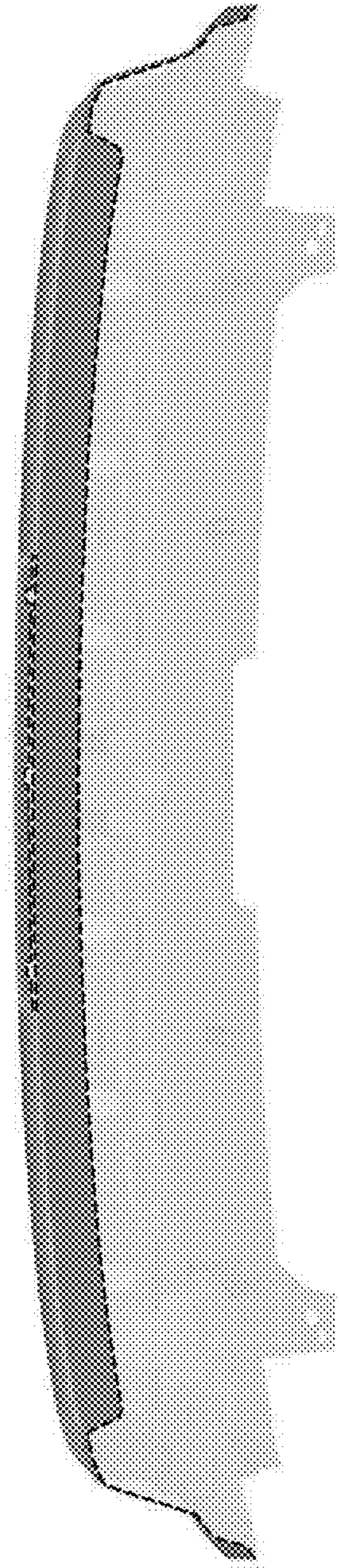

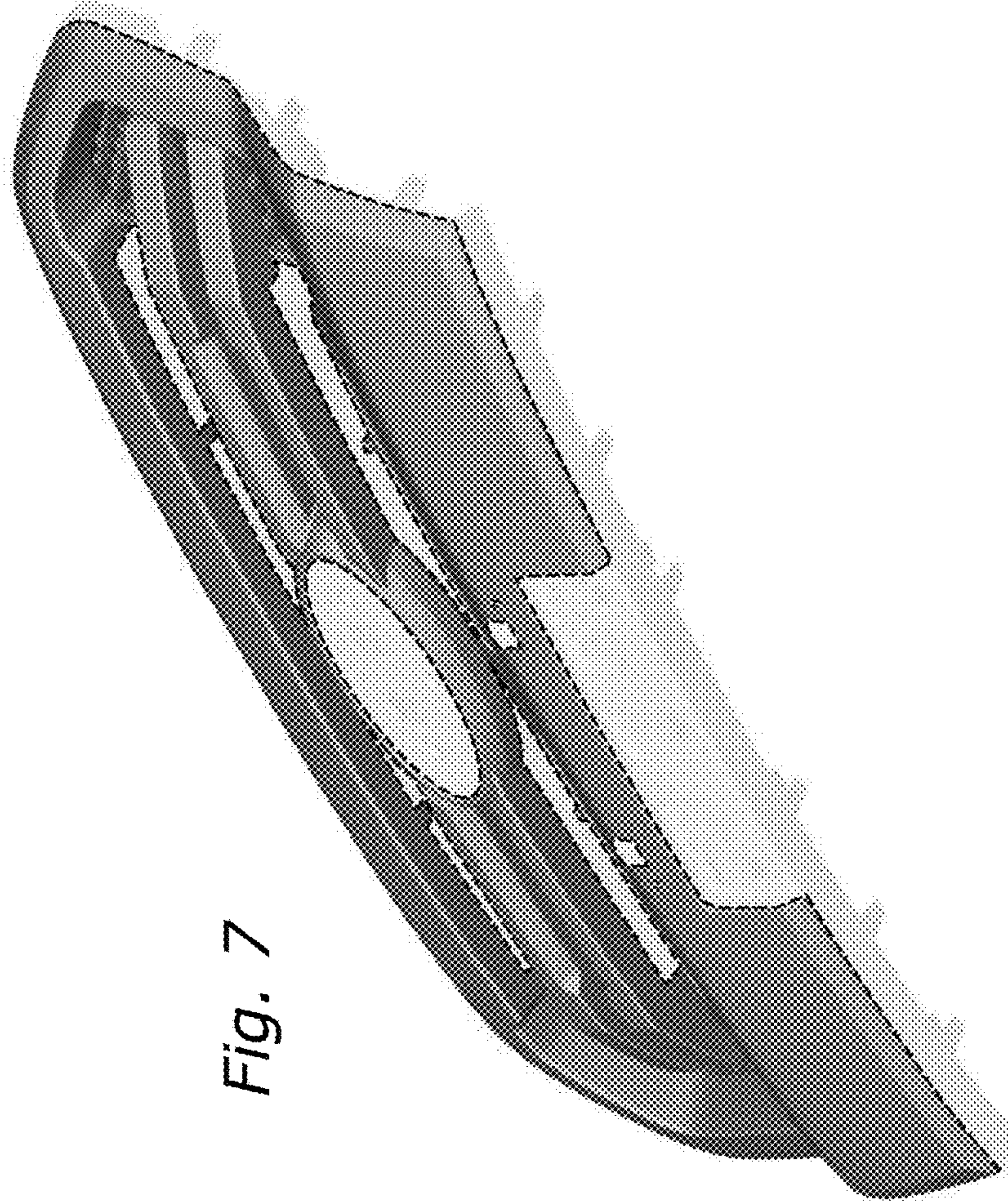
