1.4 : Left

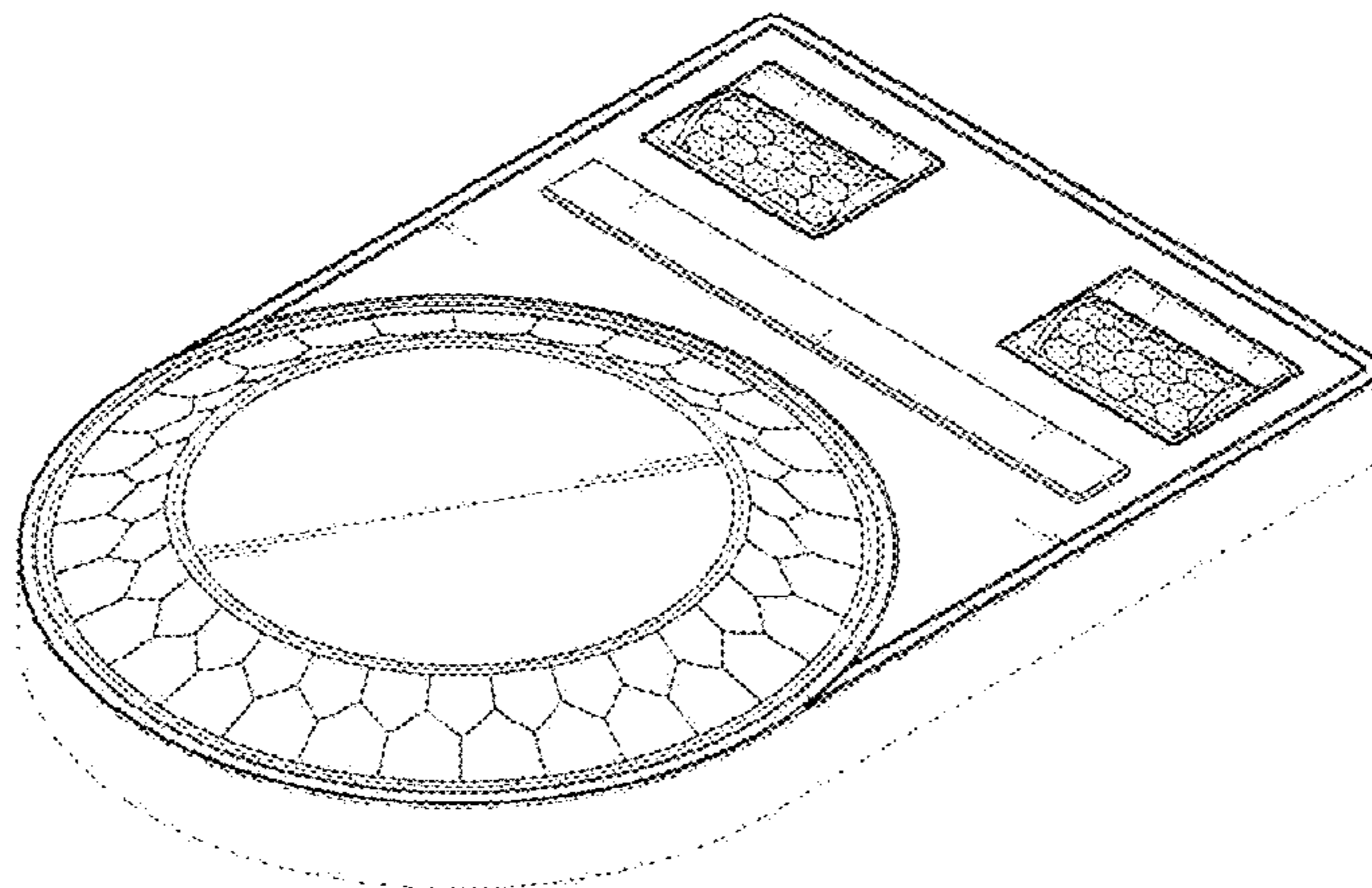

1.6 : Bottom

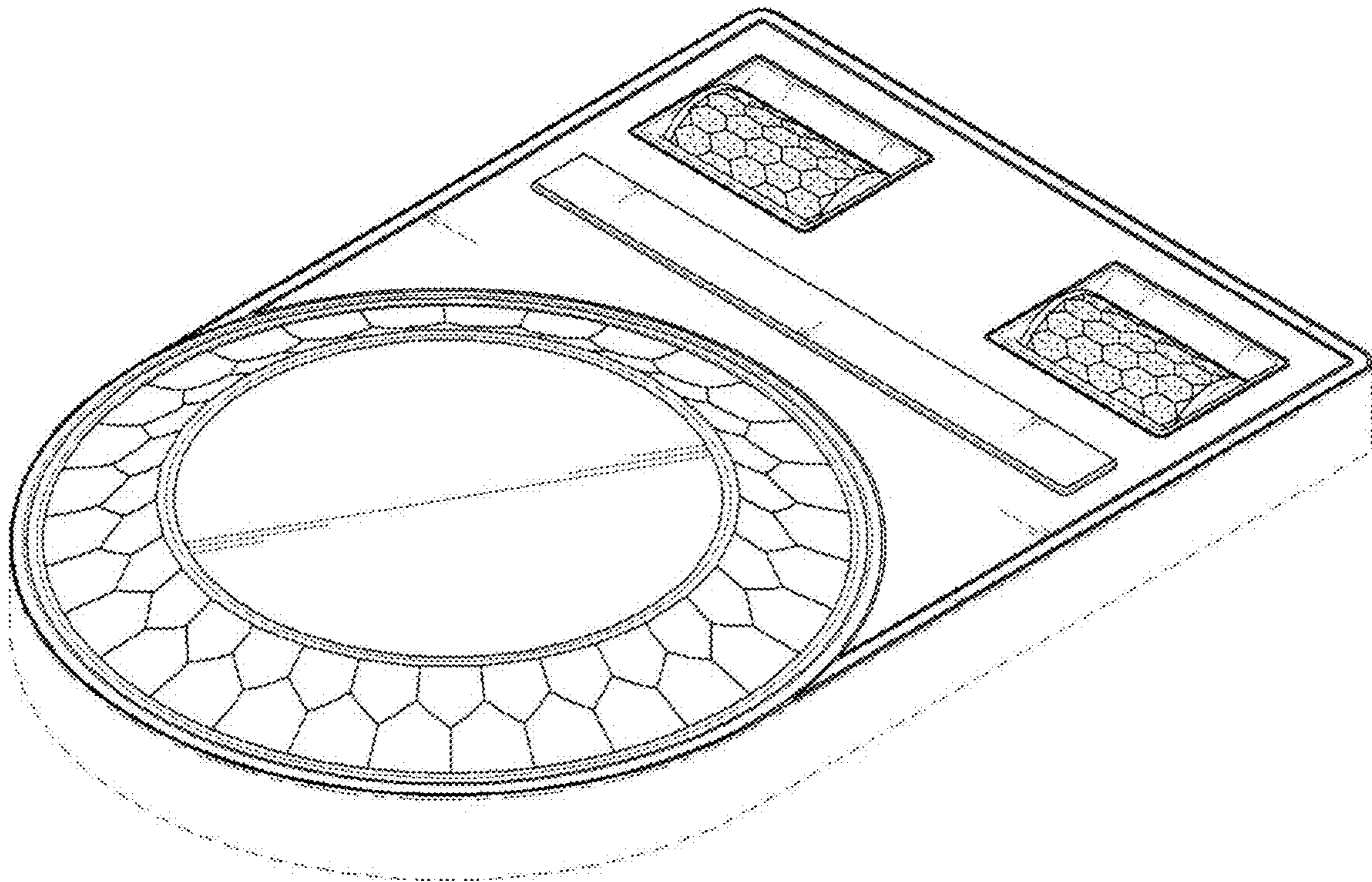
1.7 : Reference photo

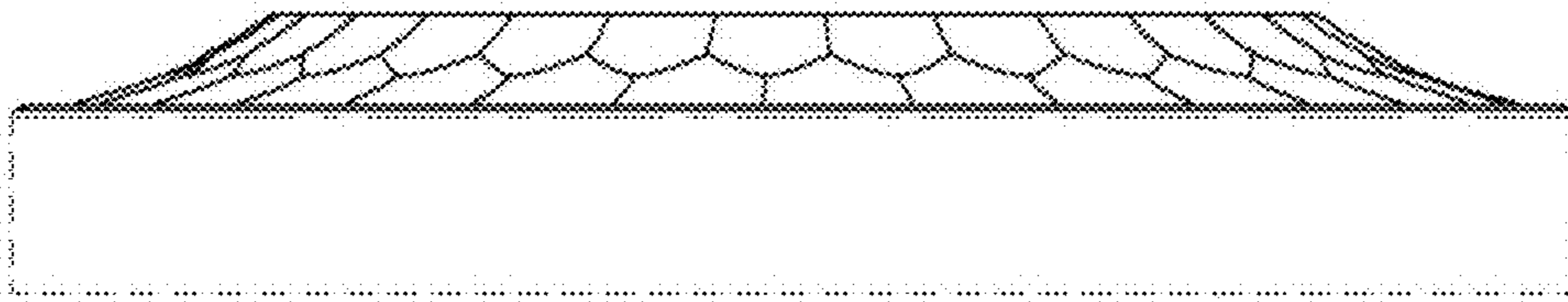

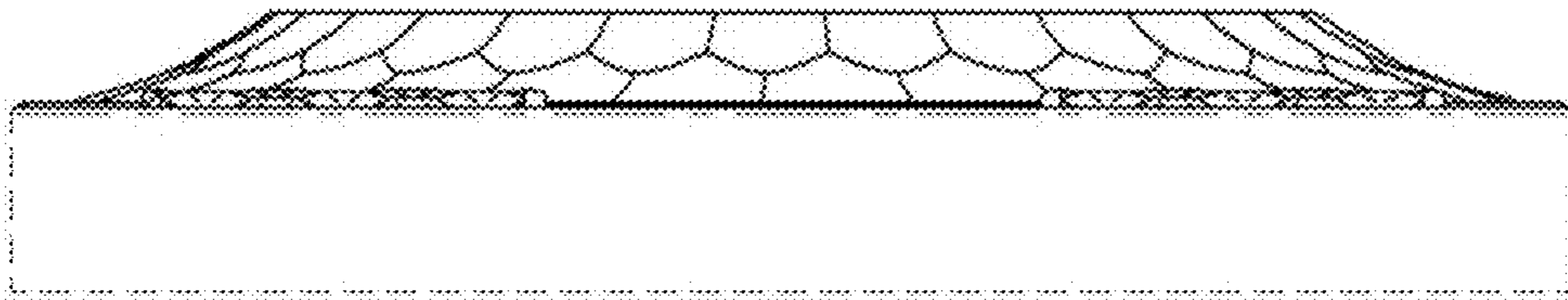

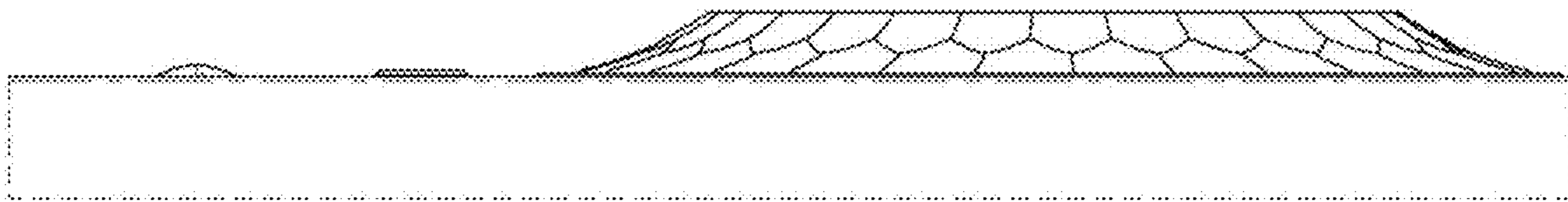

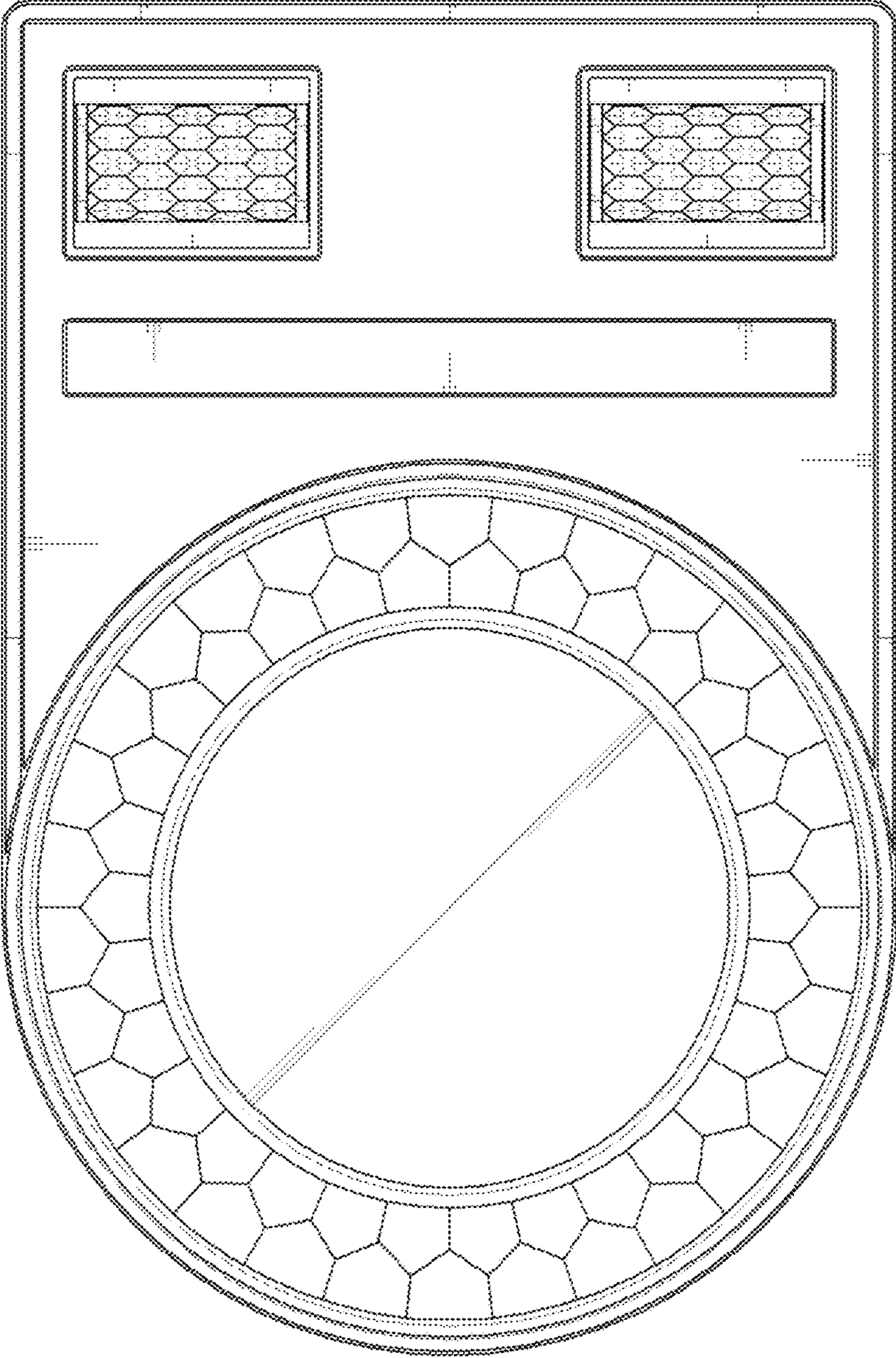

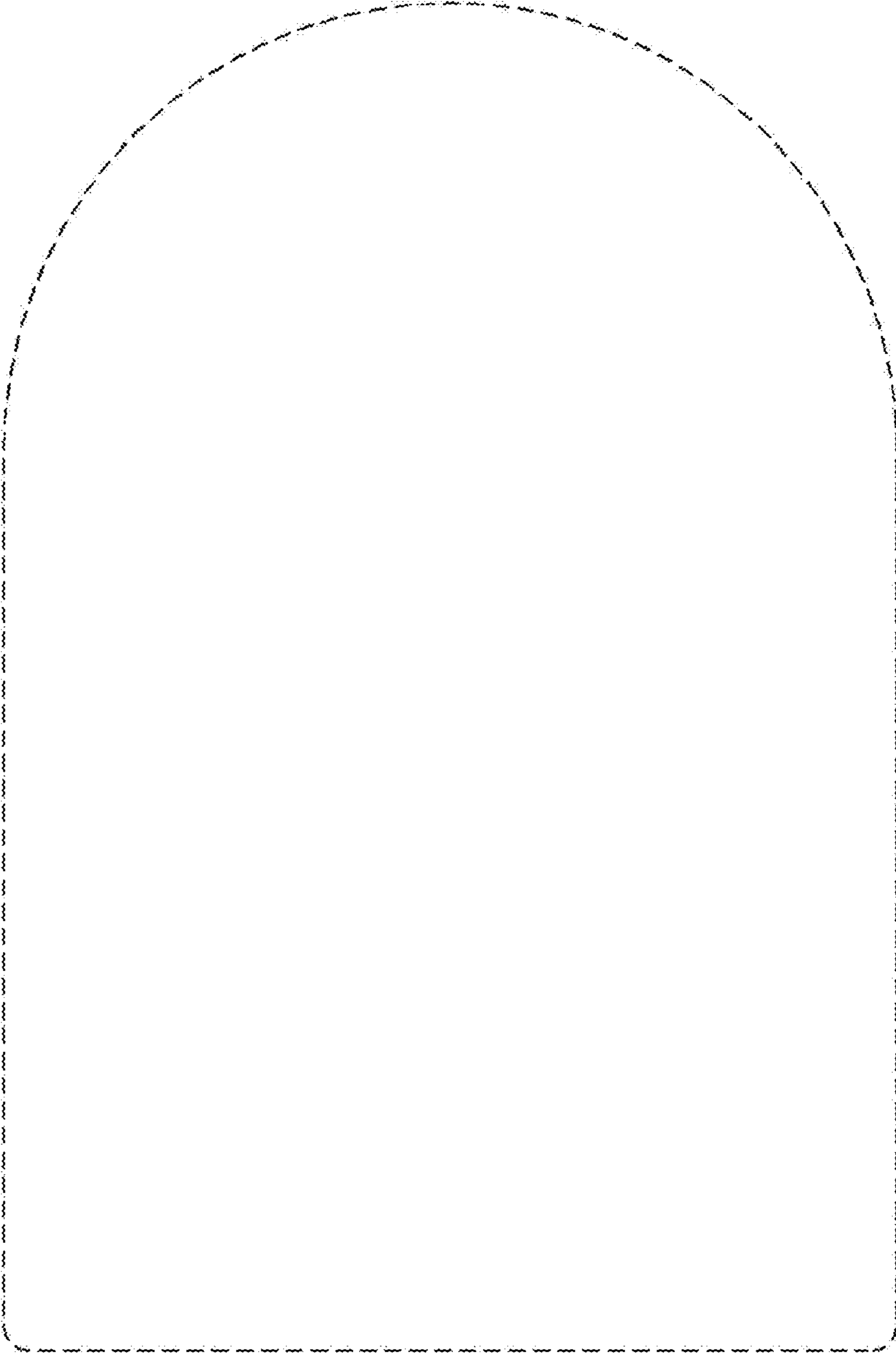
