FIG. 10 is a partially enlarged view of part III of the wireless earphone as shown in FIG. 1.

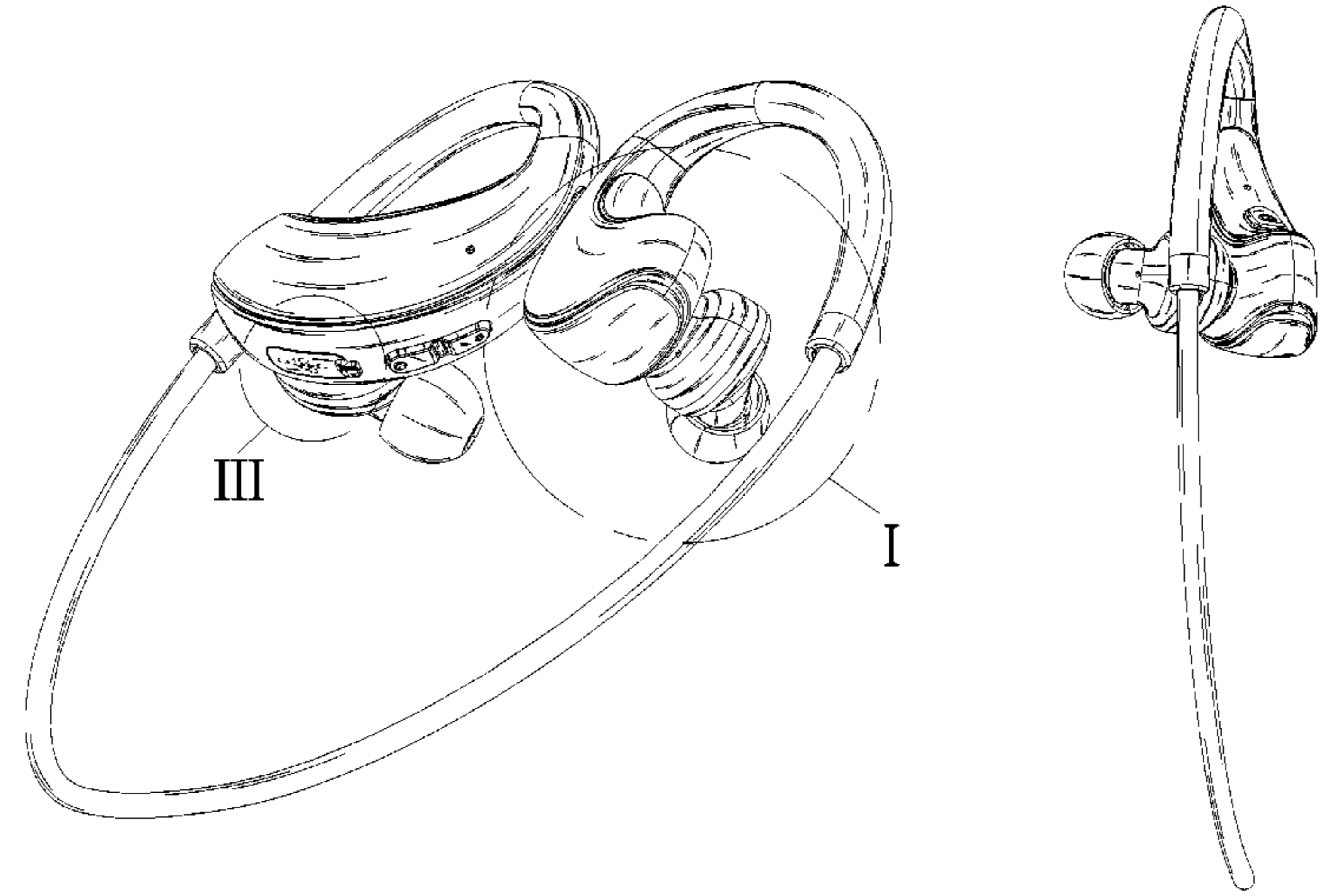

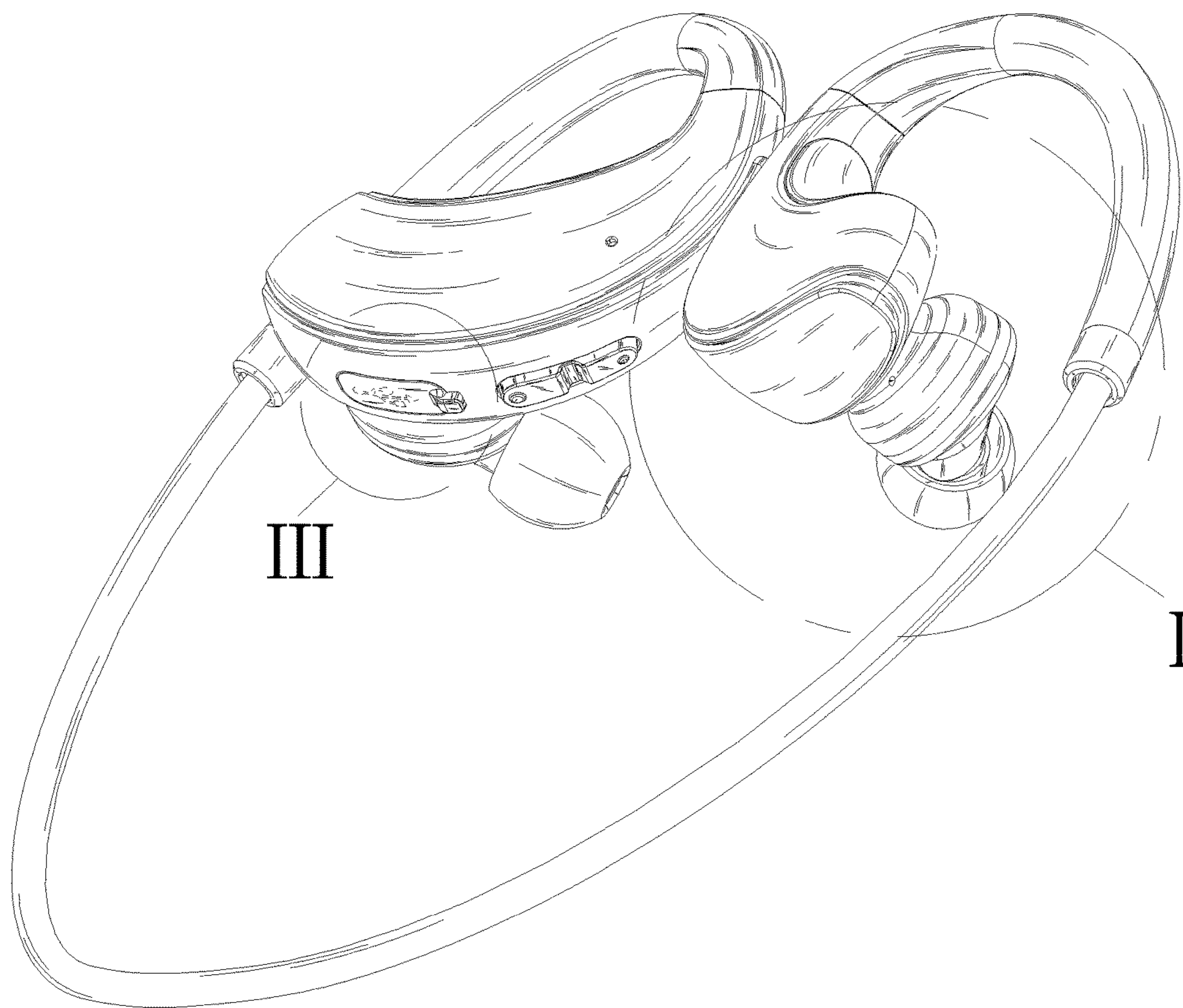

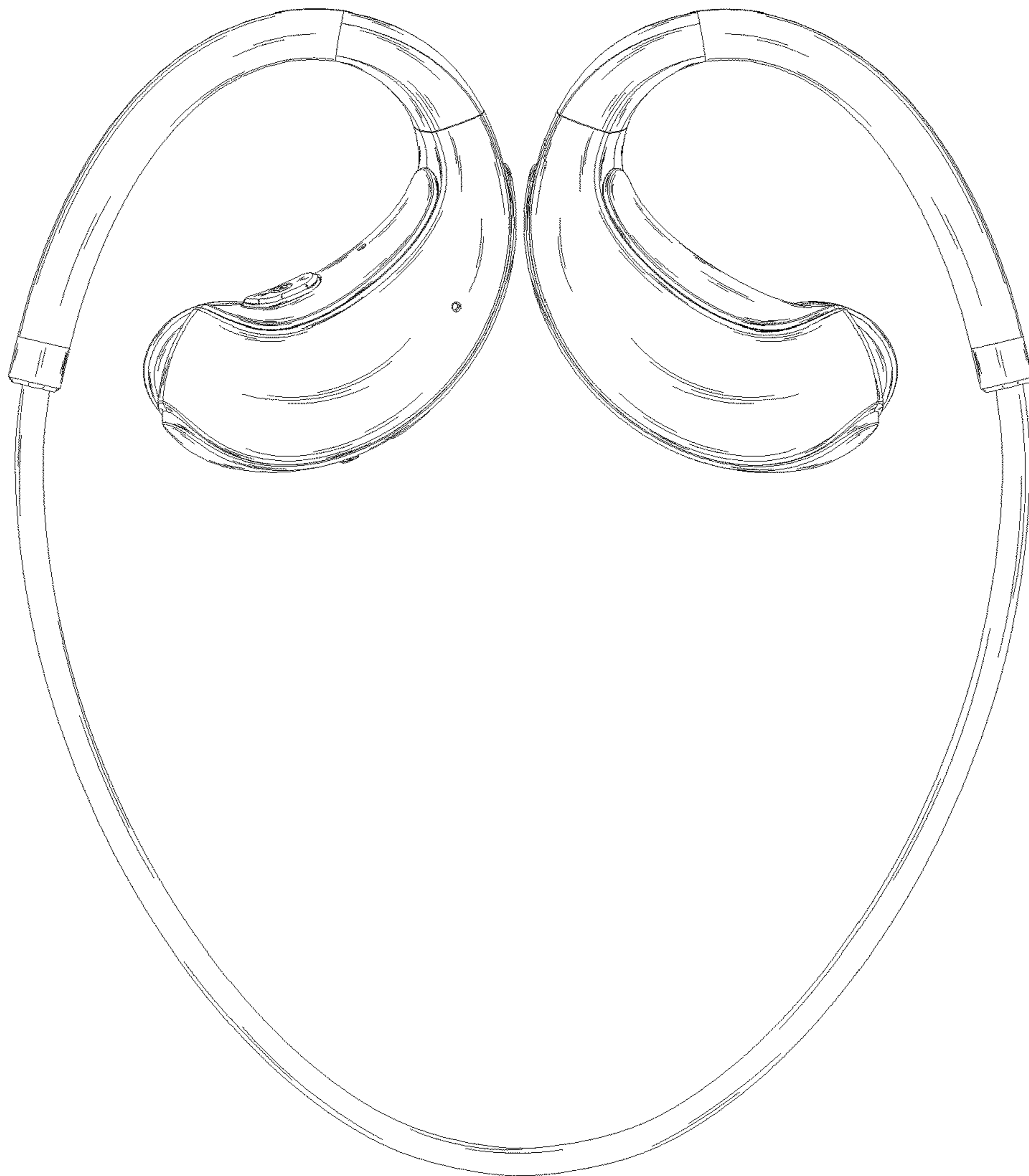

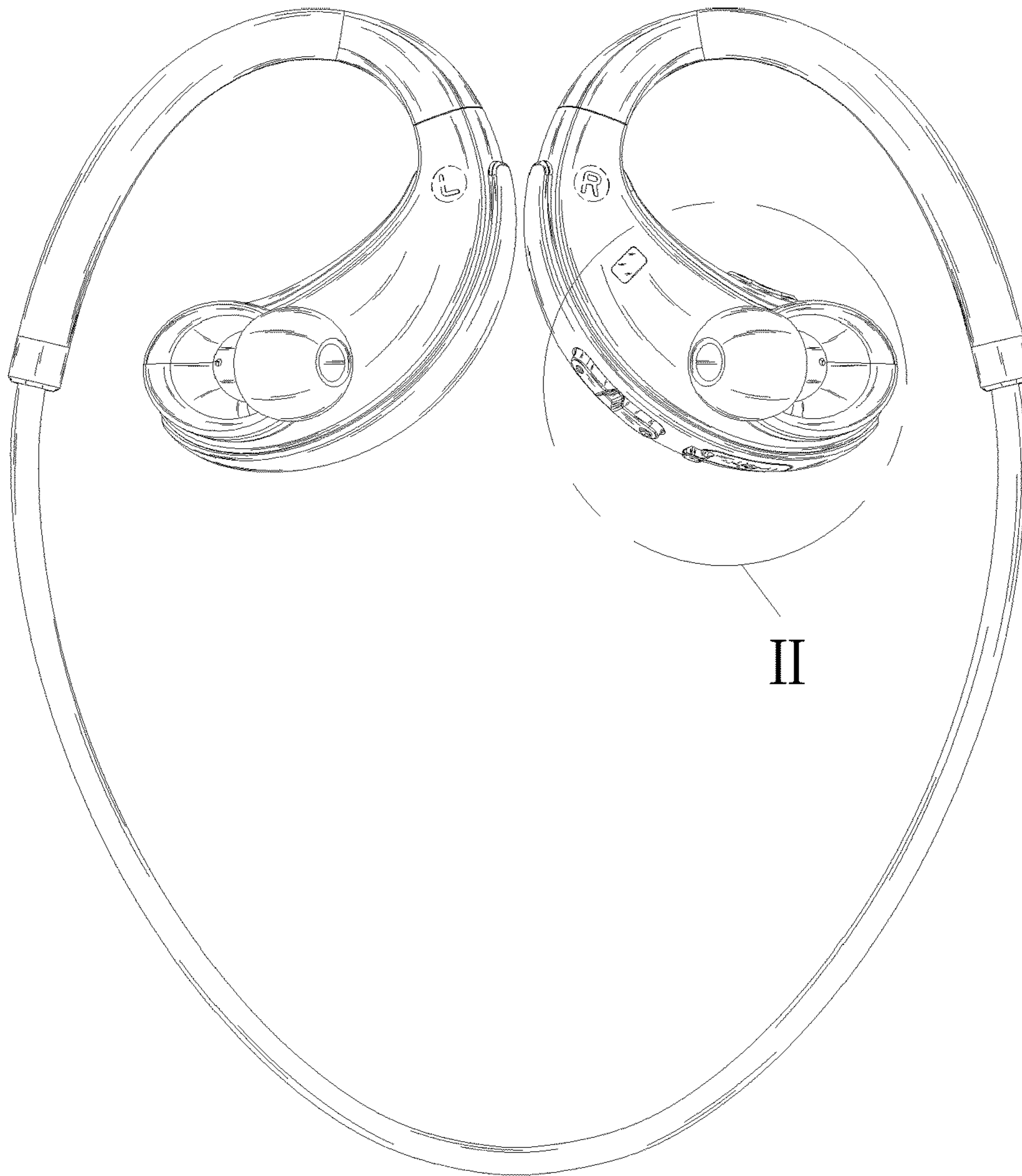

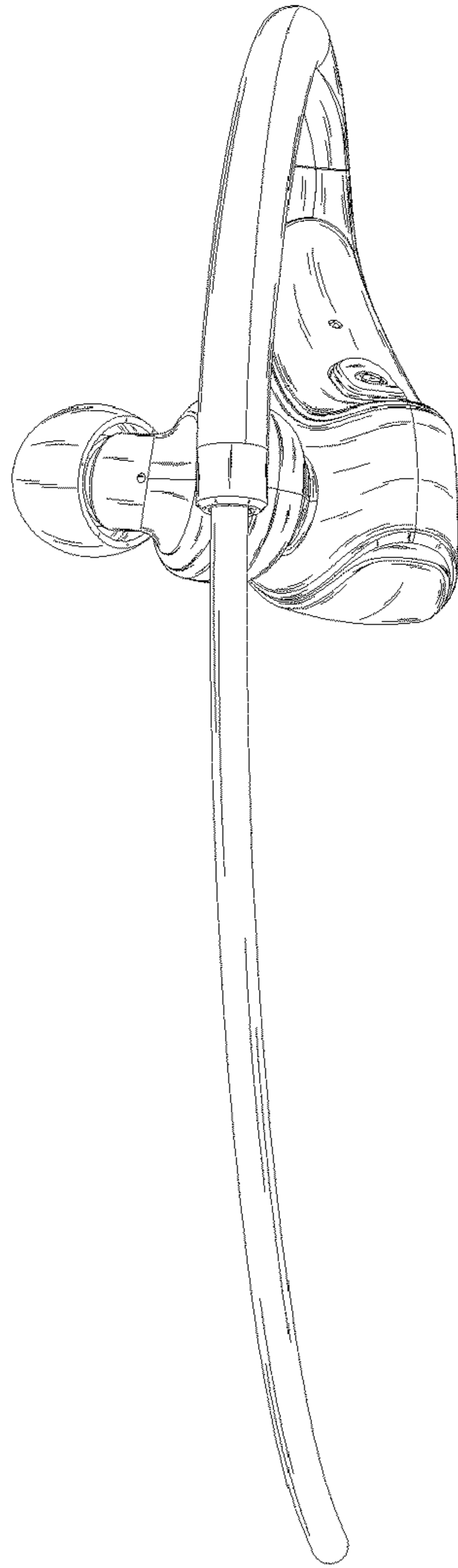

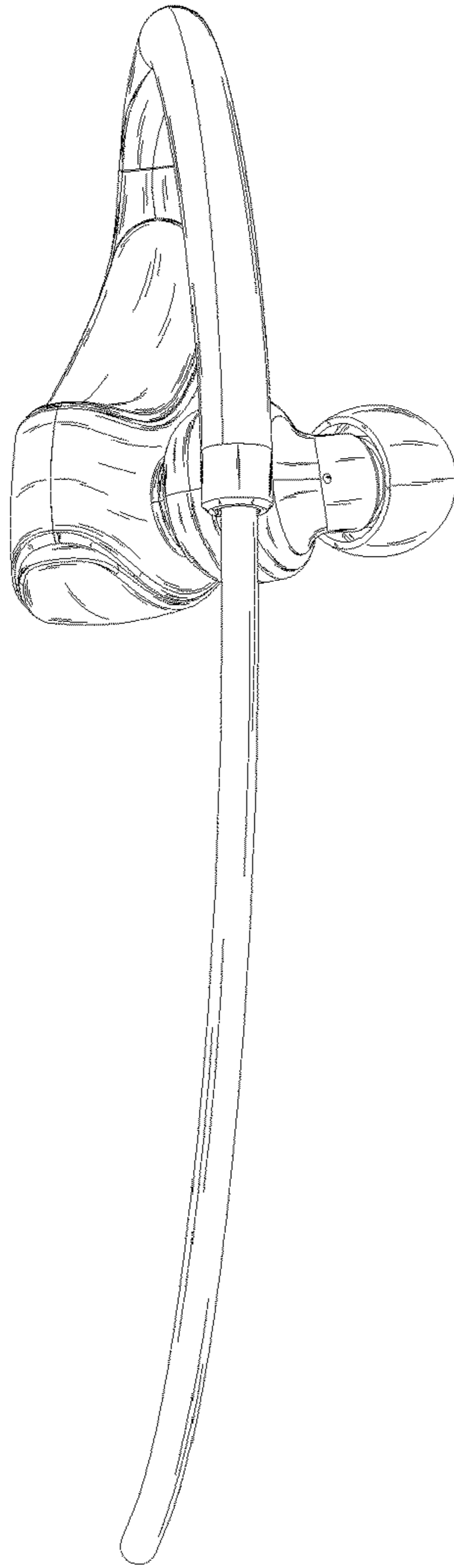

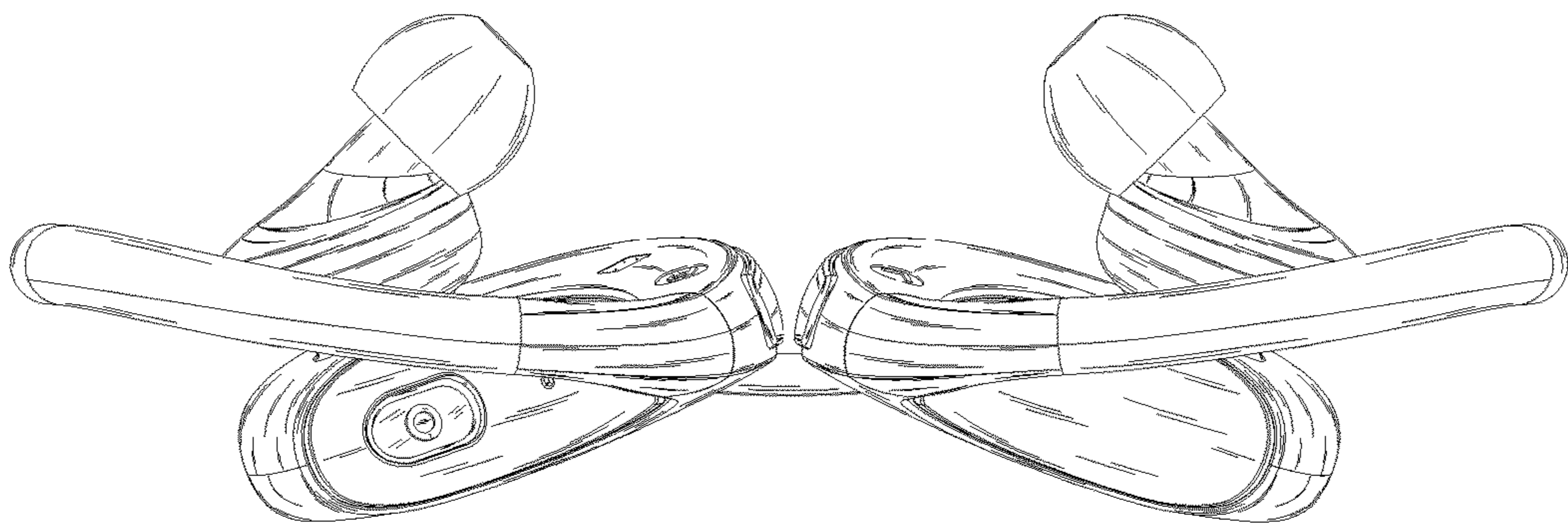

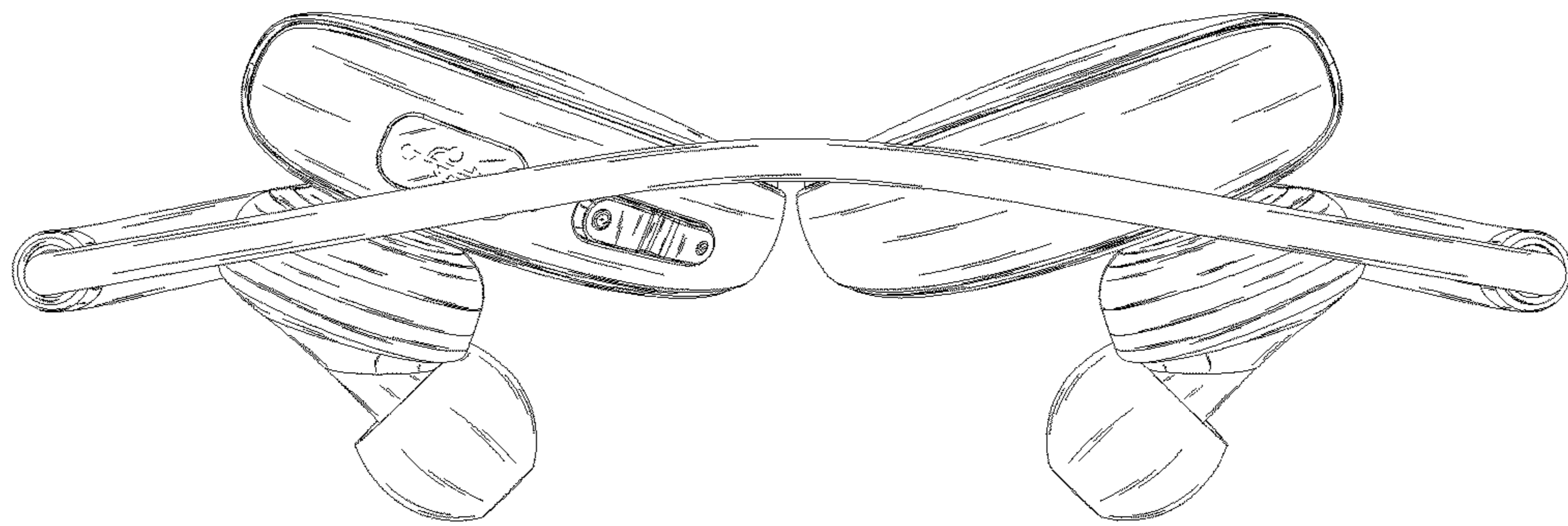

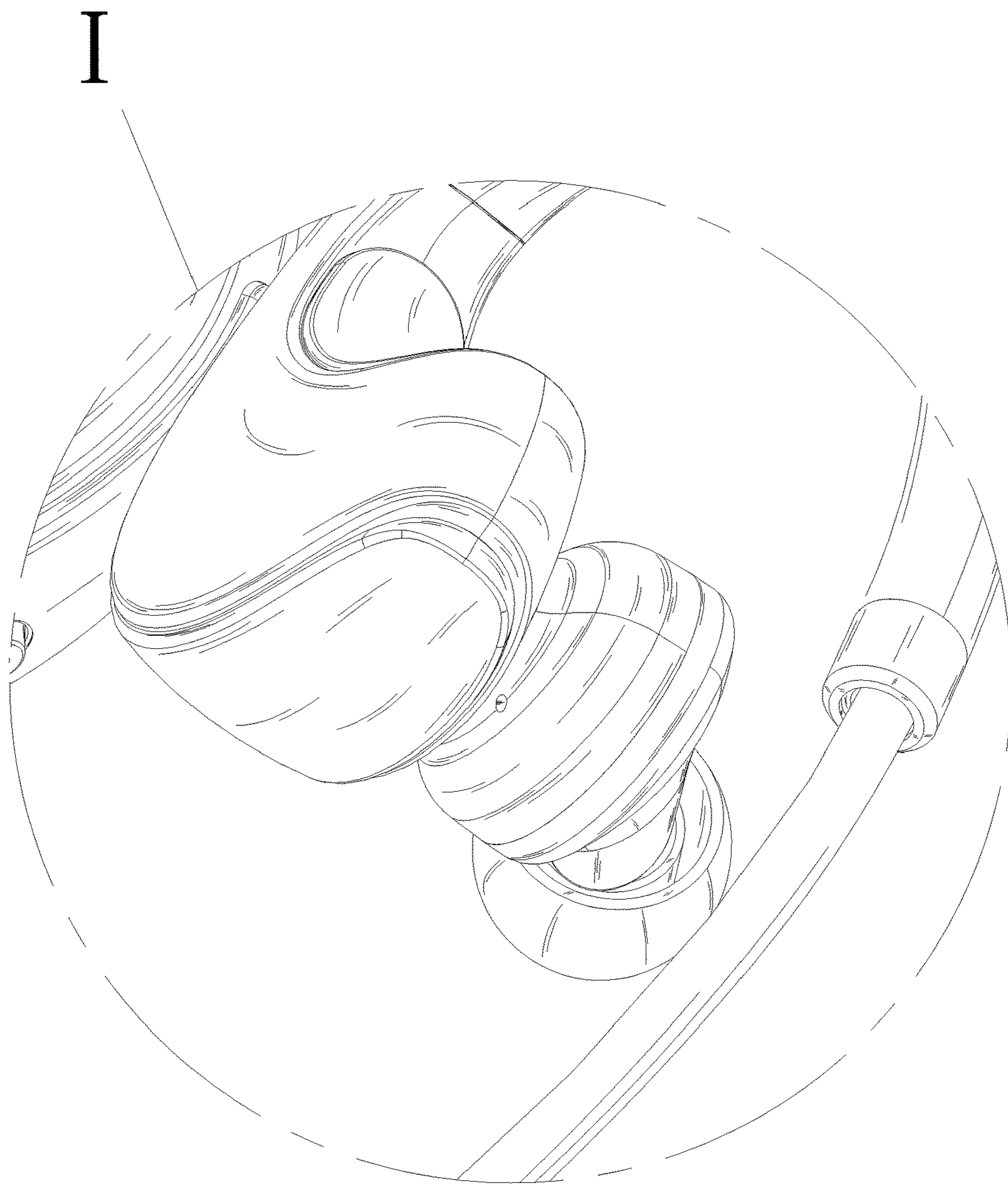

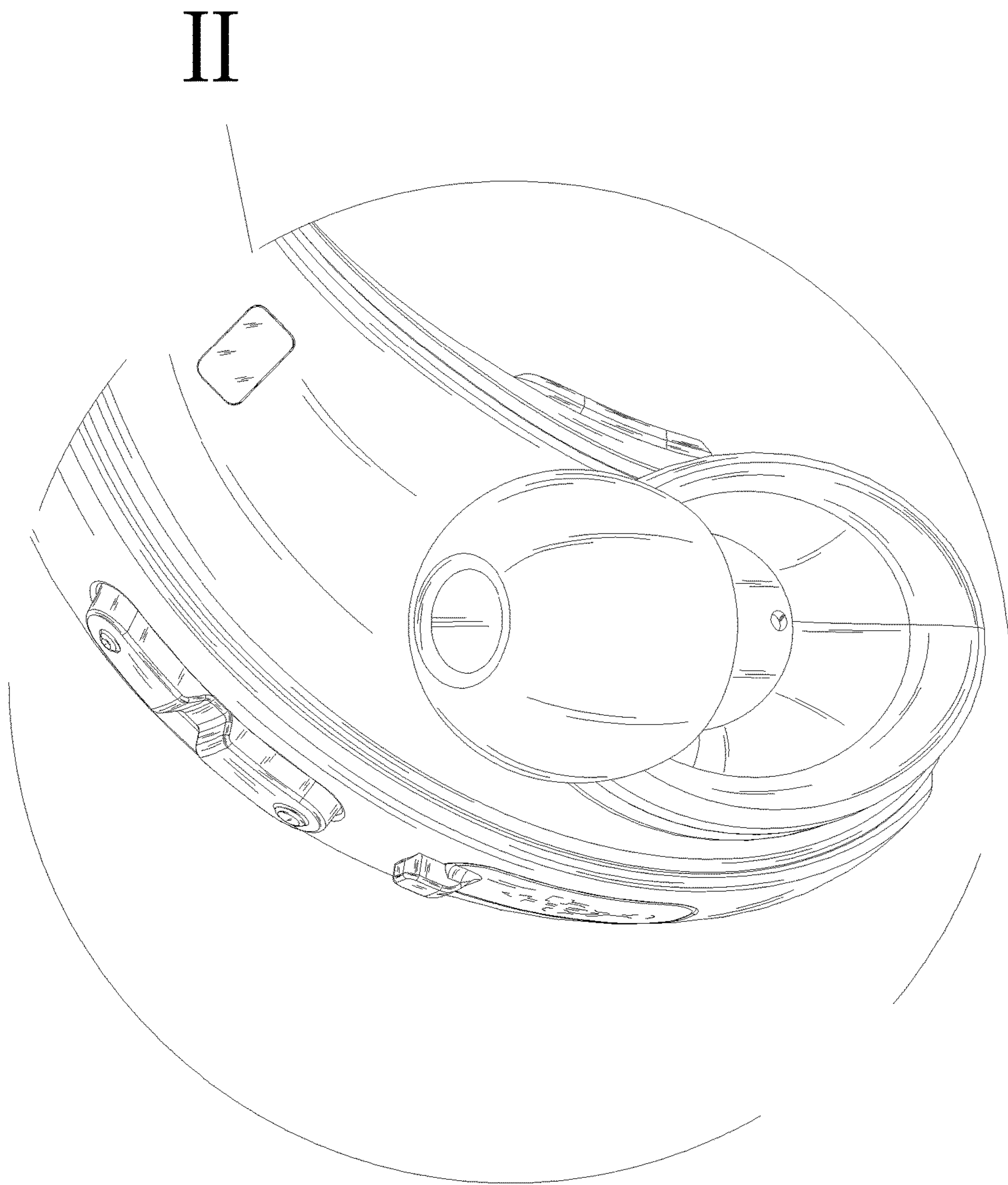
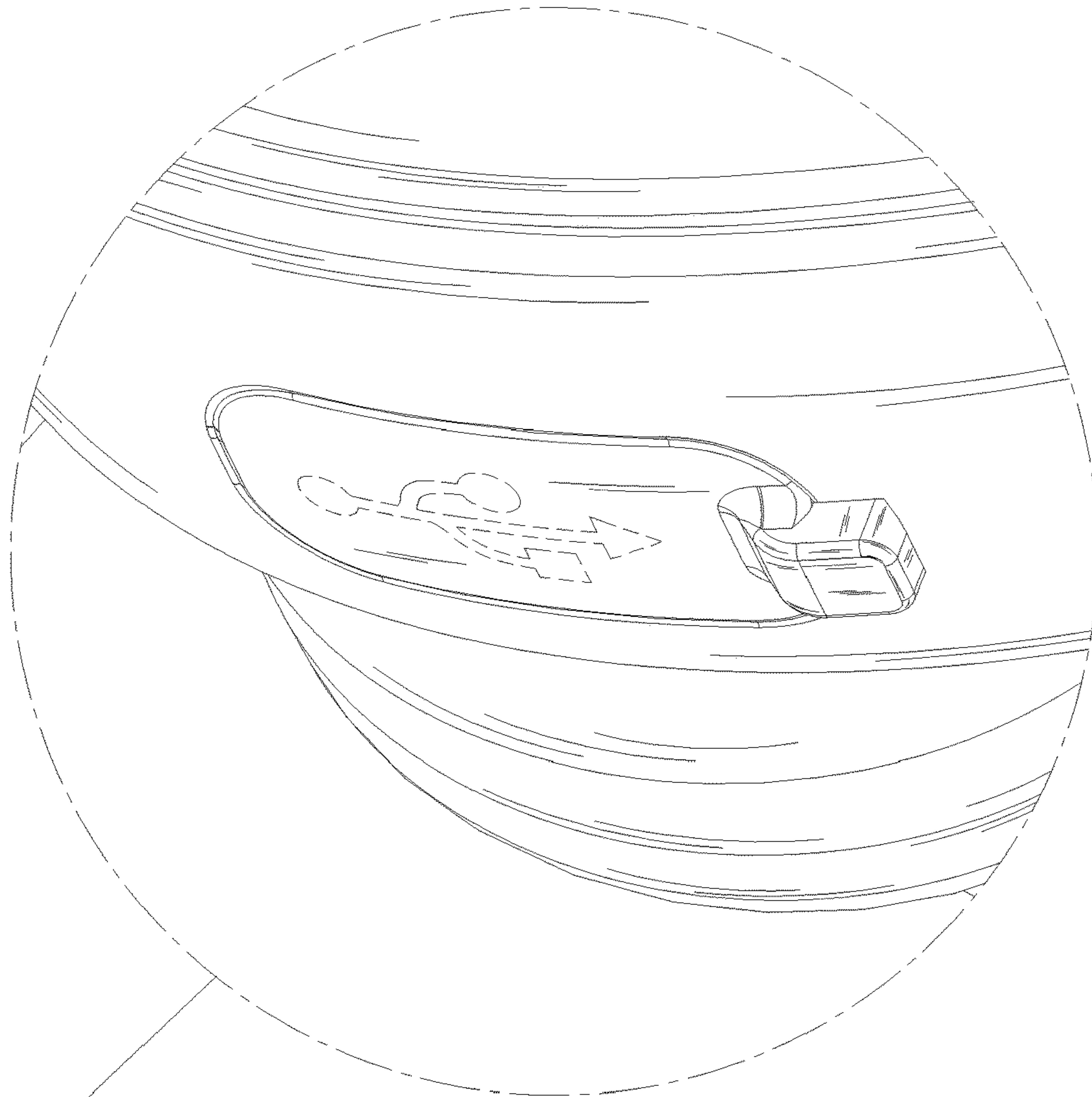
