(57) **CLAIM**

I claim the ornamental design for a headphone stand, as shown and described.

DESCRIPTION

FIG. 1 is an illuminated, color, top, perspective view of a first embodiment of a headphone stand, showing my new design;

FIG. 2 is an illuminated, color, front elevational view thereof;

FIG. 3 is an illuminated, color, rear elevational view thereof; FIG. 4 is an illuminated, color, right side elevational view thereof;

FIG. 5 is an illuminated, color, left side elevational view thereof;

FIG. 6 is an illuminated, color, top plan view thereof;

FIG. 7 is an illuminated, color, bottom plan view thereof;

FIG. 8 is an illuminated, grayscale, top perspective view of a second embodiment of a headphone stand;

FIG. 9 is an illuminated, grayscale, front elevational view thereof;

FIG. 10 is an illuminated, grayscale, rear elevational view thereof;

FIG. 11 is an illuminated, grayscale, right side elevational view thereof;

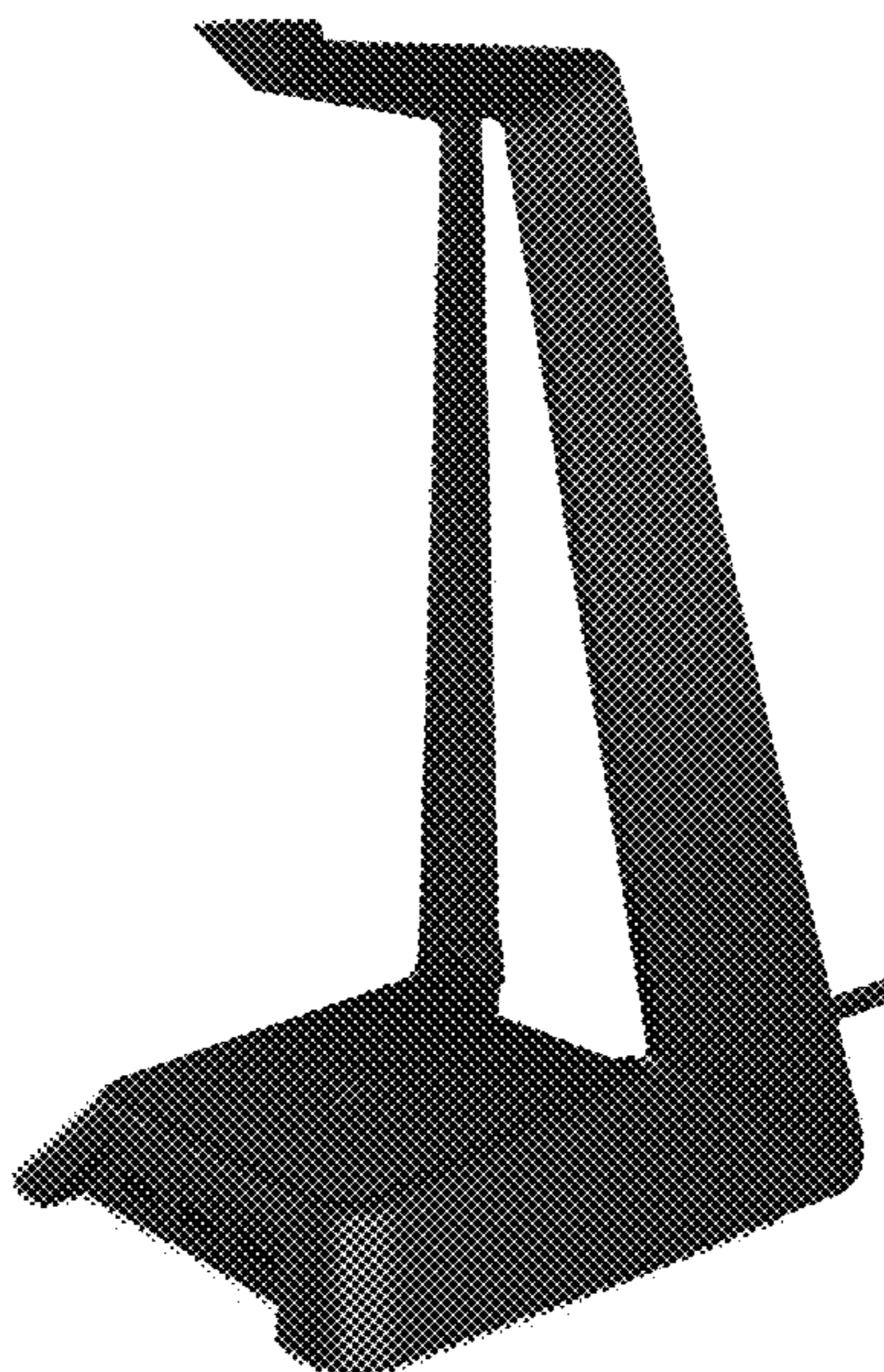
FIG. 12 is an illuminated, grayscale, left side elevational view thereof;

FIG. 13 is an illuminated, grayscale, top plan view thereof; and,

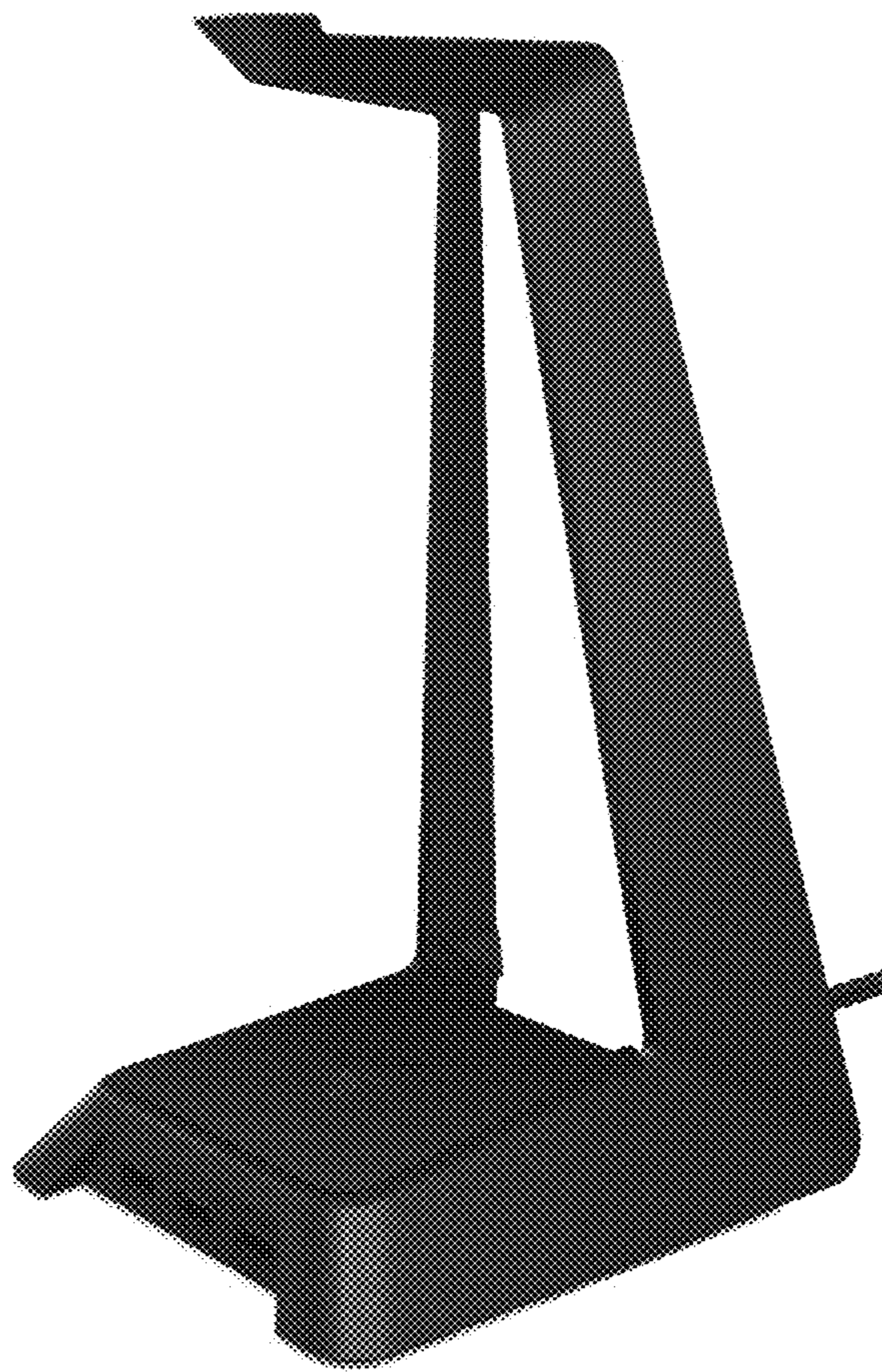

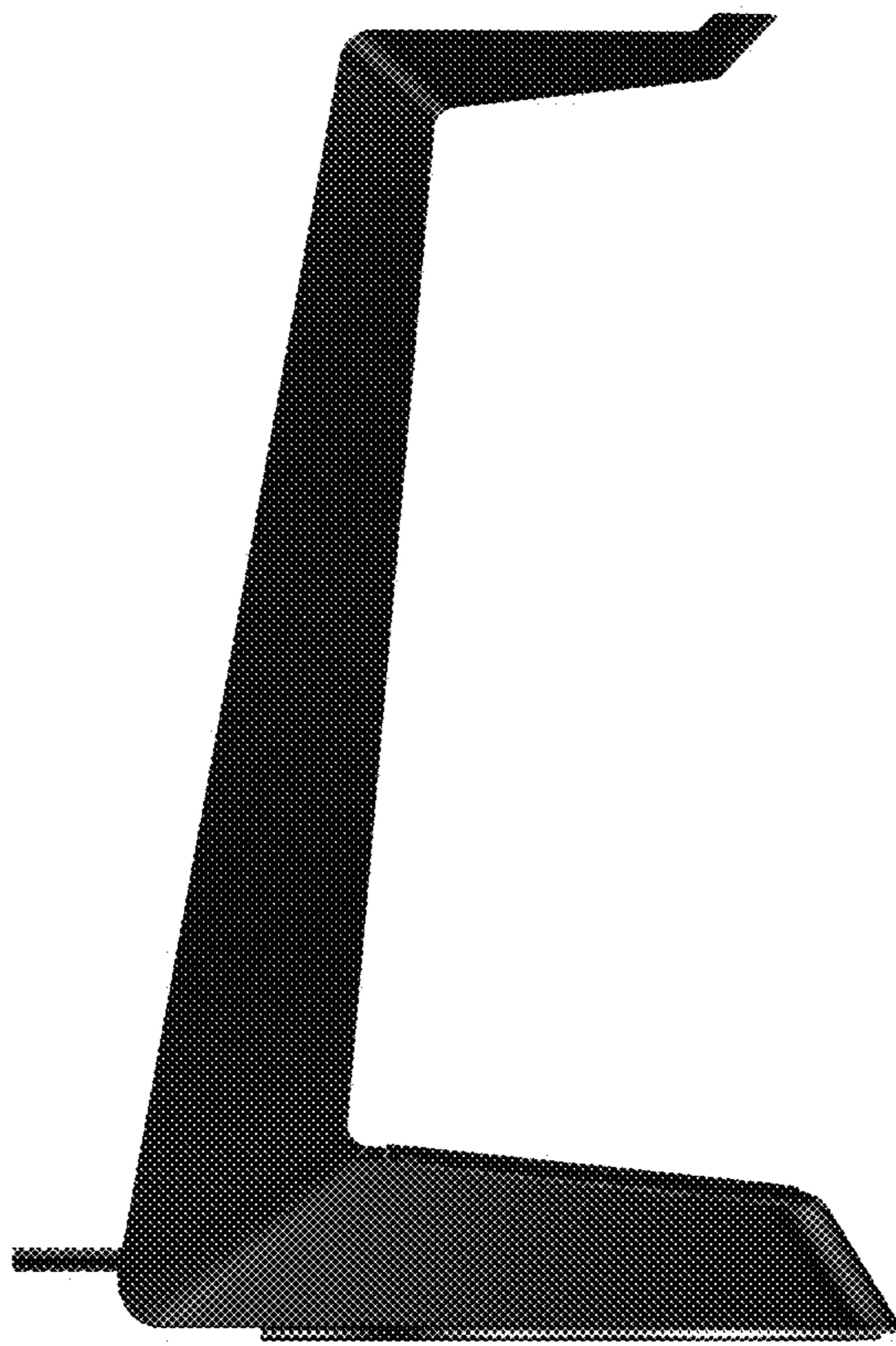

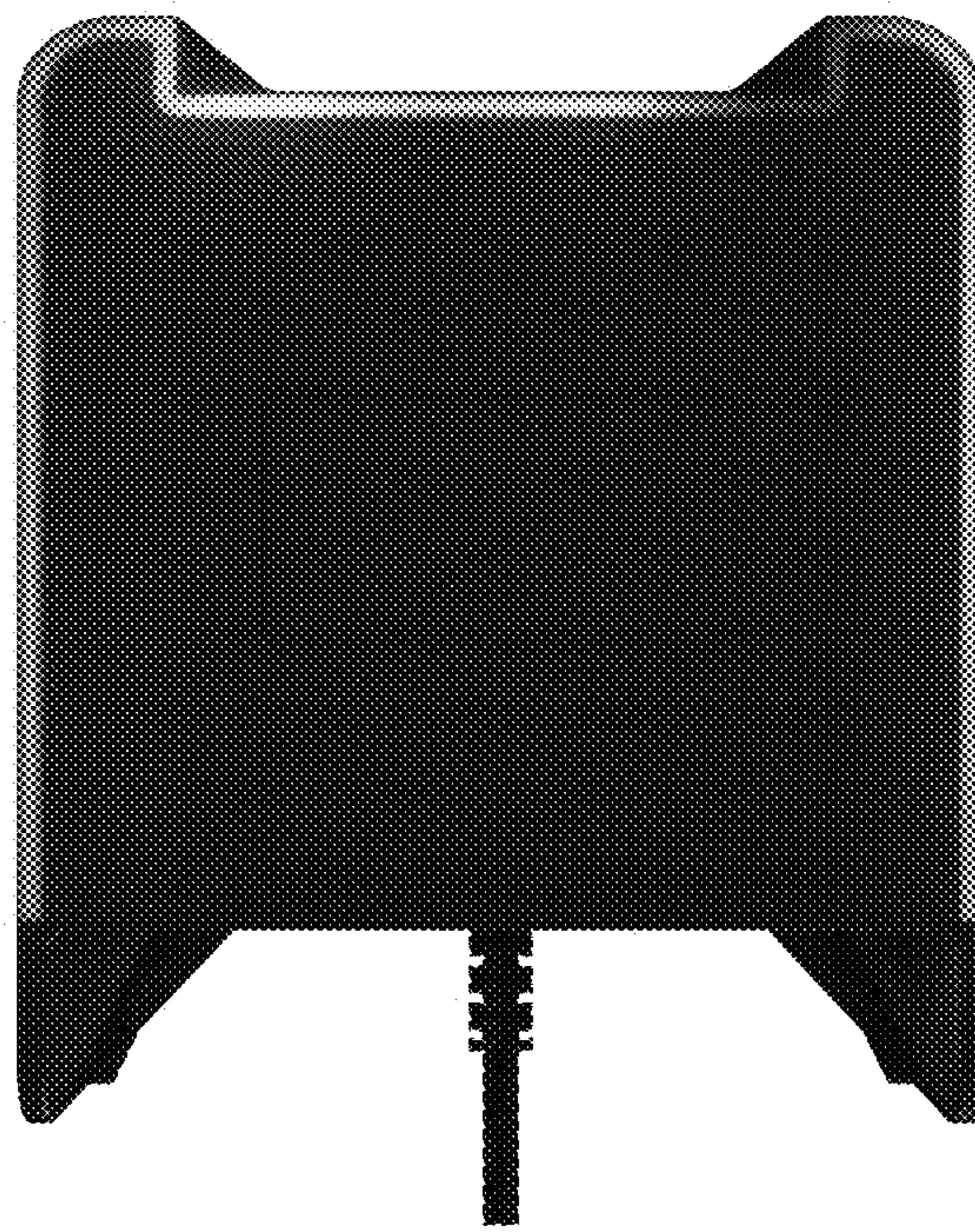

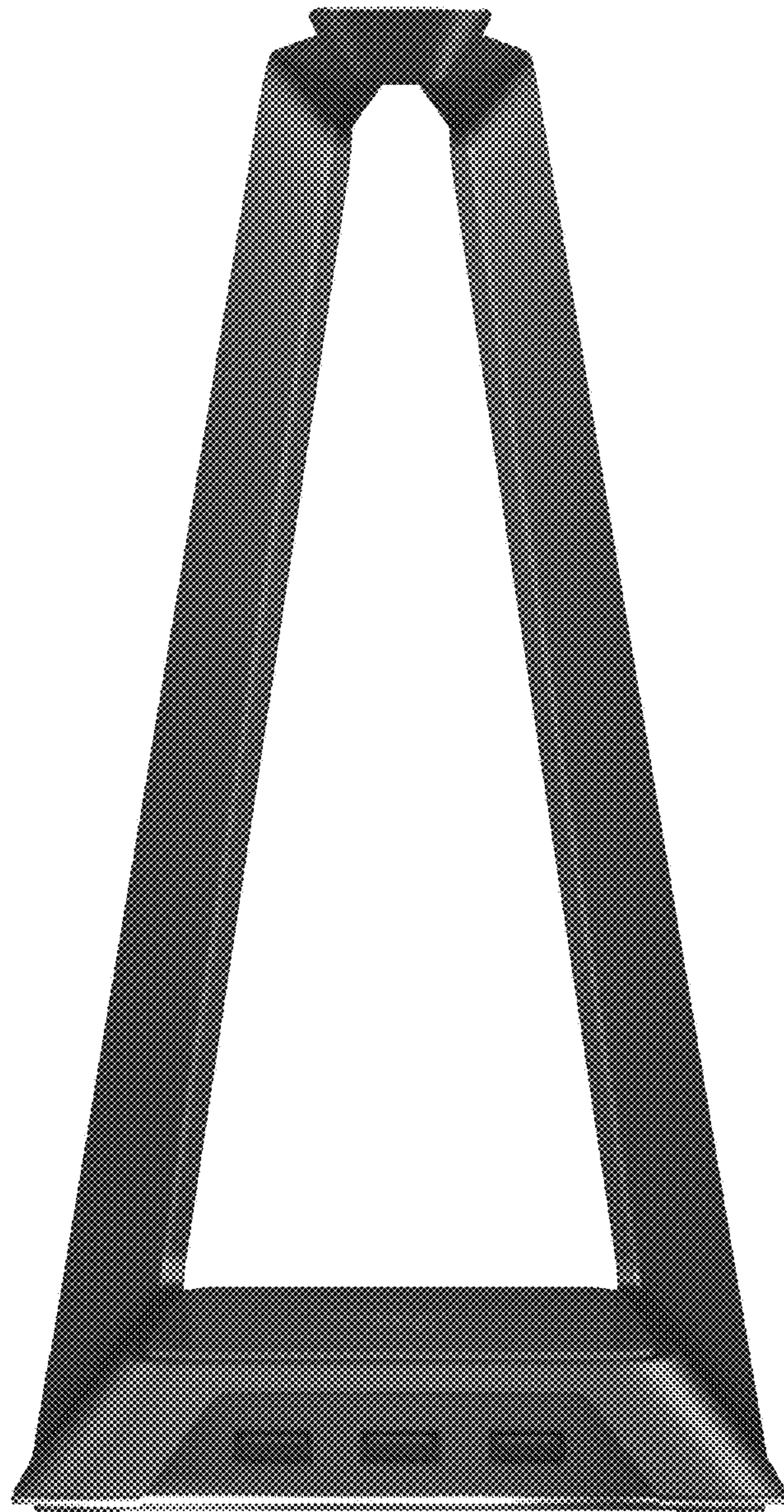

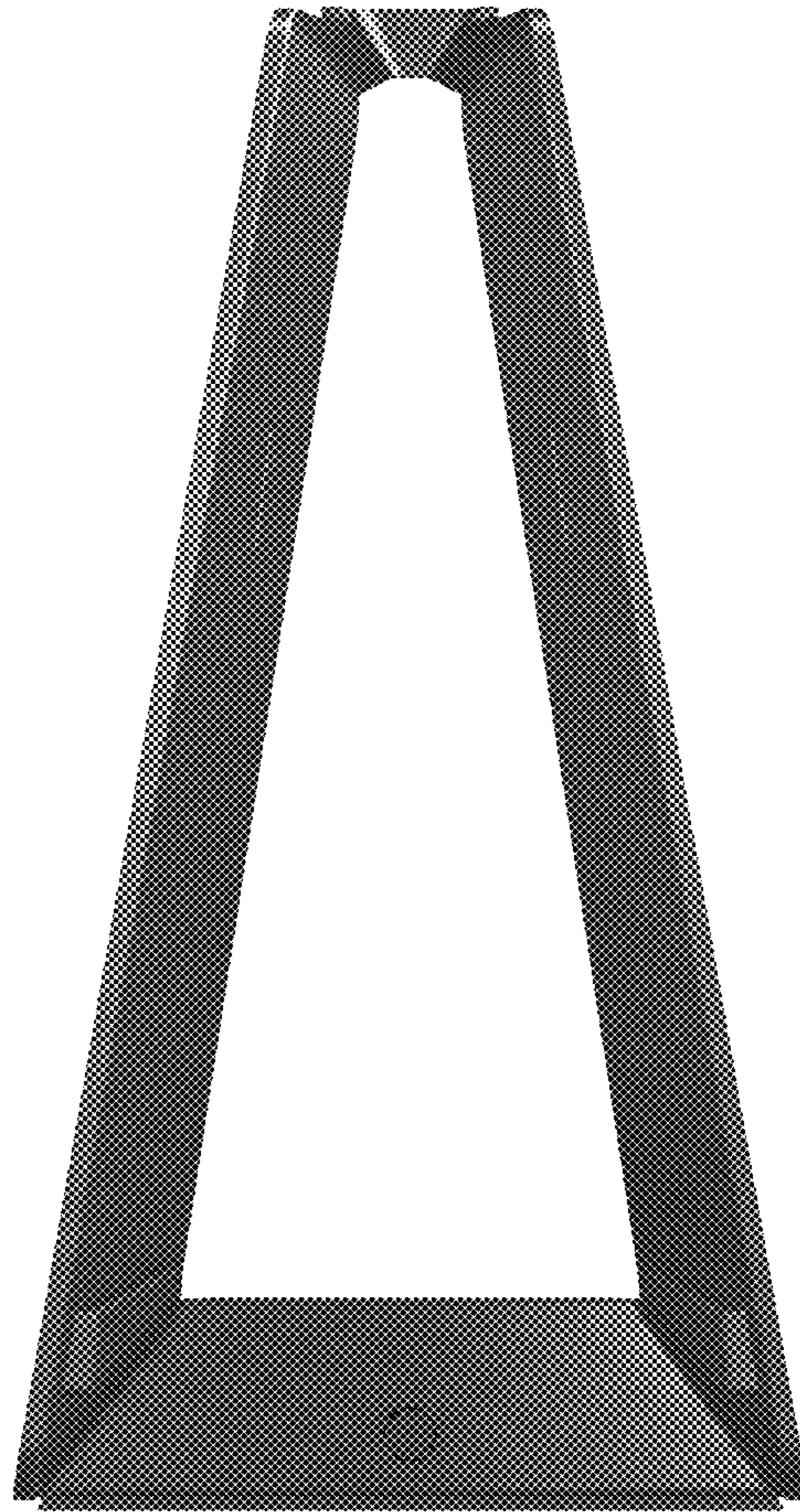

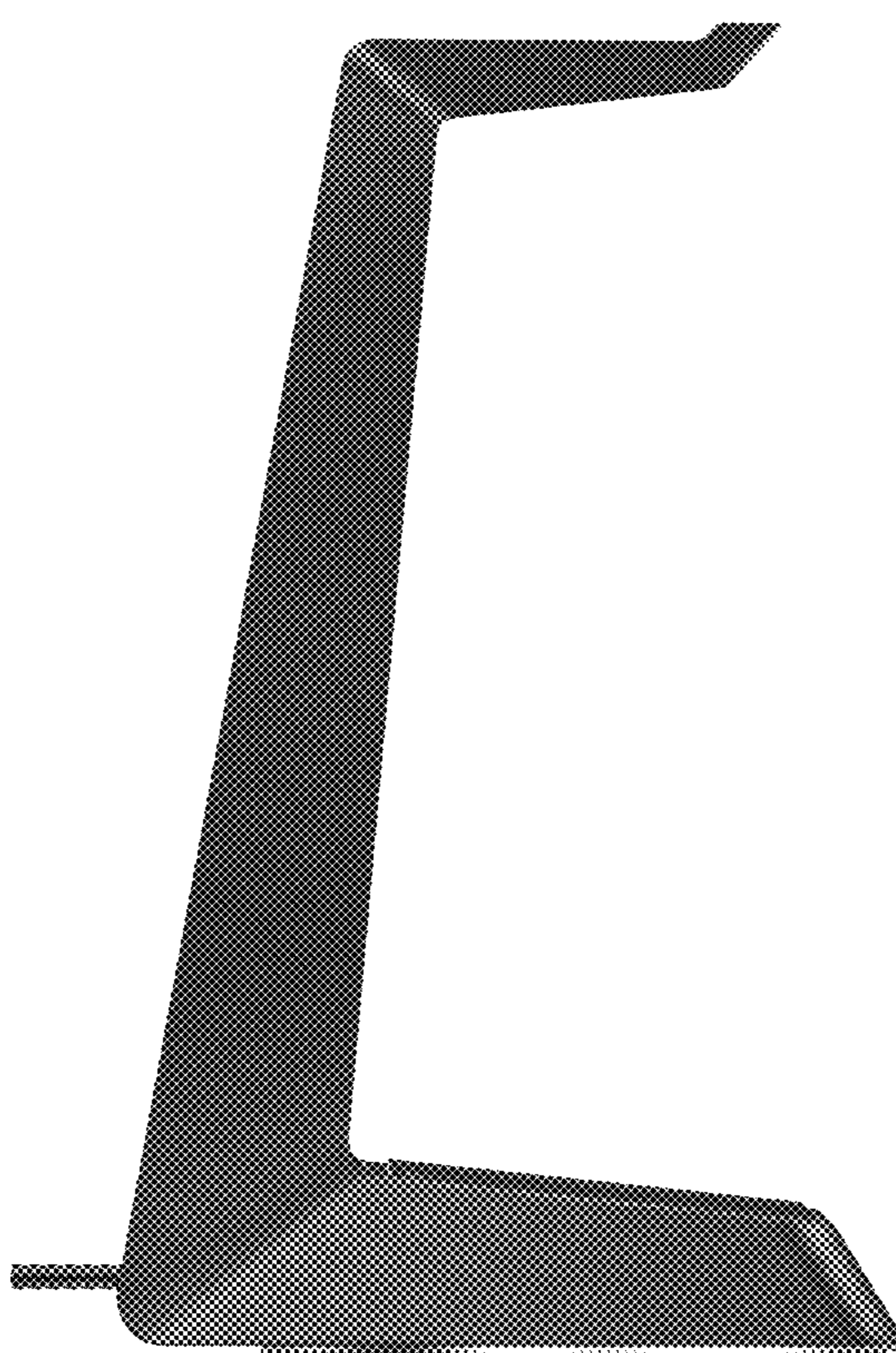

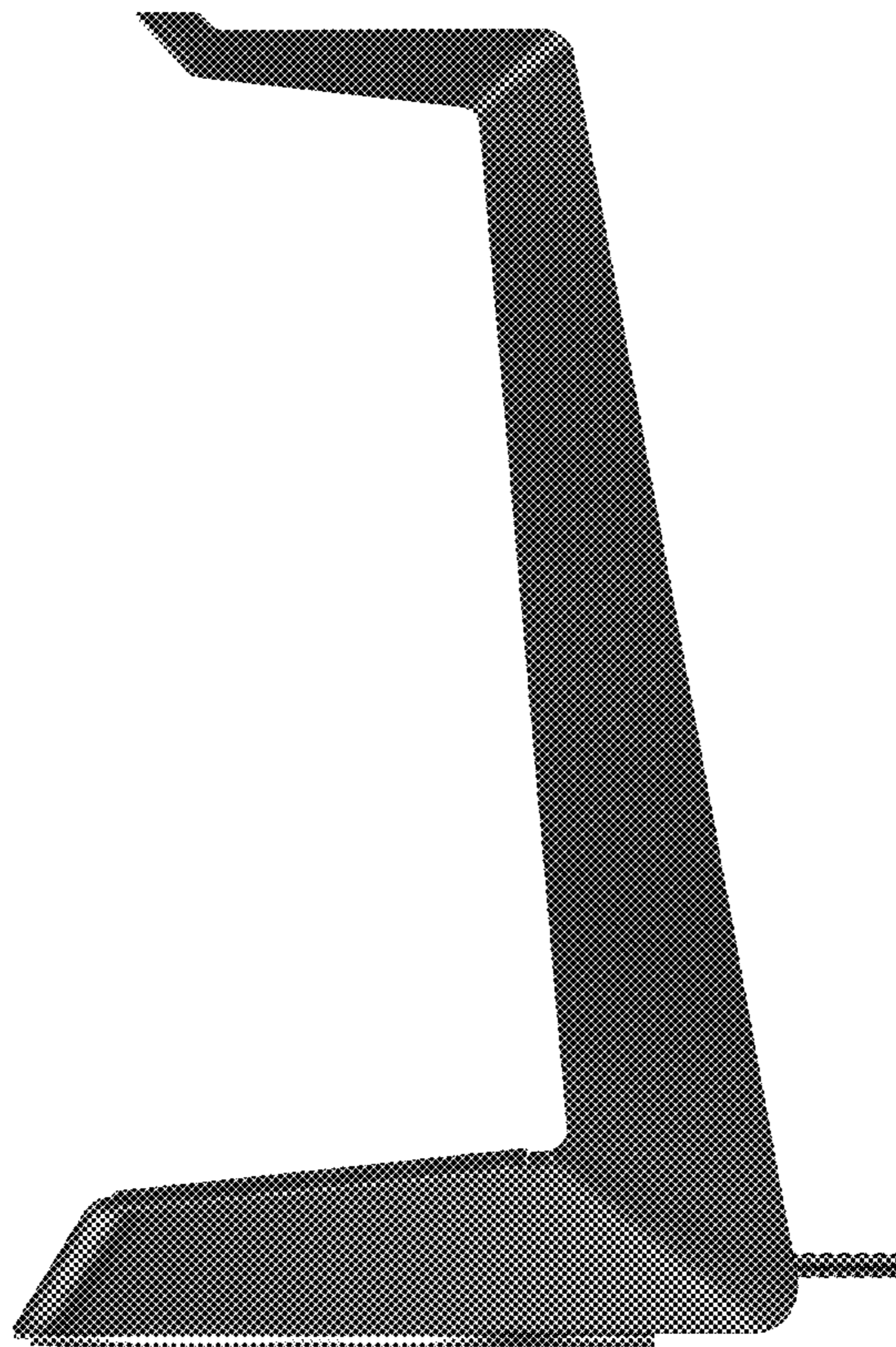

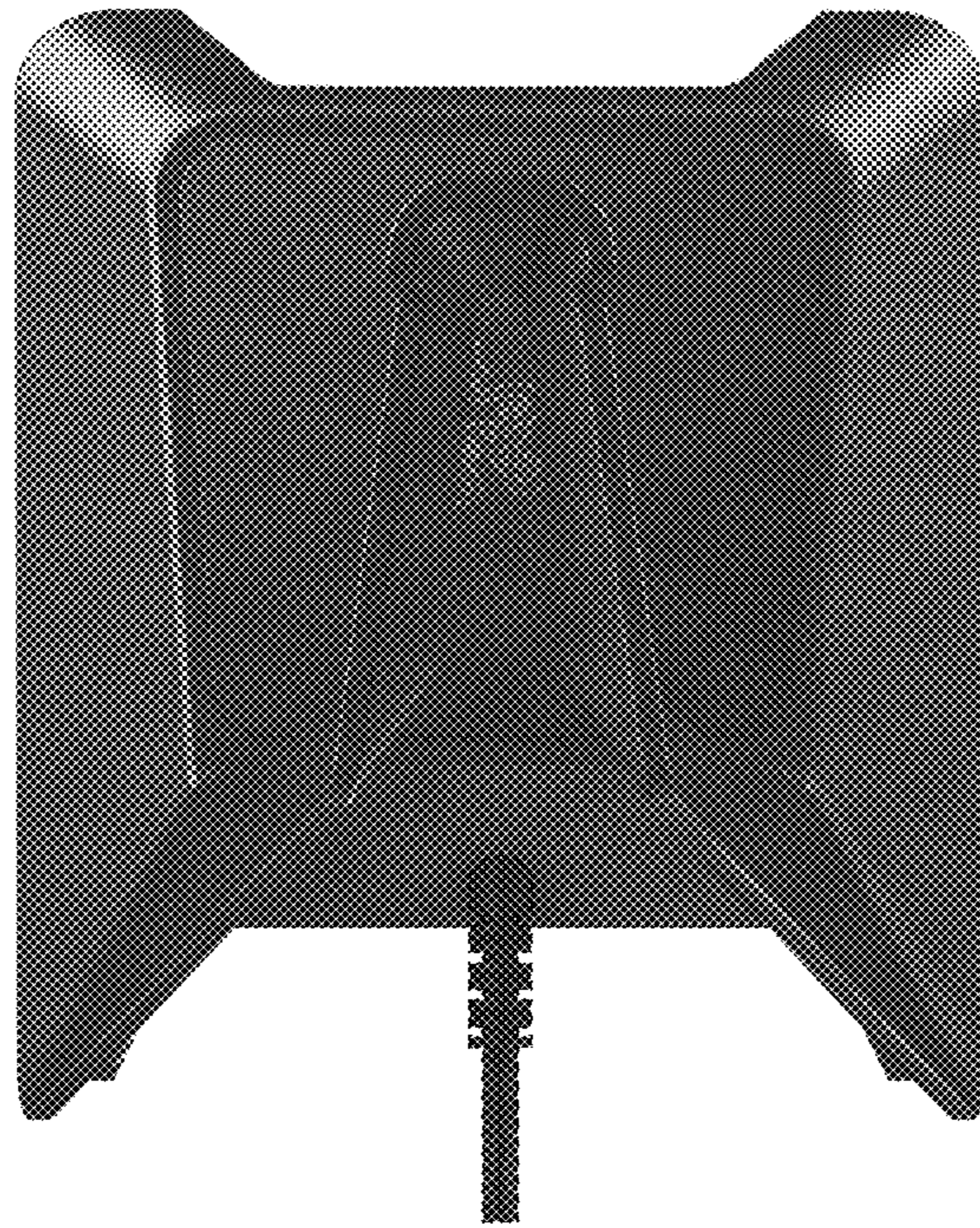

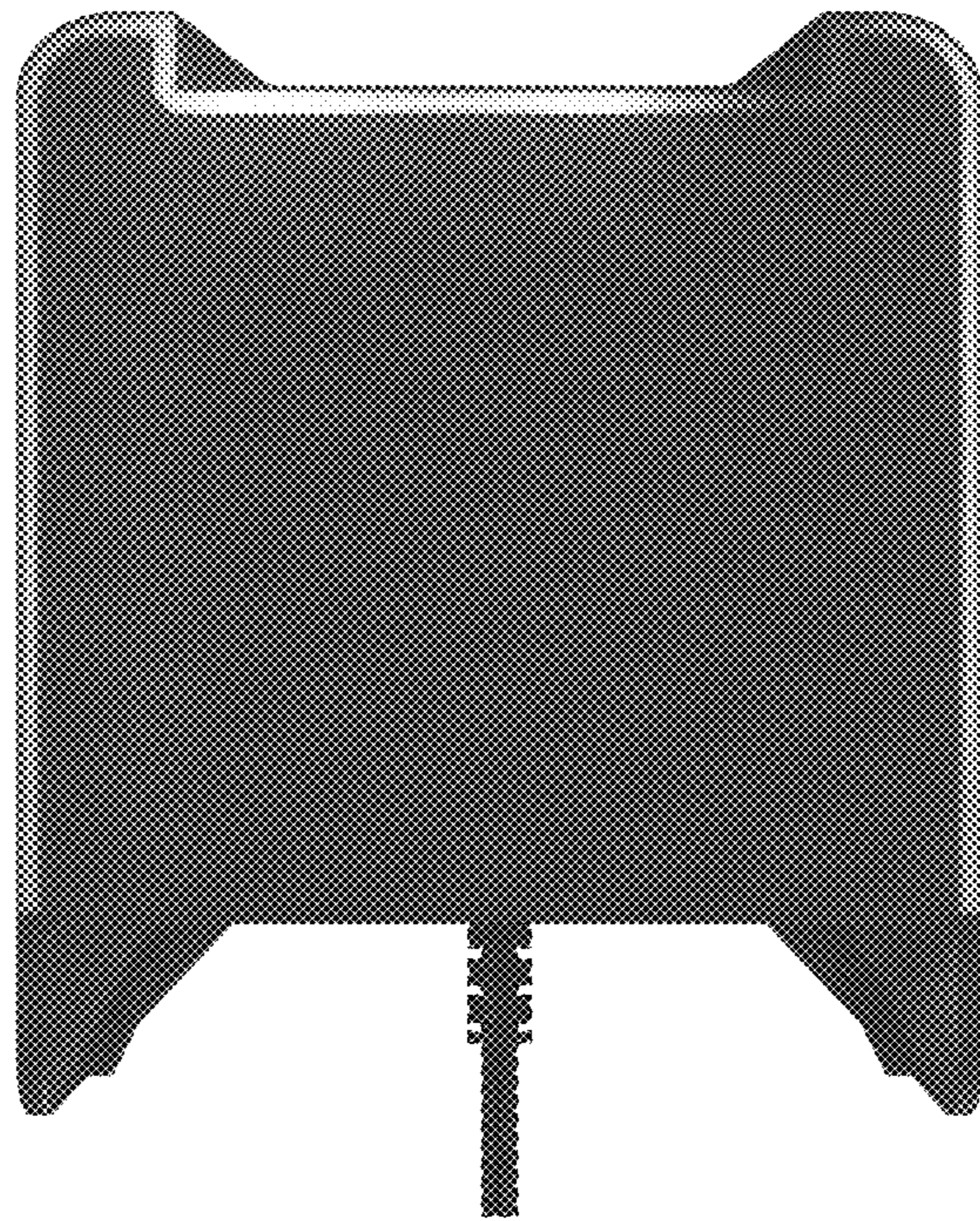
