(57) **CLAIM**

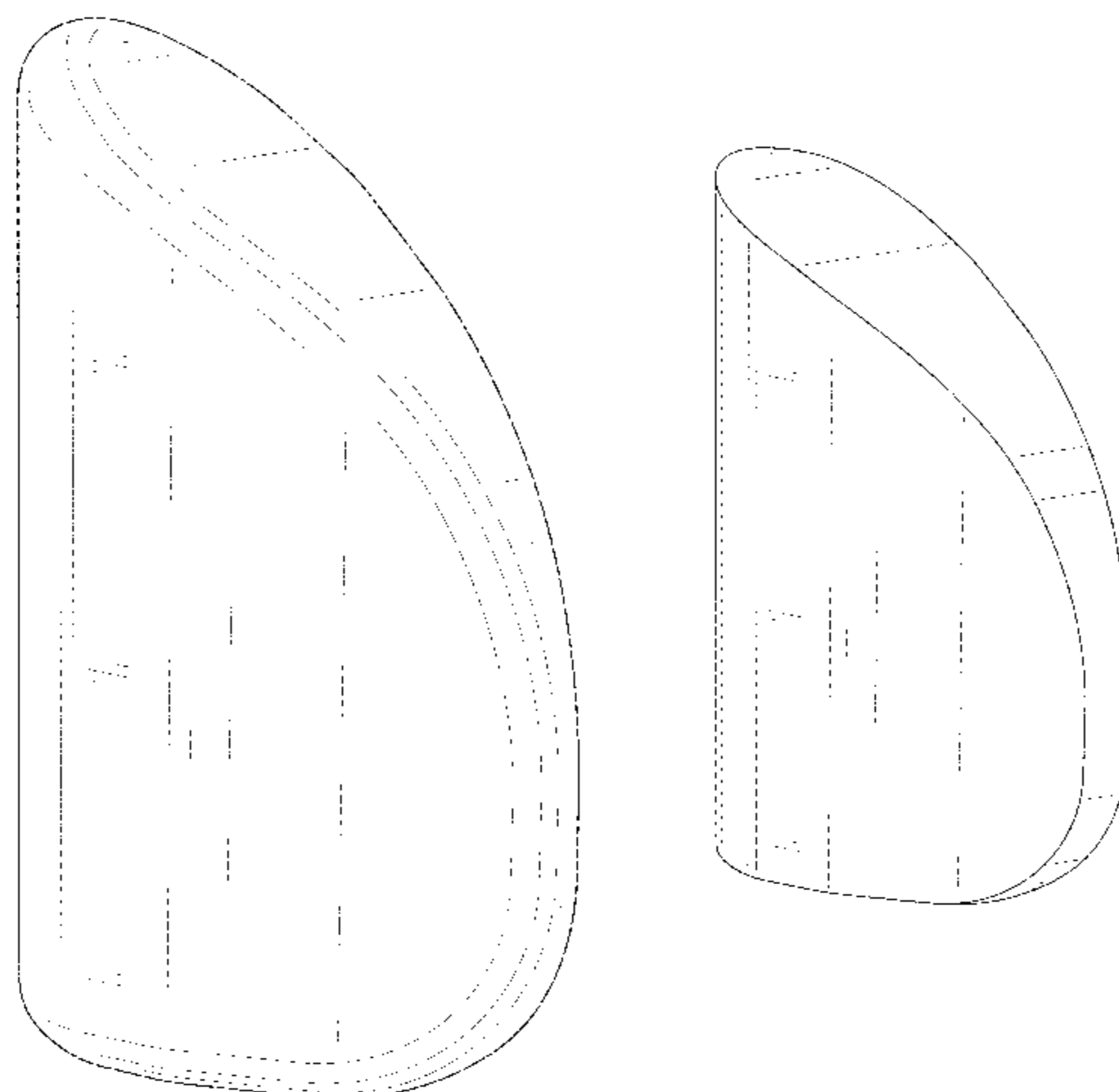
We claim the ornamental design for a handheld controller, as shown and described.

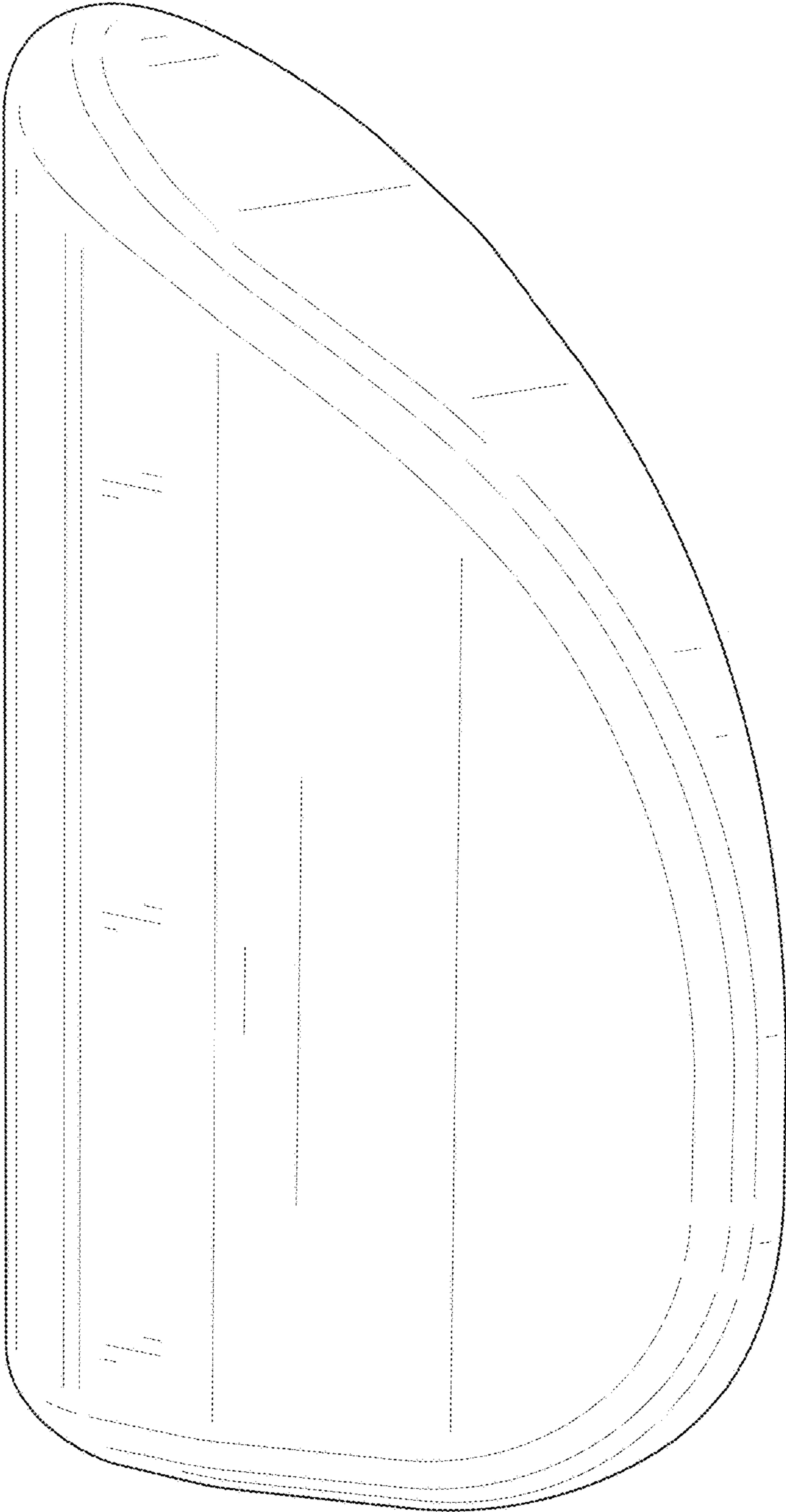

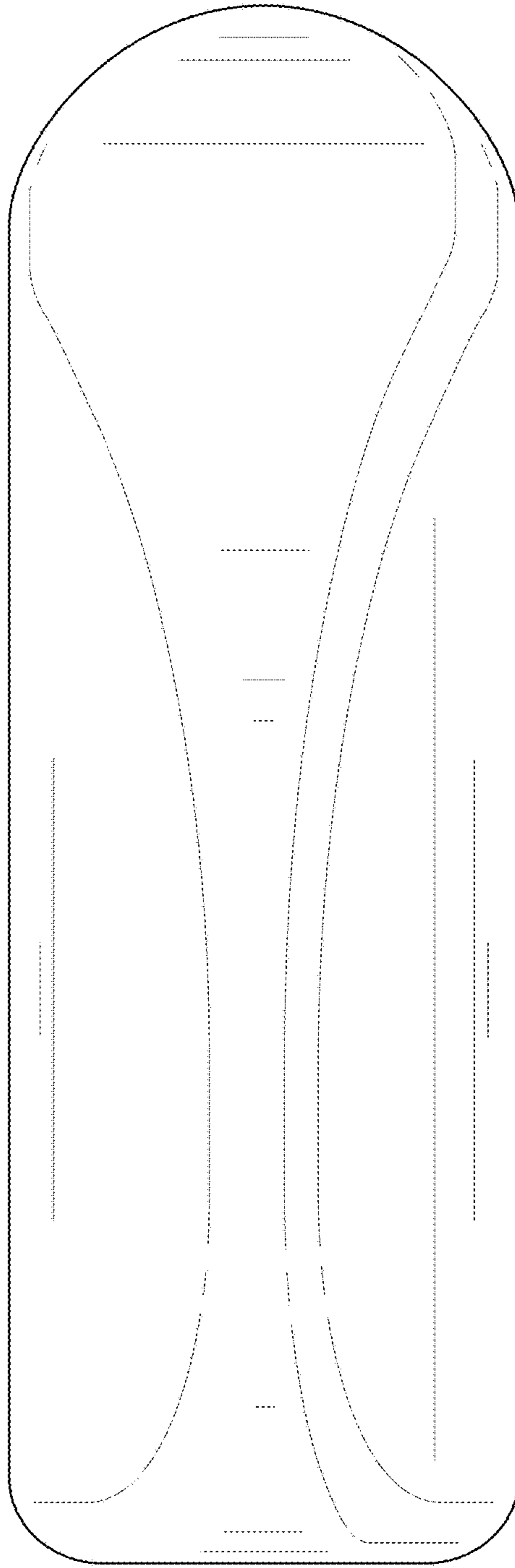

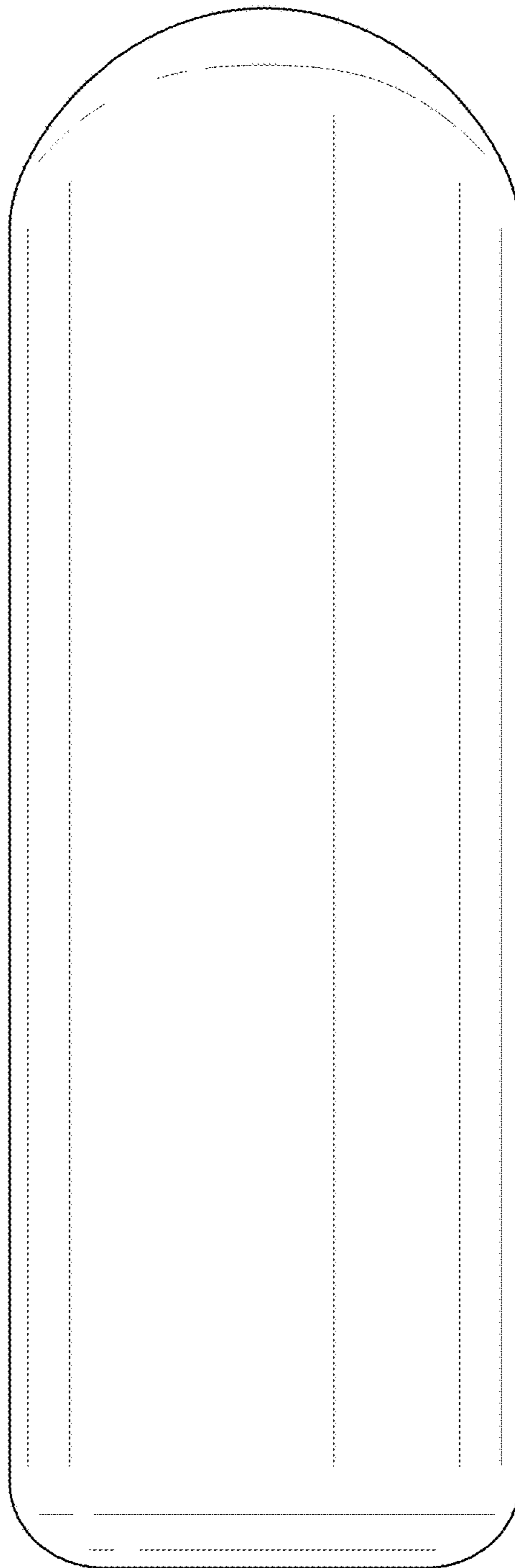

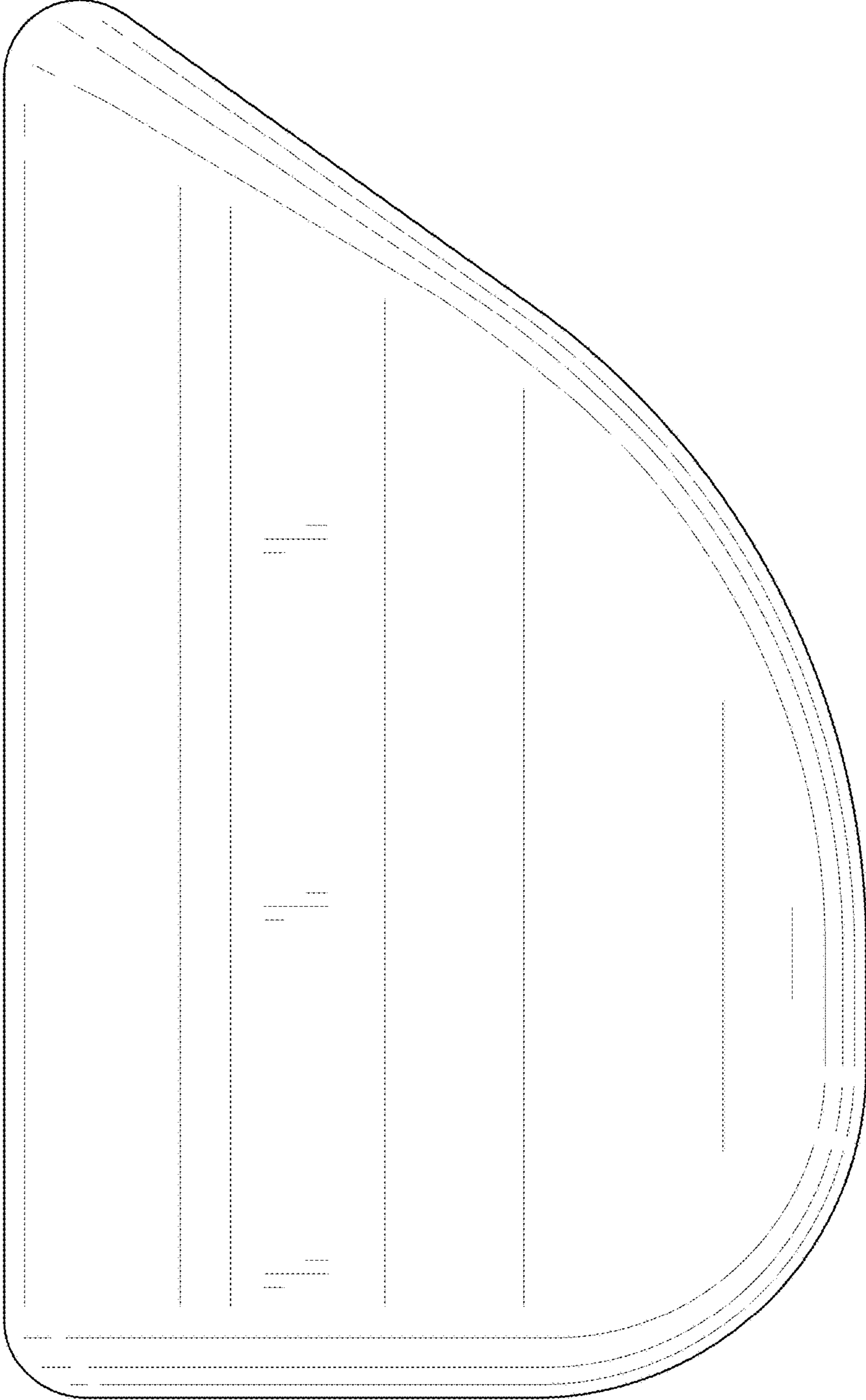

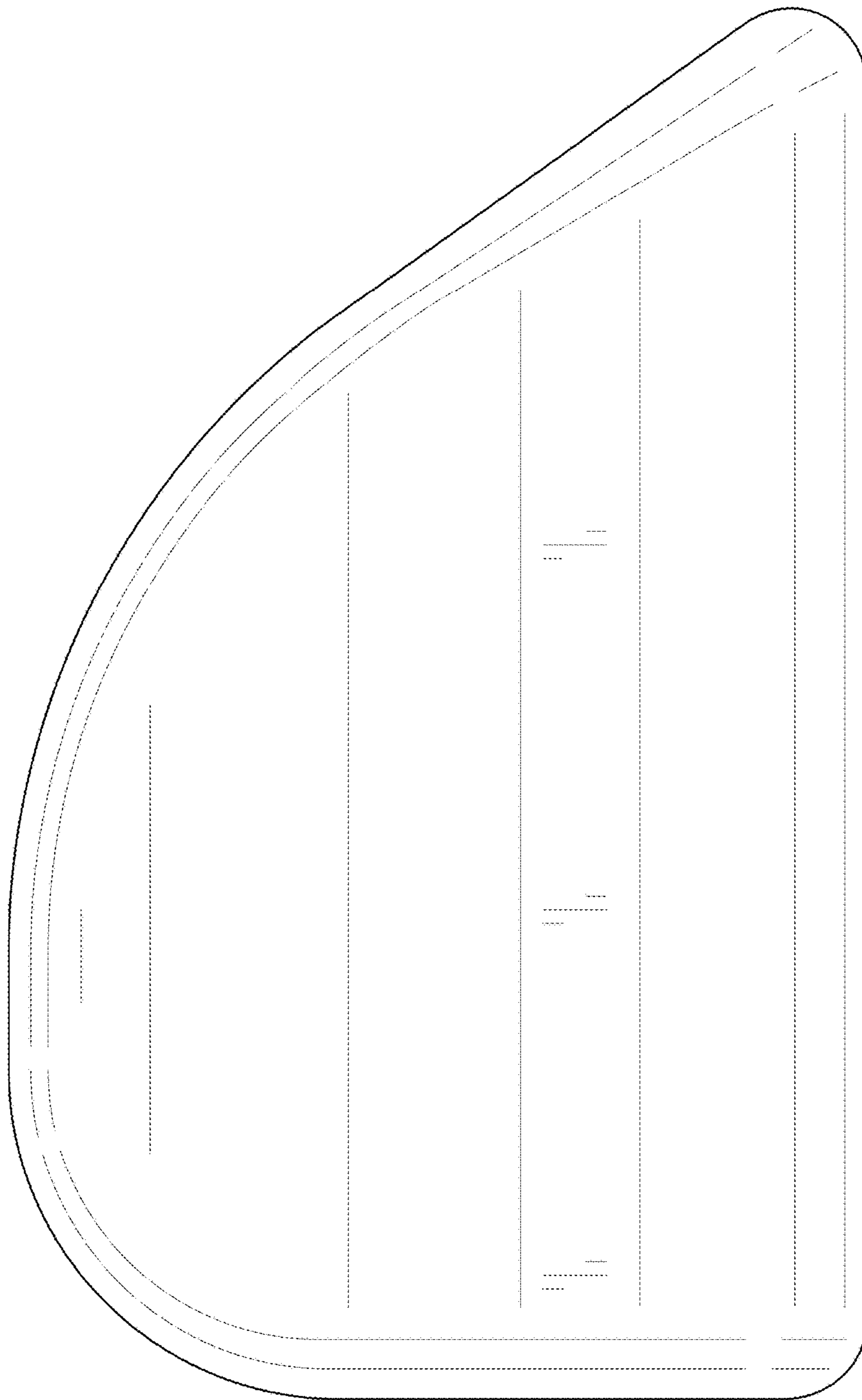

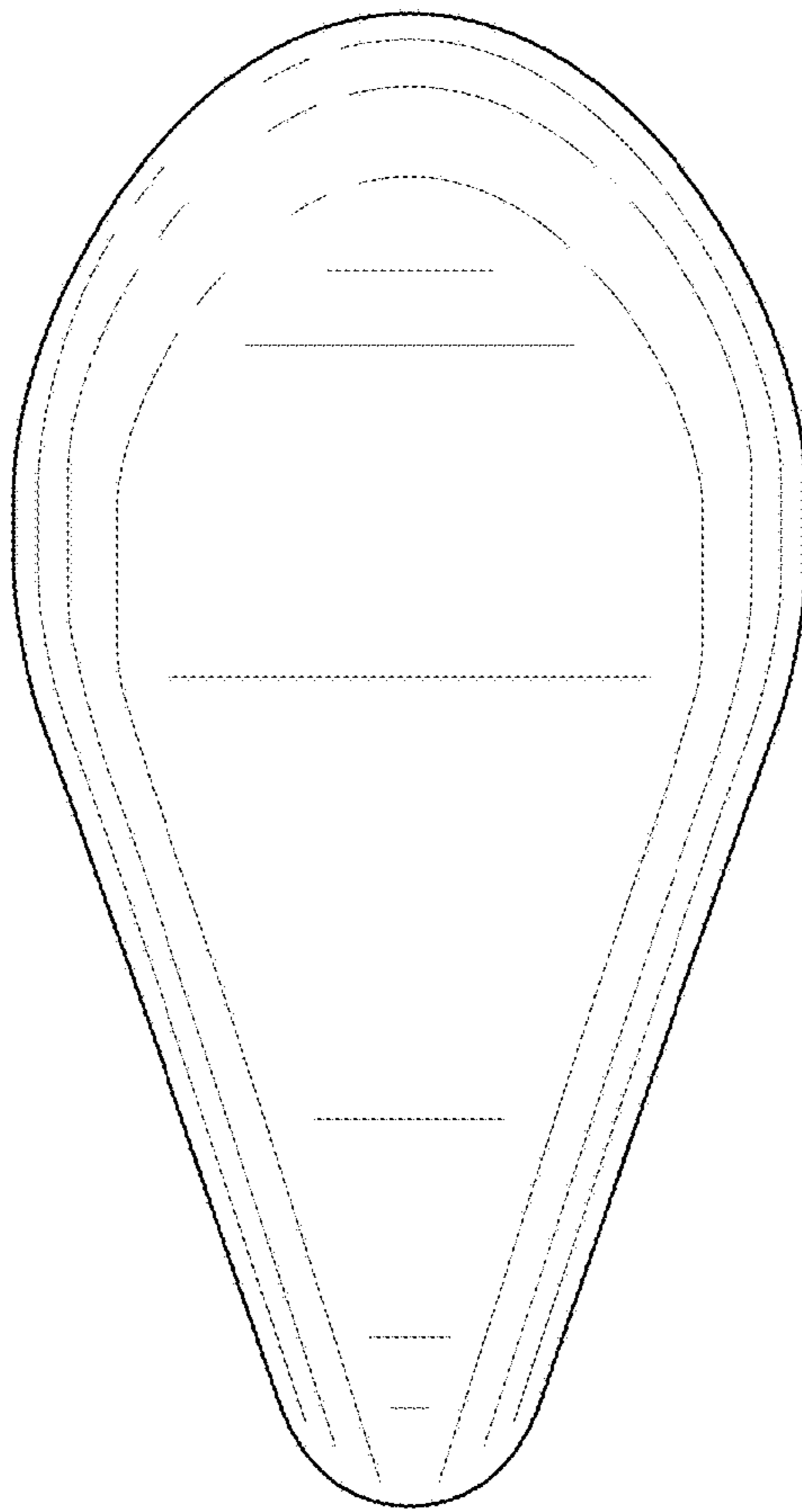

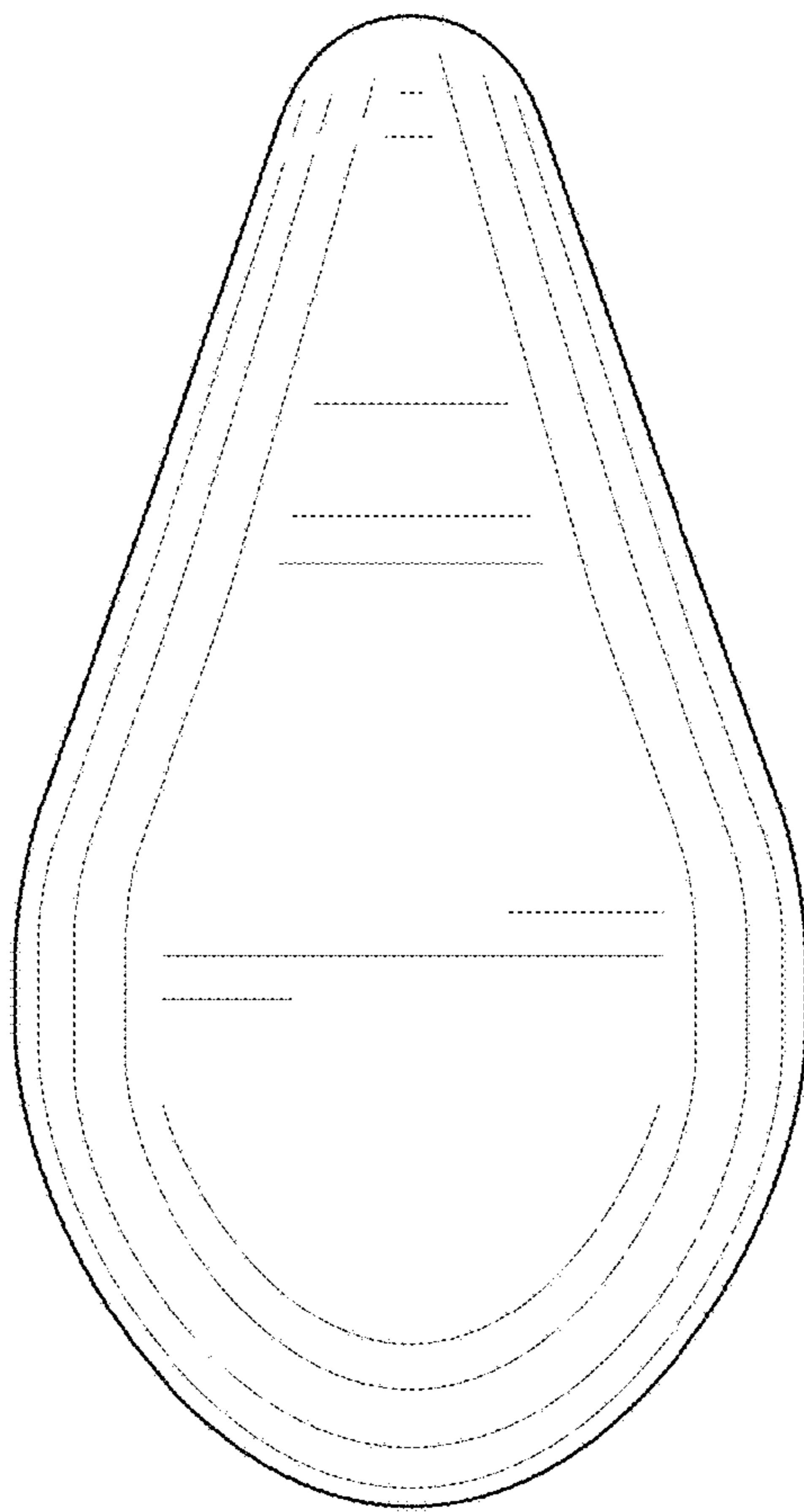

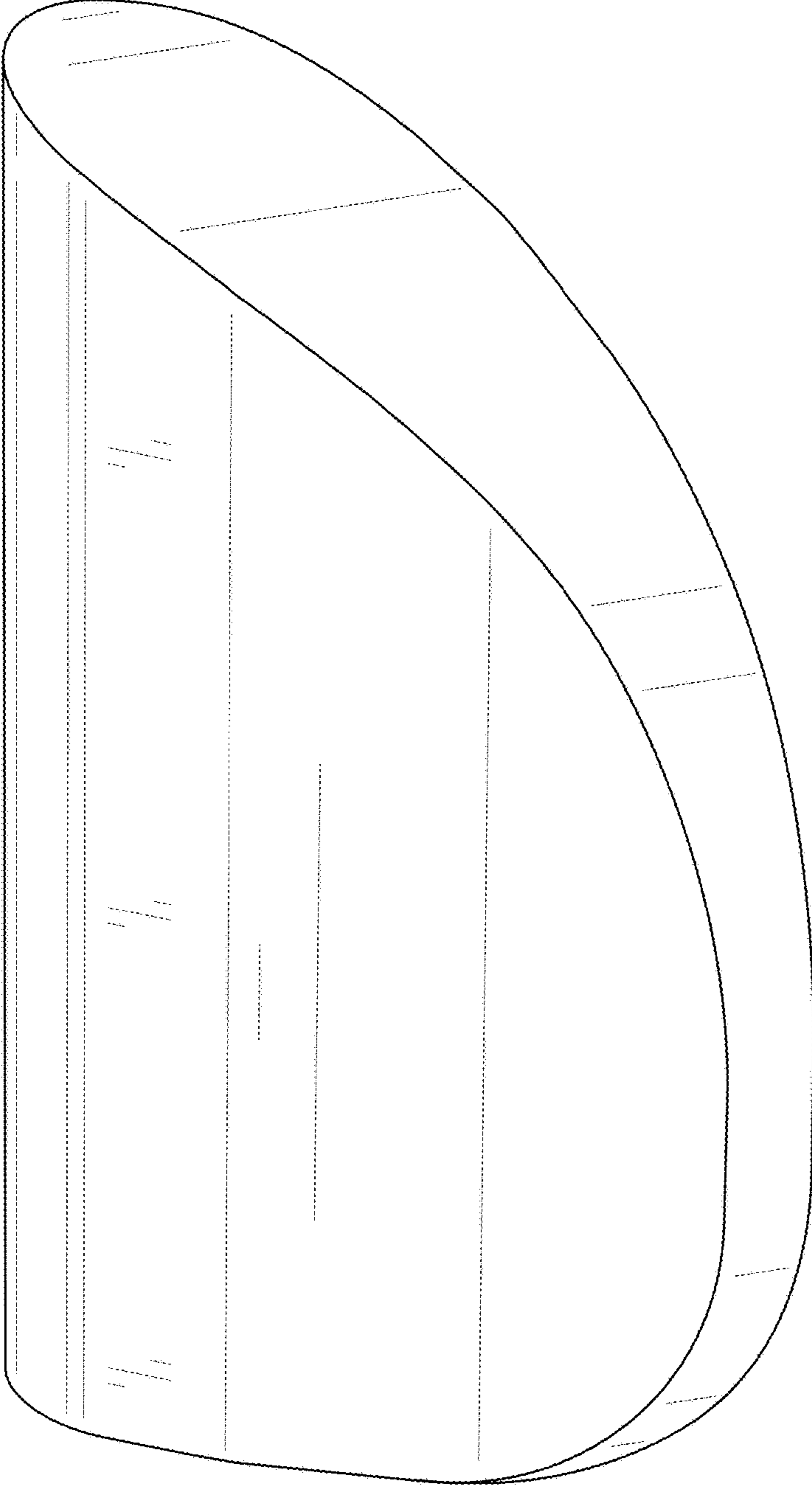

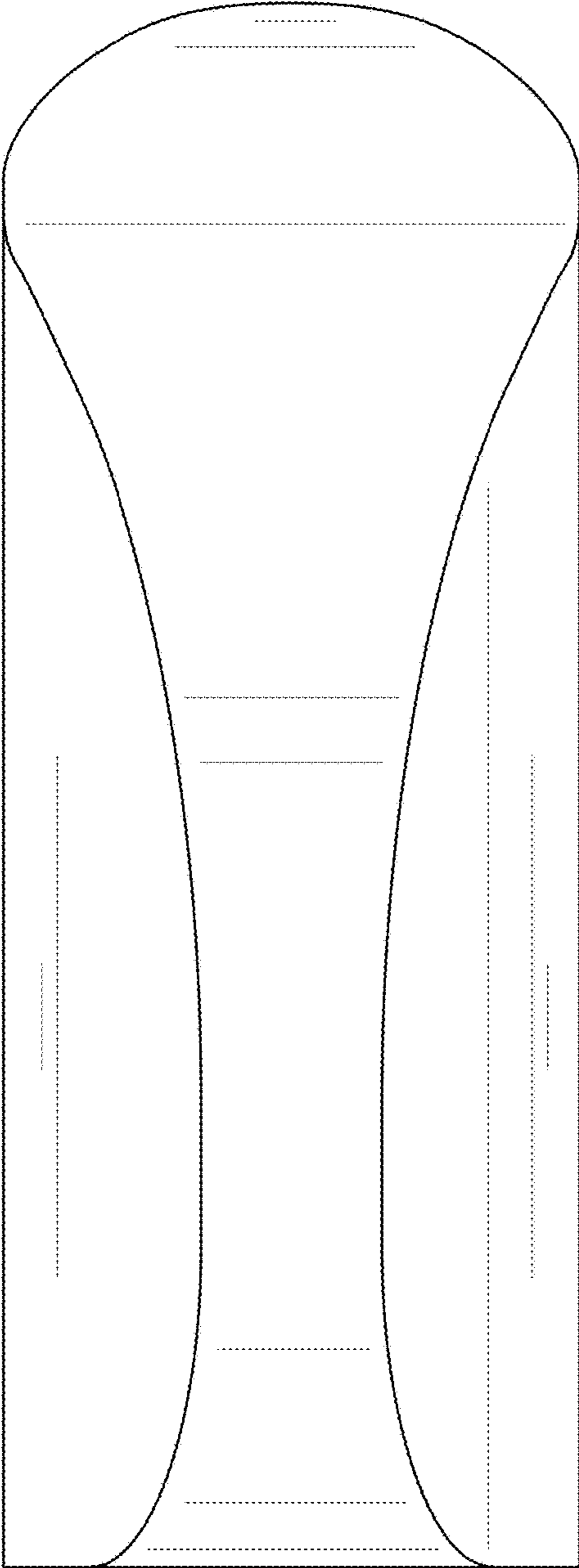

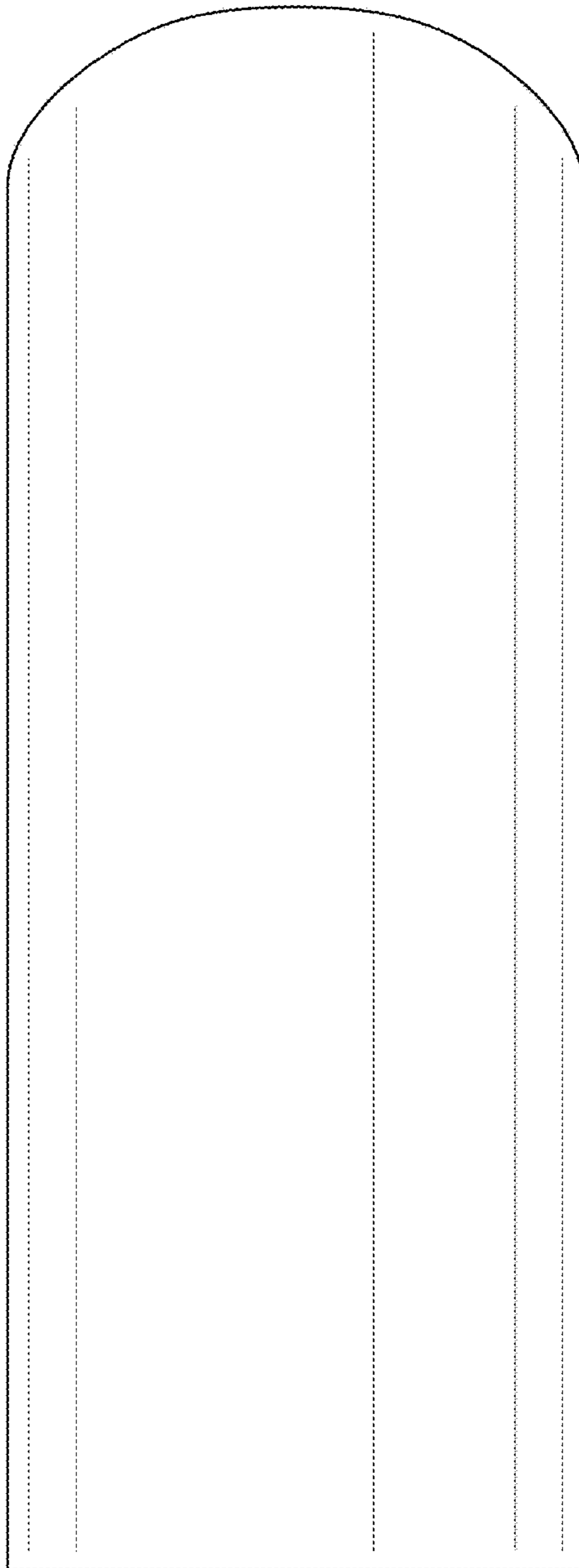

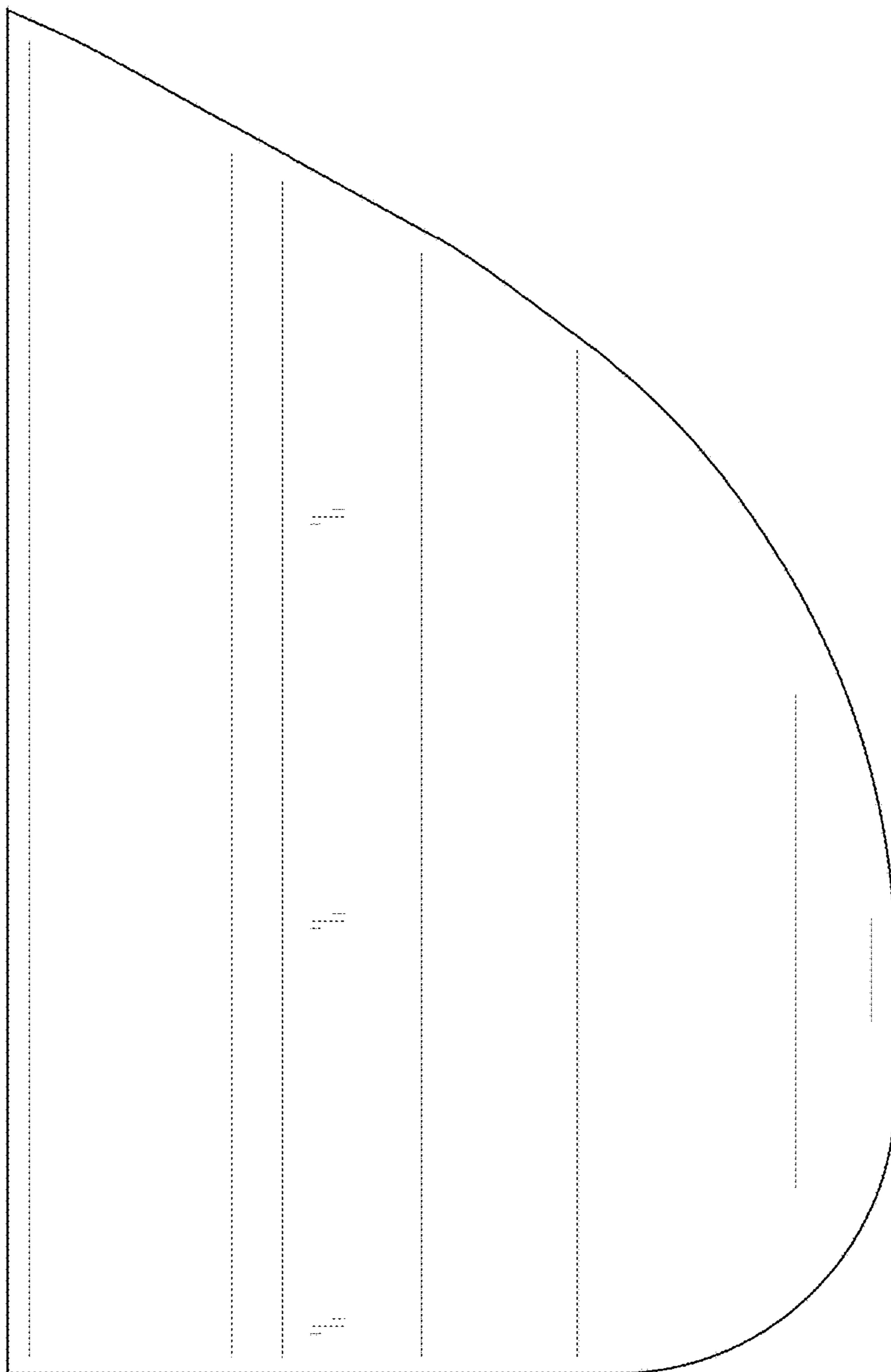

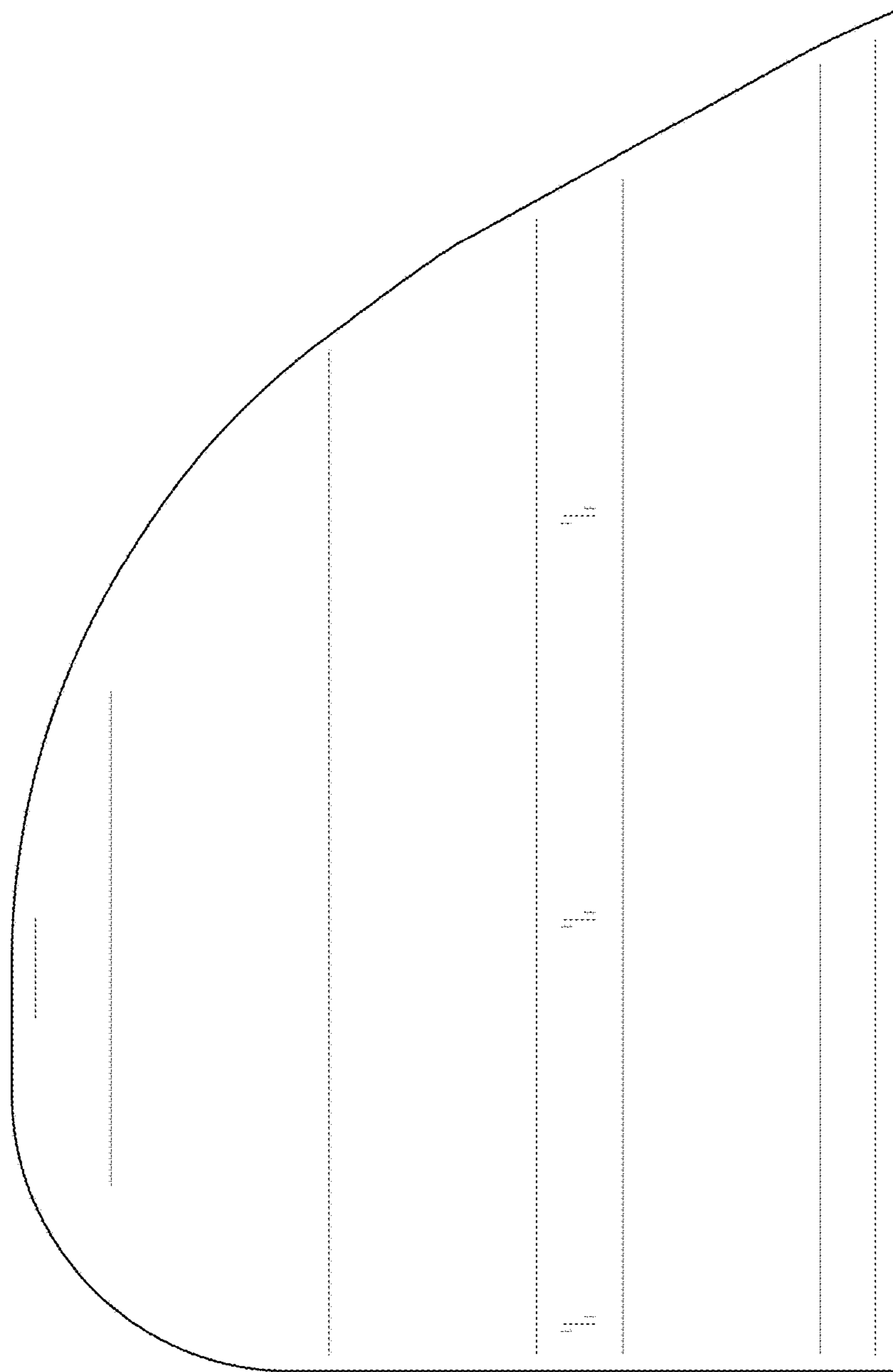

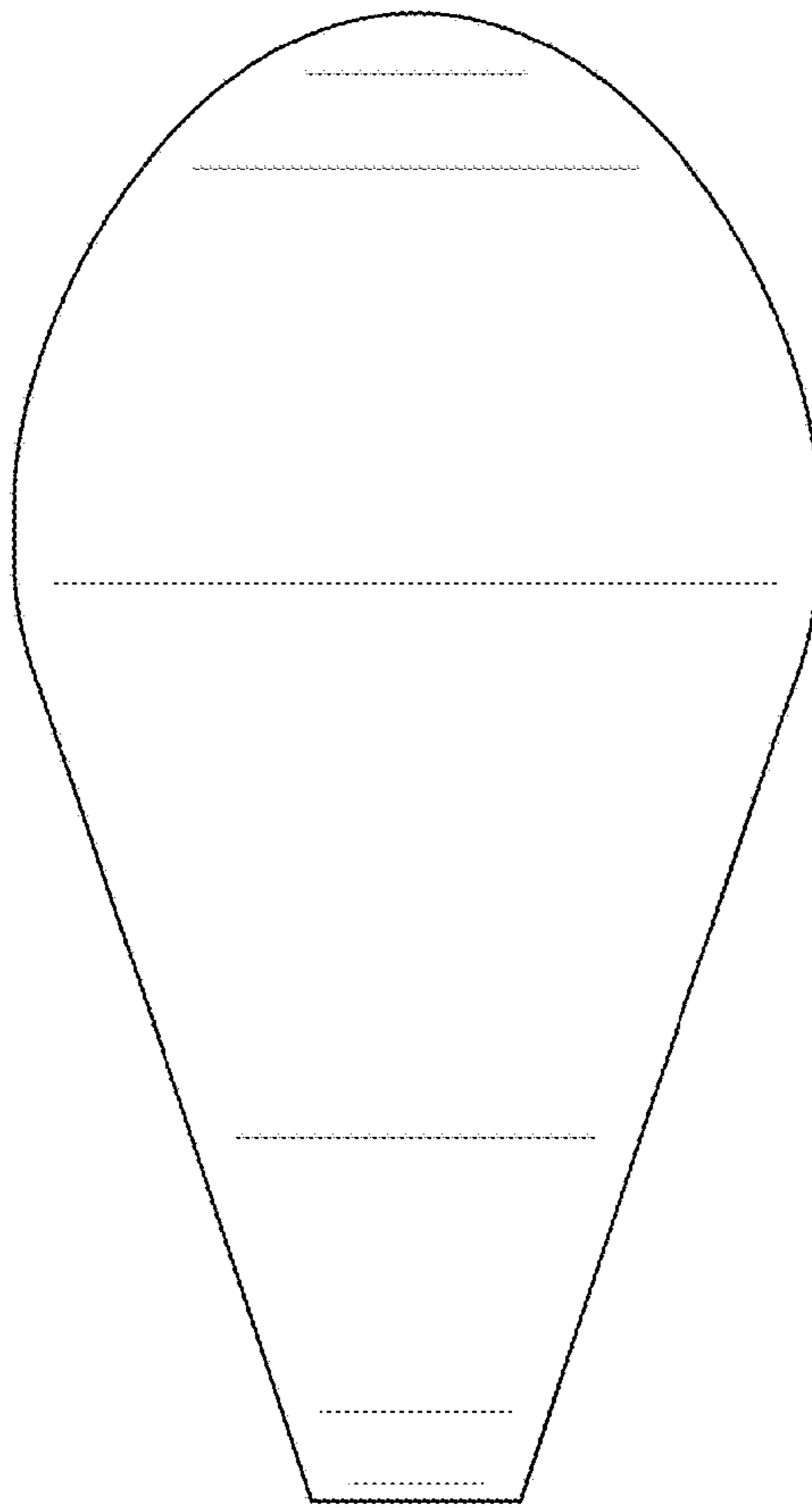

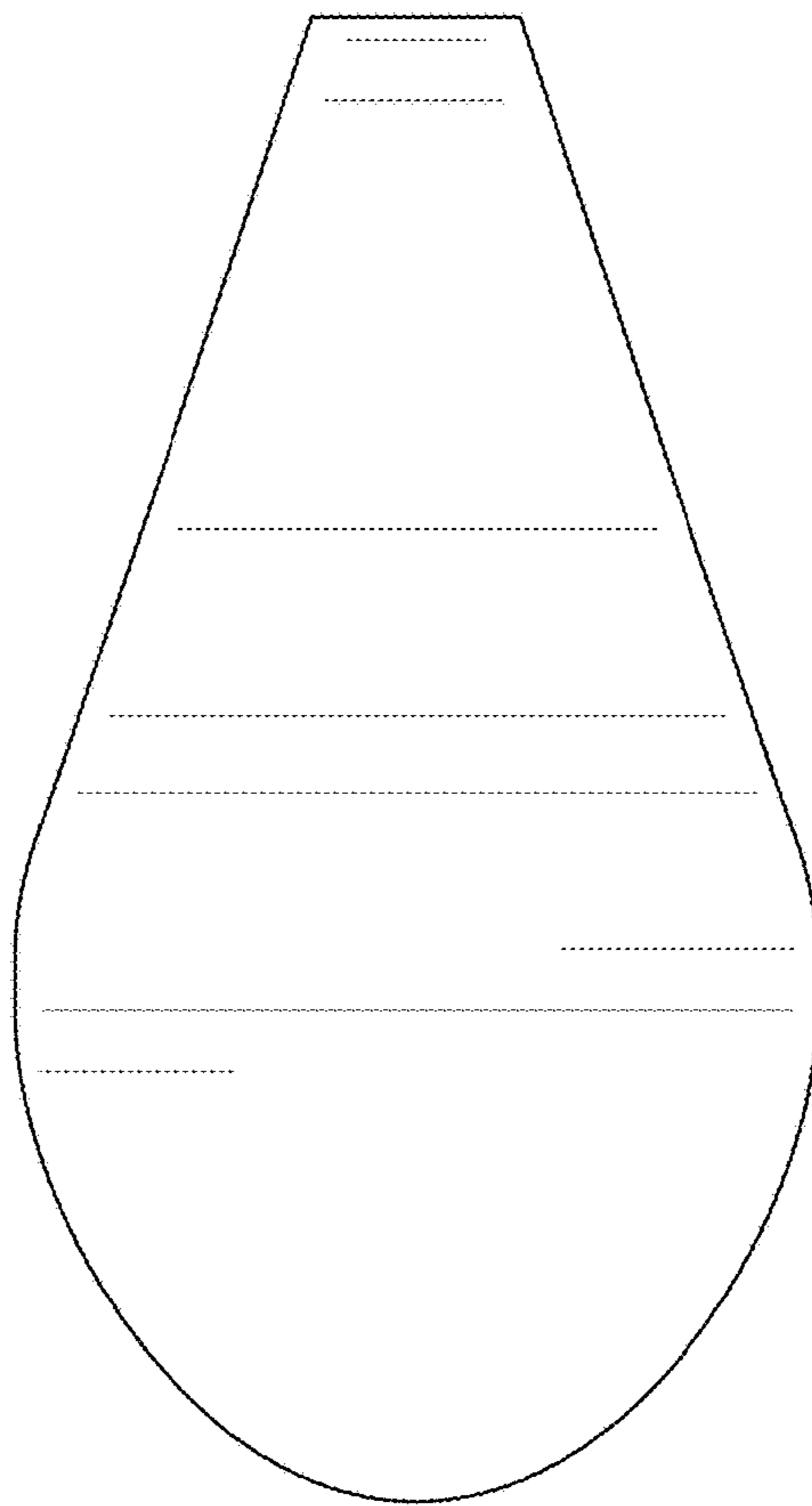

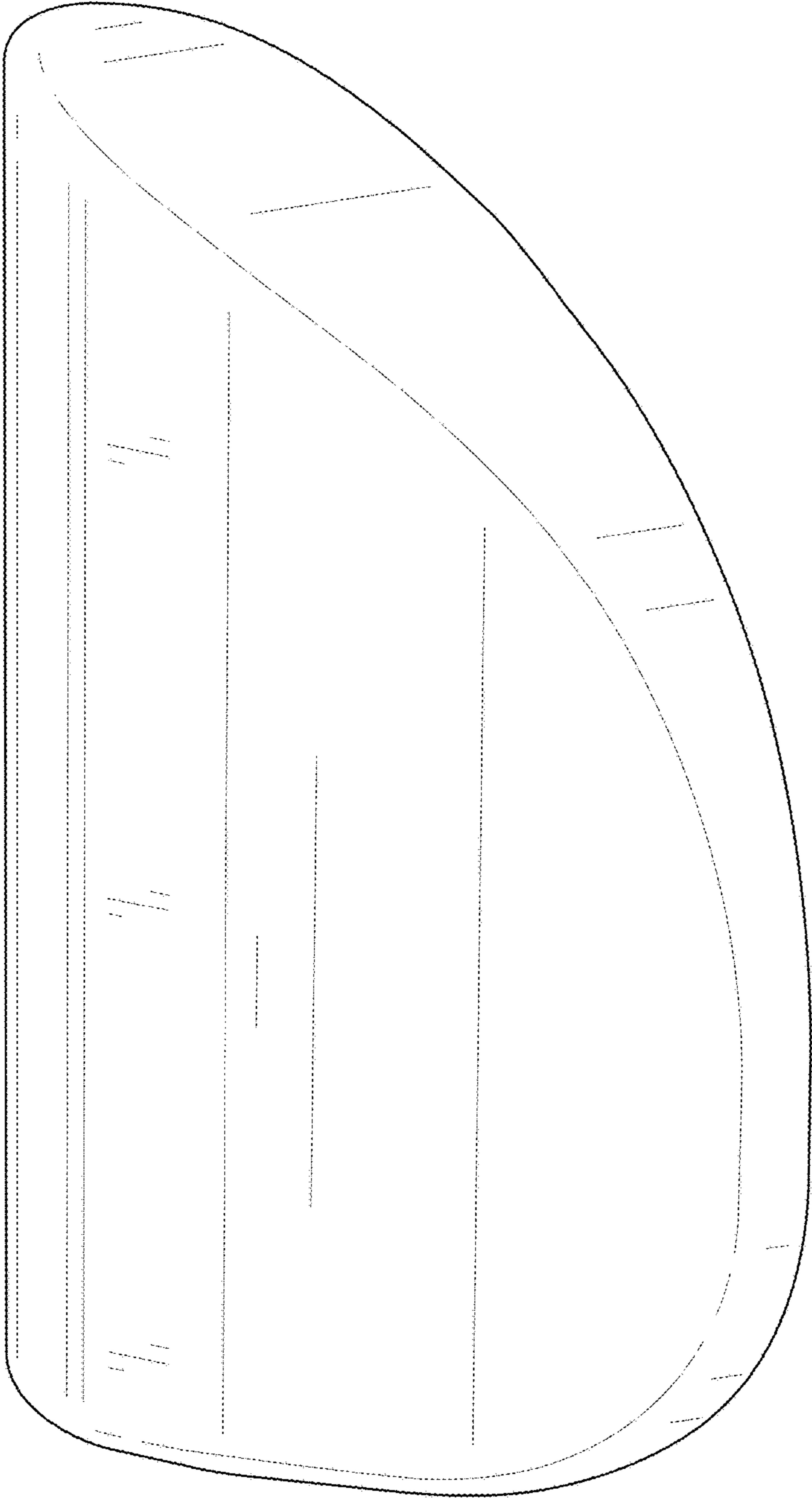

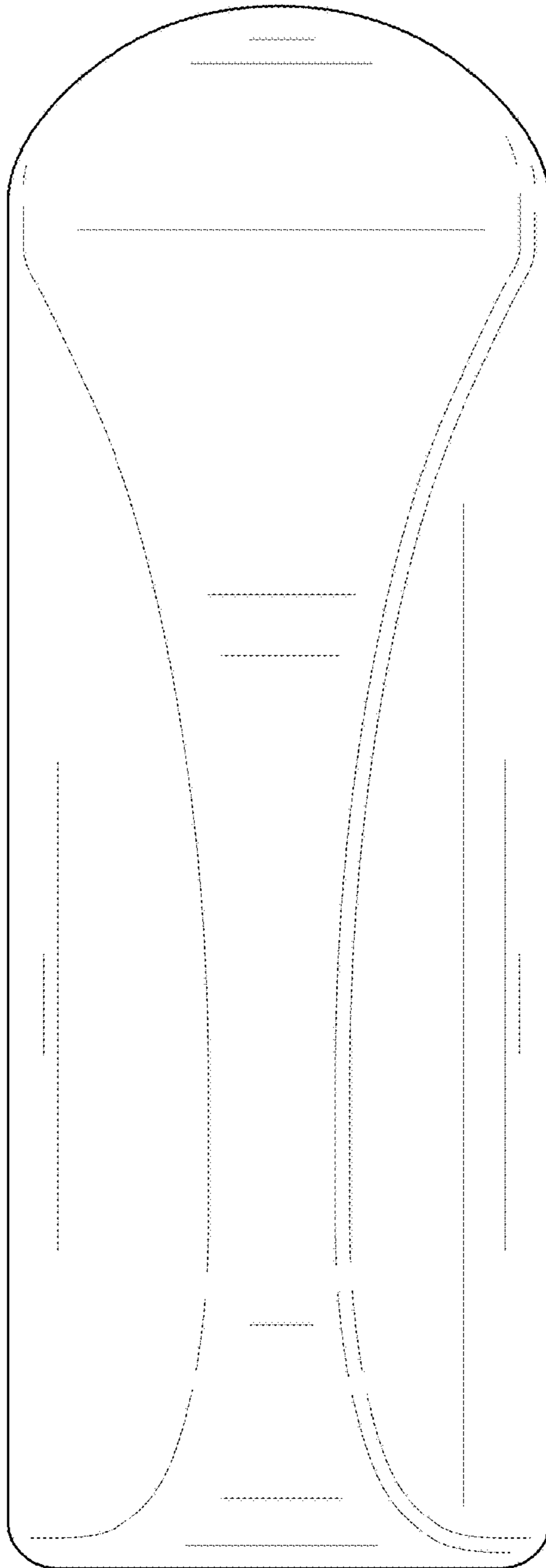

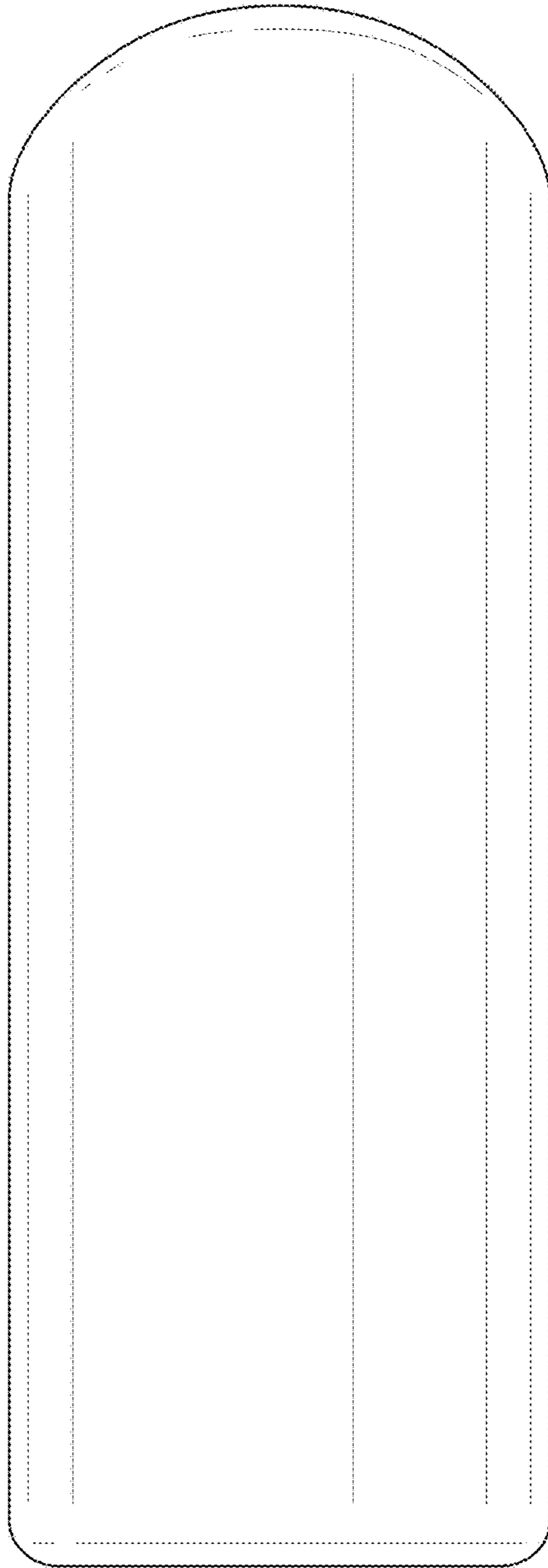

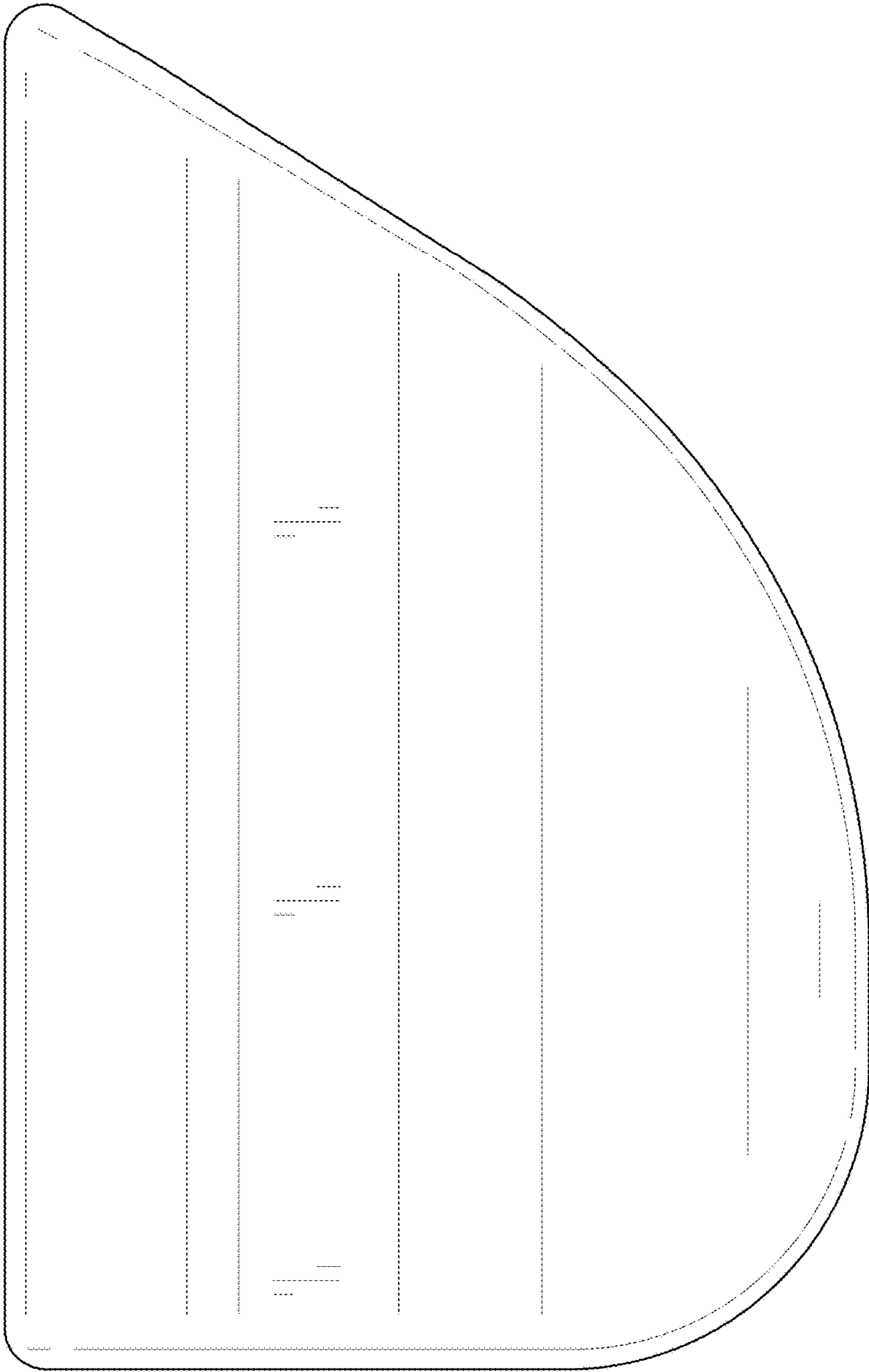

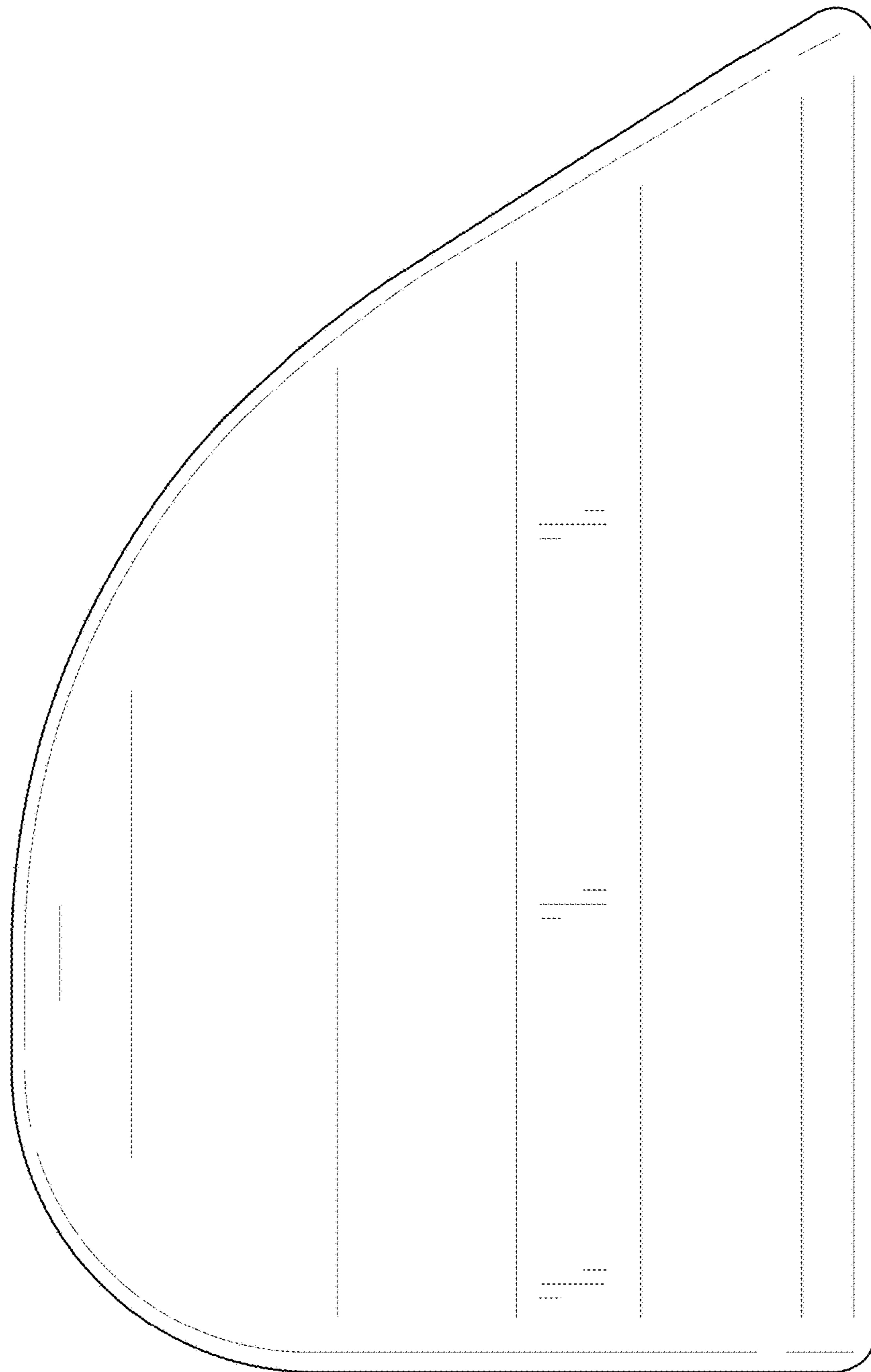

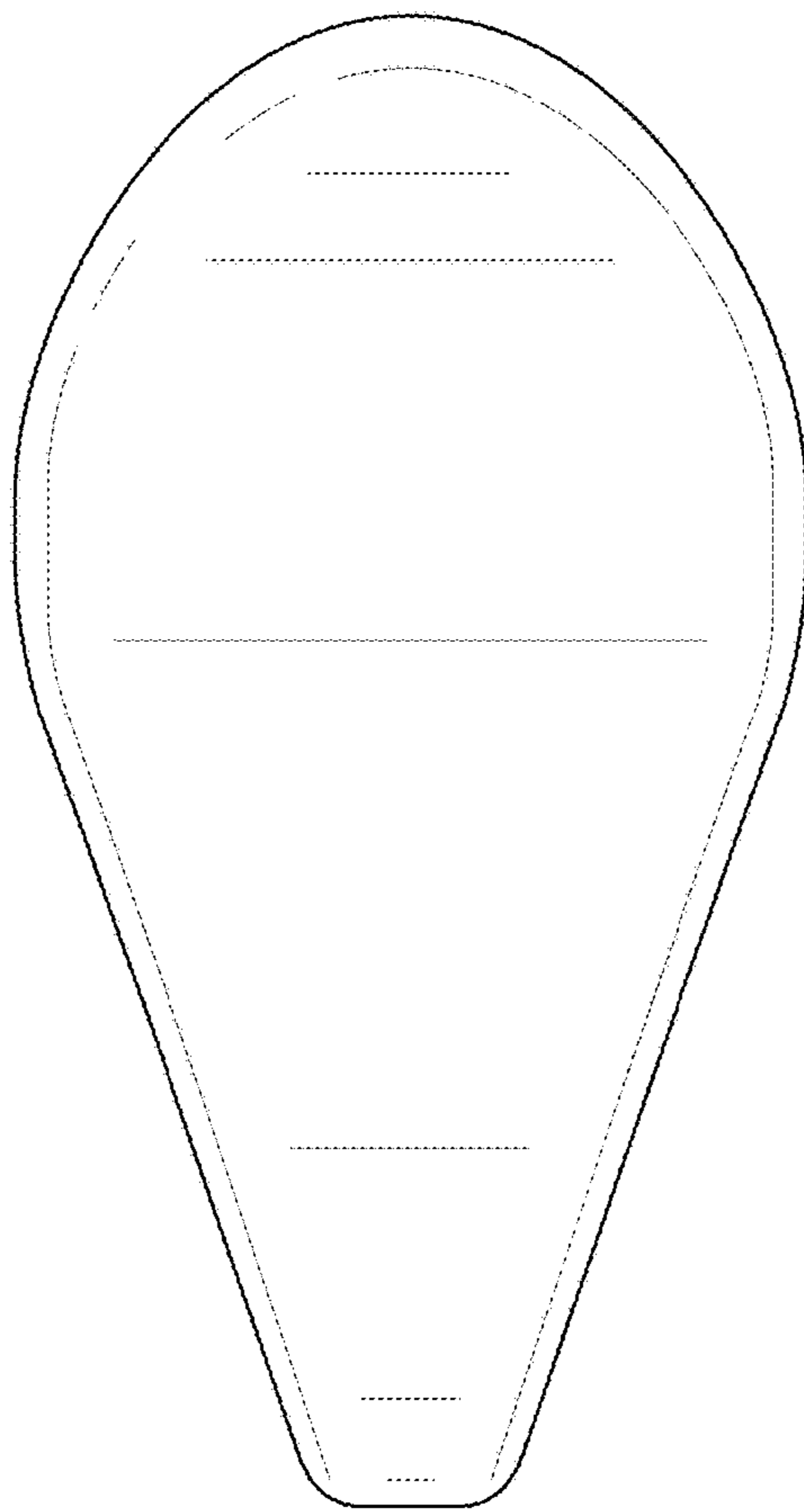

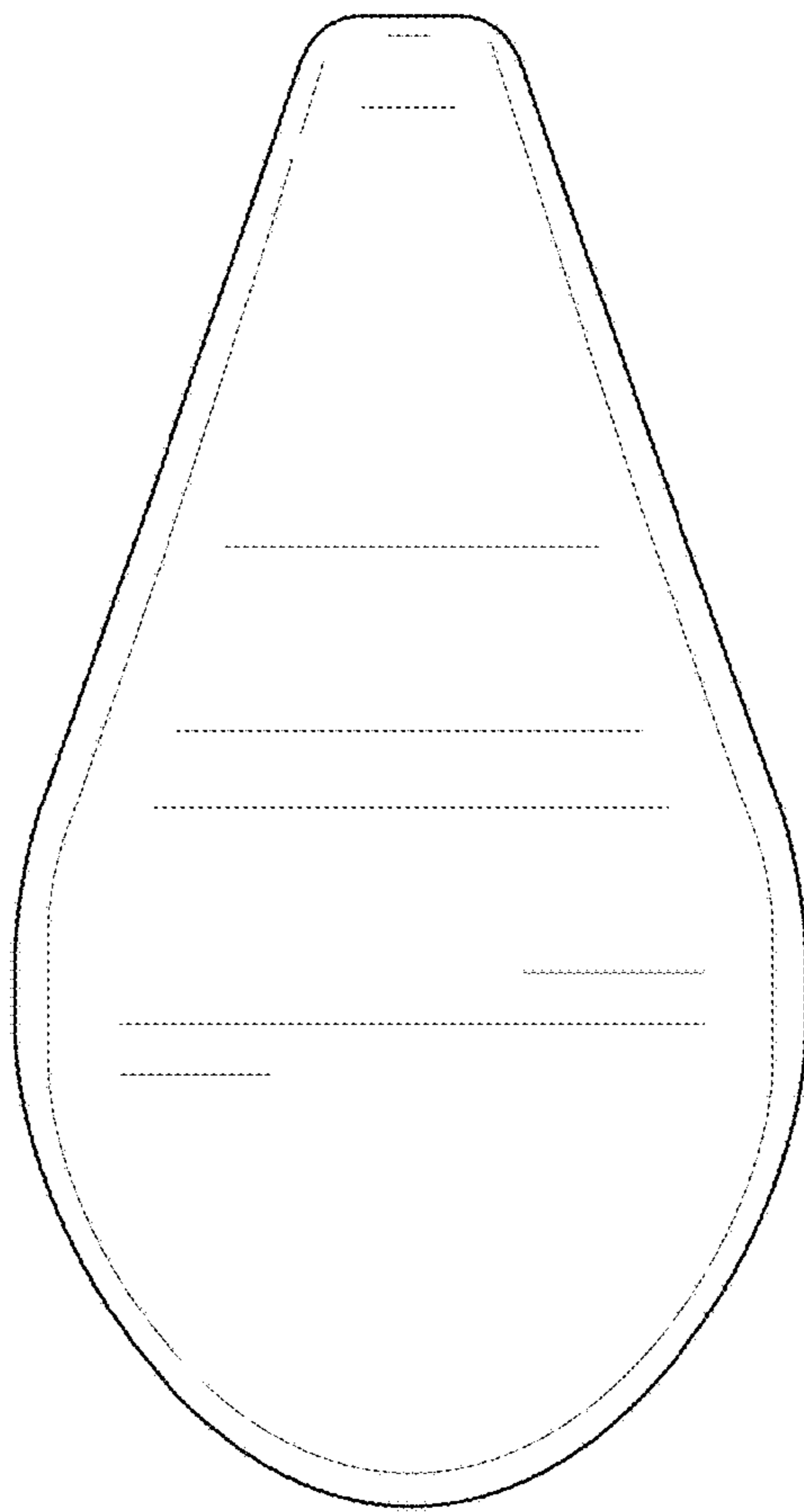
