(57) **CLAIM**

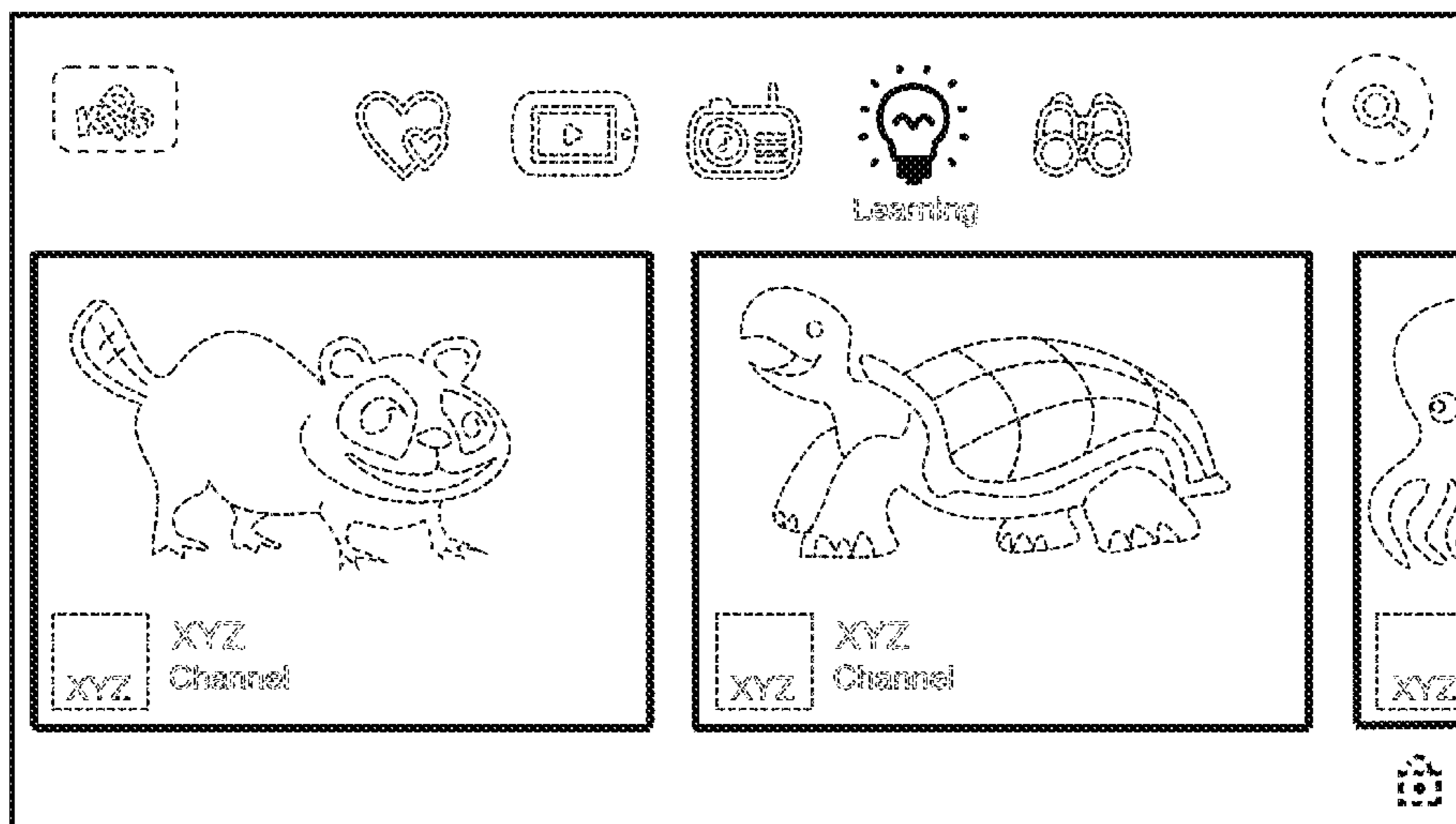
The ornamental design for a portion of a display panel with a graphical user interface with icons, as shown and described.
