(57) **CLAIM**

I claim the ornamental design for a display screen or portion thereof with graphical user interface, as shown and described.

DESCRIPTION

The FIGURE is a front view of a display screen or portion thereof with a graphical user interface. The outermost broken-line rectangle illustrates the perimeter of a display screen or portion thereof and forms no part of the claimed design. The remaining broken lines illustrate portions of a graphical user interface and form no part of the claimed design.
