FIG. 2 shows a second image thereof;

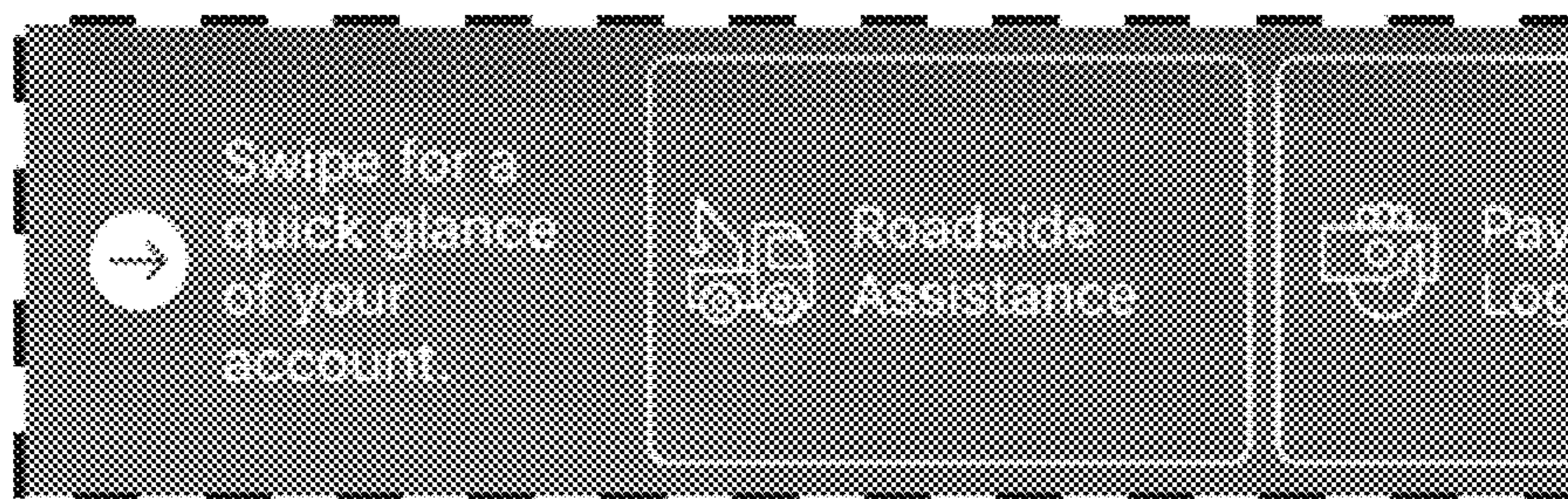
FIG. 5 shows a third image thereof; and,

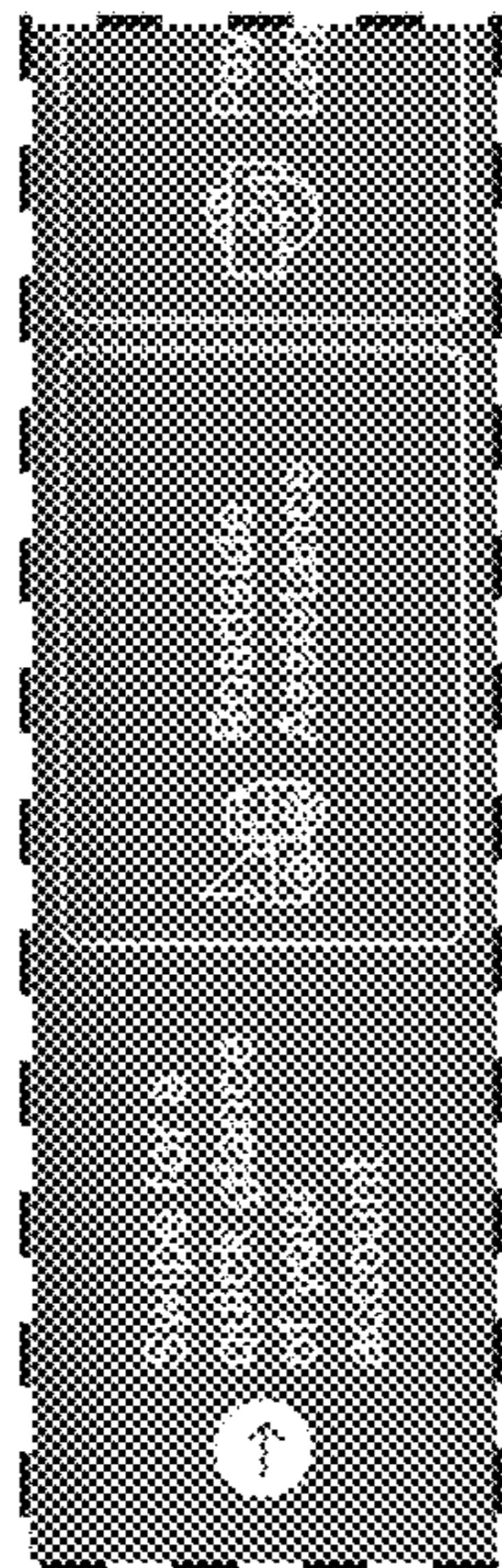

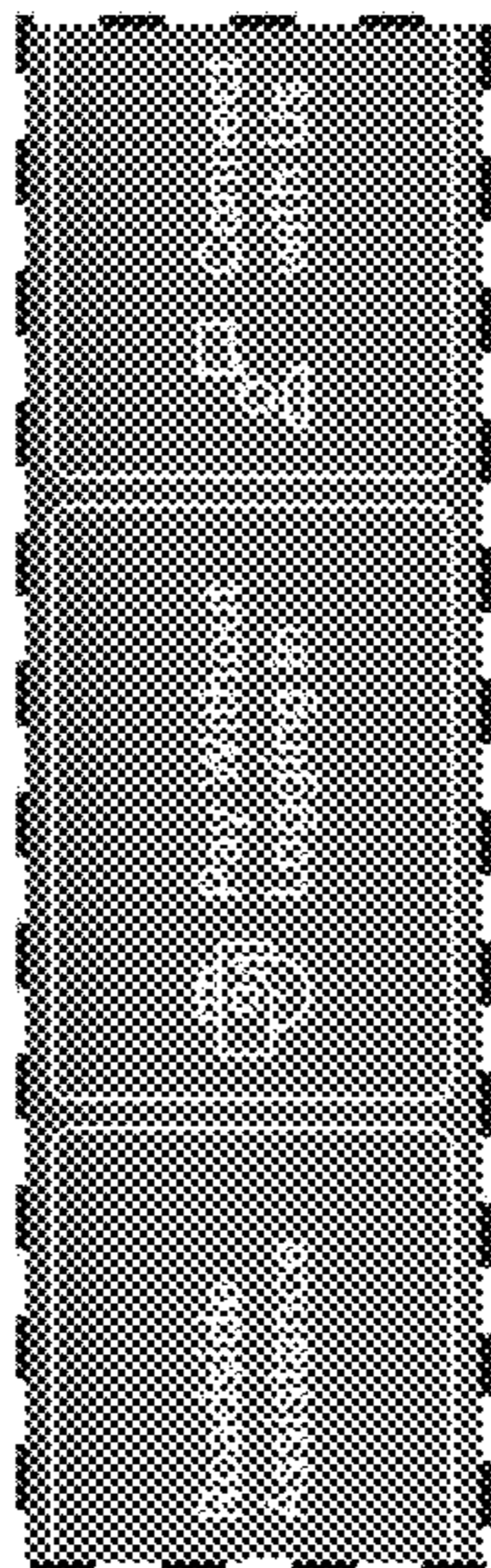

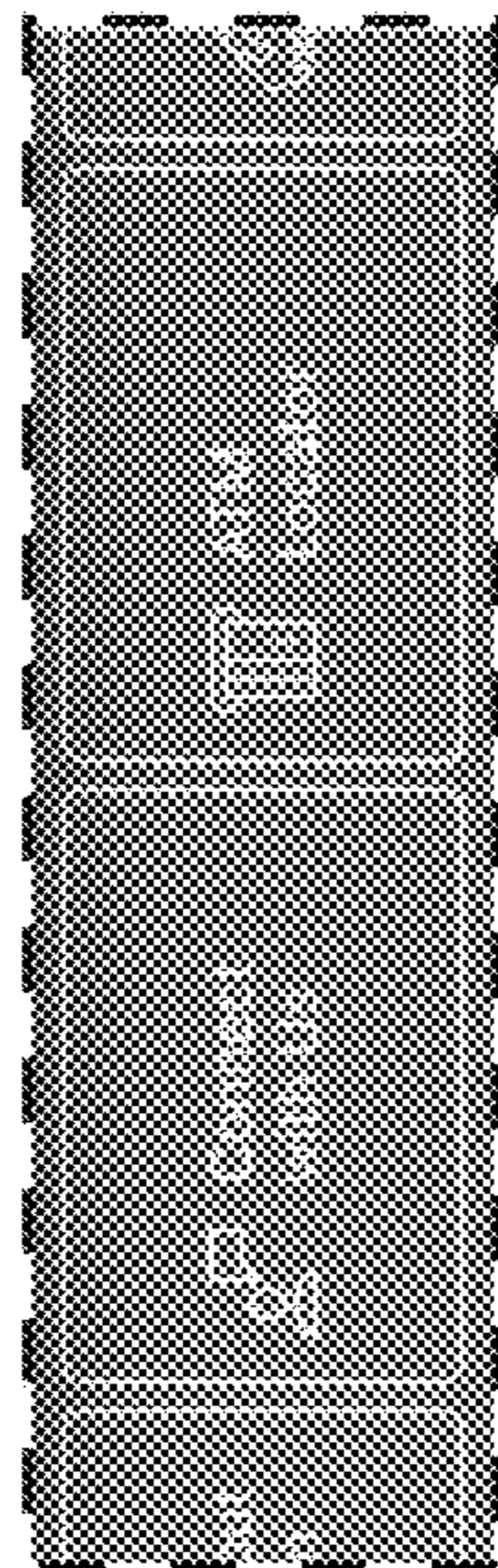

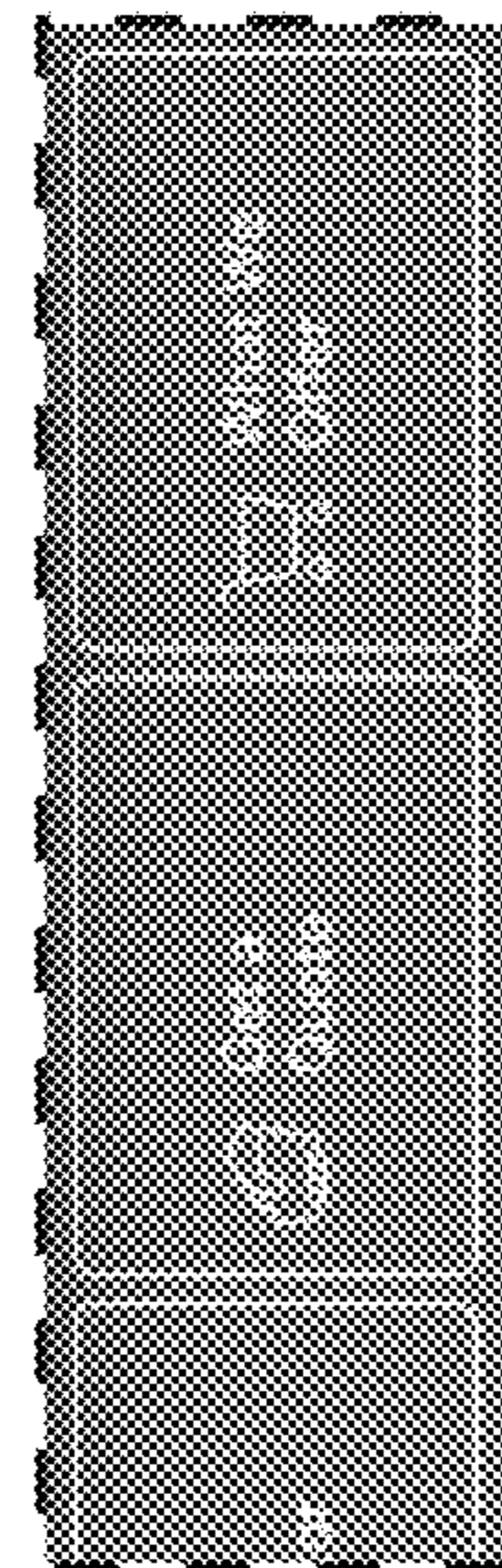
