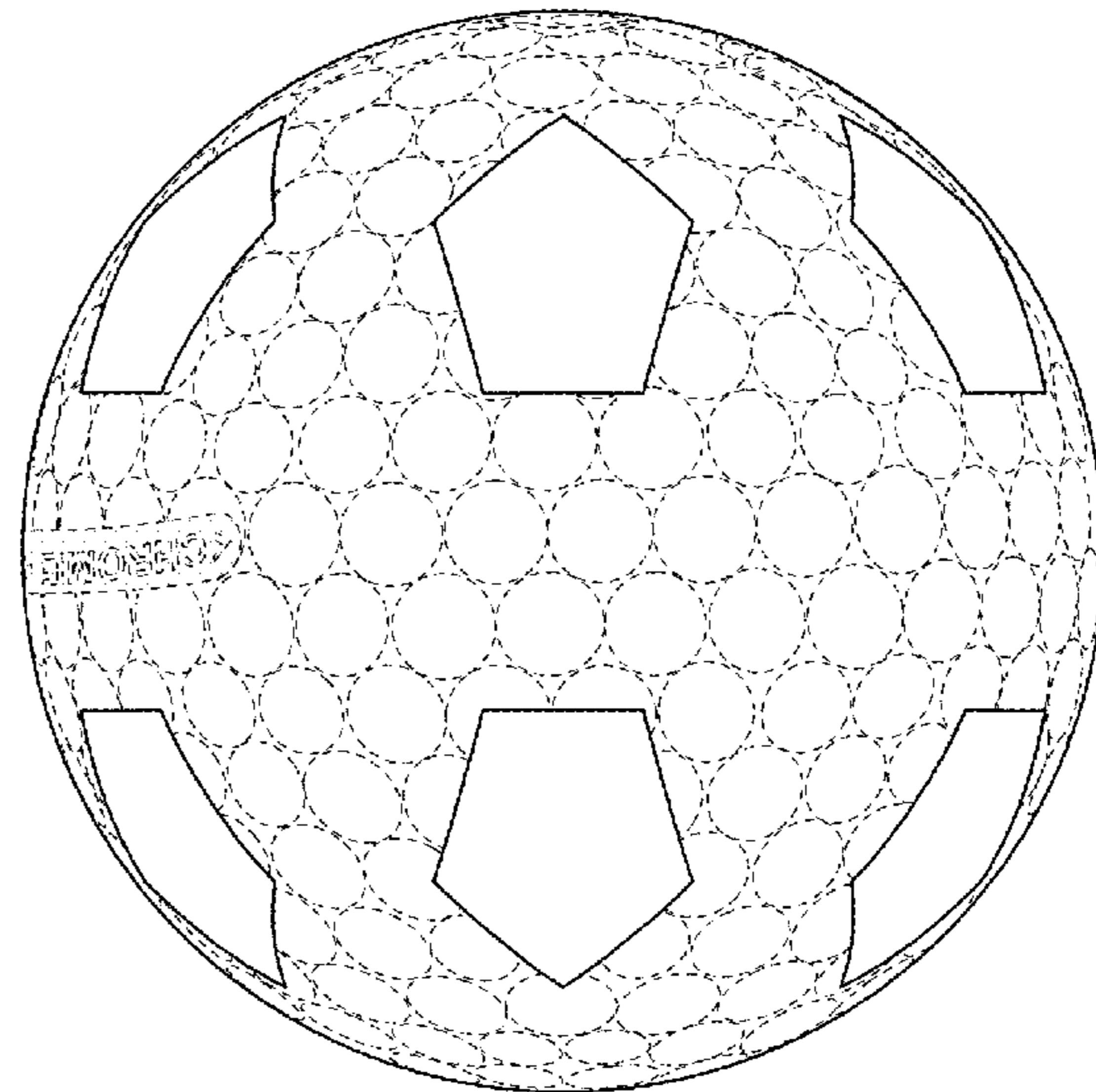
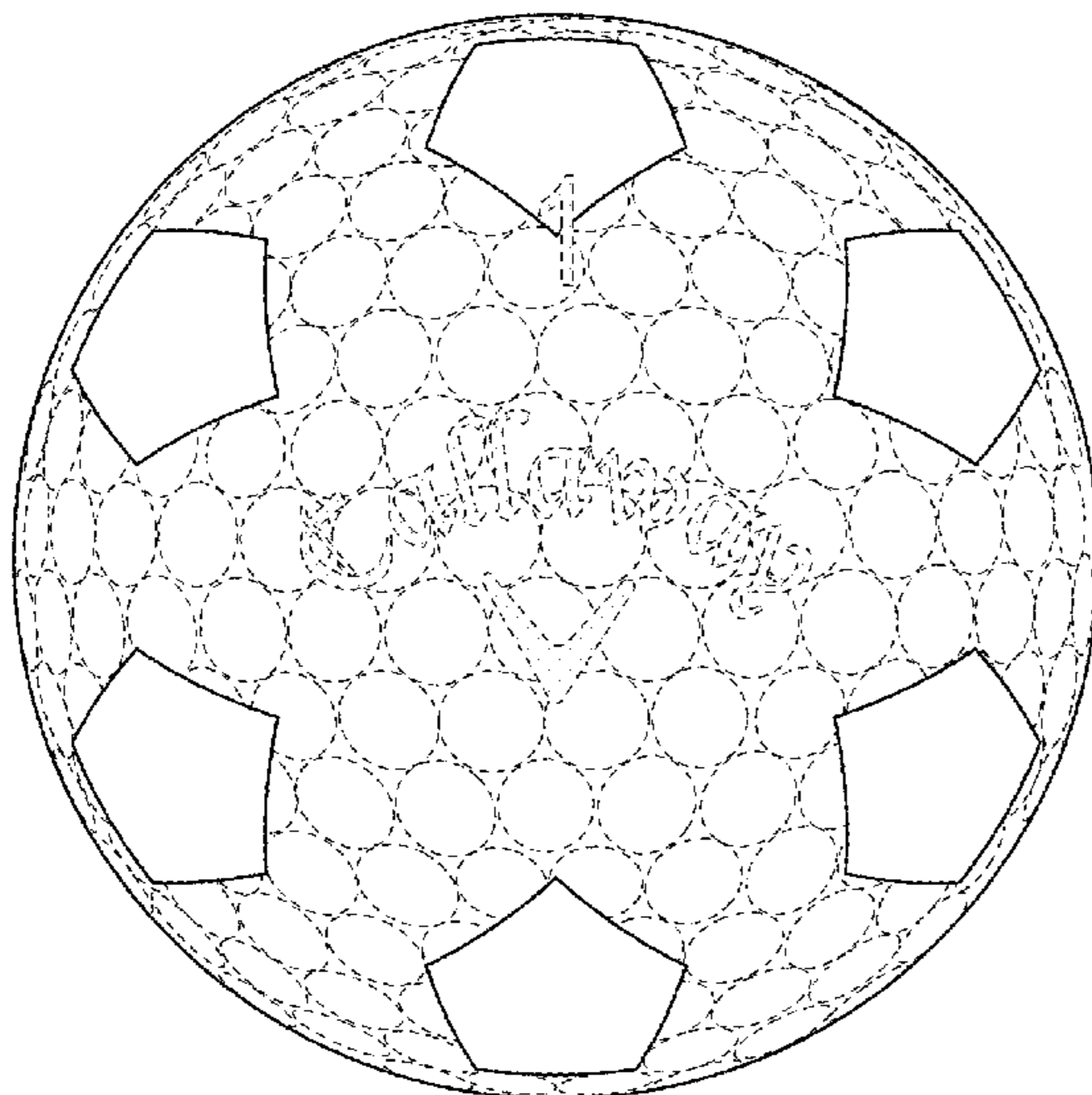
(57) **CLAIM**

The ornamental design for a golf ball, as shown and described.

**DESCRIPTION**

FIG. 1 is a top plan view showing our new design for a golf ball with a pattern of twelve equal size pentagons;  
FIG. 2 is bottom plan view thereof;  
FIG. 3 is a right side elevation view thereof;  
FIG. 4 is left side elevation view thereof;  
FIG. 5 is a rear elevation view thereof; and,  
FIG. 6 is a front elevation view thereof.  
The broken lines in the figures represent features of the golf ball that form no part of the claimed design.

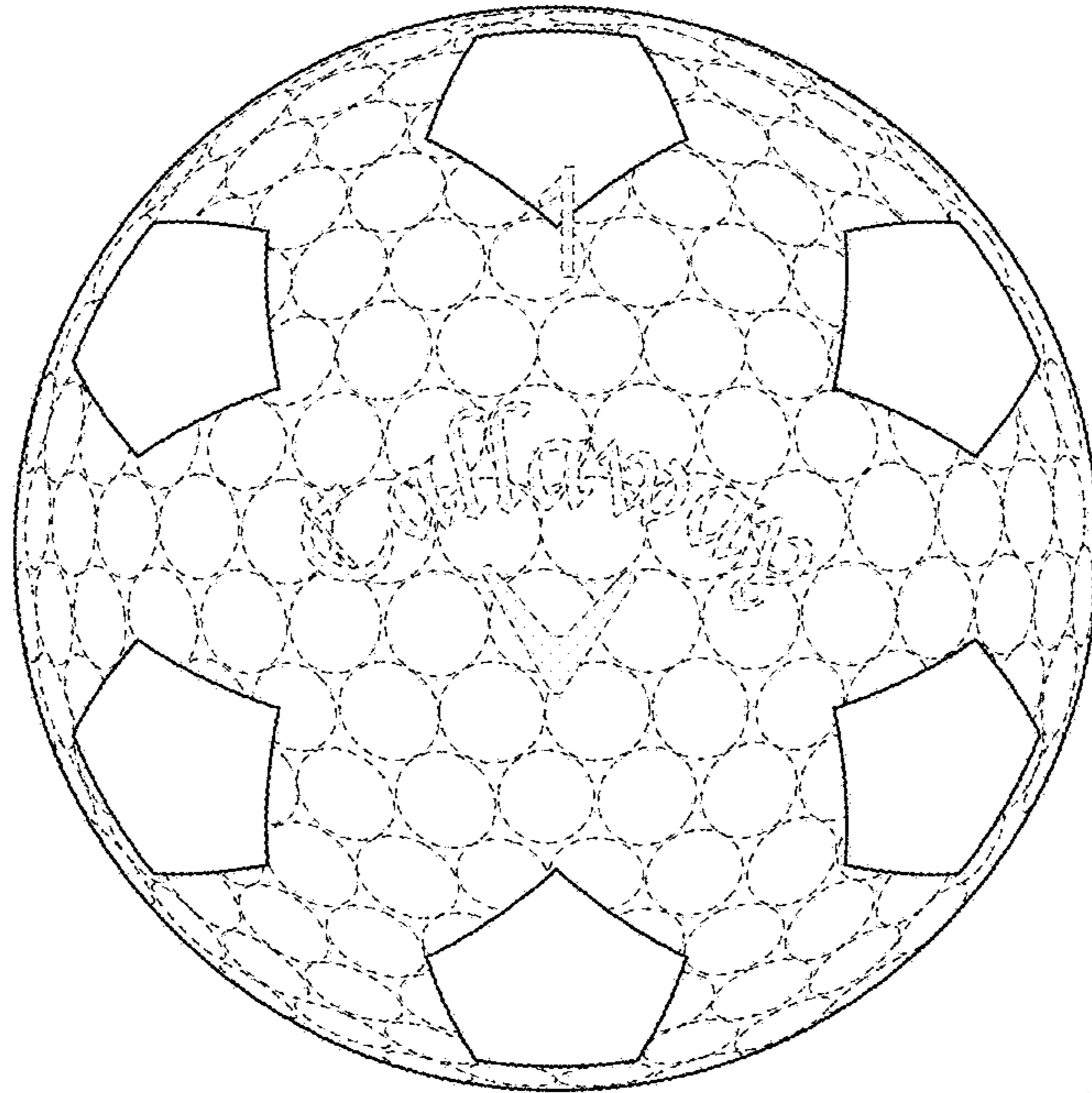

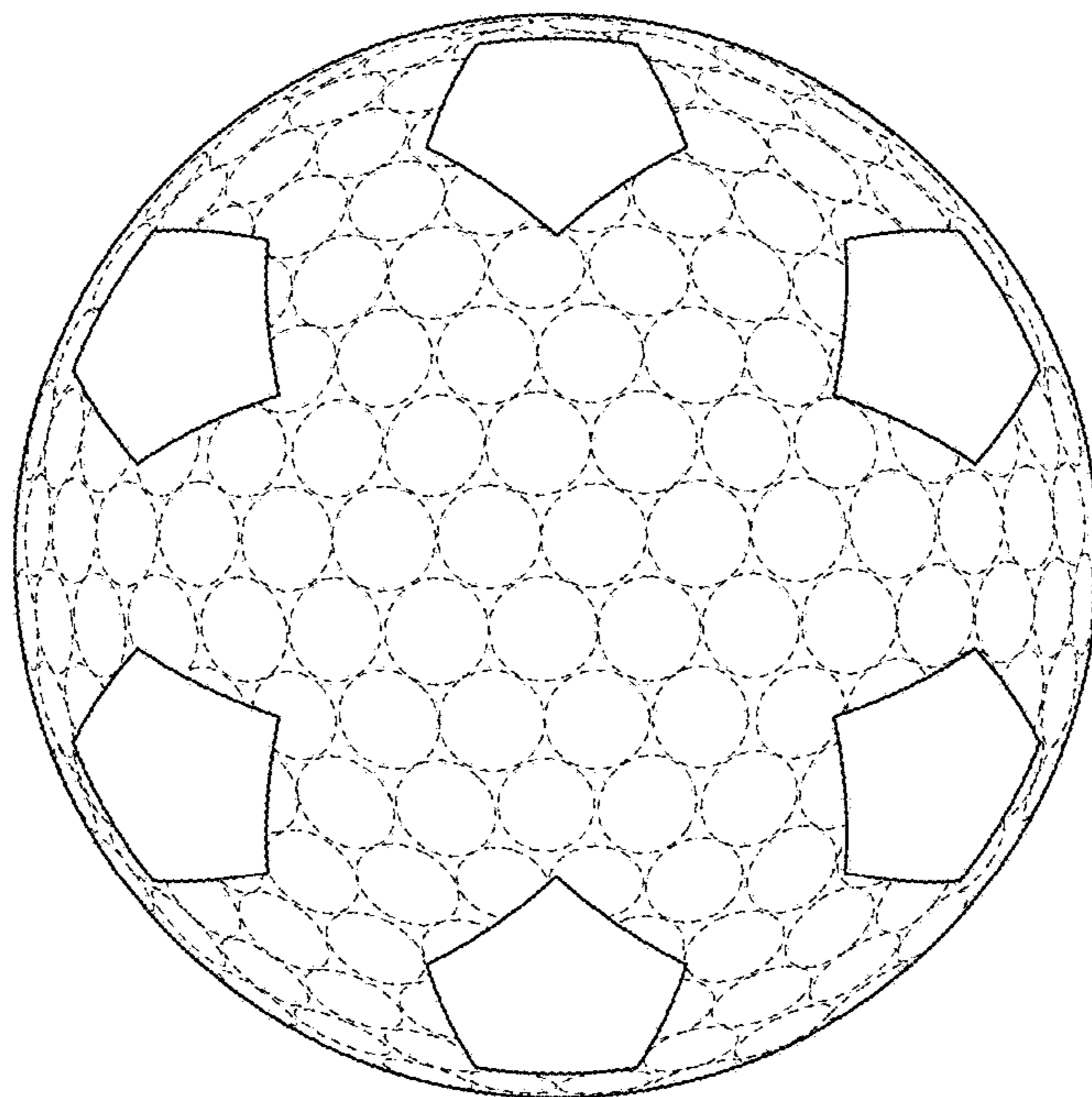

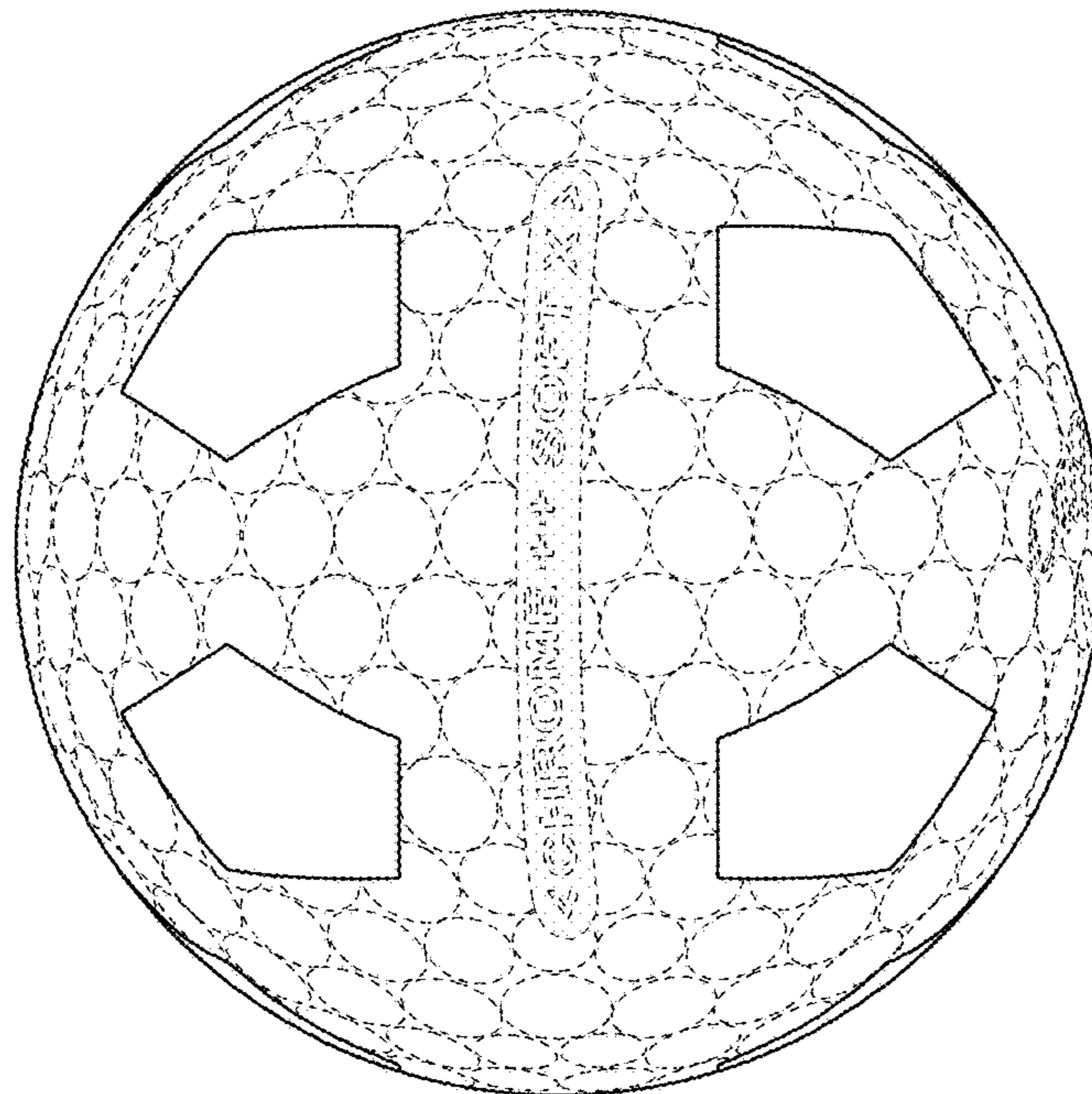

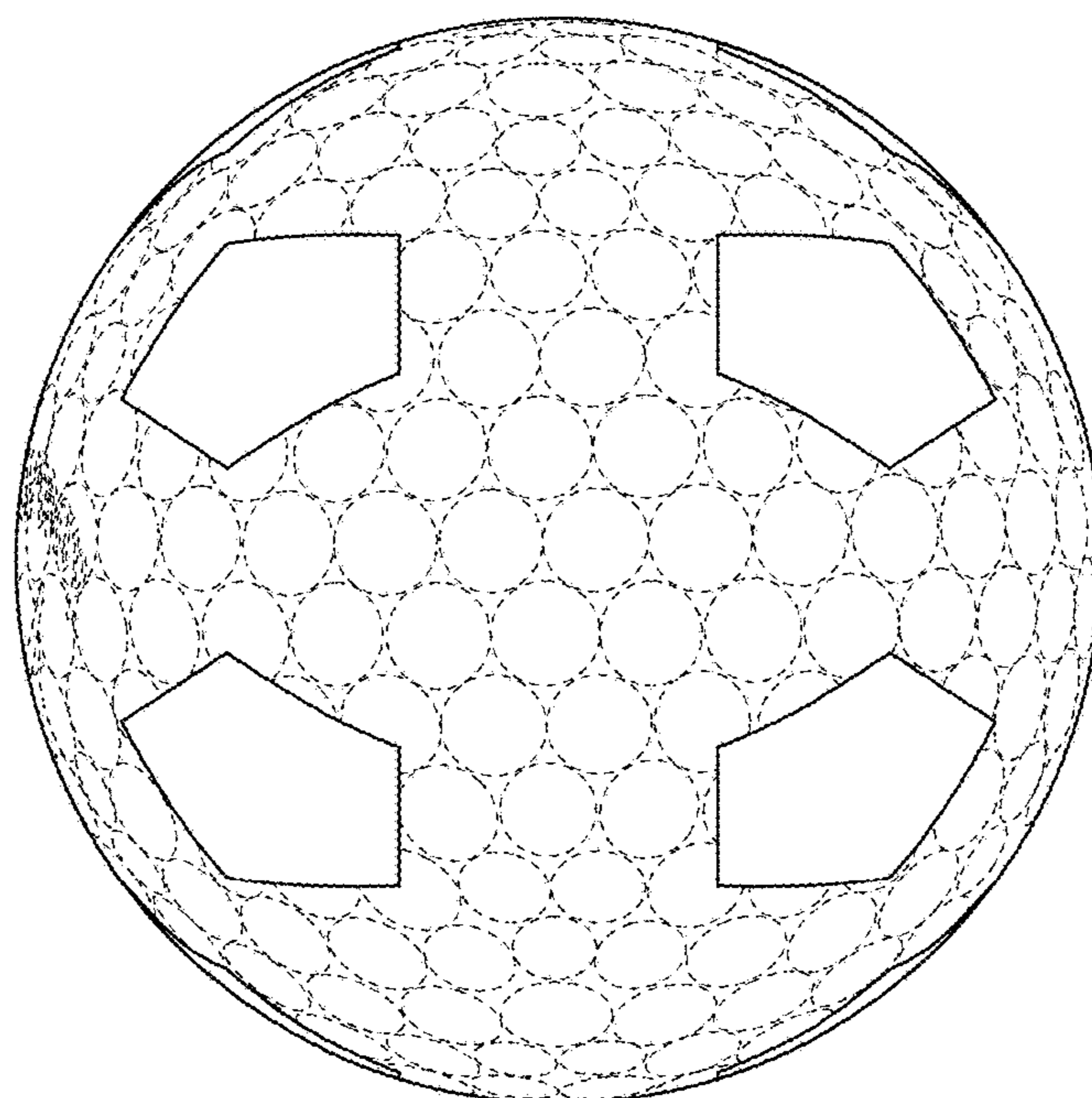

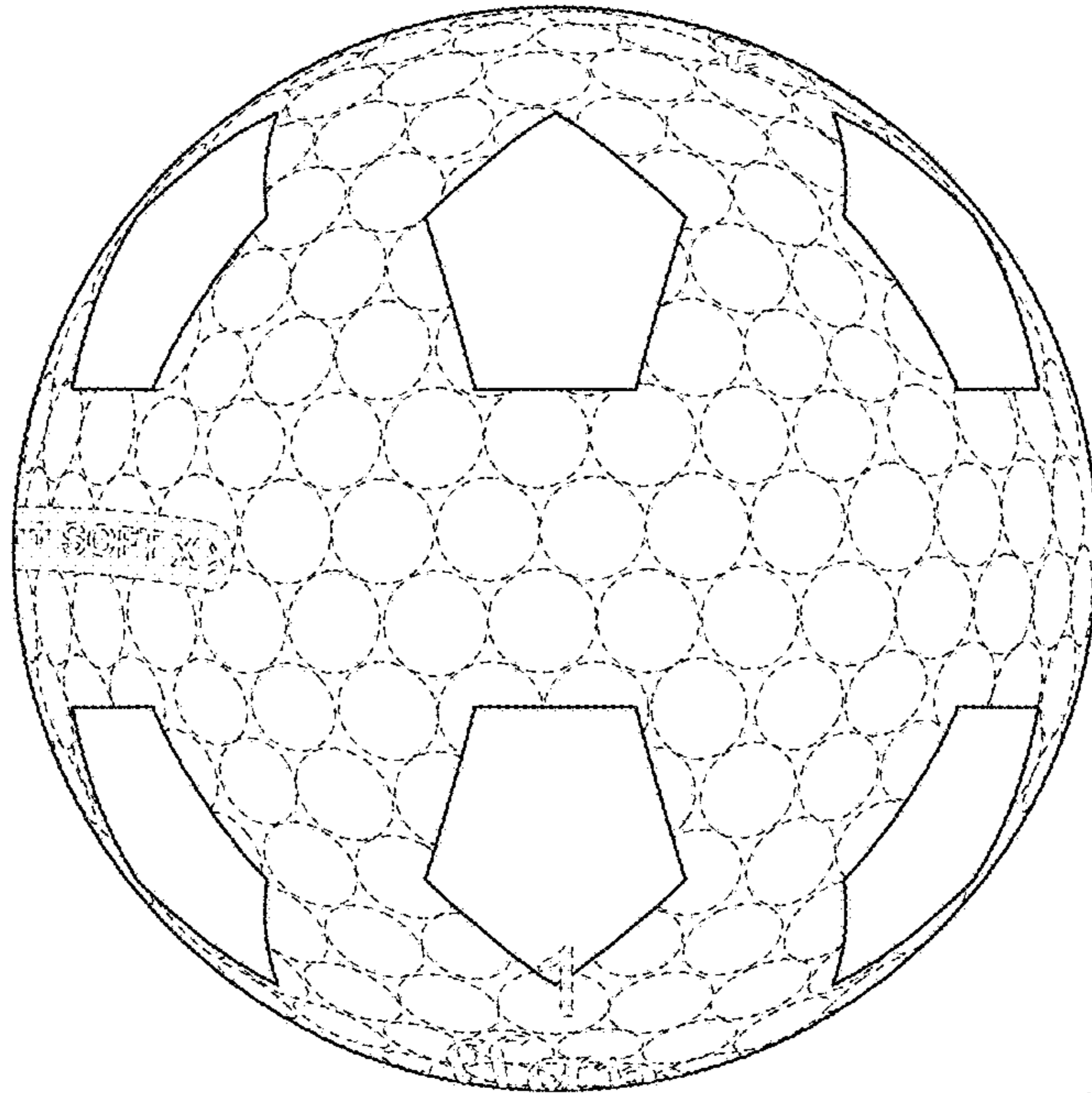

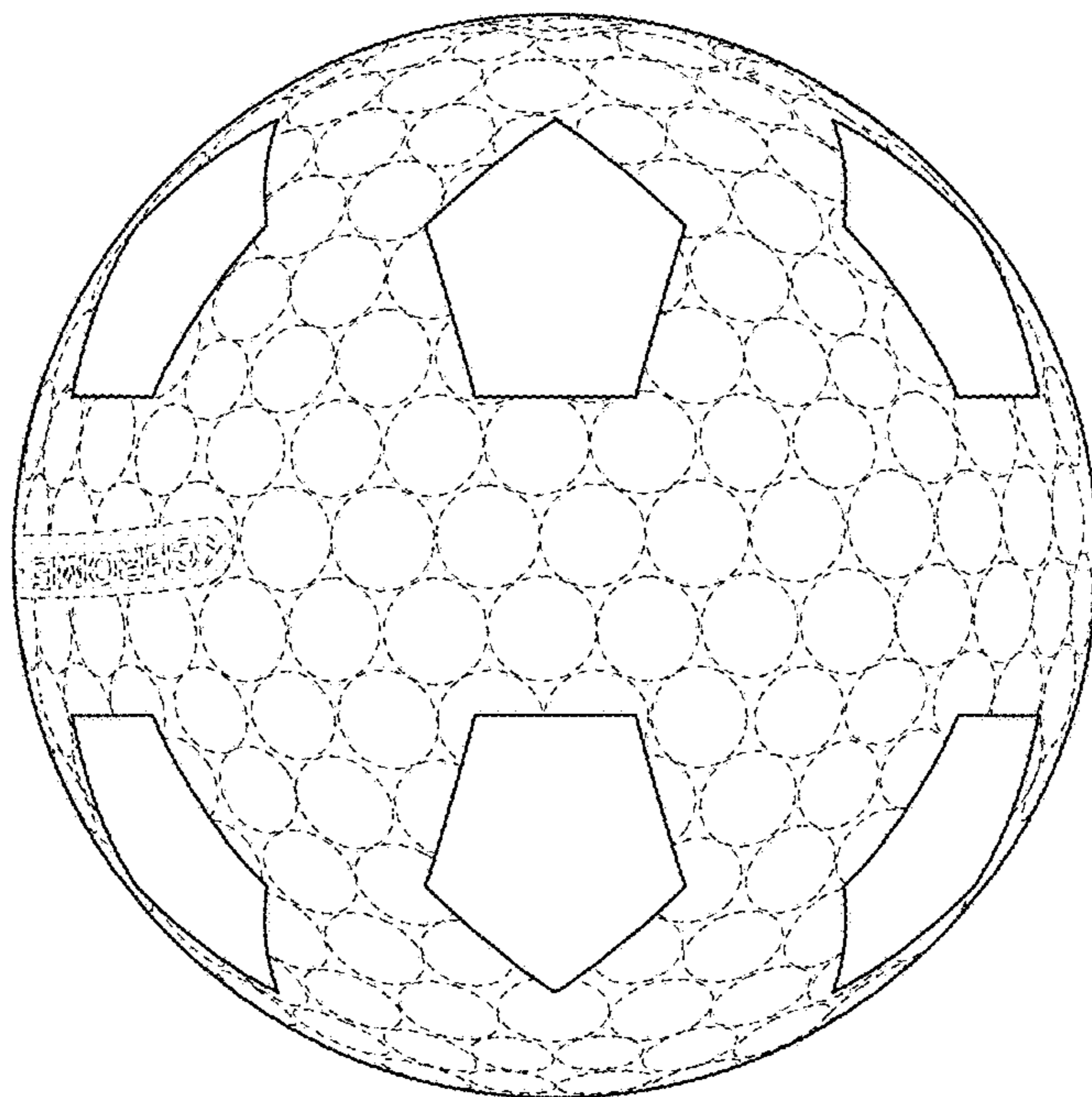
