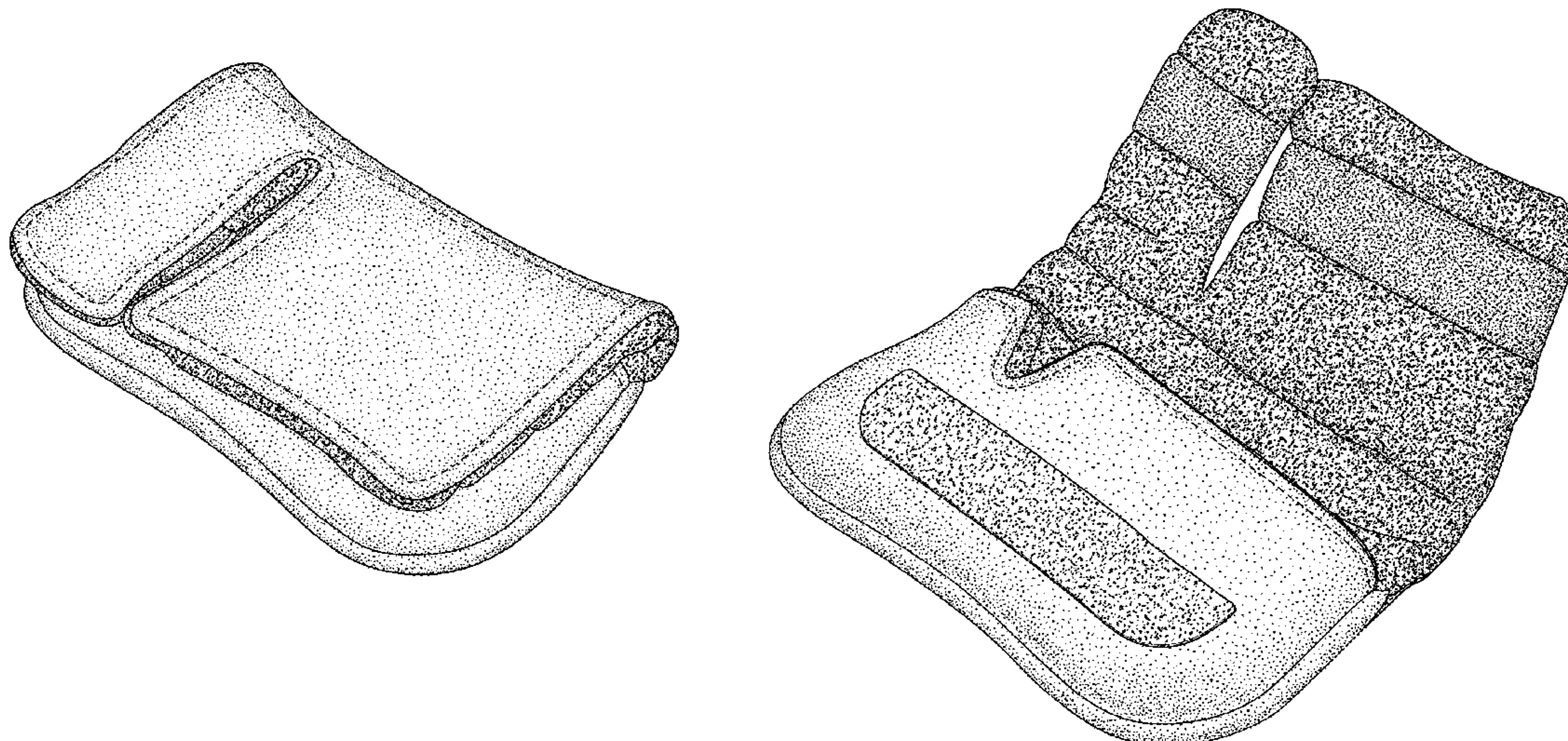
(57) **CLAIM**

The ornamental design for a golf club head cover, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a new golf club head cover design; FIG. 2 is a left side view thereof; FIG. 3 is a right side view thereof; FIG. 4 is a top side view thereof; FIG. 5 is a back side view thereof; FIG. 6 is a bottom side view thereof; FIG. 7 is a front side view thereof; and, FIG. 8 is a perspective view thereof, shown in an alternate position. The broken line showing is illustrating conventional stitching.

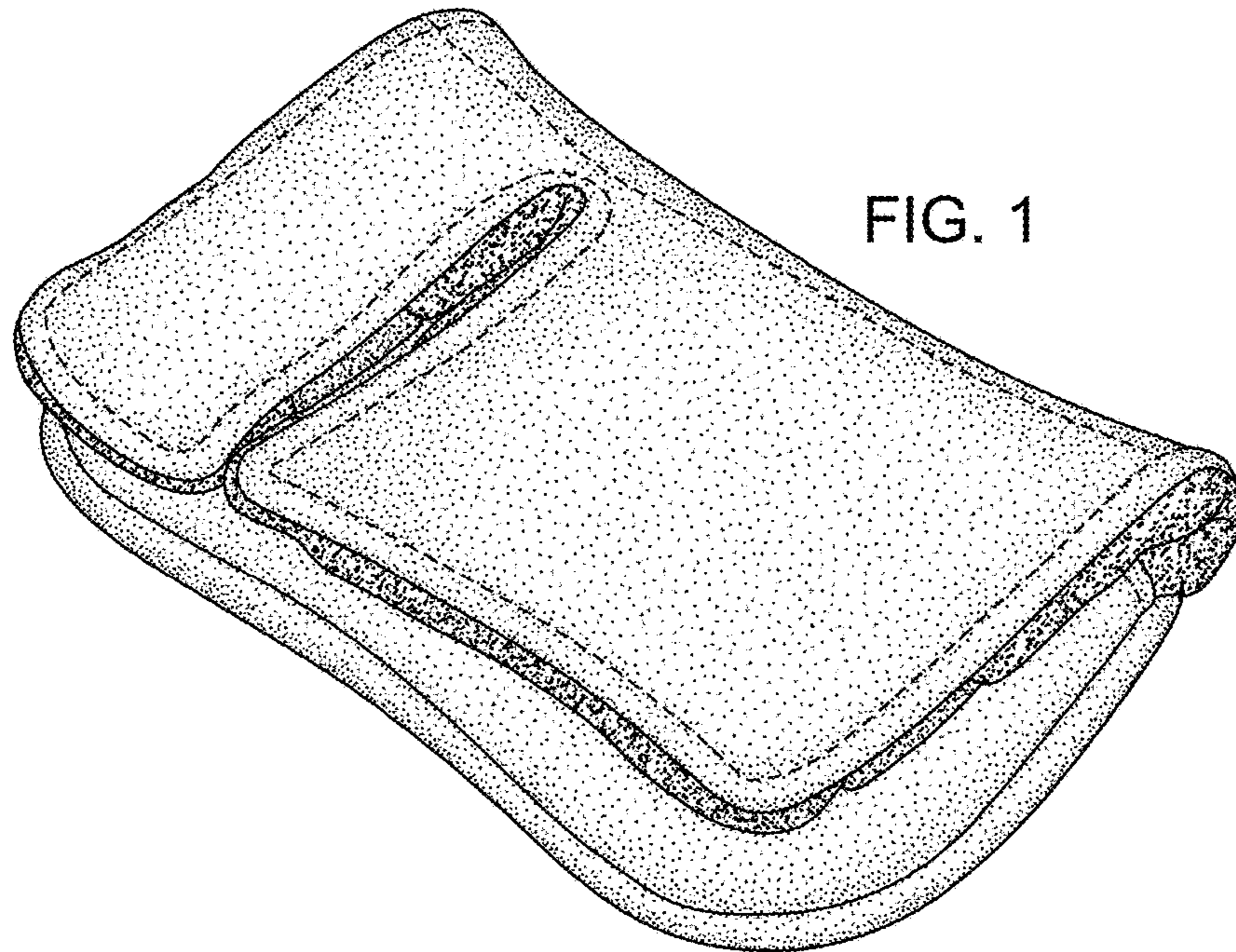

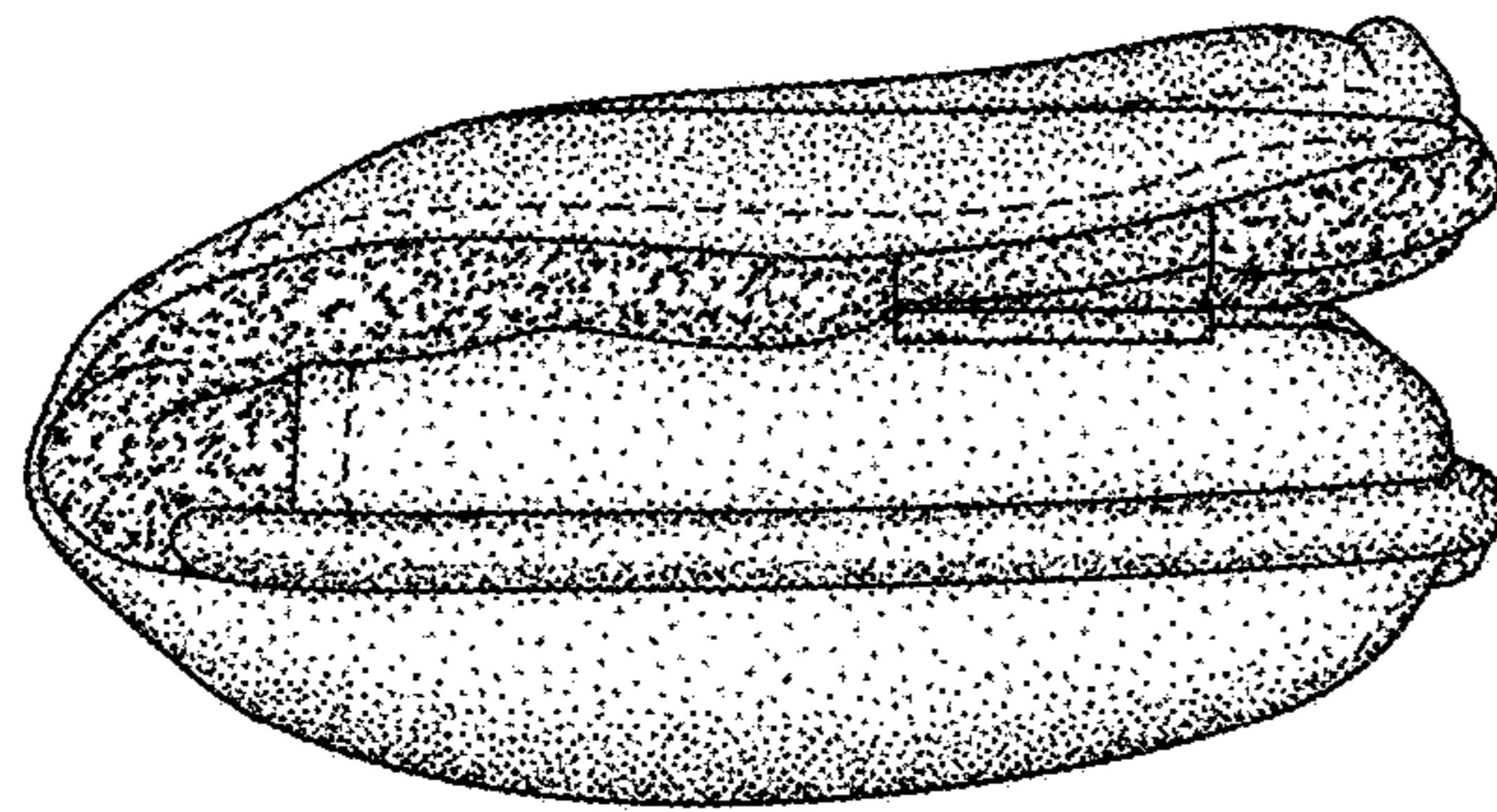

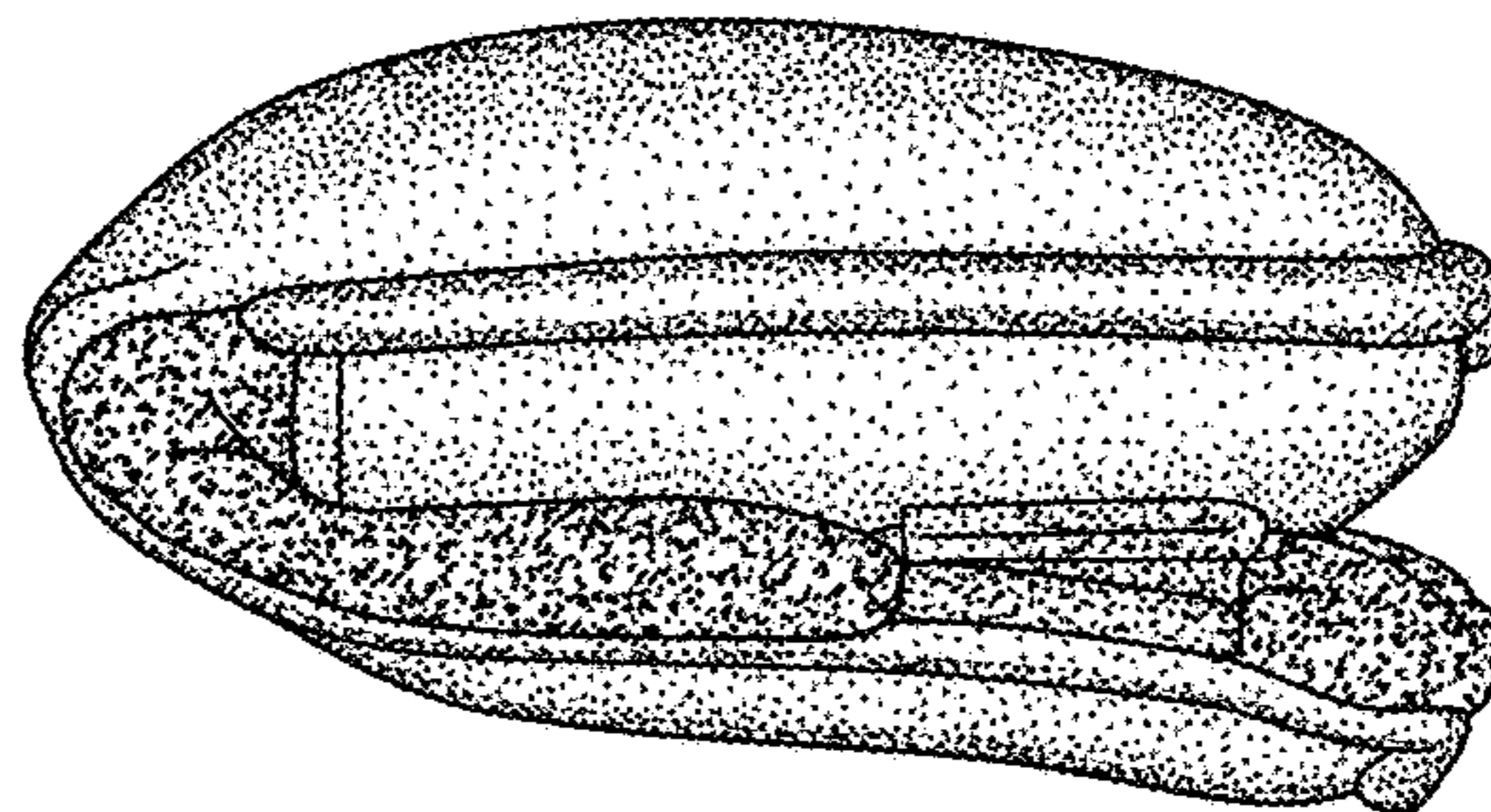

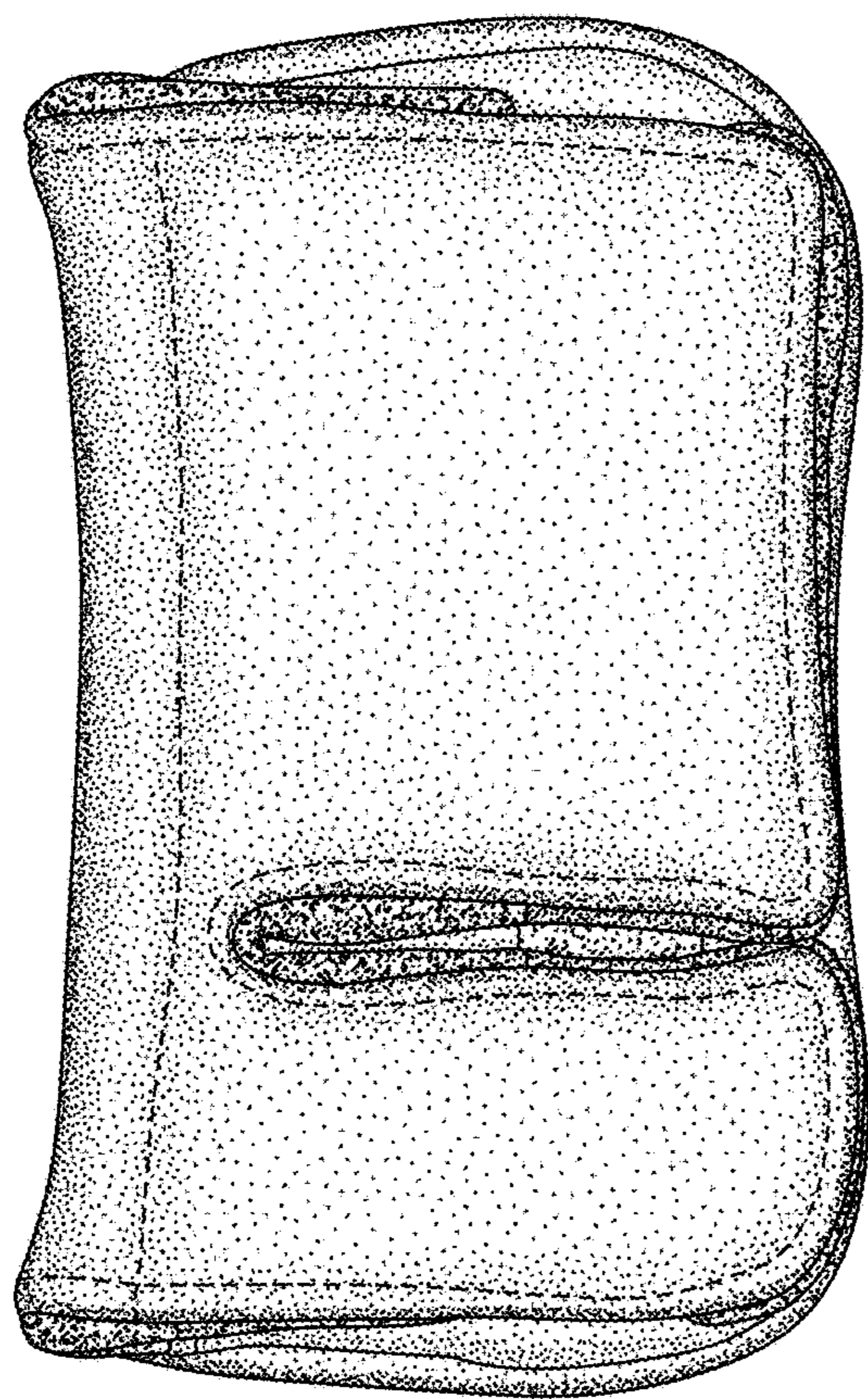

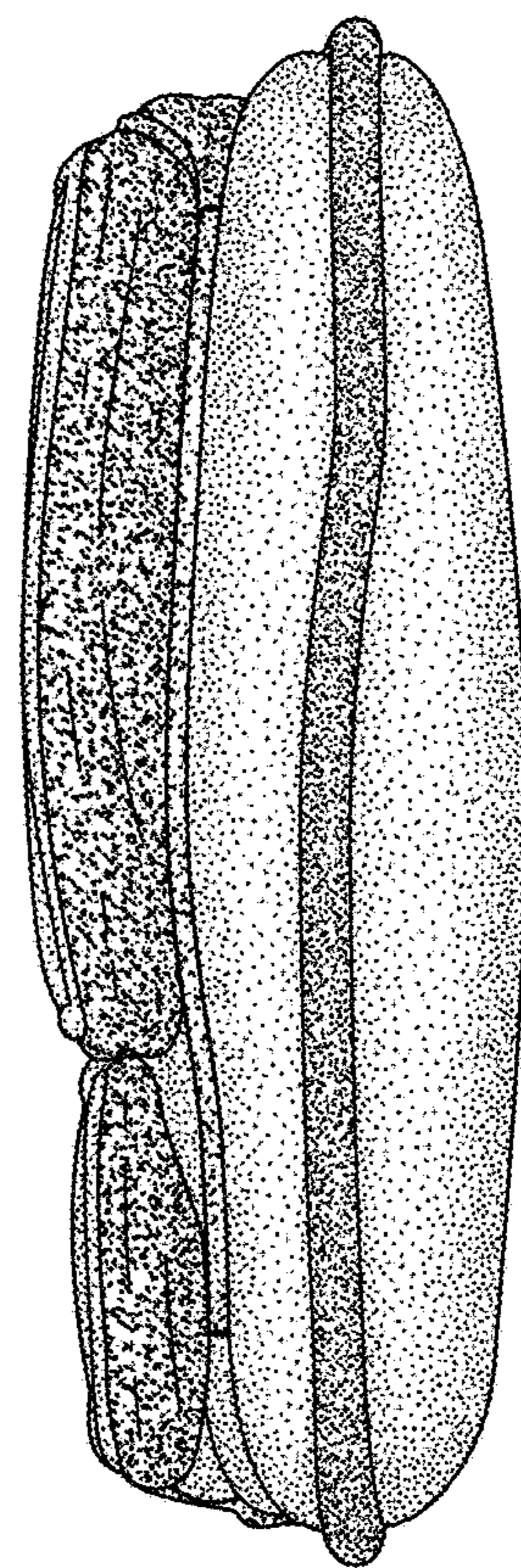

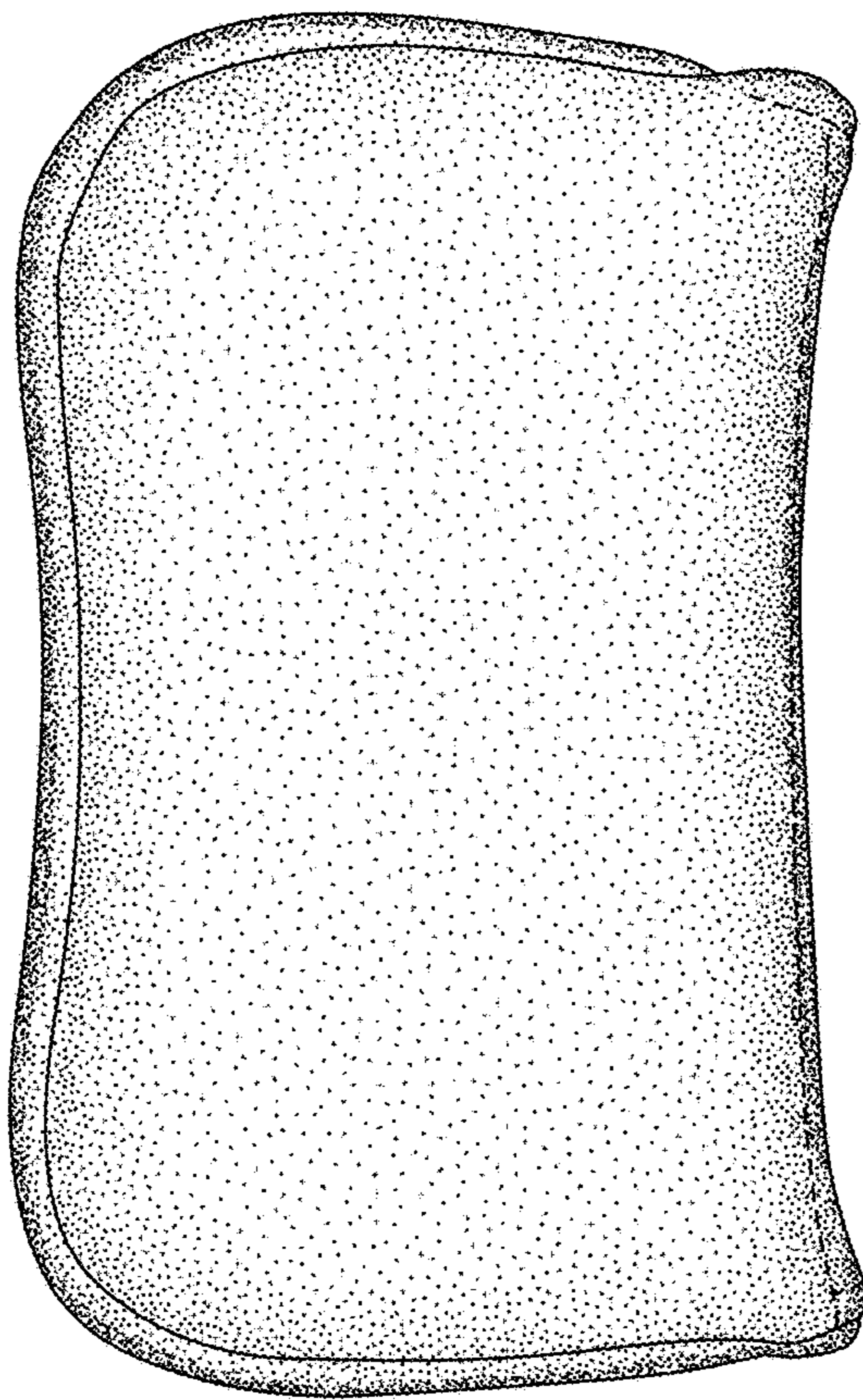

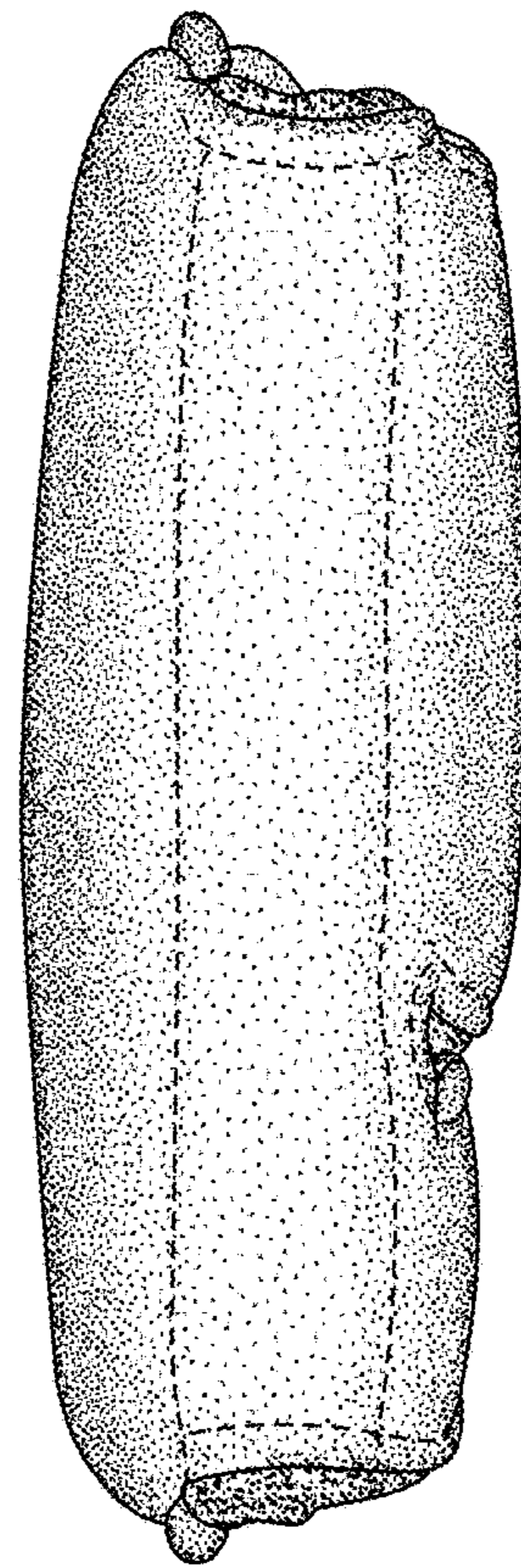

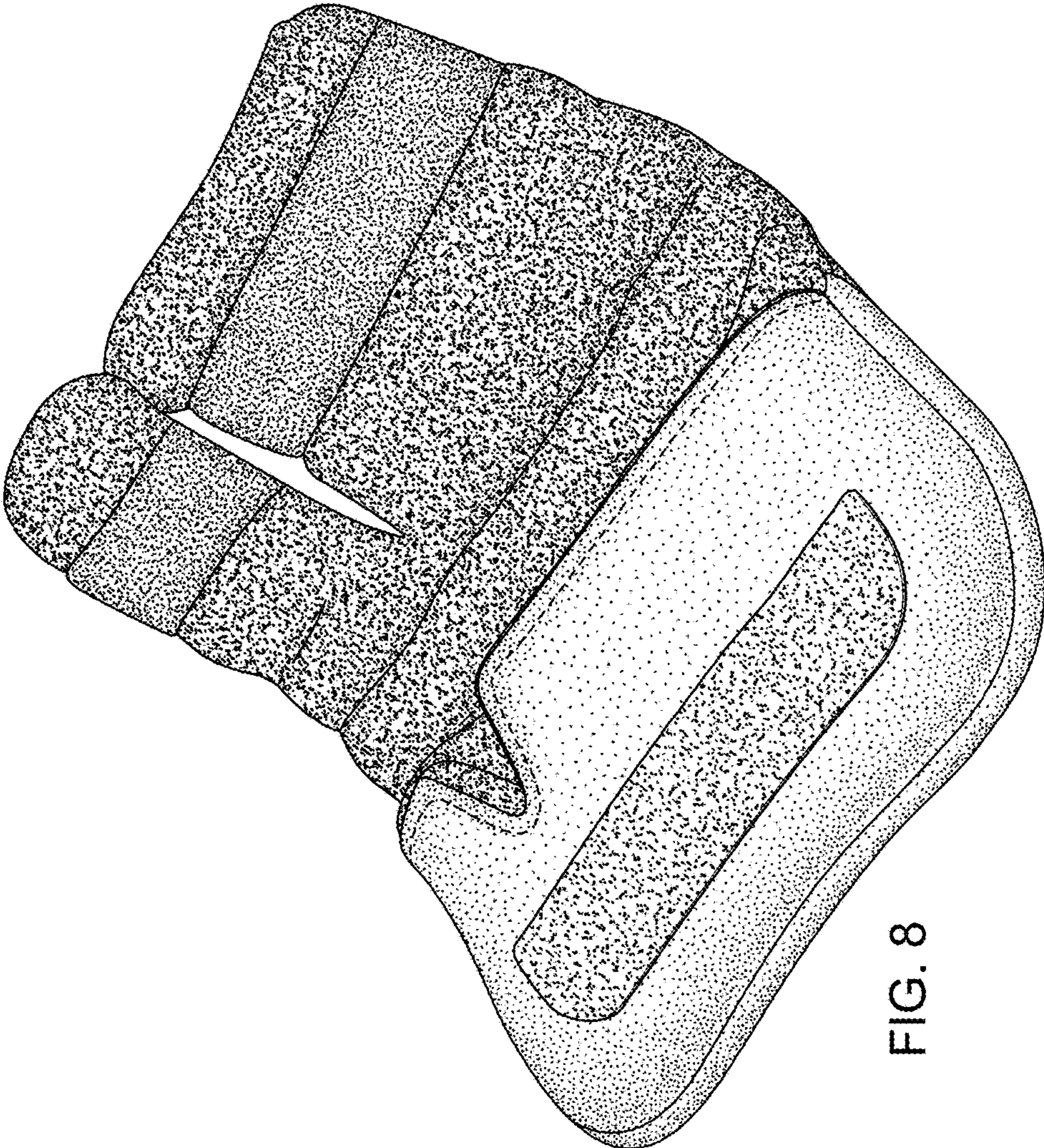
