FIG. 4 is a rear view of a container for a forced air warming machine showing the claimed design.

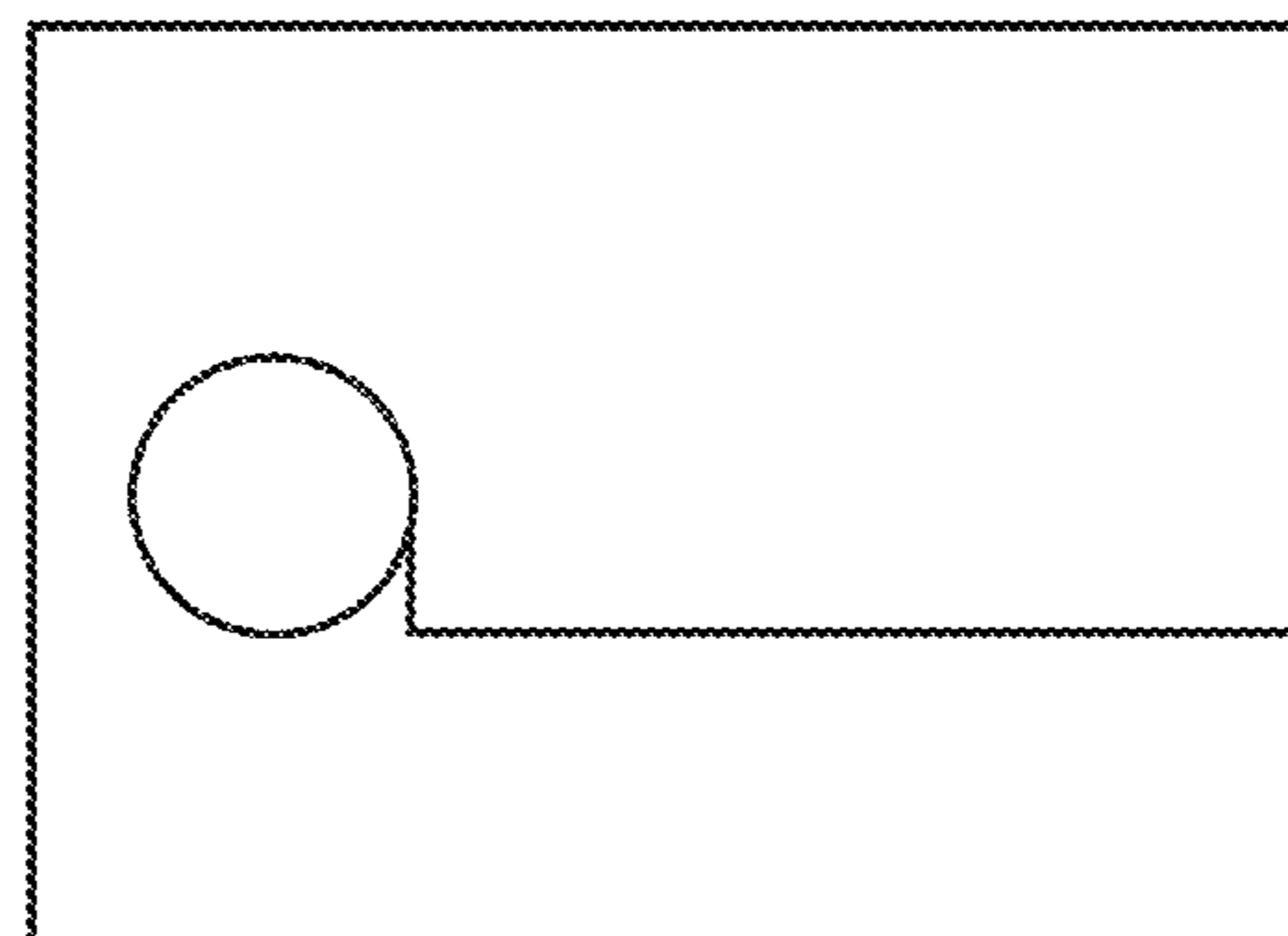
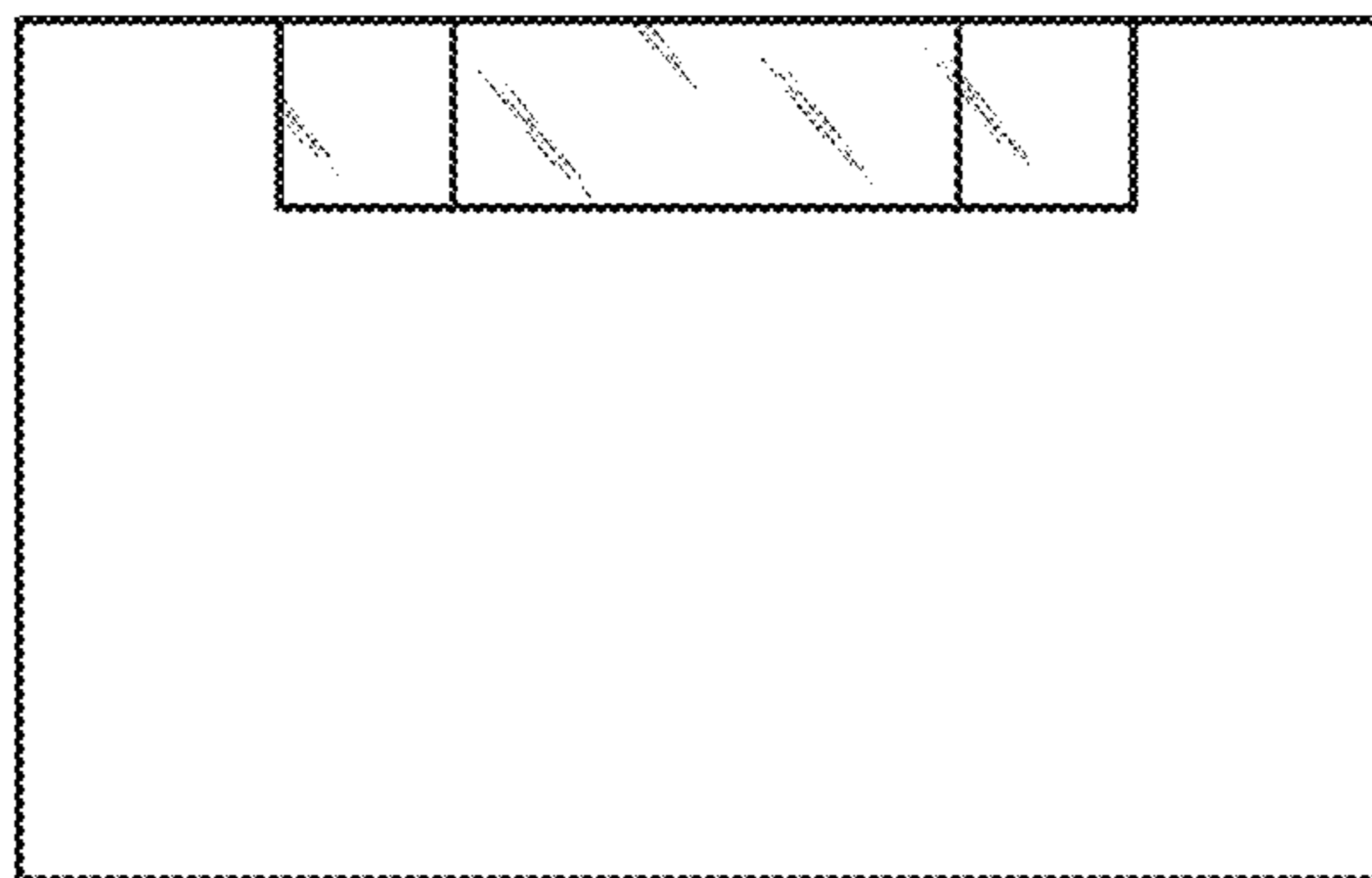
FIG. 5 is a top view of a container for a forced air warming machine showing the claimed design.

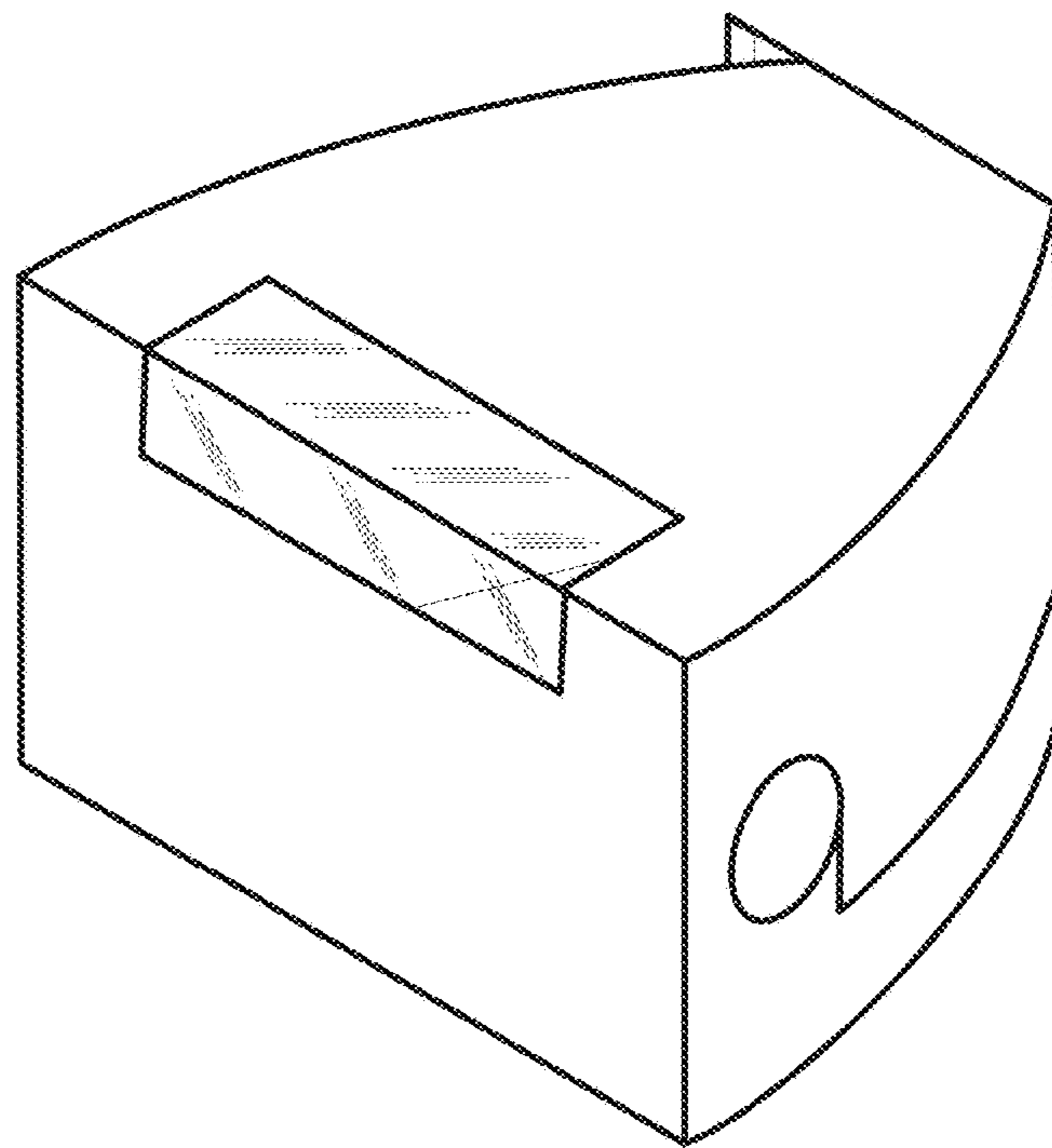

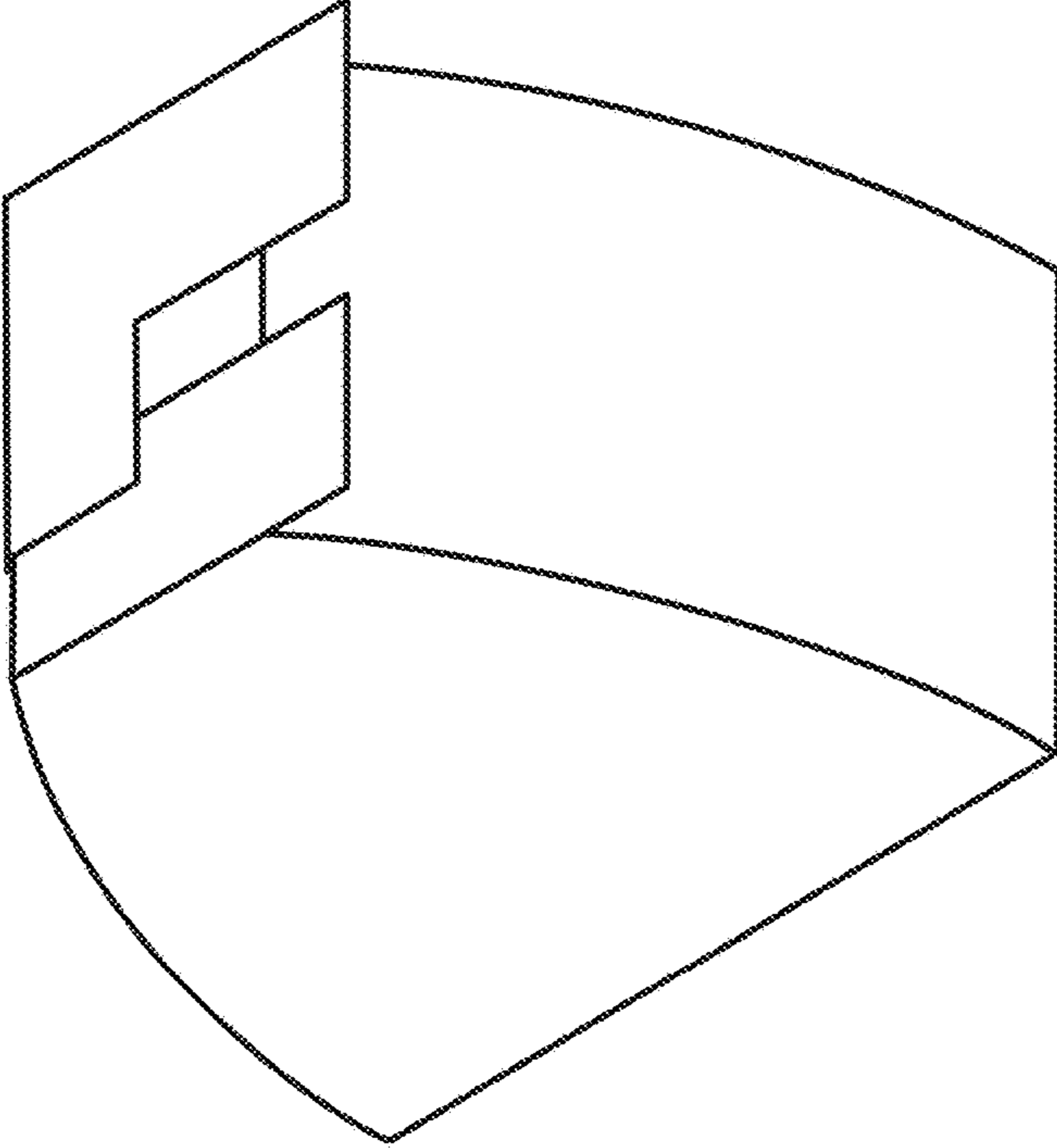

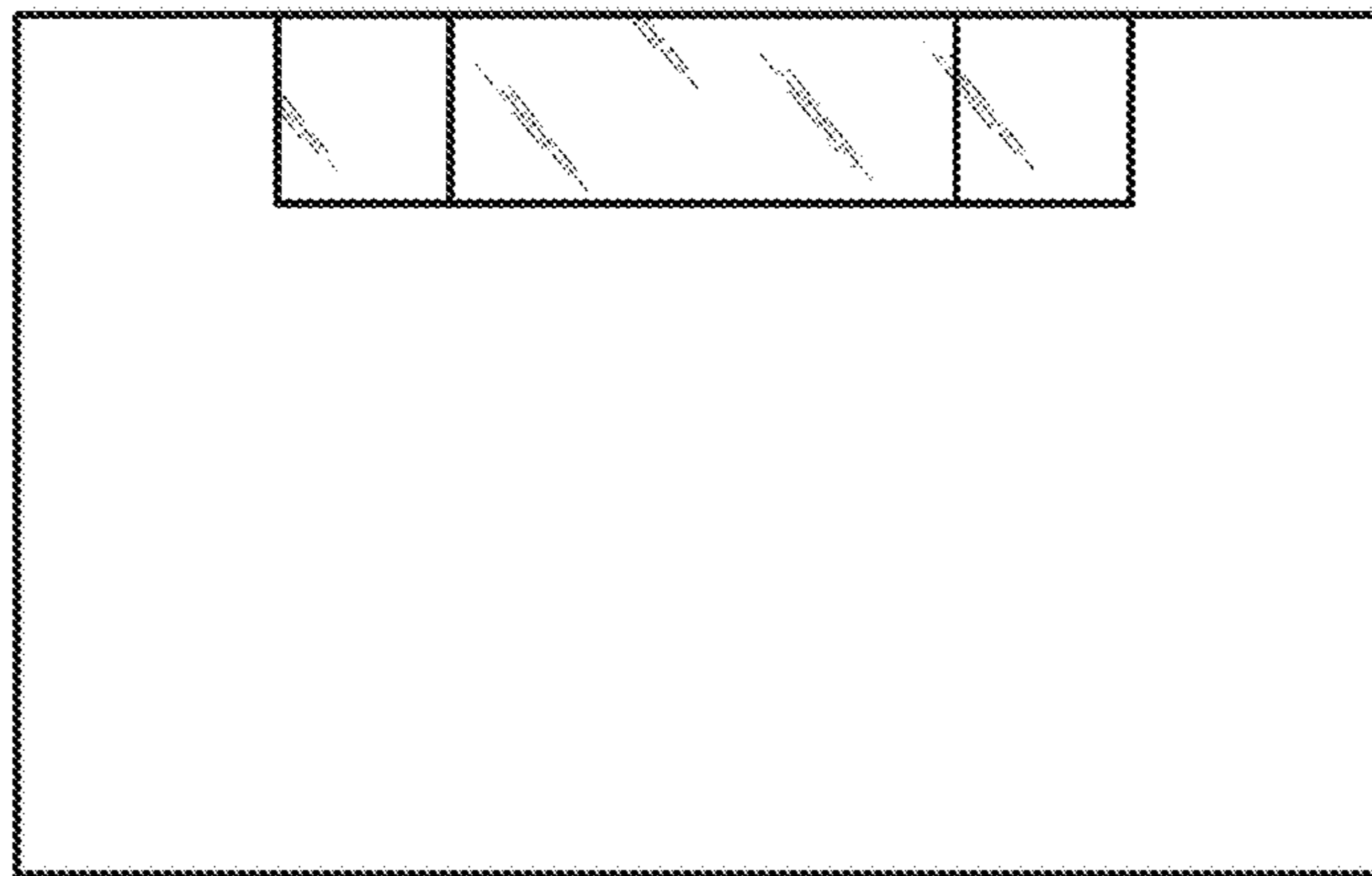

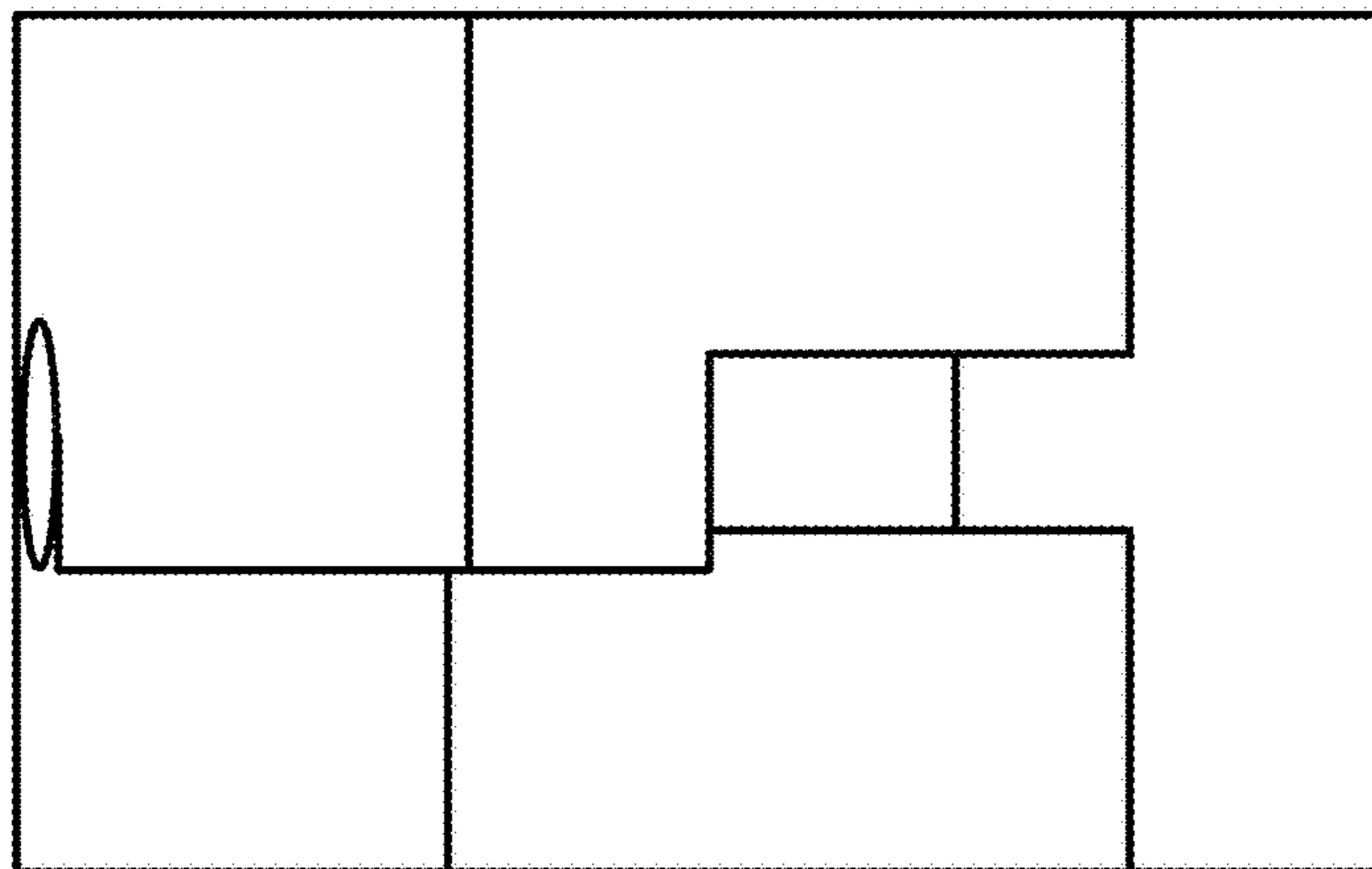

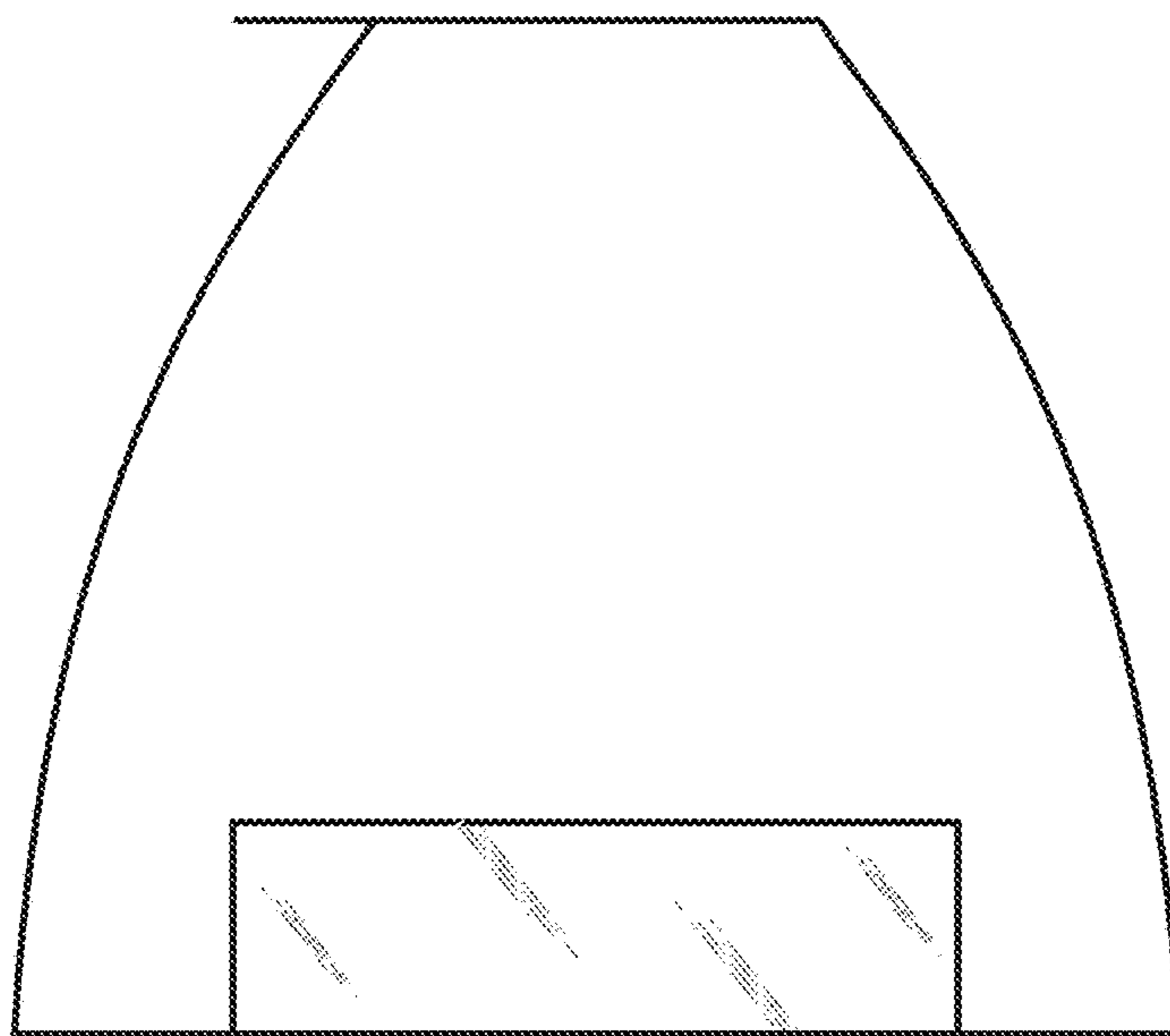

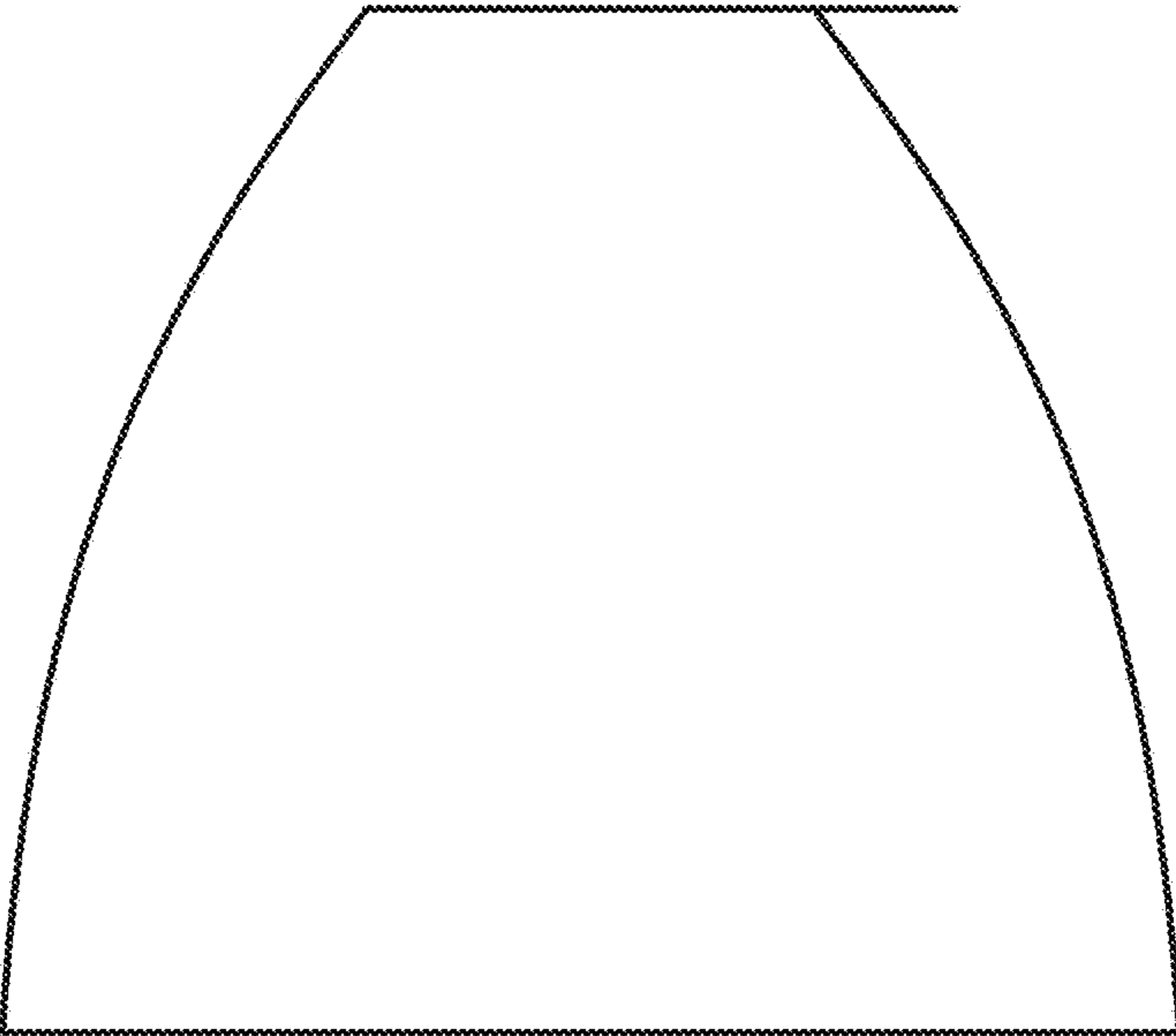

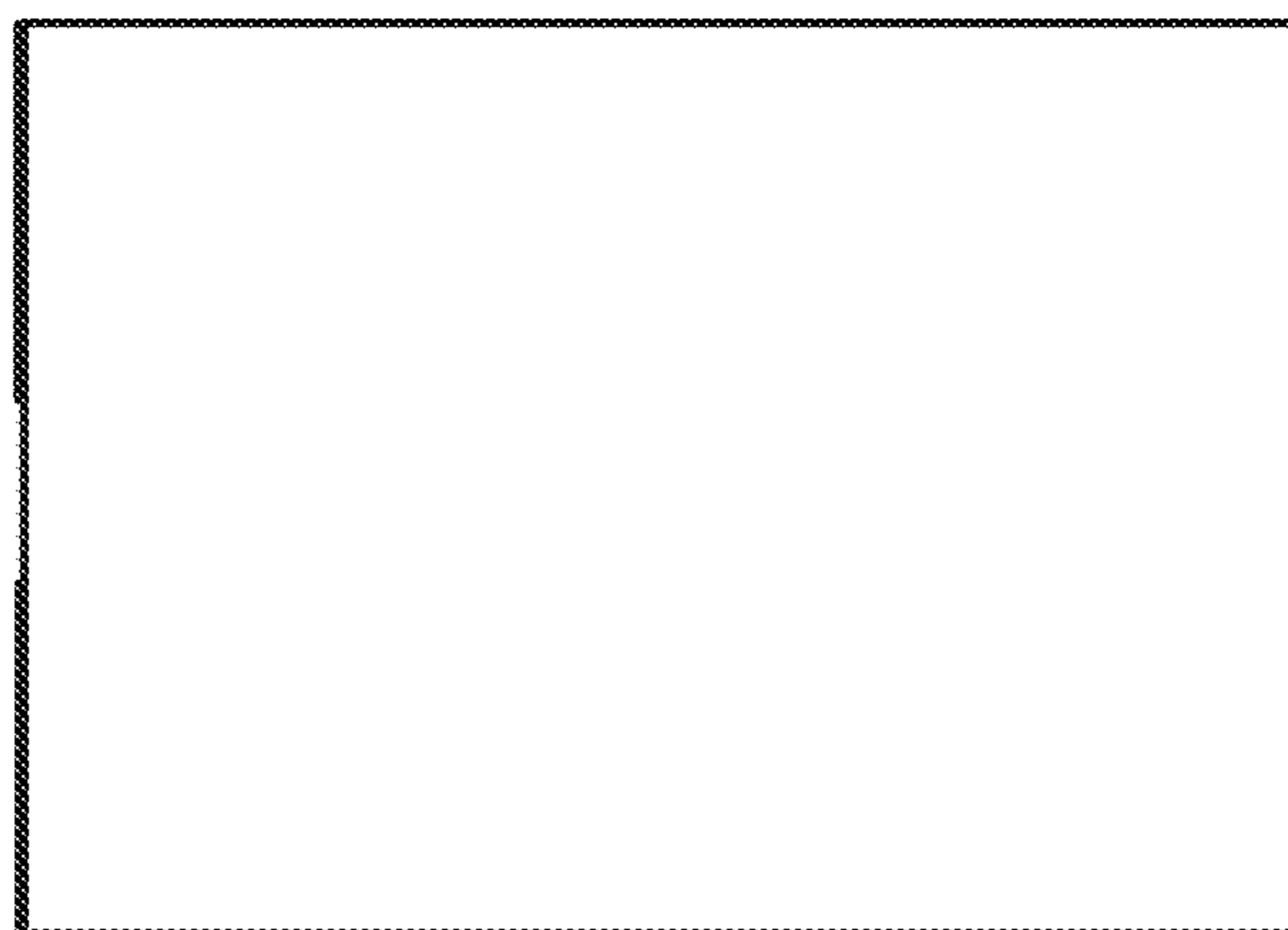

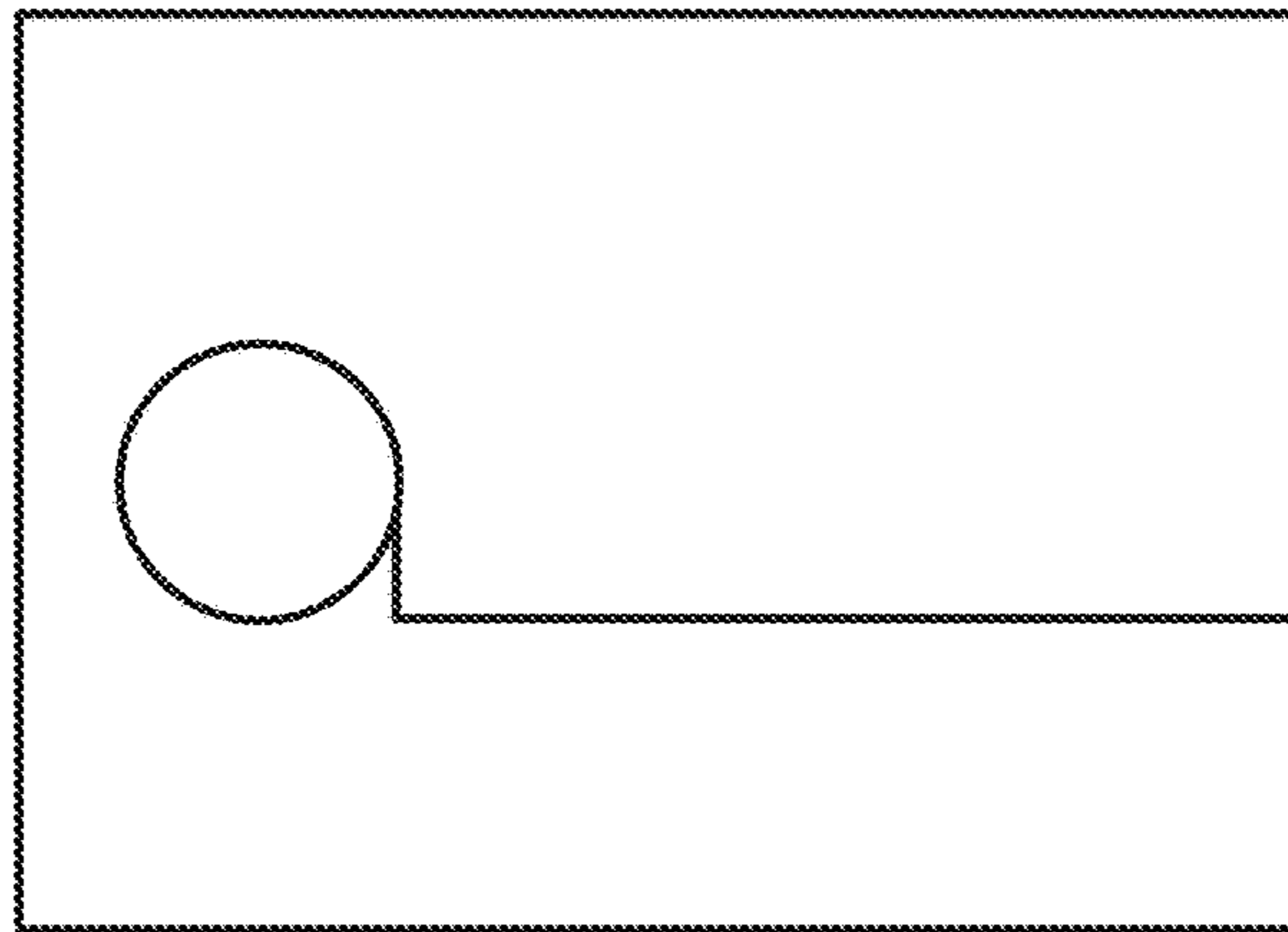
