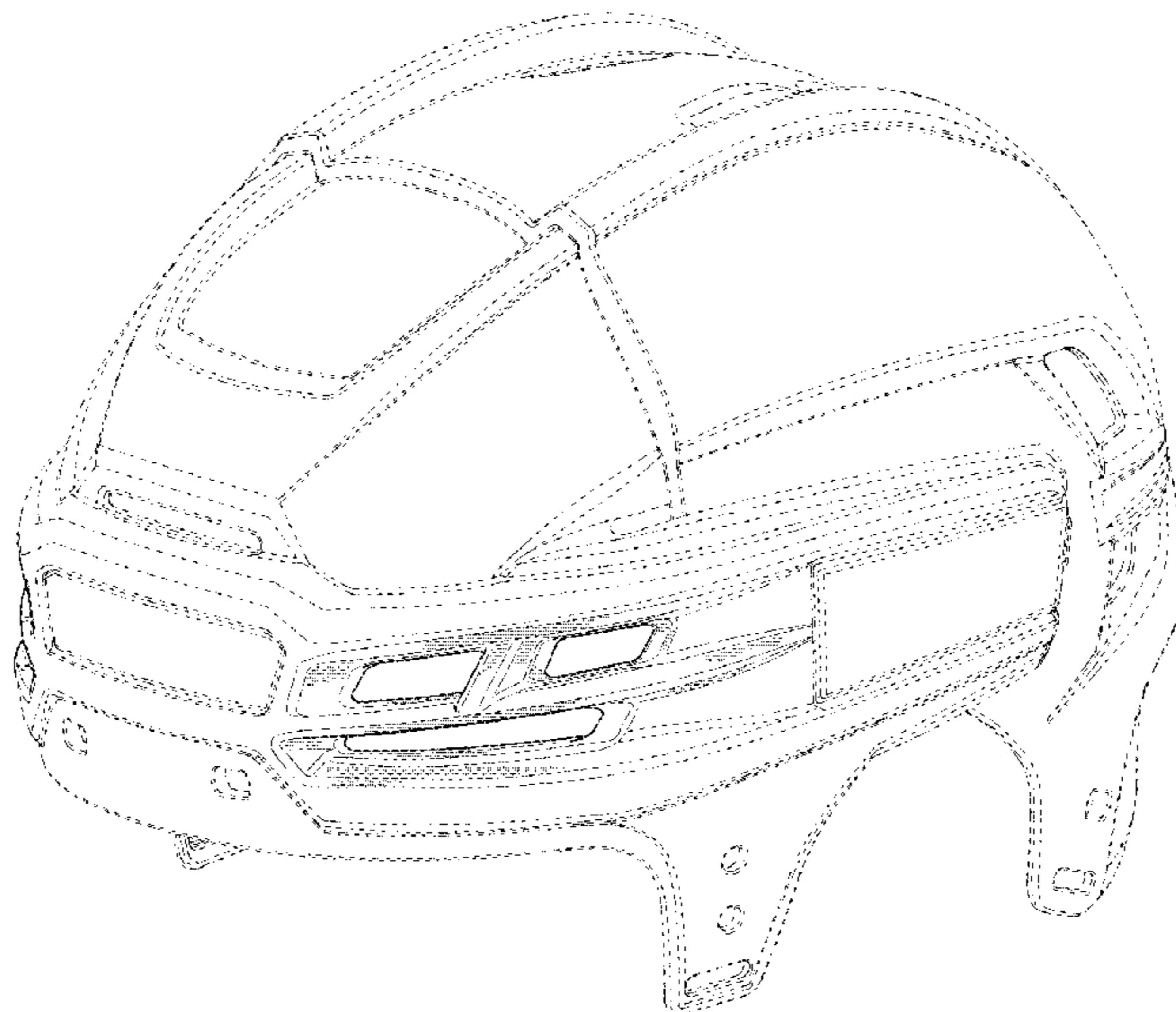
(57) **CLAIM**

The ornamental design for left and right front side portions of an outer shell of a sports helmet, as shown and described.

DESCRIPTION

FIG. 1 is a front perspective view of left and right front side portions of an outer shell of a sports helmet, showing our new design;
FIG. 2 is a rear perspective view of the left and right front side portions of FIG. 1;
FIG. 3 is a front elevational view of the left and right front side portions of FIG. 1;
FIG. 4 is a side elevational view of the left and right front side portions of FIG. 1; and,
FIG. 5 is a side elevational view of the left and right front side portions of FIG. 1, opposite that of FIG. 4.

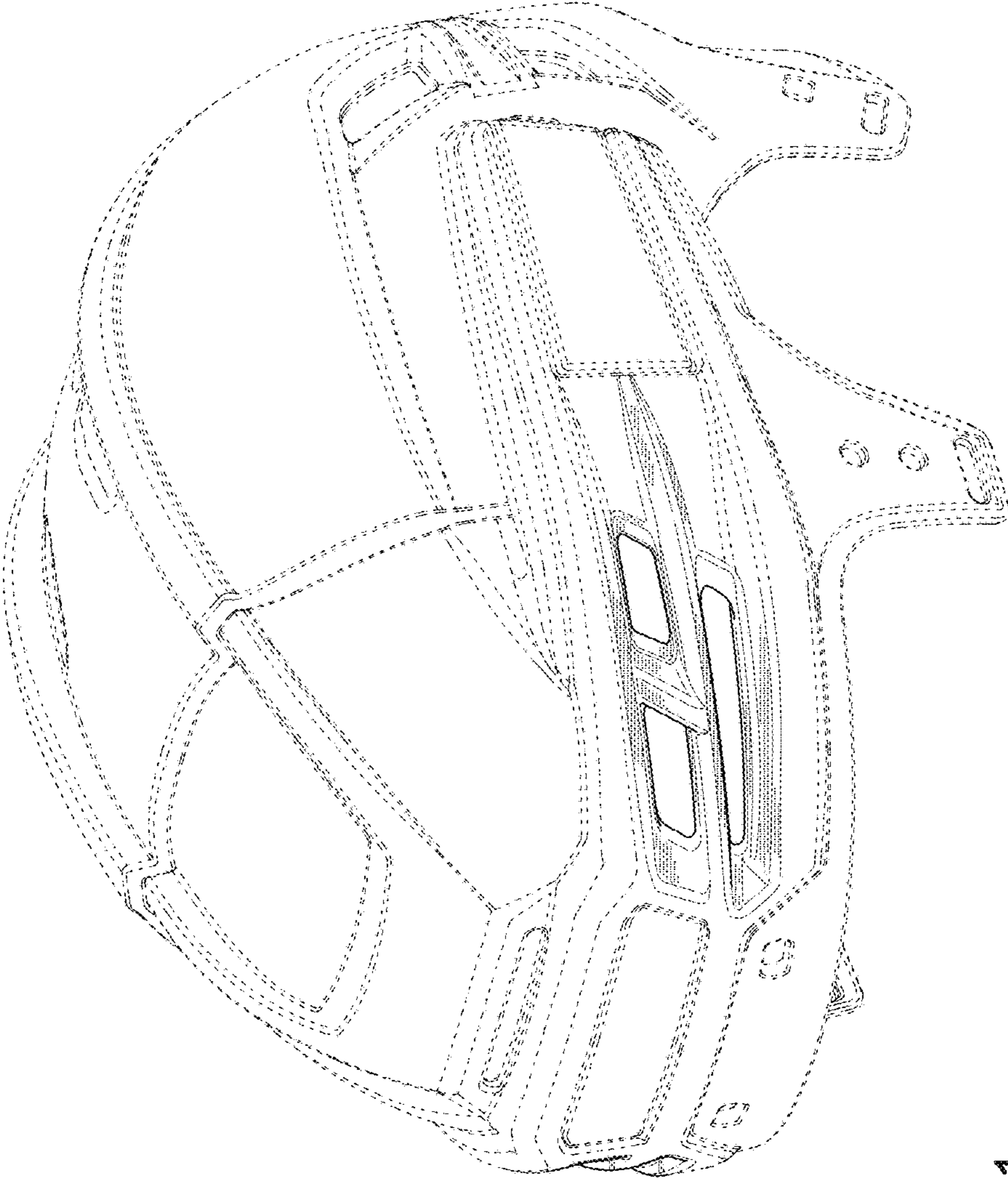

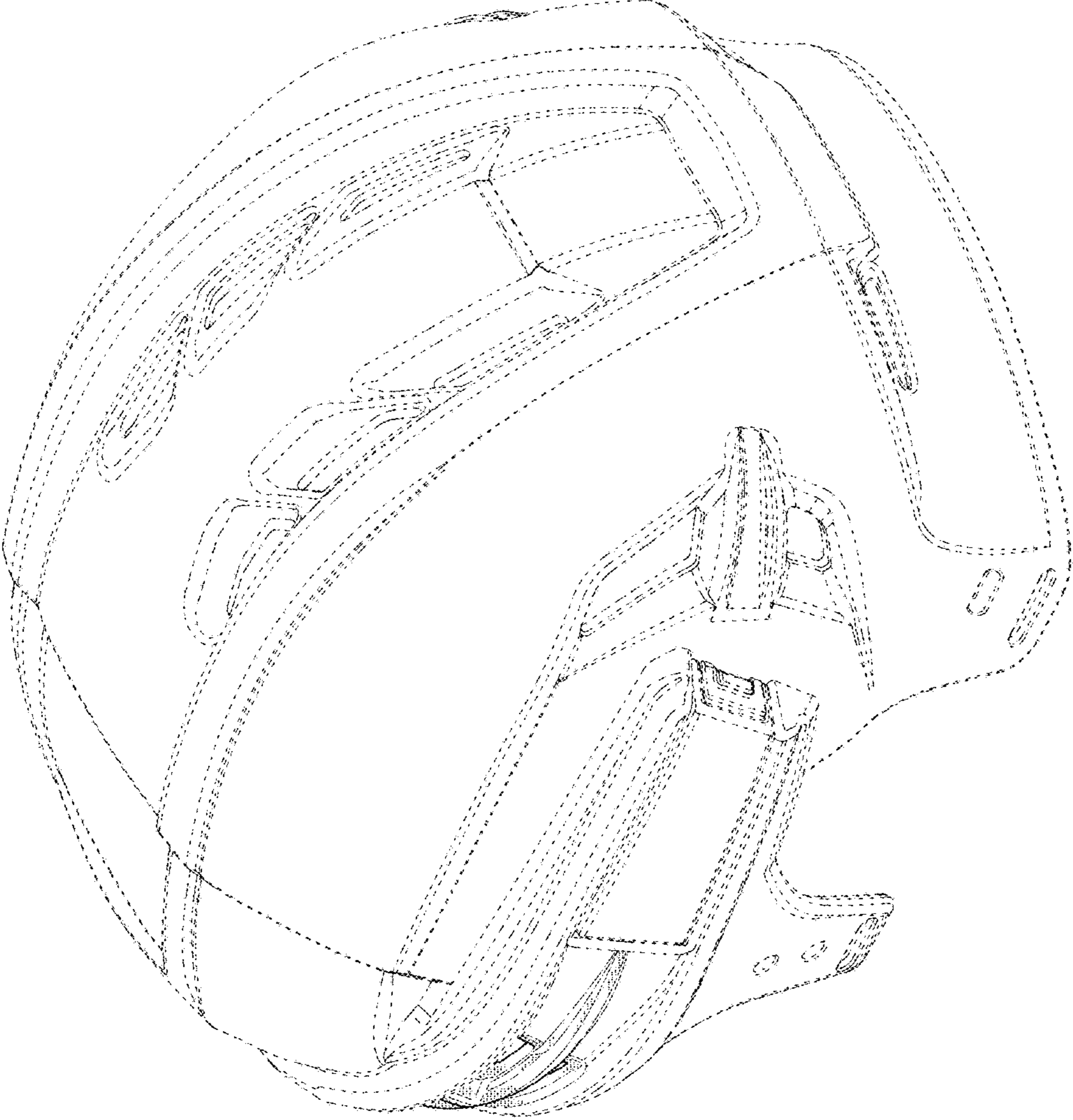

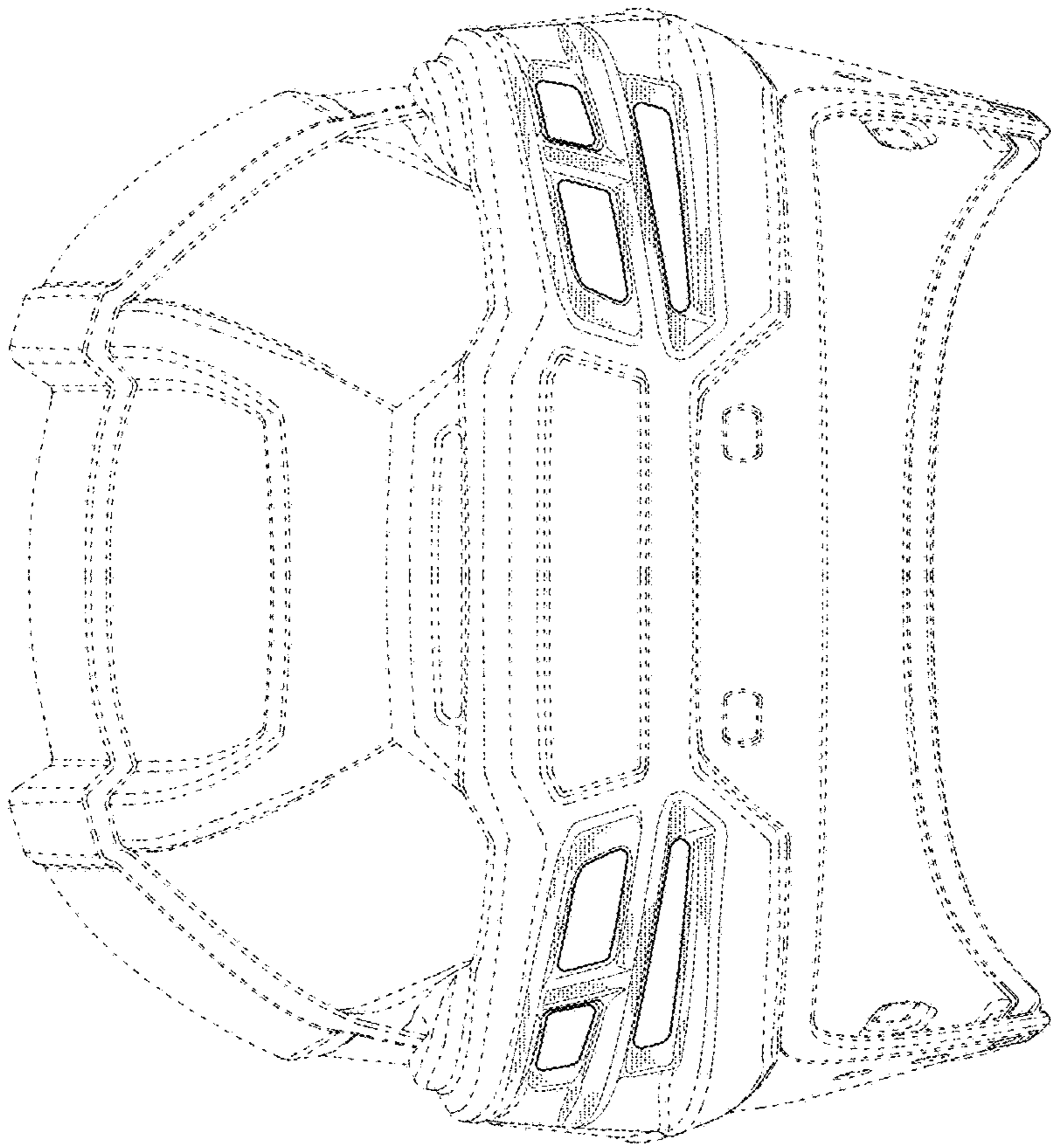

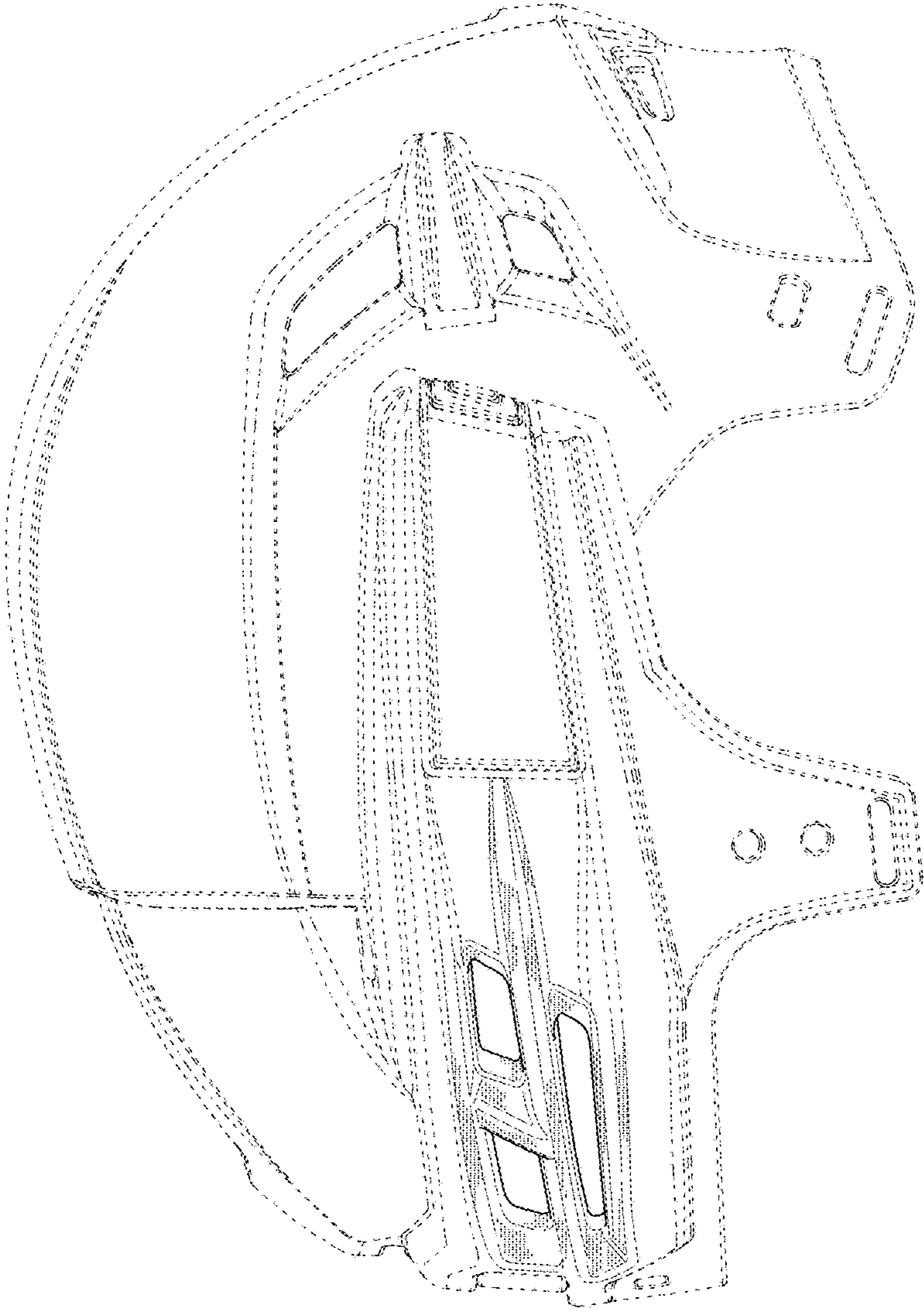

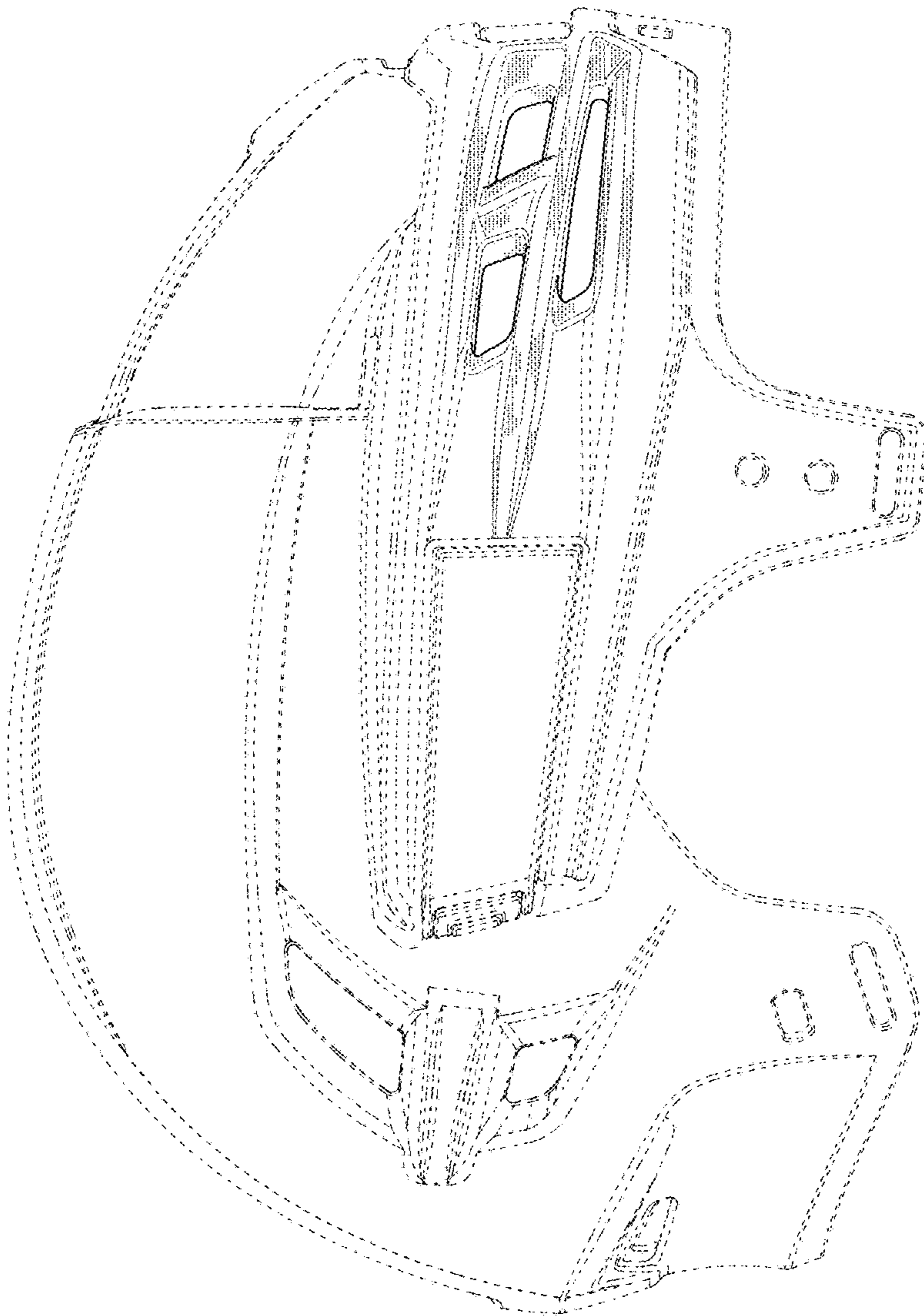
