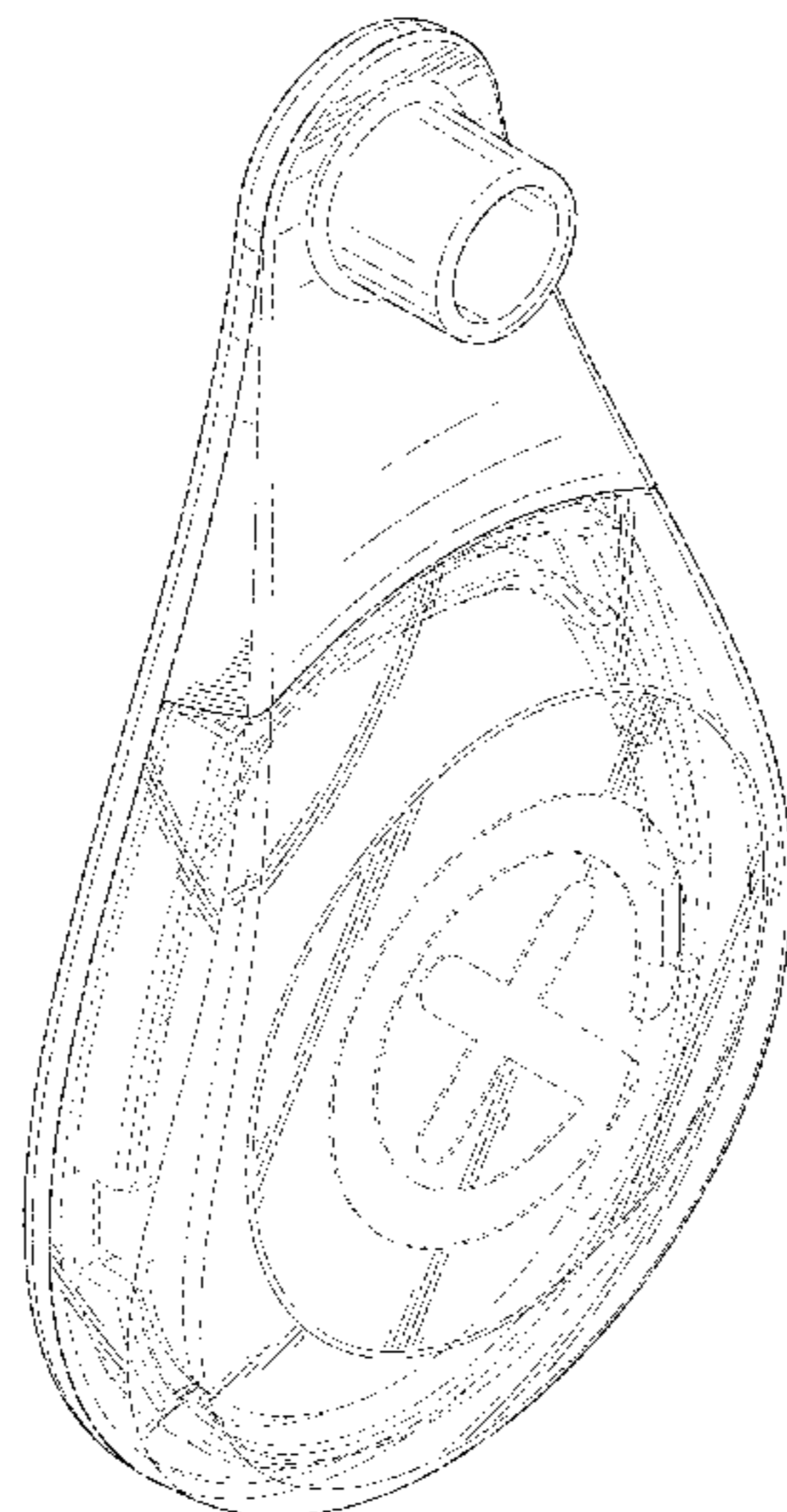

(57) **CLAIM**  
We claim the ornamental design for an animal ear tag, as shown and described.

**DESCRIPTION**

FIG. 1 is a top, front, left perspective view of an animal ear tag according to our design;  
FIG. 2 is a front view thereof;  
FIG. 3 is a back view thereof;  
FIG. 4 is a right view thereof;  
FIG. 5 is a left view thereof;  
FIG. 6 is a top view thereof; and,  
FIG. 7 is a bottom view thereof.

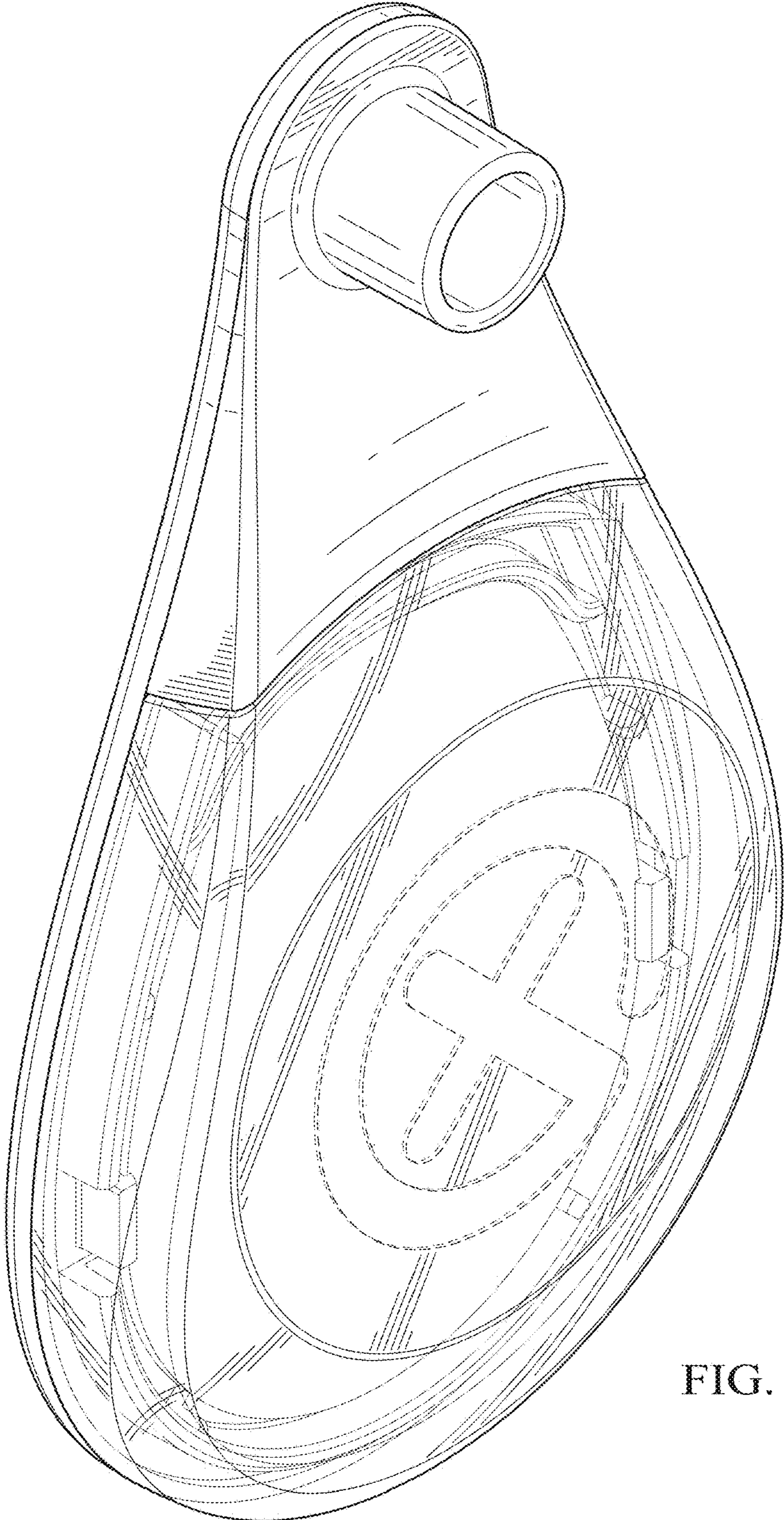

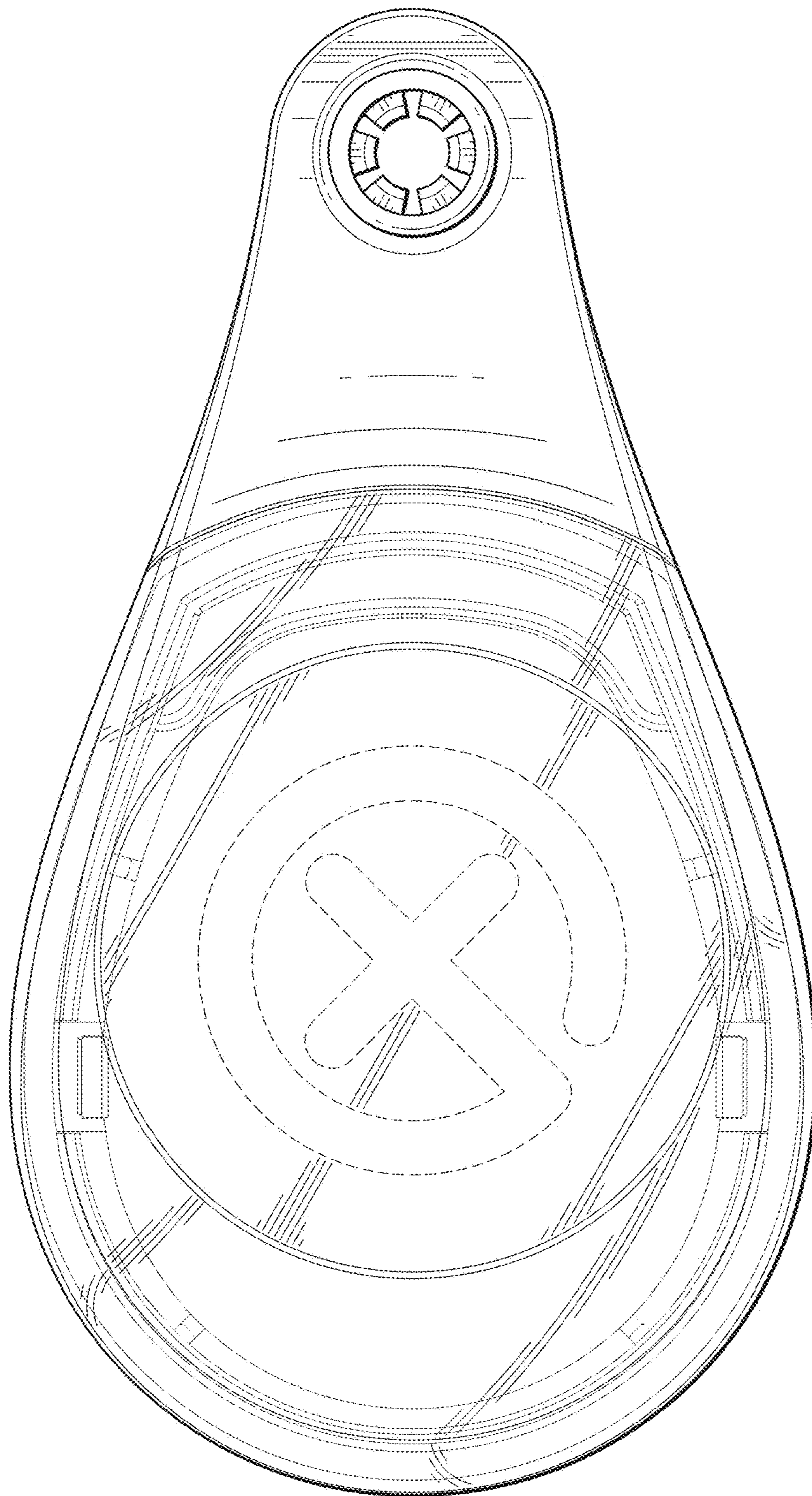

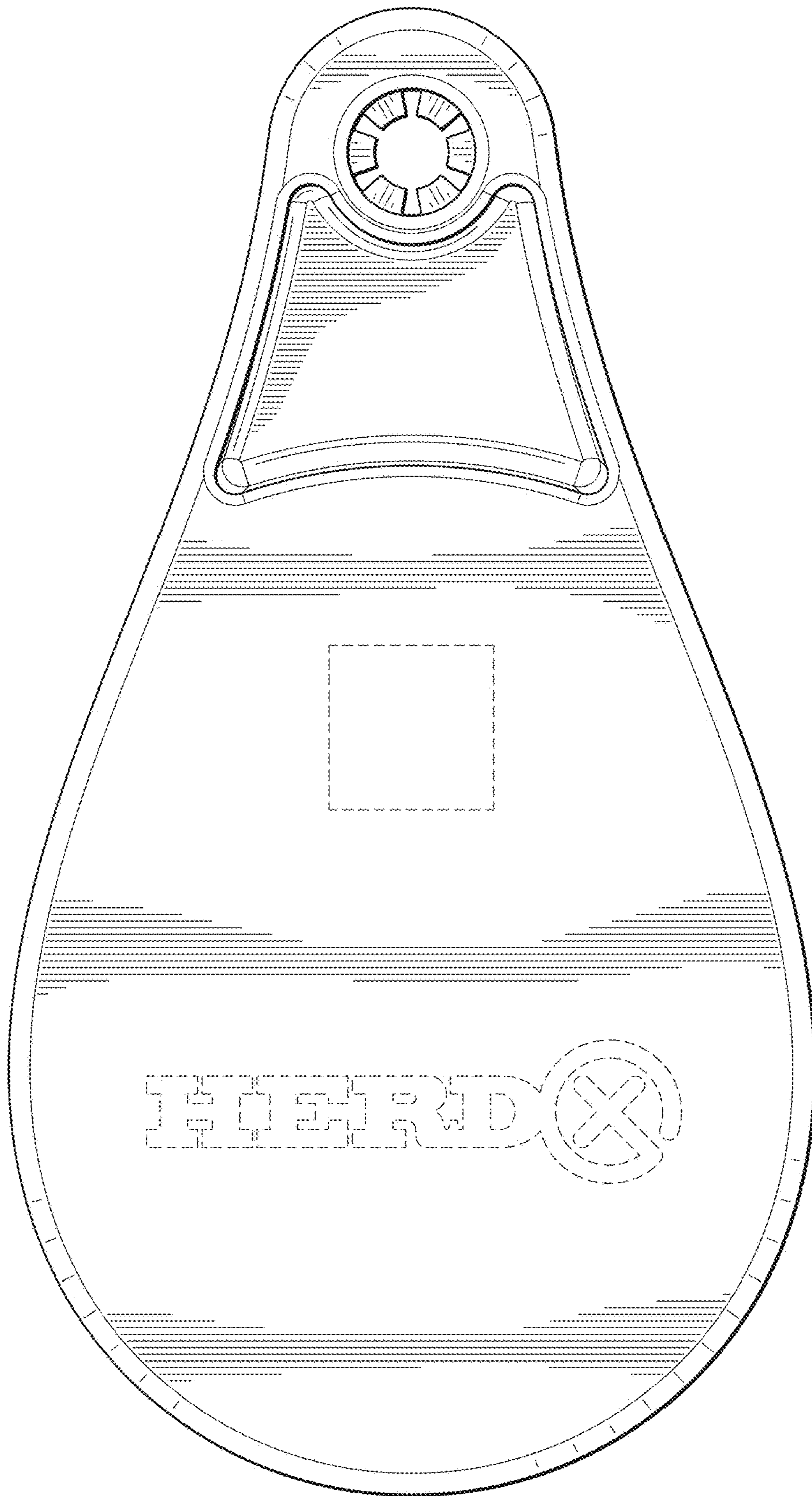

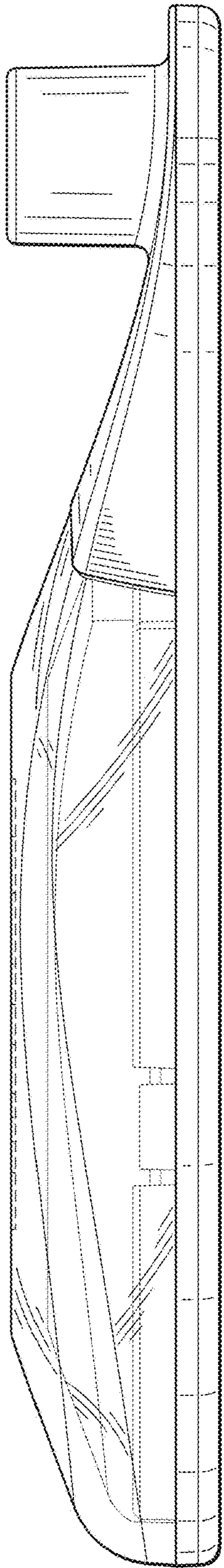

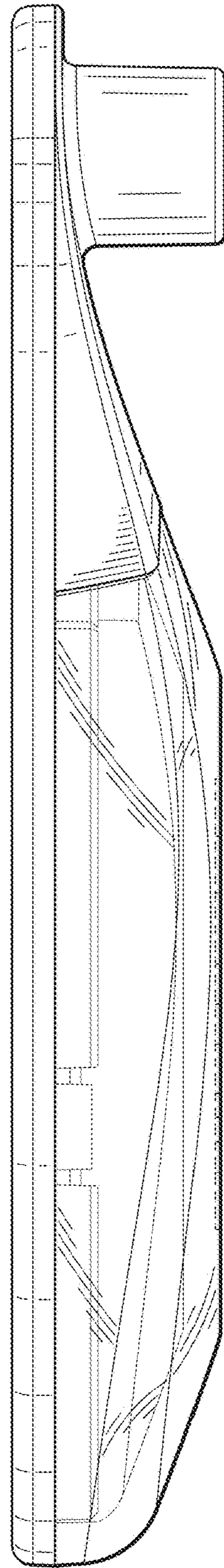

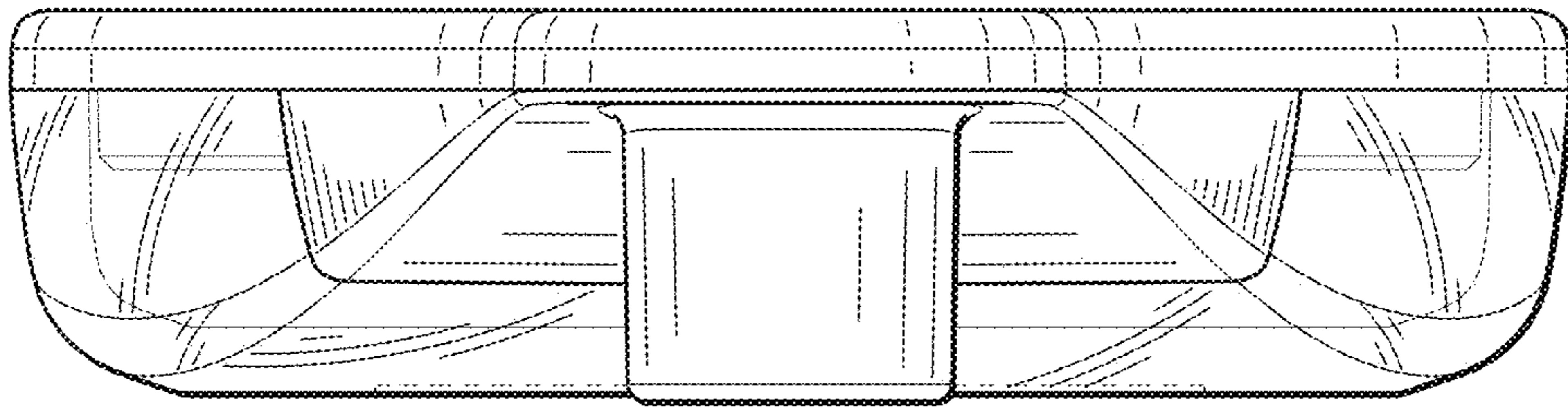

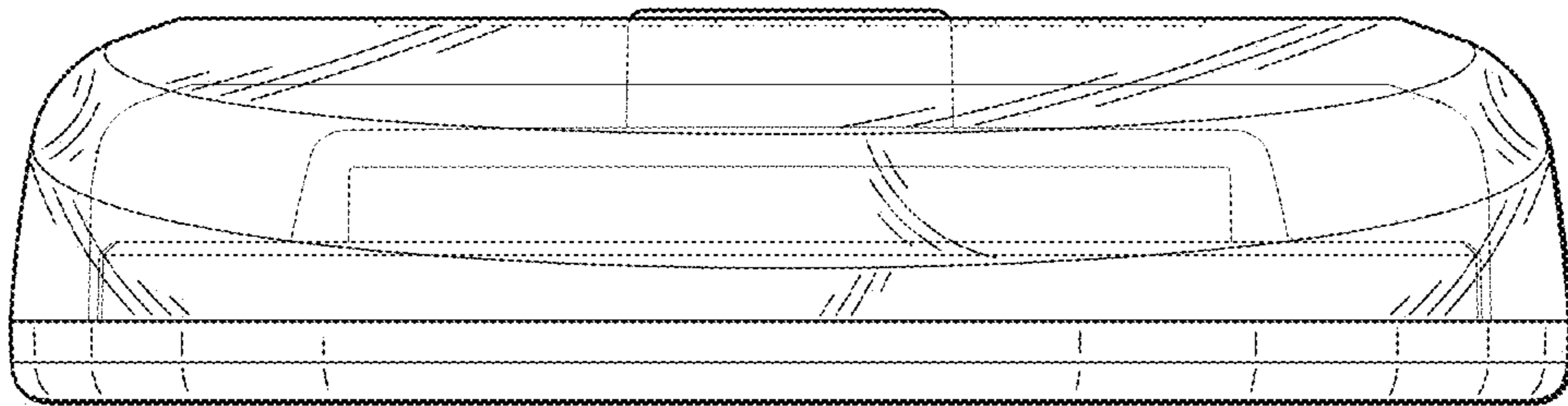
