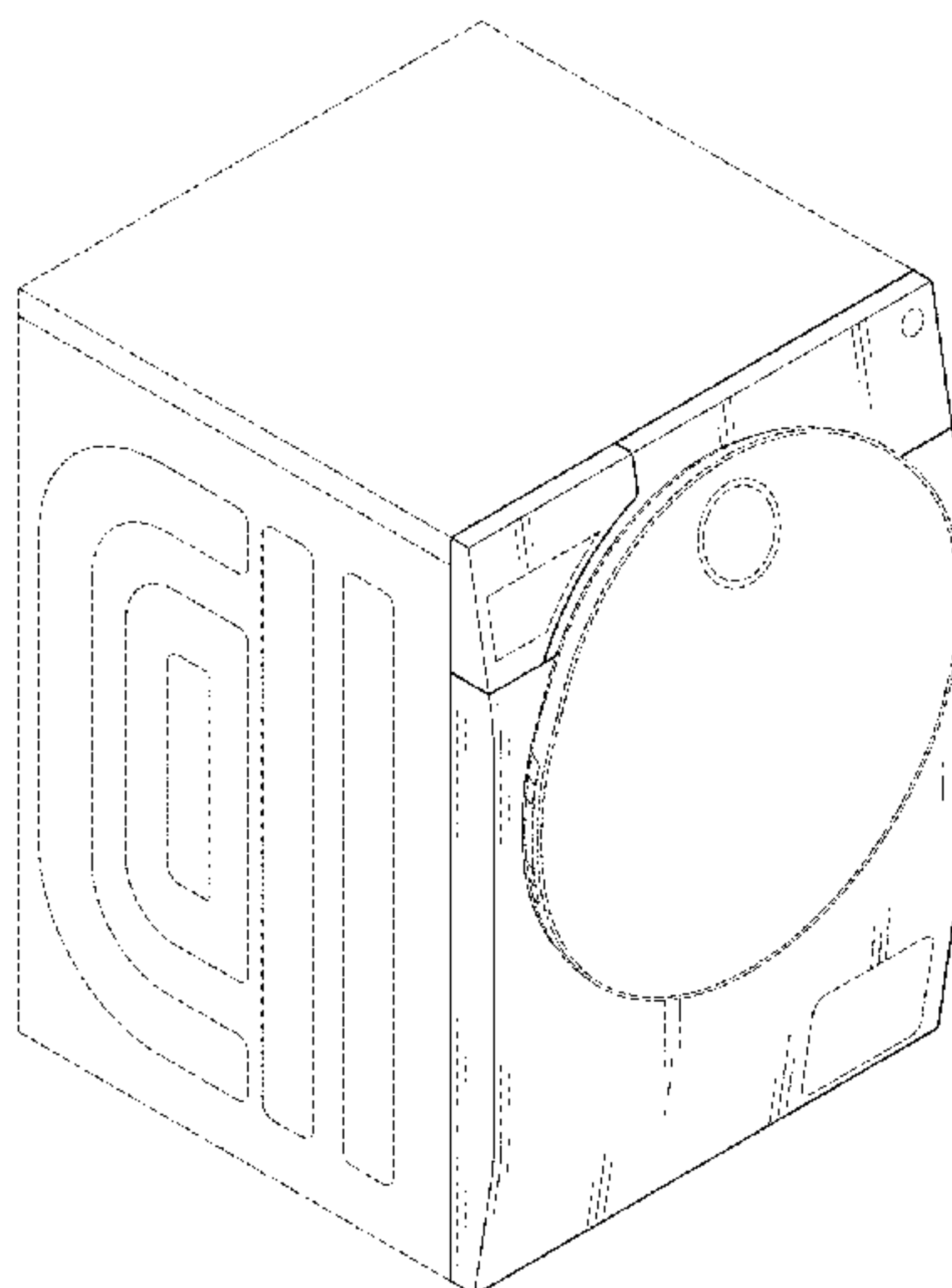
CLAIM
