(57) **CLAIM**

The ornamental design for a combined foldable chair and cart, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a combined foldable chair and cart, showing my new design, shown in its fully folded collapsed configuration;

FIG. 2 is a perspective view thereof, shown in its unfolded chair configuration;

FIG. 3 is a side perspective view thereof, the other side being a mirror image thereof;

FIG. 4 is a side perspective view shown in its folded cart configuration, shown without a basket for convenience of illustration;

FIG. 5 is a side perspective view thereof, the other side being a mirror image thereof;

FIG. 6 is a side perspective view, shown without the basket for convenience of illustration; and,

FIG. 7 is a side perspective view, shown with the basket in place and the handle in an alternate configuration.

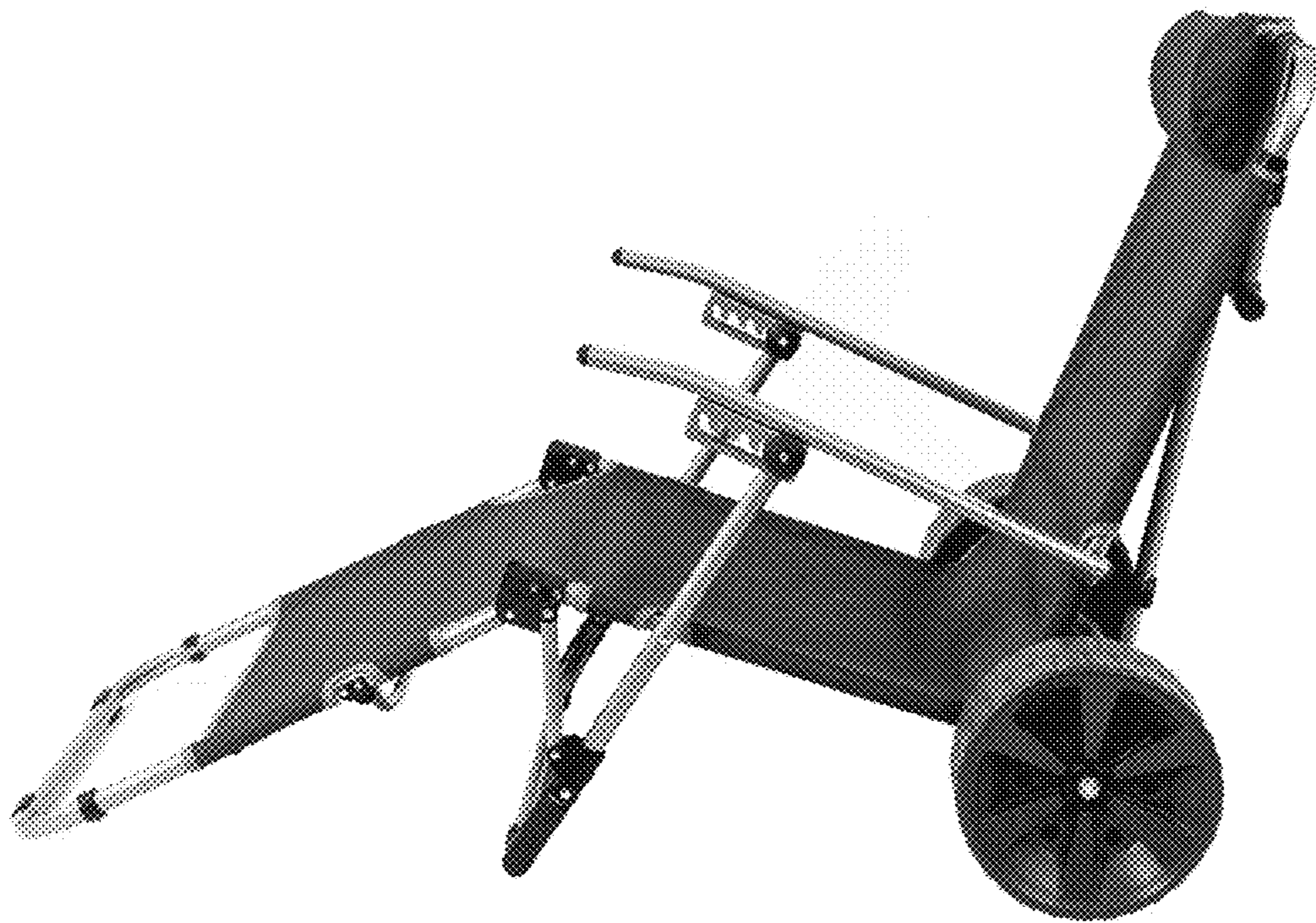
