(57) **CLAIM**

The ornamental design for a garment, as shown and described.

DESCRIPTION

FIG. 1 is a front perspective view of a garment showing my design;

FIG. 2 is a front view thereof;

FIG. 3 is a rear view thereof;

FIG. 4 is a first side view thereof; and,

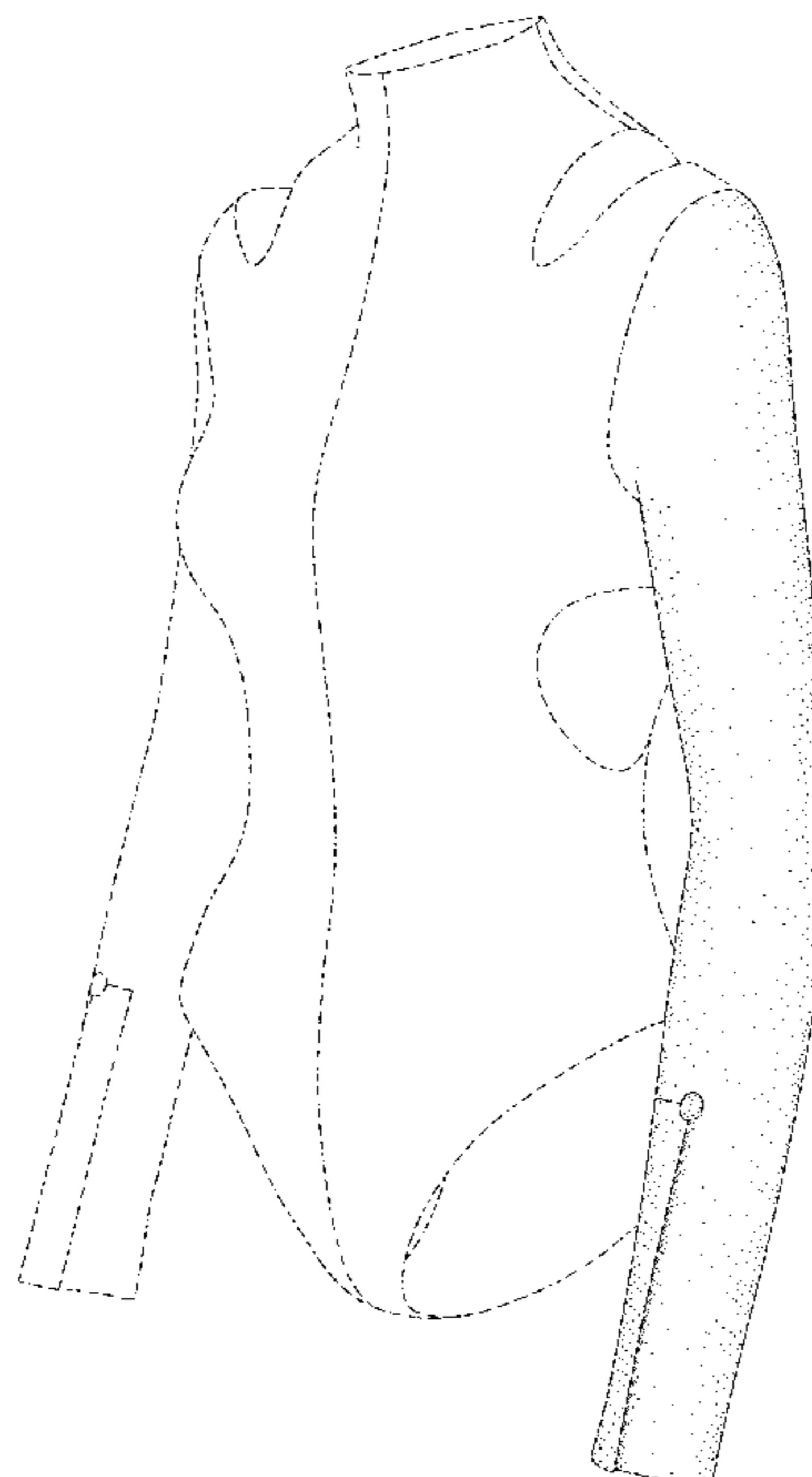
FIG. 5 is a top view thereof.

The dash-dot-dash broken lines immediately adjacent the shaded area represents boundaries to the claimed design and forms no part of the claimed design.

The even dash broken lines shown in the figures represent portions of the garment that form no part of the claimed design.

The contrast in shading on the circular element, which is positioned part-way up the forearm of the sleeve, represents a contrast in appearance only and does not represent any particular color, material, texture, or finish.

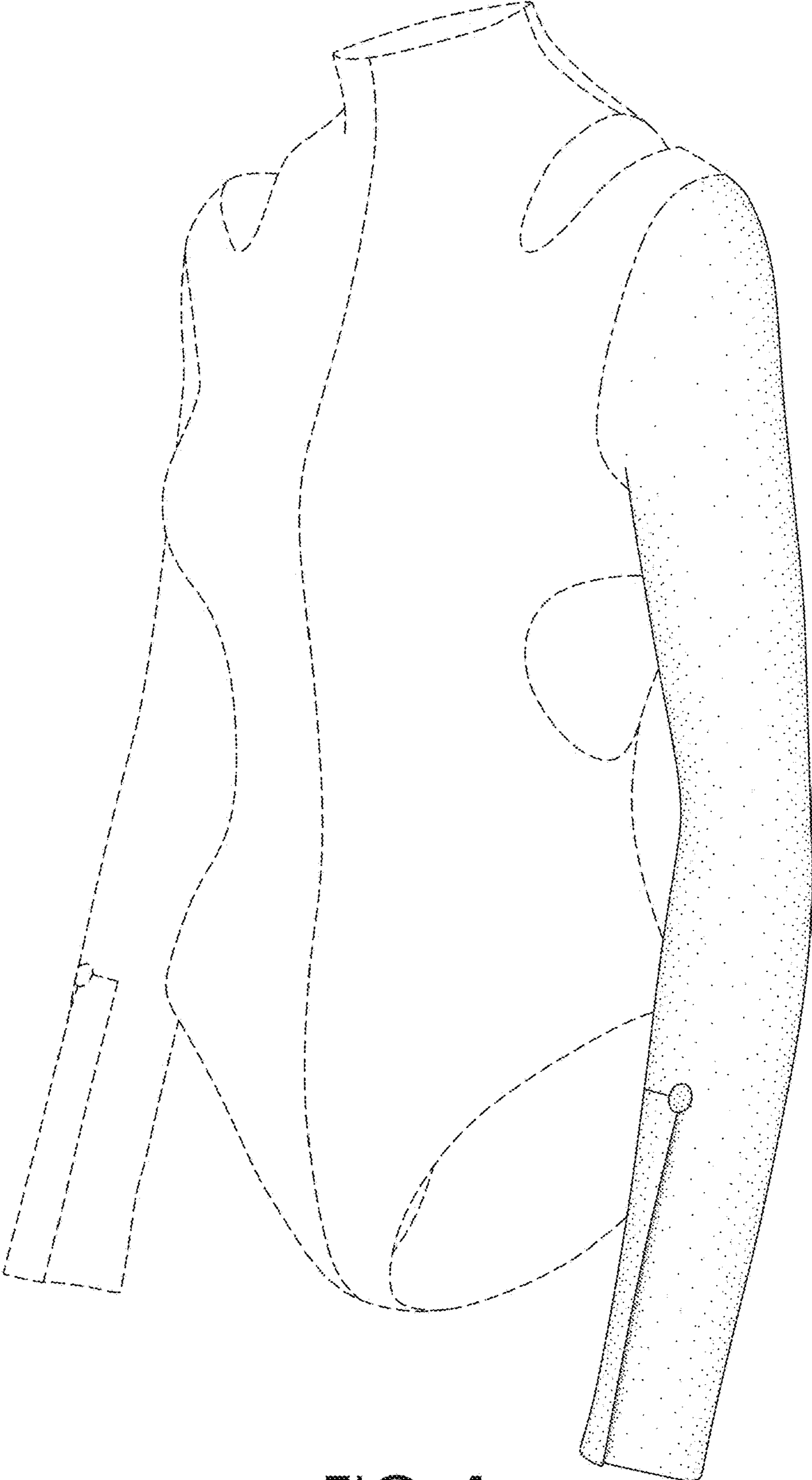

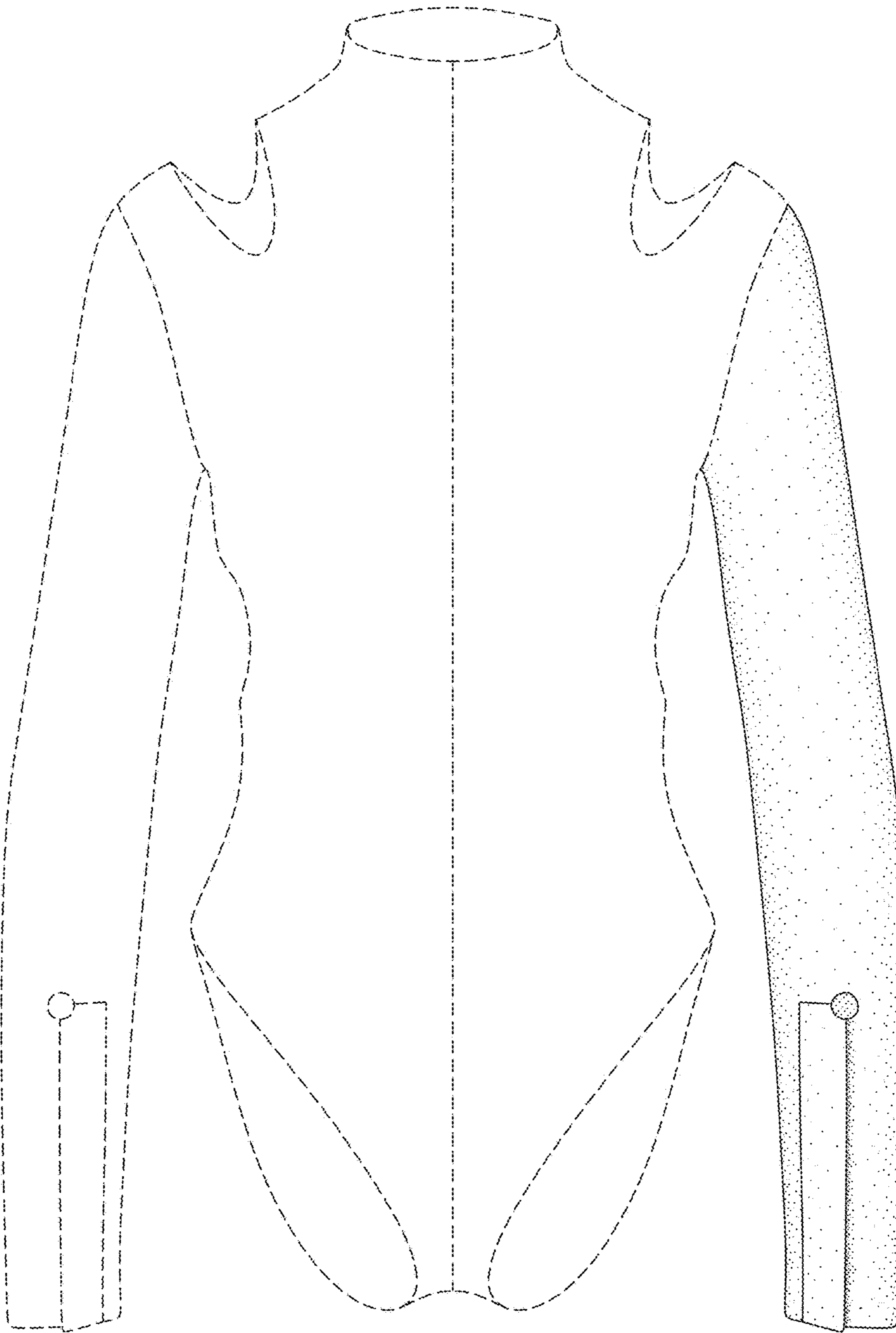

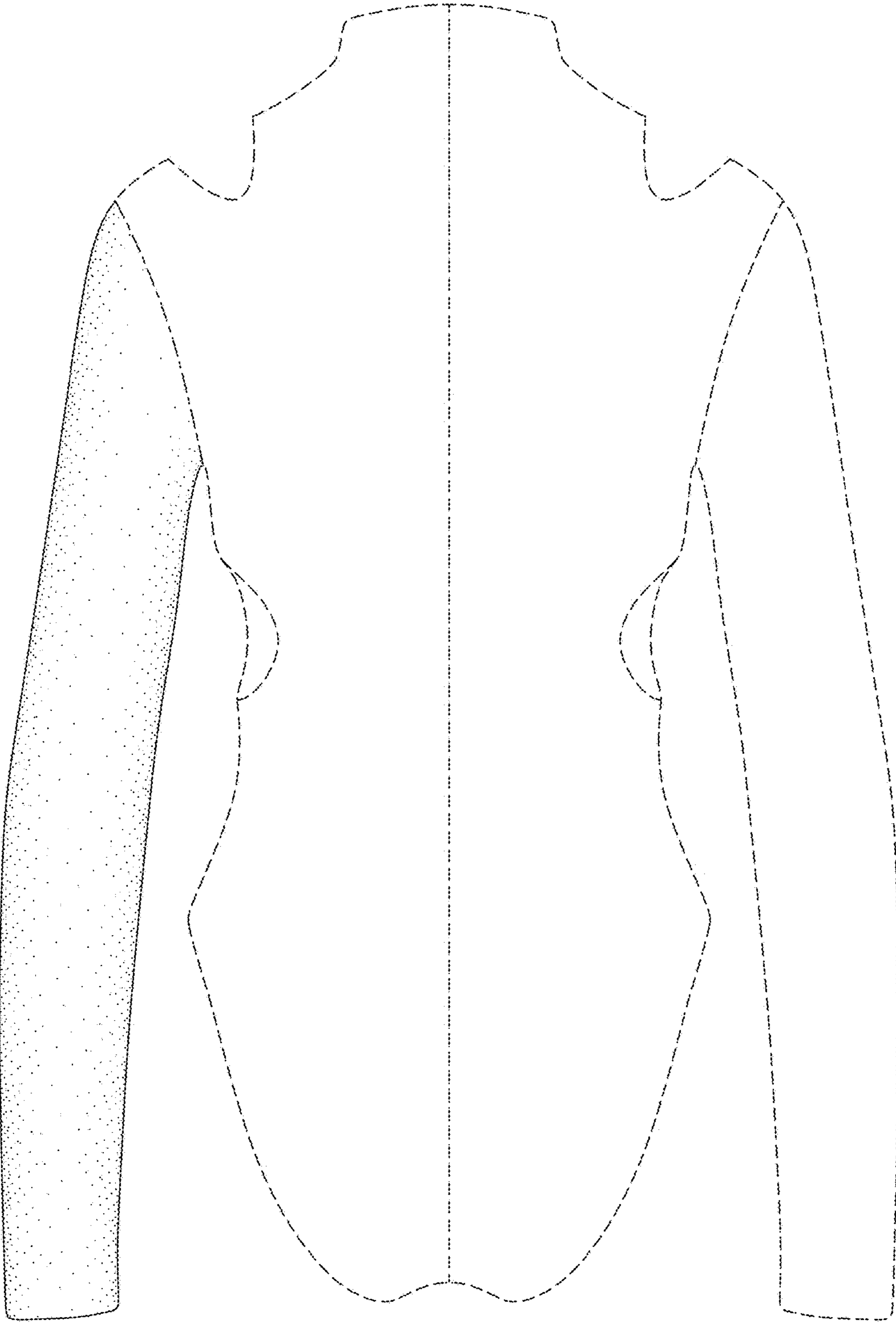

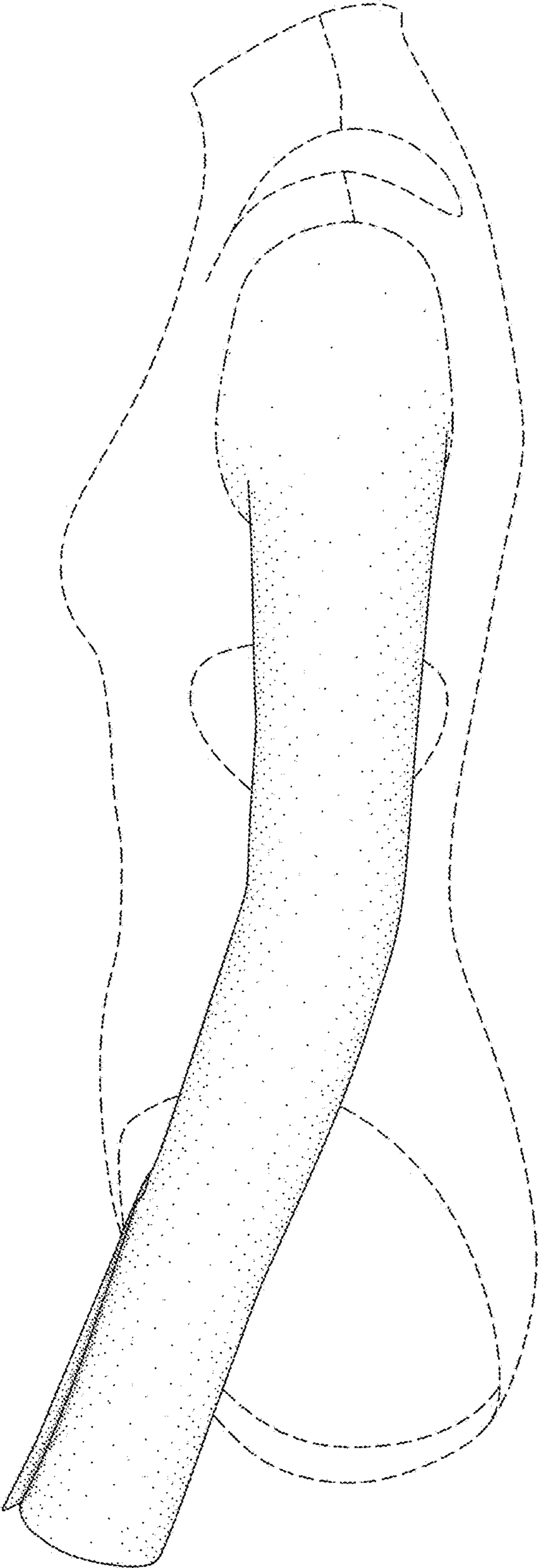

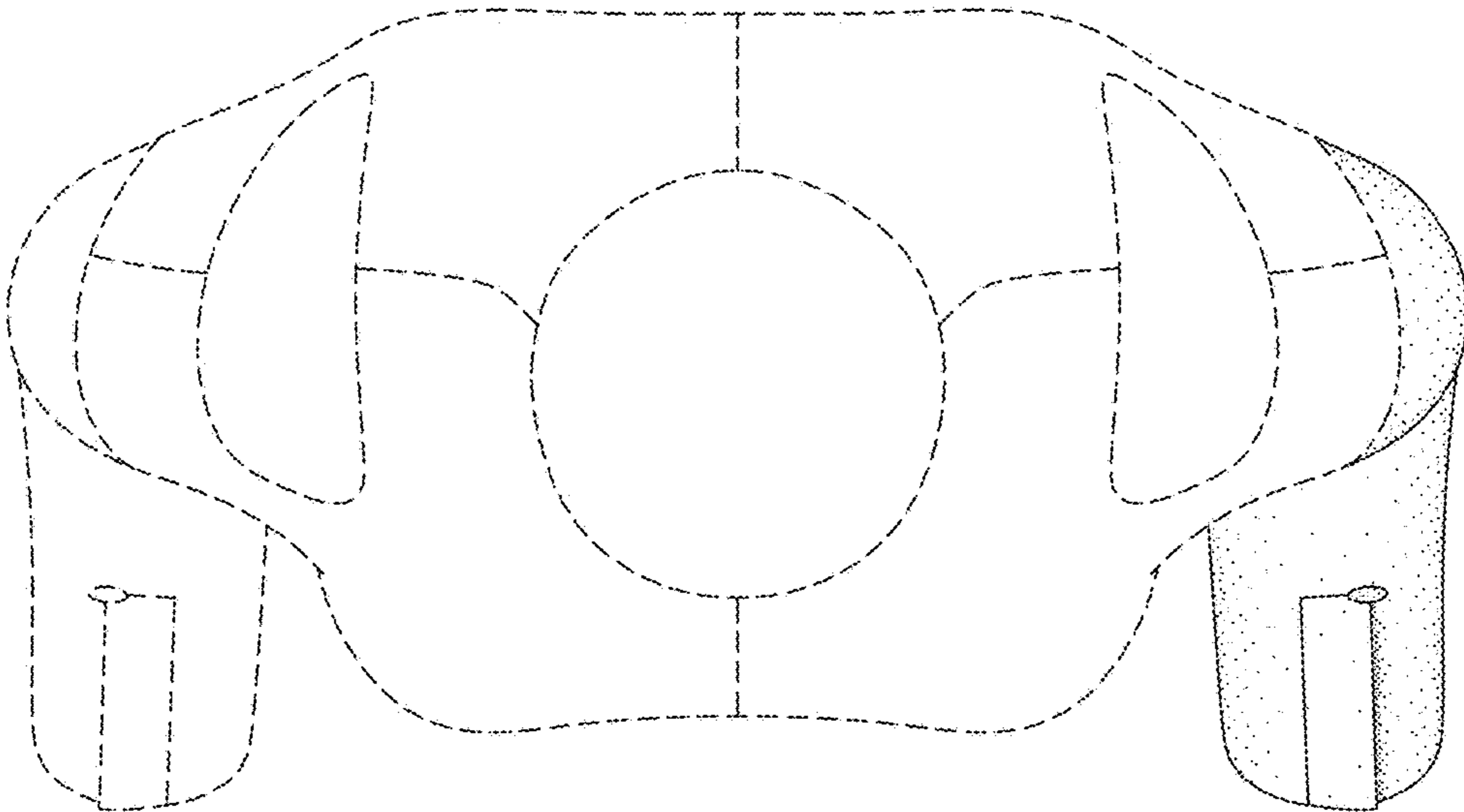
