FIG. 1 is a side perspective view of a shoe showing my new design;

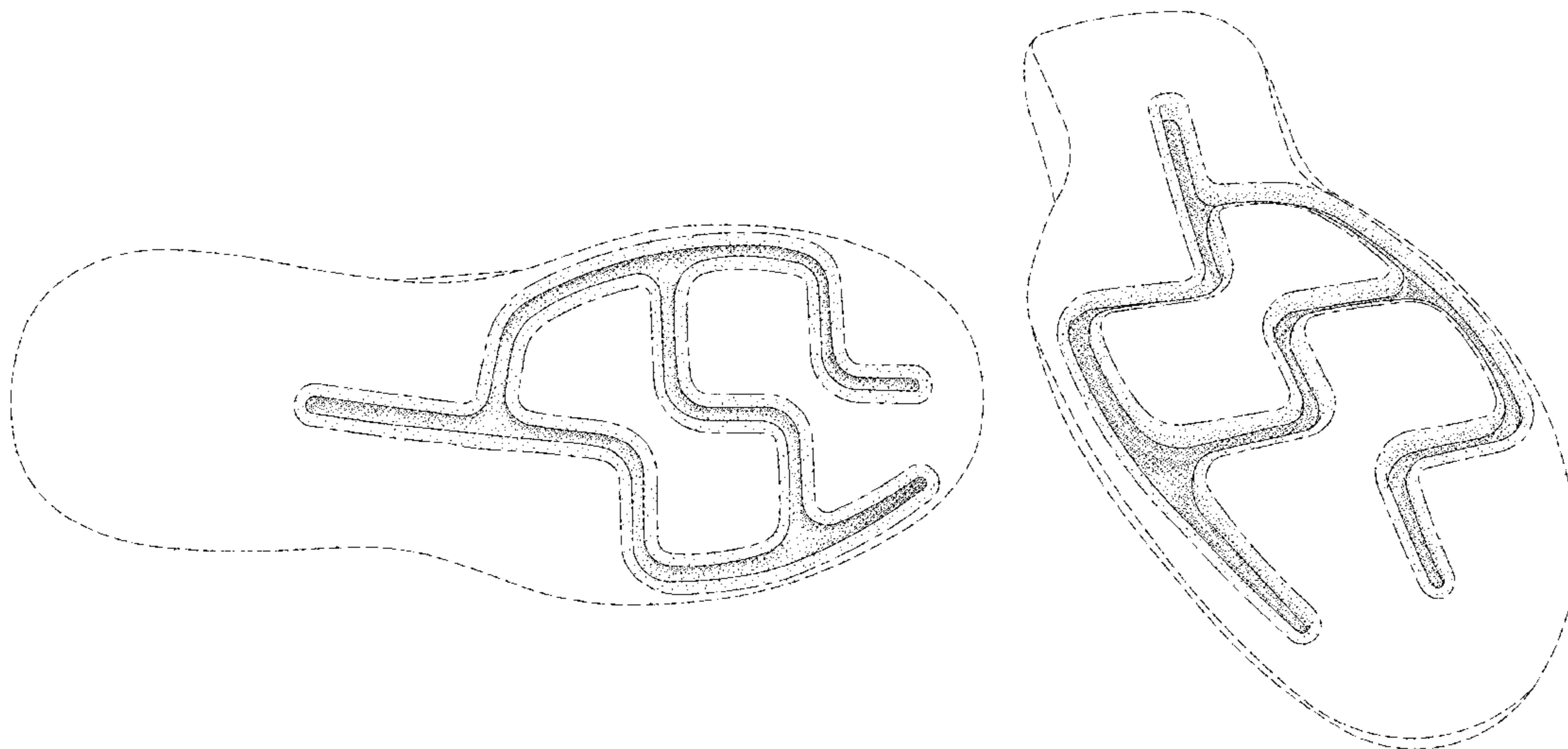
FIG. 2 is a plan view thereof;

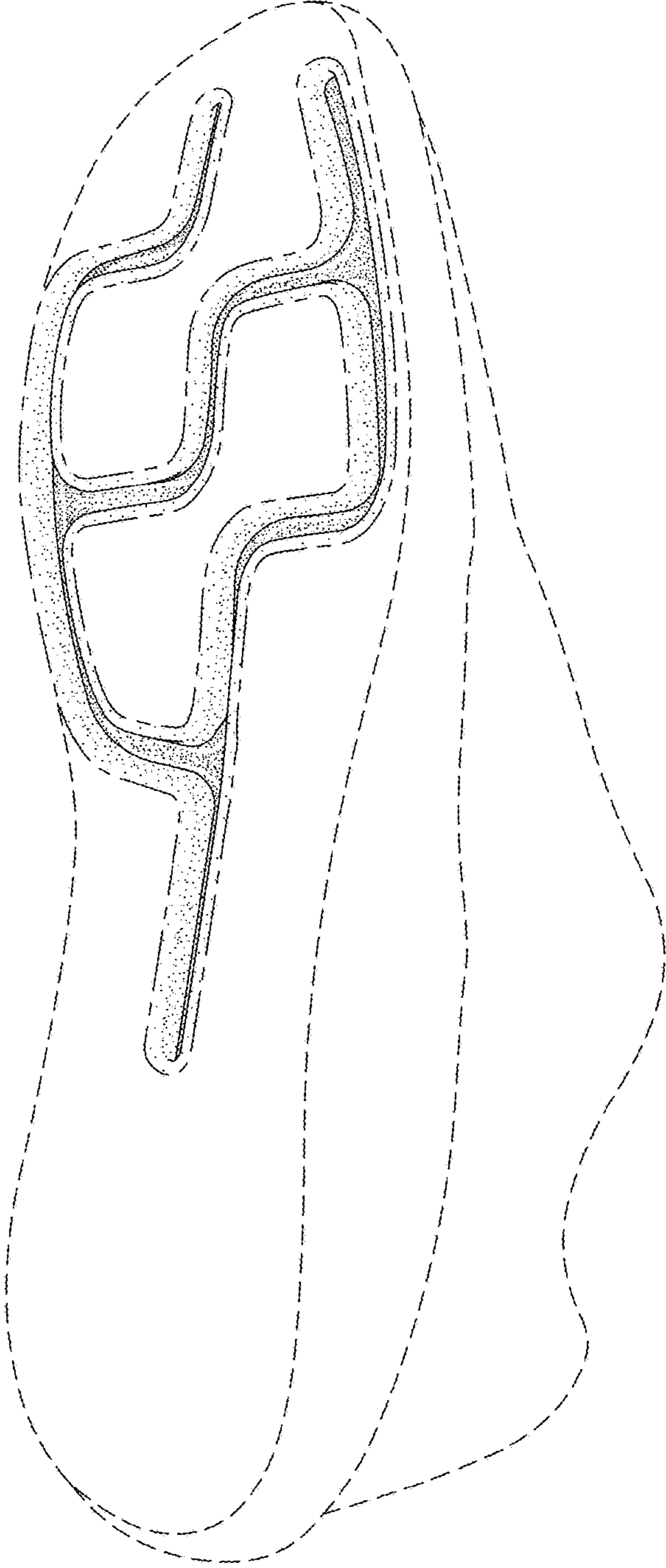

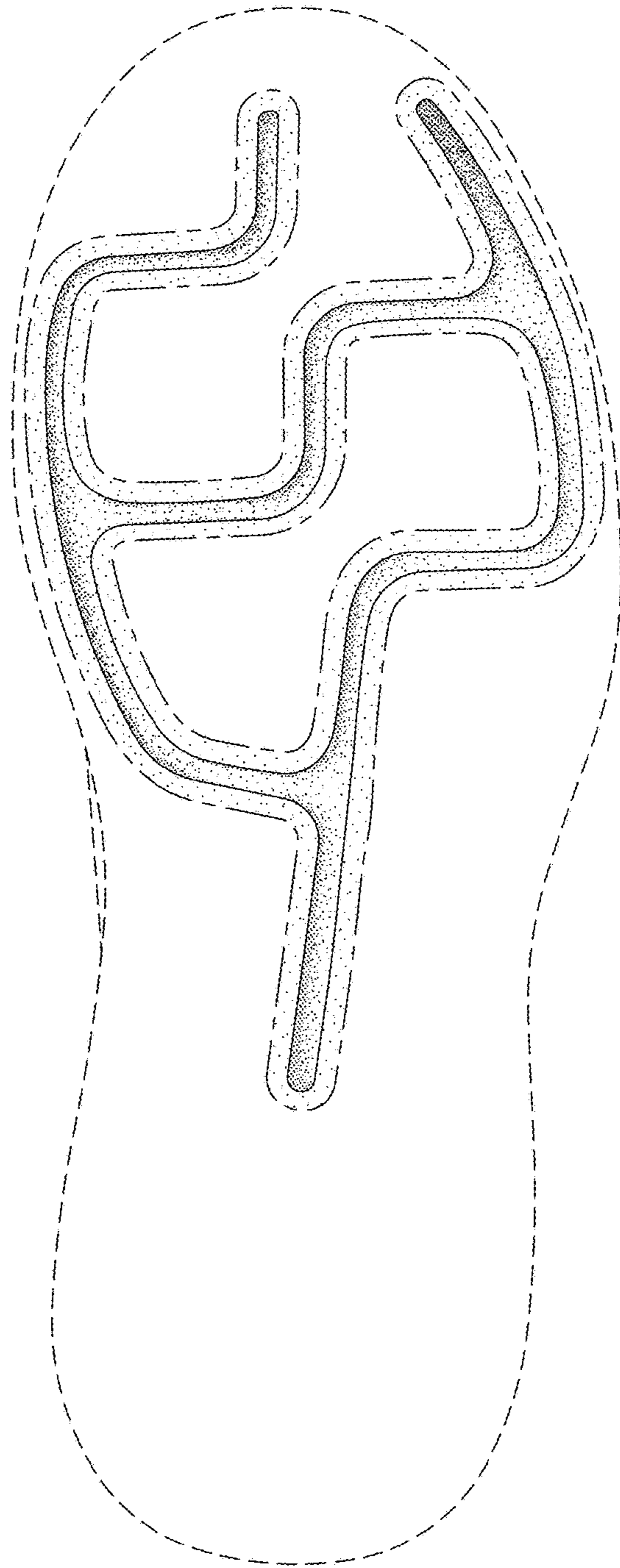

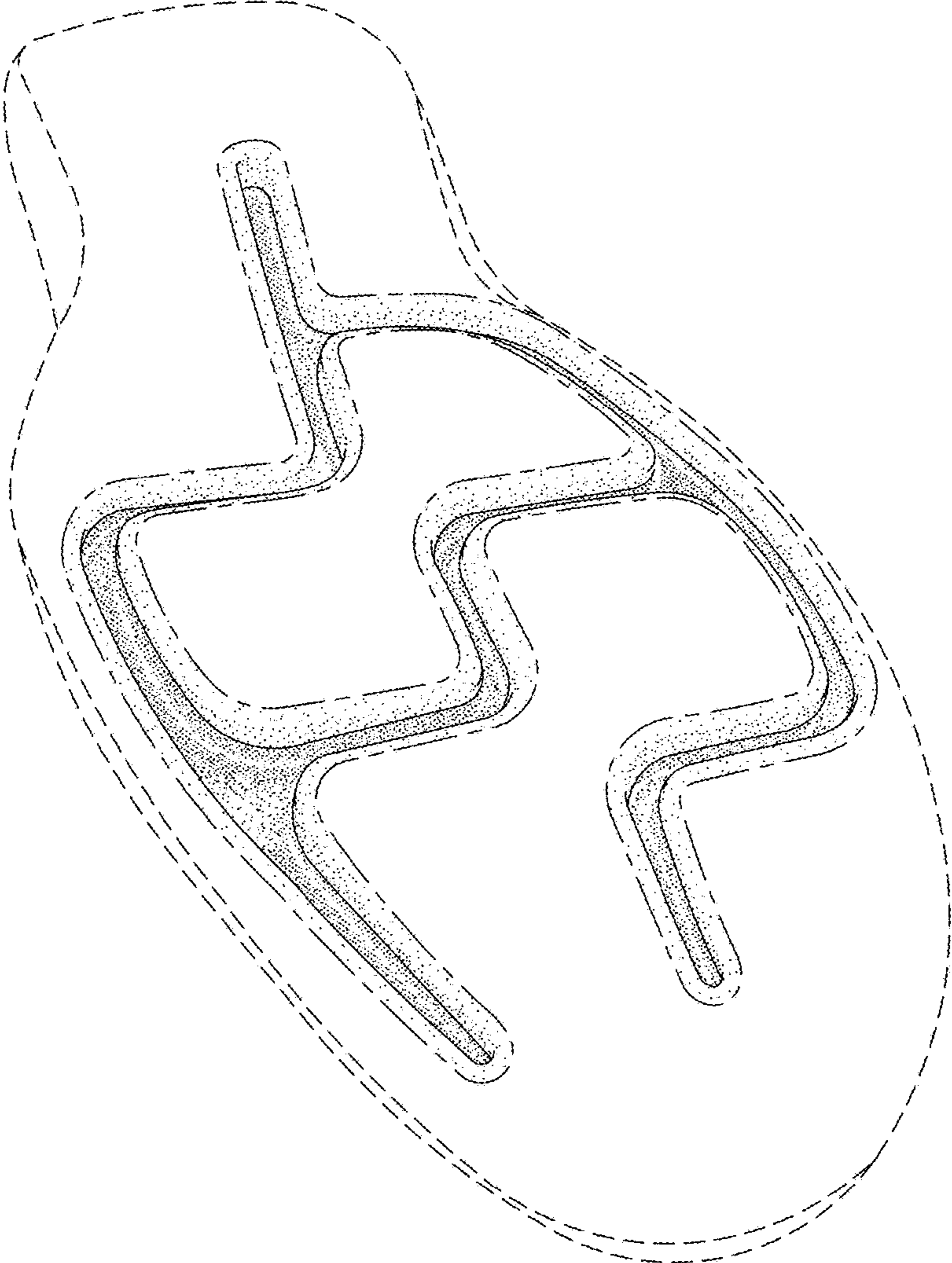

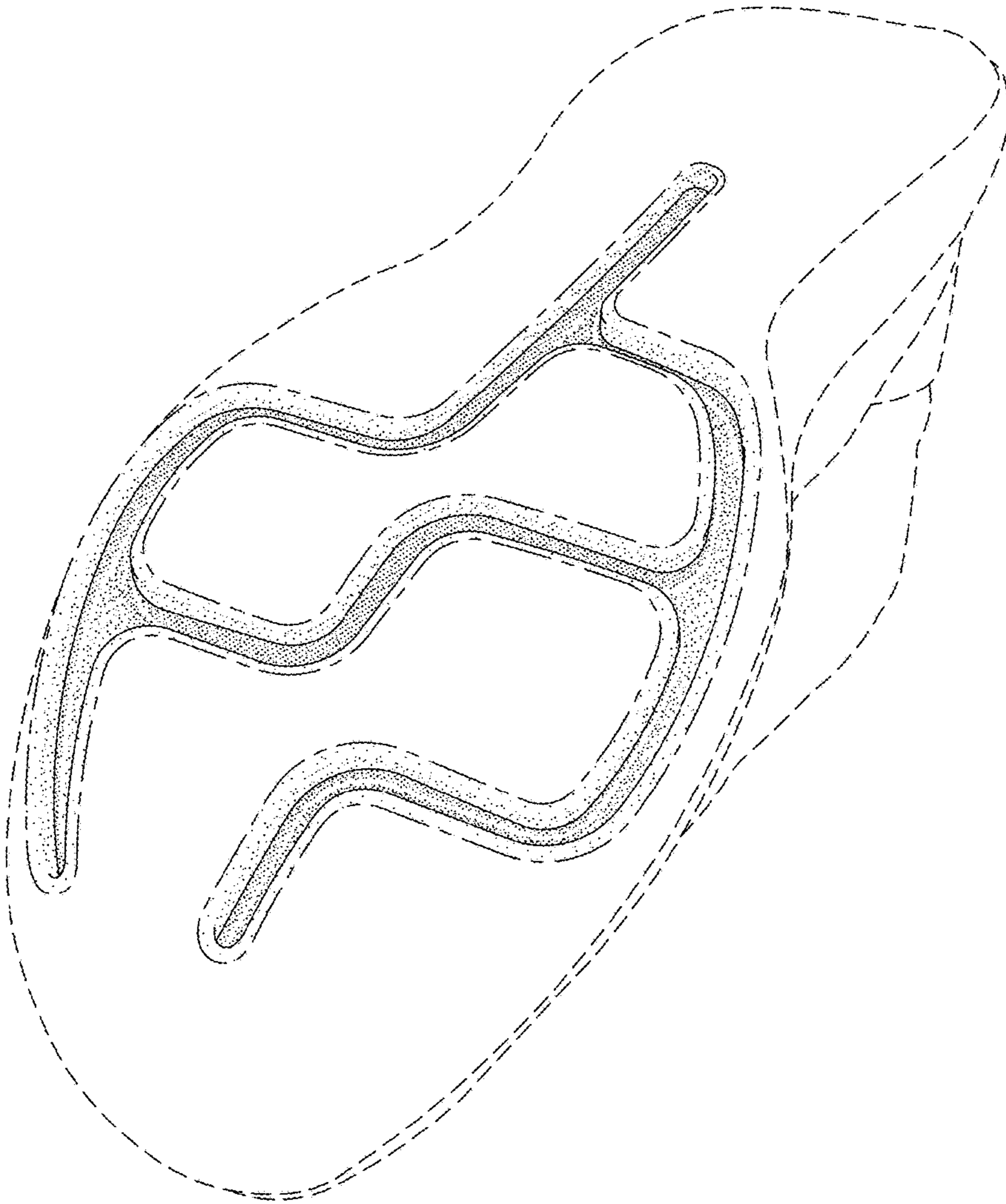
