The ornamental design for a shoe insert, as shown and described.

DESCRIPTION

FIG. 1 is a top, front, left side perspective view of a shoe insert for a right foot showing our new design;
 FIG. 2 is a bottom, rear, left side perspective view thereof;
 FIG. 3 is a top plan view thereof;
 FIG. 4 is a bottom plan view thereof;
 FIG. 5 is a right side elevational view thereof;
 FIG. 6 is a left side elevational view thereof;
 FIG. 7 is a front elevational view thereof;
 FIG. 8 is a rear elevational thereof;
 FIG. 9 is a cross sectional view taken along line 9-9 of FIG. 4; and,
 FIG. 10 is a cross sectional view taken along line 10-10 of FIG. 4.

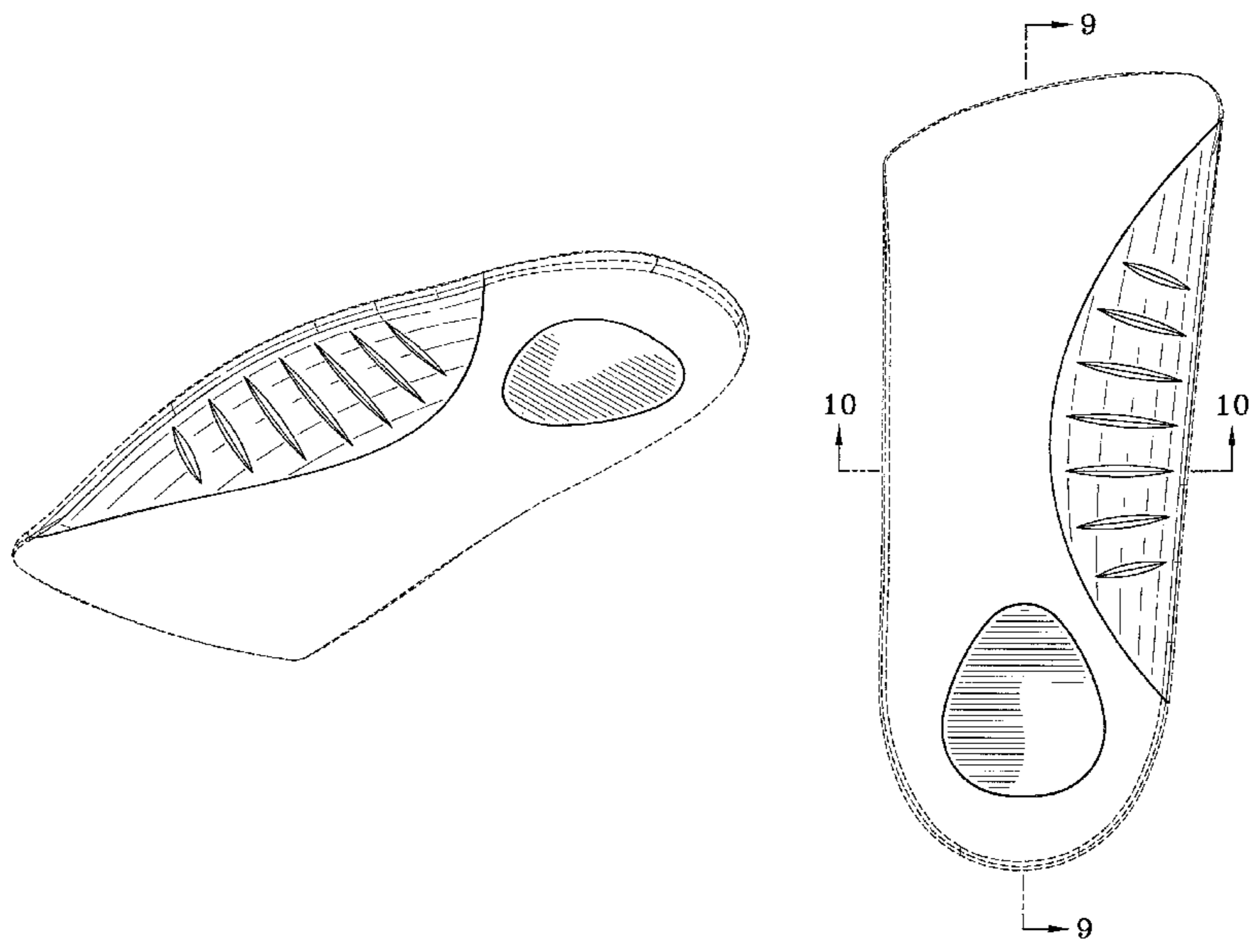
The design for a left foot shoe insert would be the mirror image of FIGS. 1-10.

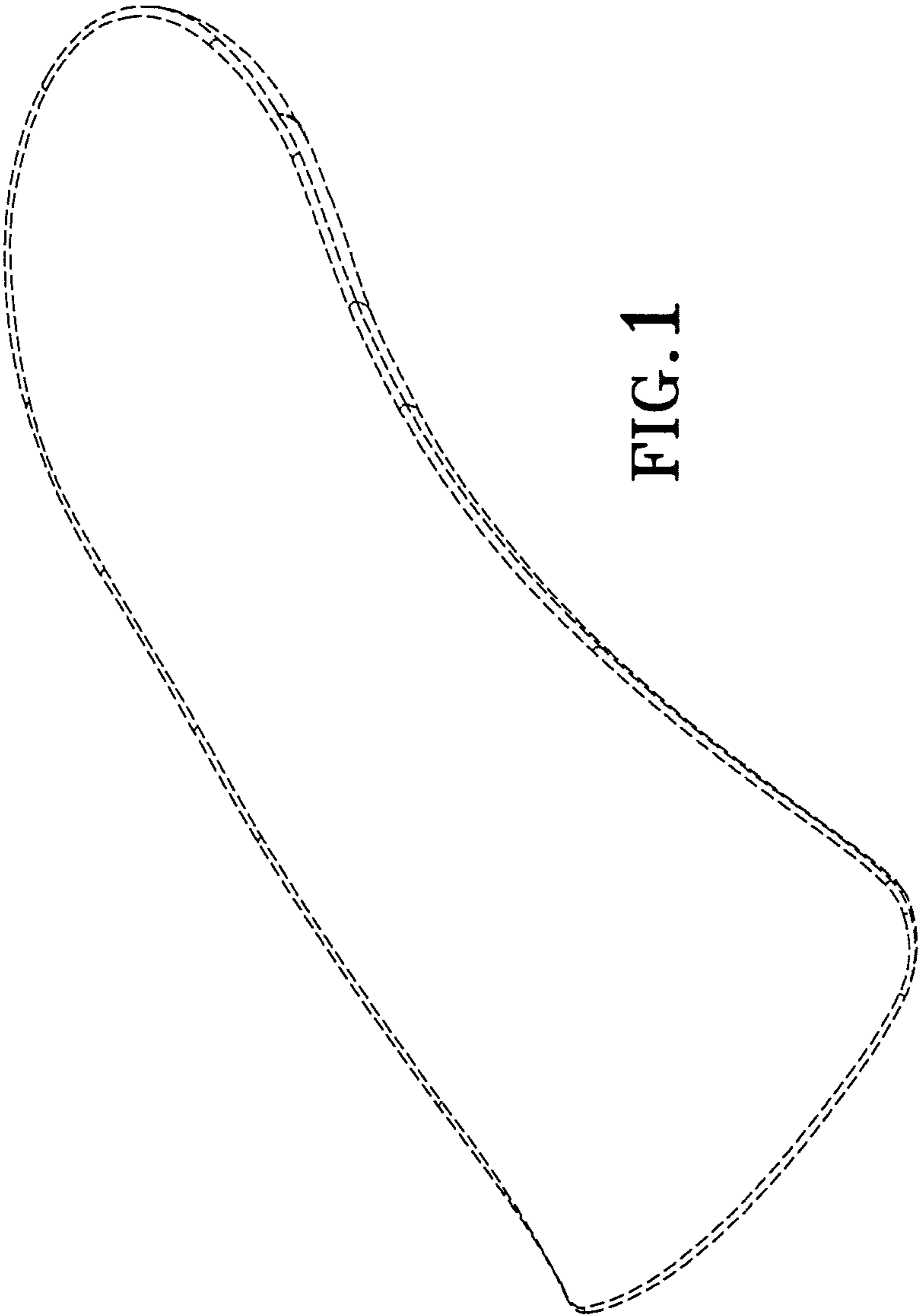

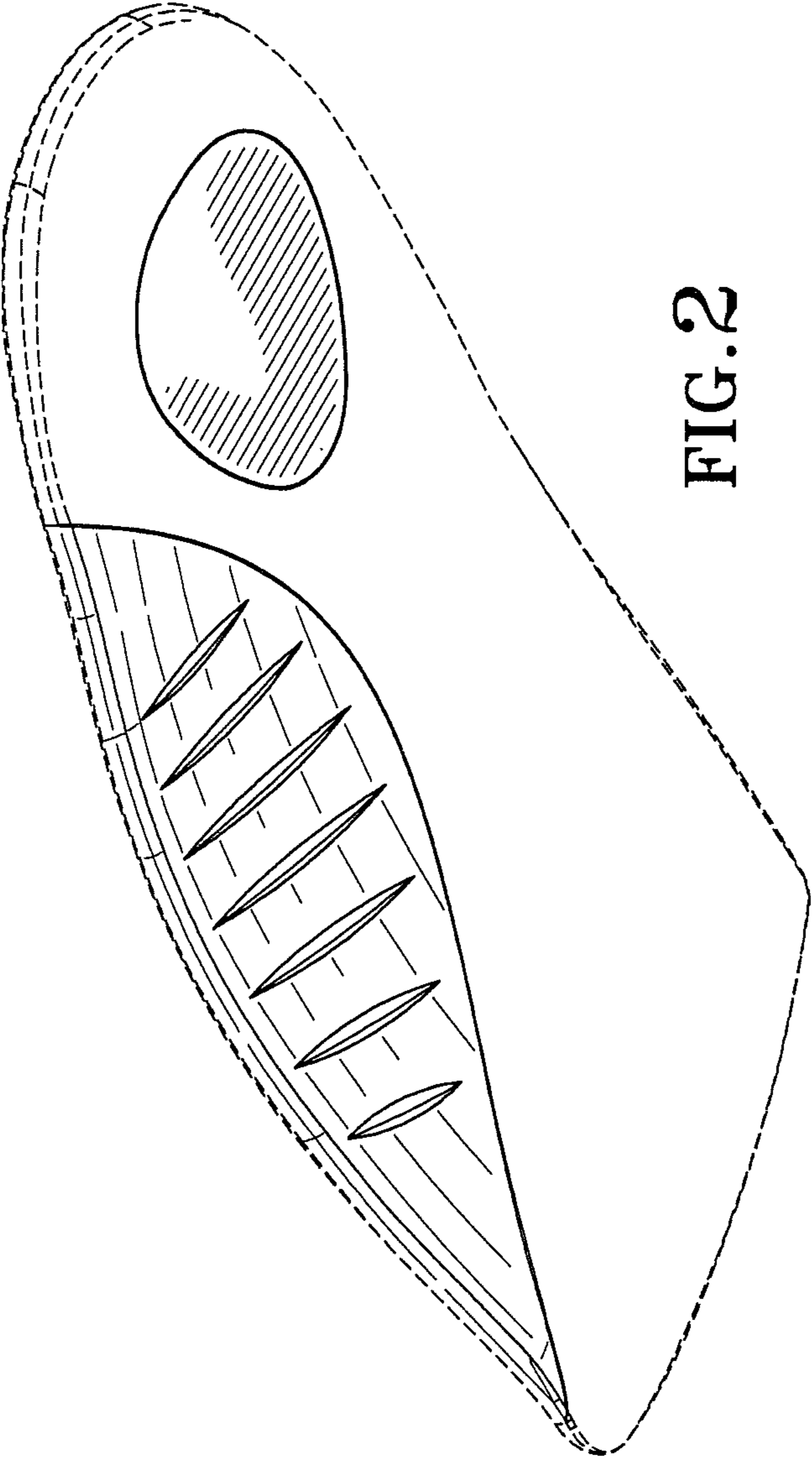

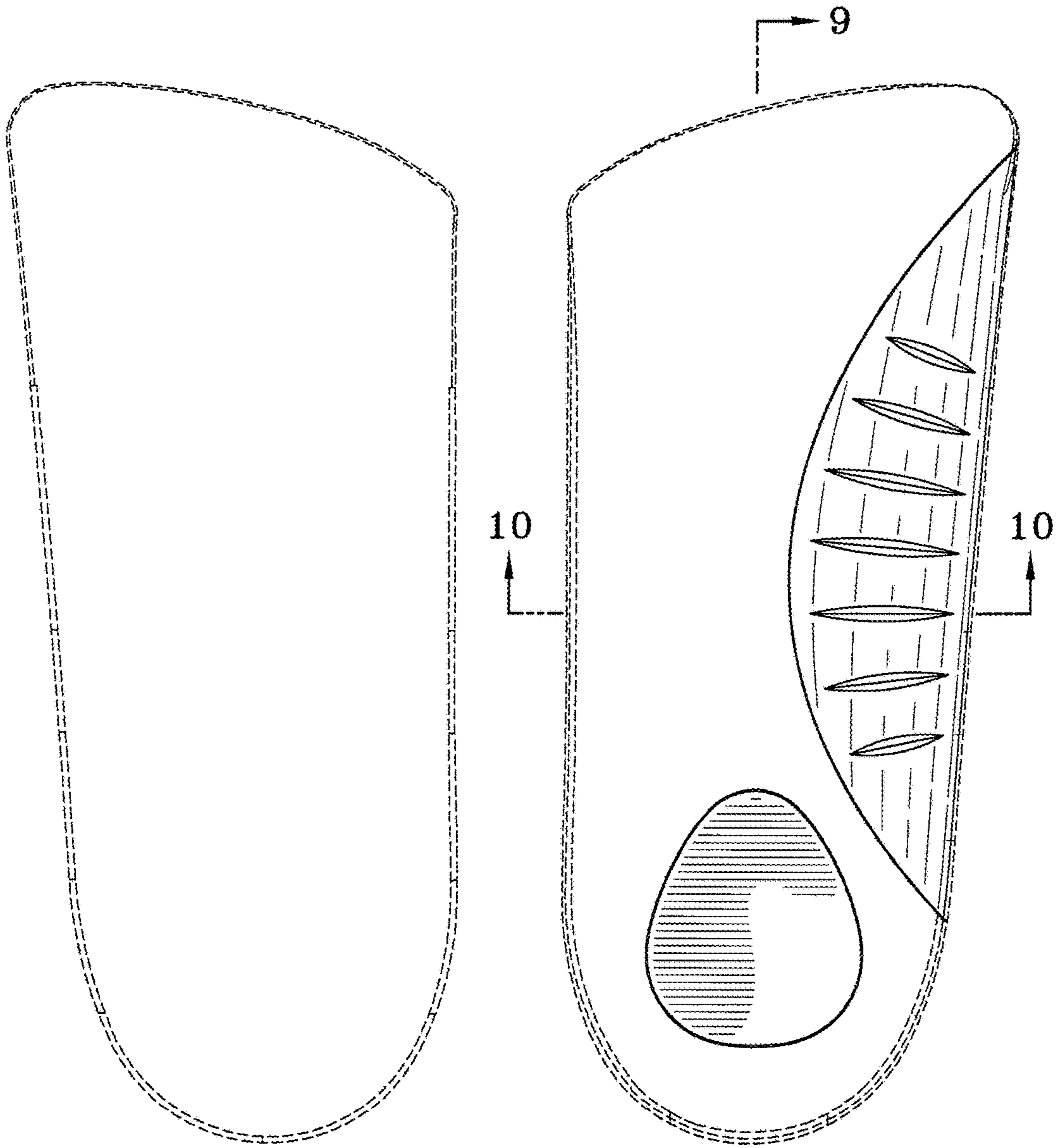

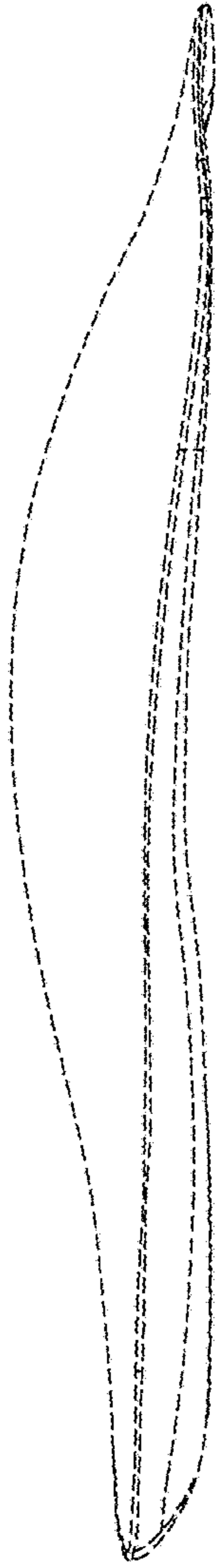

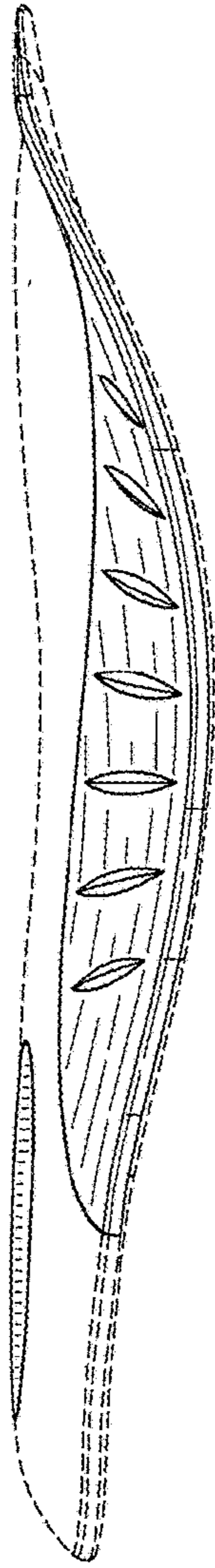

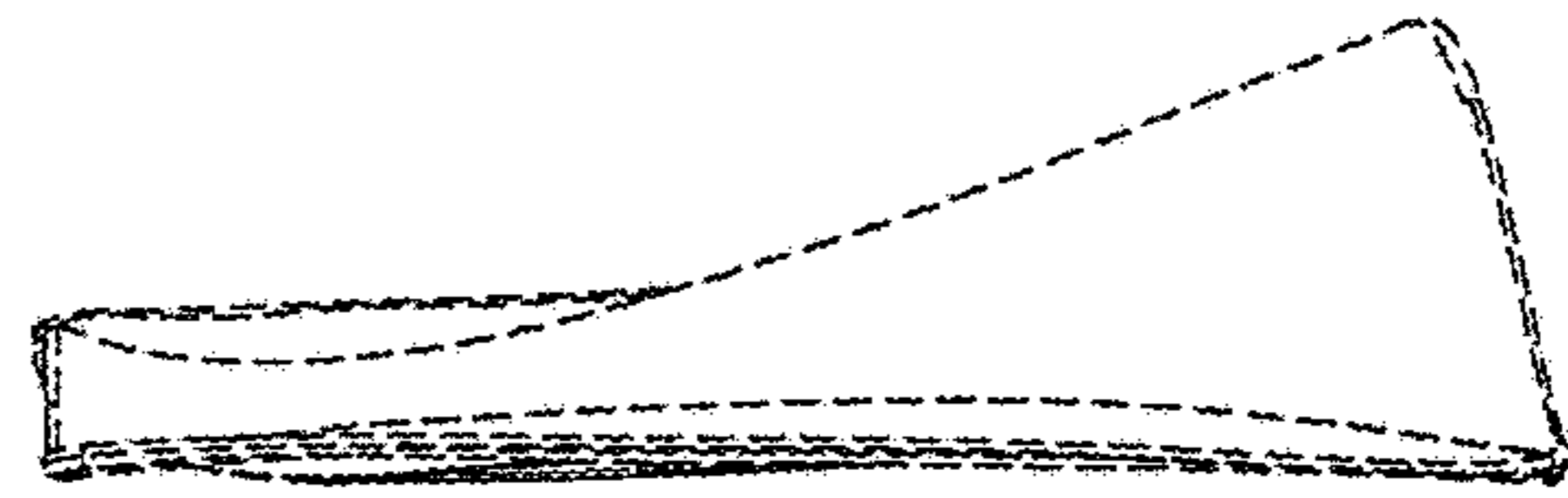

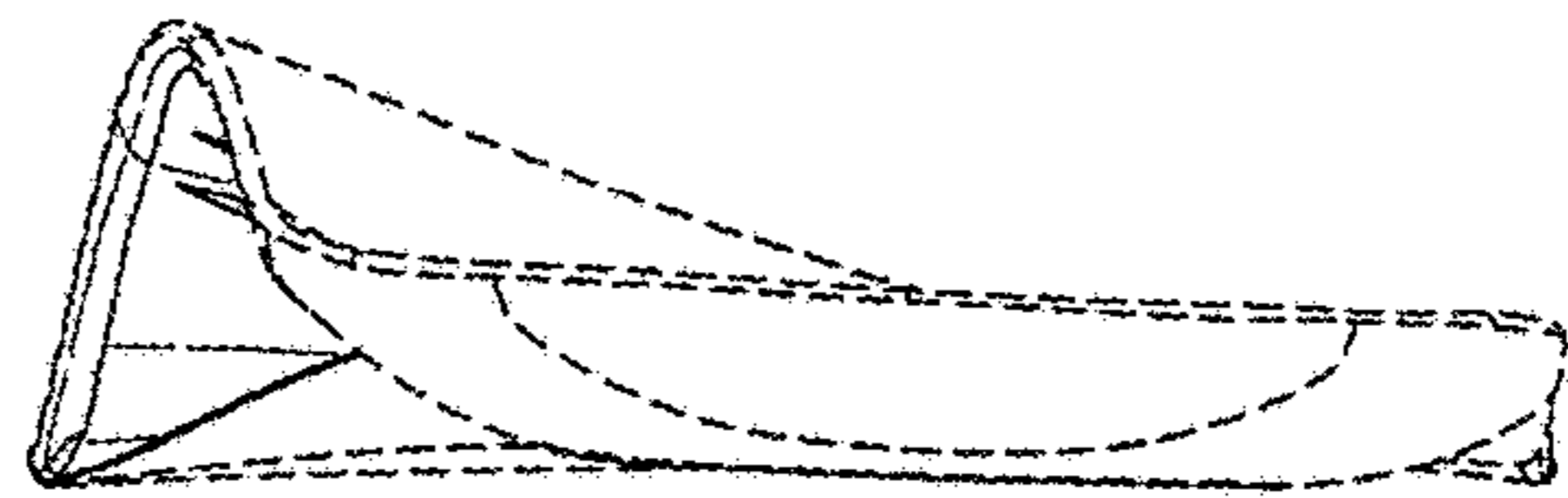

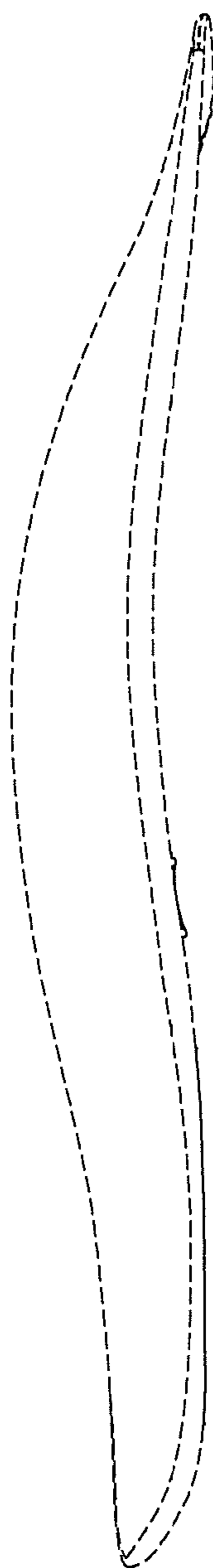

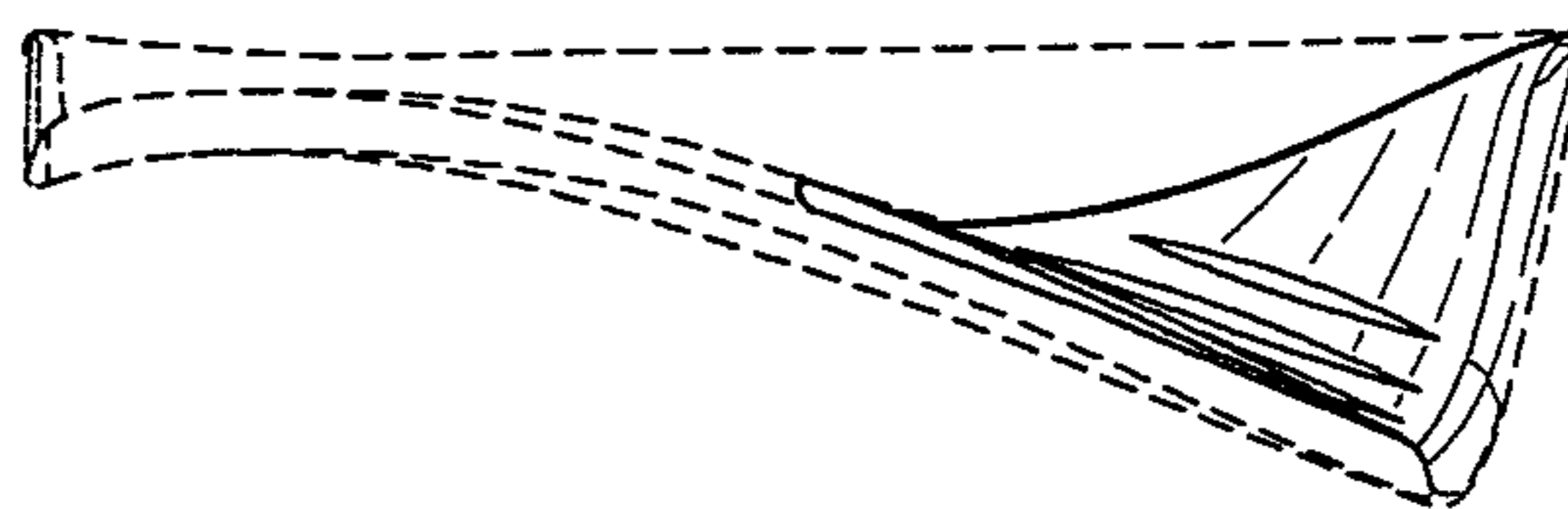
