The ornamental design for a shoe upper, as shown and described.

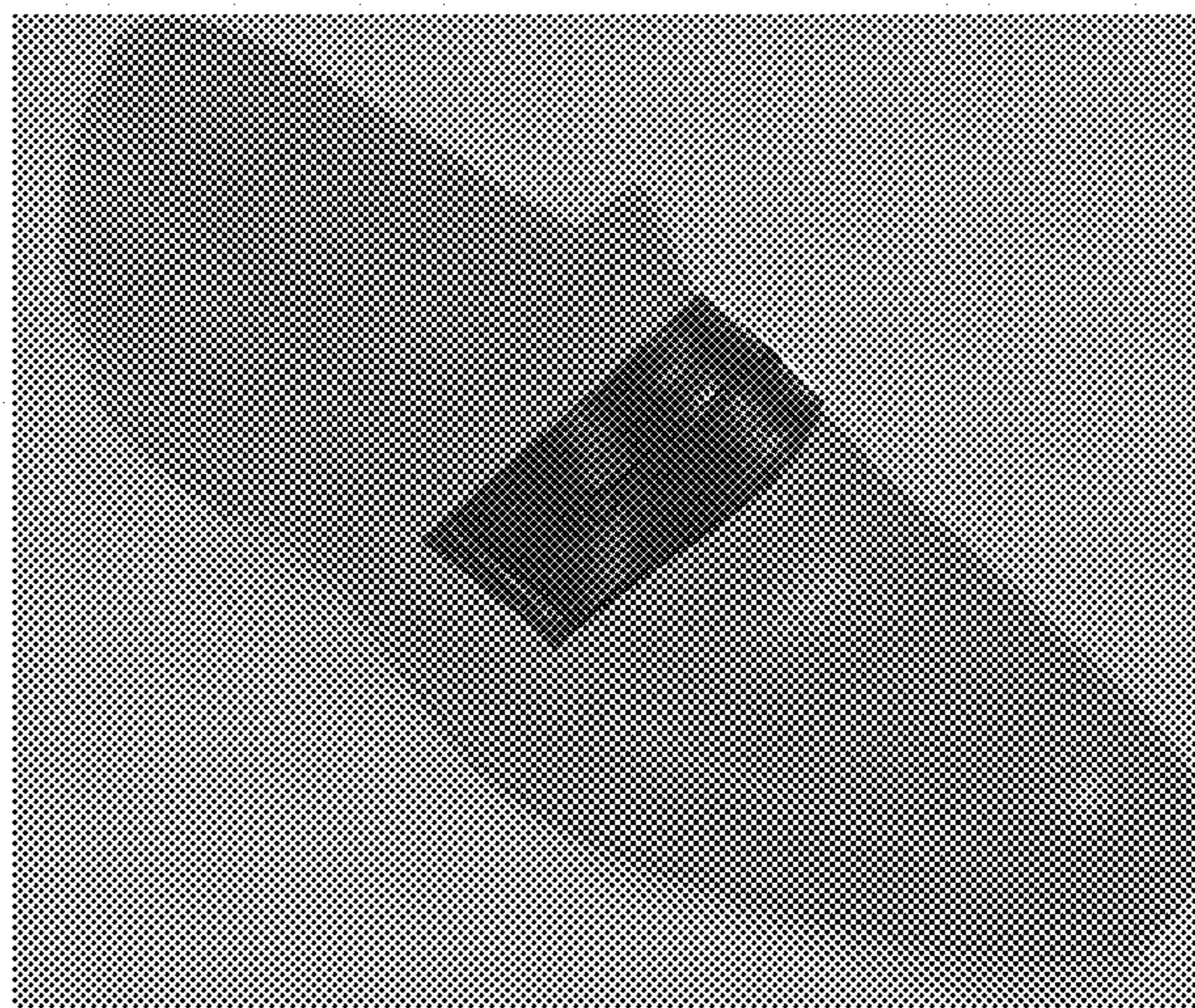

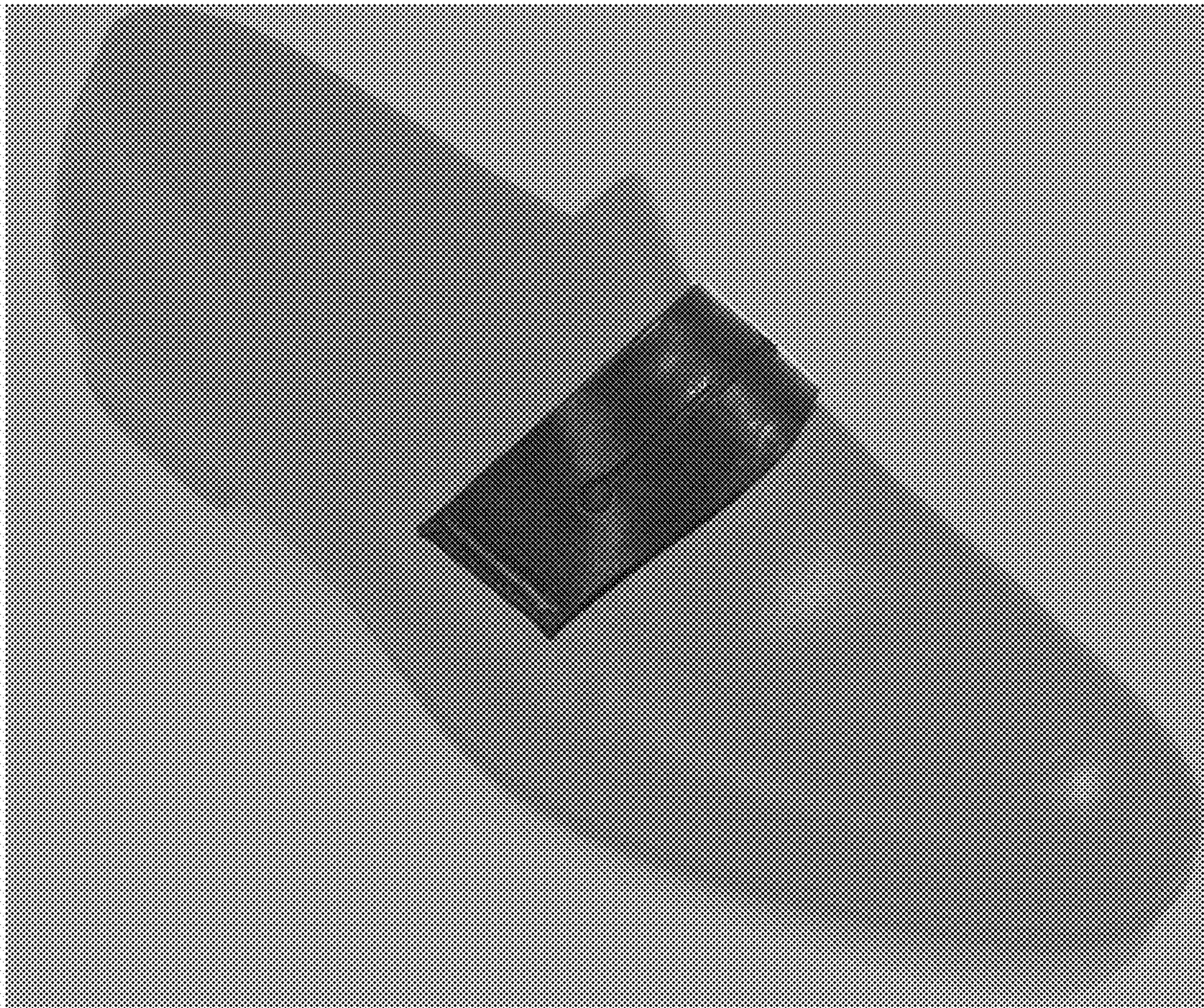

Protection is claimed for the sole part of the shoe in gray scale of design 6, while protection of the parts of the shoe which are colored in blue is disclaimed.

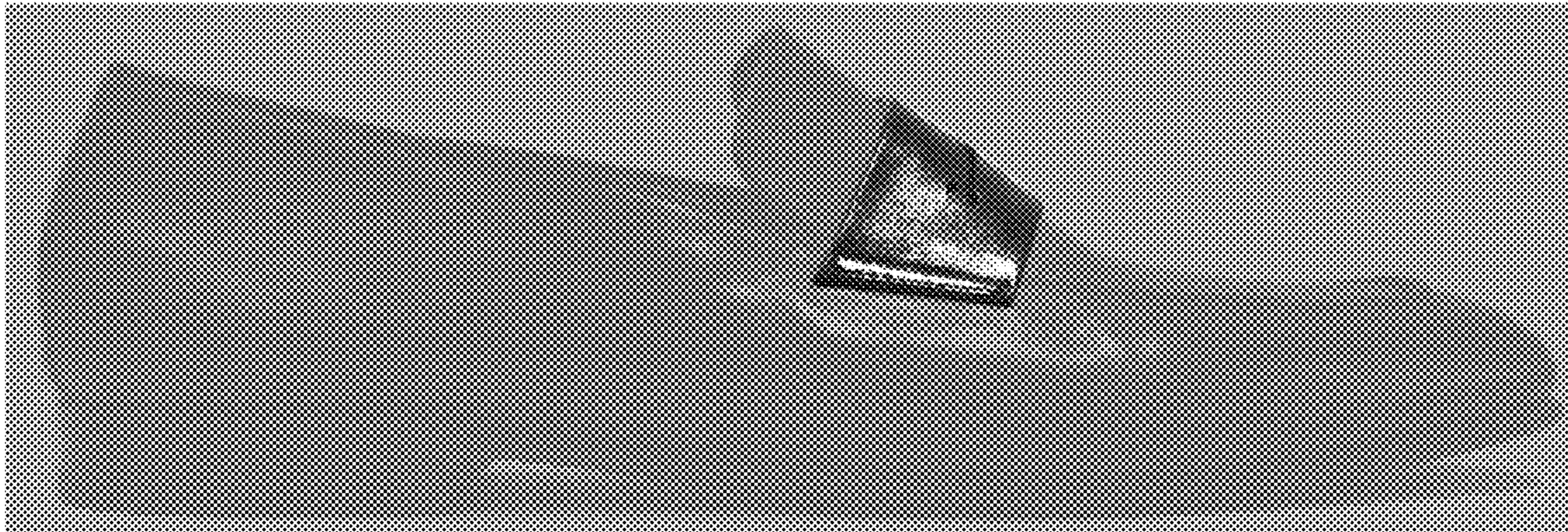

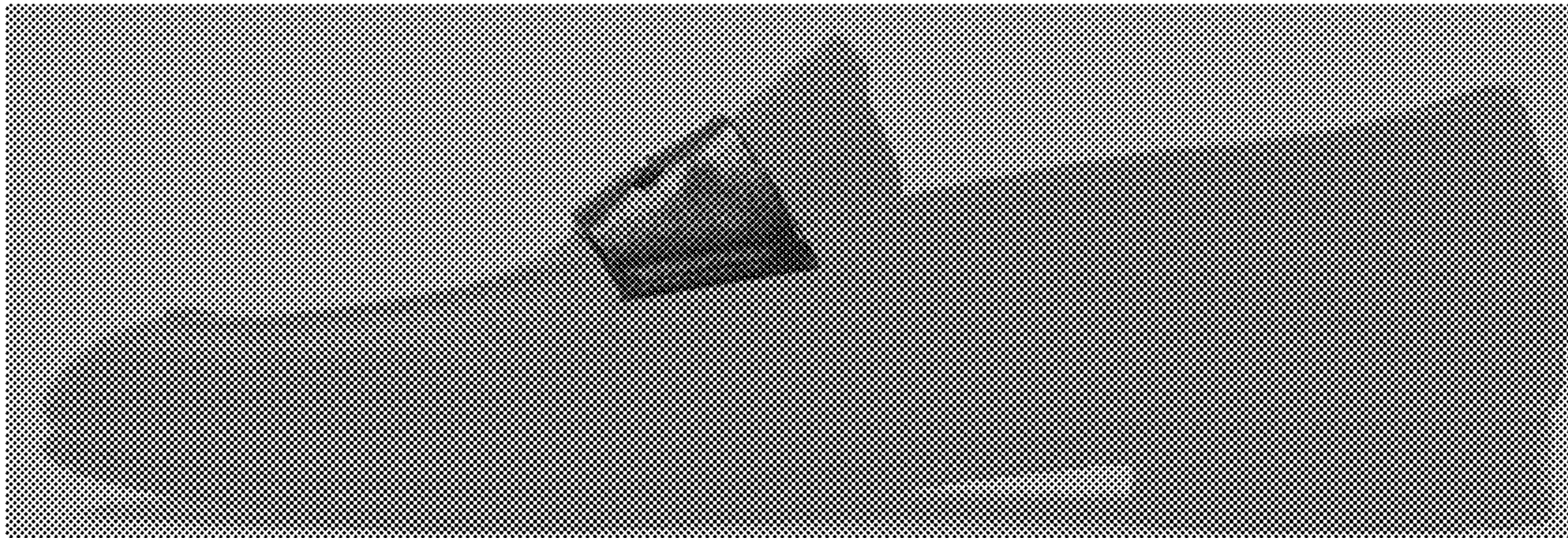

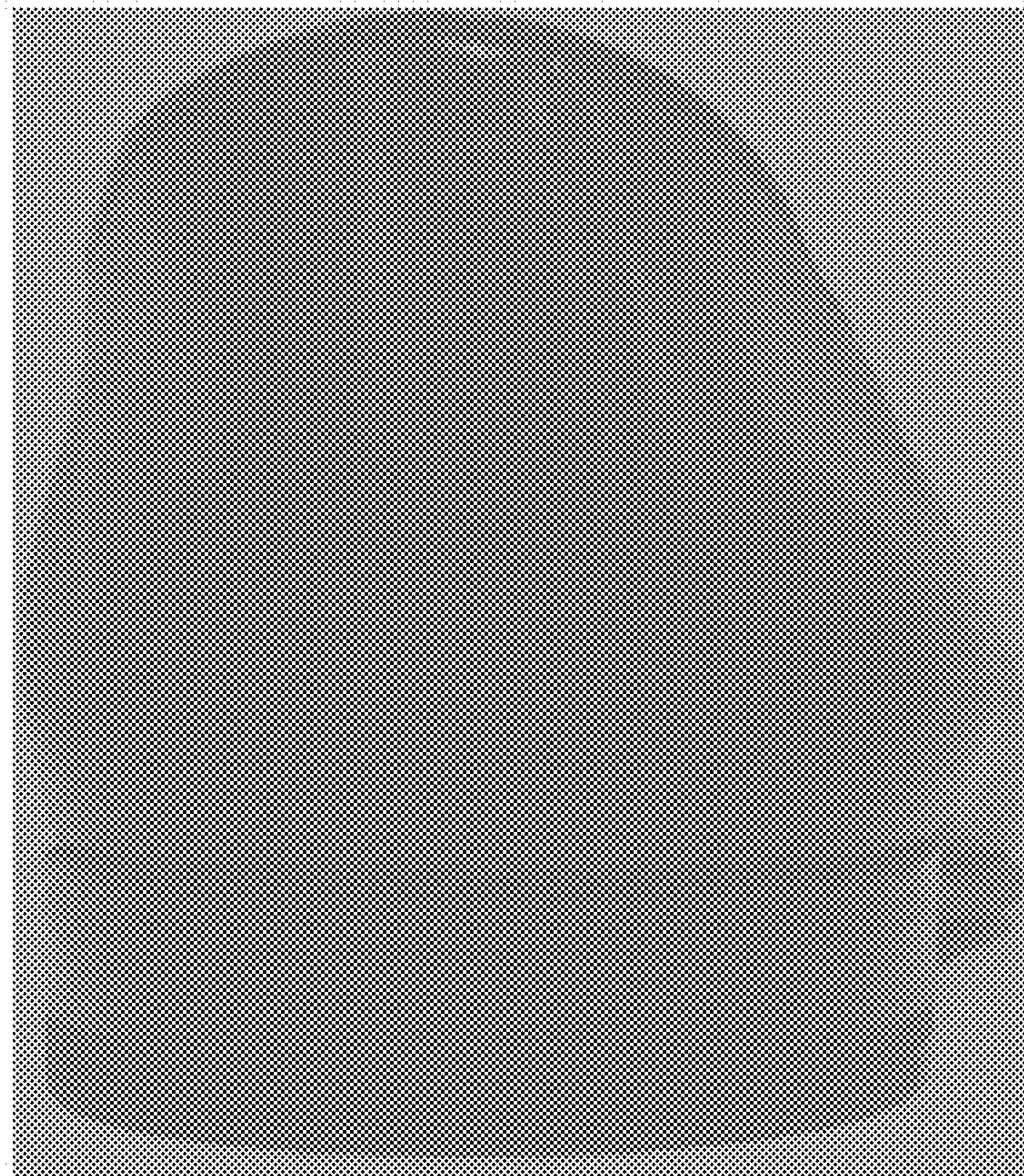

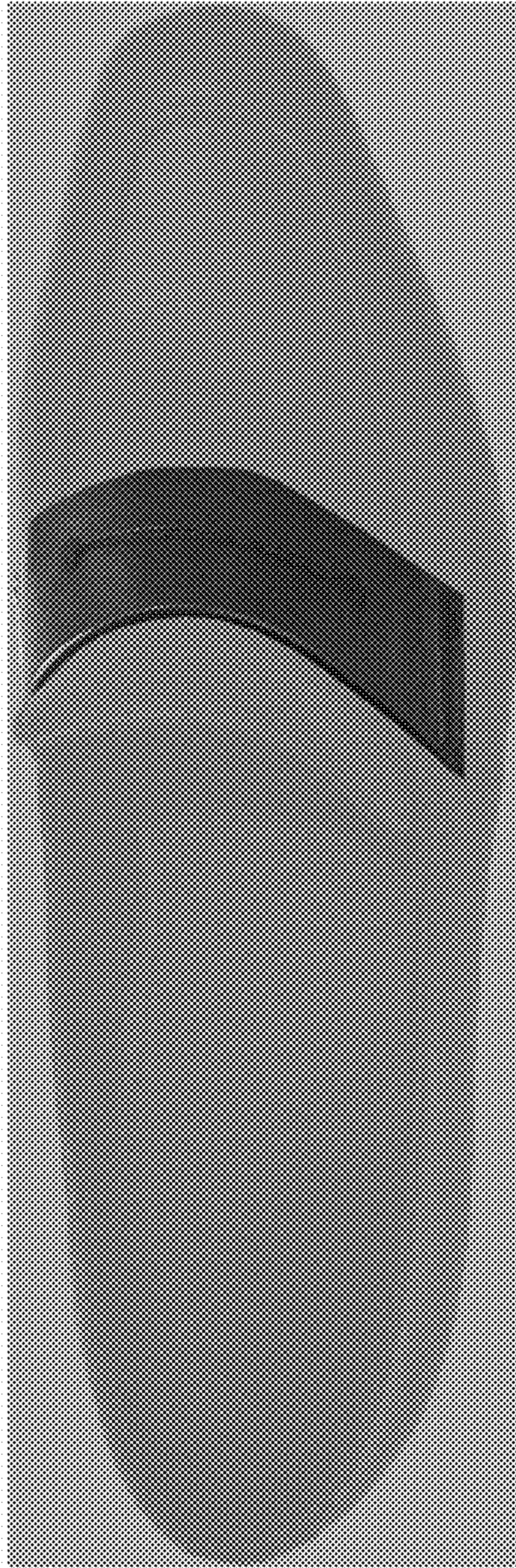
