DESCRIPTION

FIG. 7 is a side view thereof;

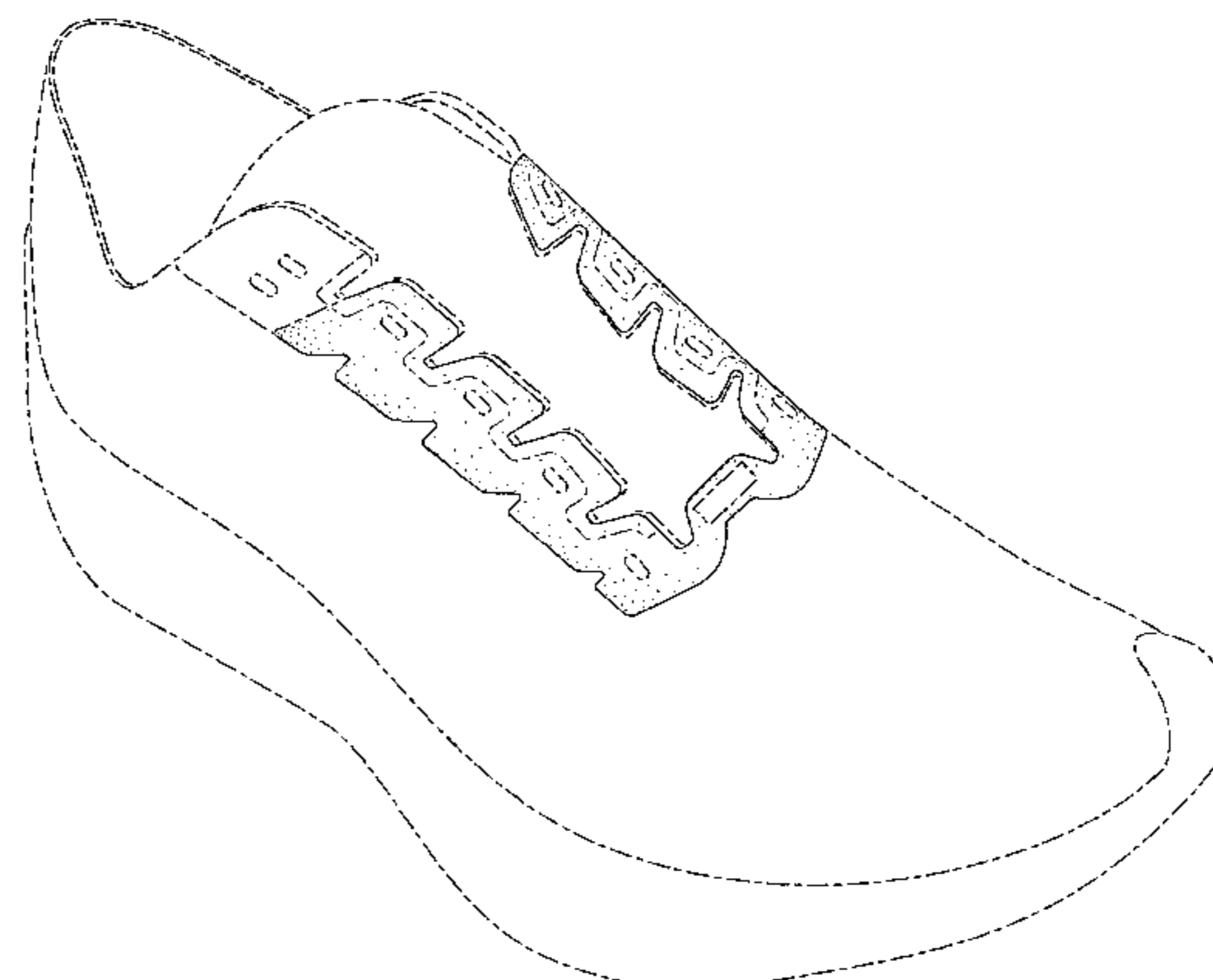
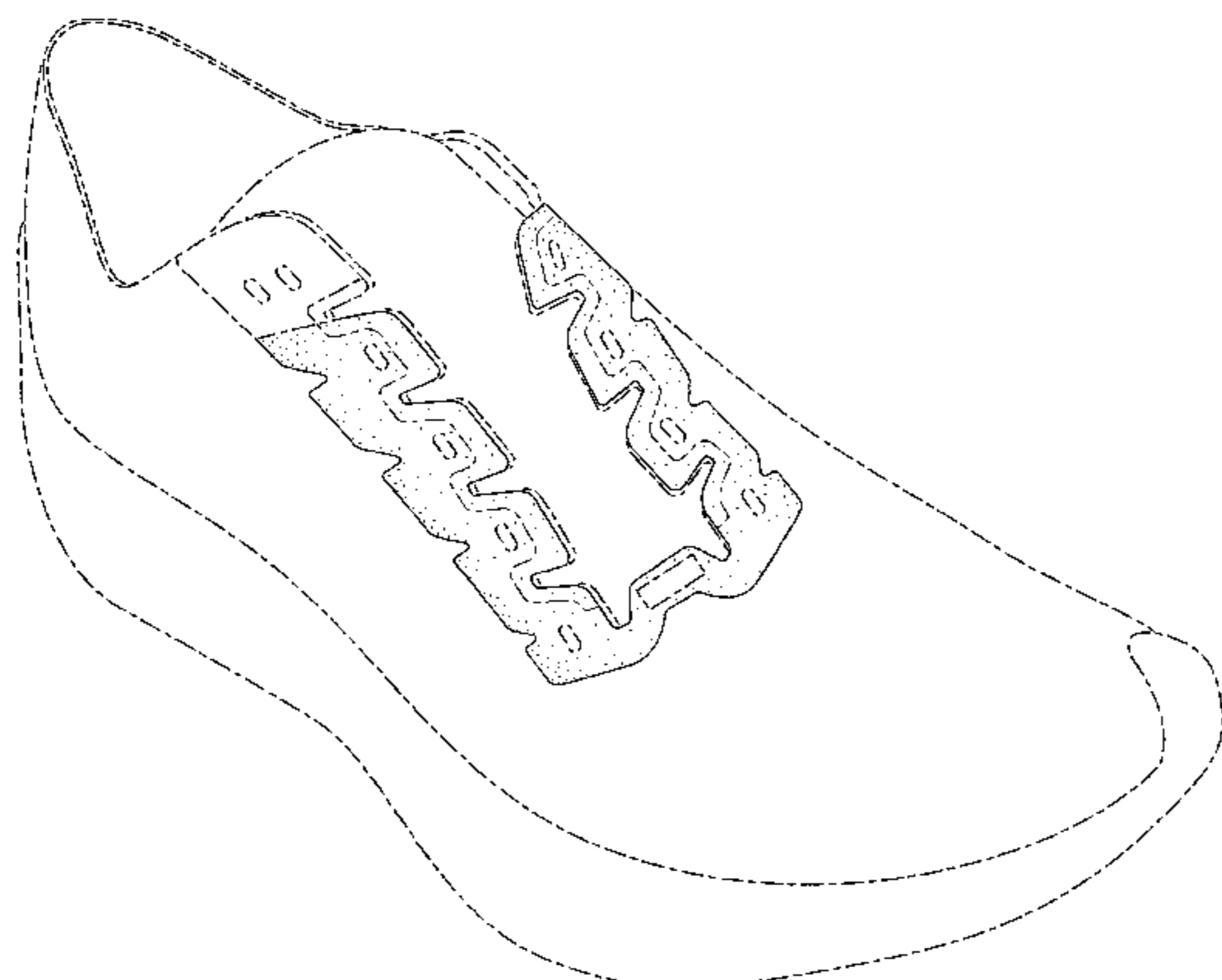
FIG. 8 is an opposite side view thereof;

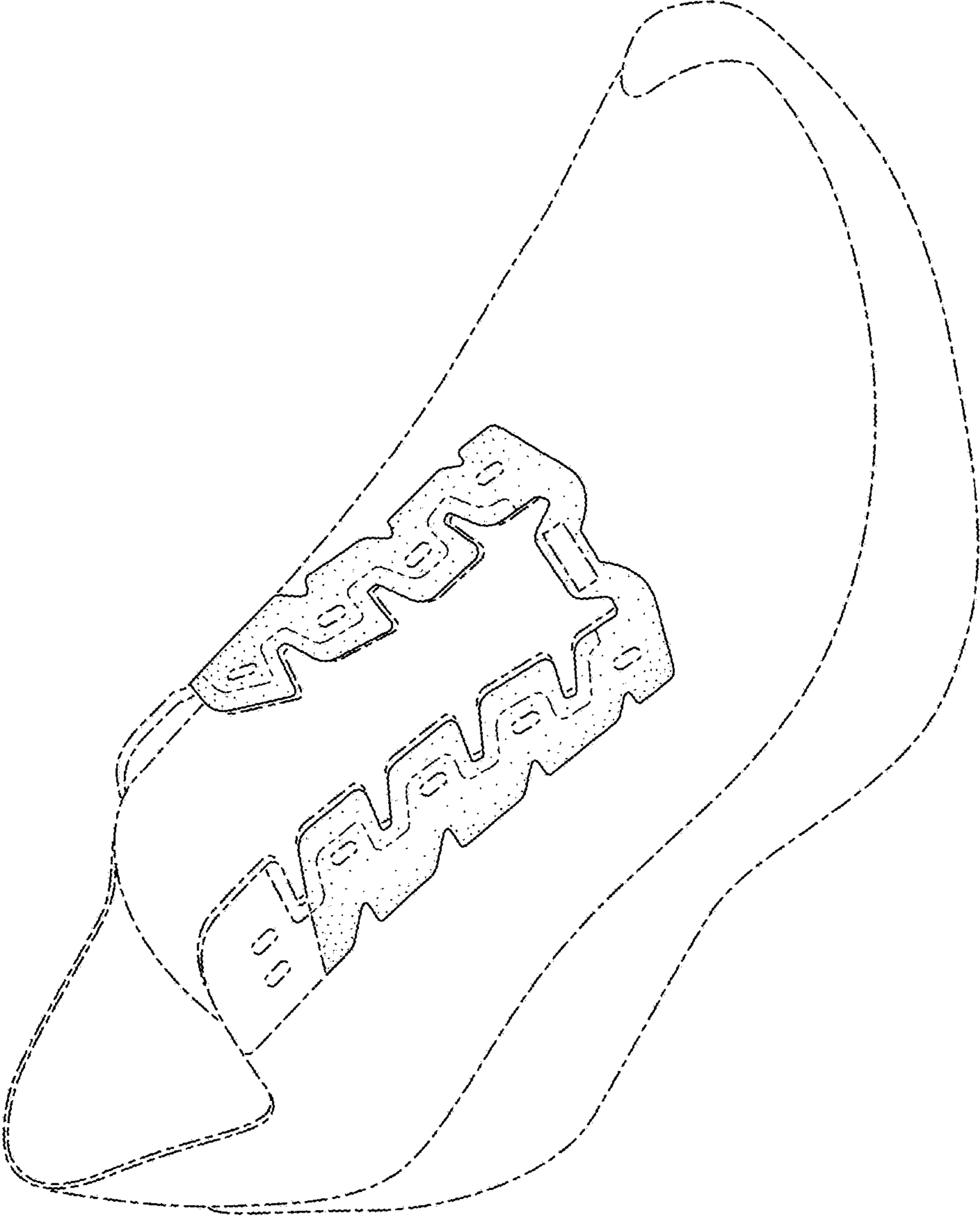

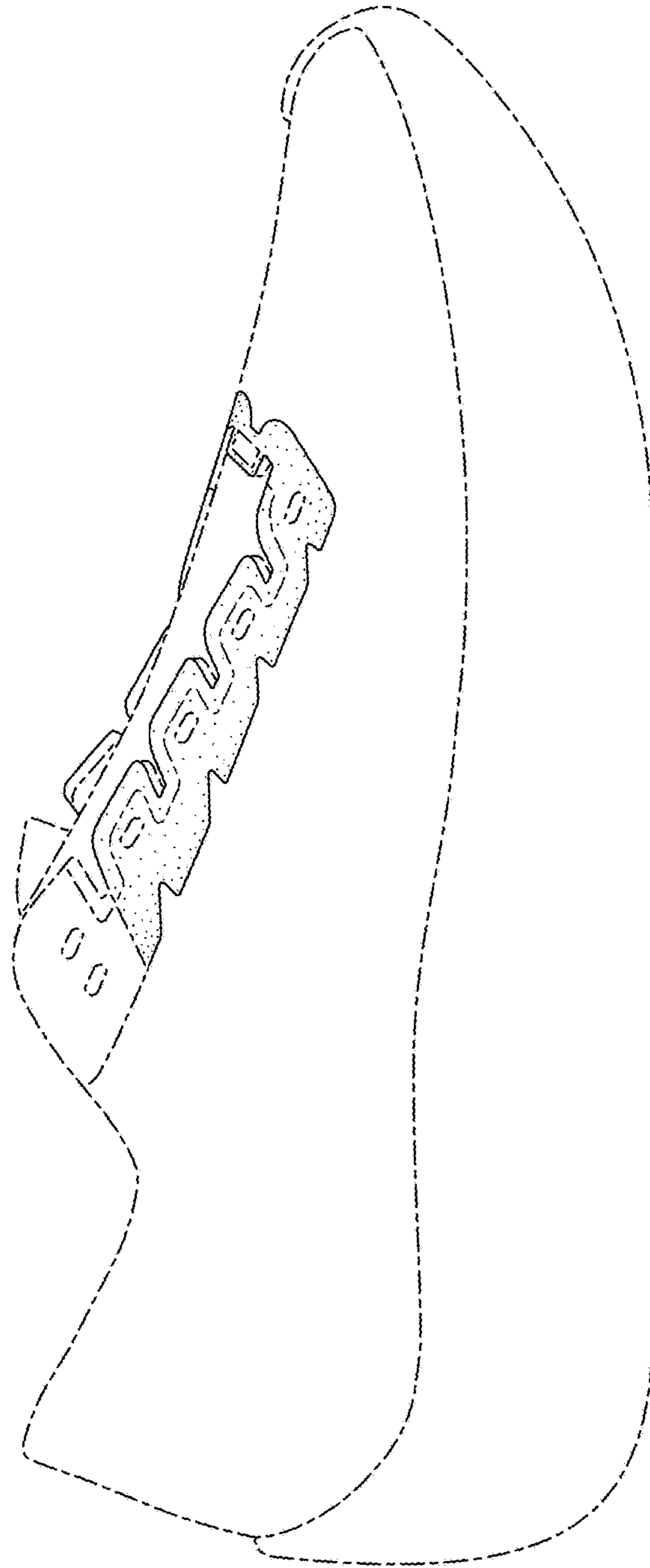

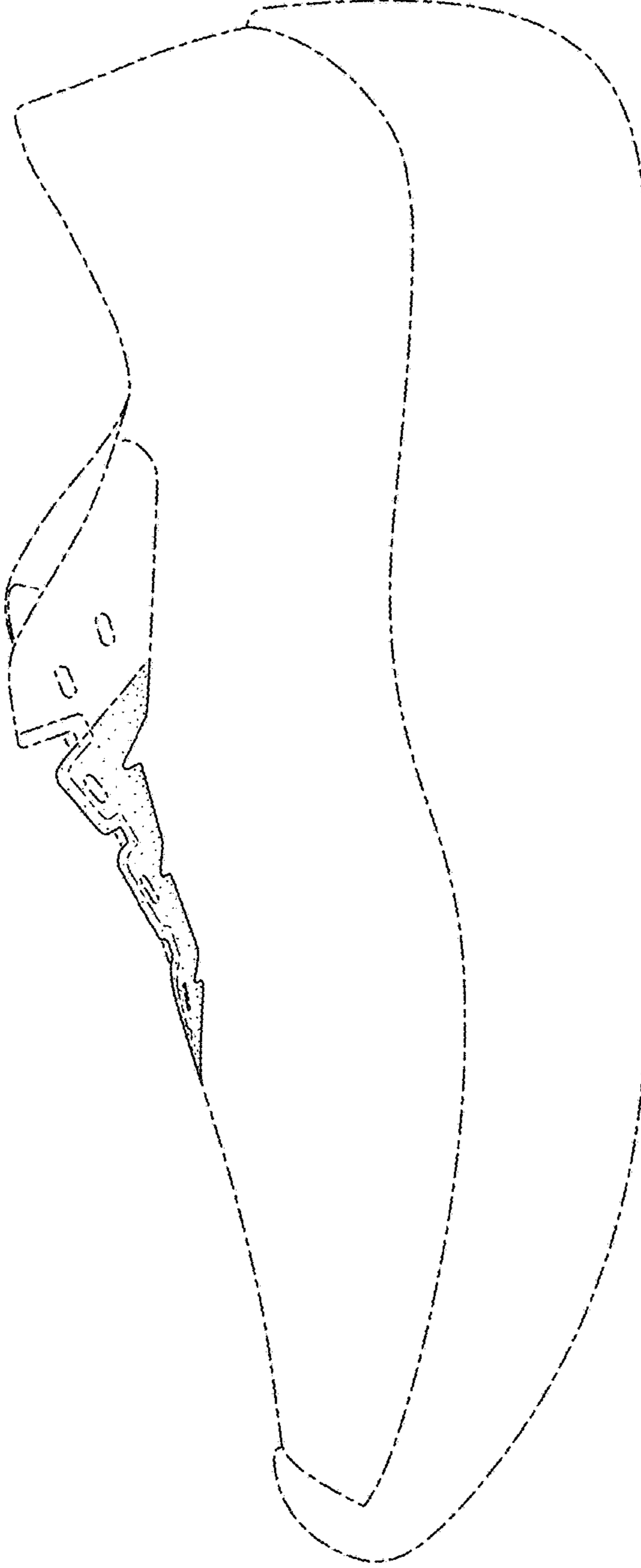

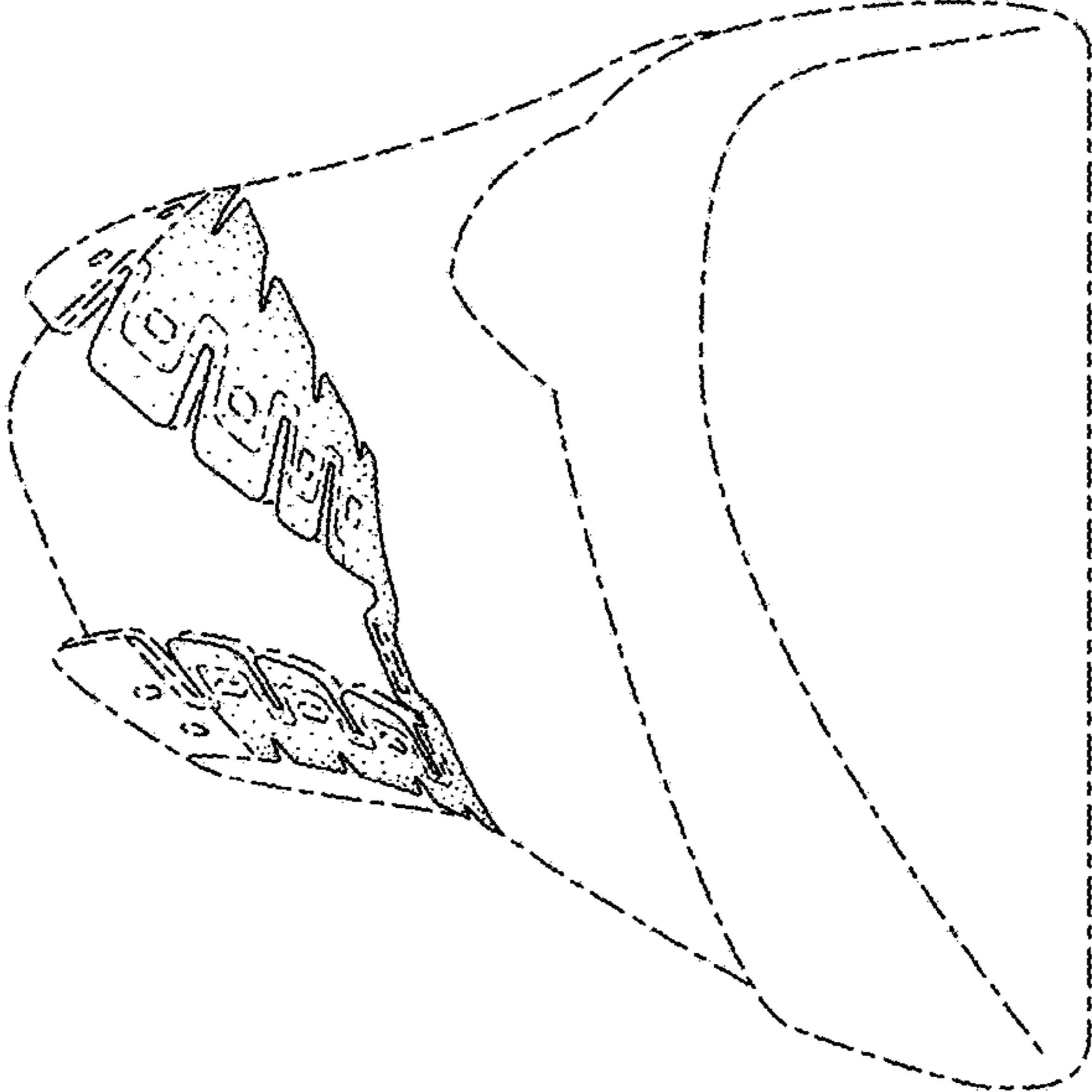

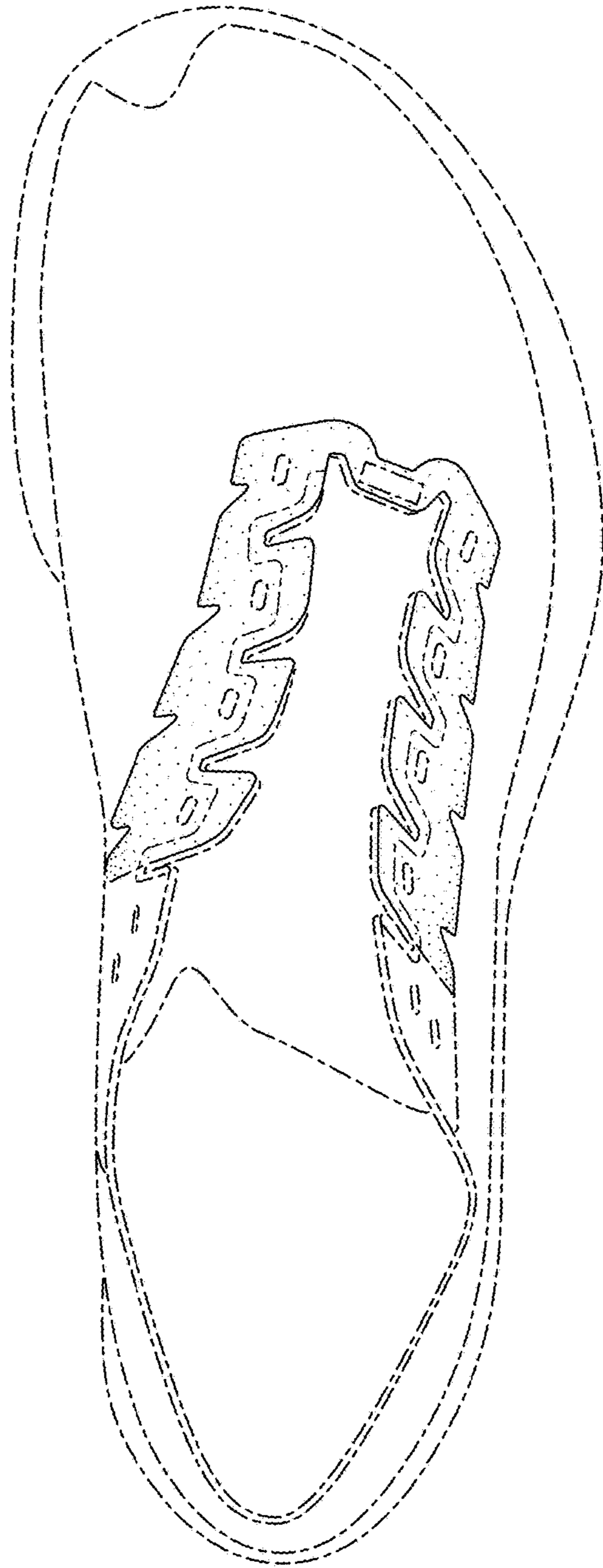

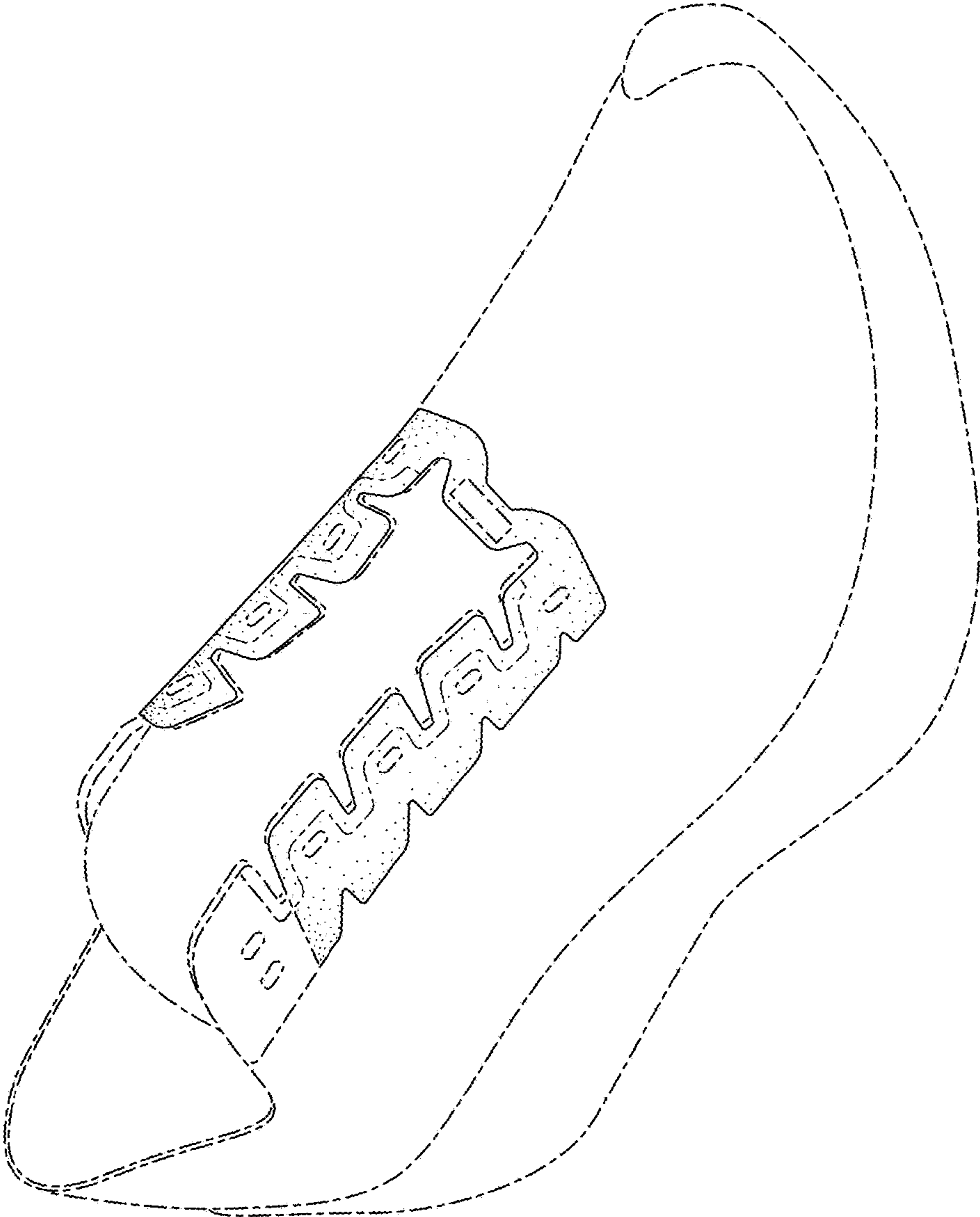

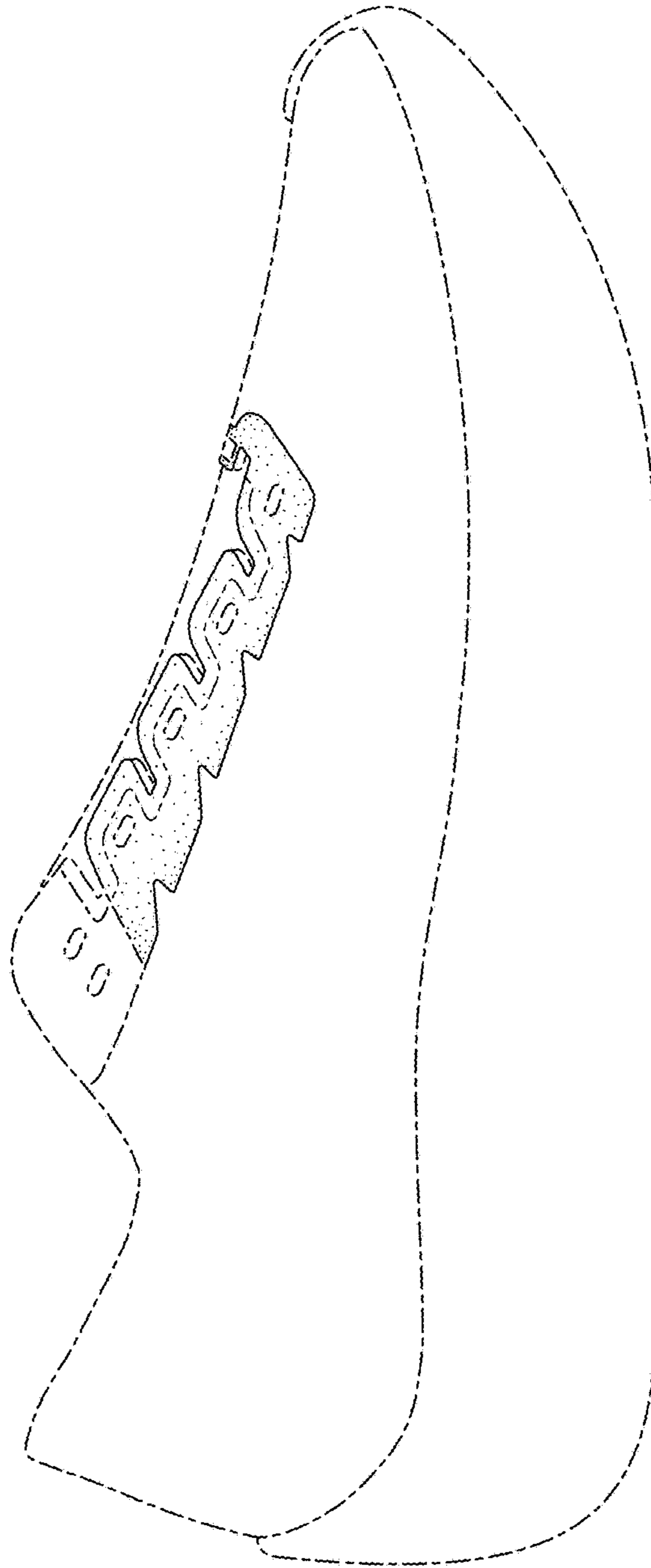

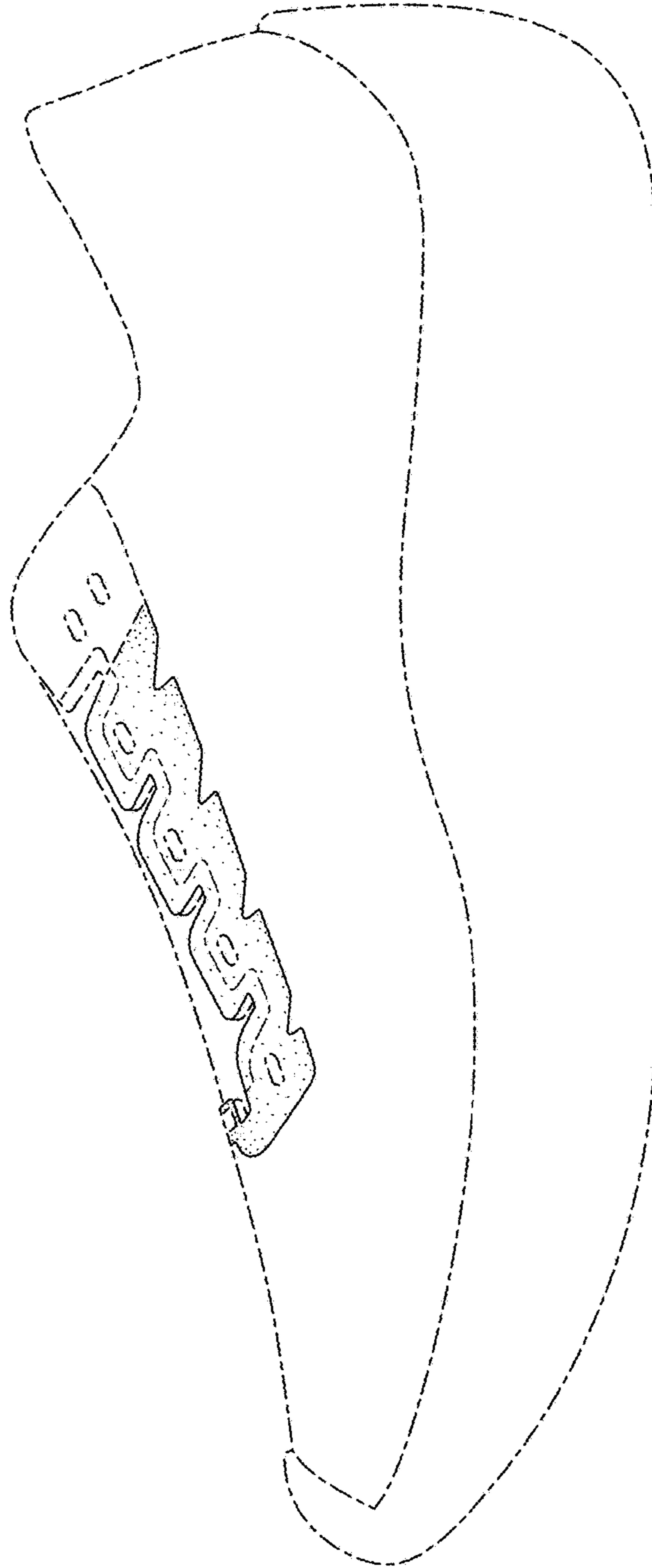

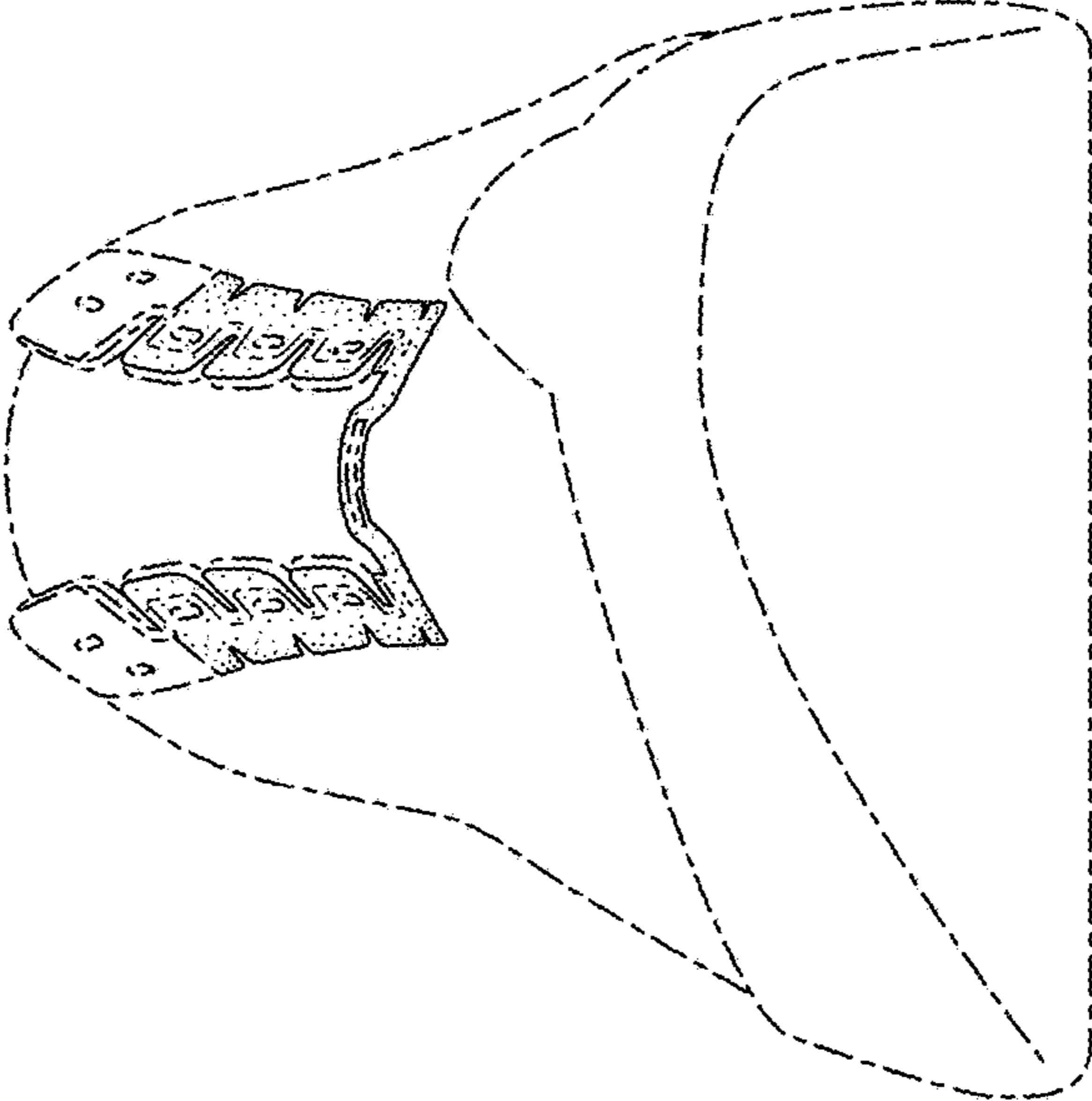

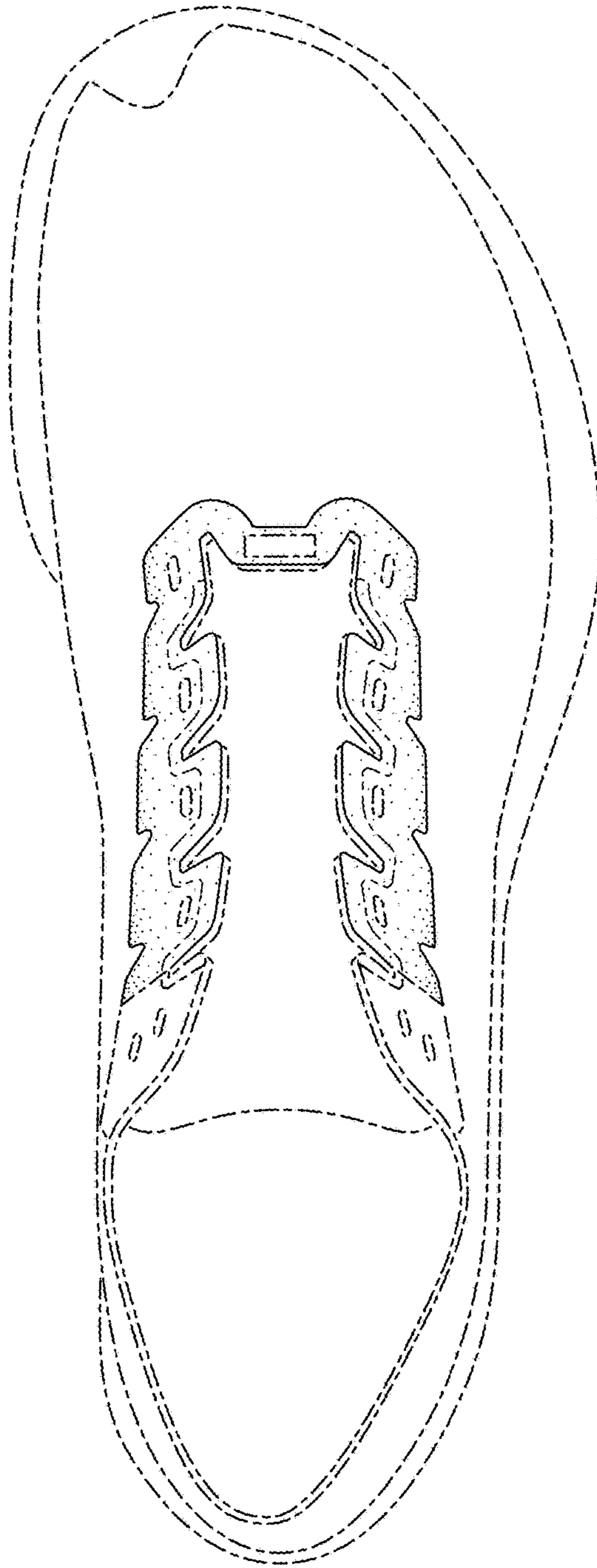
