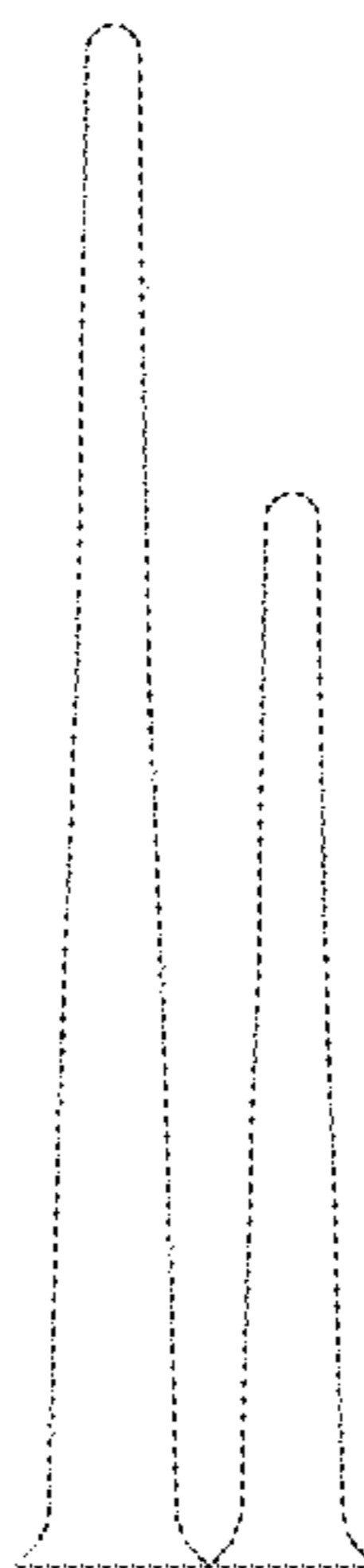
**CLAIM**

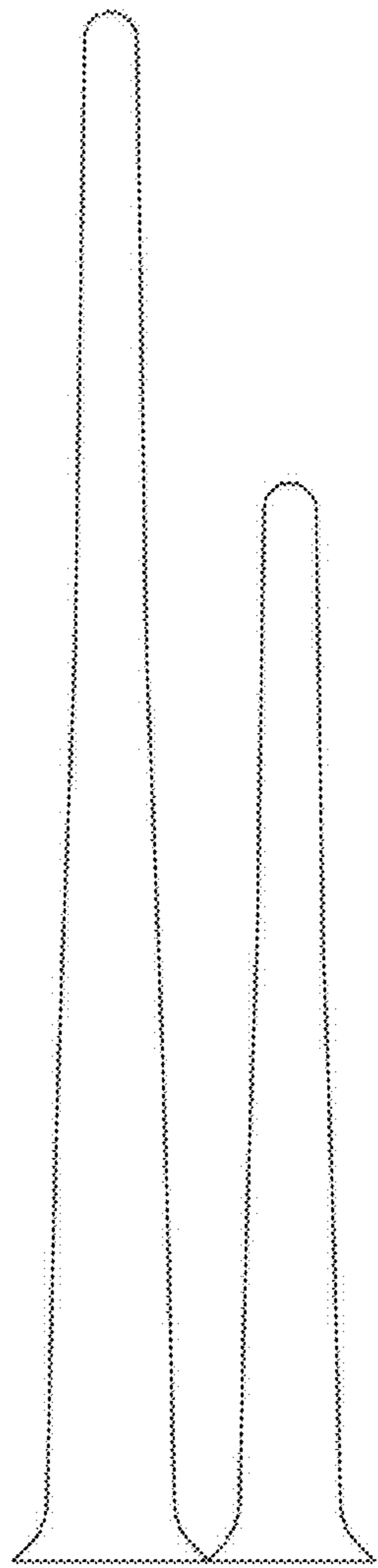

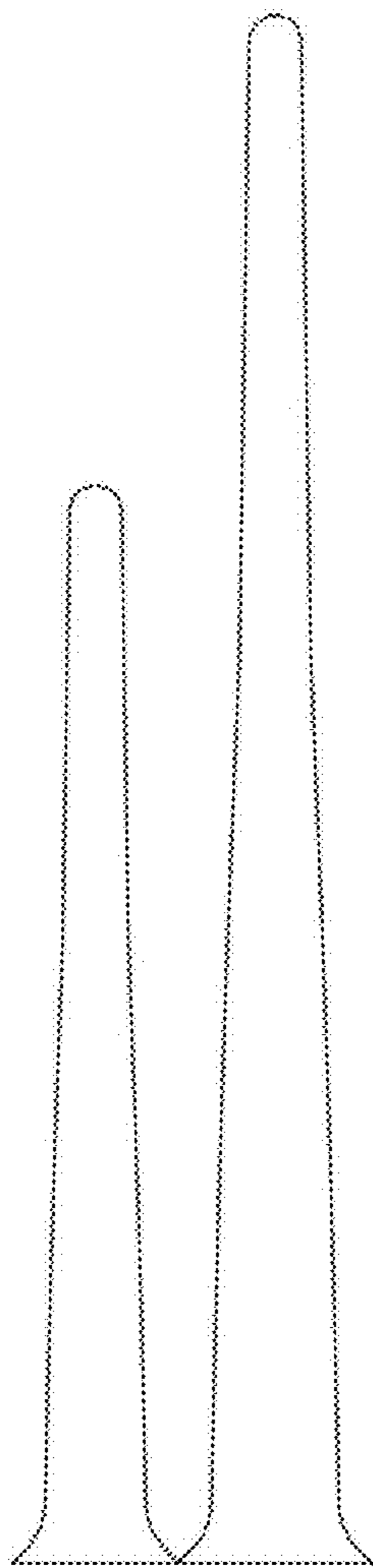

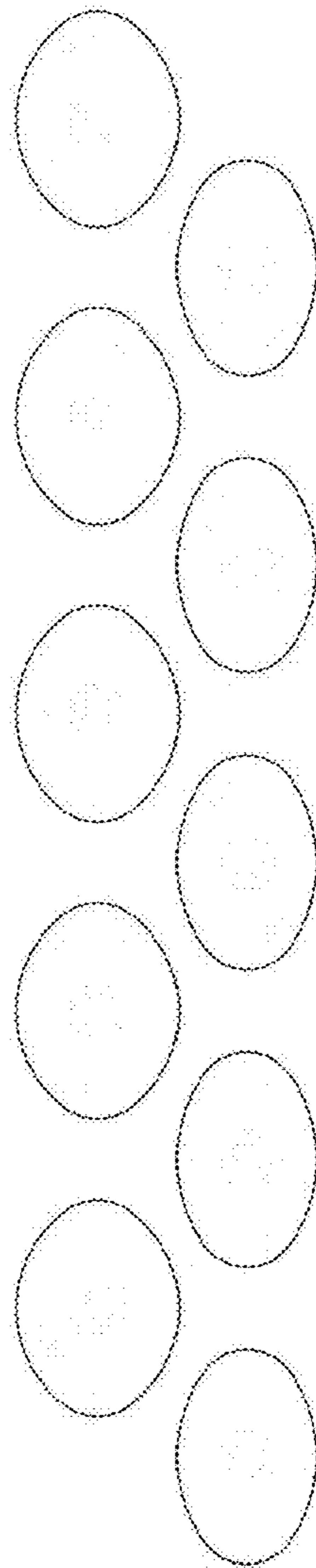

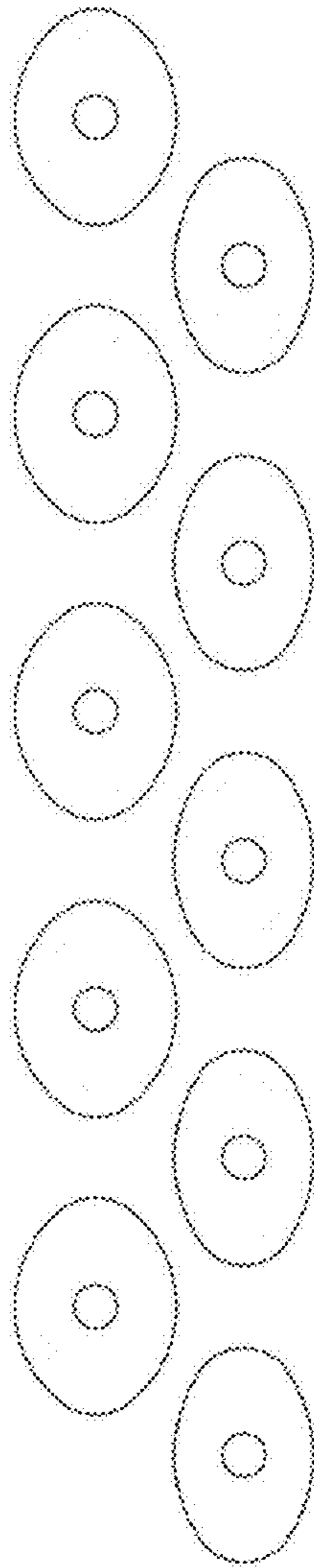

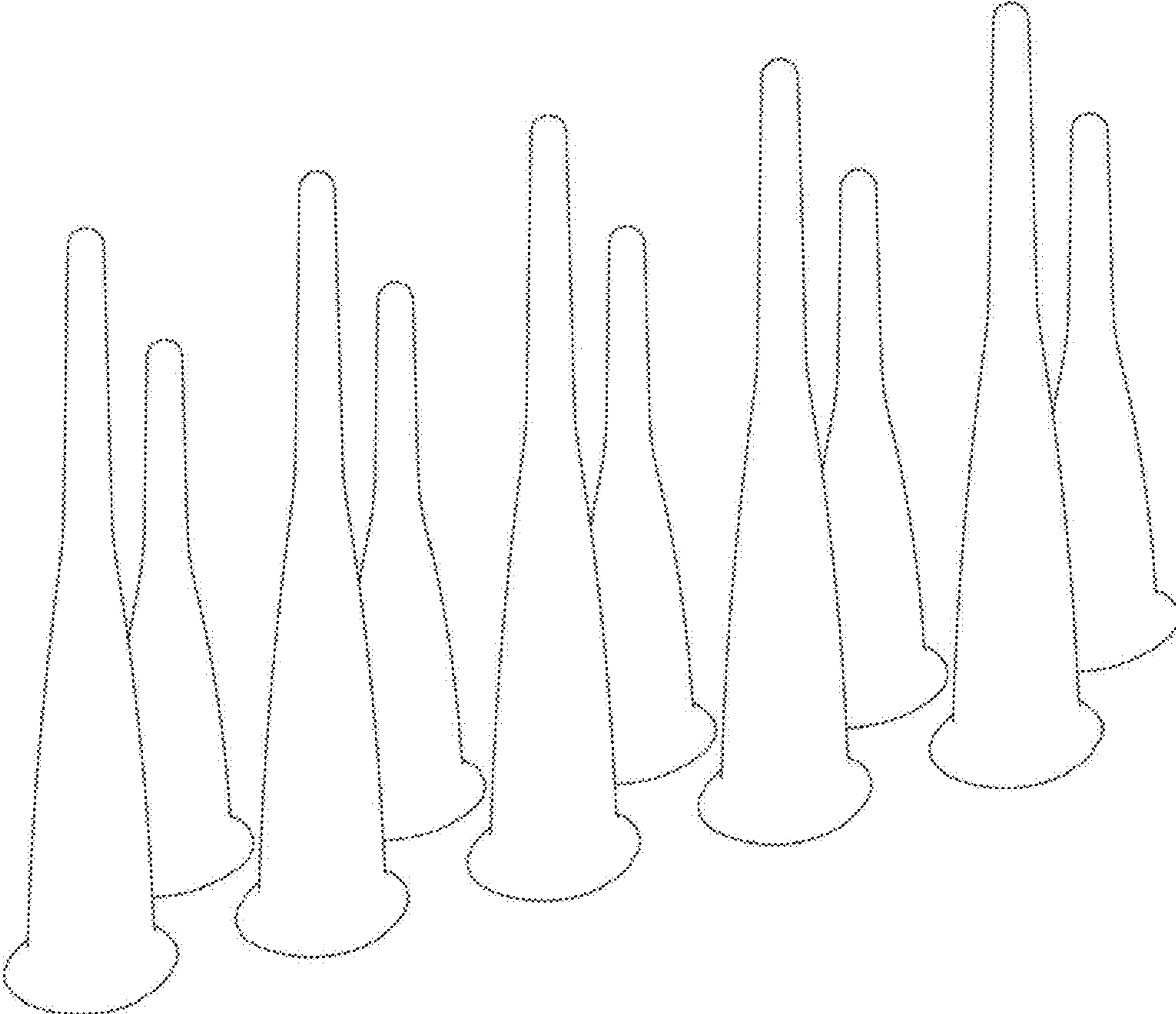

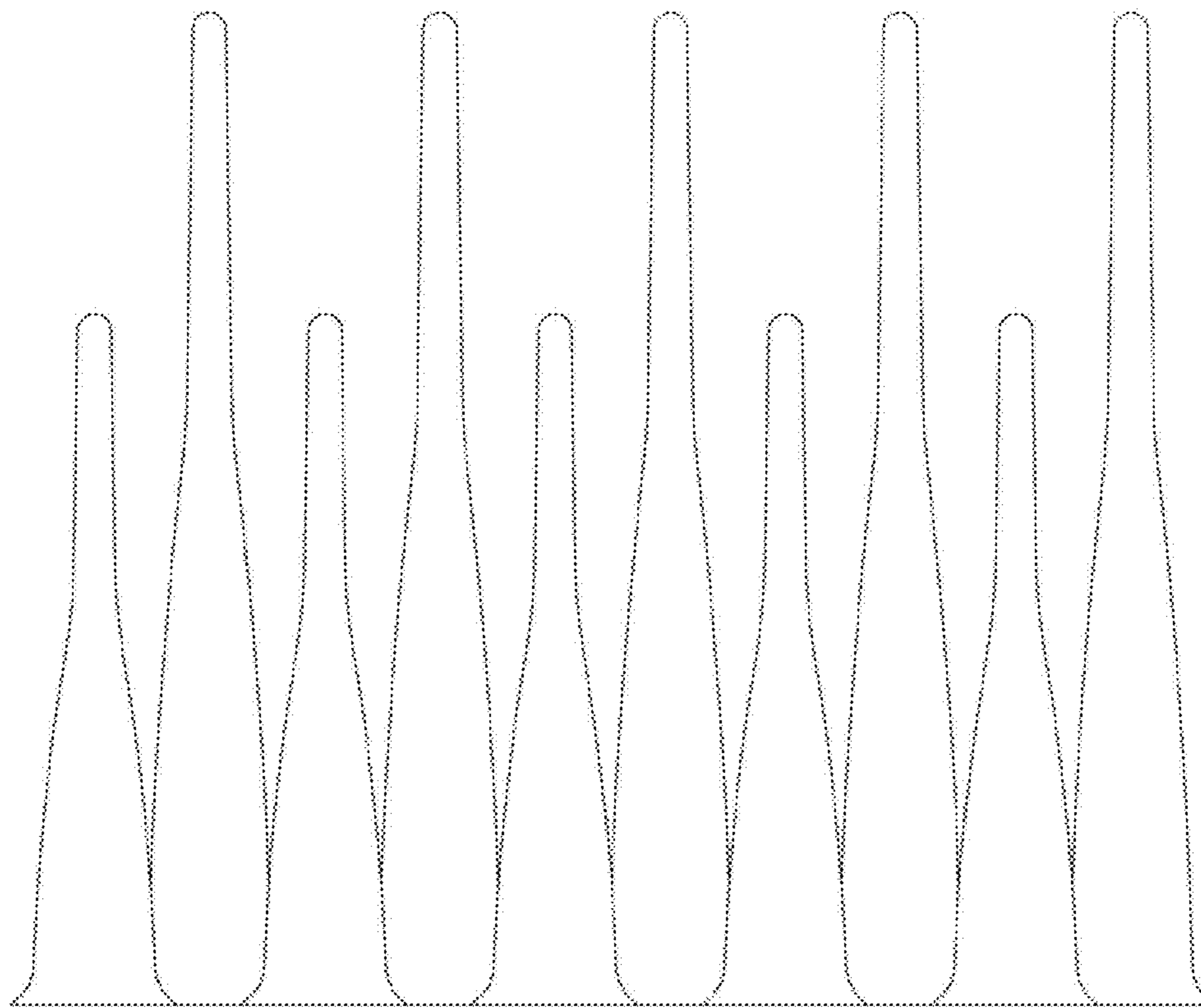

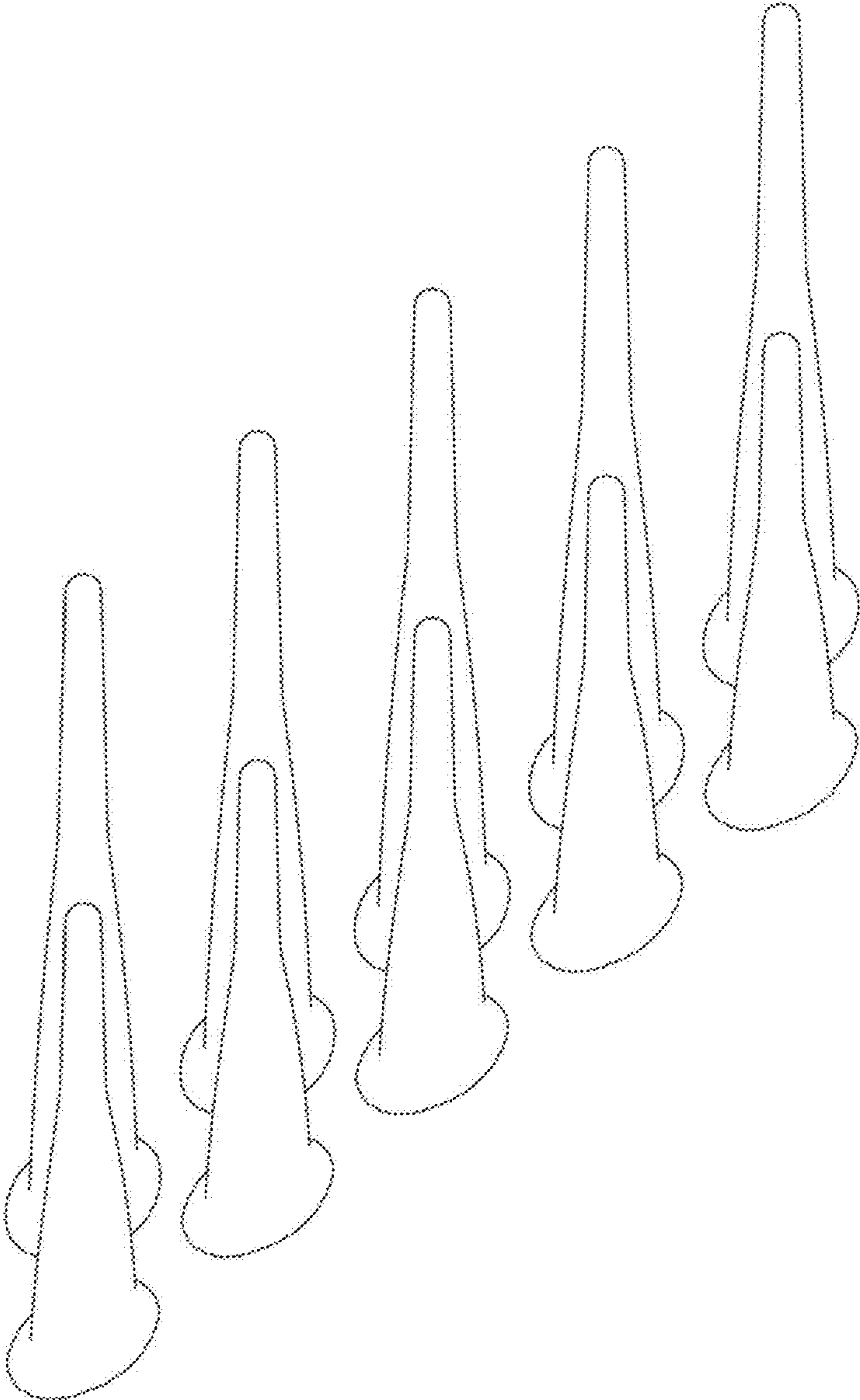

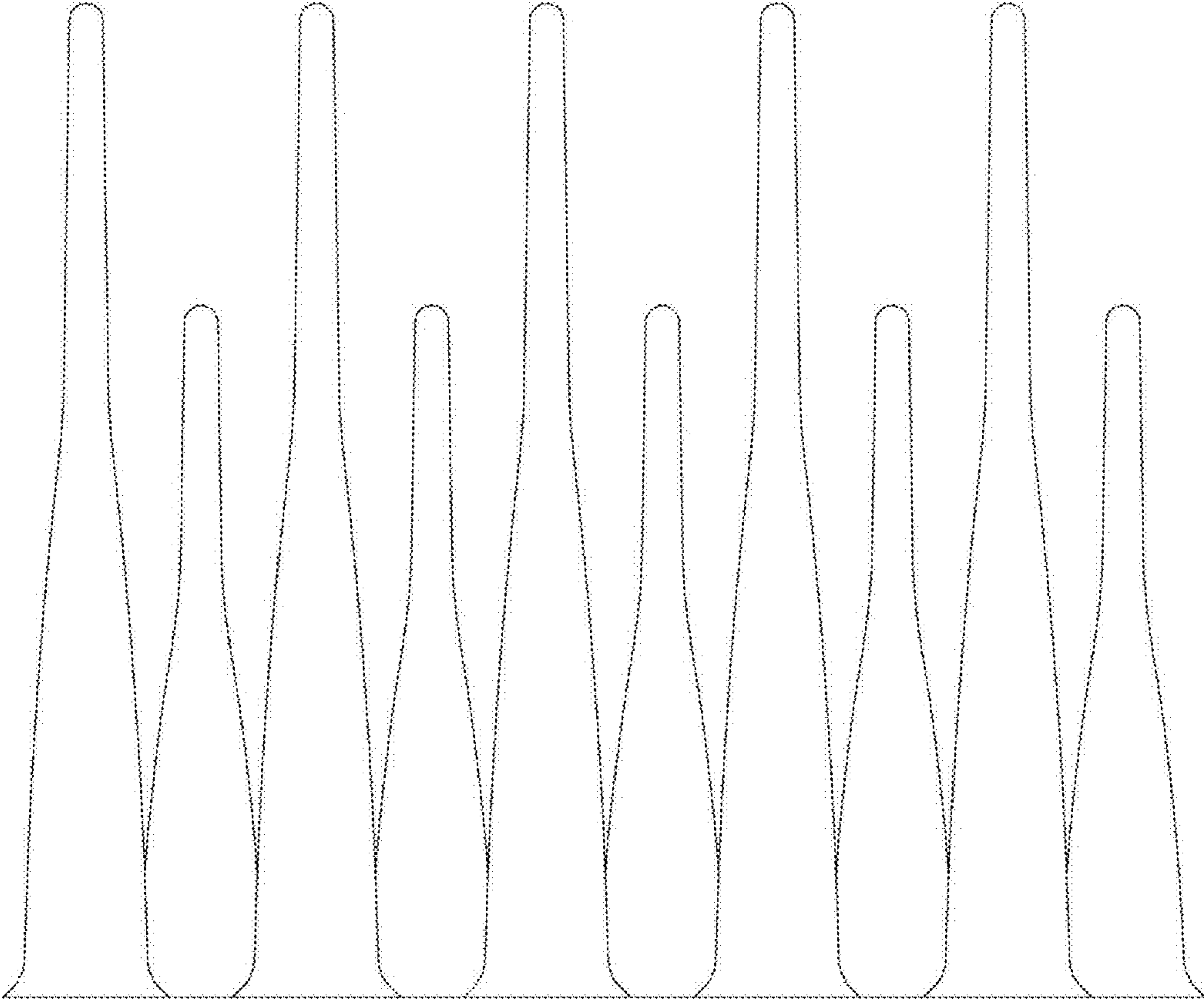
