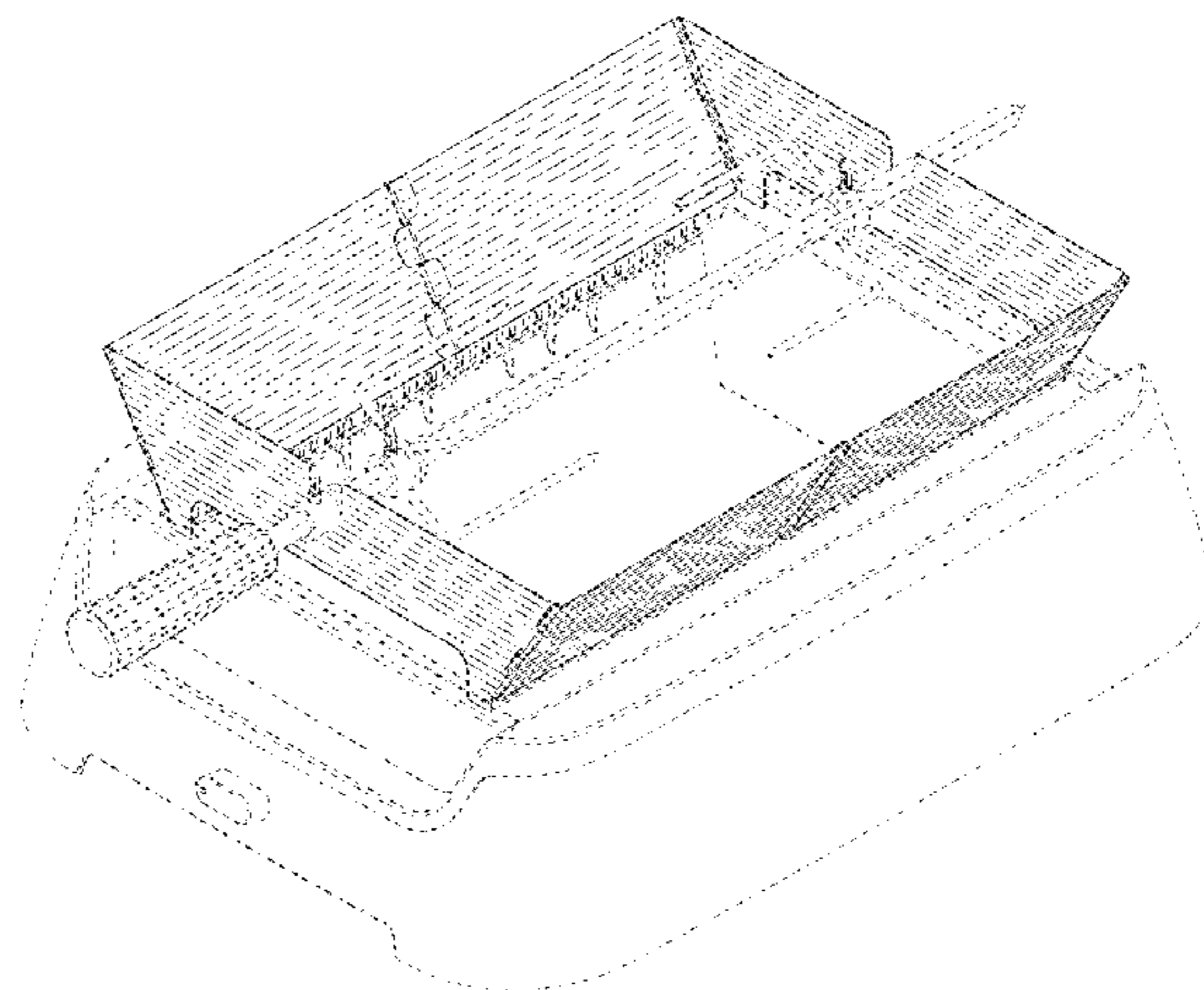
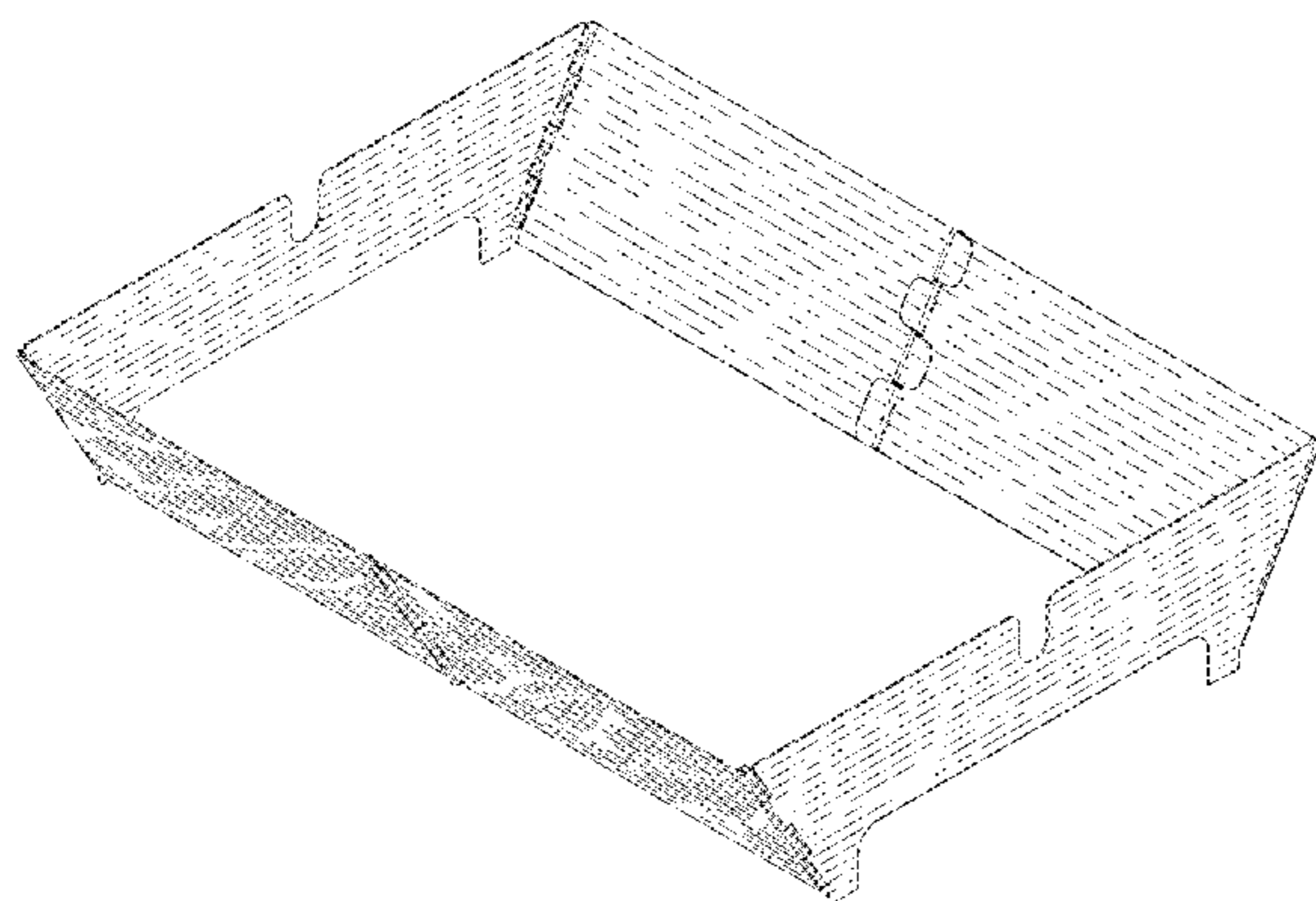
(57) **CLAIM**

DESCRIPTION

FIG. 1 is a perspective view showing my design;
FIG. 2 is a front elevational view thereof;
FIG. 3 is a rear elevational view thereof;
FIG. 4 is a right side elevational view thereof;
FIG. 5 is a left side elevational view thereof;
FIG. 6 is a top plan view thereof;
FIG. 7 is a bottom plan view thereof.
FIG. 8 is a front elevational view of the rotisserie frame
broken down for transport; and,
FIG. 9 is a perspective view of the rotisserie frame carrying
a rotisserie spit and arranged on a grill.

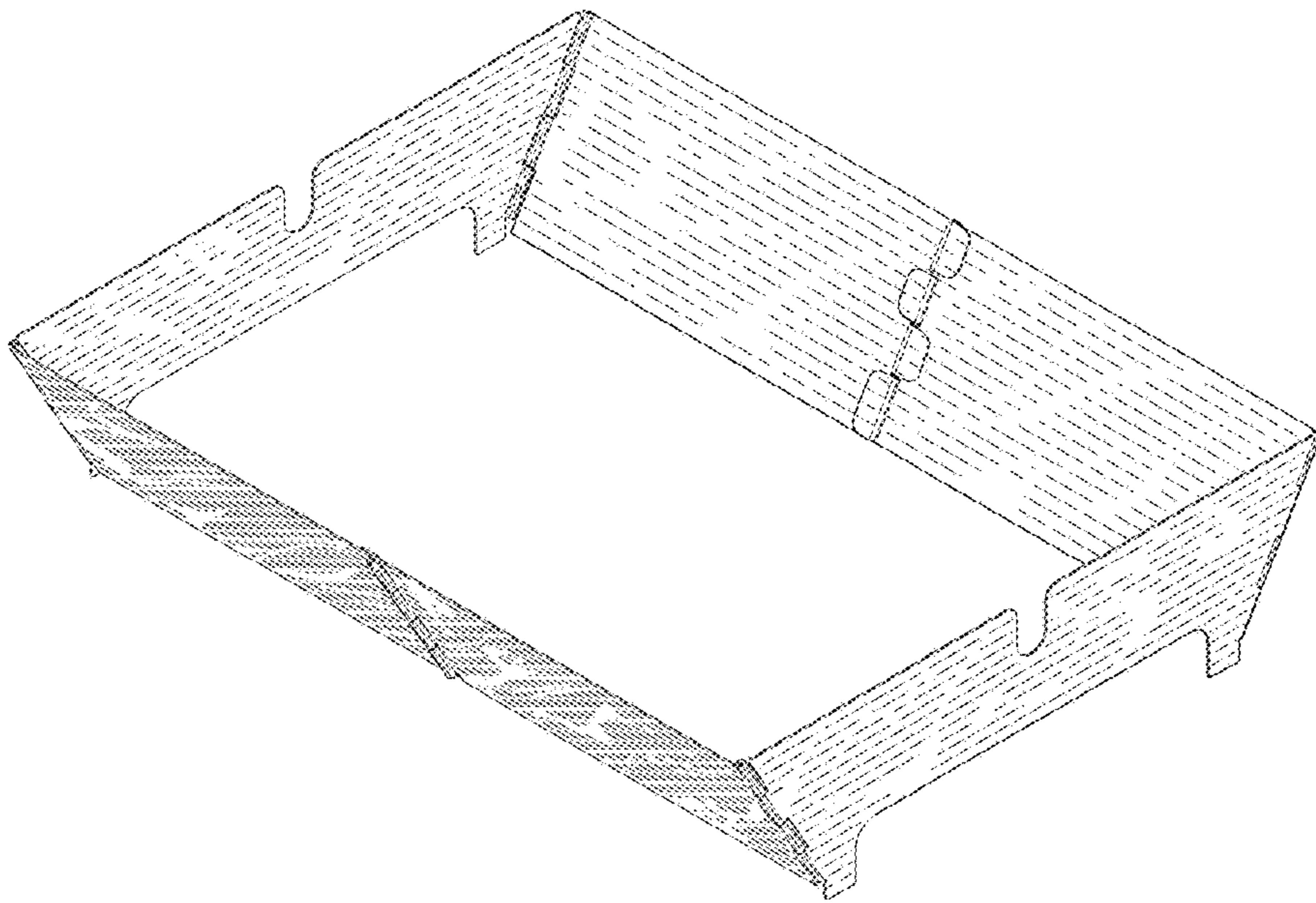

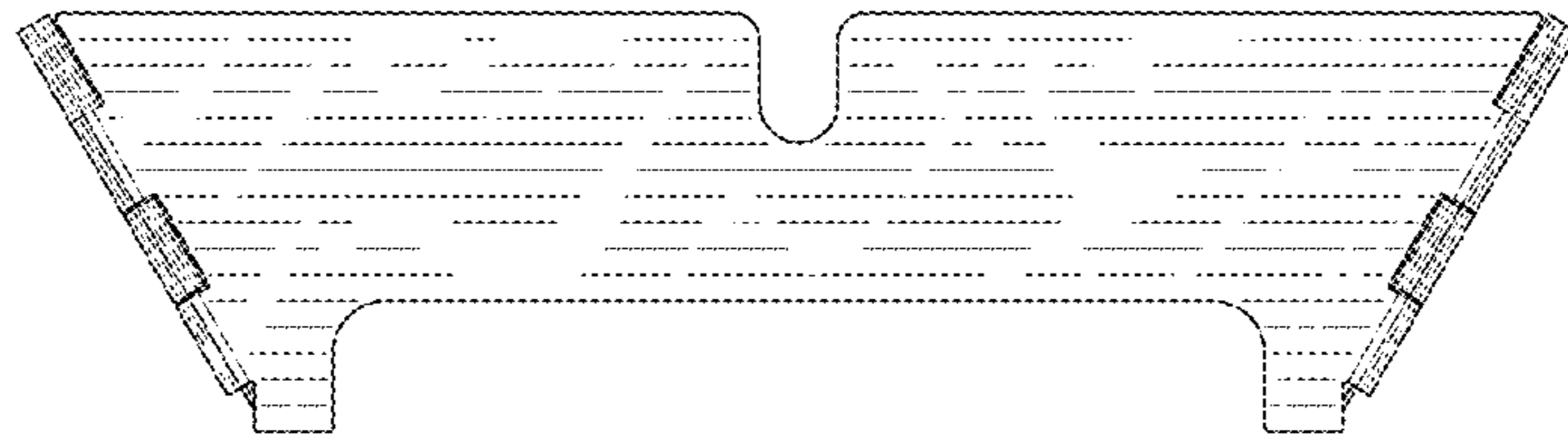

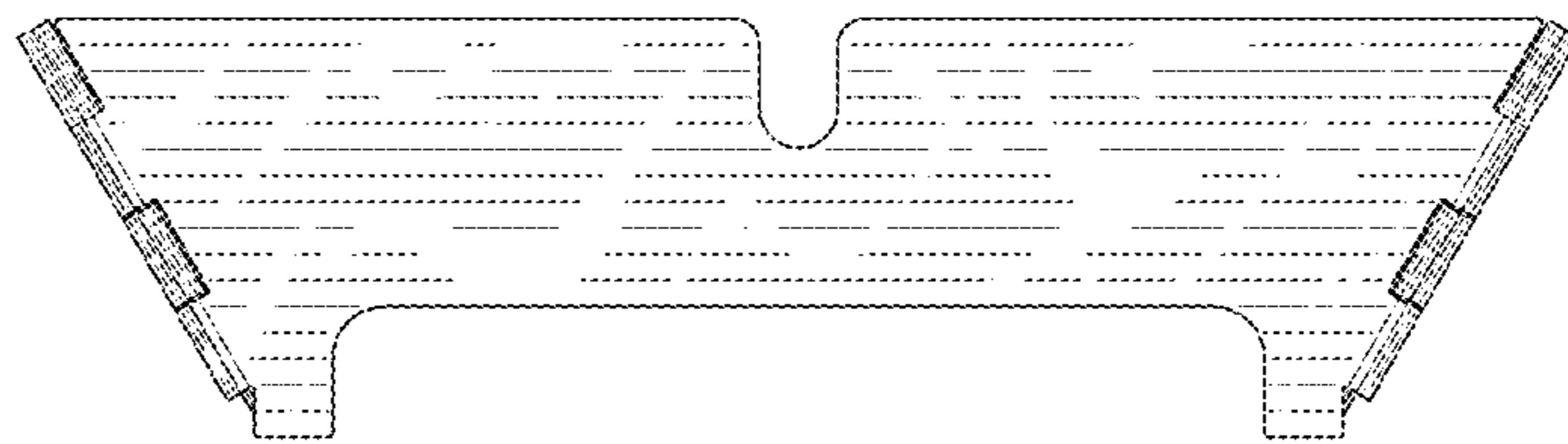

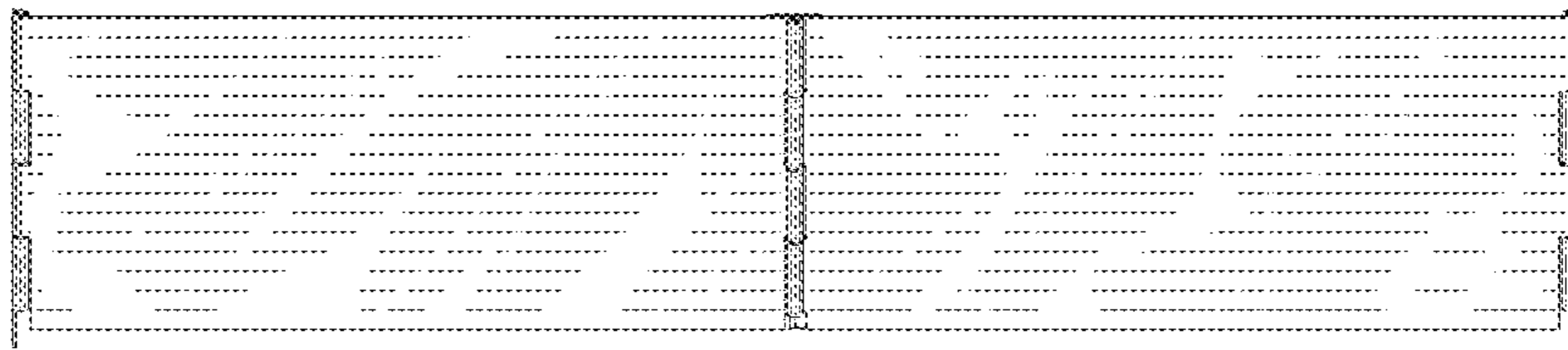

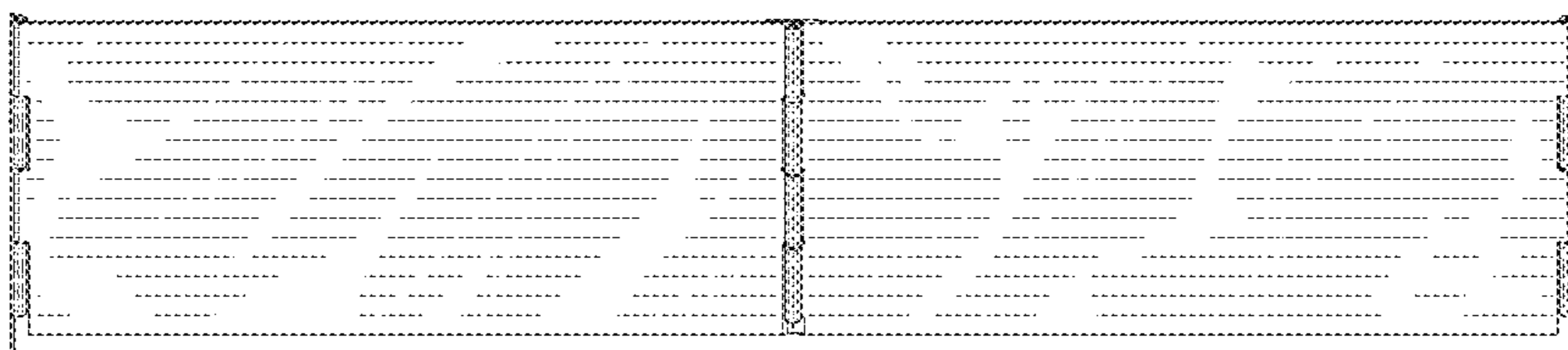

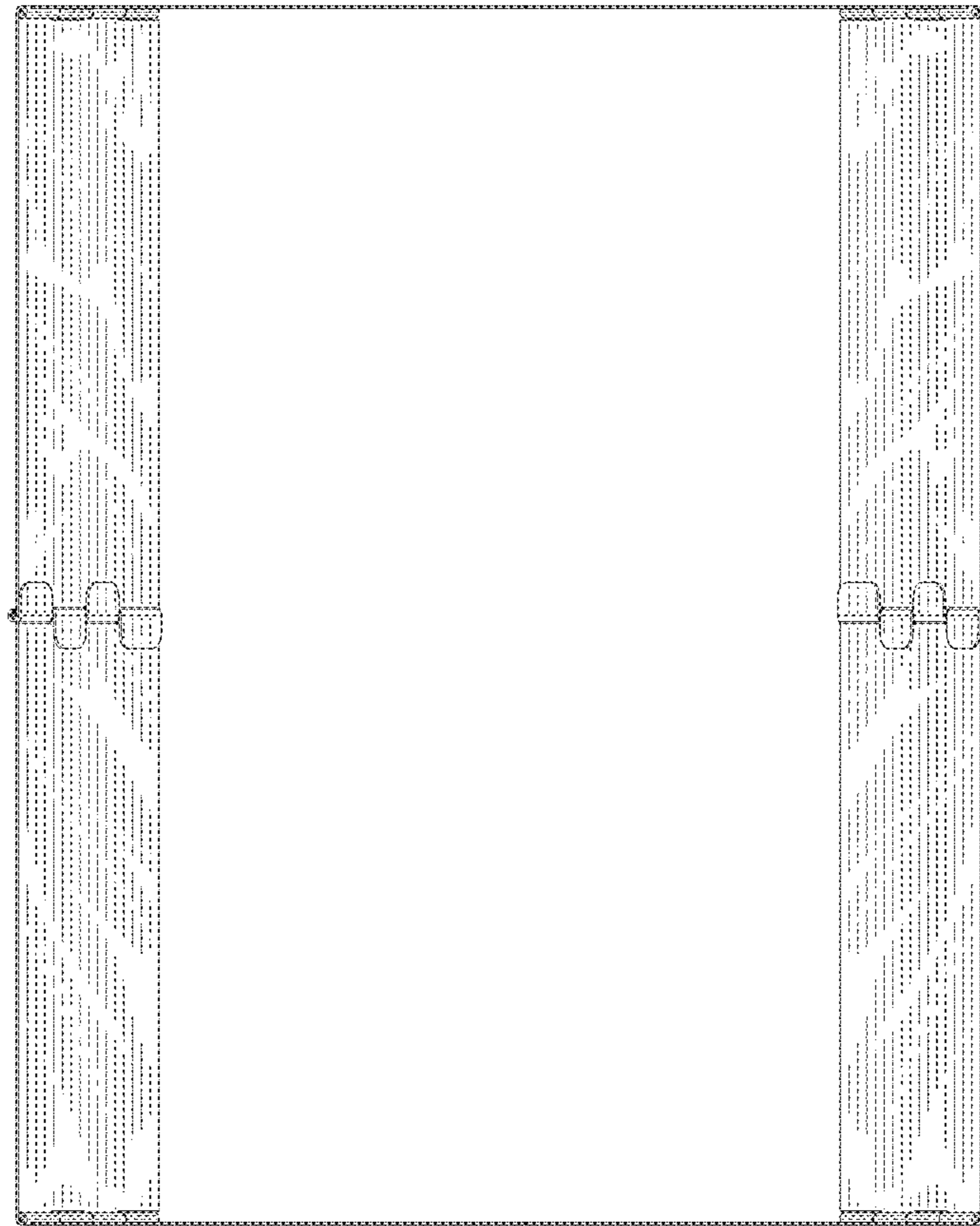

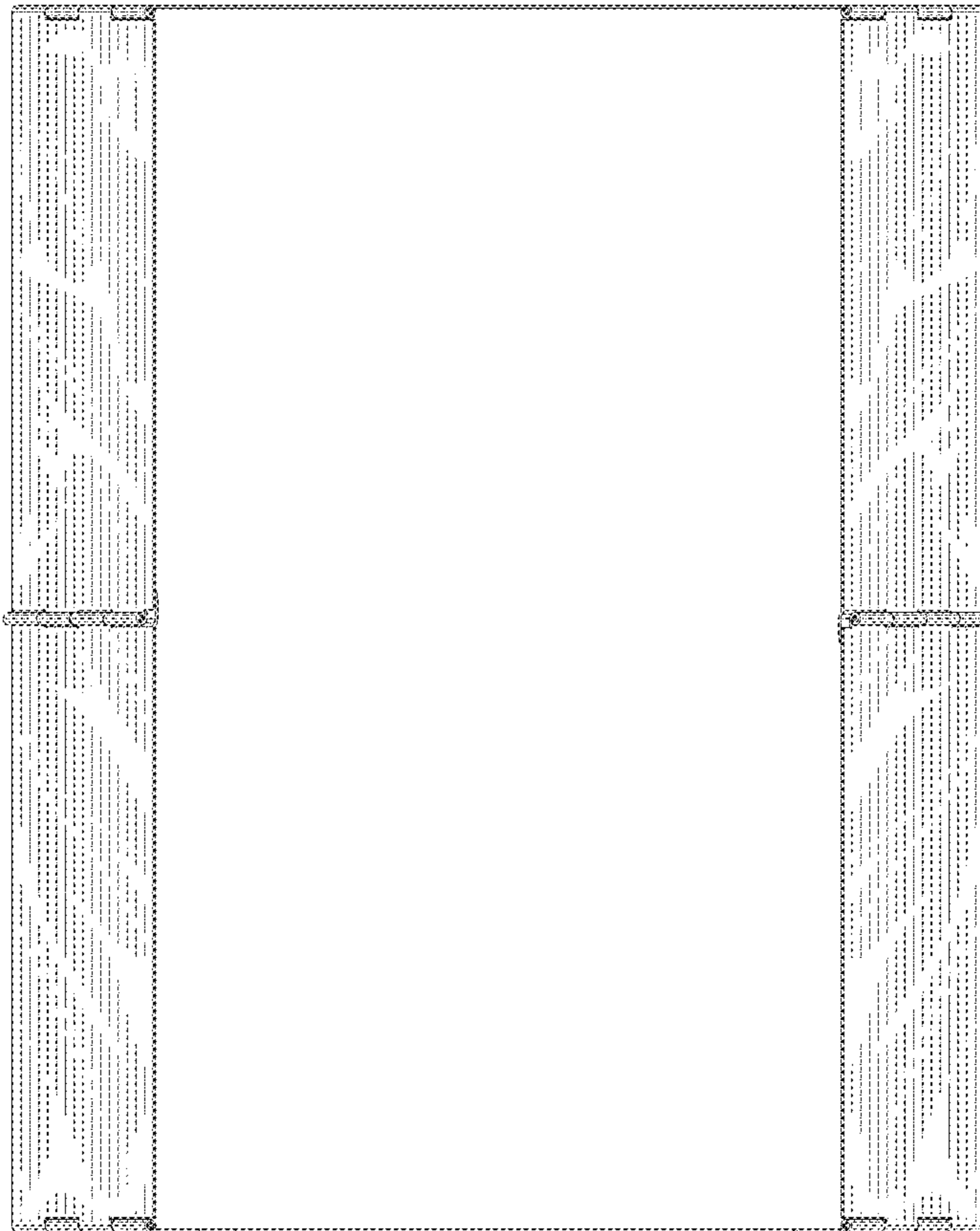

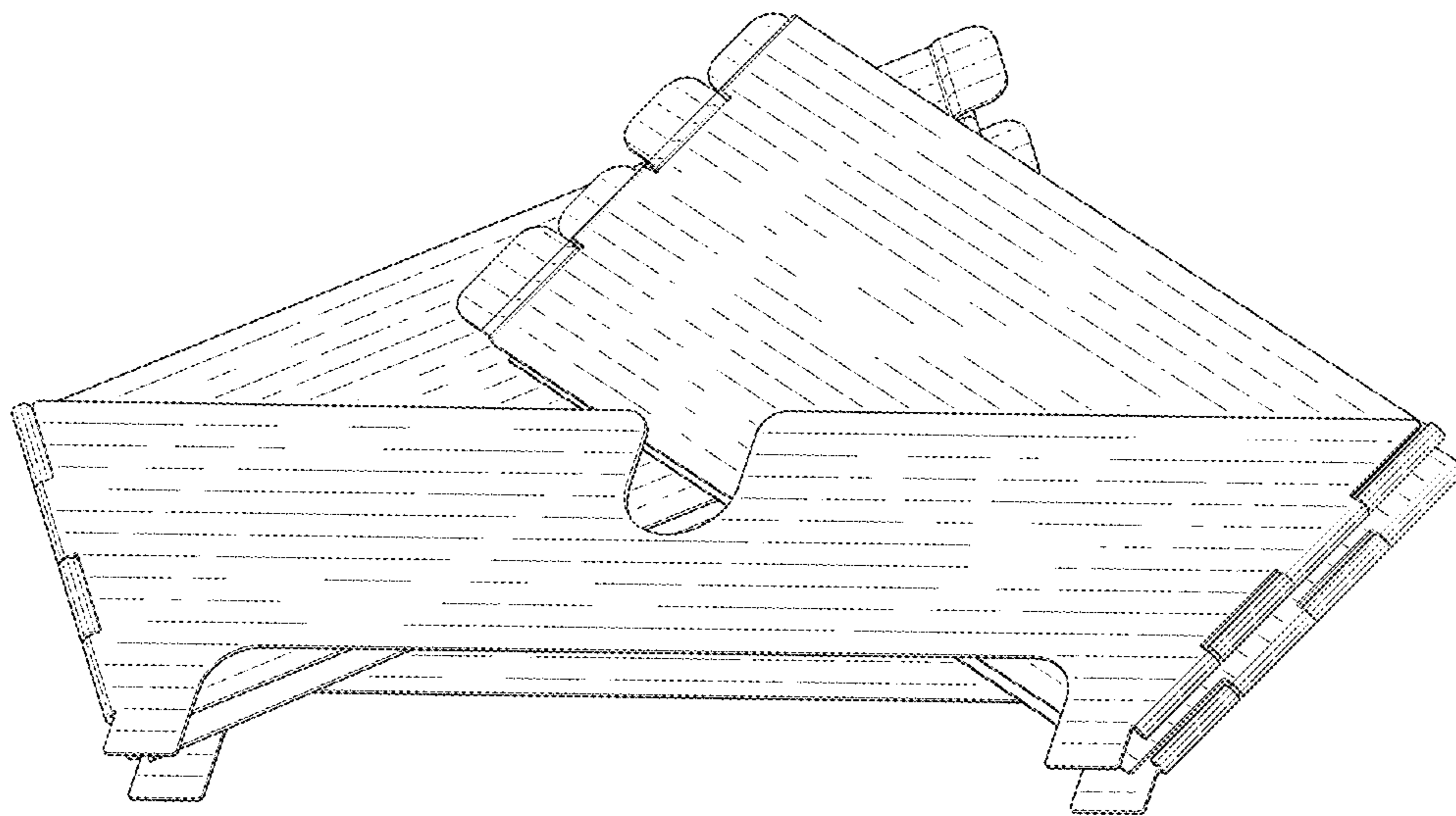

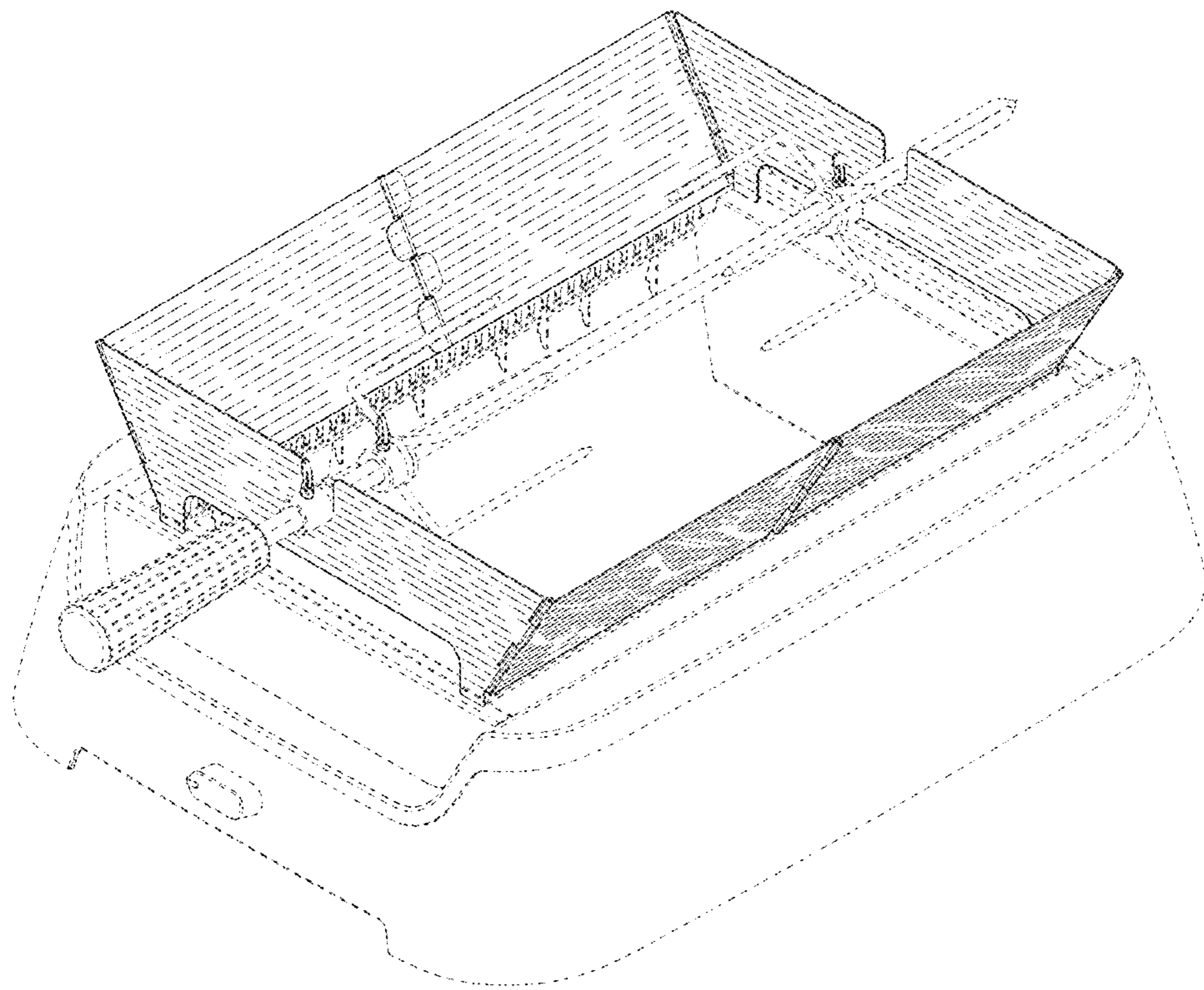
