FIG. 12 is a cross-sectional view thereof taken along line 12-12 in FIG. 8.

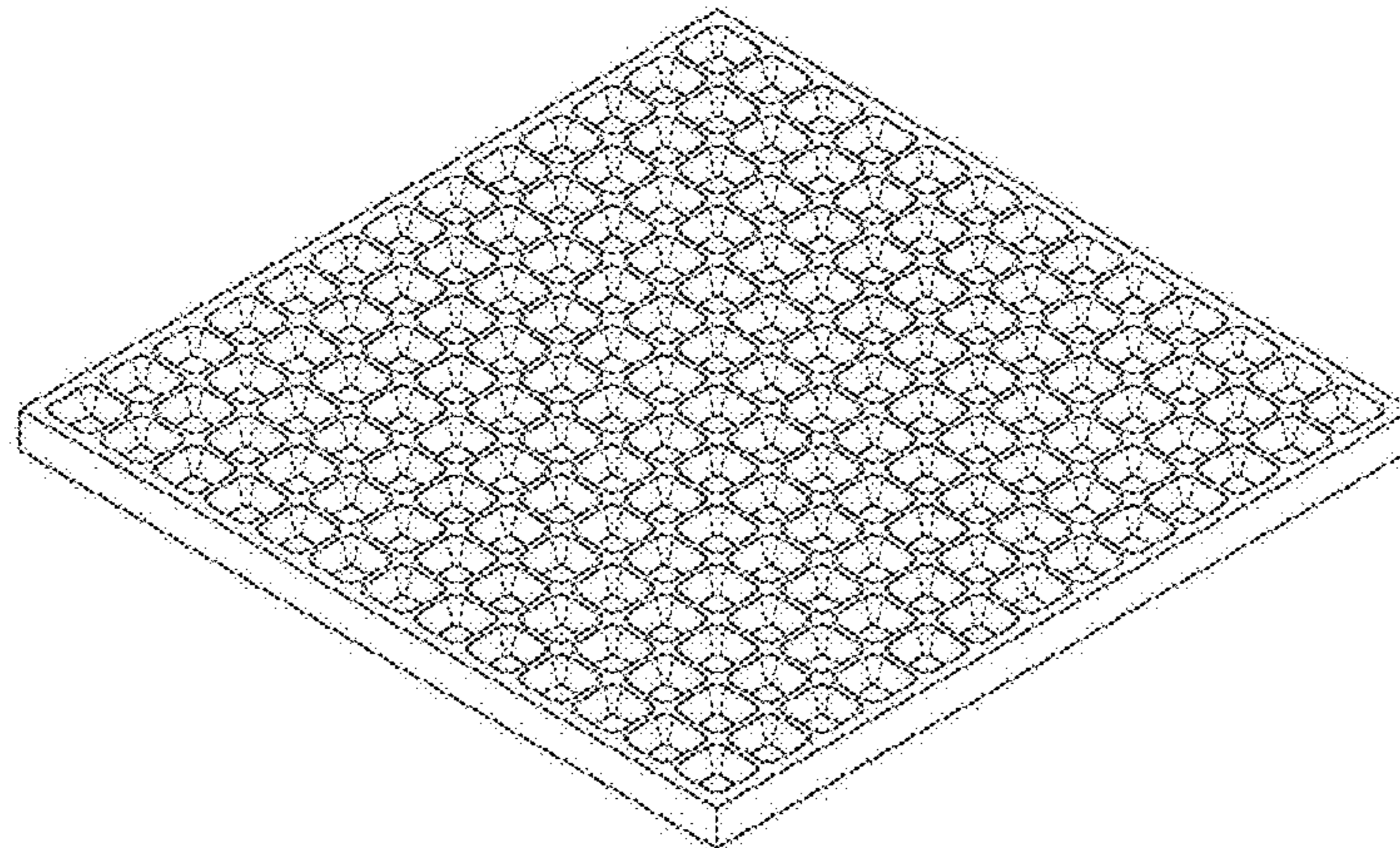

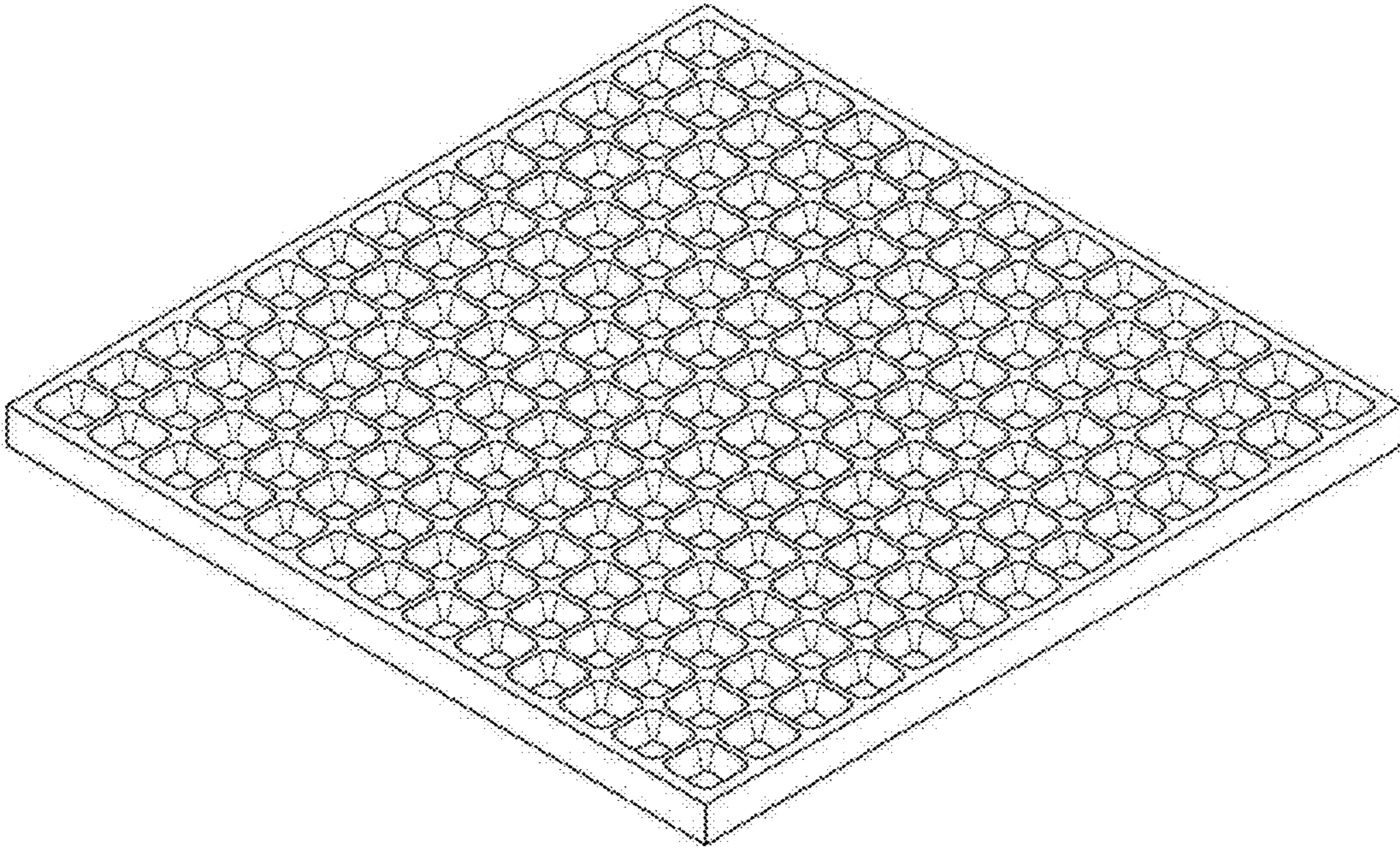

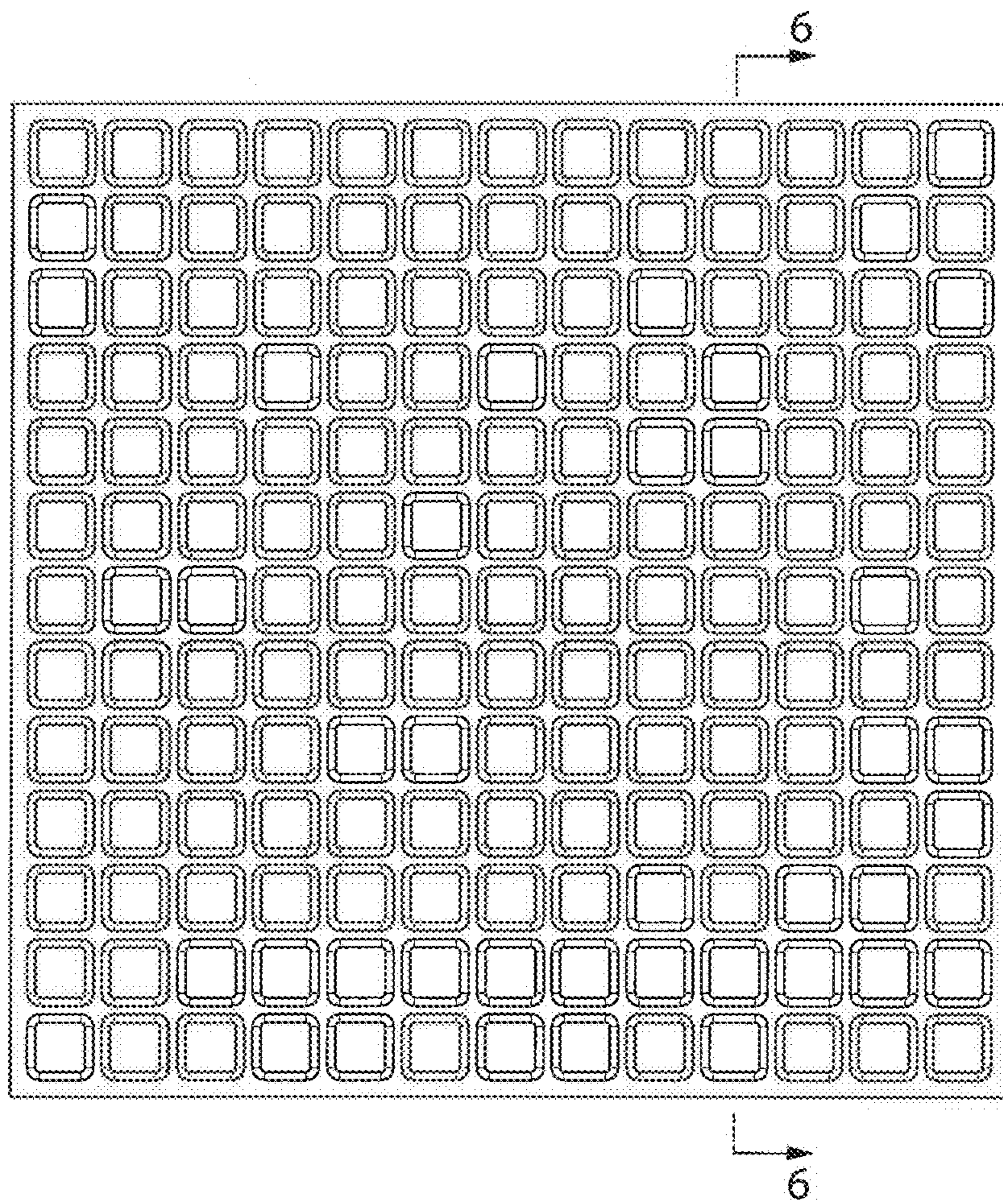

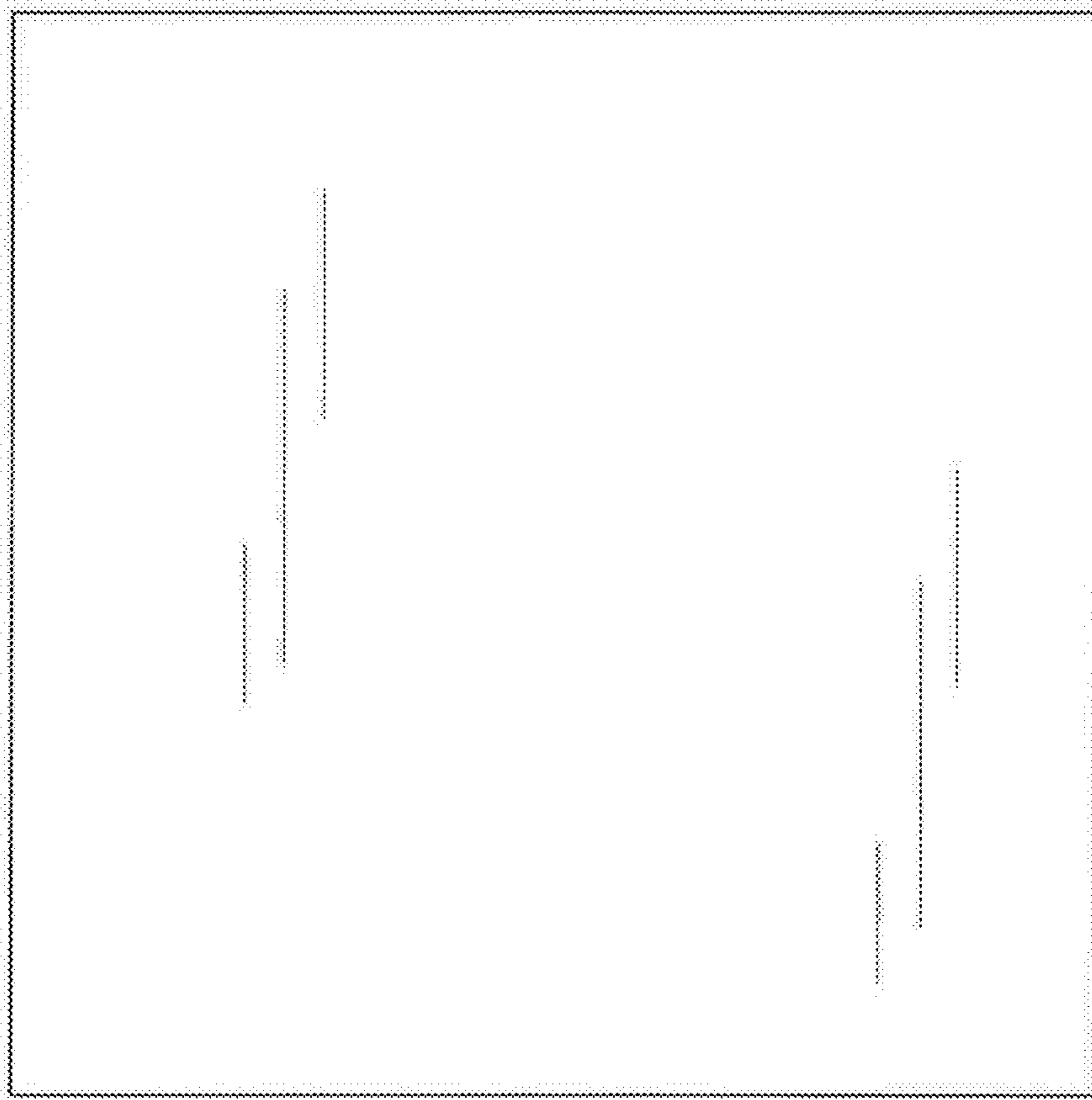

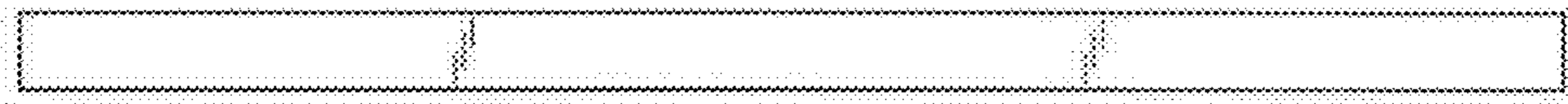

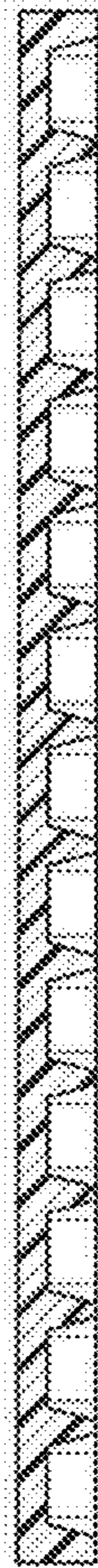

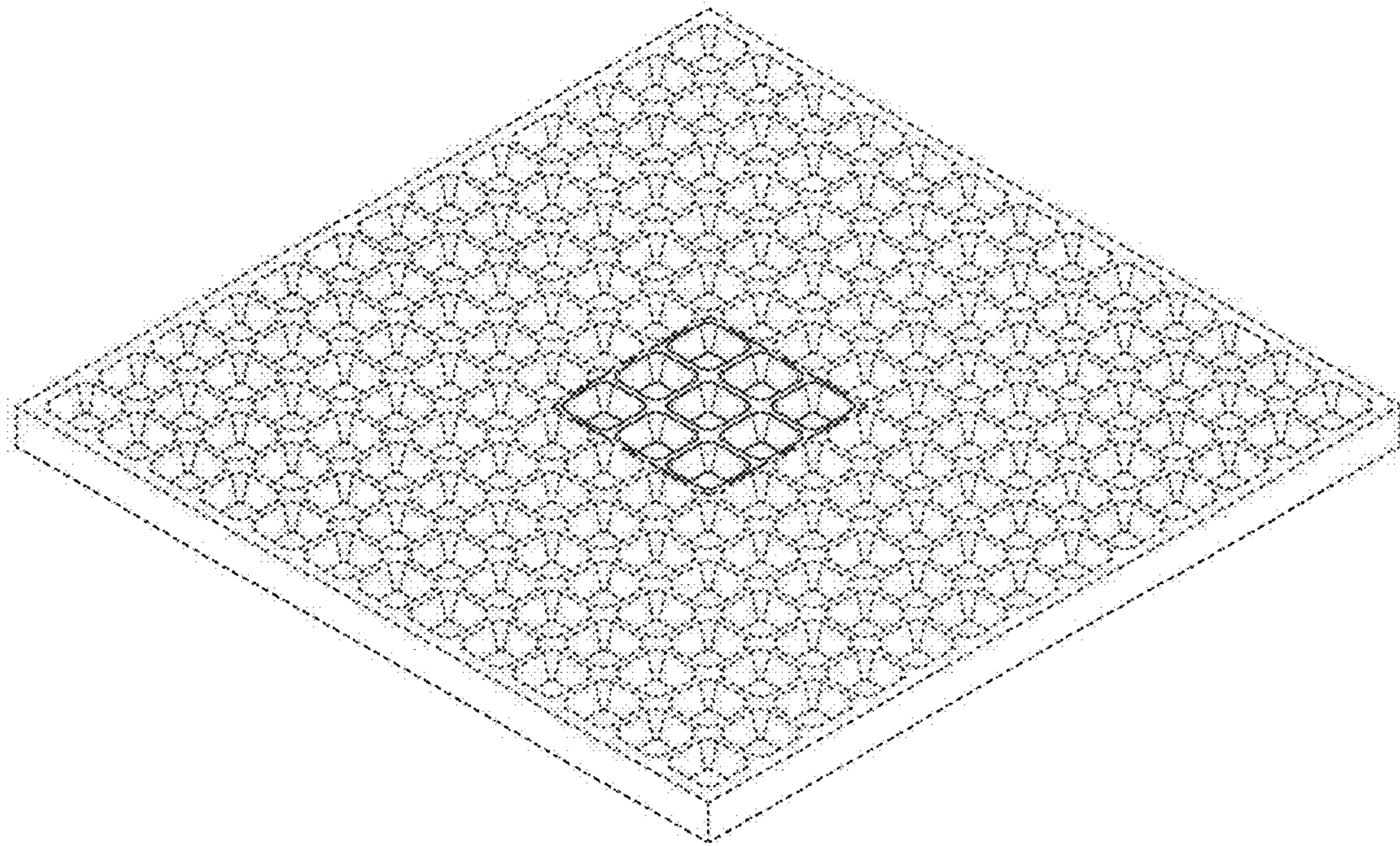

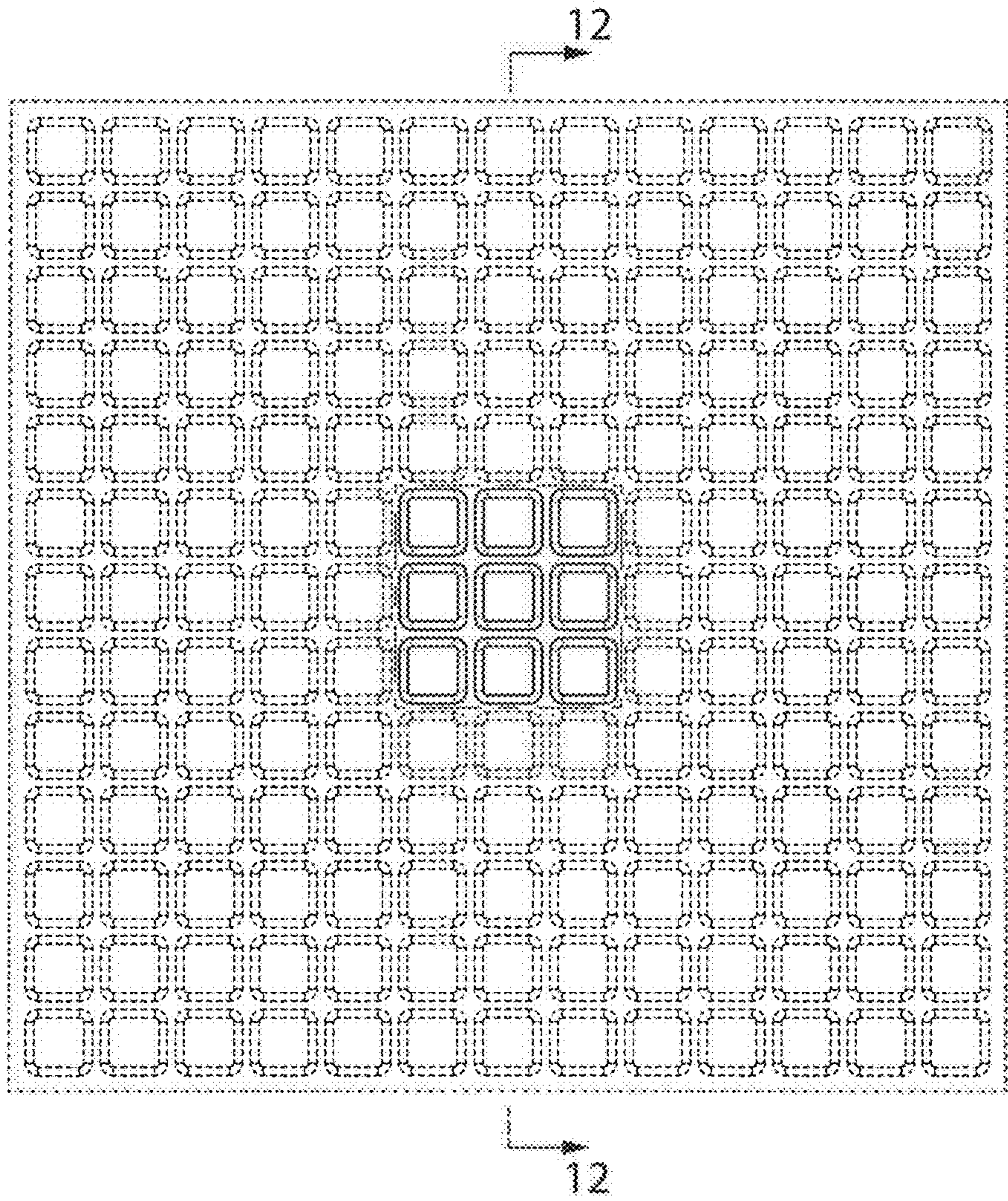

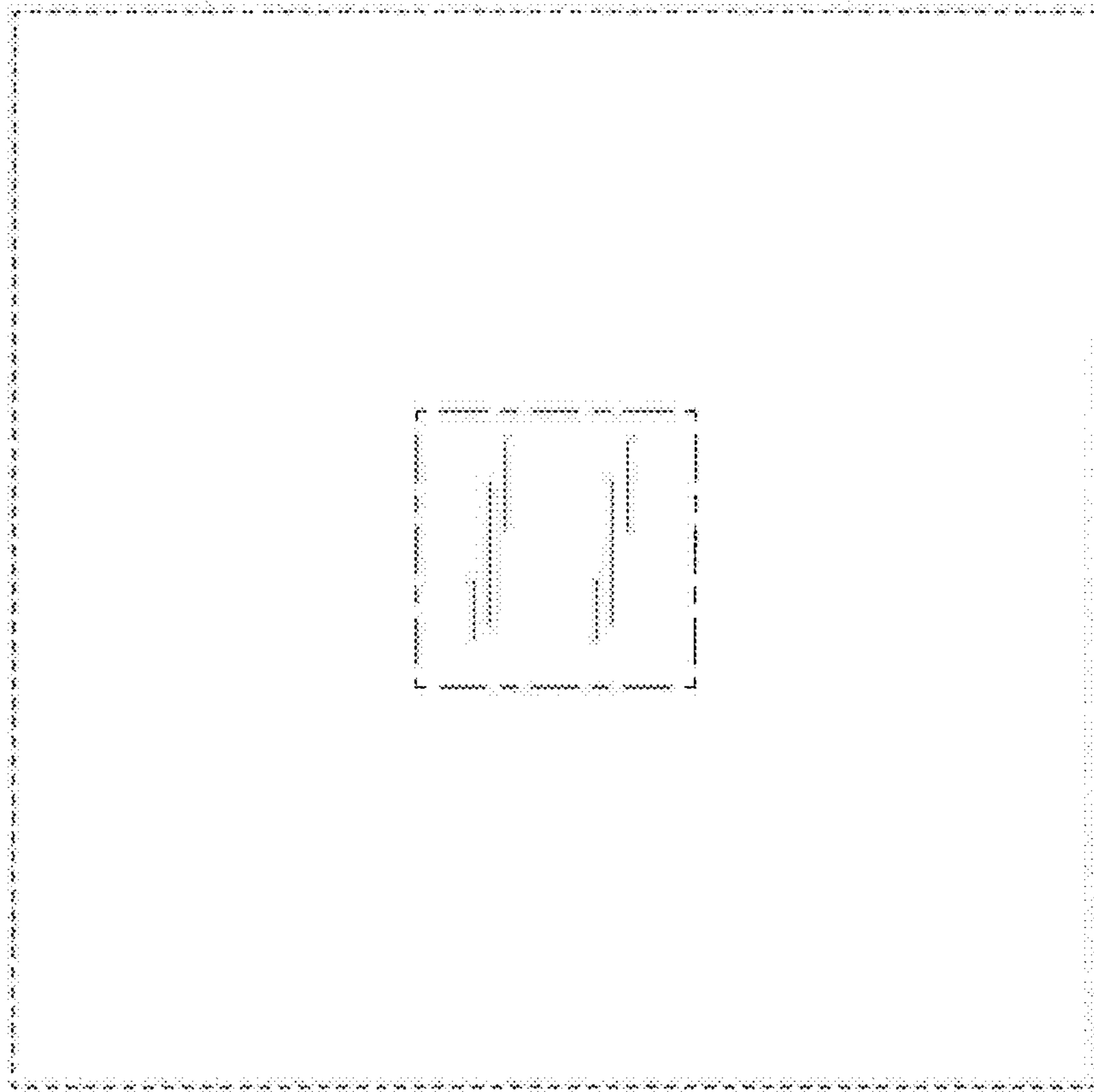
