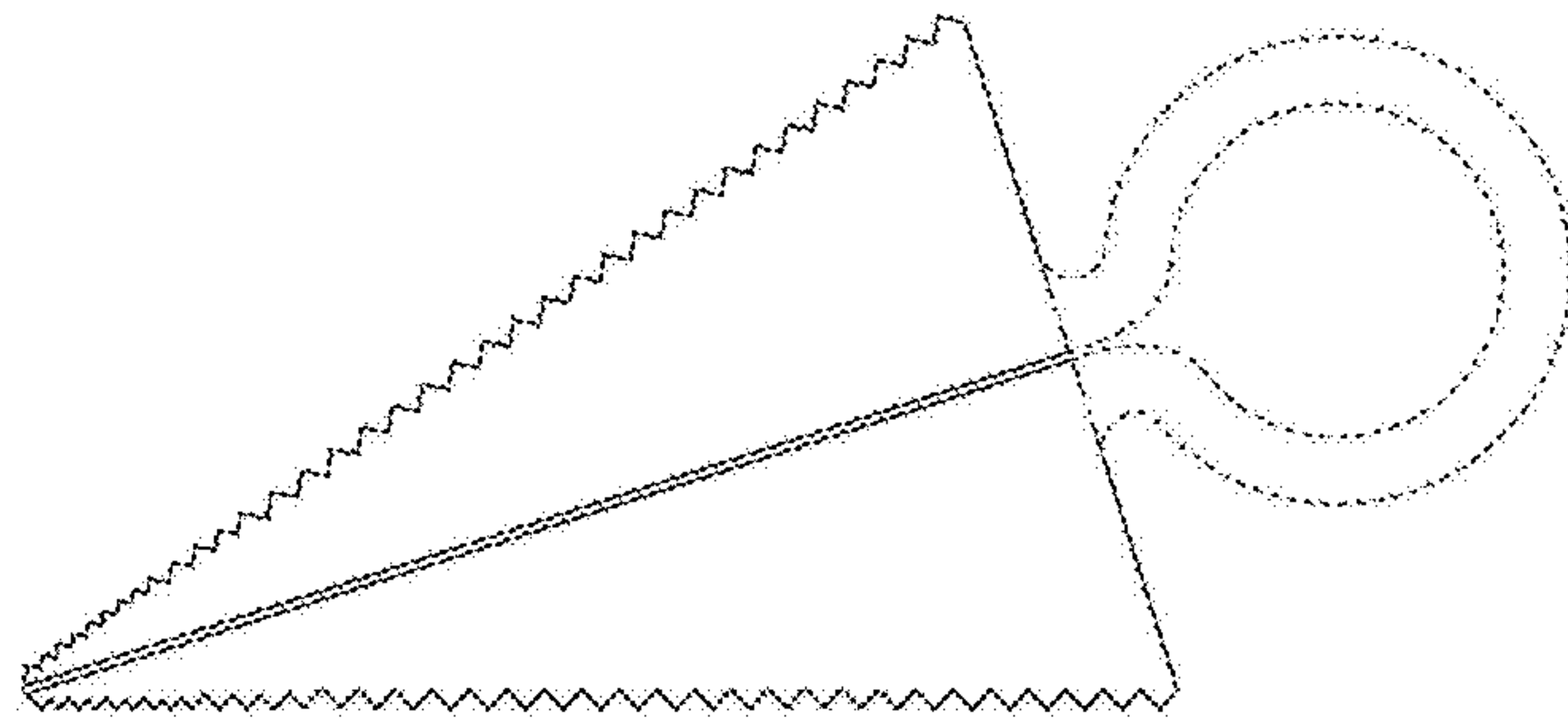
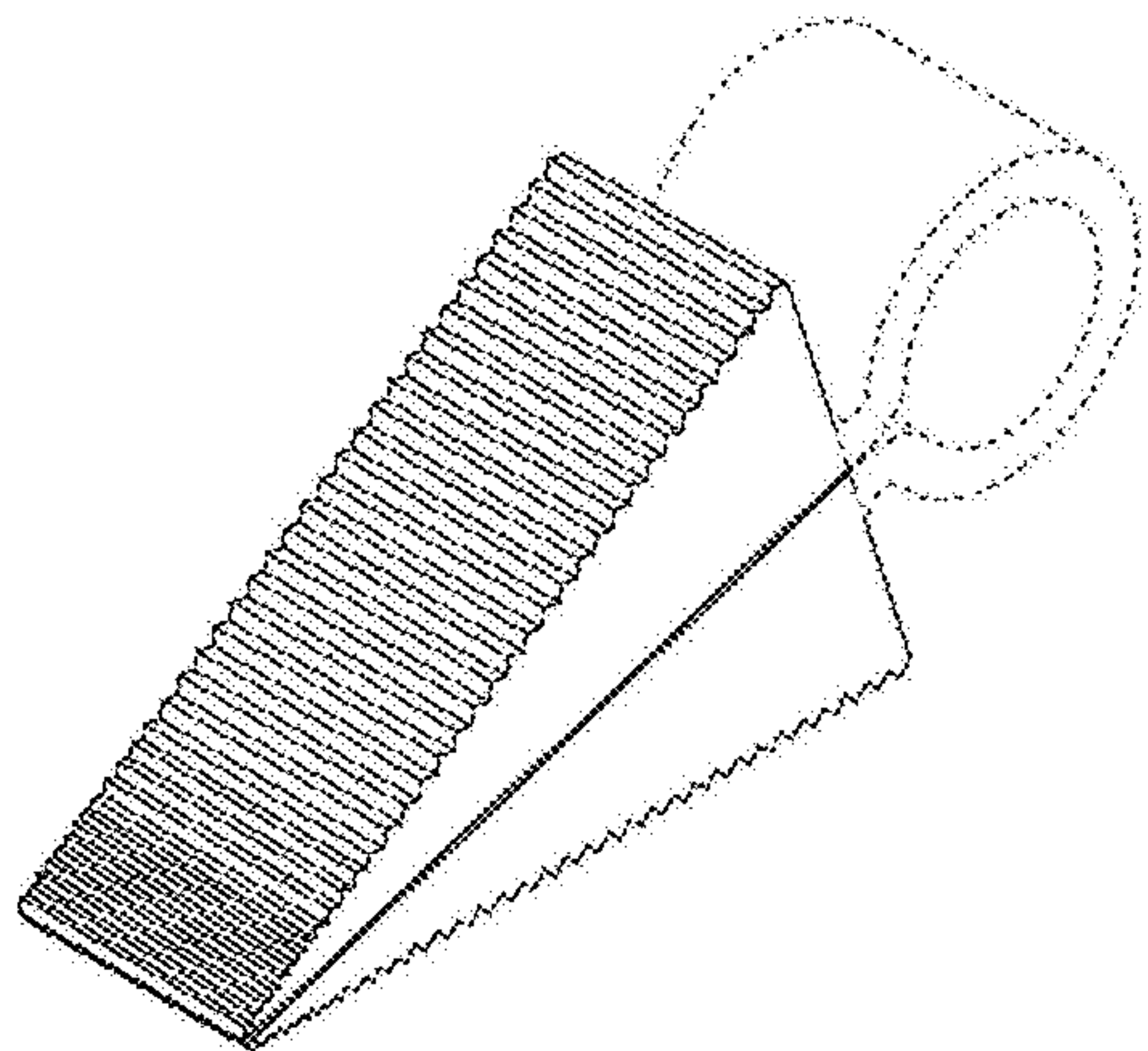

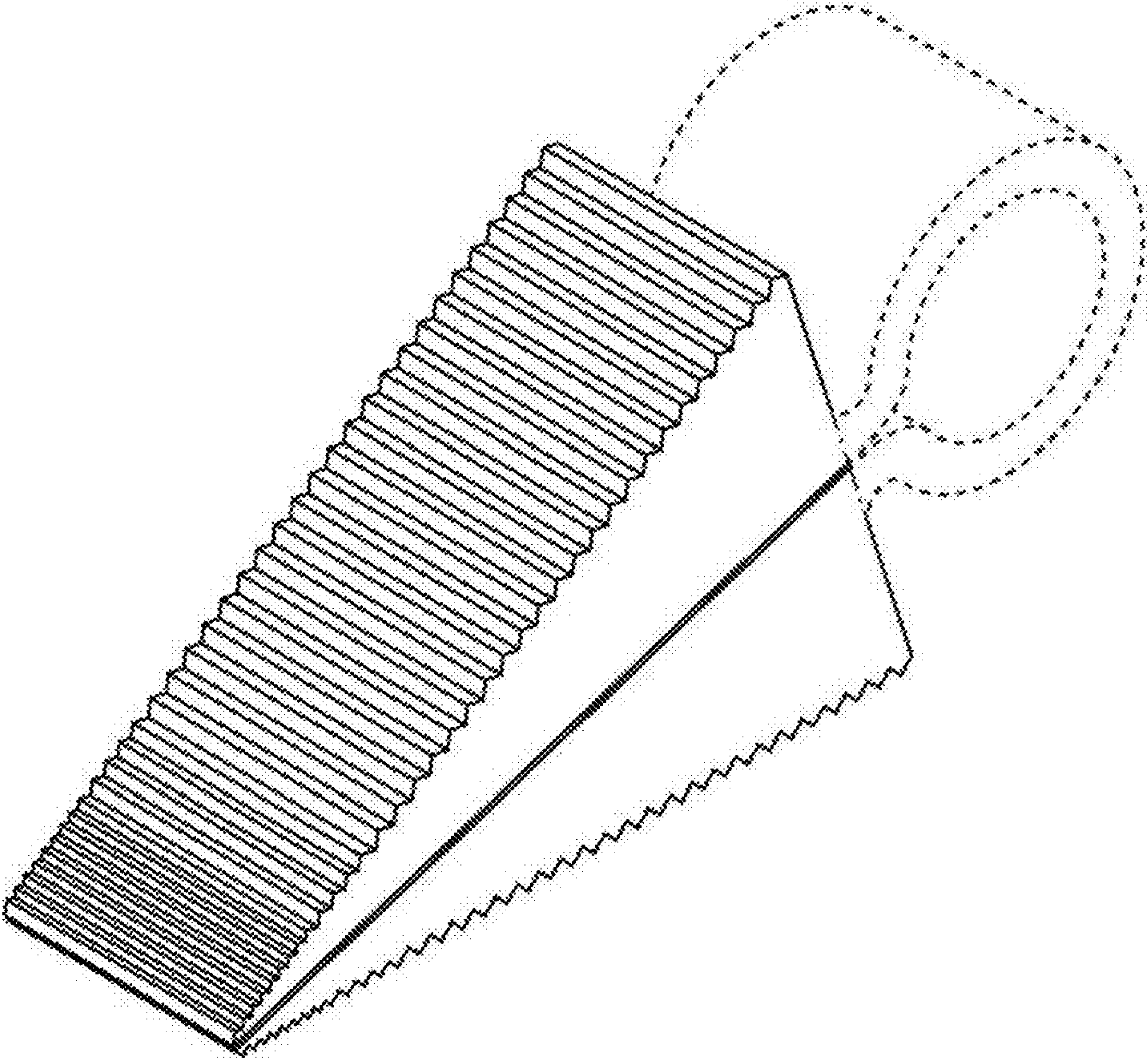

The broken lines in the drawings illustrate portions of the doorstop that form no part of the claimed design.

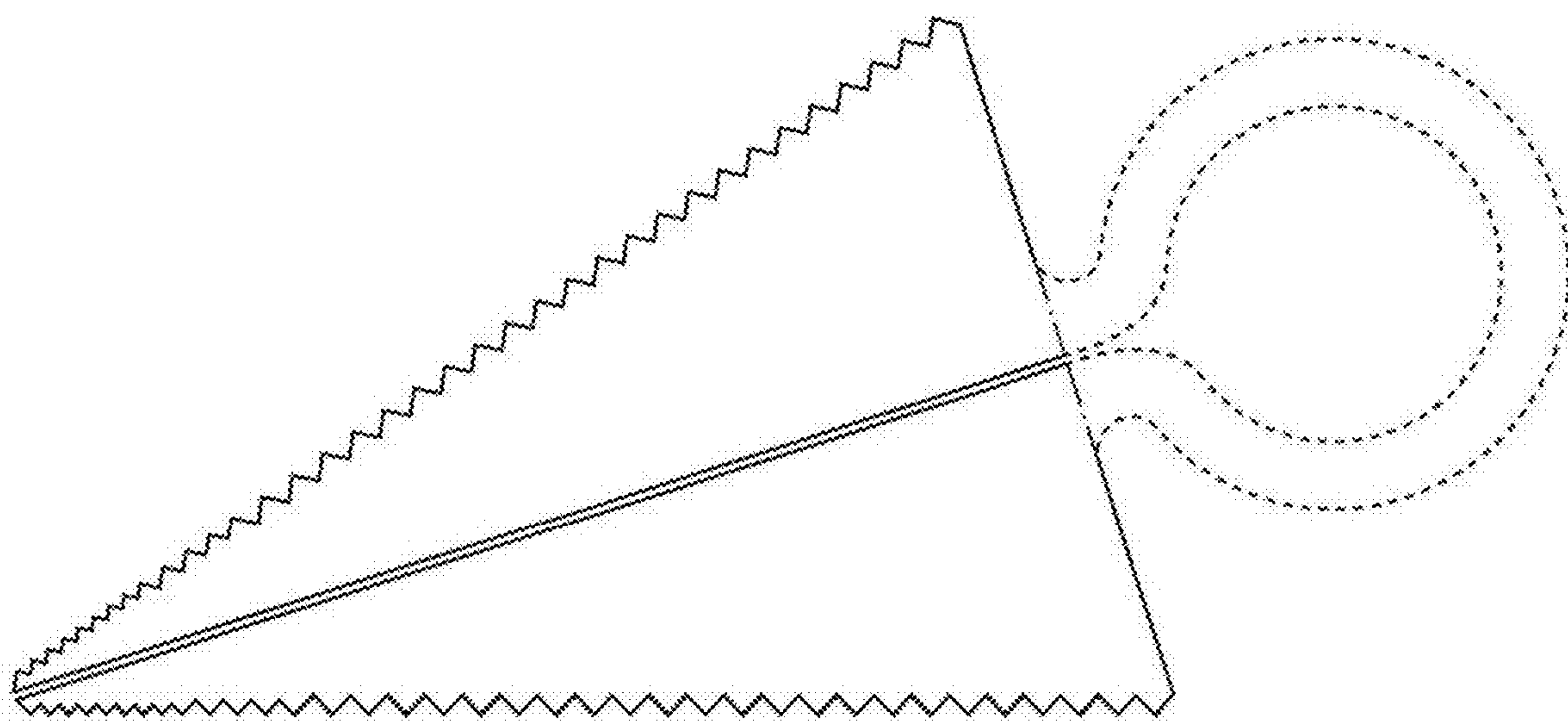

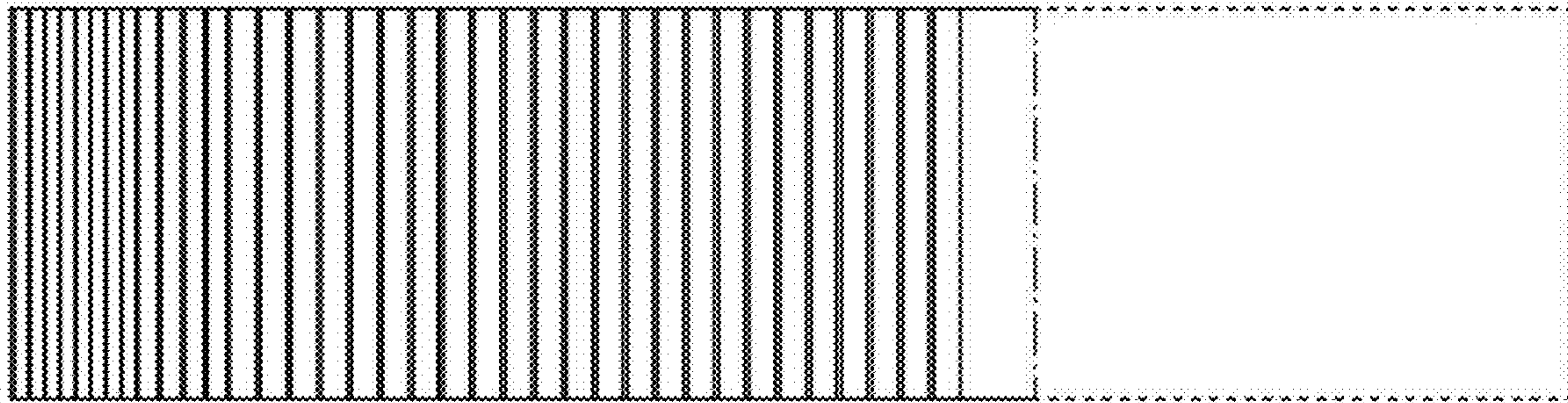

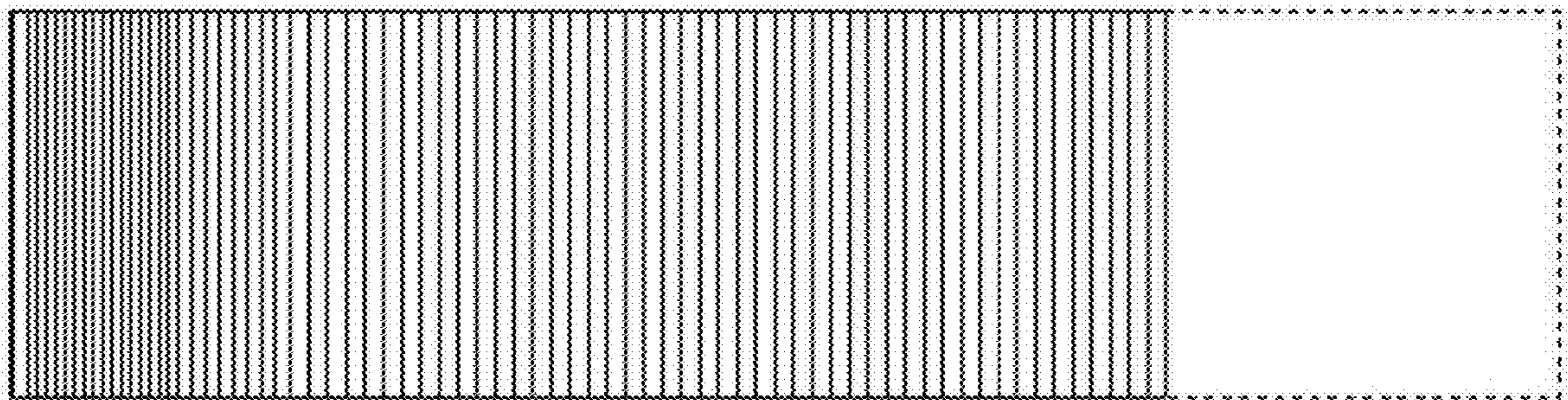

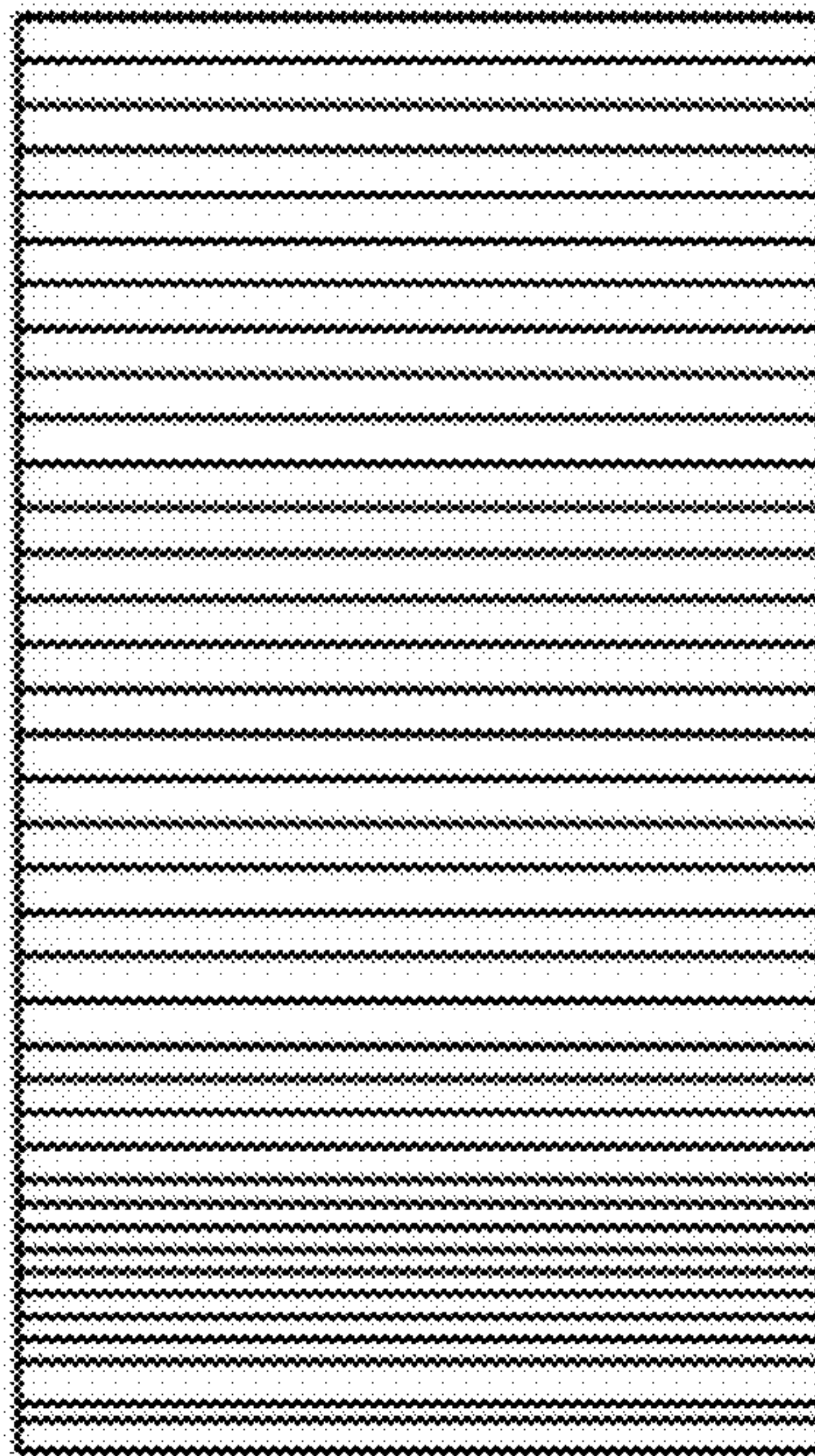
