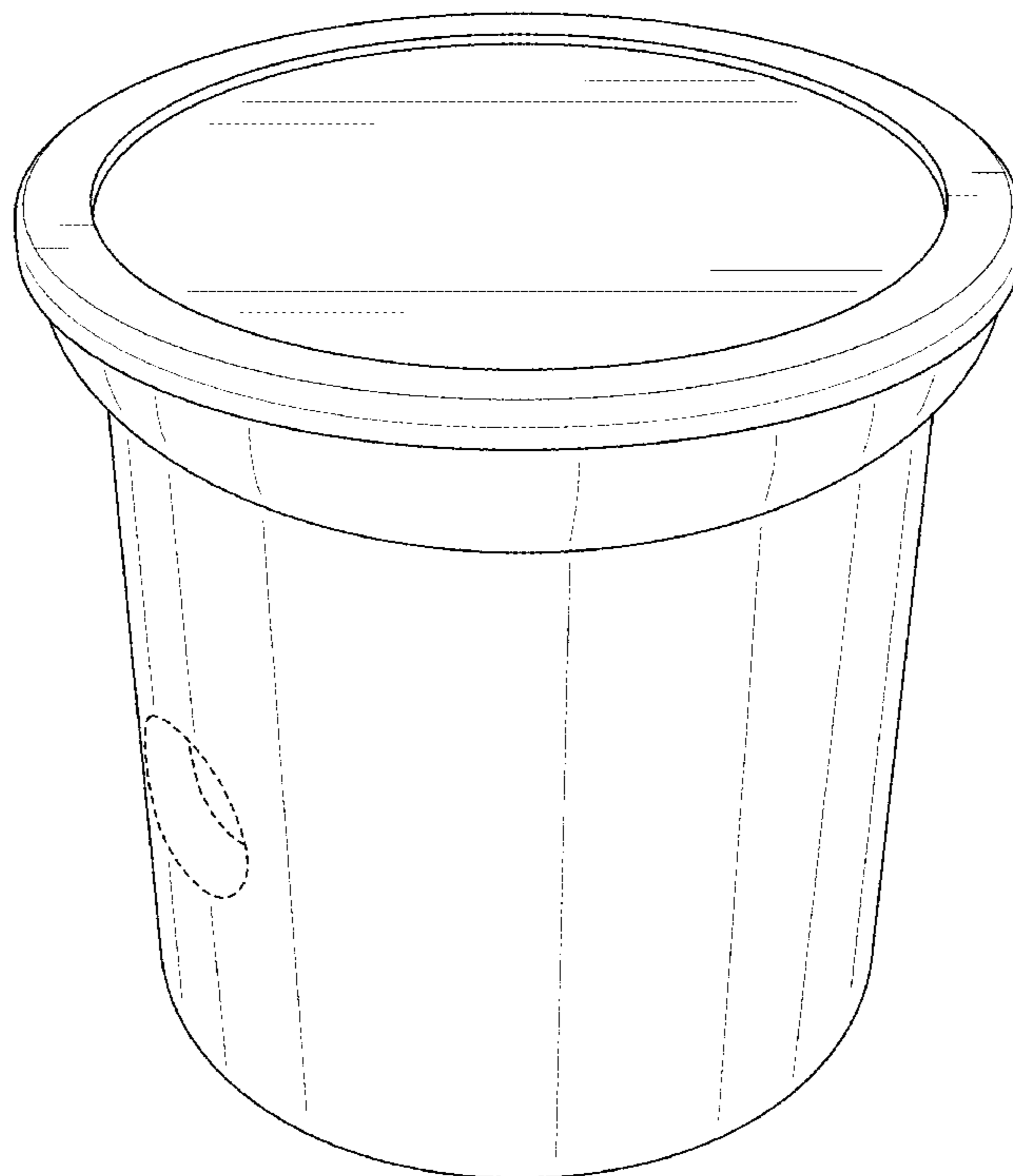

DESCRIPTION
FIG. 1 is a top perspective view of an end cap showing my new design;
FIG. 2 is a left side elevation view thereof;

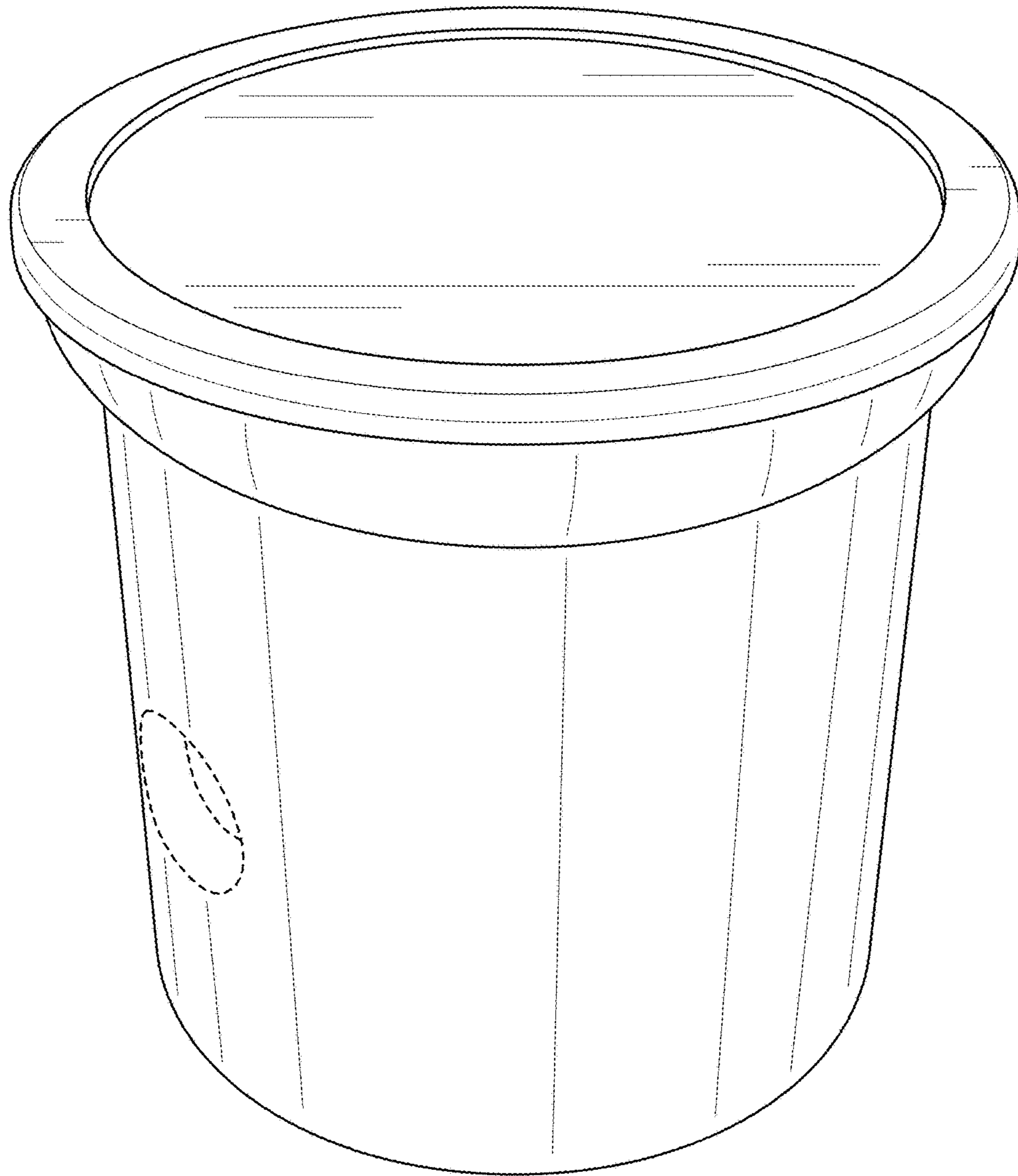

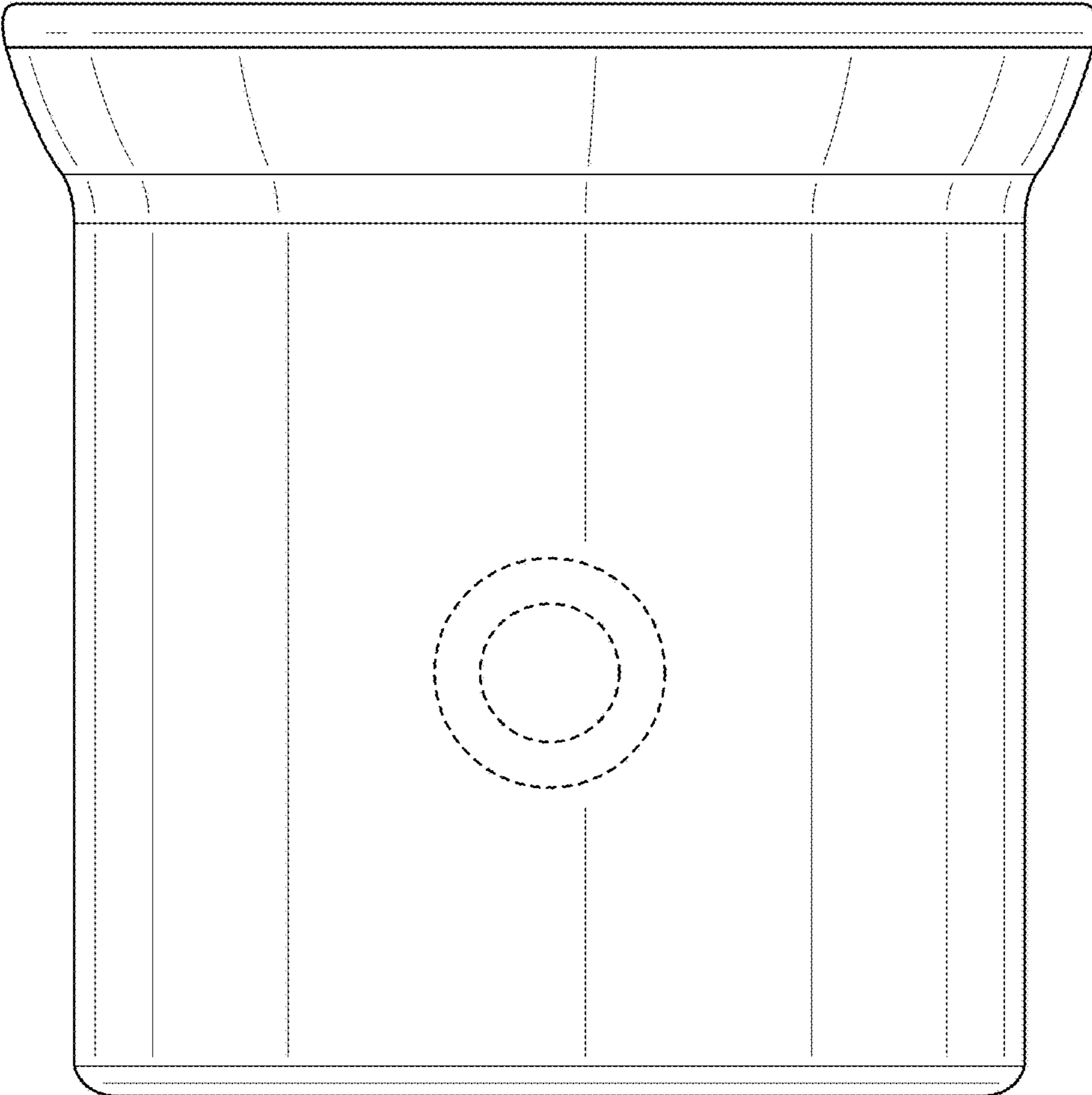

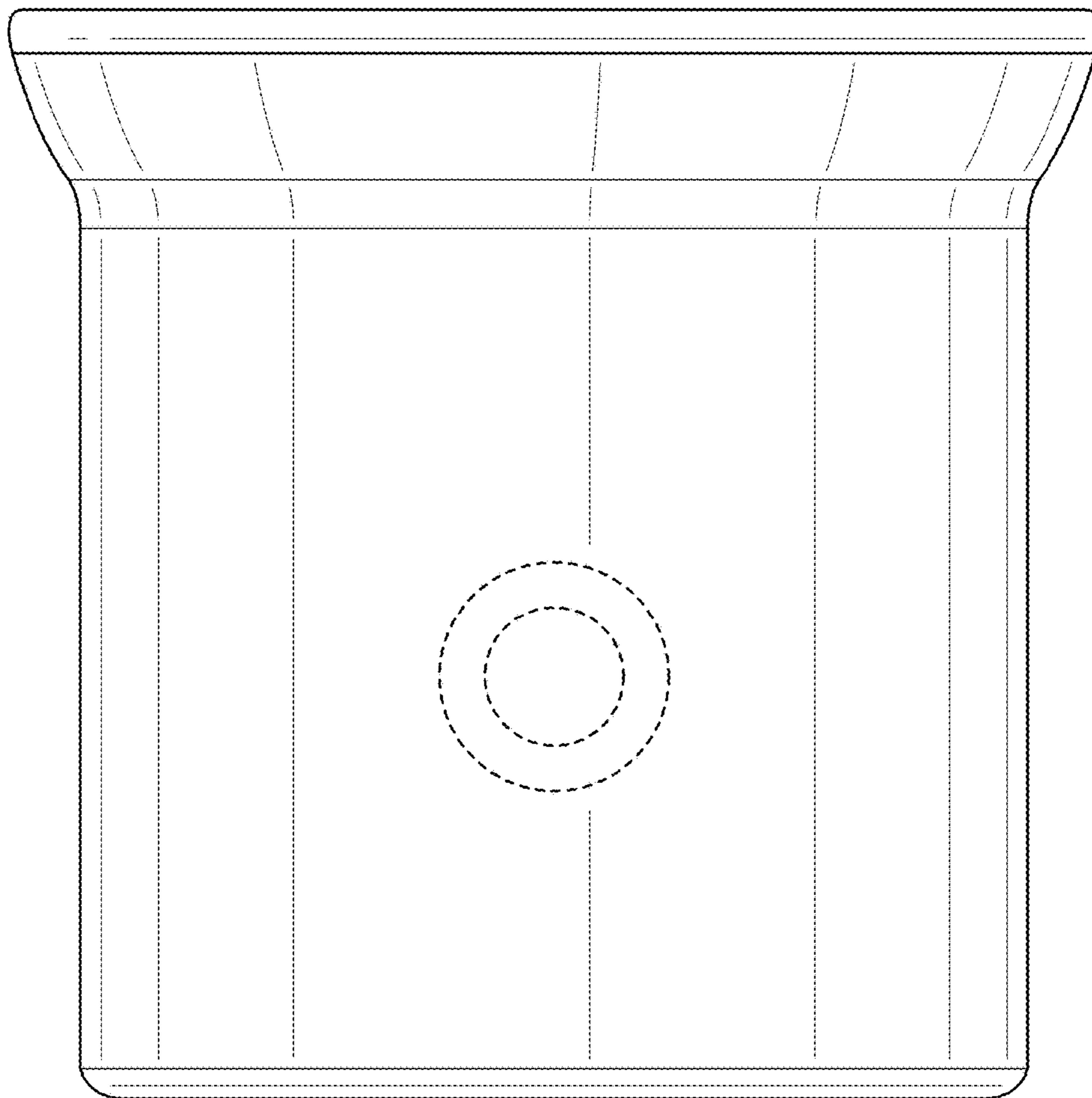

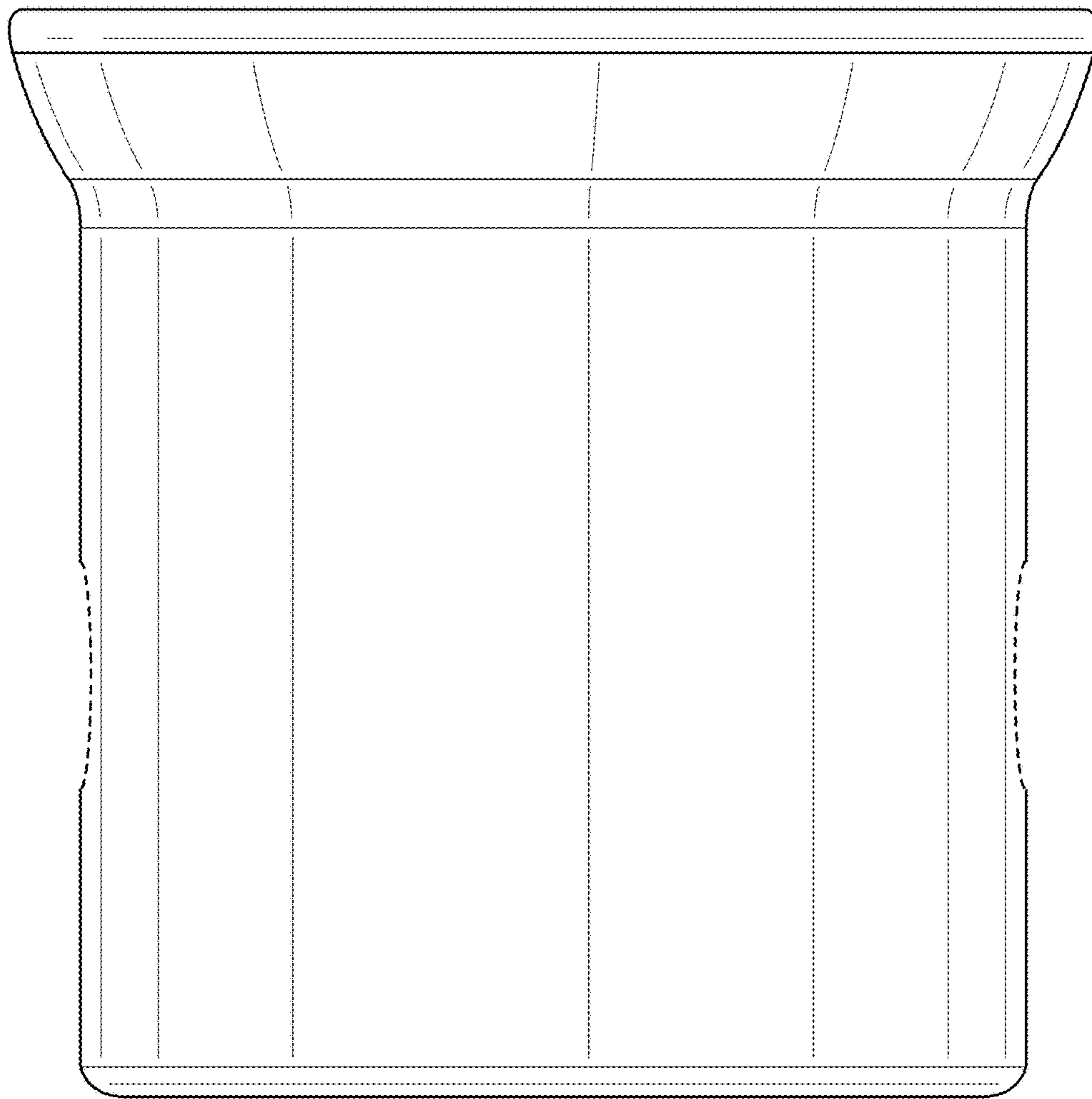

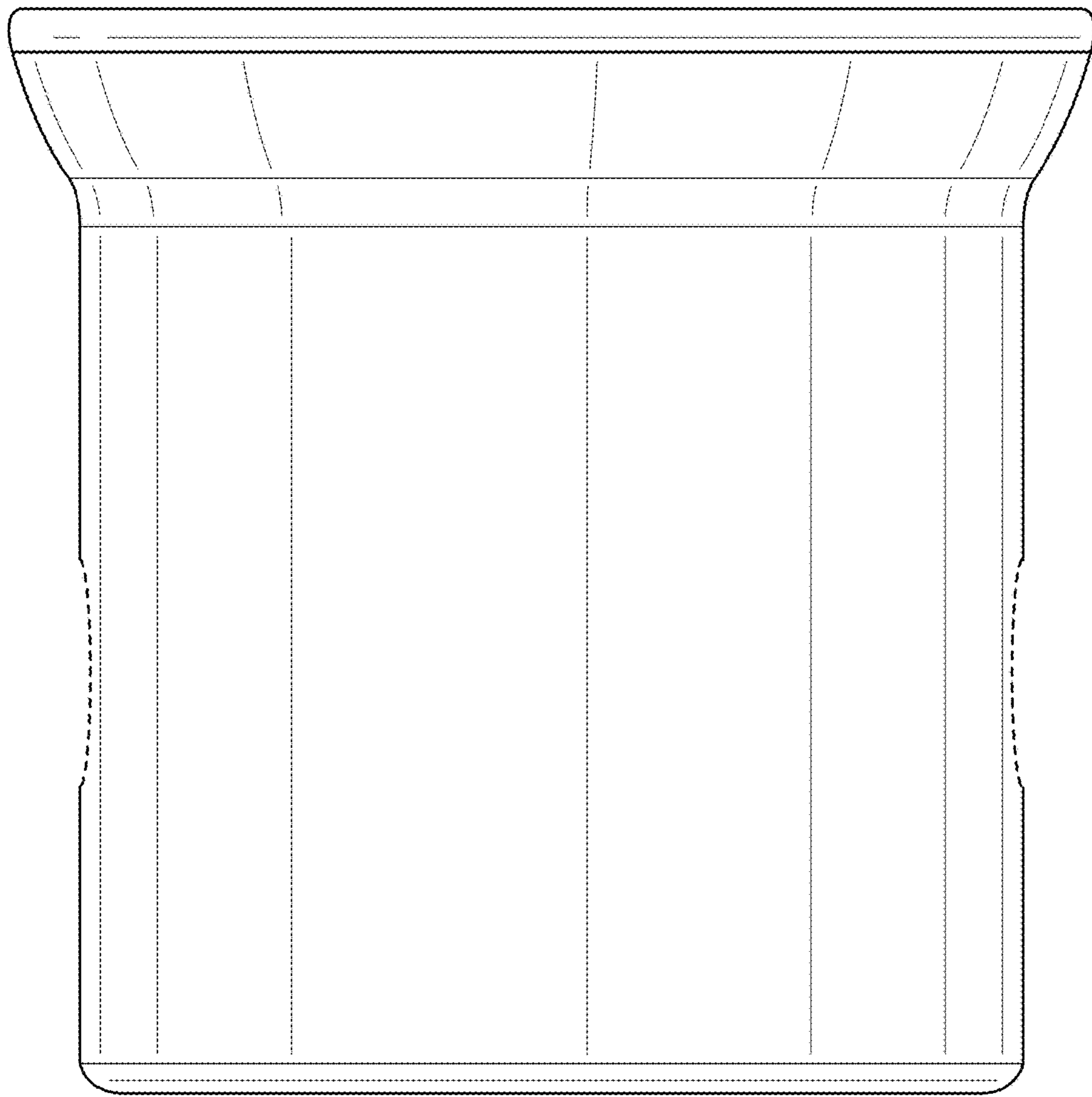

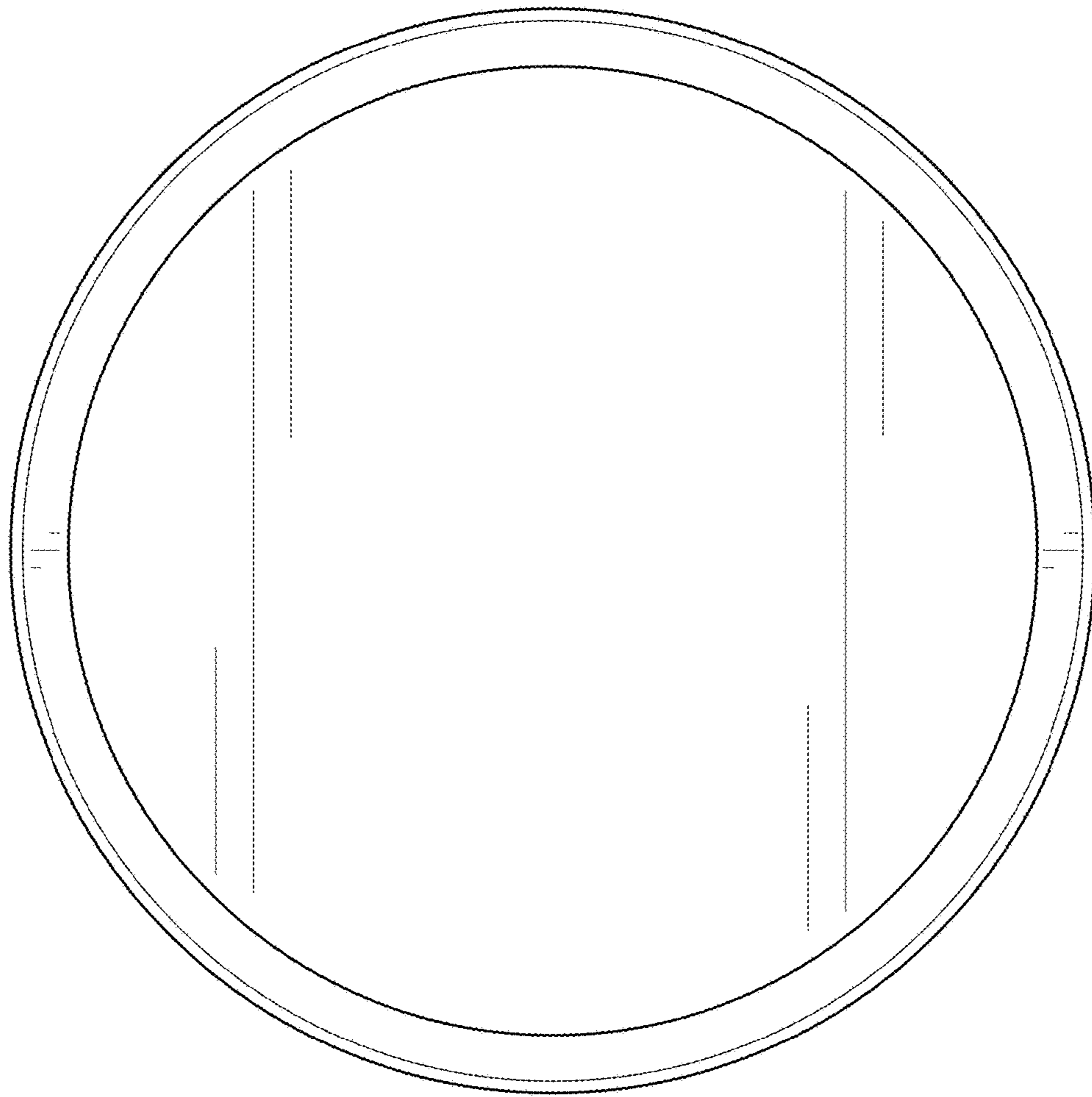

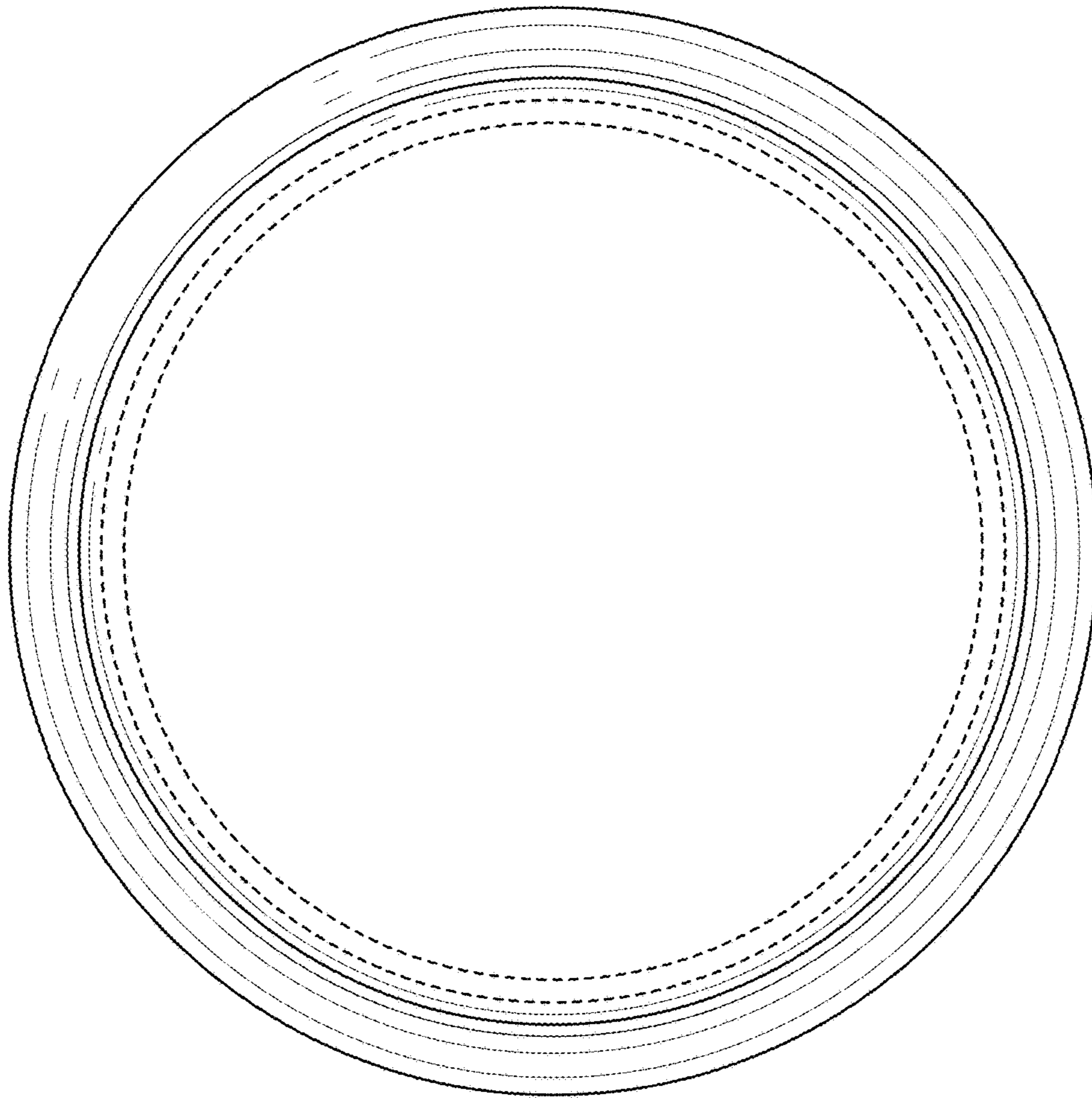
