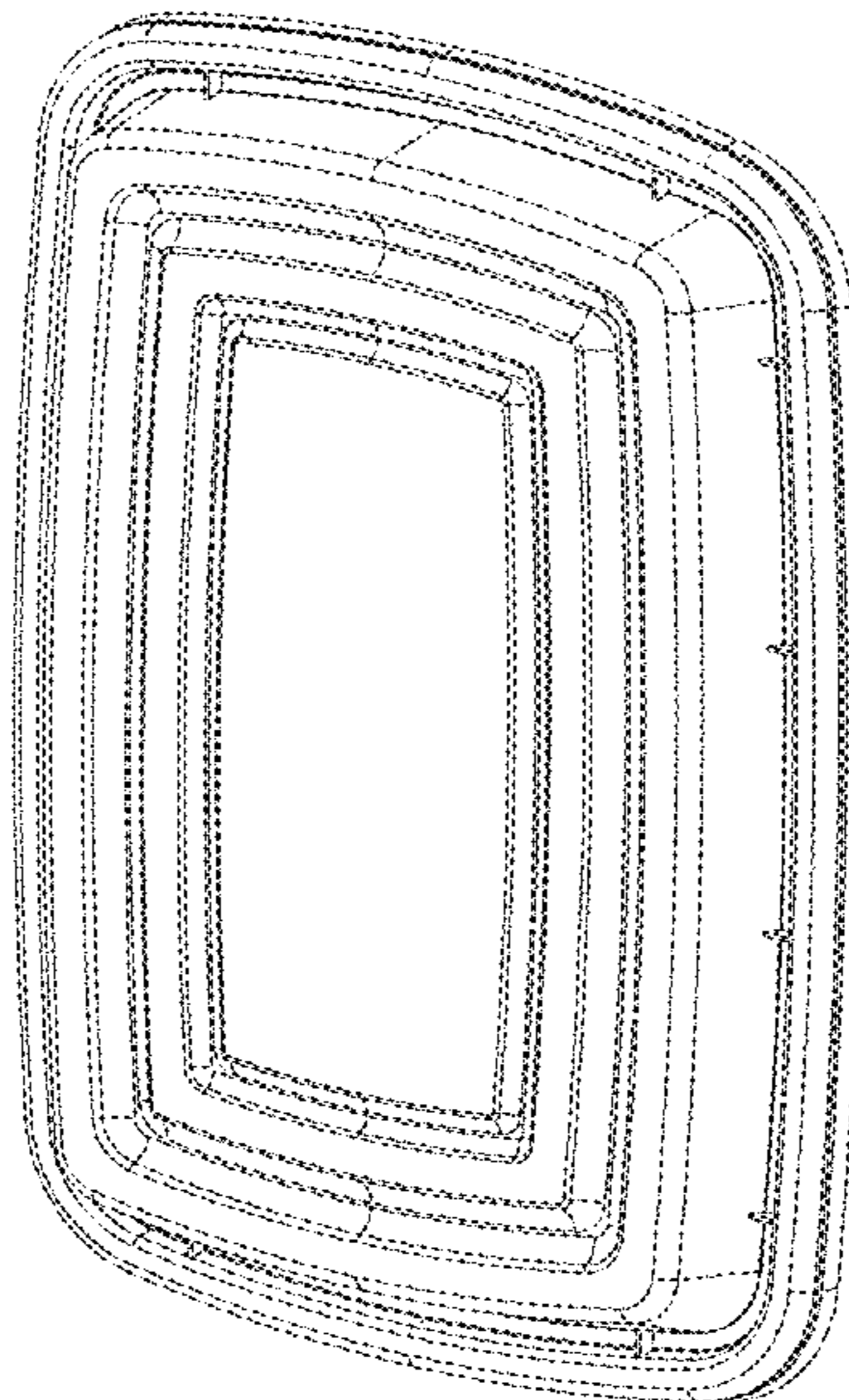
(57) **CLAIM**

I claim the ornamental design for a container lid, as shown and described.

DESCRIPTION

FIG. 1 is a left side, bottom perspective view of a container lid, showing my new design;
FIG. 2 is a top plan view thereof;
FIG. 3 is a bottom plan view thereof;
FIG. 4 is a left side view thereof, the right side view being a mirror image thereof; and,
FIG. 5 is a front plan view thereof, the rear plan view being a mirror image thereof.
The broken lines depict portions of the container lid, that form no part of the claim.

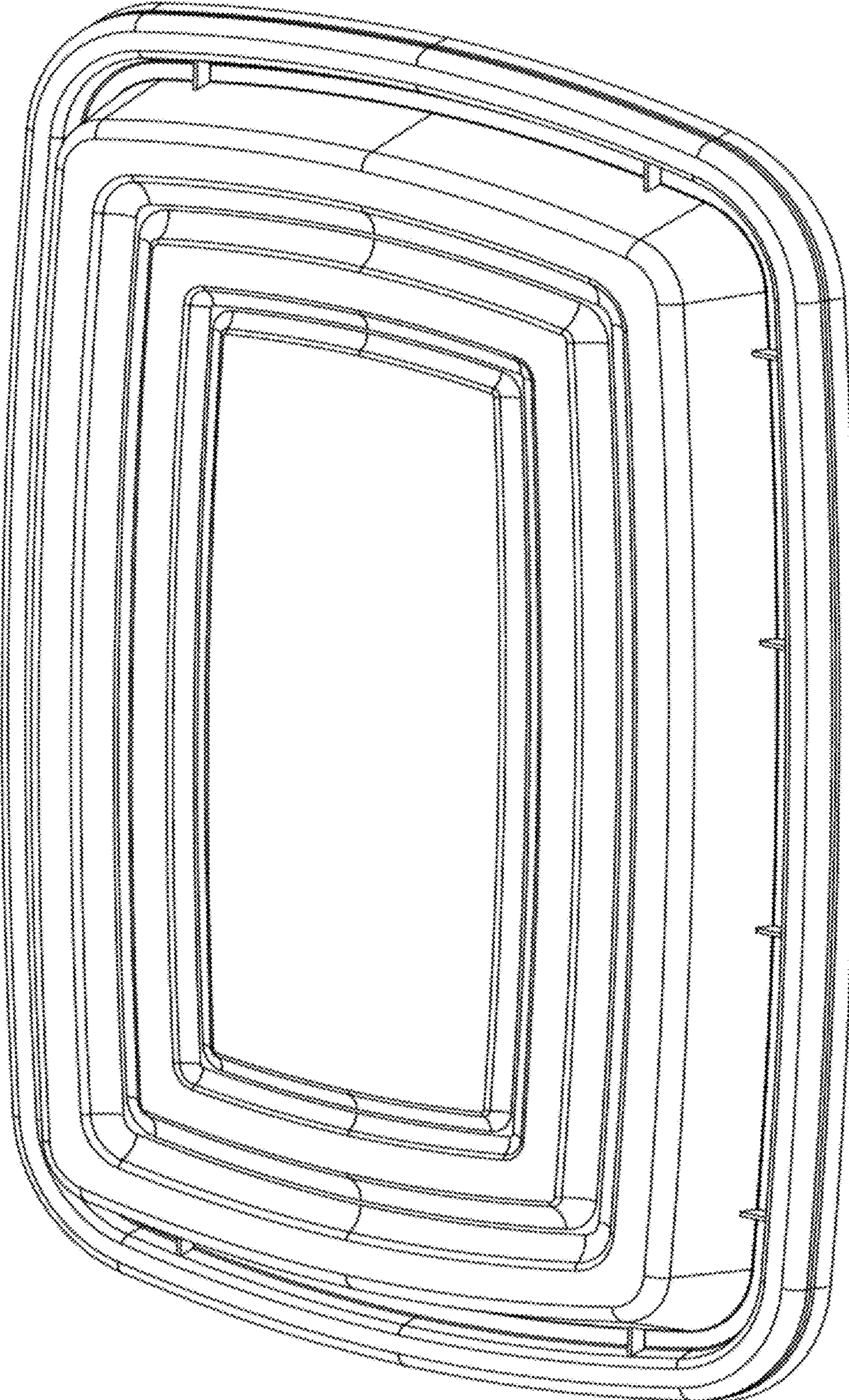

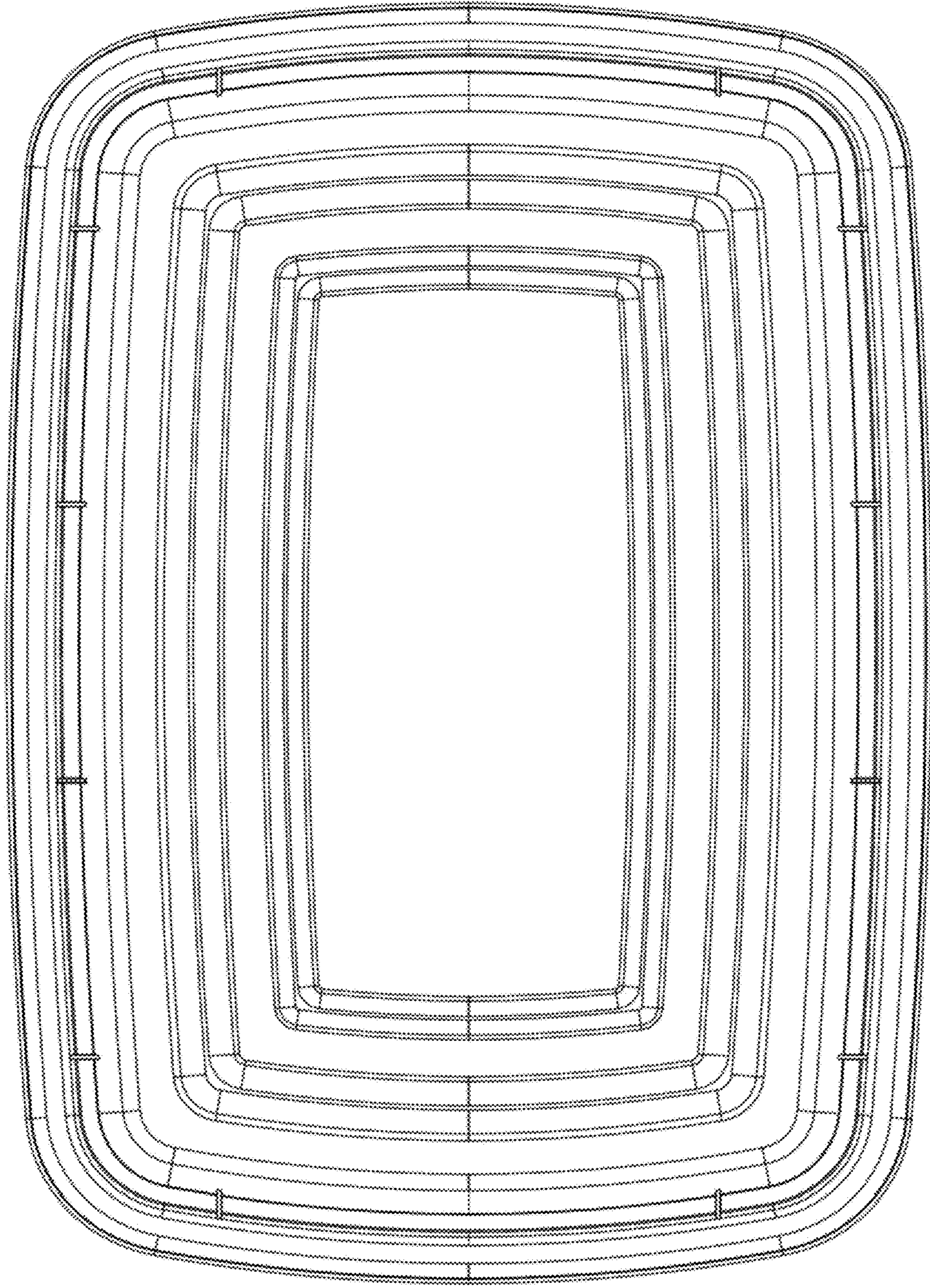

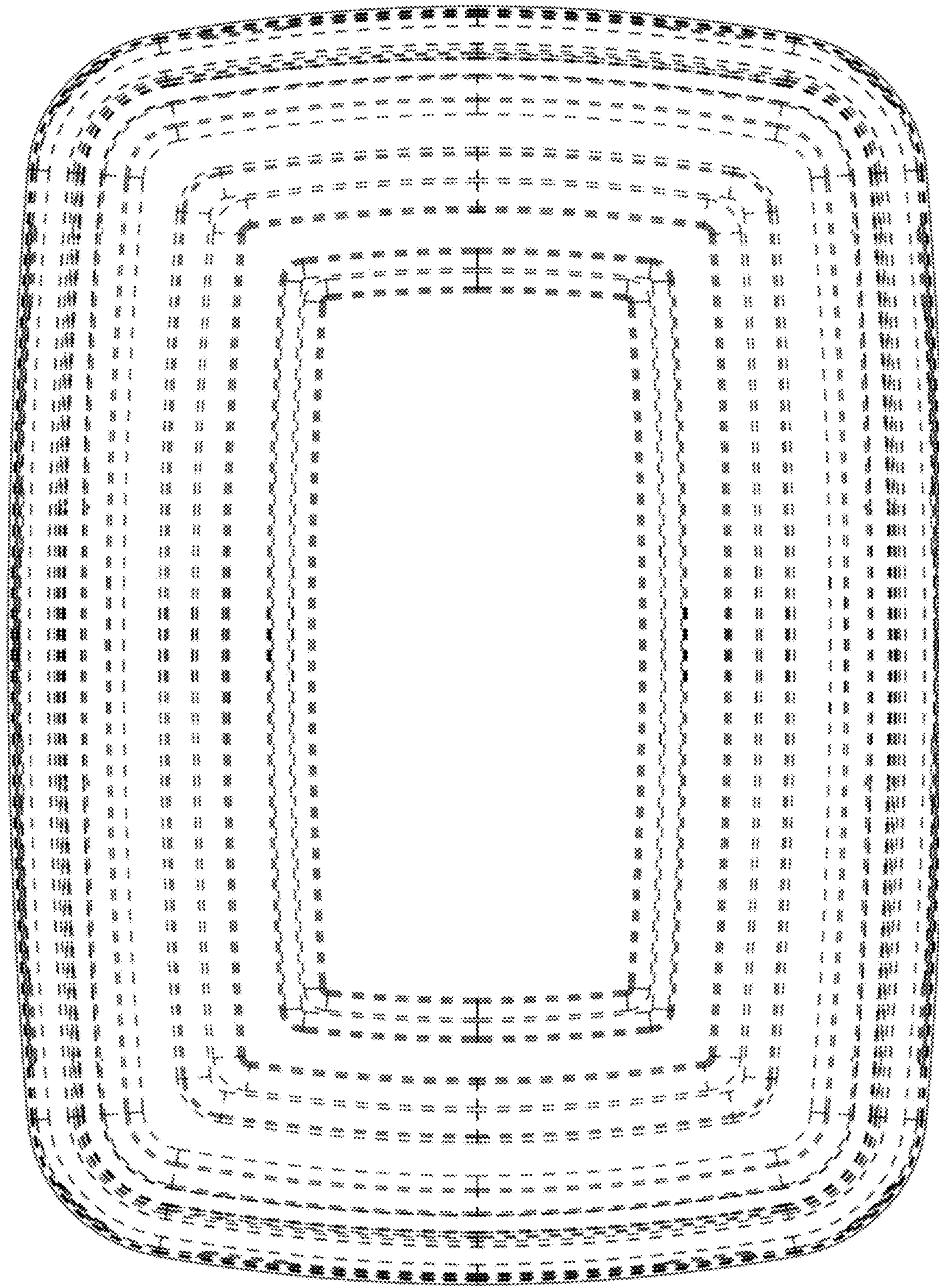

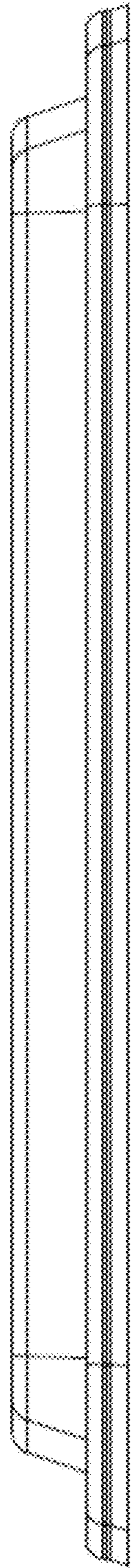

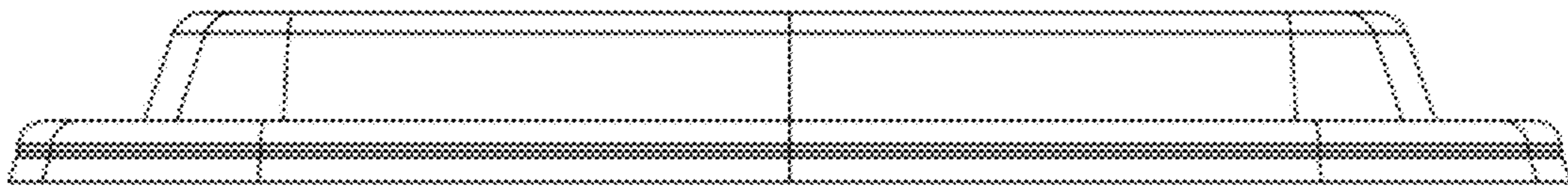
