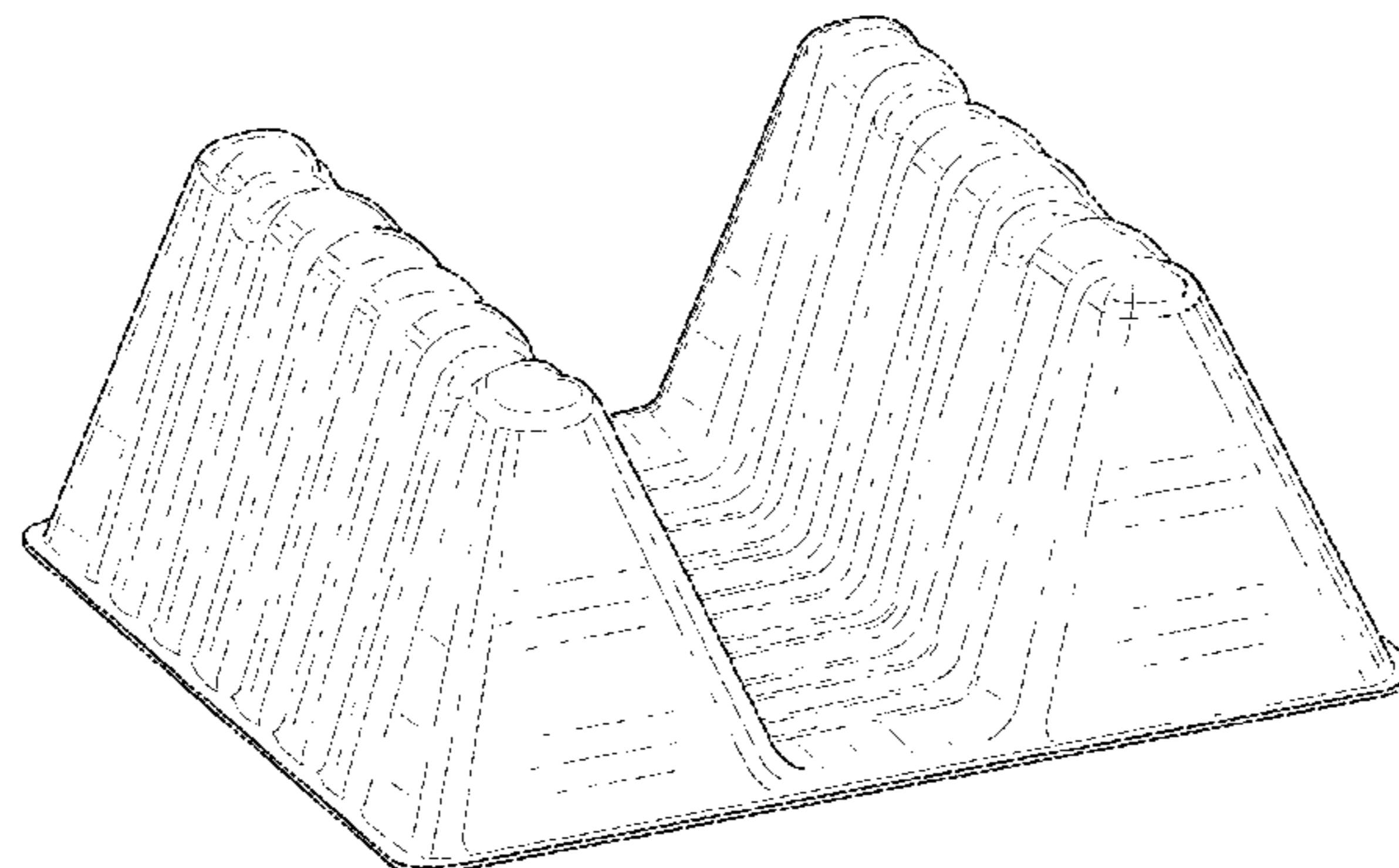


FIG. 6 is a side view thereof, as shown from the right side of FIG. 2.

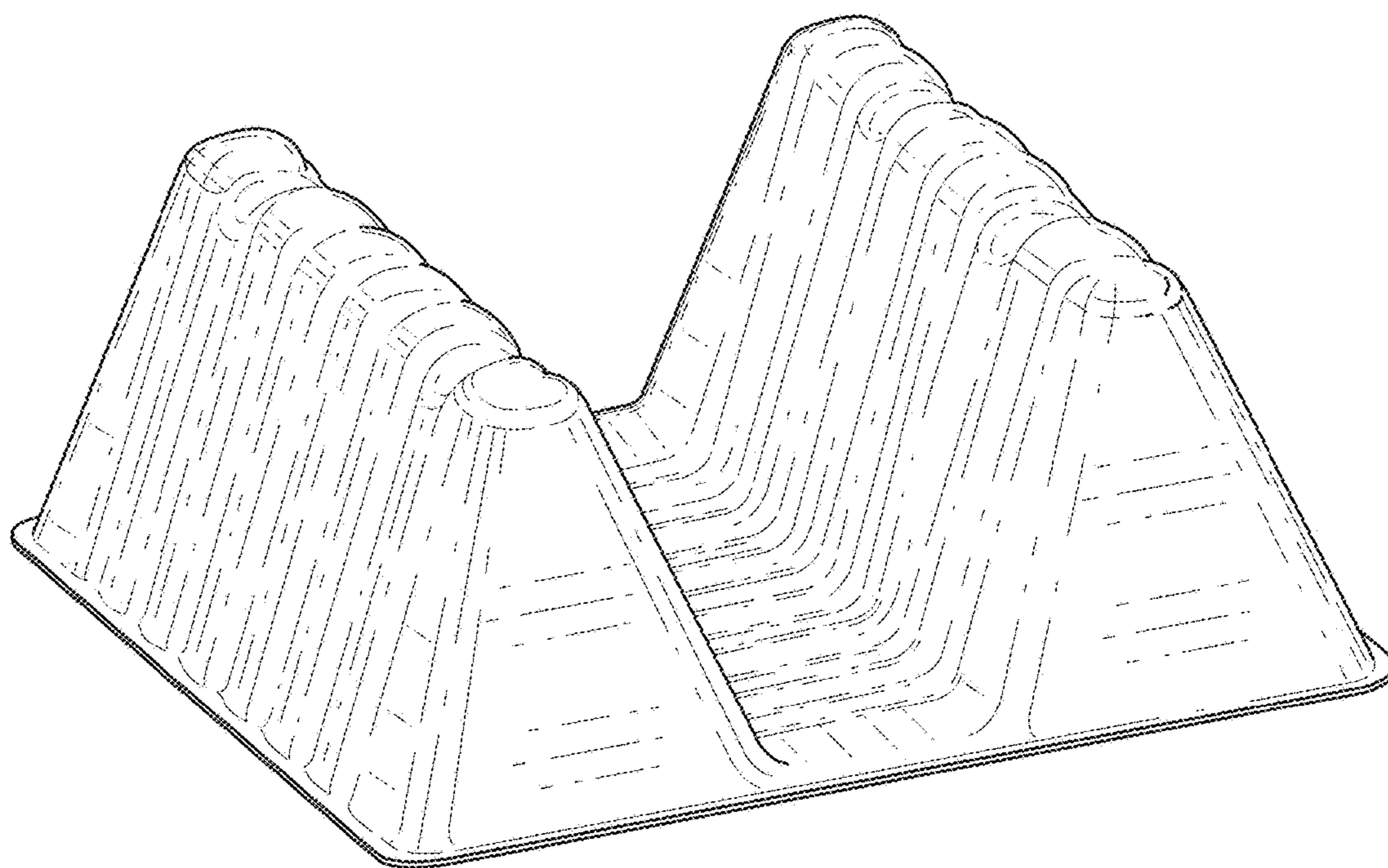

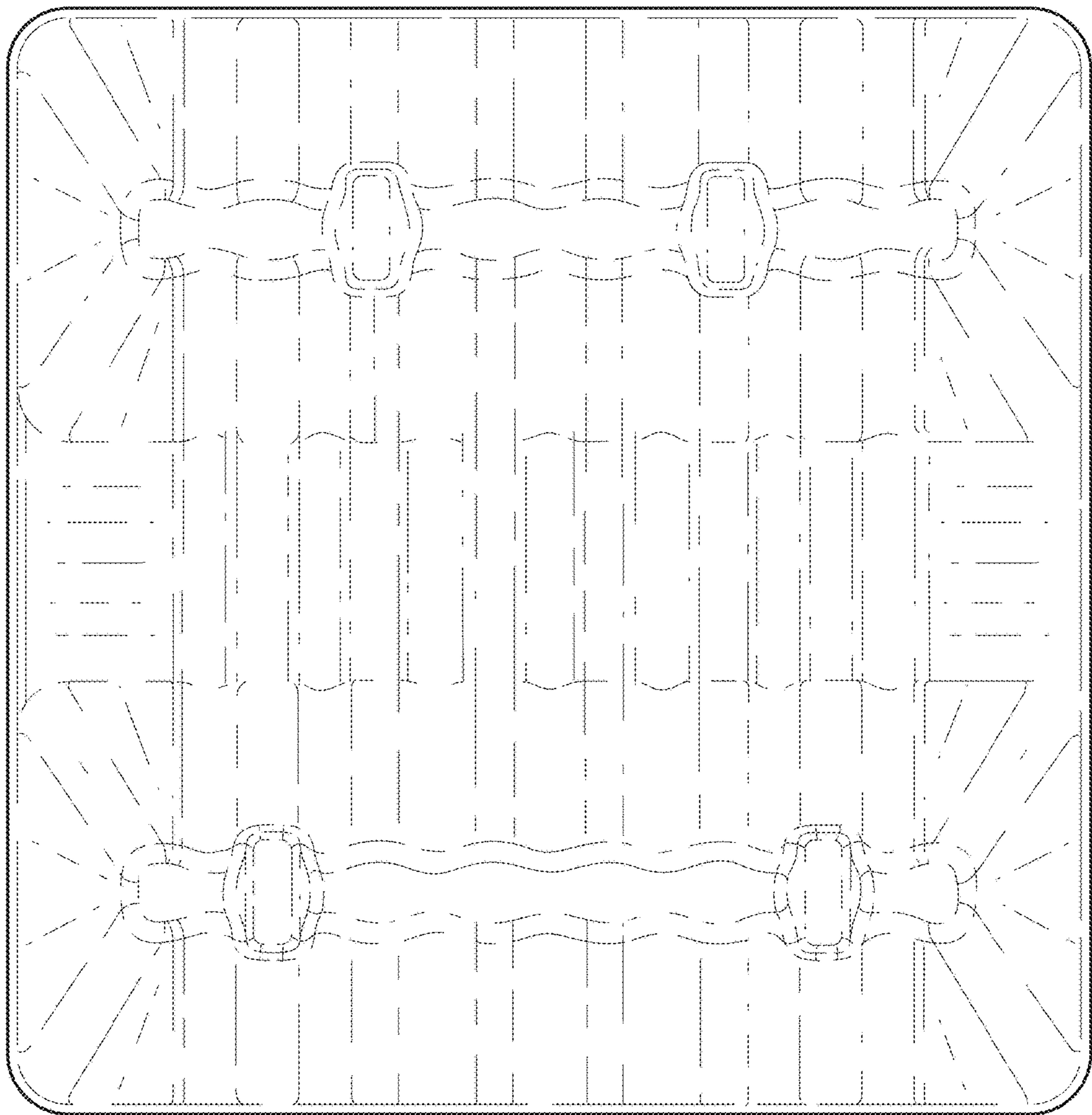

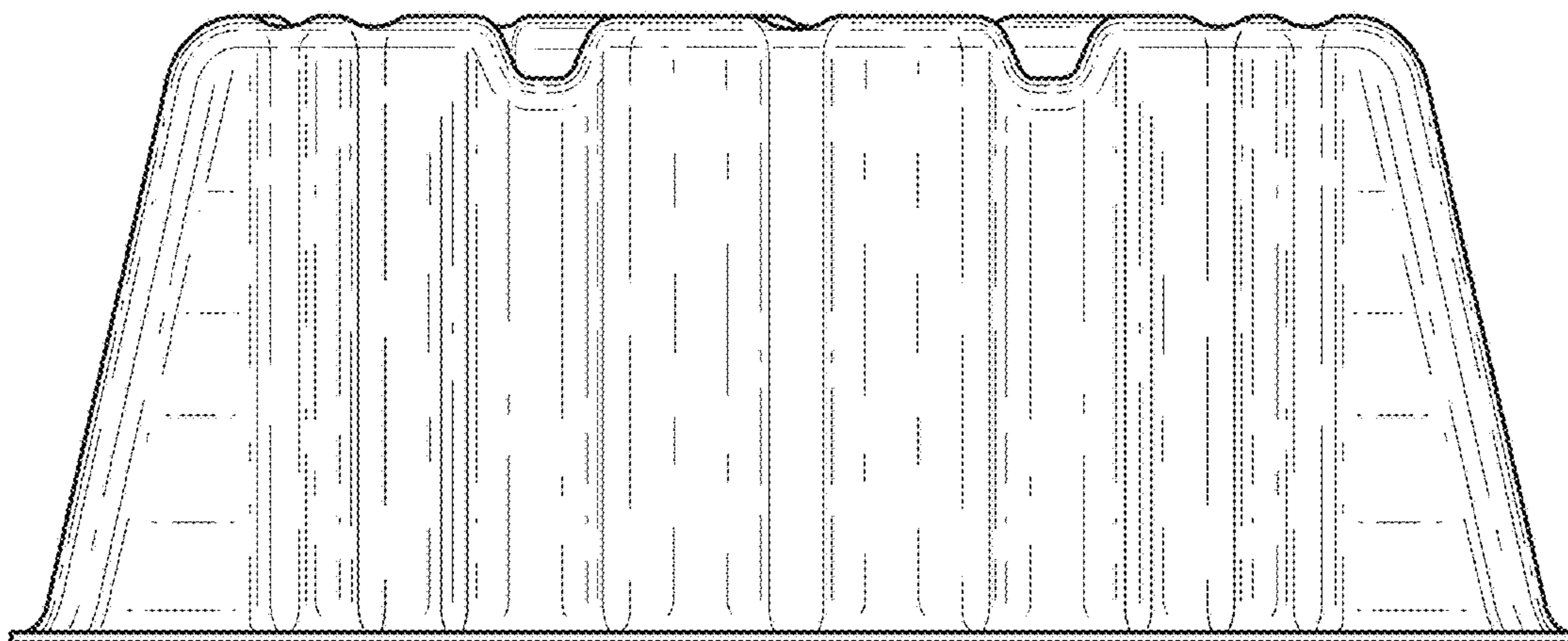

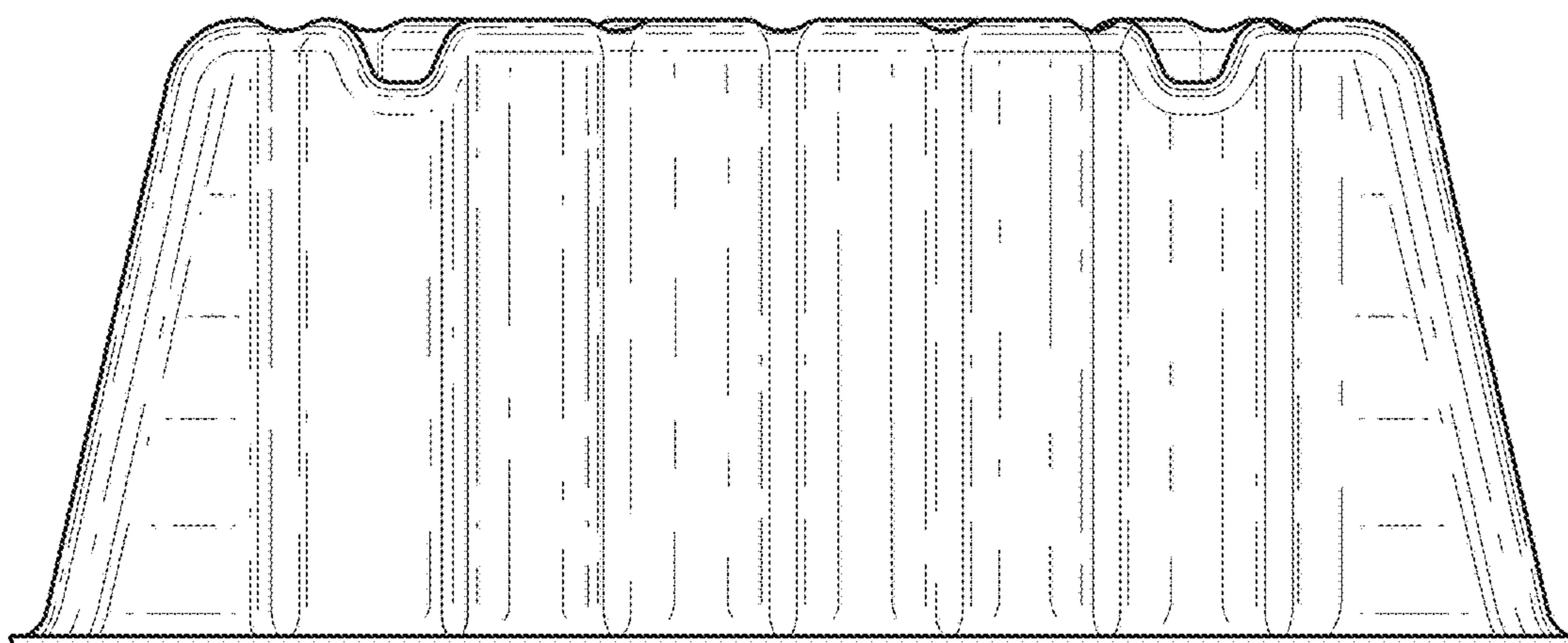

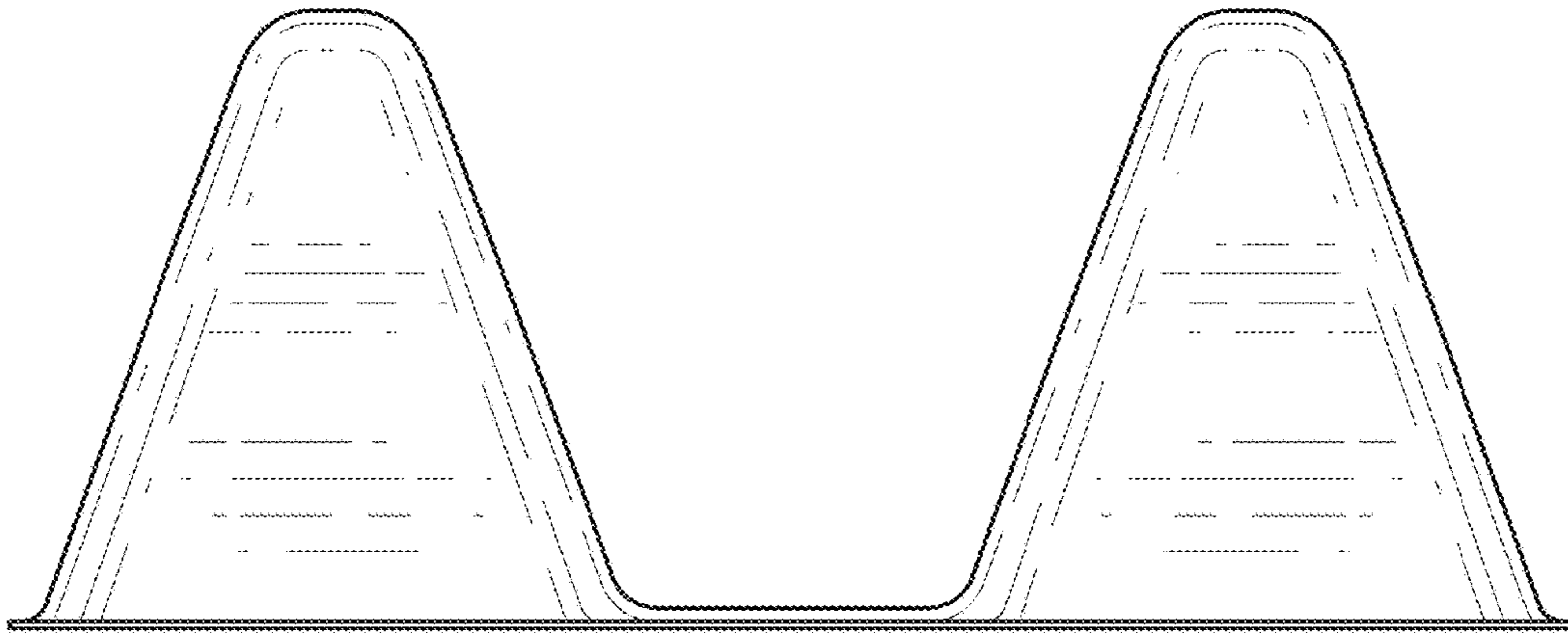

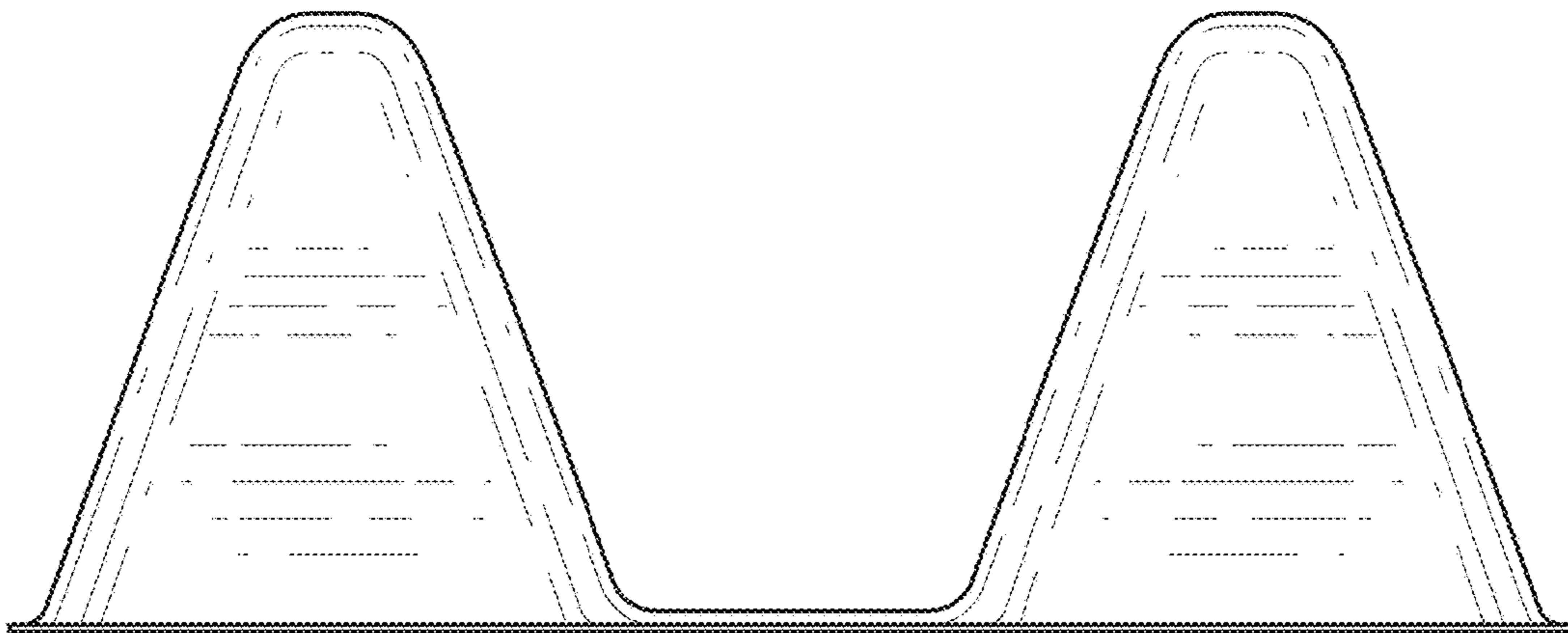
