(57) **CLAIM**

The ornamental design for a tire, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a tire, it being understood that the tread is repeated throughout the circumference of the tire, it being understood that the sidewall forms no part of the claimed design;

FIG. 2 is a front elevation view thereof, the back elevation view being the same but with the features reversed;

FIG. 3 is a side elevation view thereof, as seen from the right of FIG. 2;

FIG. 4 is a side elevation view thereof, as seen from the left of FIG. 2;

FIG. 5 is a cross-sectional view taken along line 5-5 of FIG. 2;

FIG. 6 is a perspective view of a tire, it being understood that the tread is repeated throughout the circumference of the tire;

FIG. 7 is a front elevation view of the tire of FIG. 6;

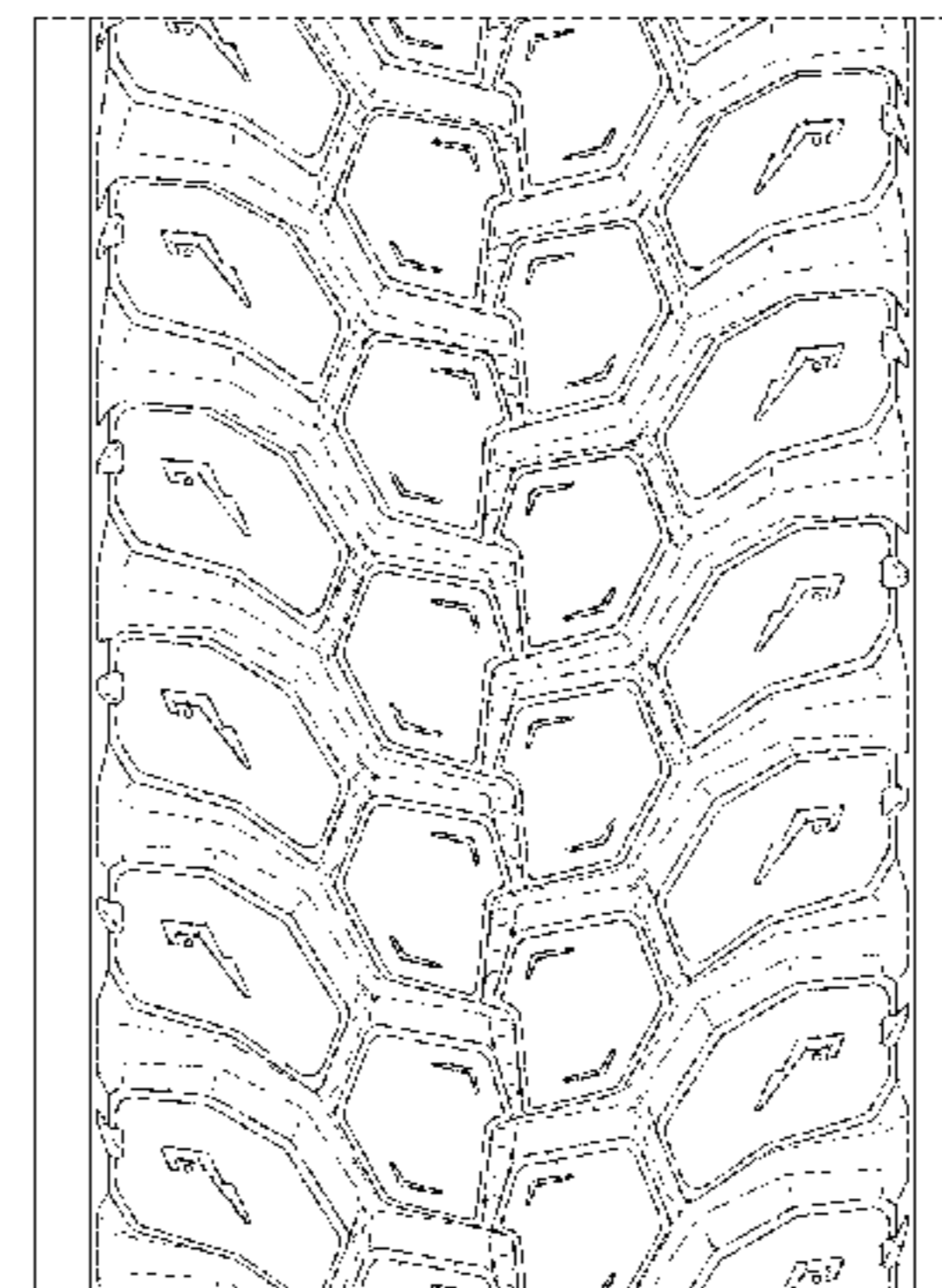
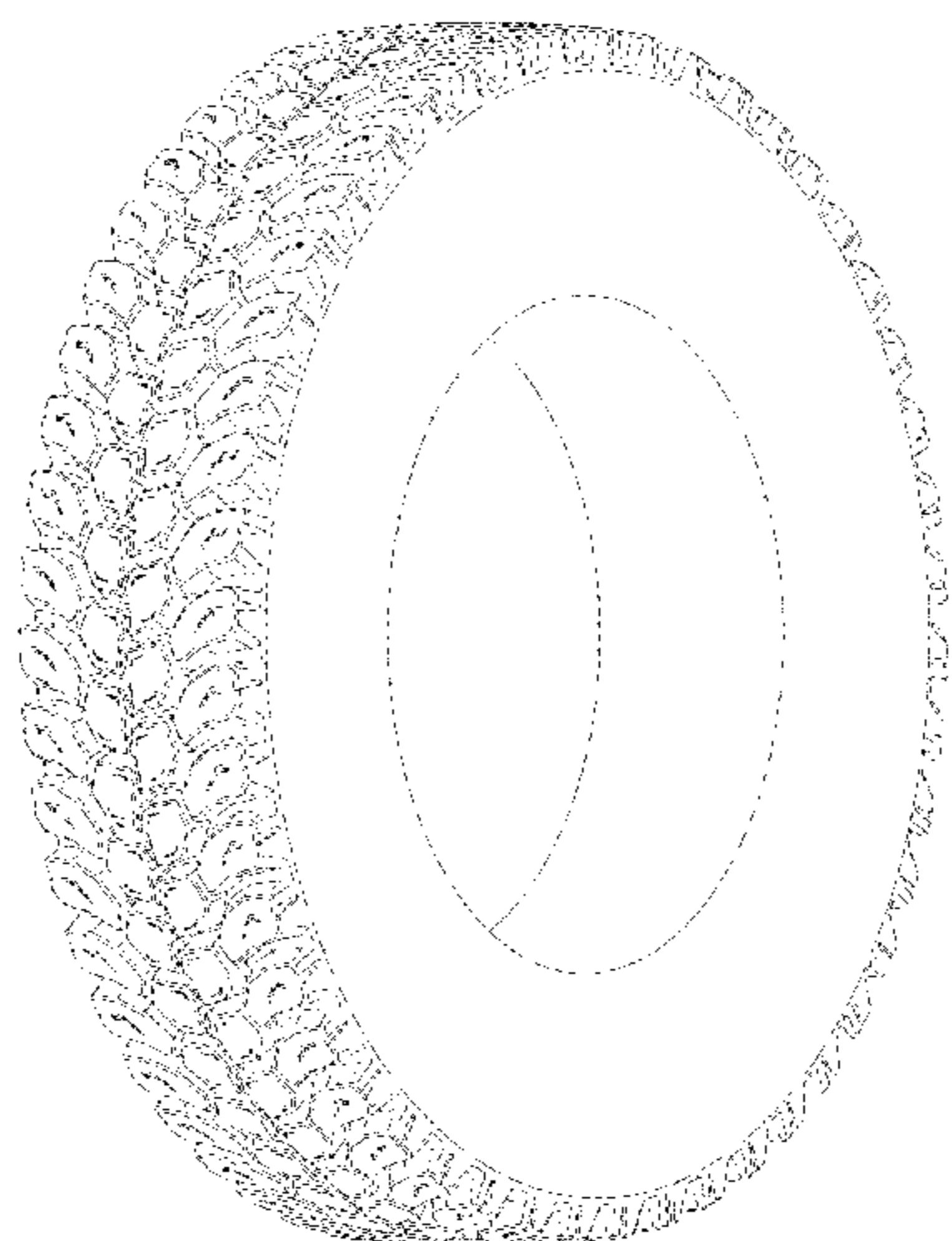
FIG. 8 is a side elevation view thereof, as seen from the right of FIG. 7;

FIG. 9 is a side elevation view thereof, as seen from the left of FIG. 7;

FIG. 10 is a cross-sectional view taken along line 10-10 of FIG. 7; and,

FIG. 11 is a detail view of the tire of FIG. 7, it being understood that the tread of FIG. 2 is the same as the tread shown in FIG. 11.

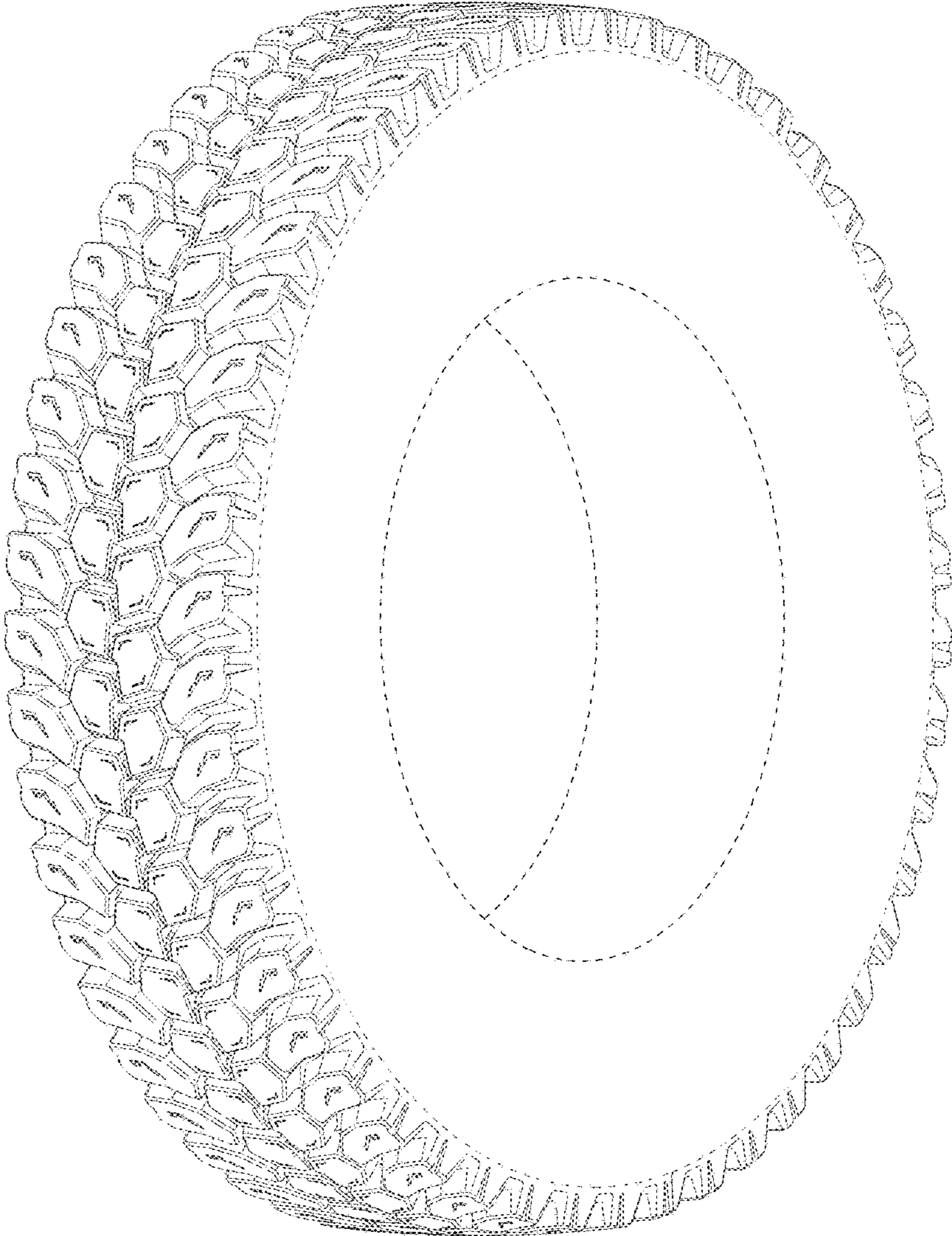

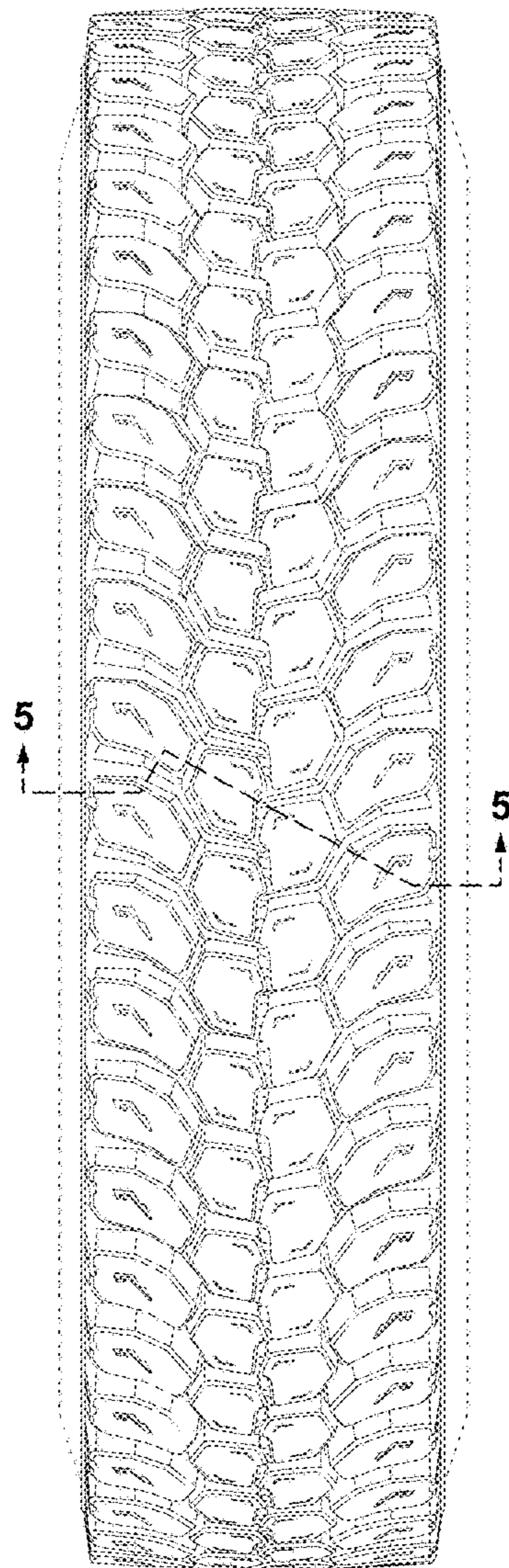

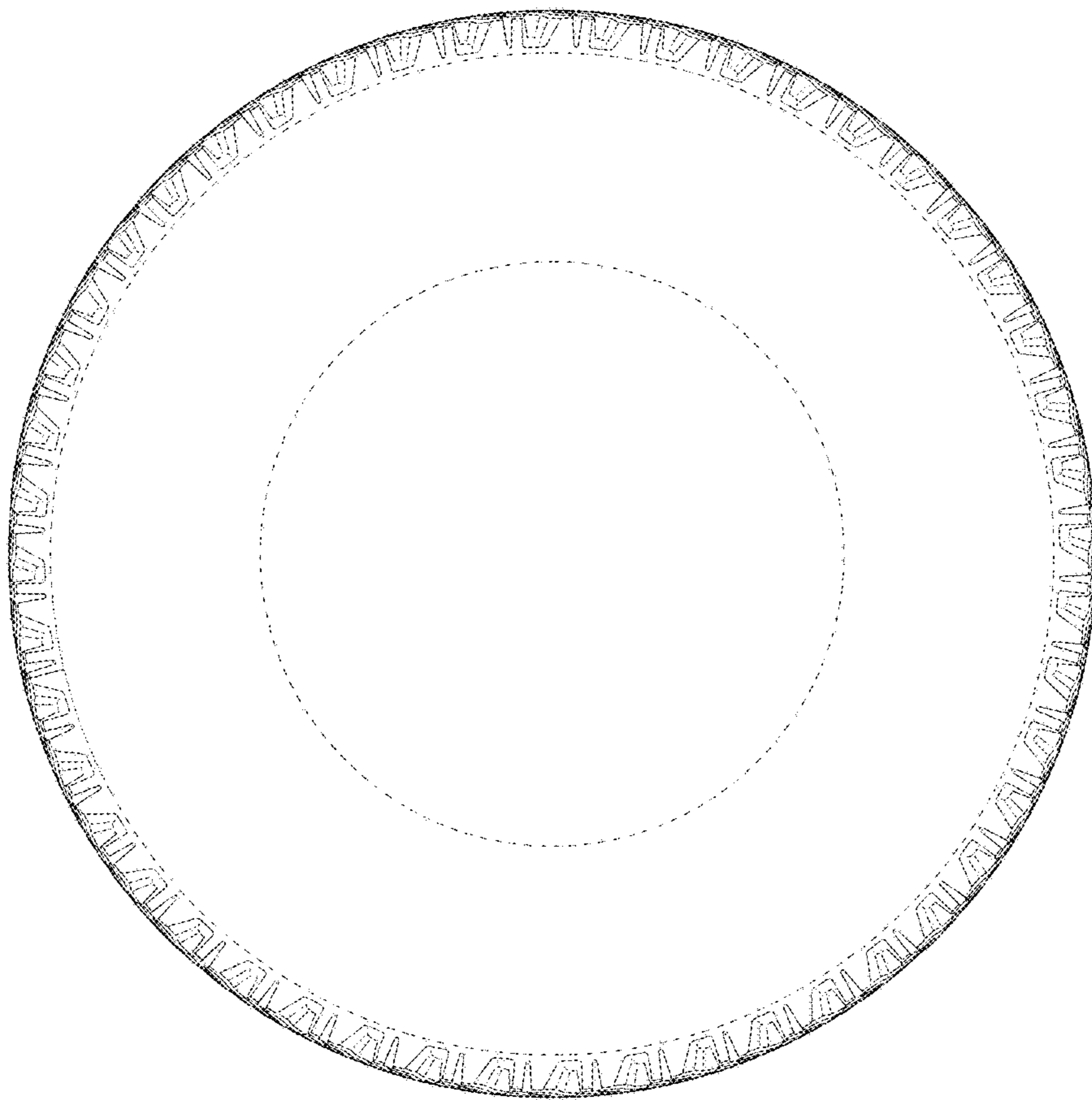

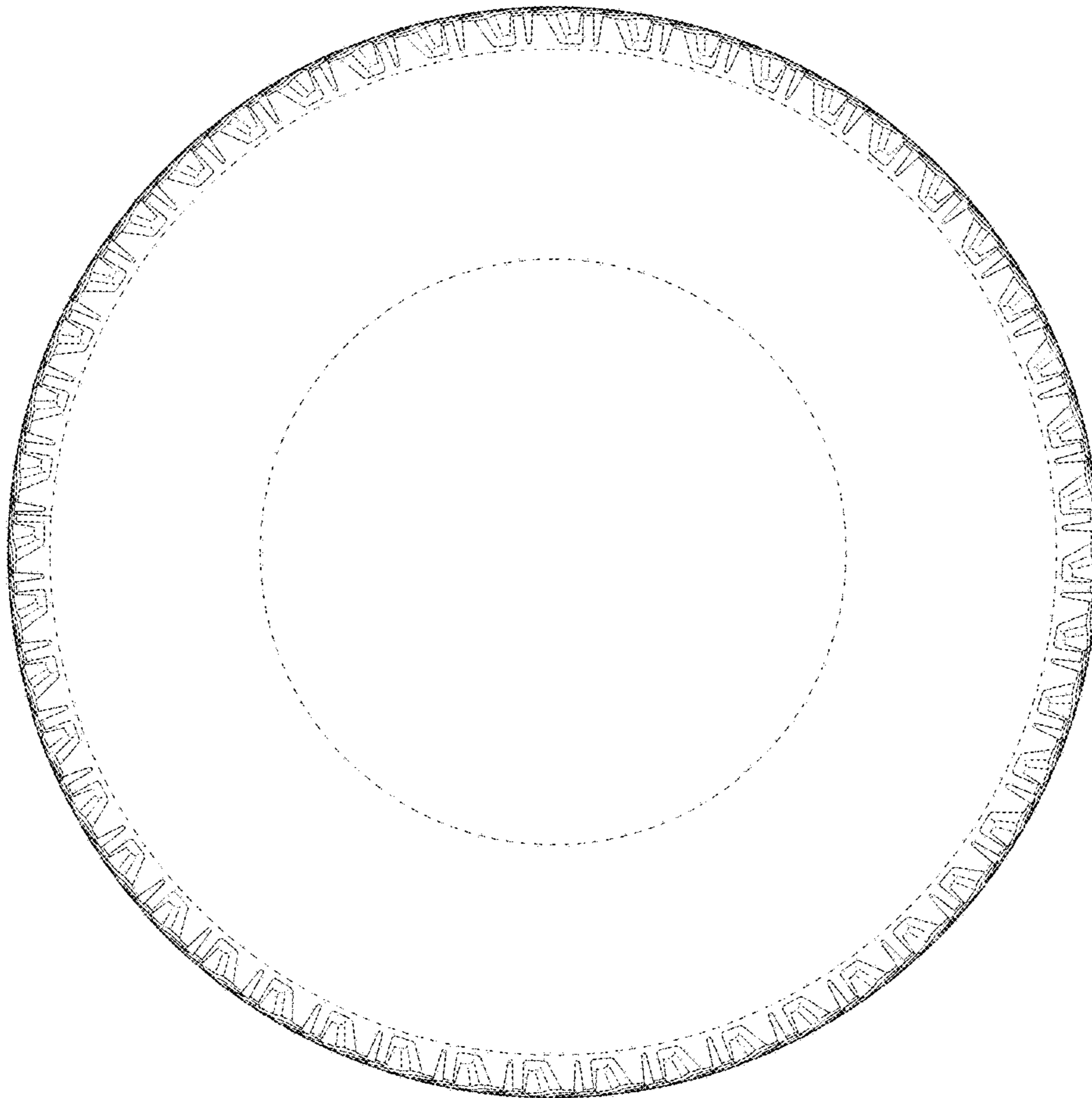

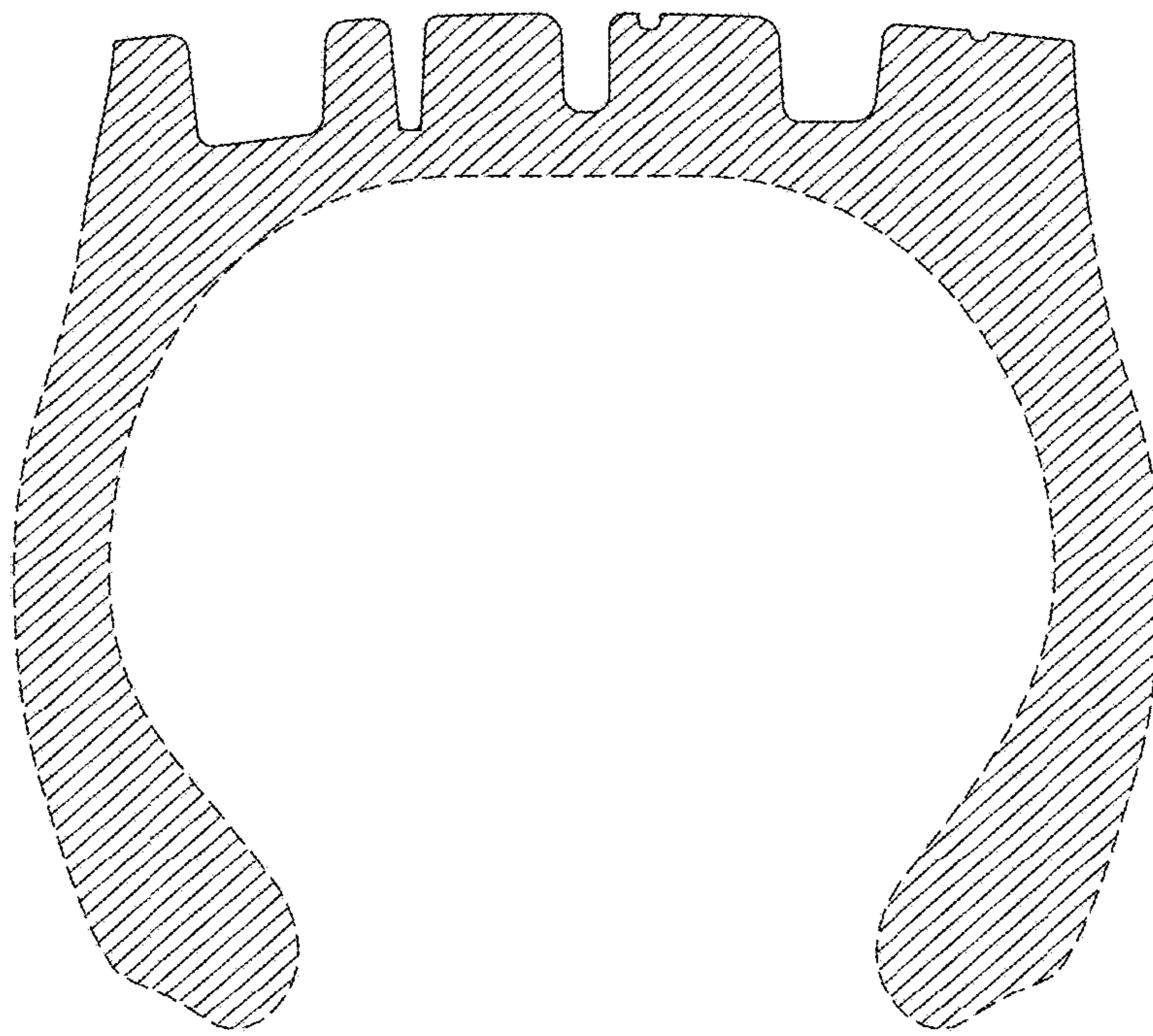

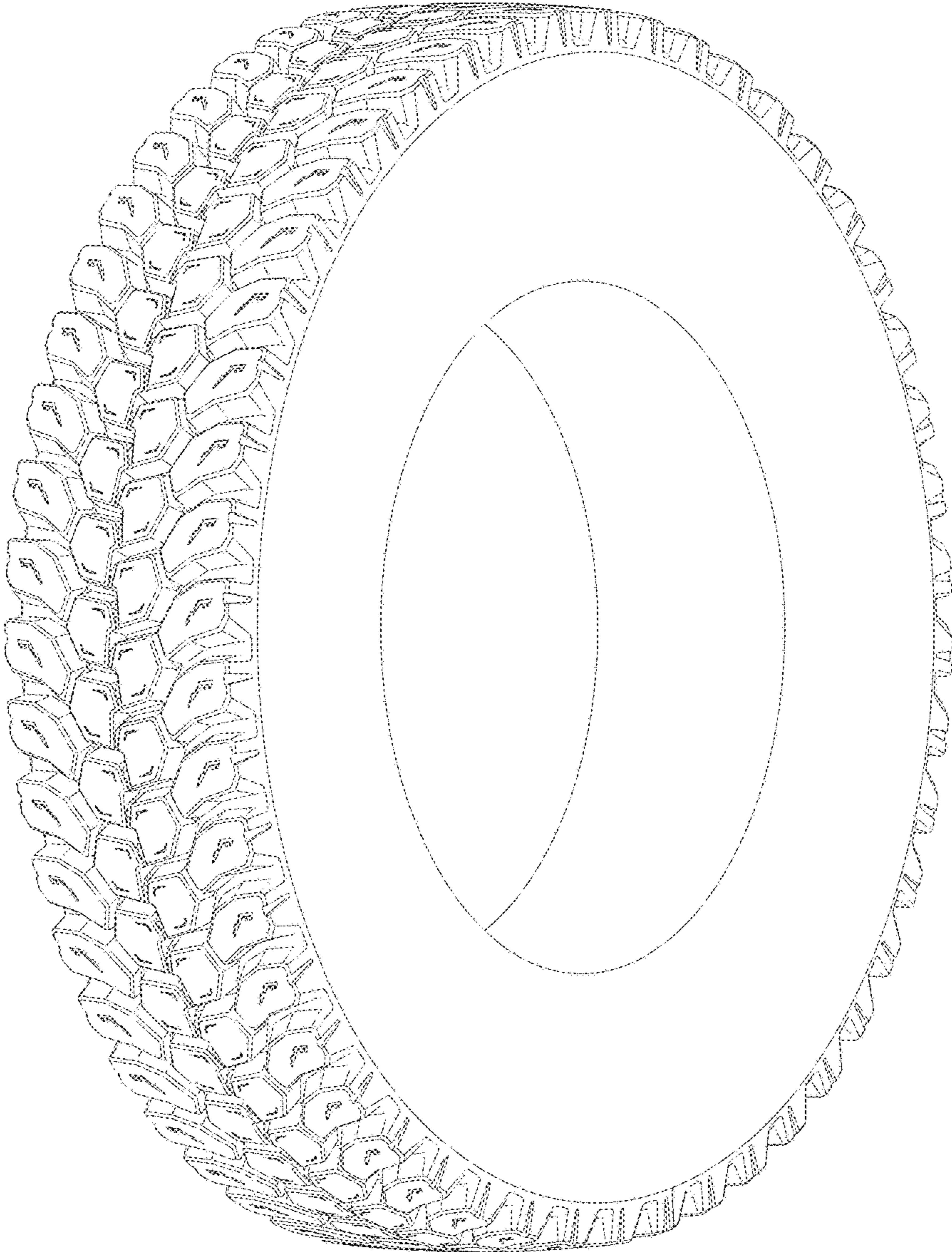

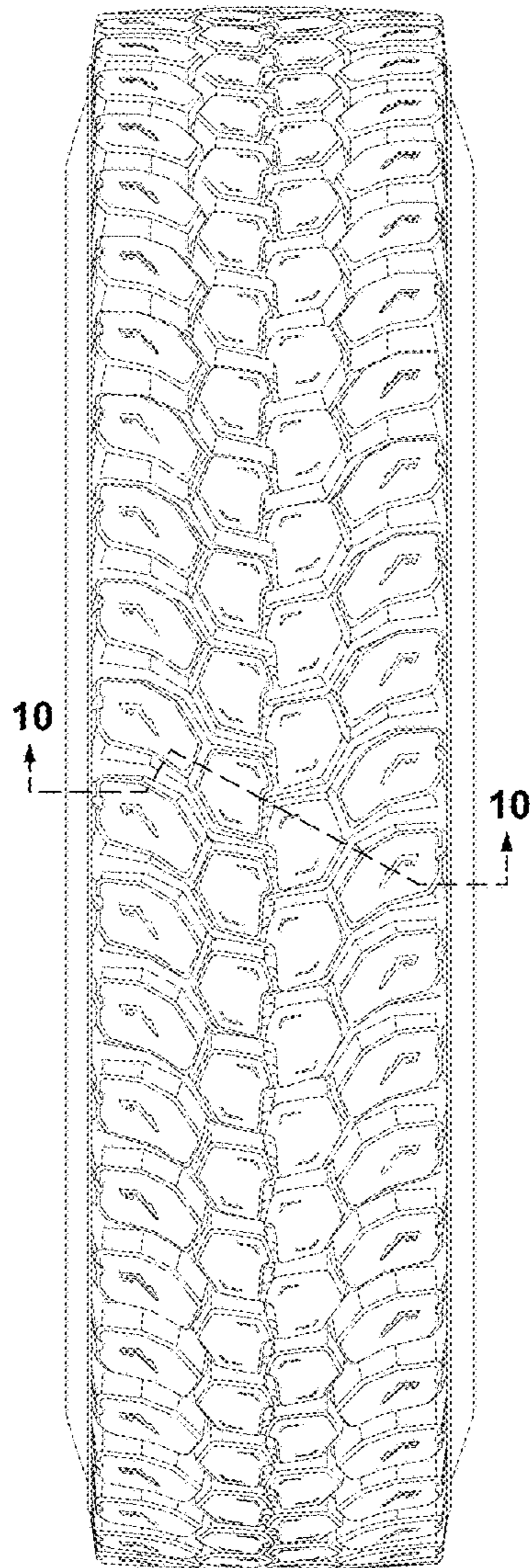

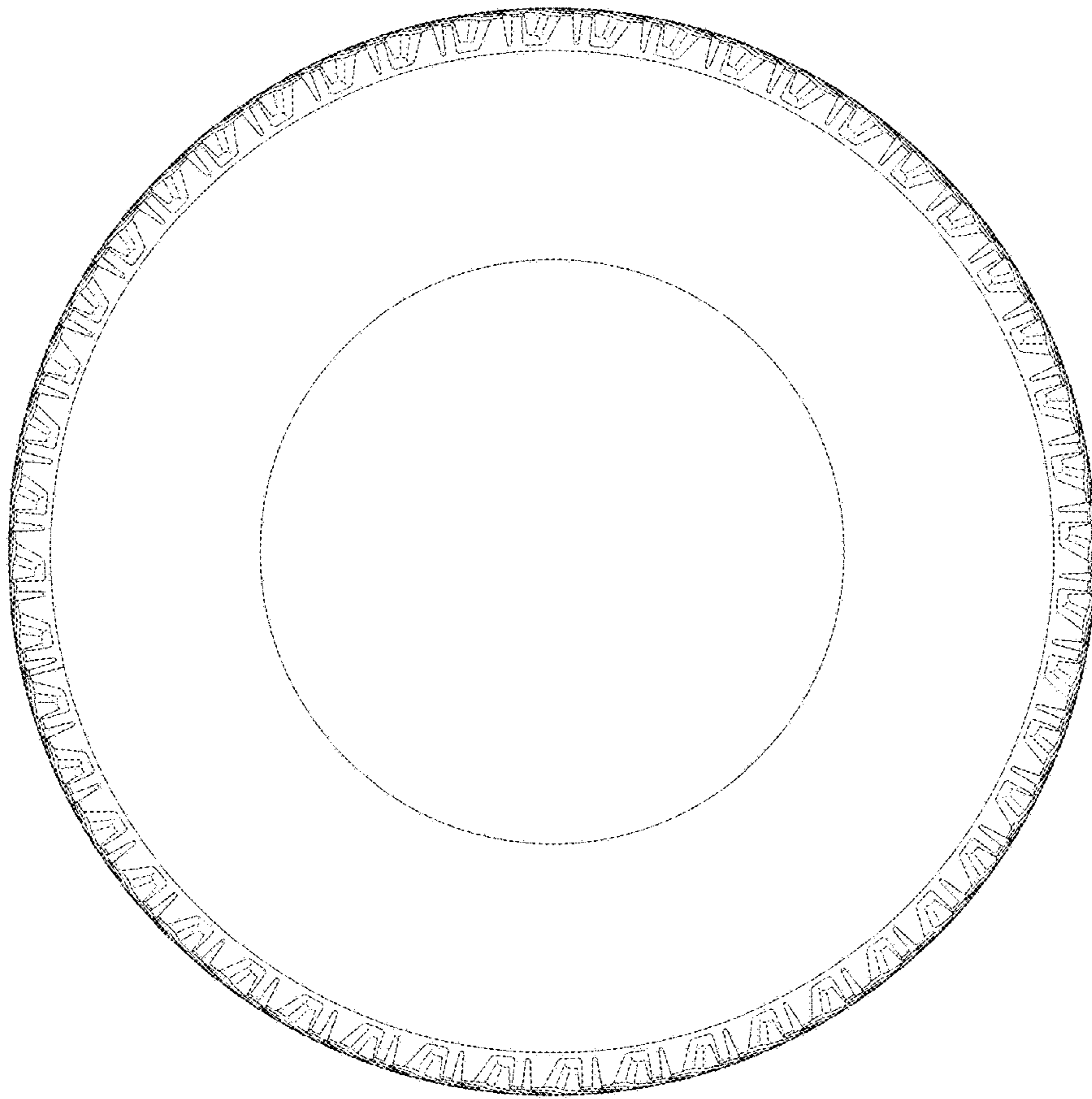

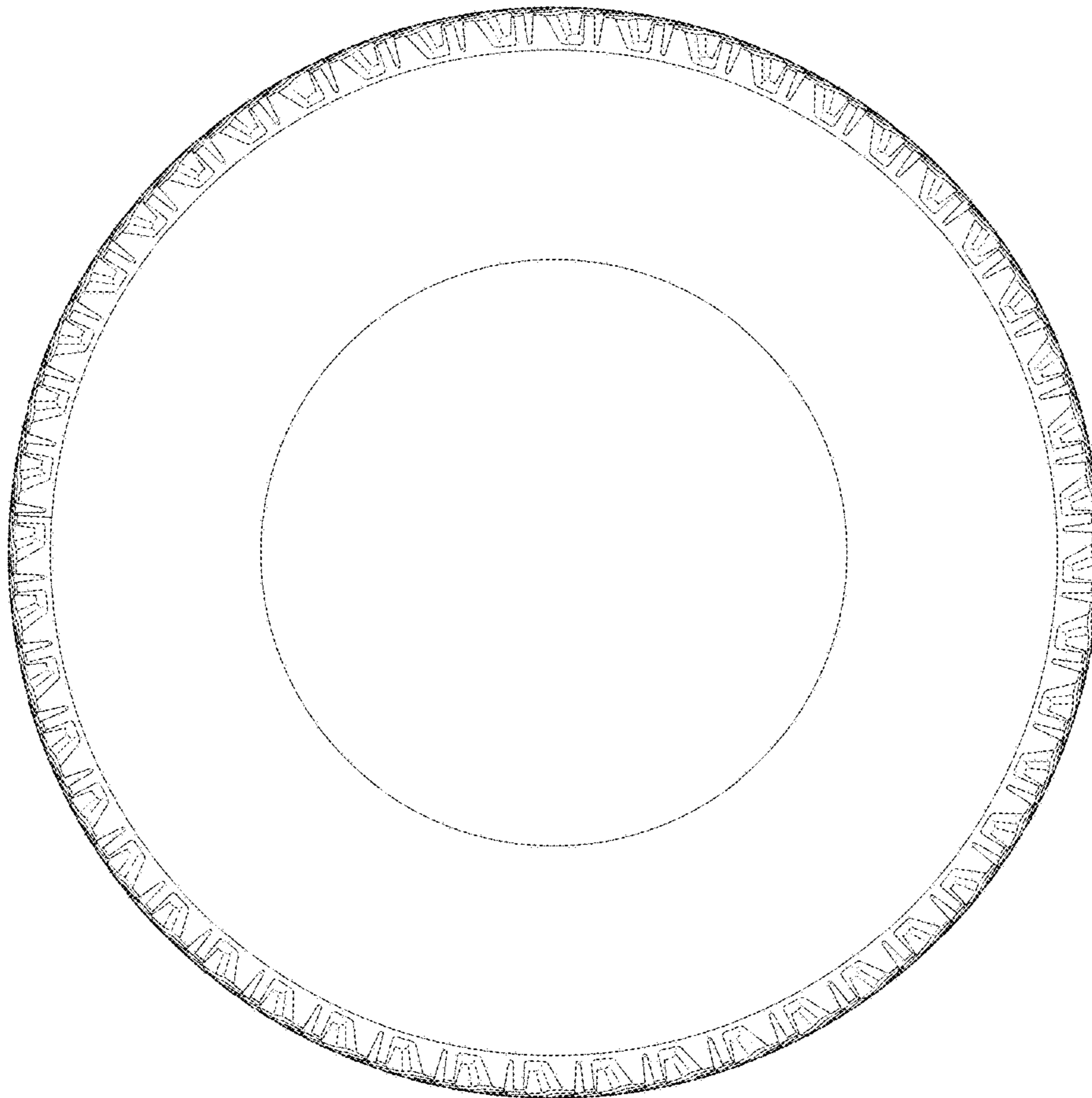

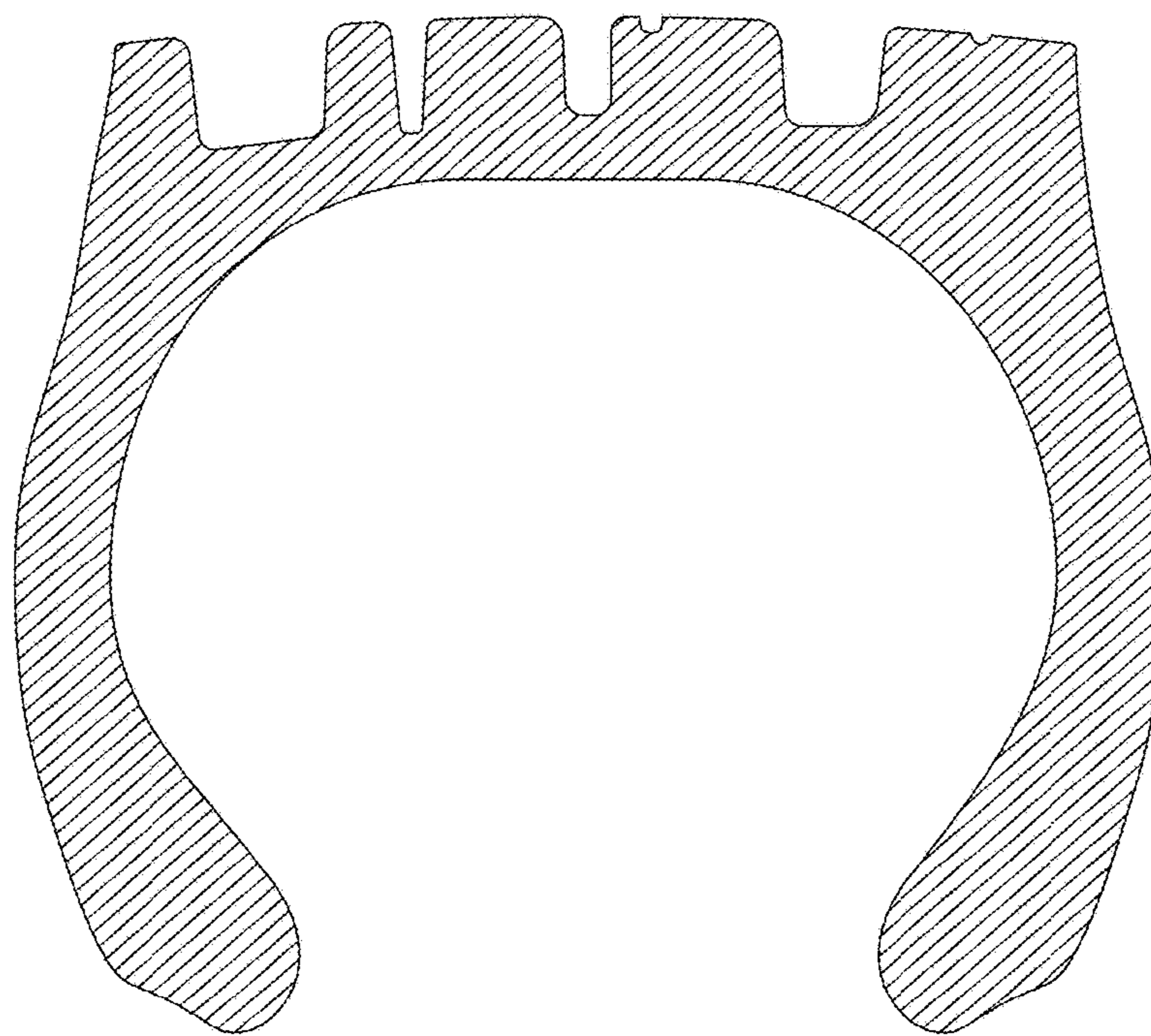

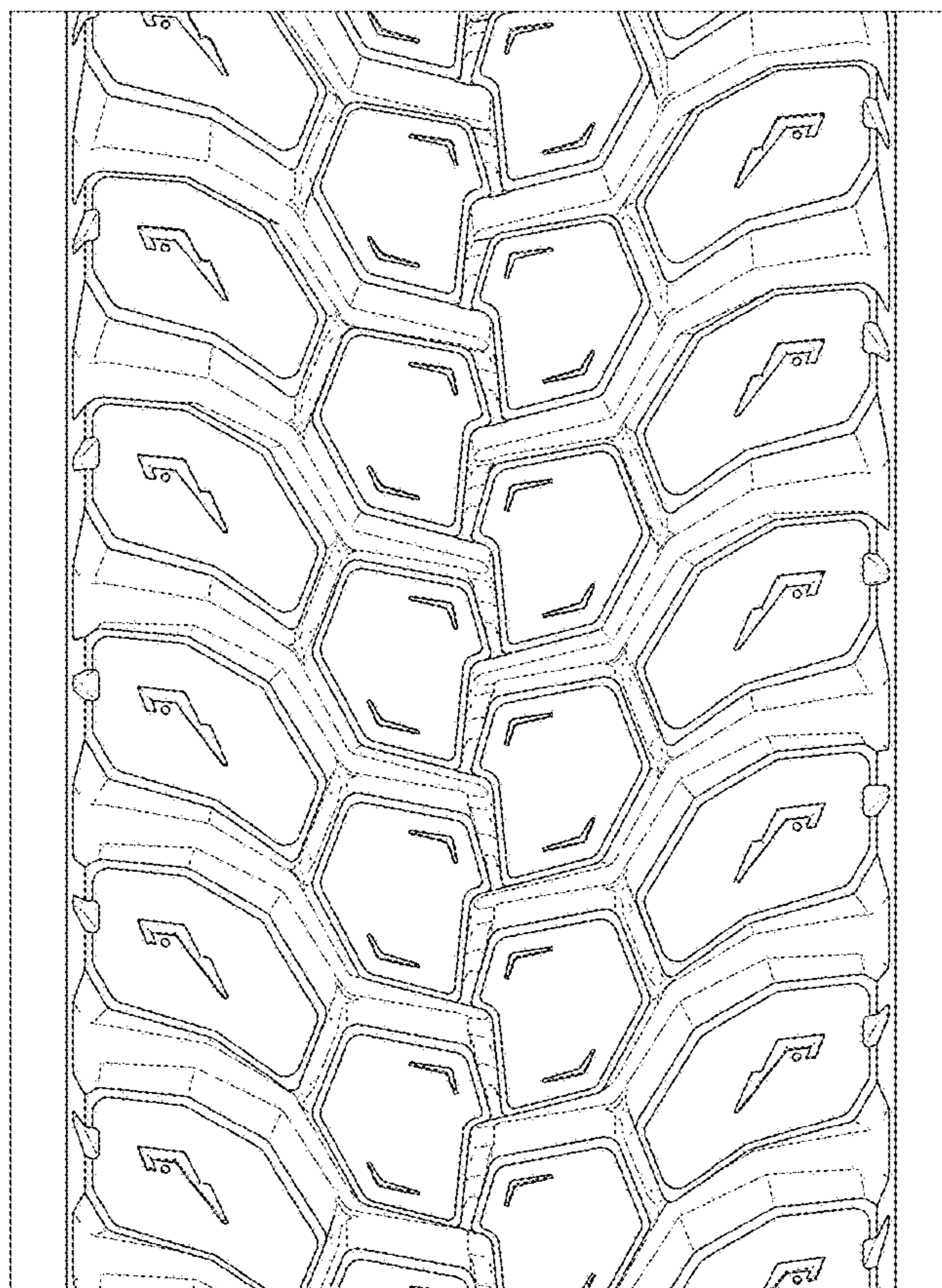
